DESCRIPTION

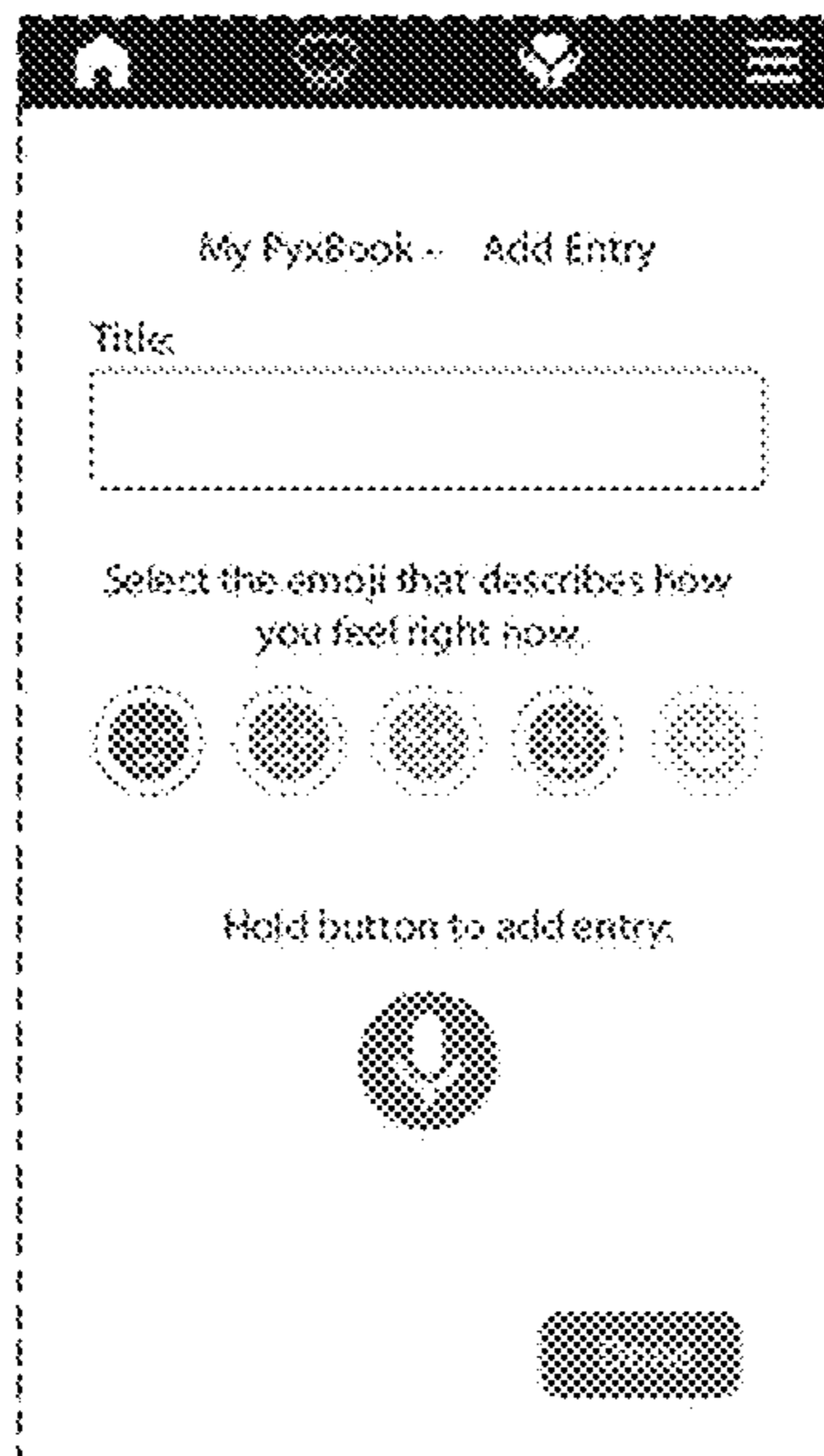

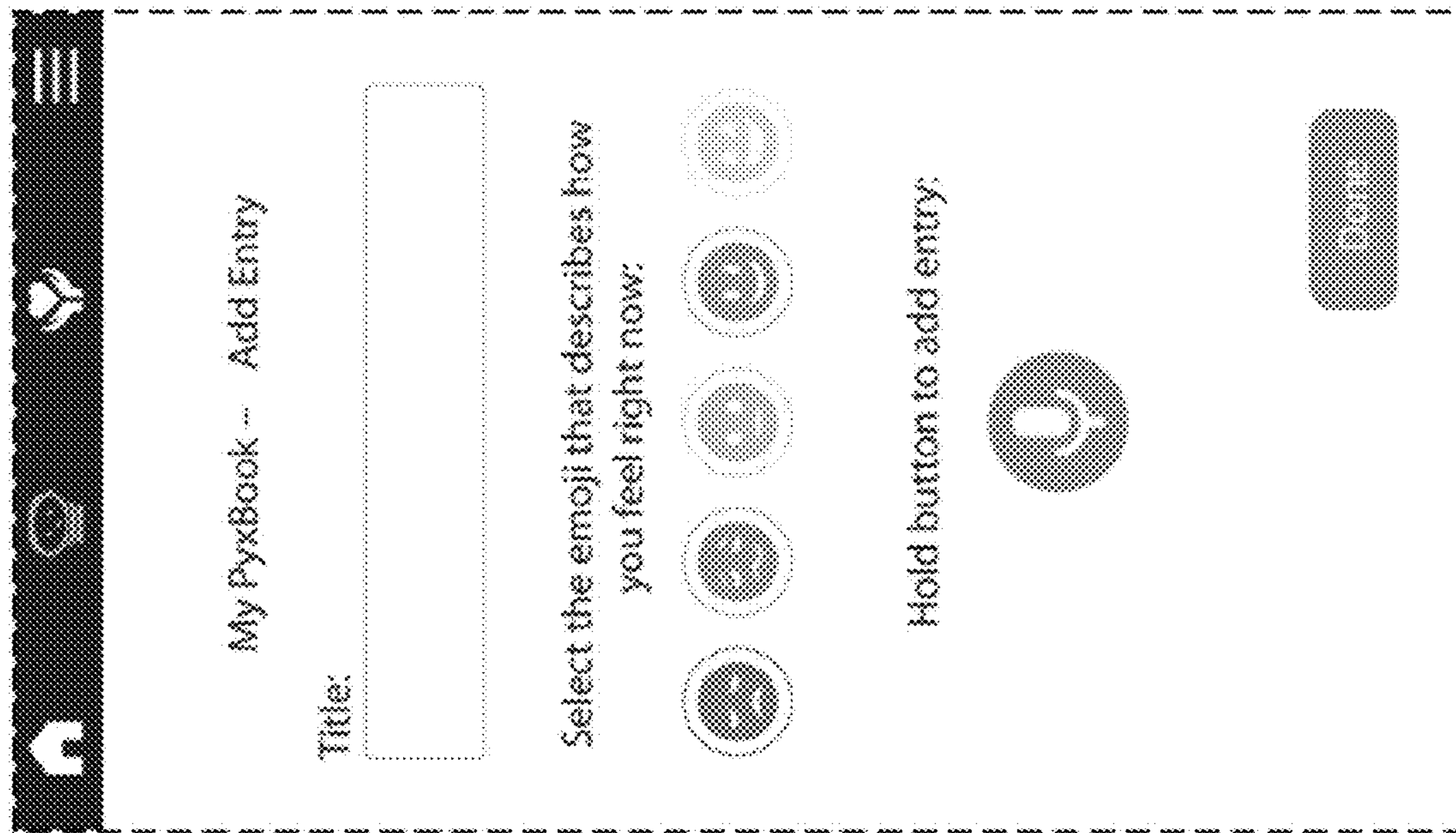

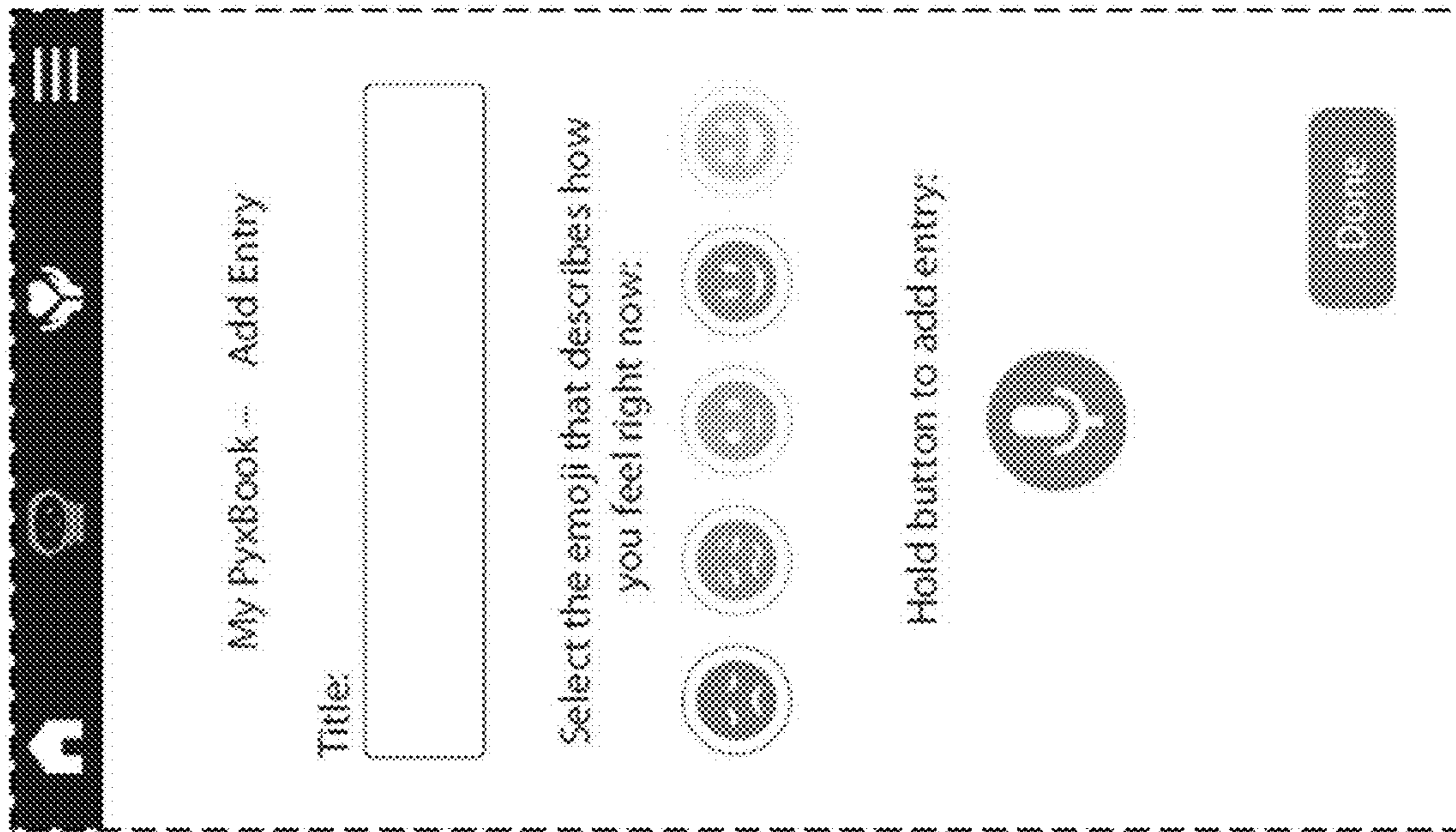
