FIG. 1 is a front view of a display screen or portion thereof with a graphical user interface showing a first image of the claimed design.

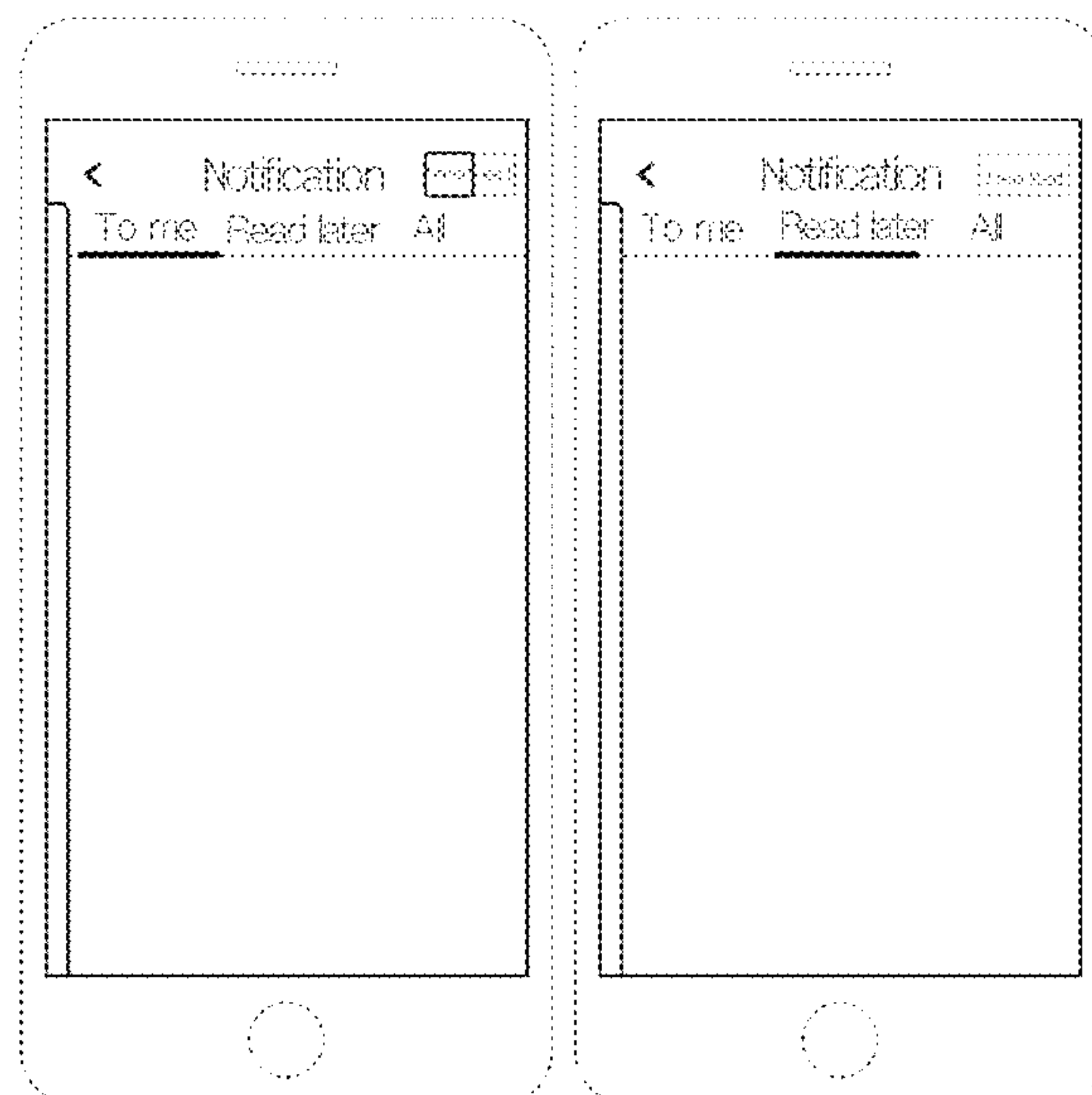
FIG. 2 is a second image thereof; and,

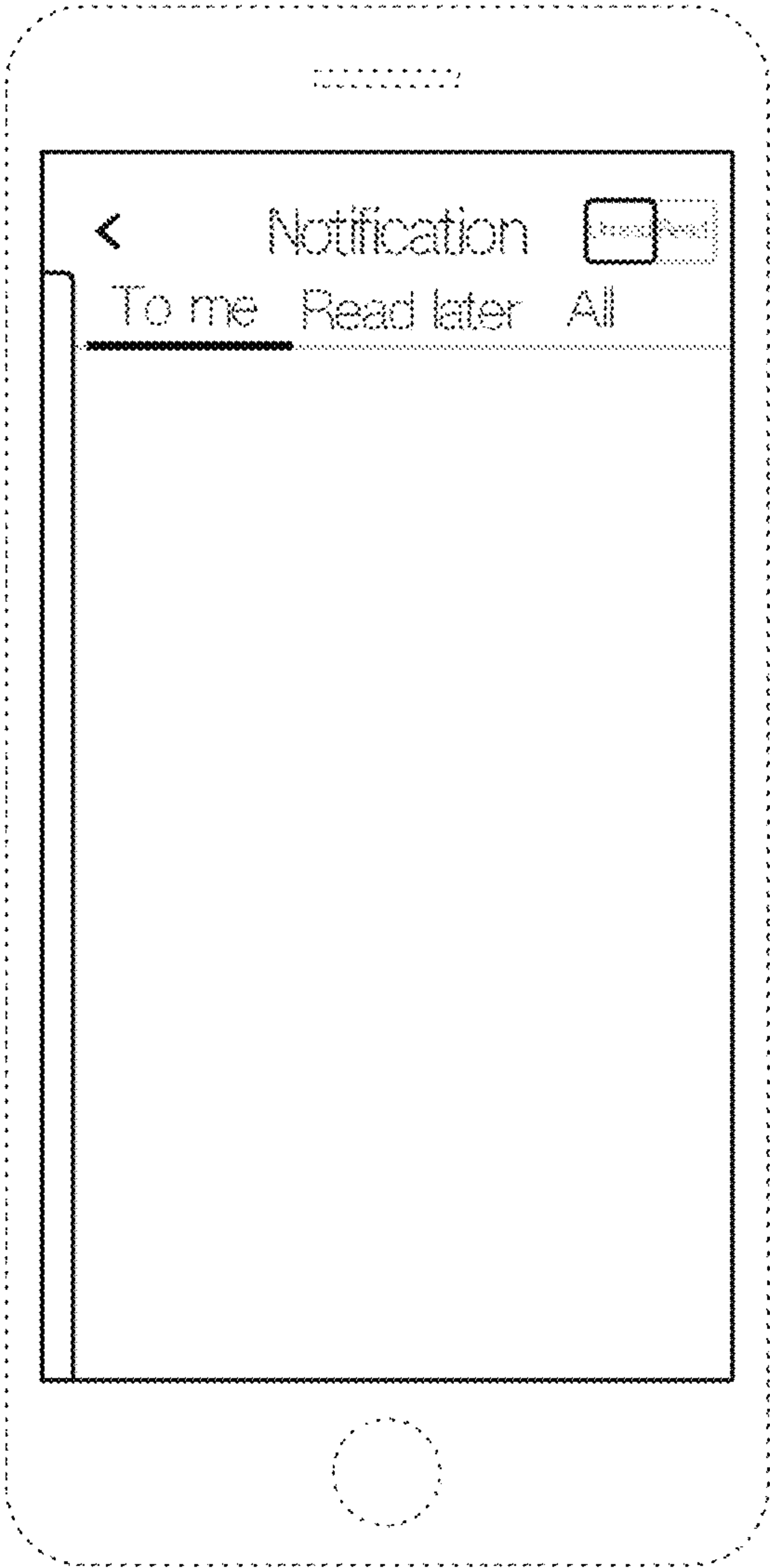

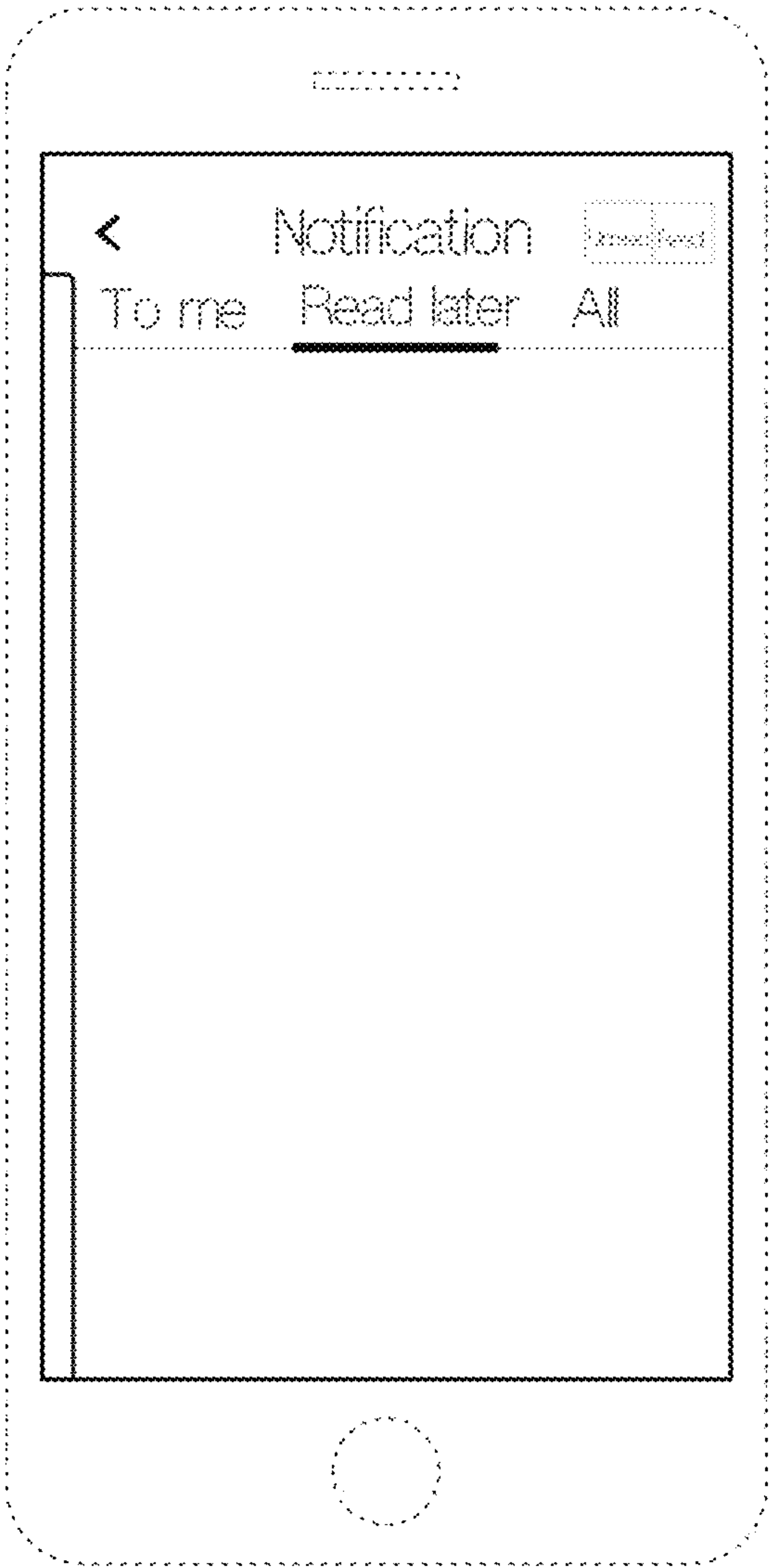
