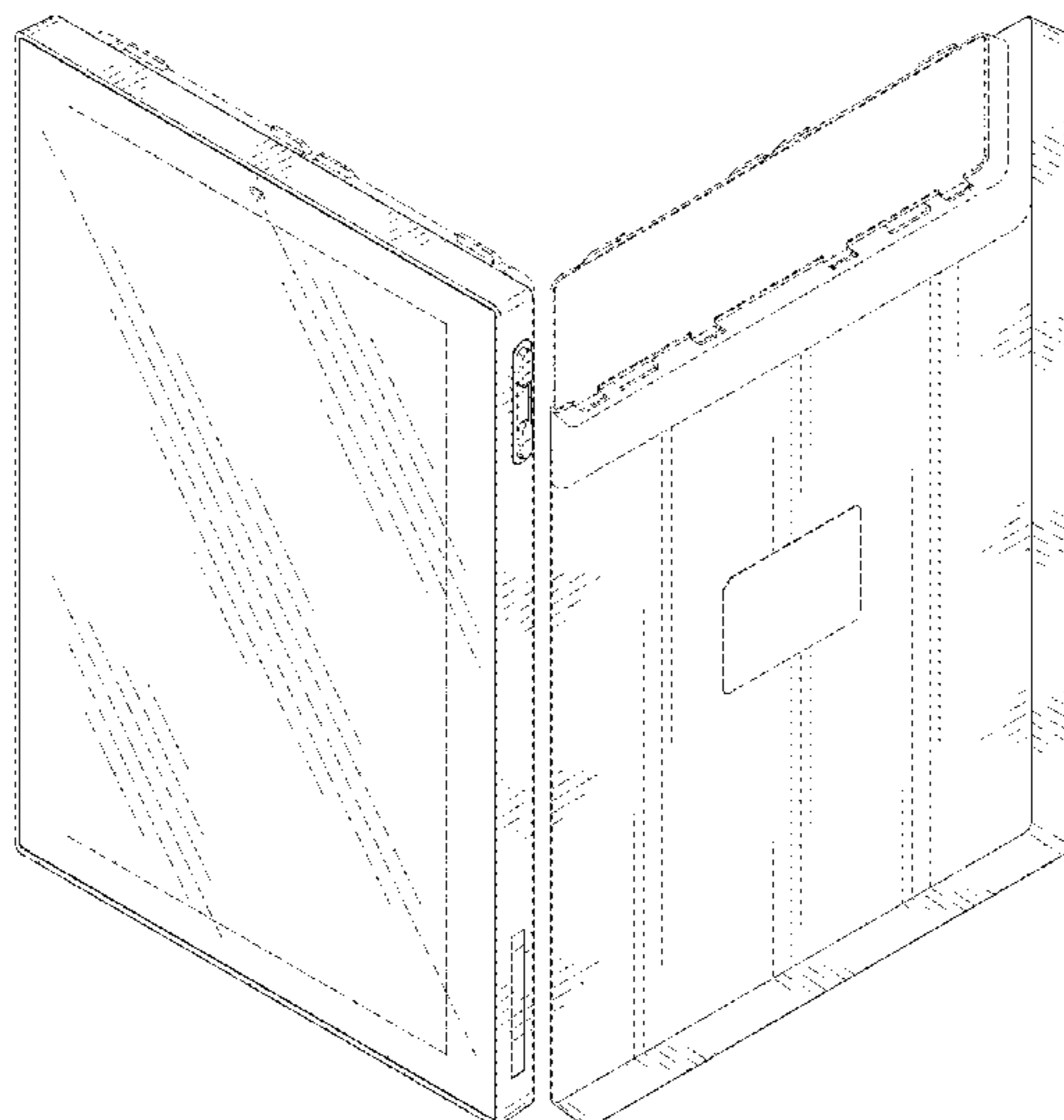
The ornamental design for an electronic shelf label, as shown and described.

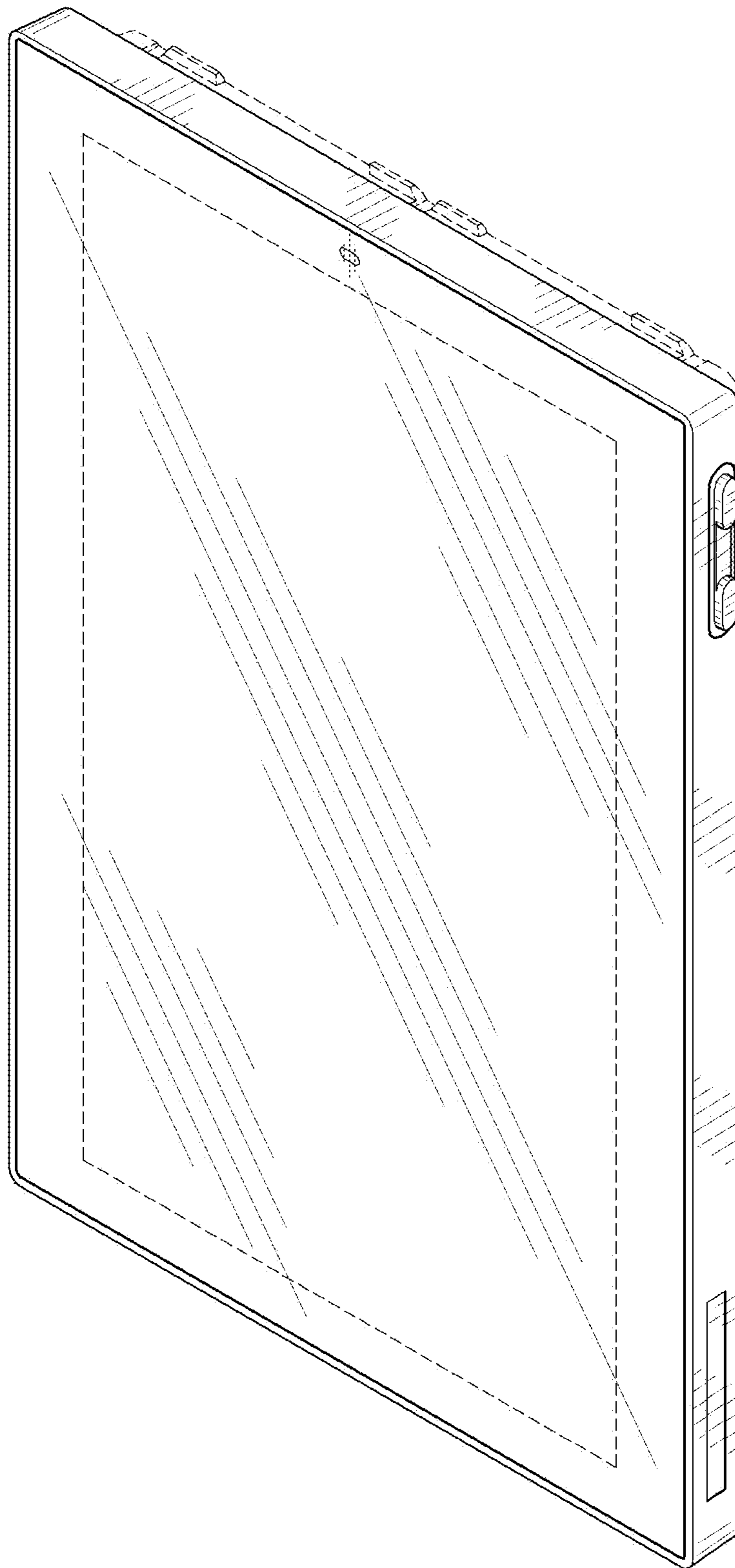

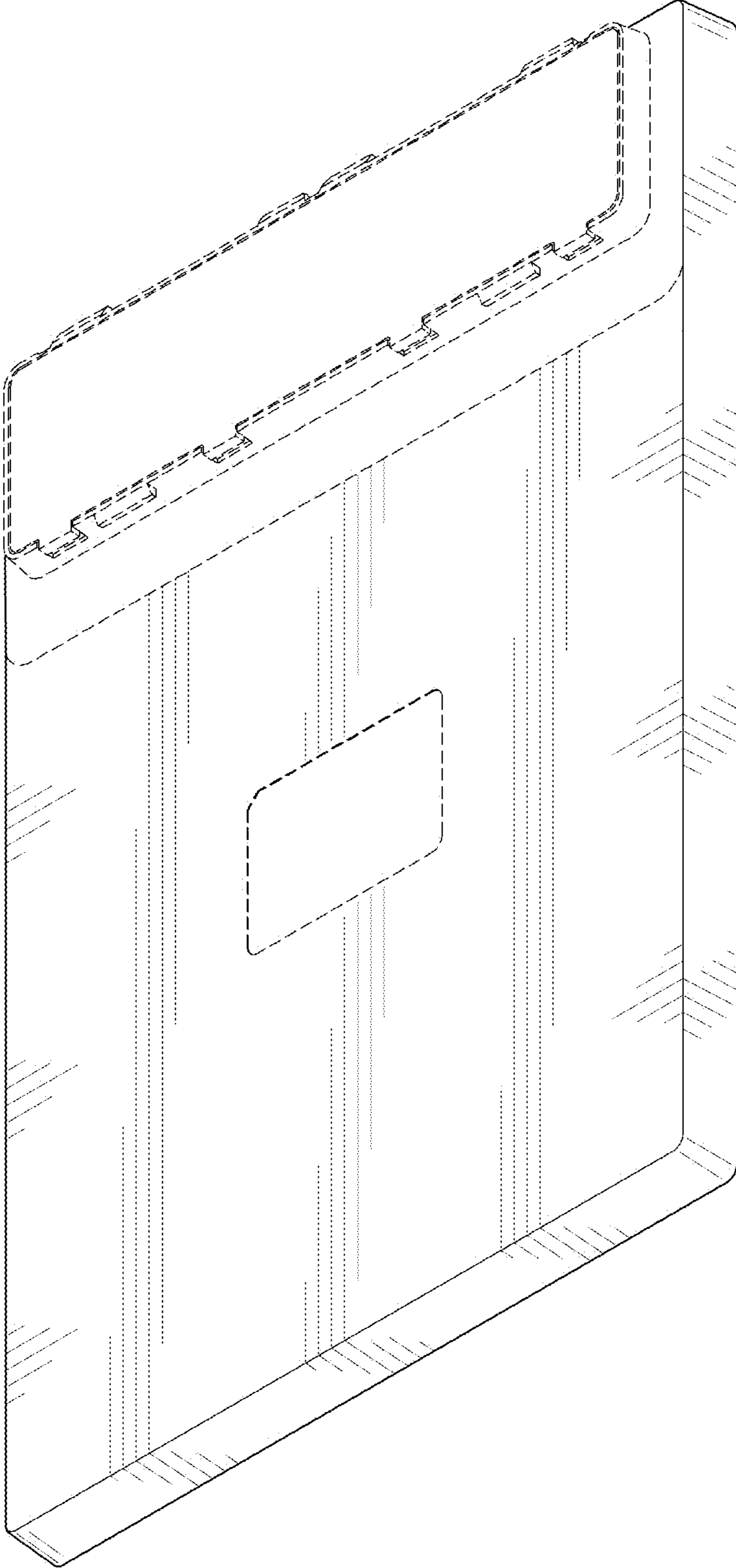

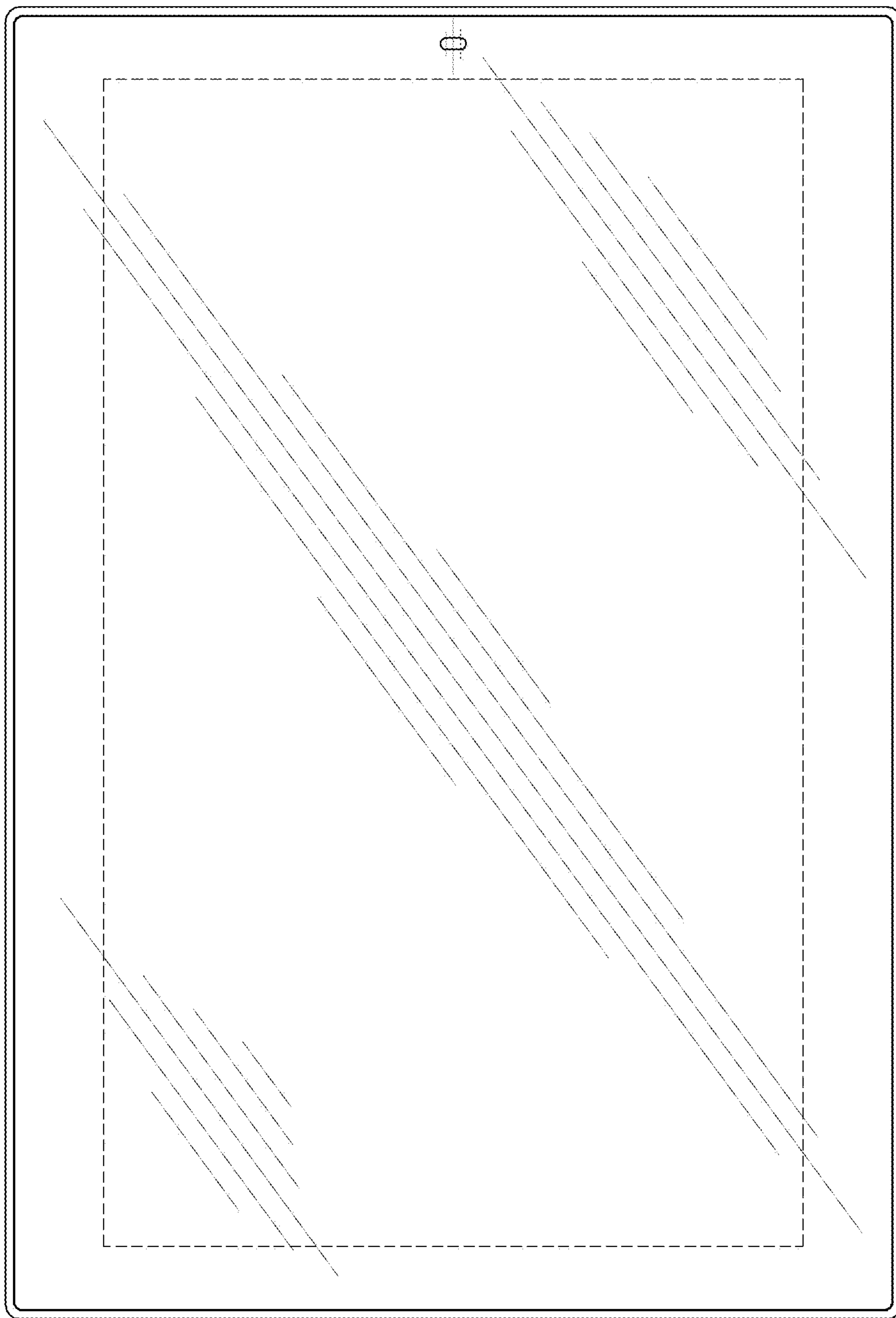

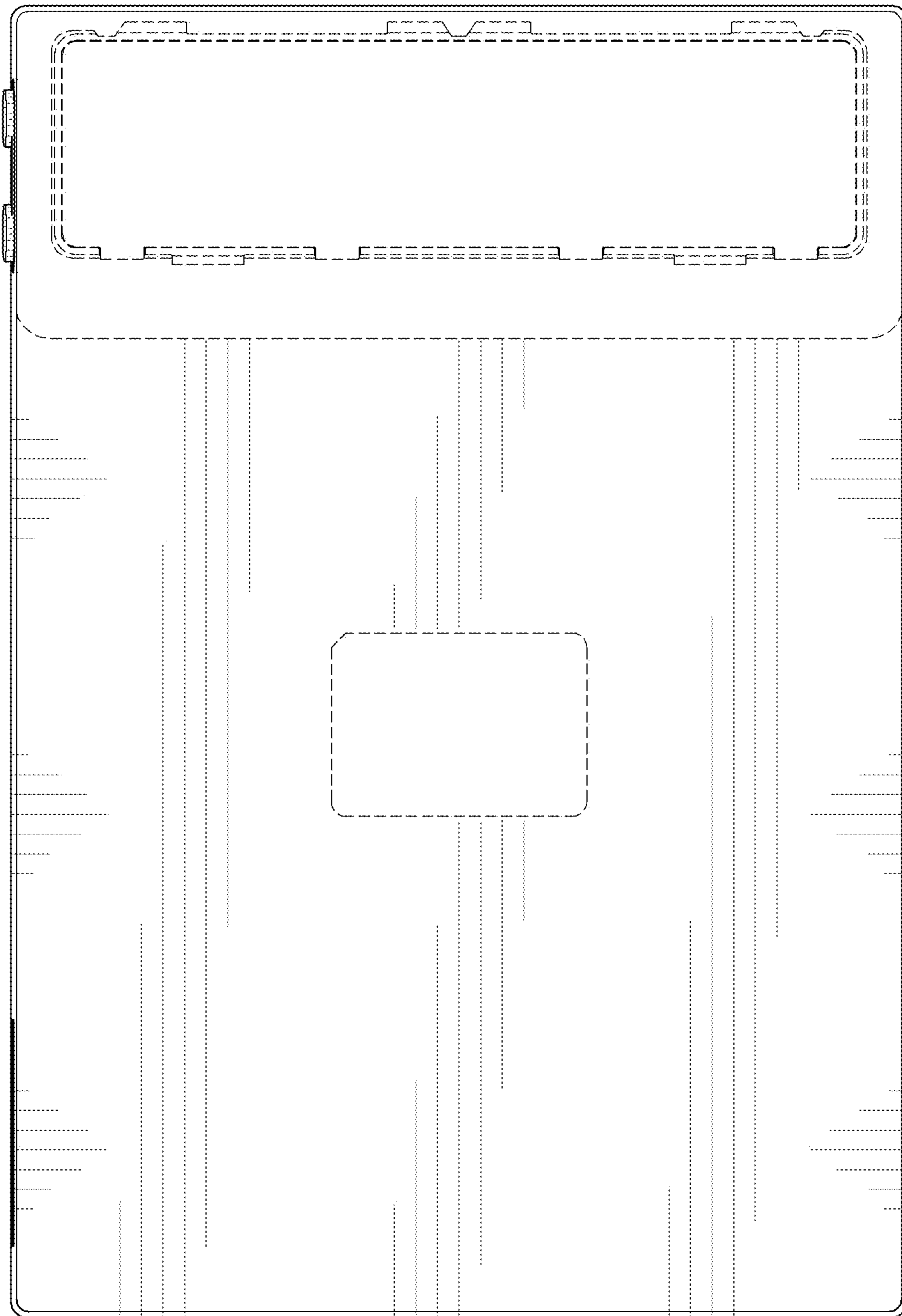

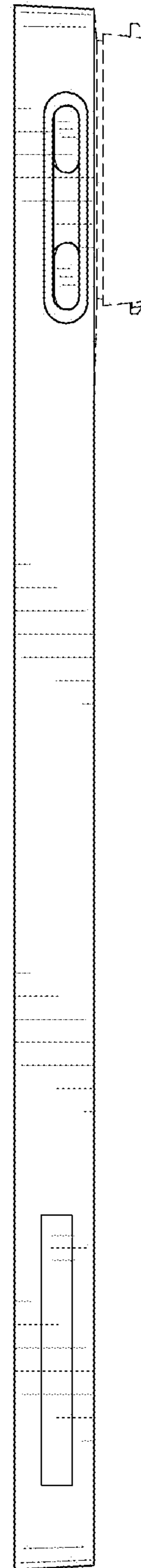

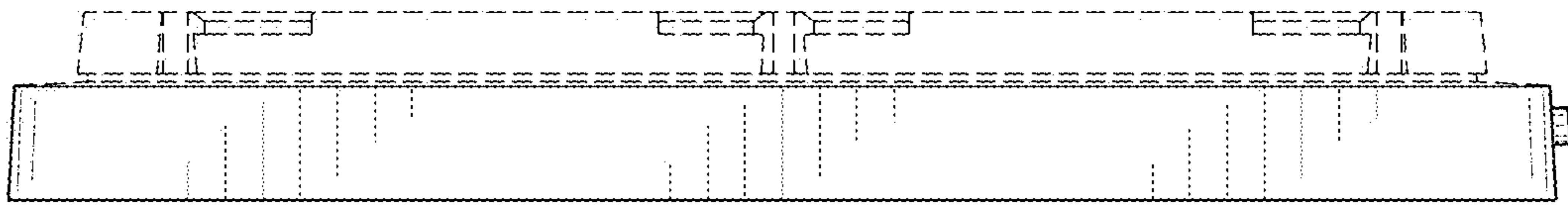

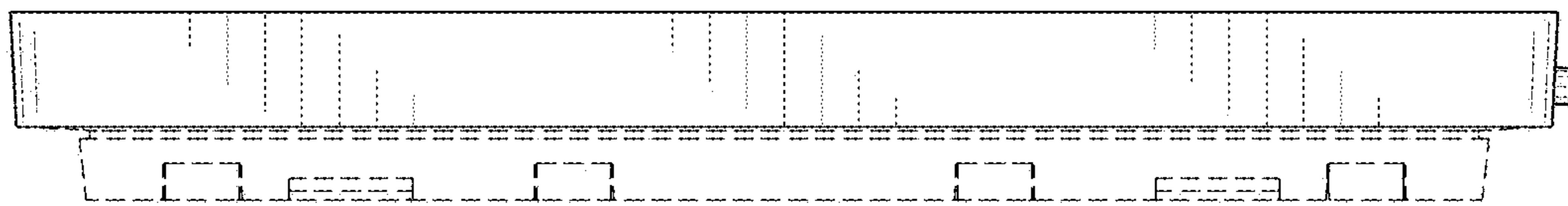
