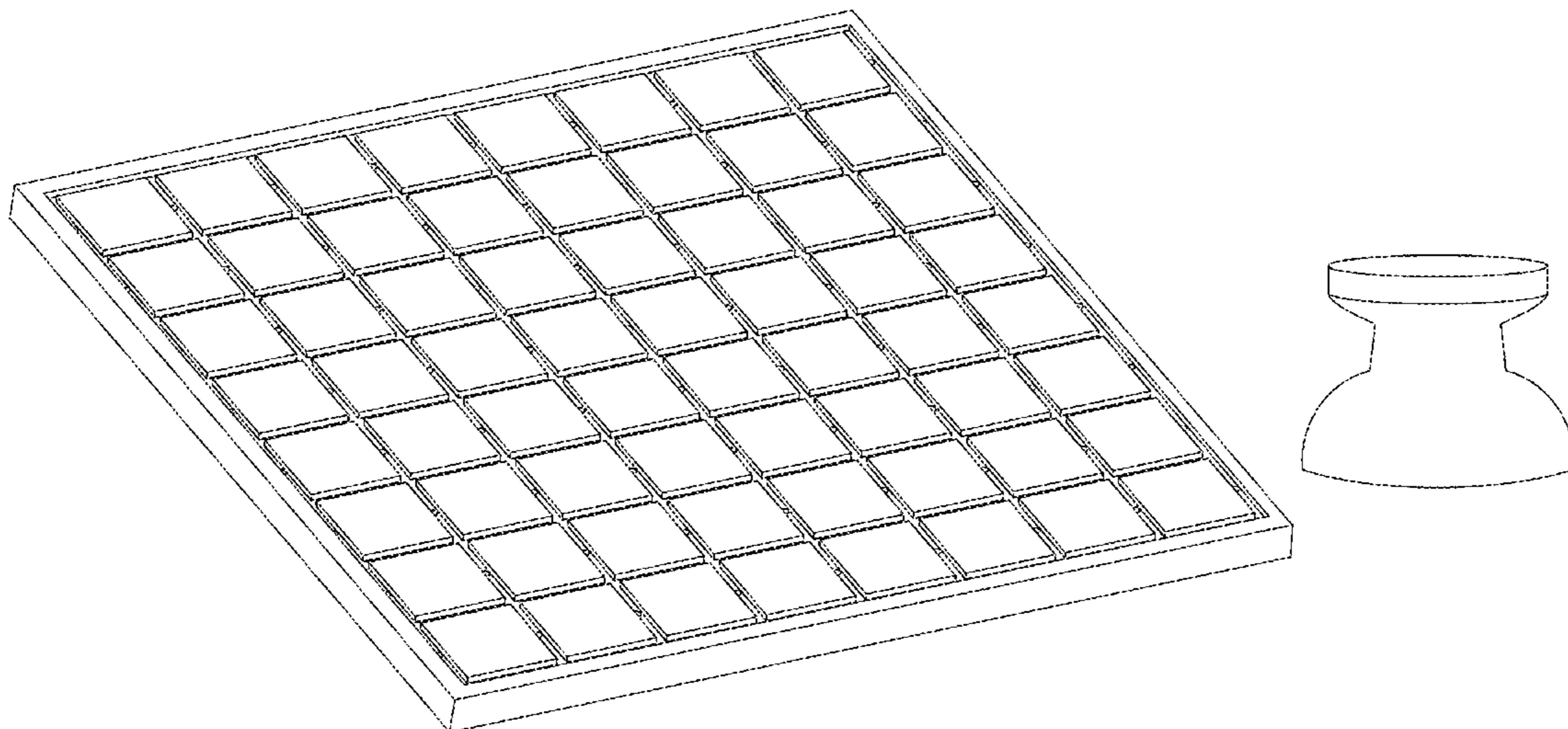
(57) **CLAIM**

The ornamental design for a square control board game, as shown and described.

DESCRIPTION

FIG. 1 is top plan view of the board of the square control board game, showing my new design;
FIG. 2 is a cross-sectional view of the board (at the broken line A-A' in FIG. 1) of the square control board game;
FIG. 3 is a perspective view of the board of the square control board game;
FIG. 4 is an enlarged side elevational view of an edge piece of the square control board game, the other side being identical;
FIG. 5 is an enlarged bottom plan view thereof;
FIG. 6 is an enlarged top plan view thereof;
FIG. 7 is an enlarged side elevational view of a control piece for a first player of the square control board game;
FIG. 8 is an enlarged top plan view thereof;
FIG. 9 is an enlarged bottom plan view thereof;
FIG. 10 is an enlarged side elevational view of a control piece for a second player of the square control board game;
FIG. 11 is an enlarged top plan view thereof; and,
FIG. 12 is an enlarged bottom plan view thereof.
The broken line disclosure represents portions which form no part of the claimed design.

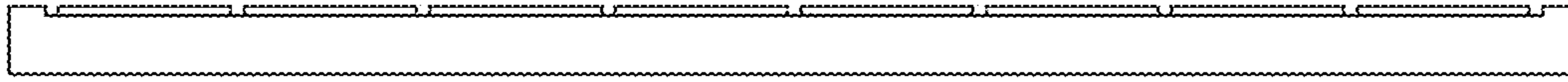

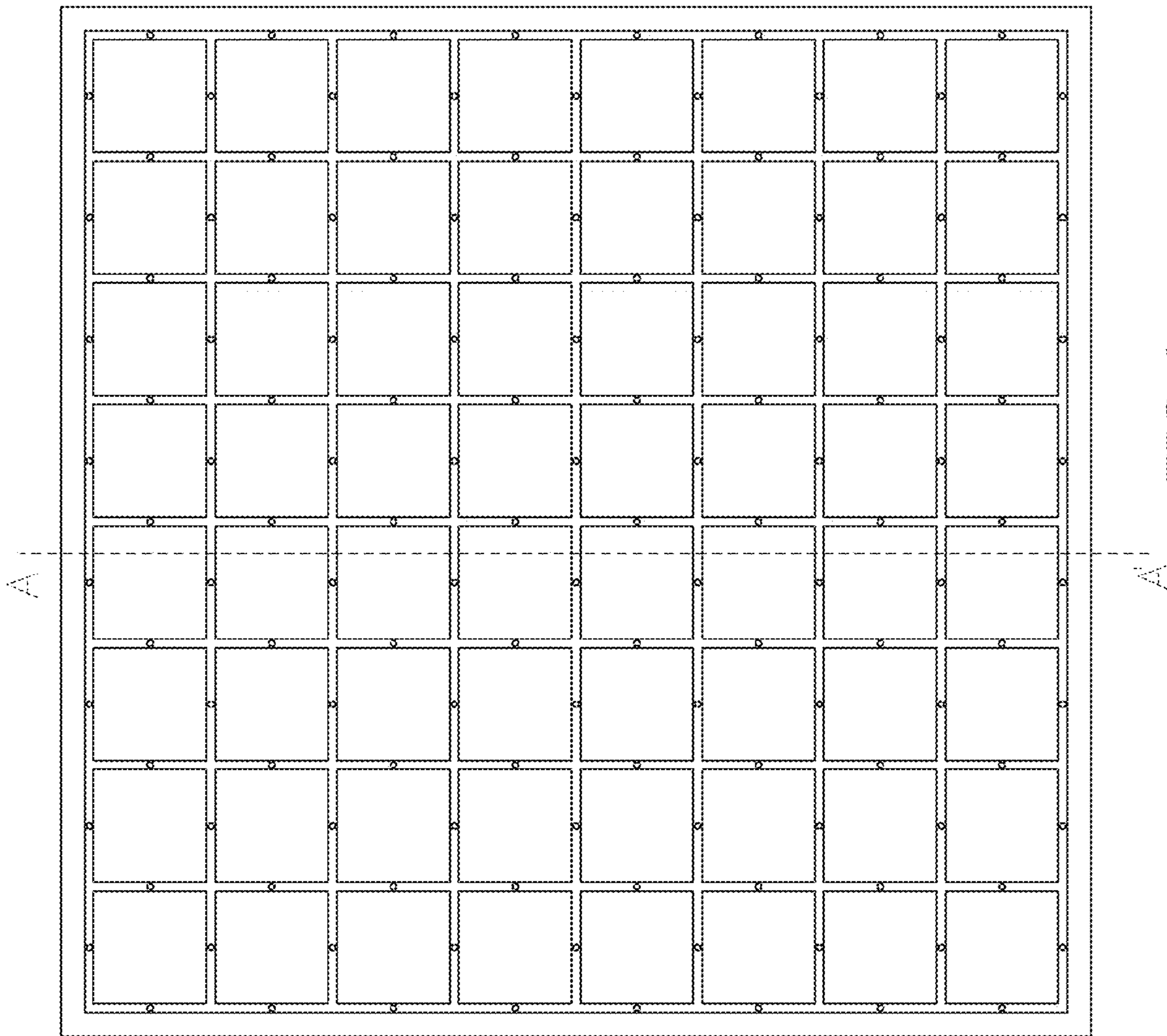

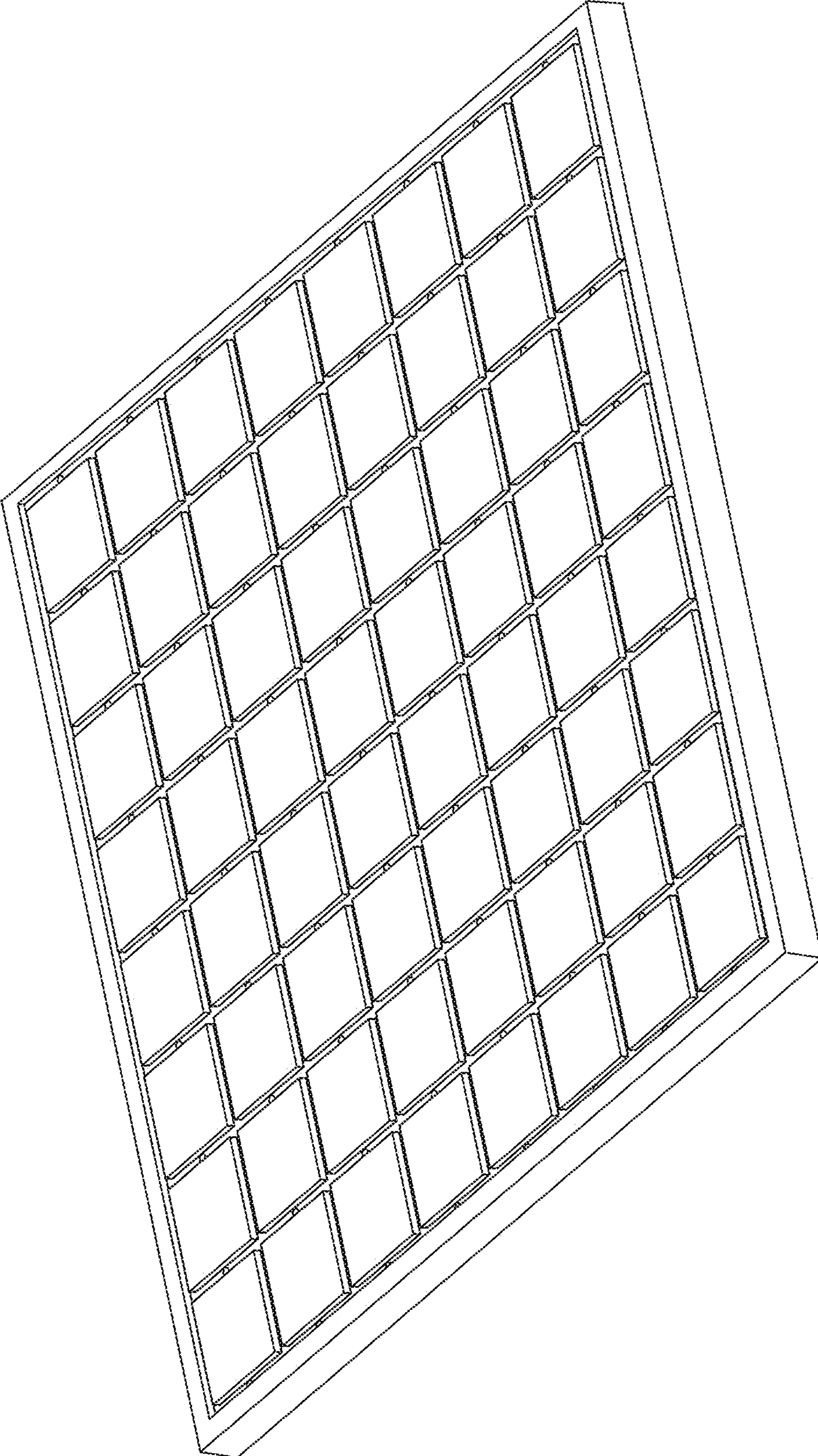

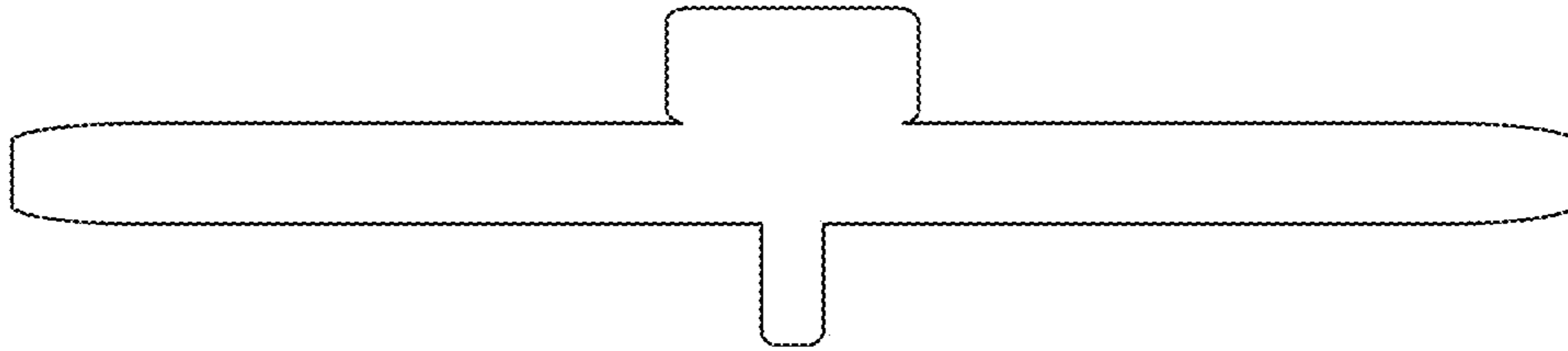

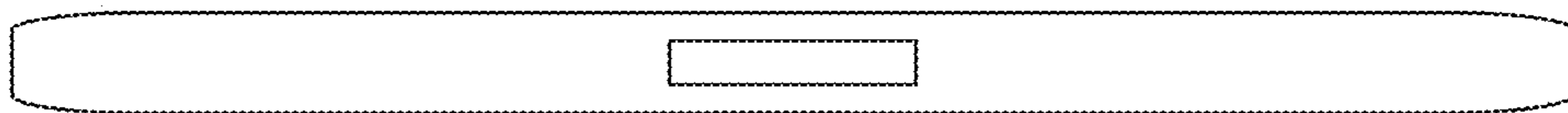

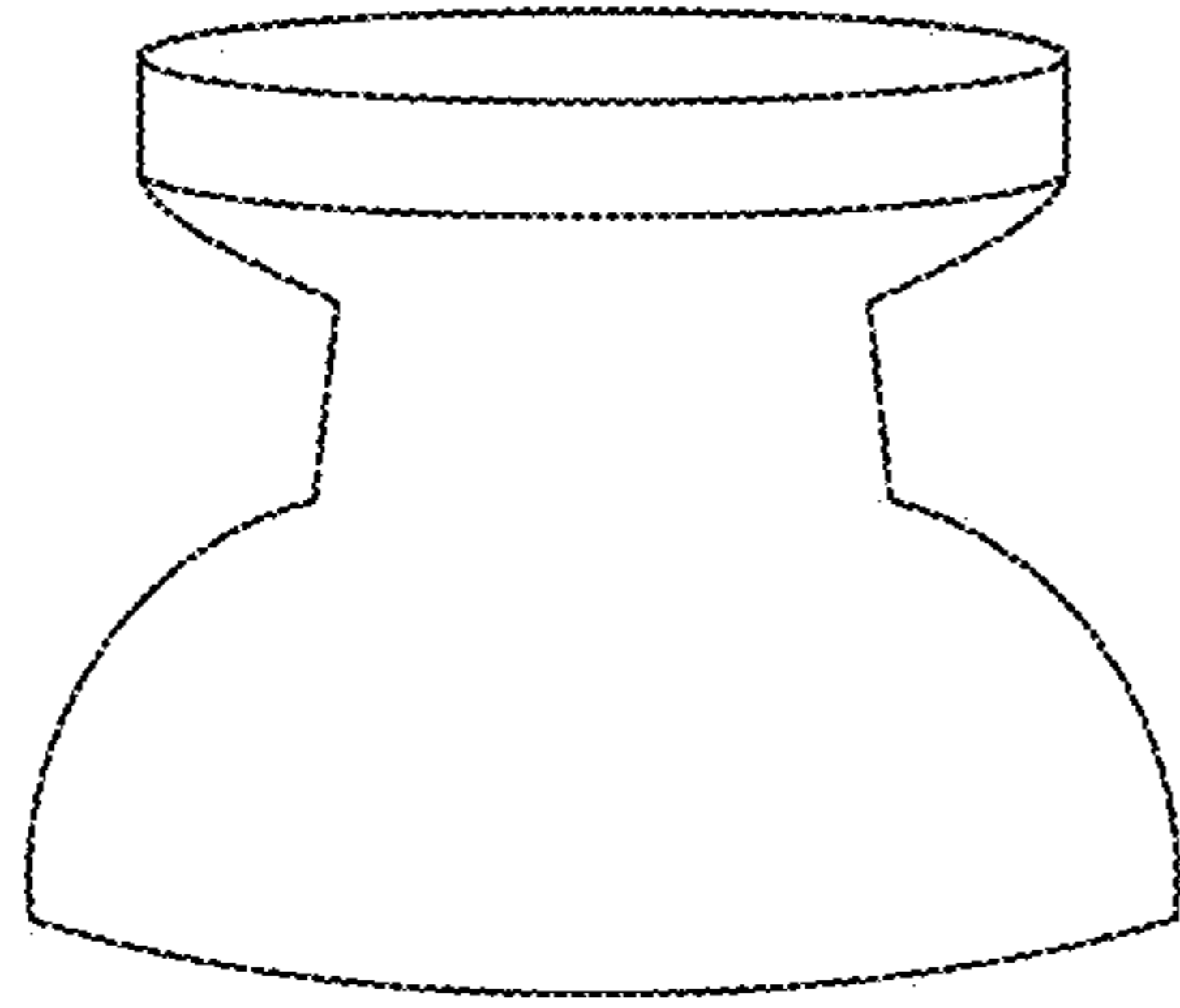

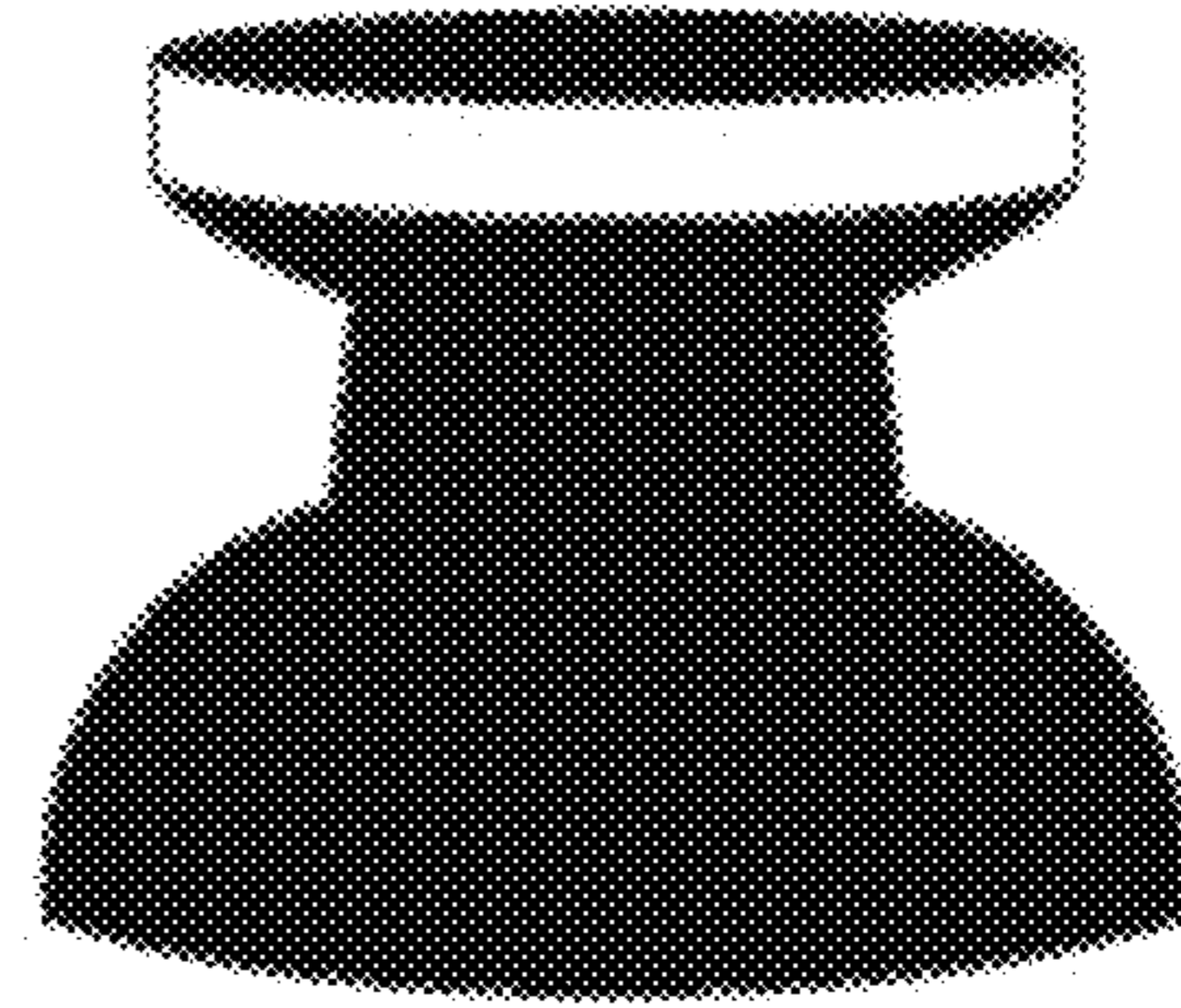

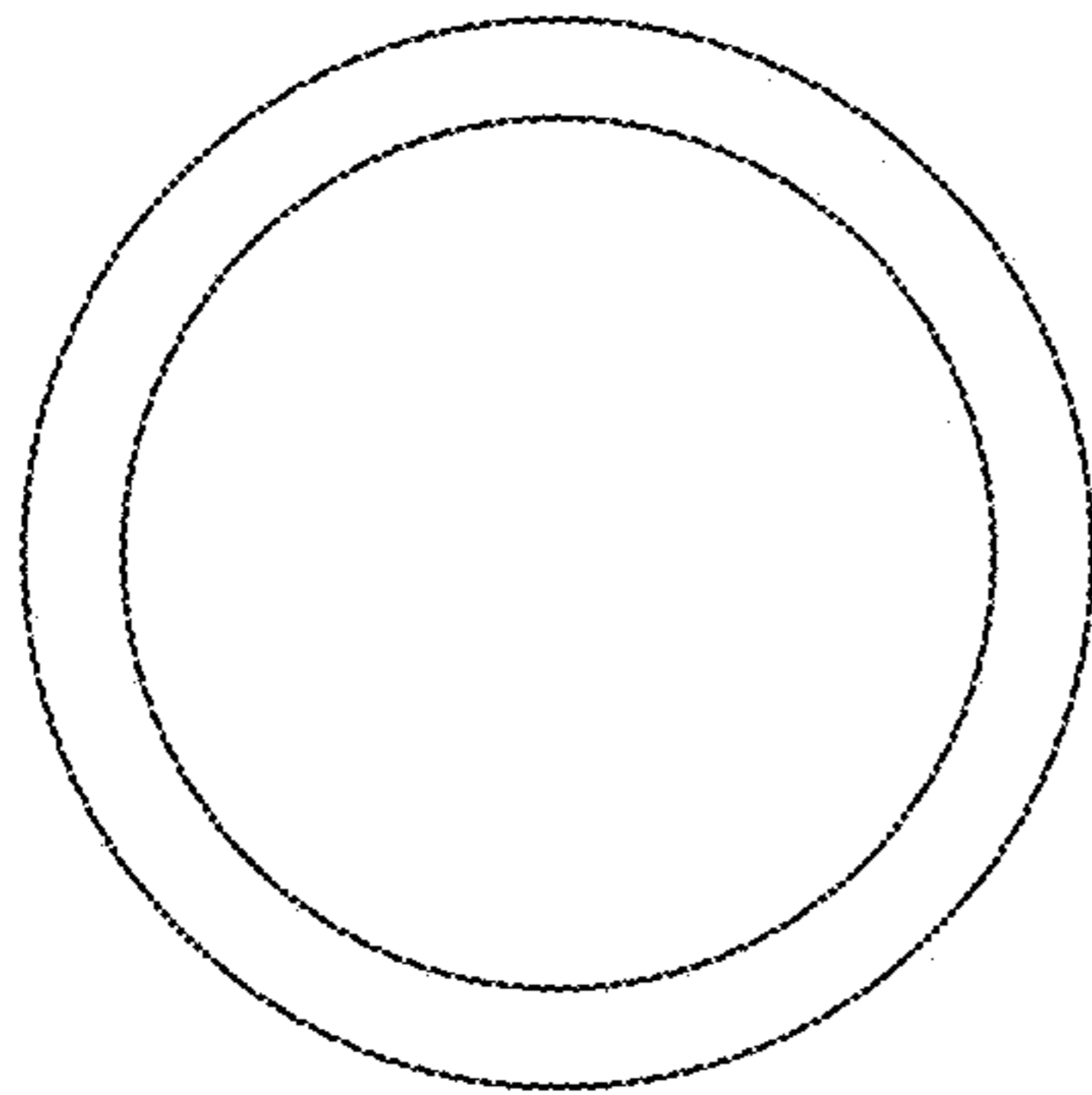

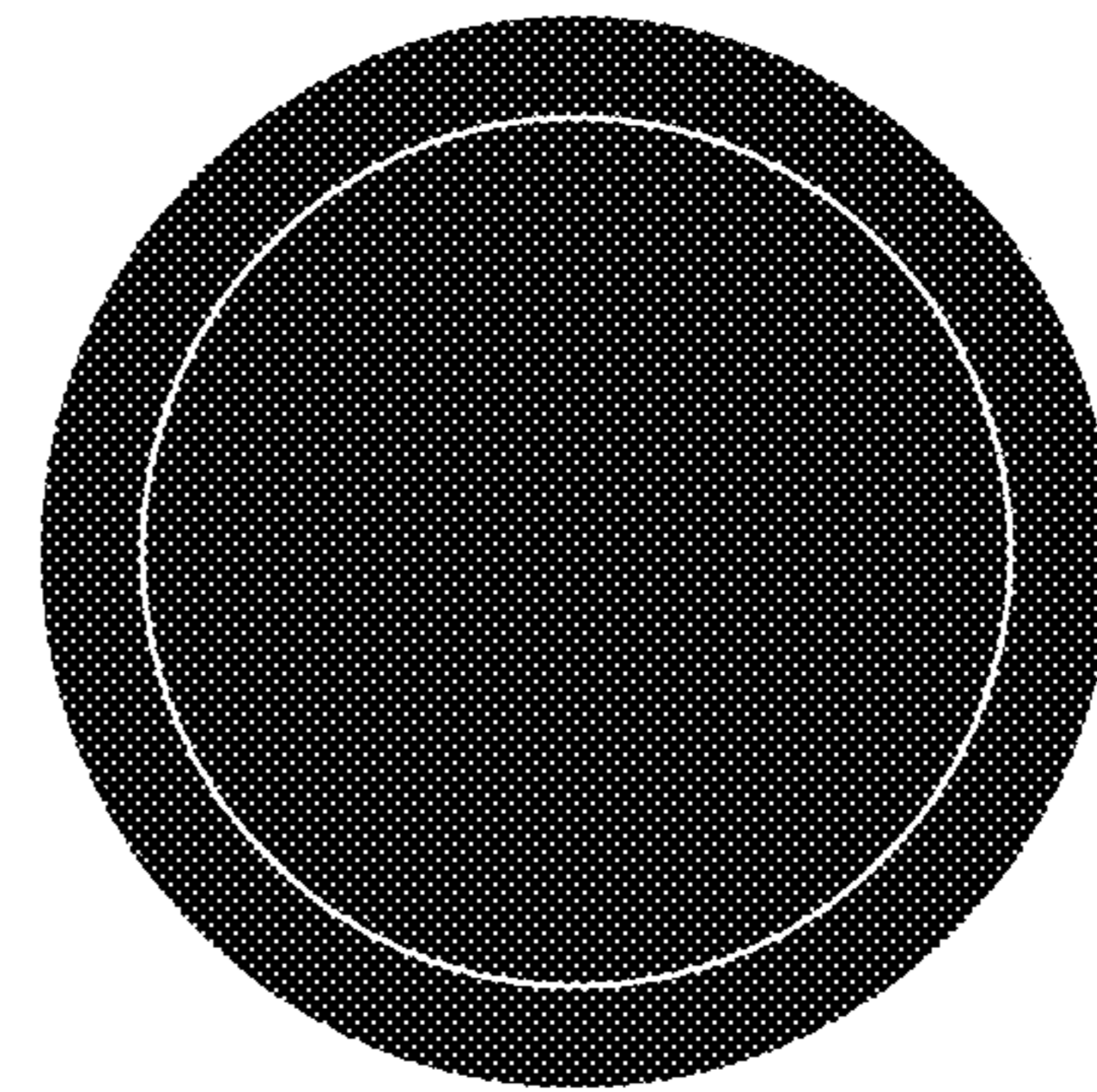

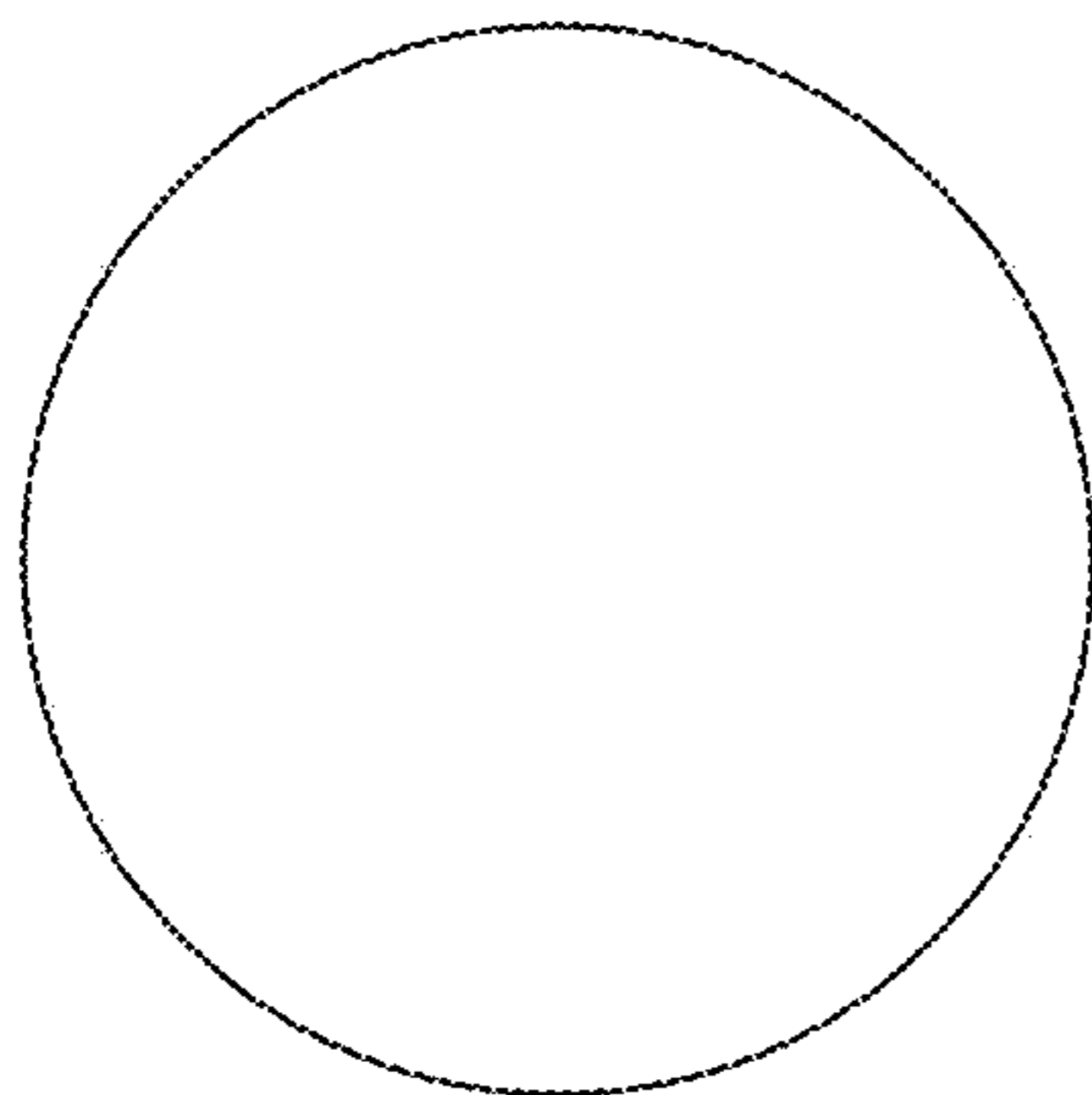

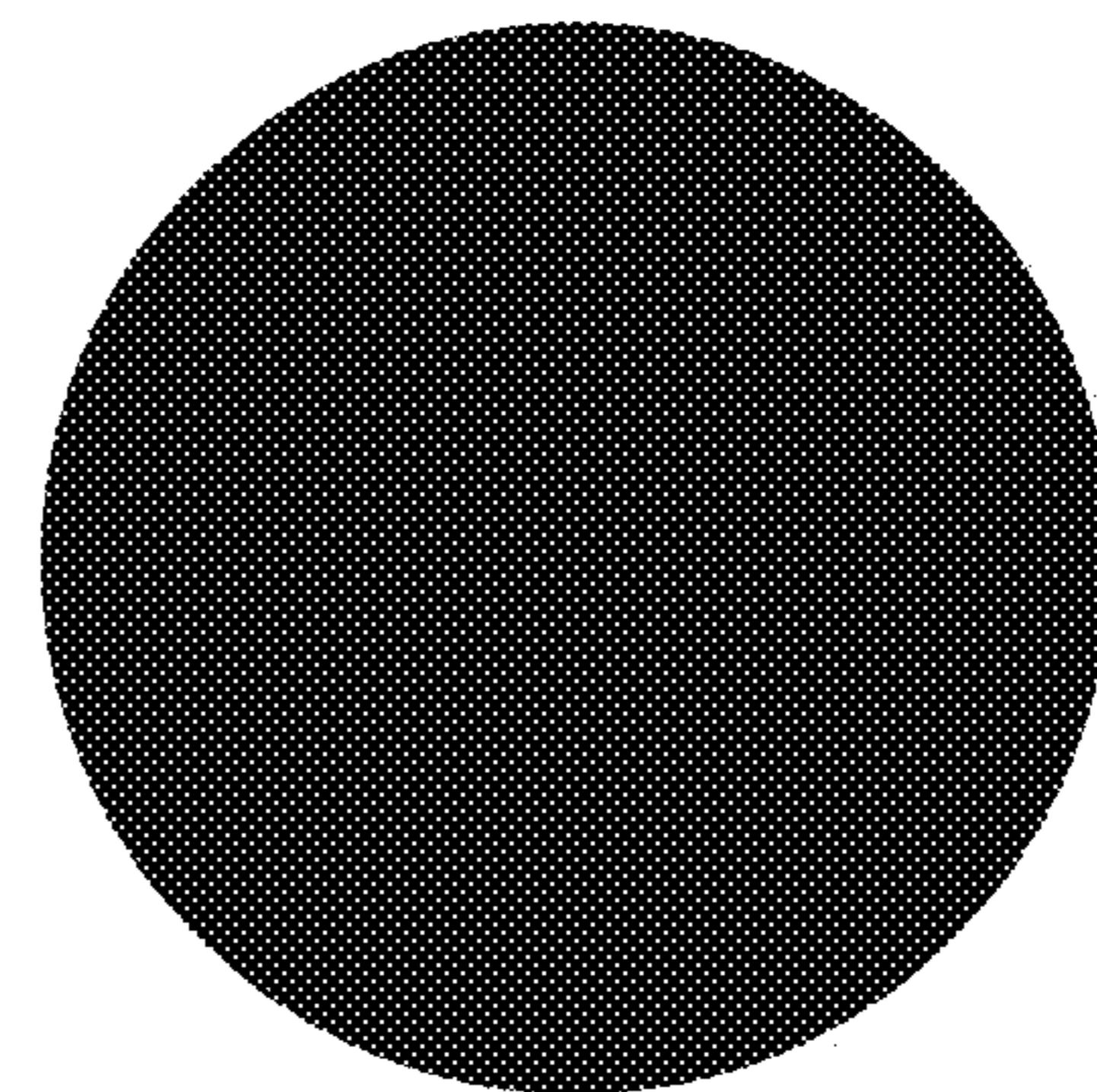
