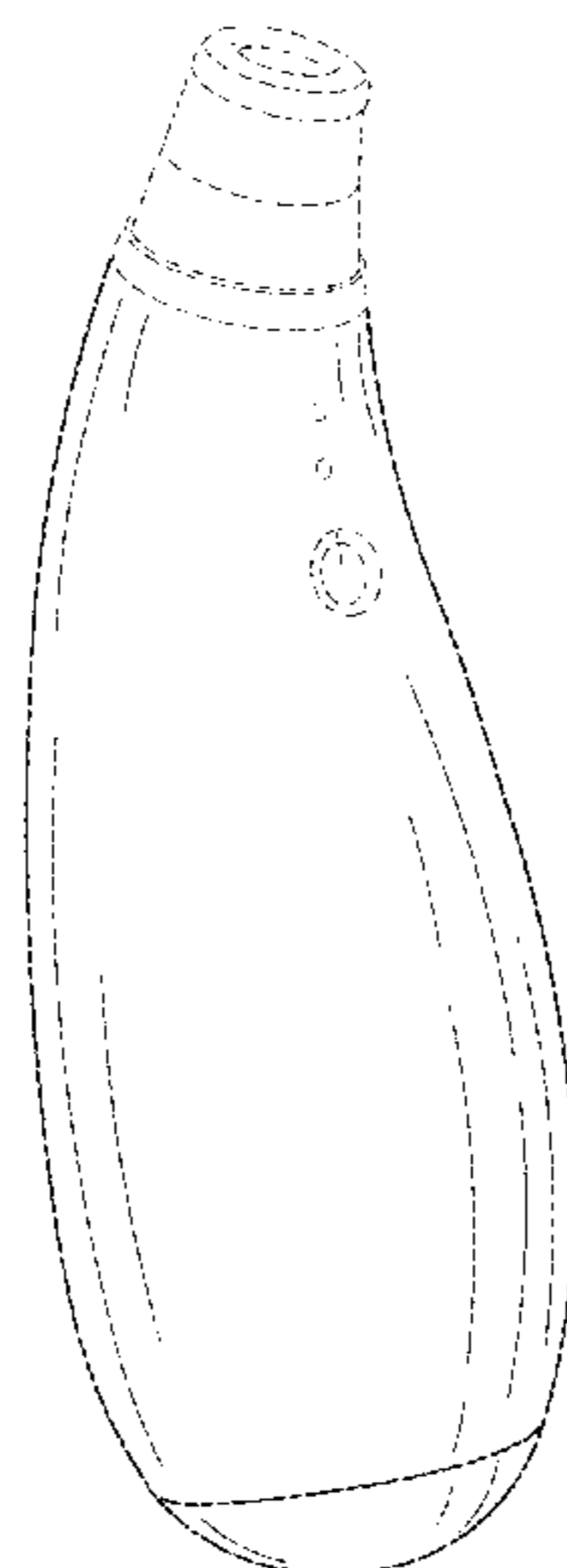
(57) **CLAIM**

The ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electronic device in accordance with the present invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a right side elevation view thereof. The broken lines shown in the drawings depict portions of the electronic device that form no part of the claimed design.

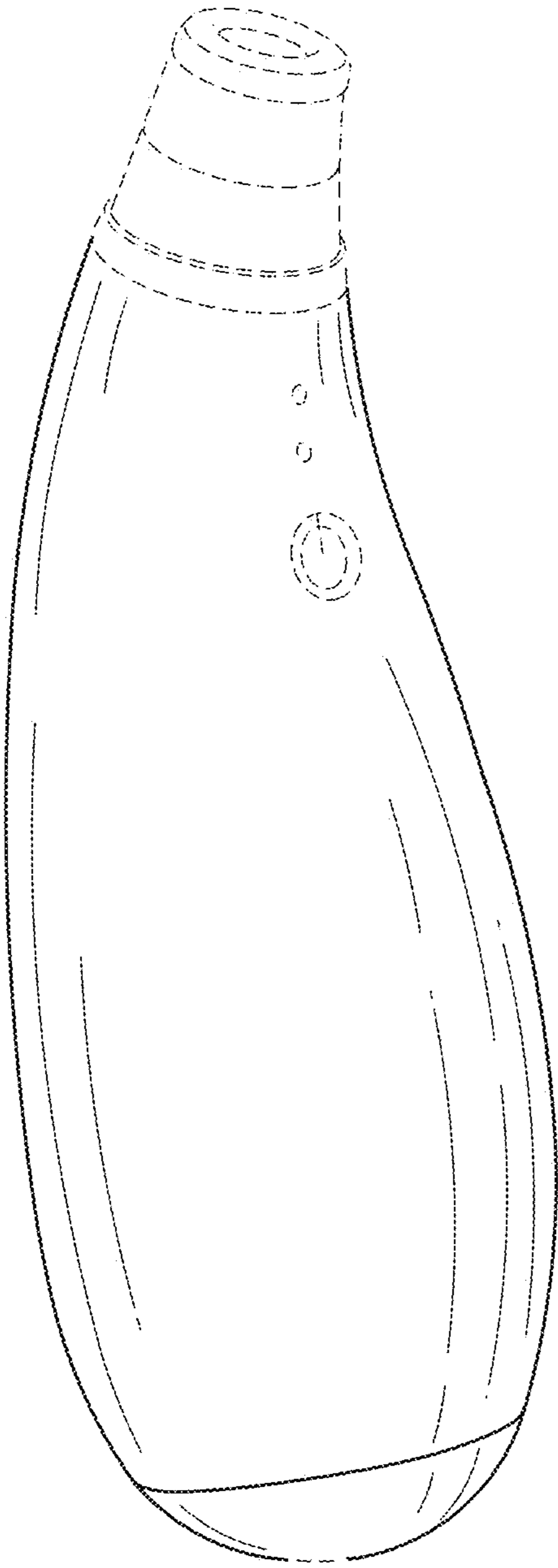

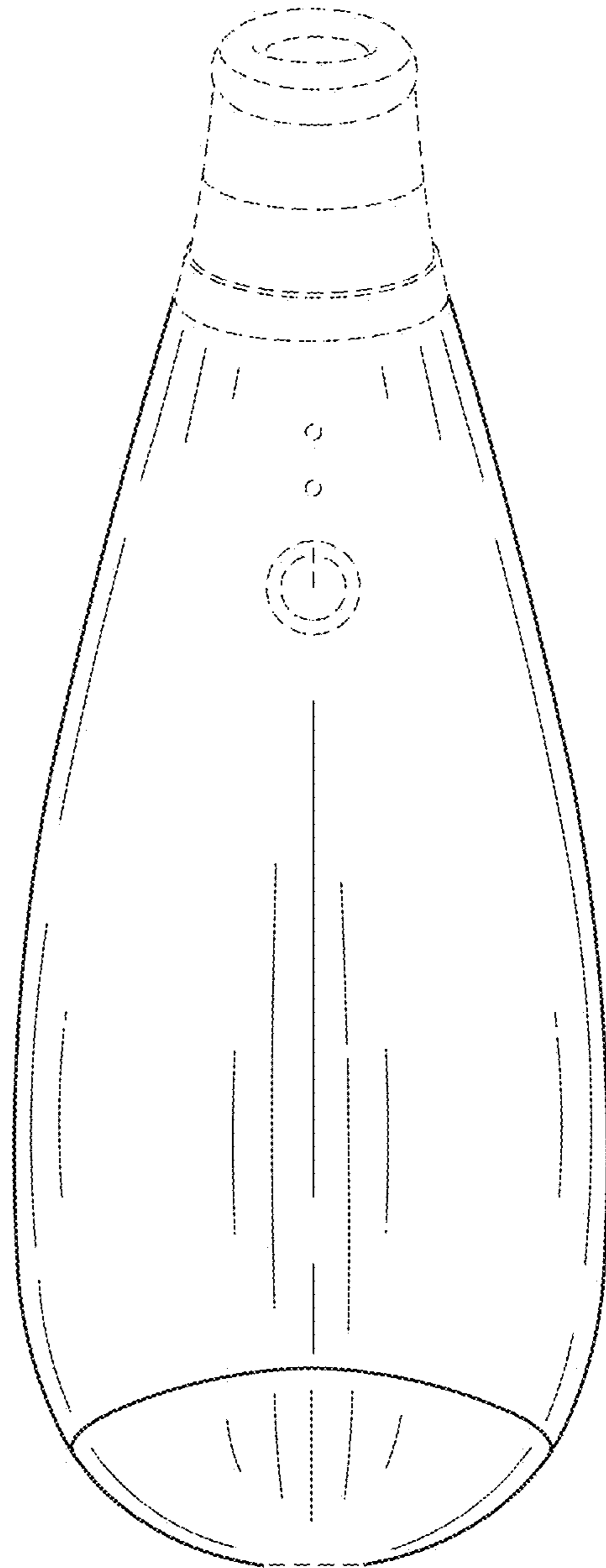

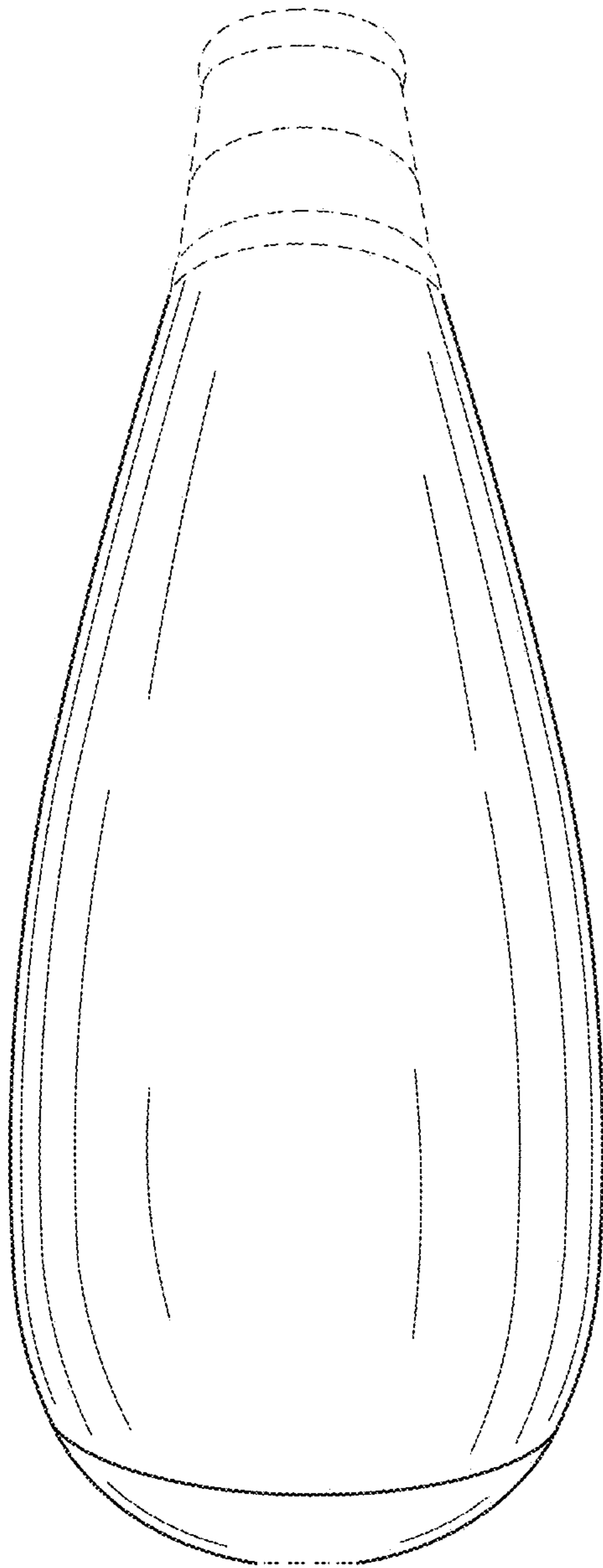

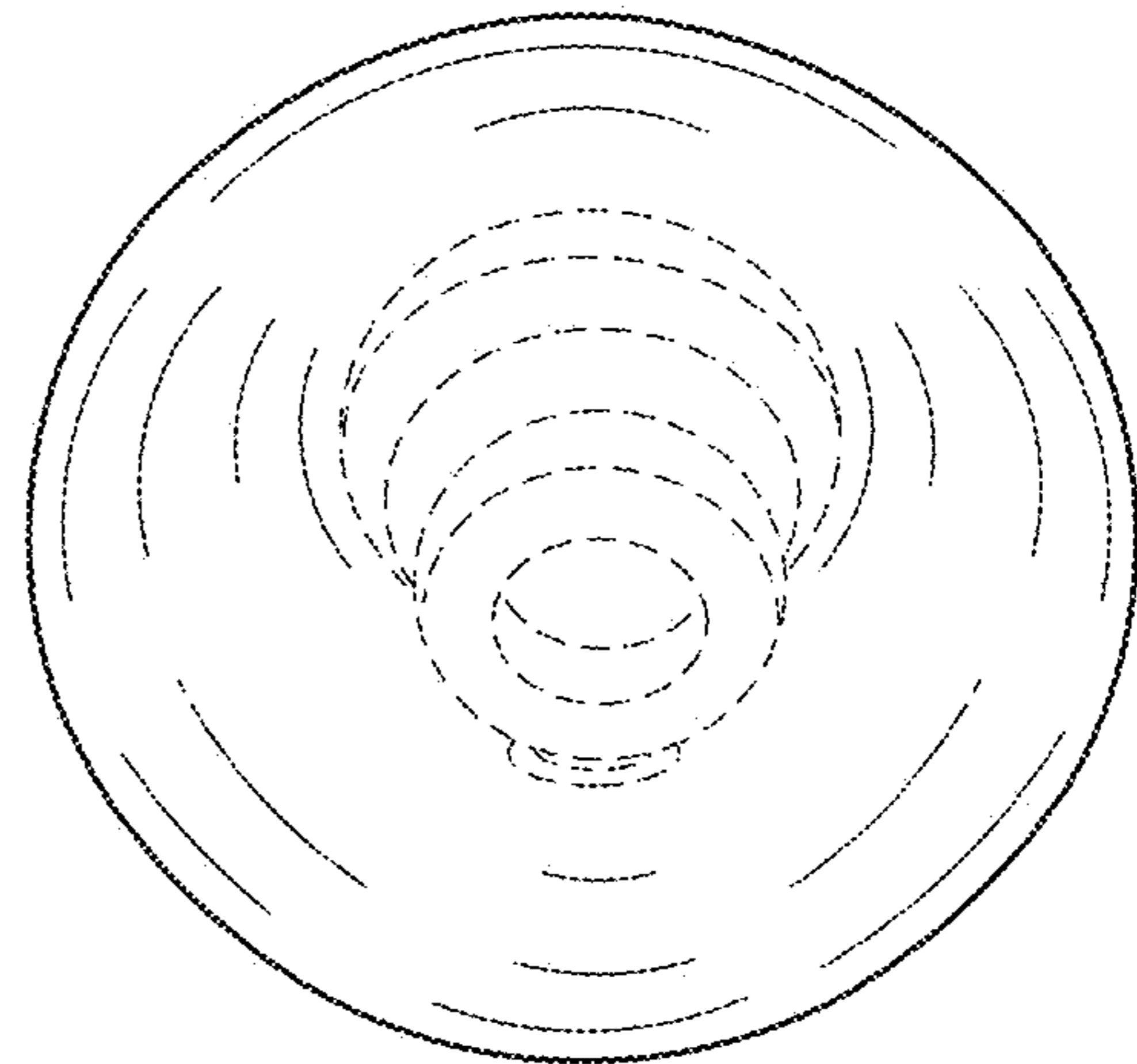

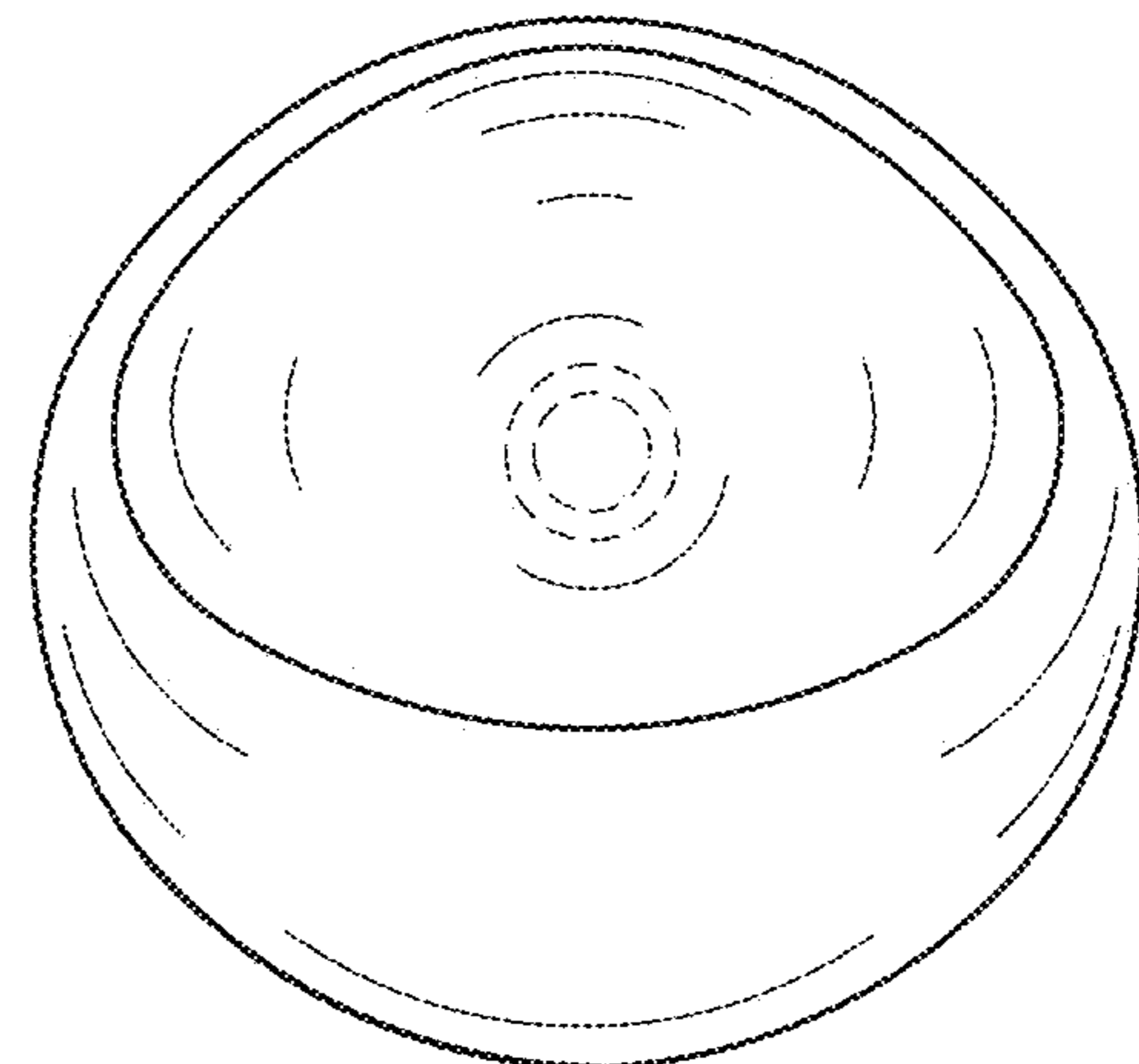

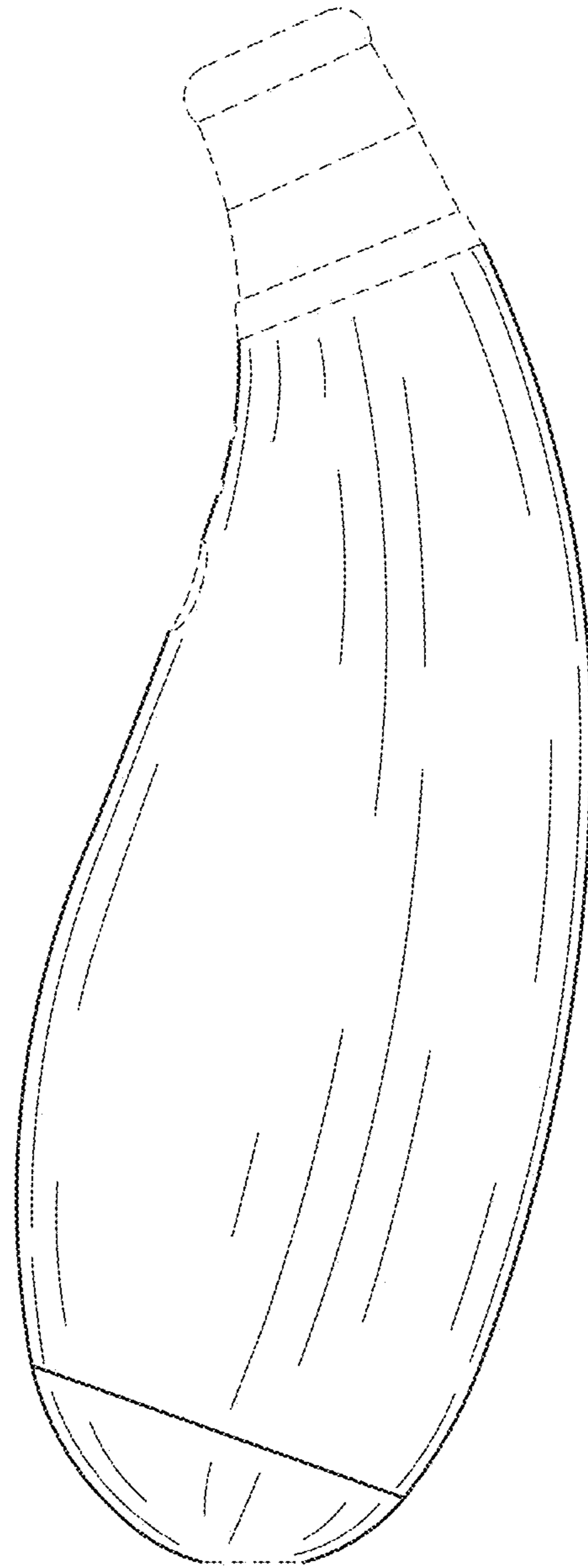
