(57) **CLAIM**

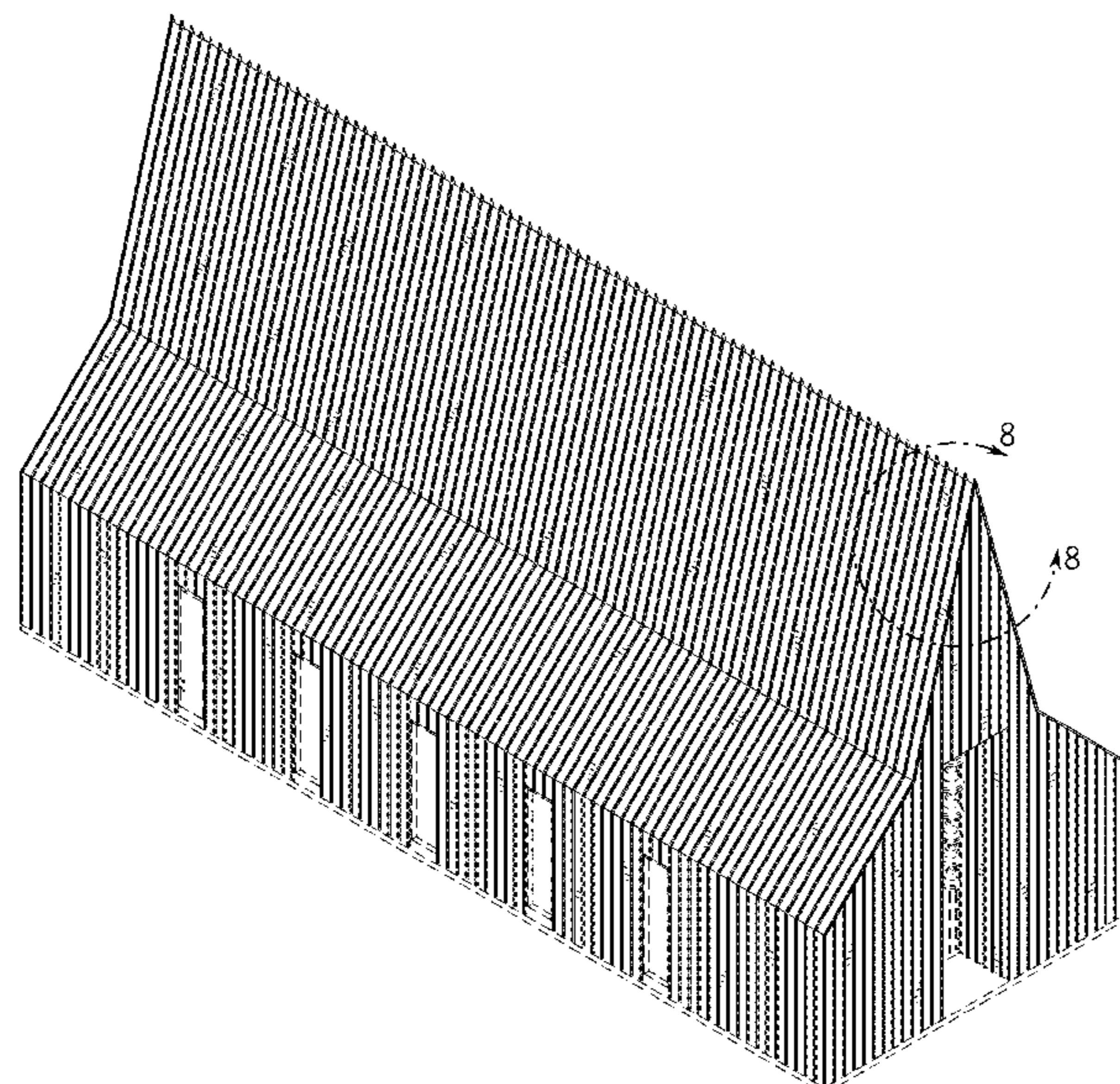
I claim the ornamental design for a building structure, as shown and described.

**DESCRIPTION**

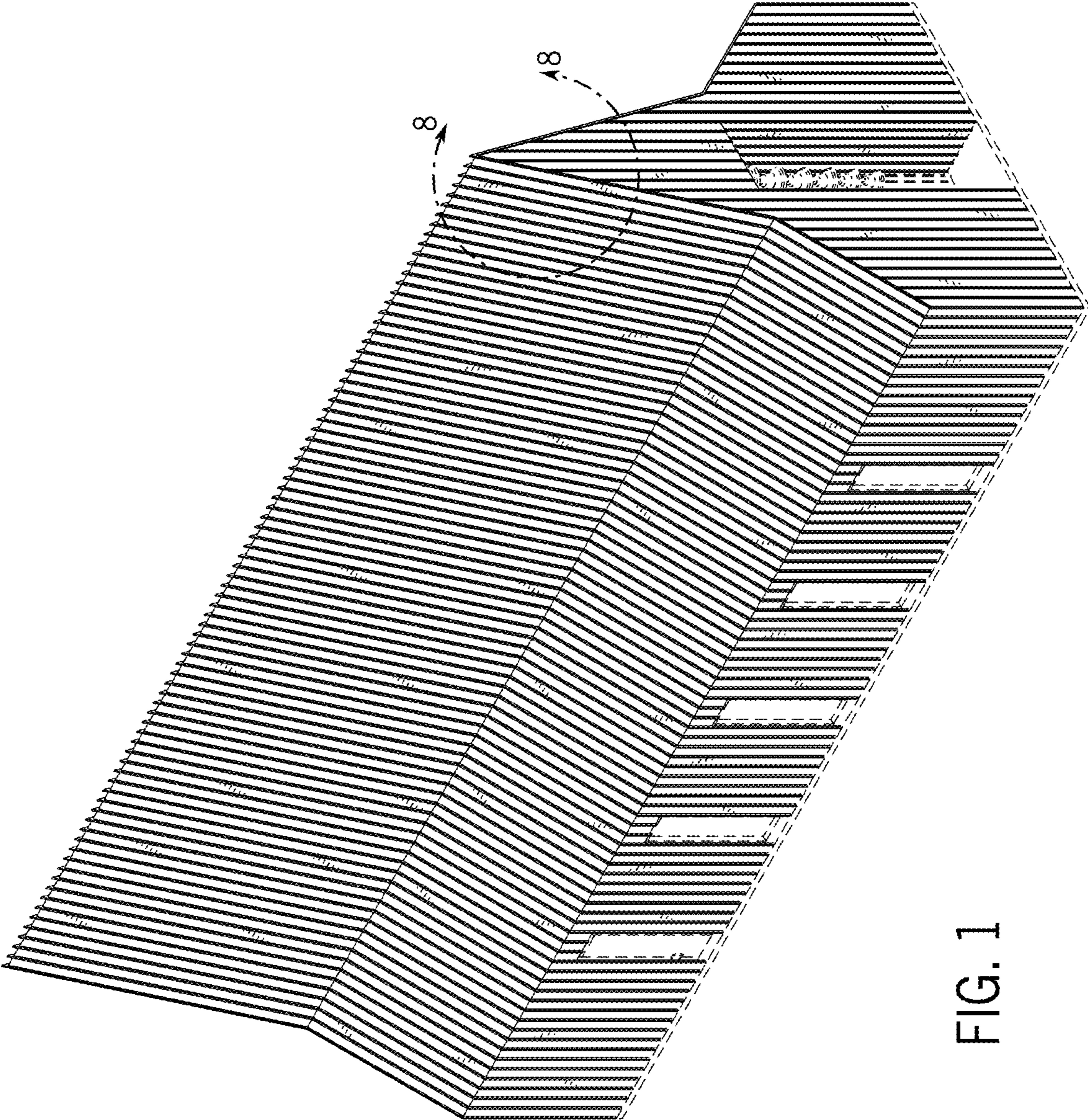

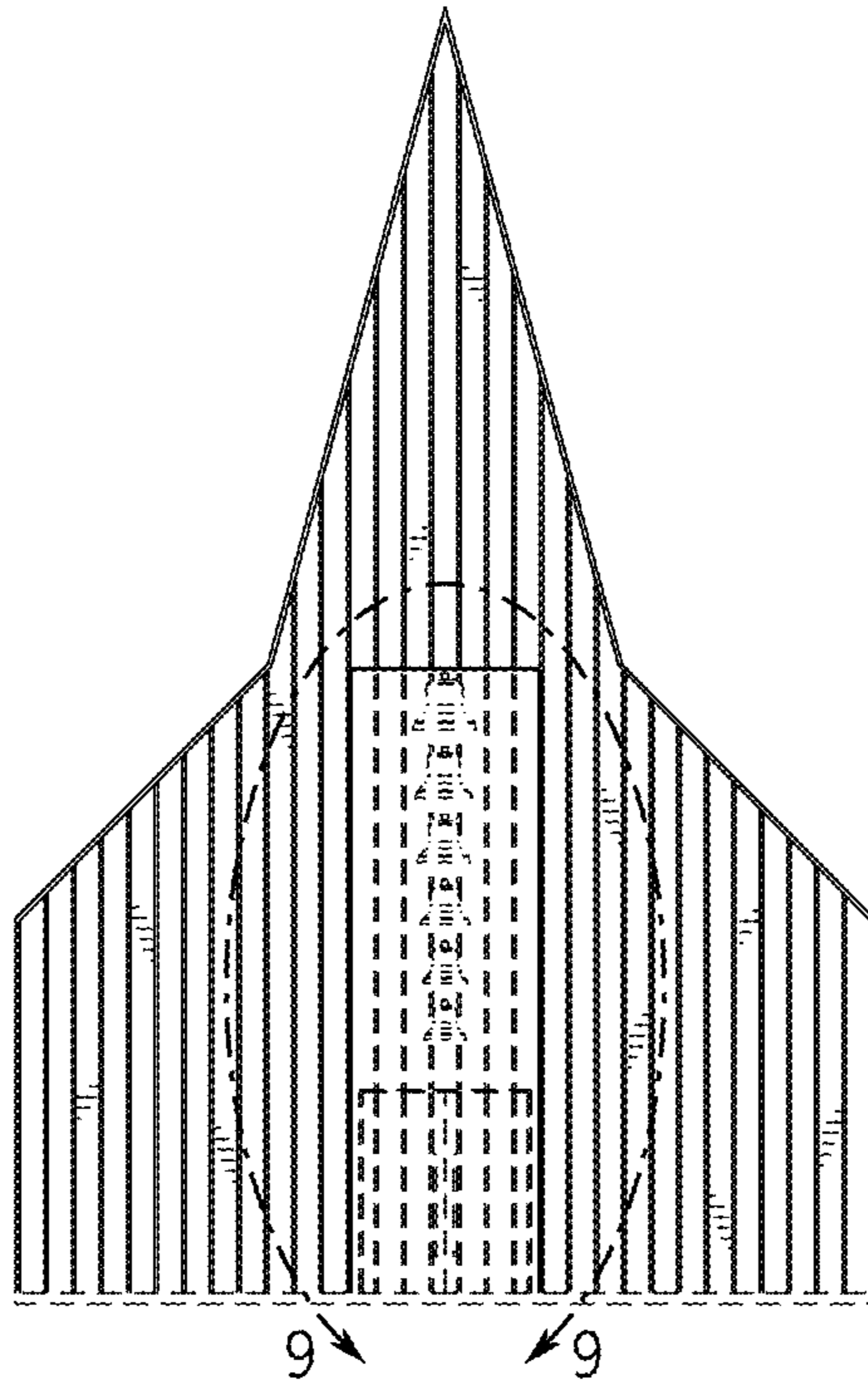

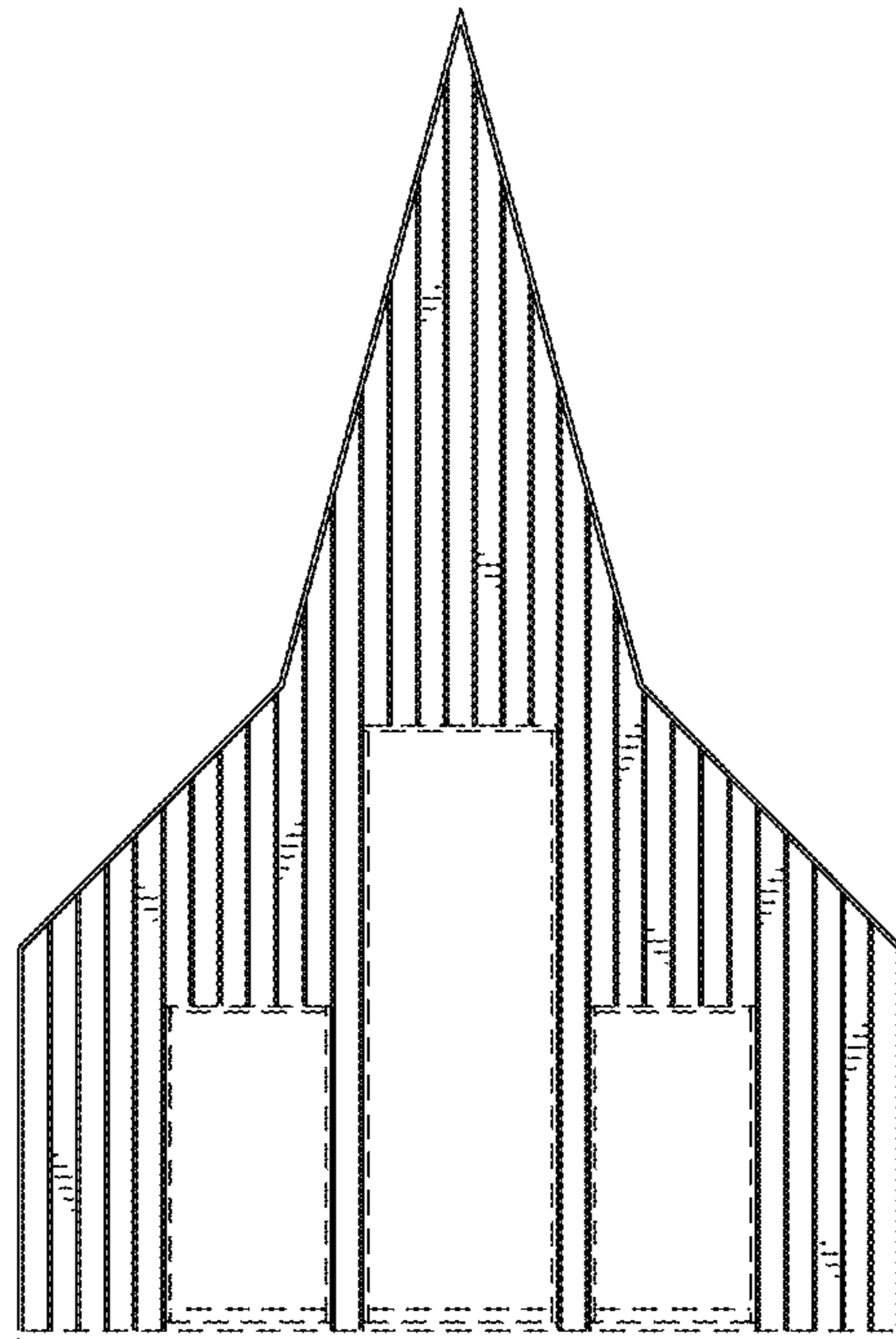

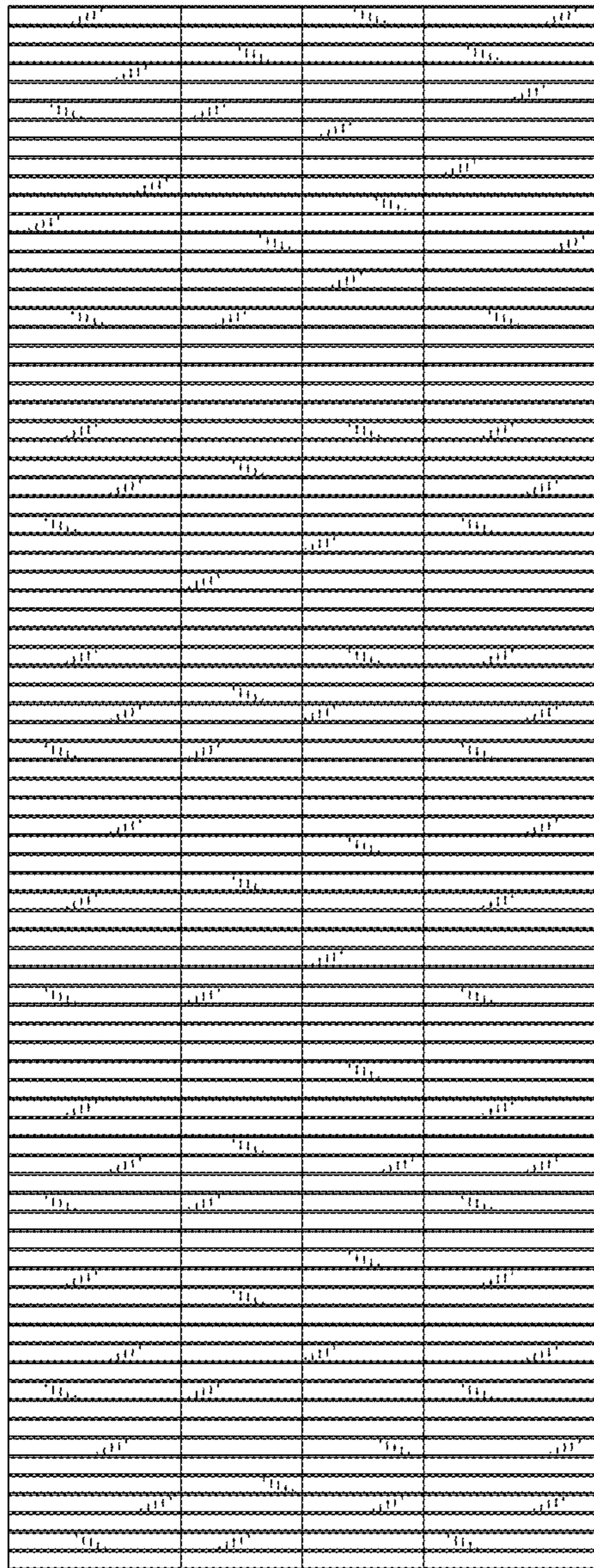

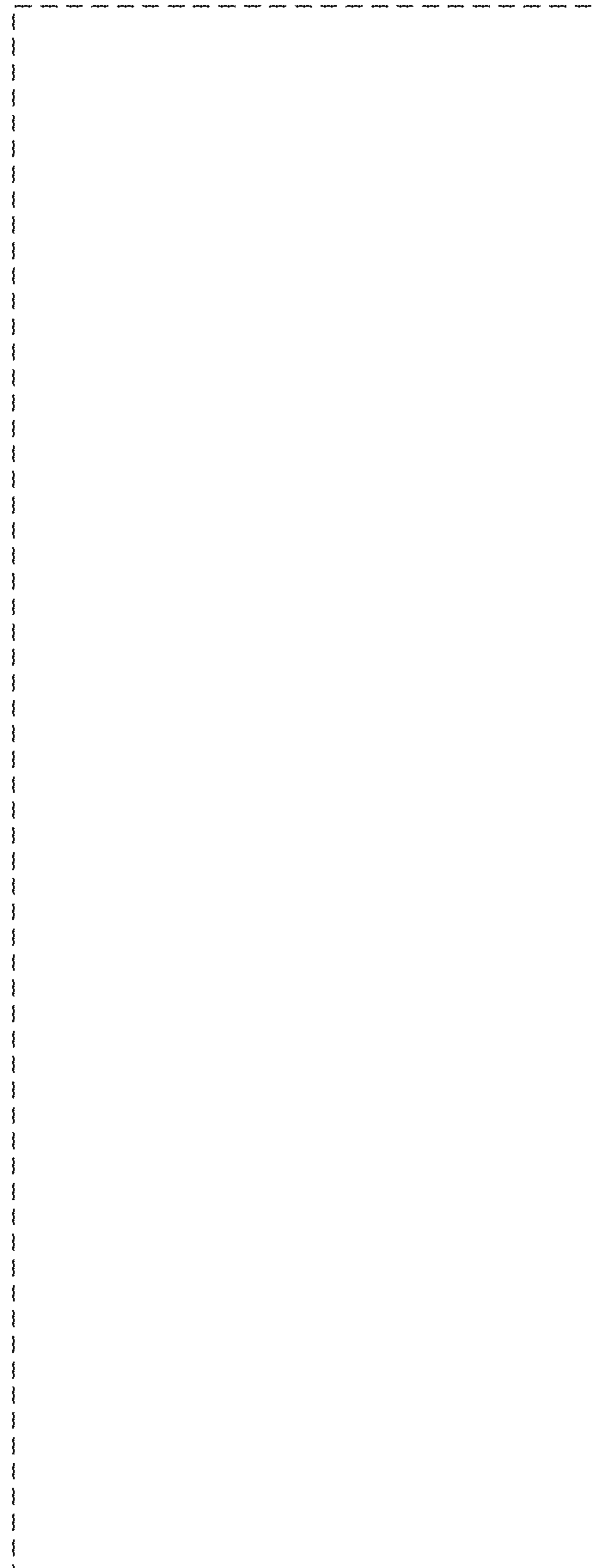

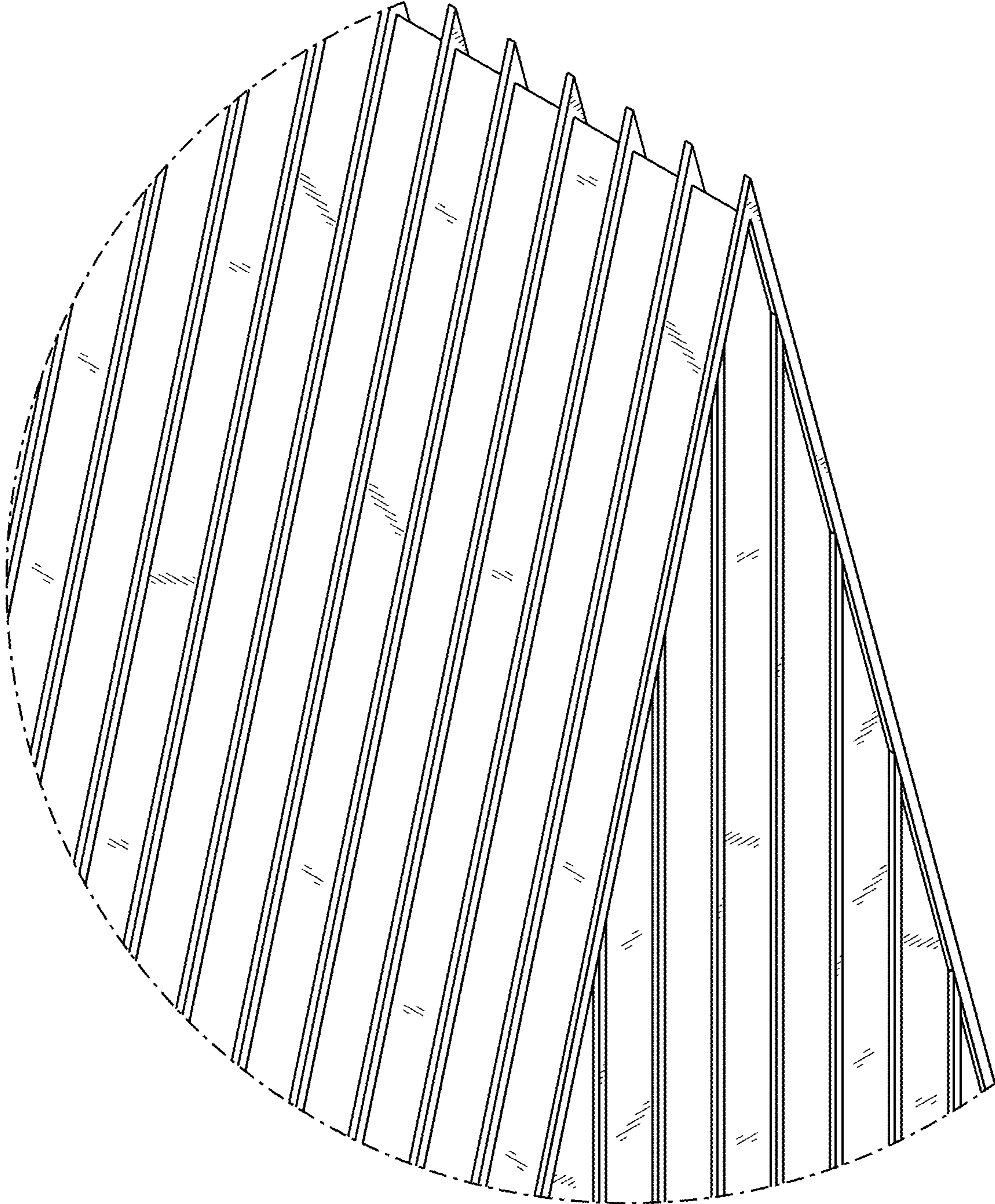

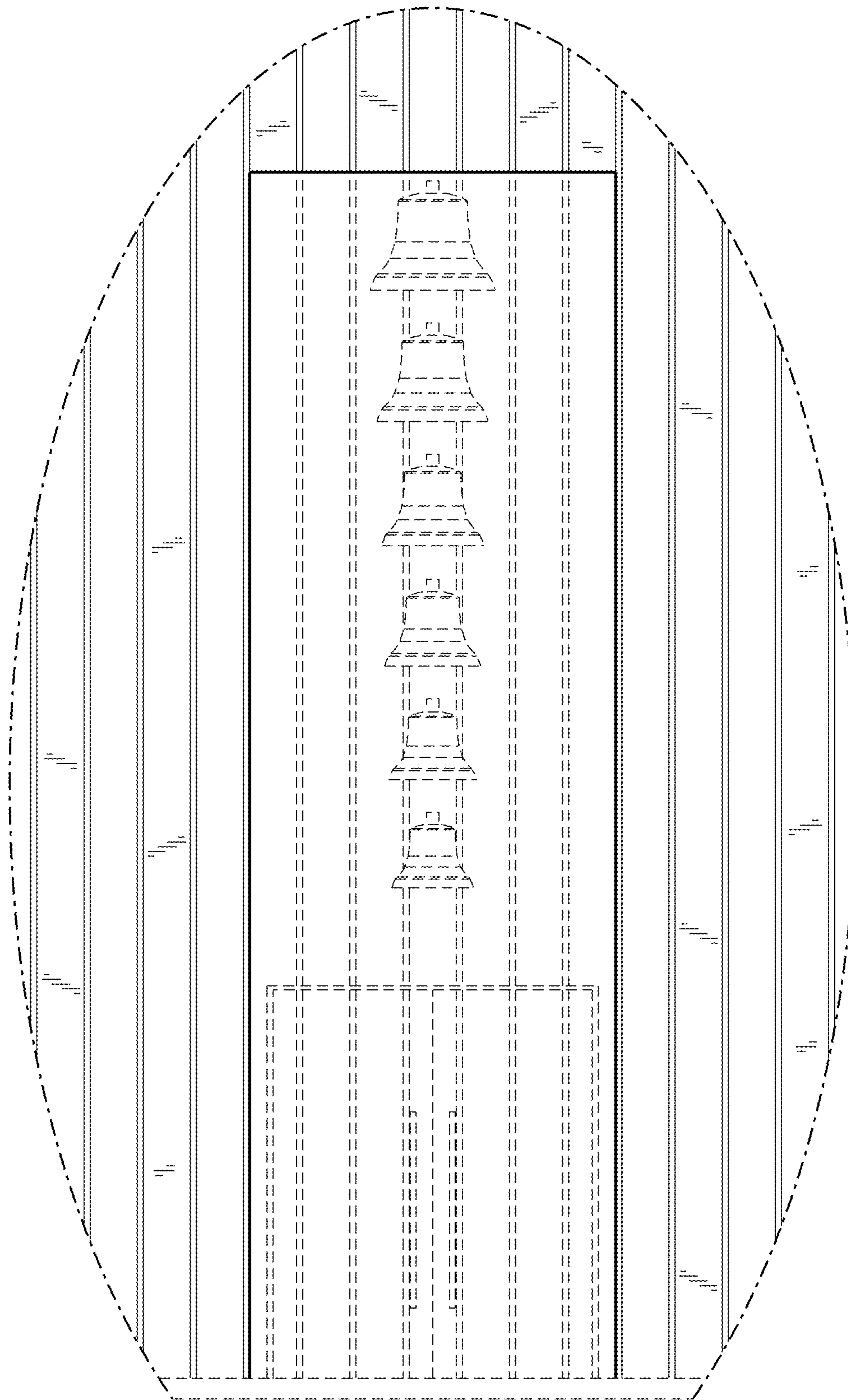
