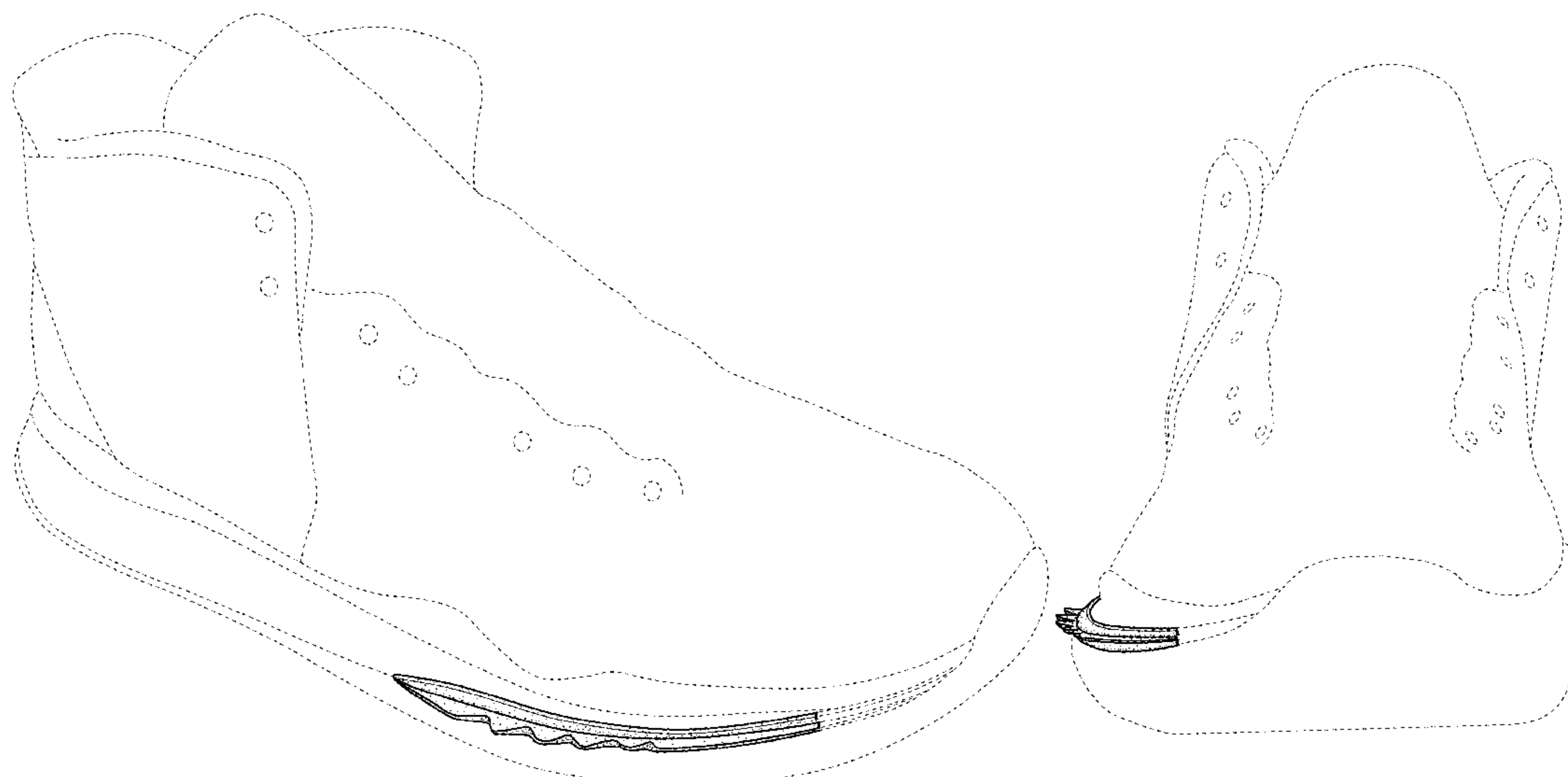
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe, showing my new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a front view thereof; and,
FIG. 4 is a top view thereof.
The bold broken lines adjacent to the shaded area represent unclaimed boundaries of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

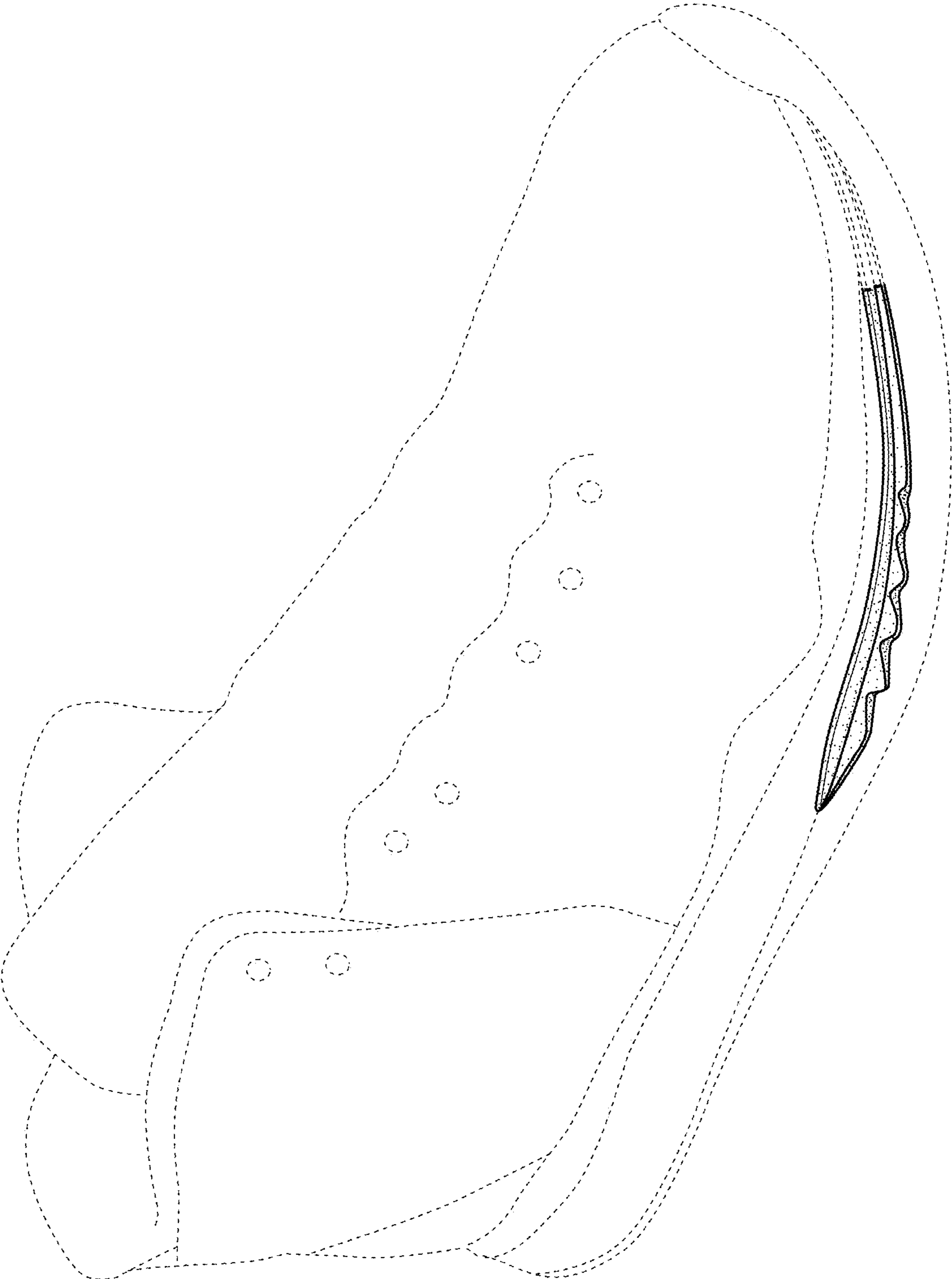

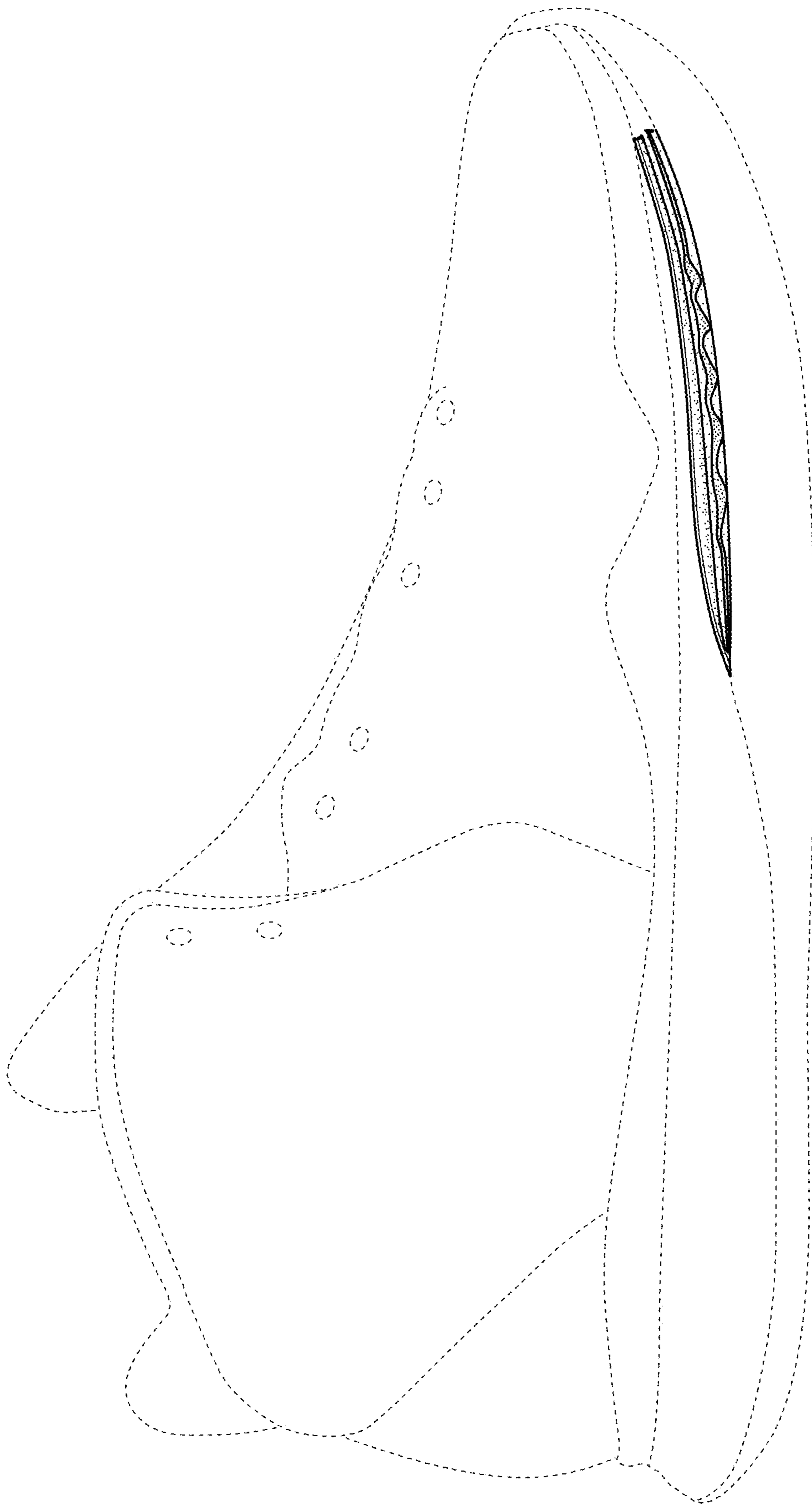

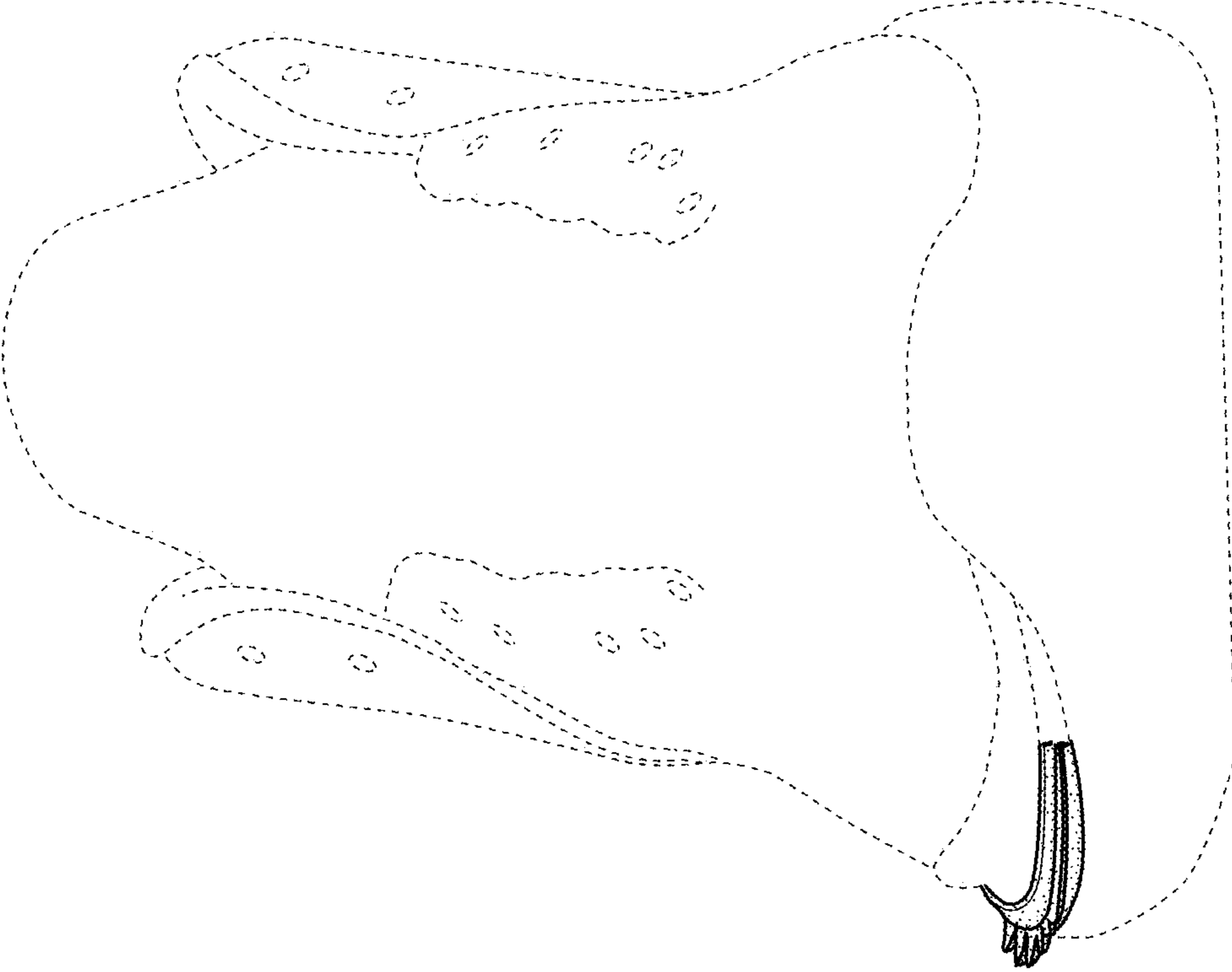

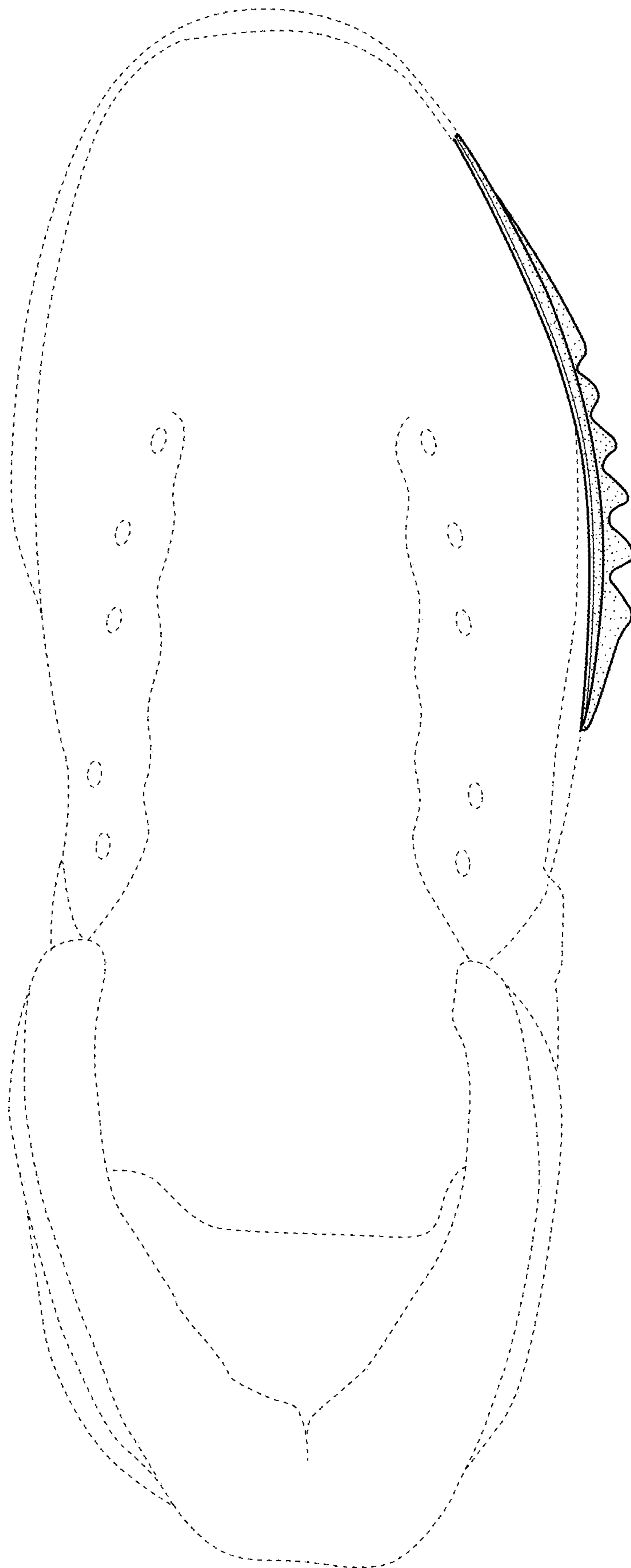
