FIG. 1 is a front perspective view of a bed, showing my new design;

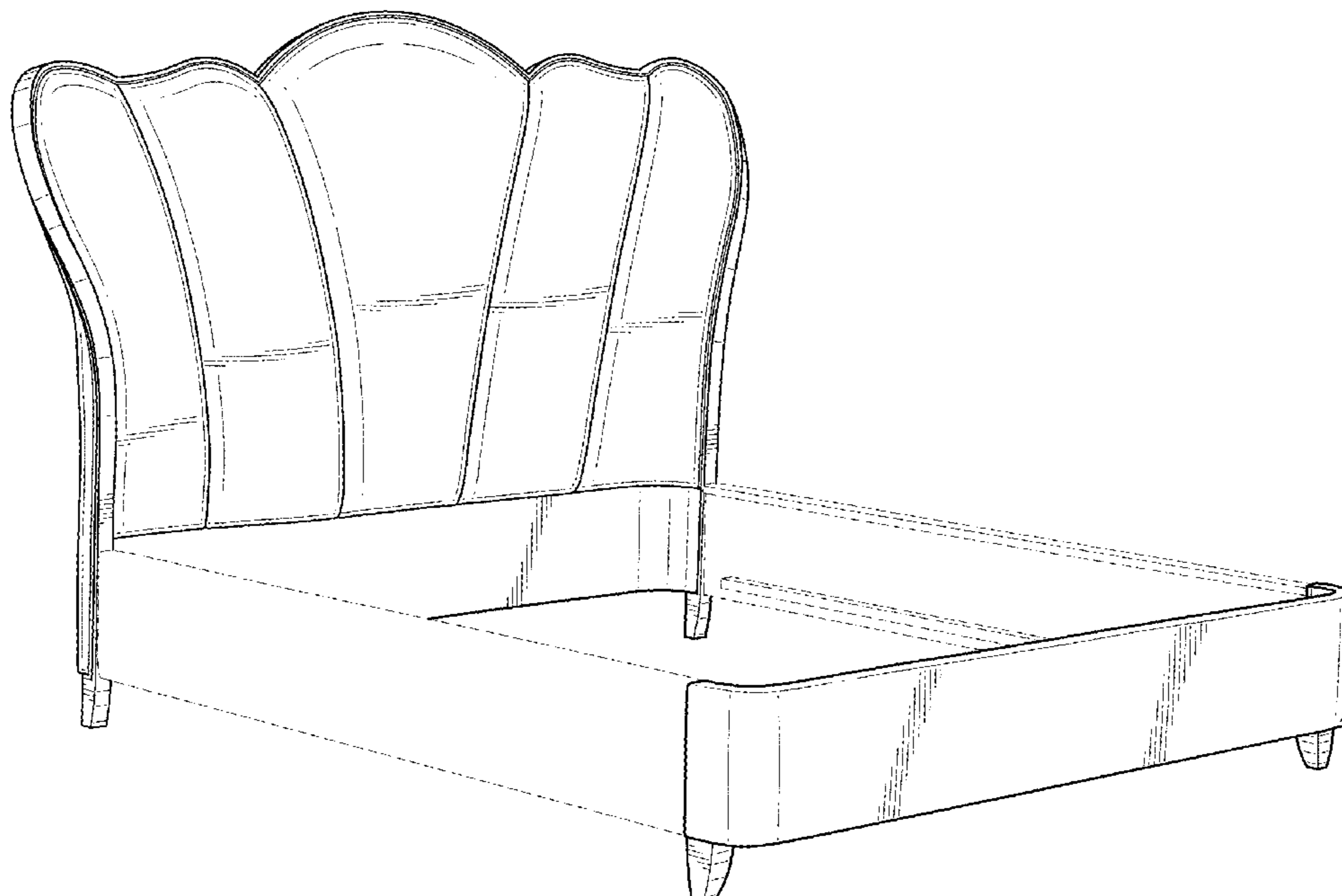
FIG. 2 is a front view thereof;

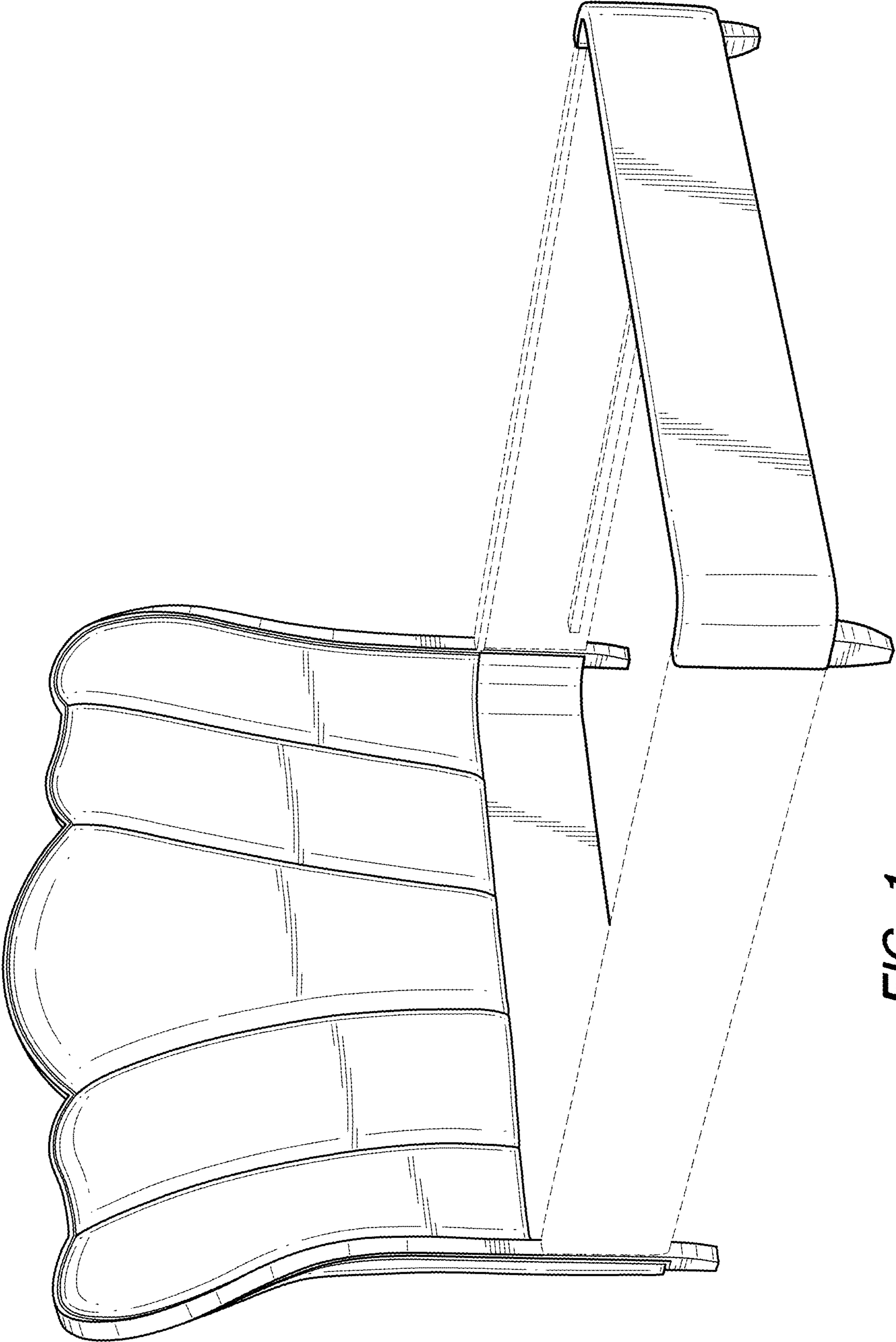
FIG. 3 is a left side view thereof, with the right side being a mirror image thereof; and,

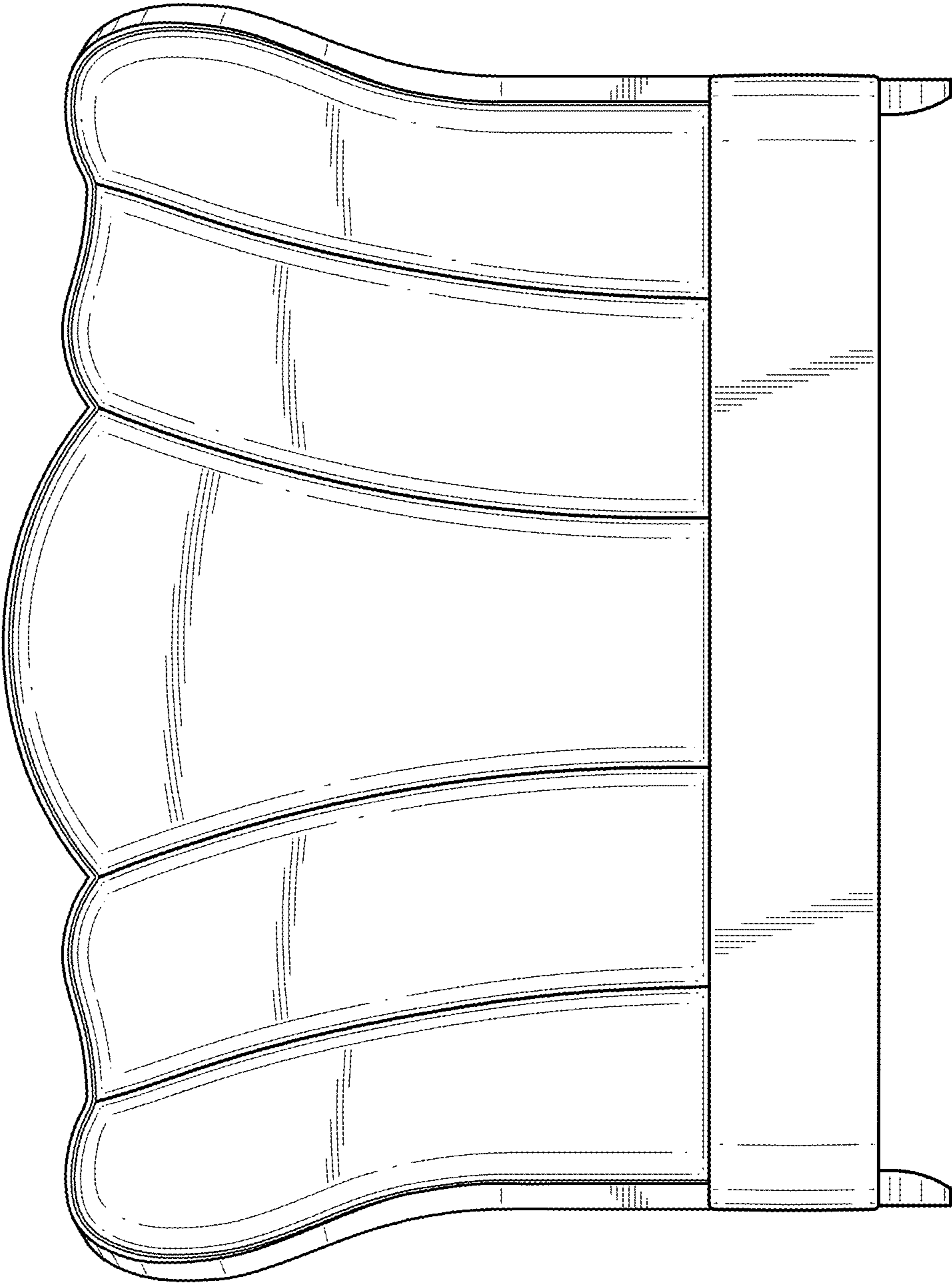

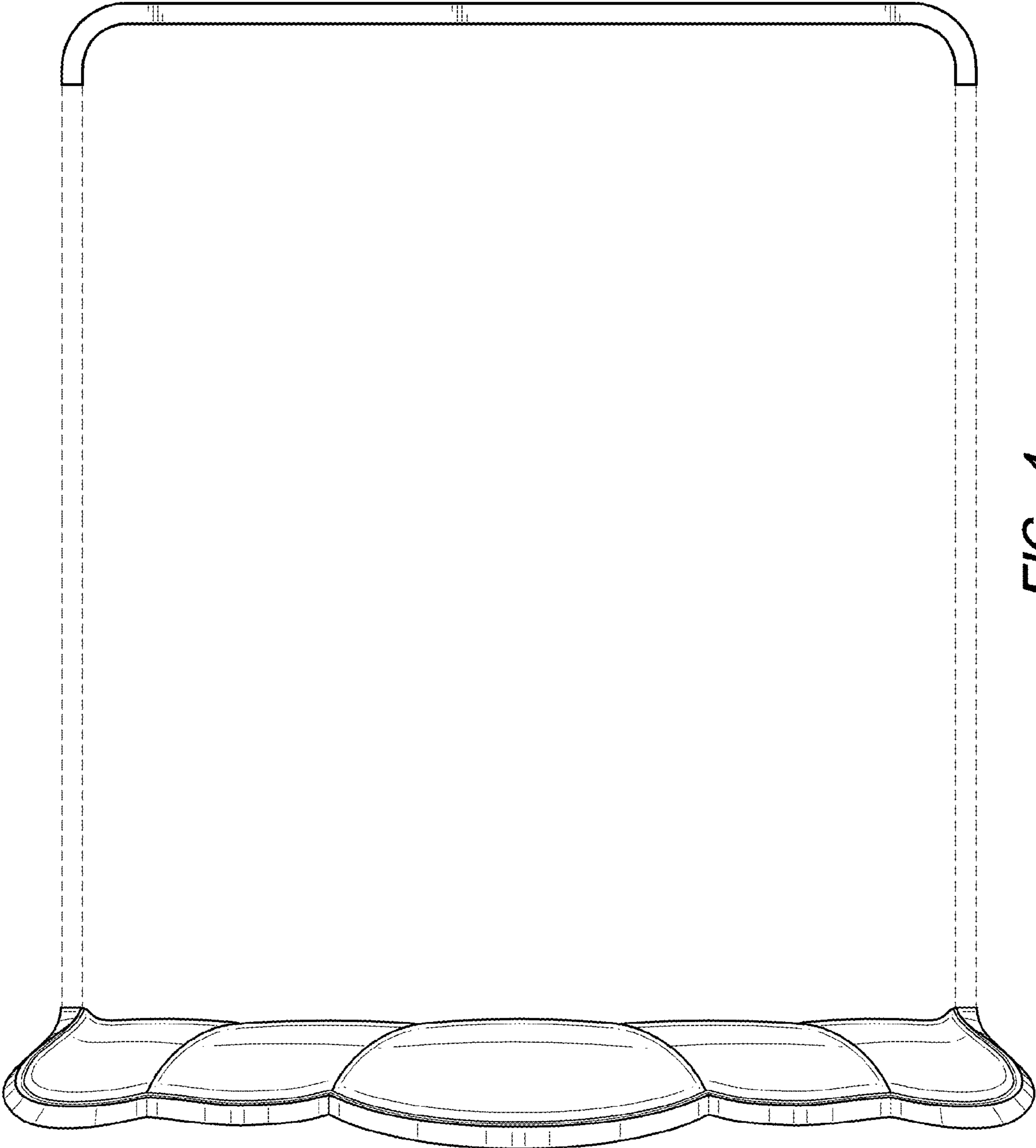
