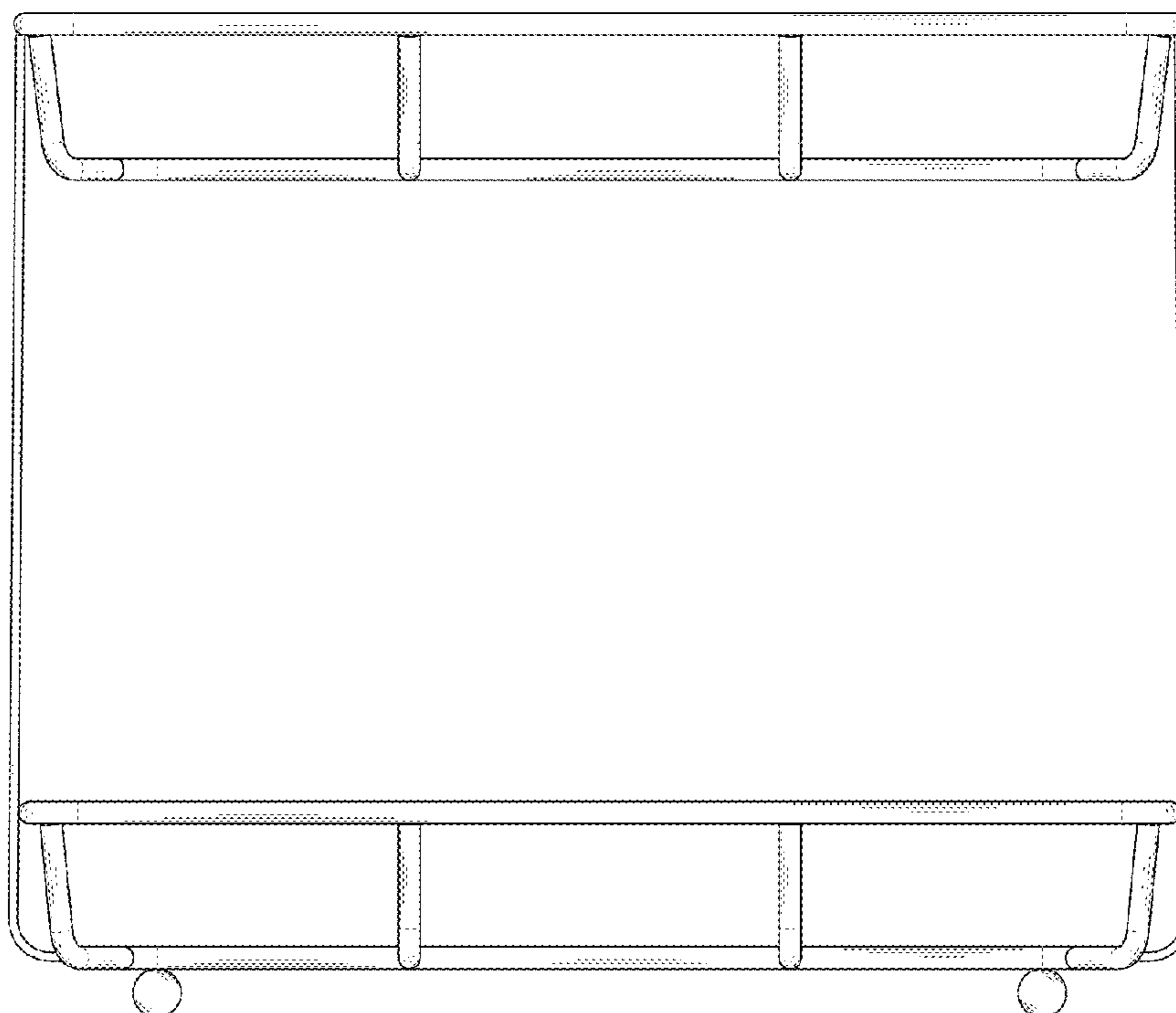

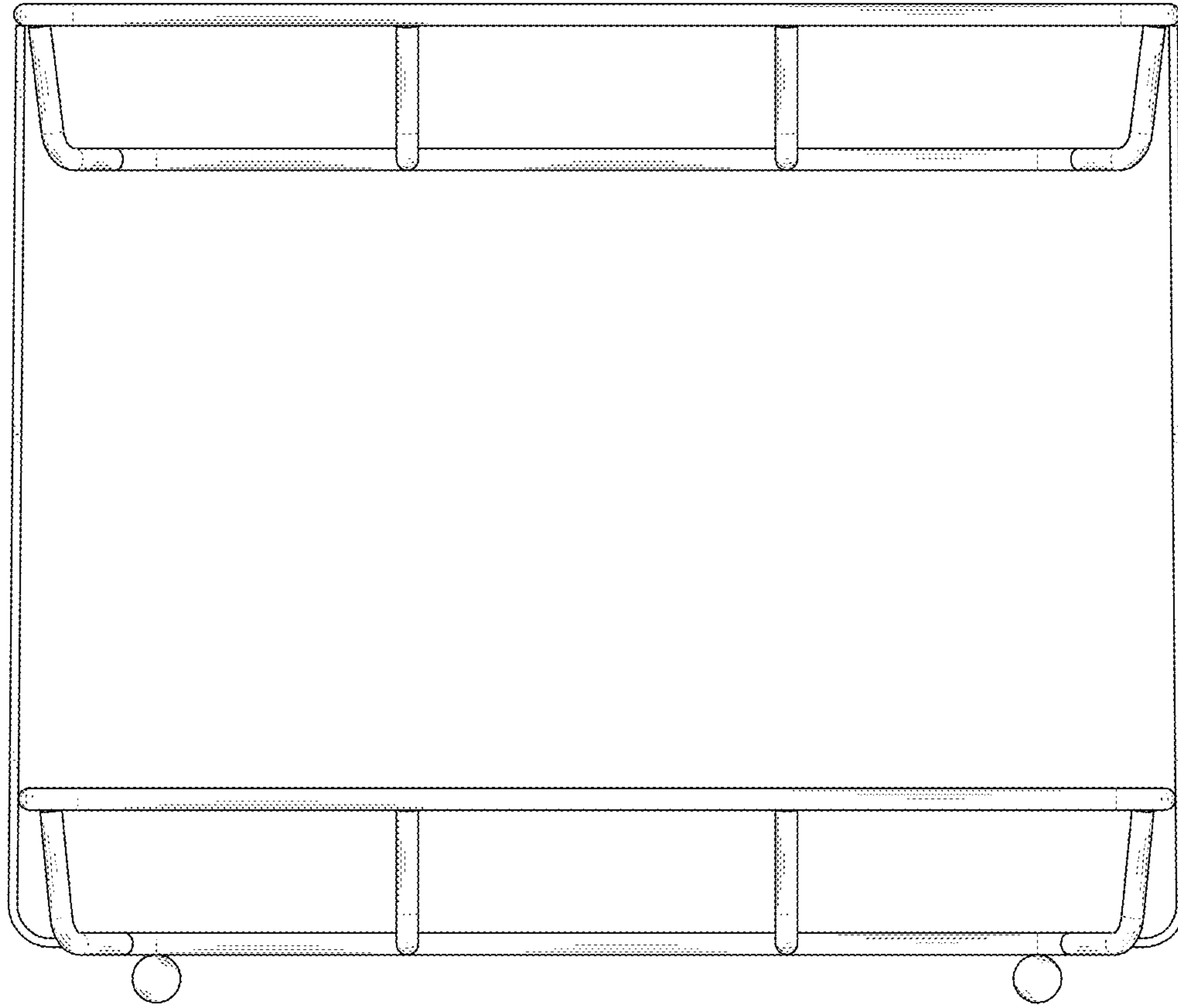
The ornamental design for a shelf, as shown and described.

**DESCRIPTION**

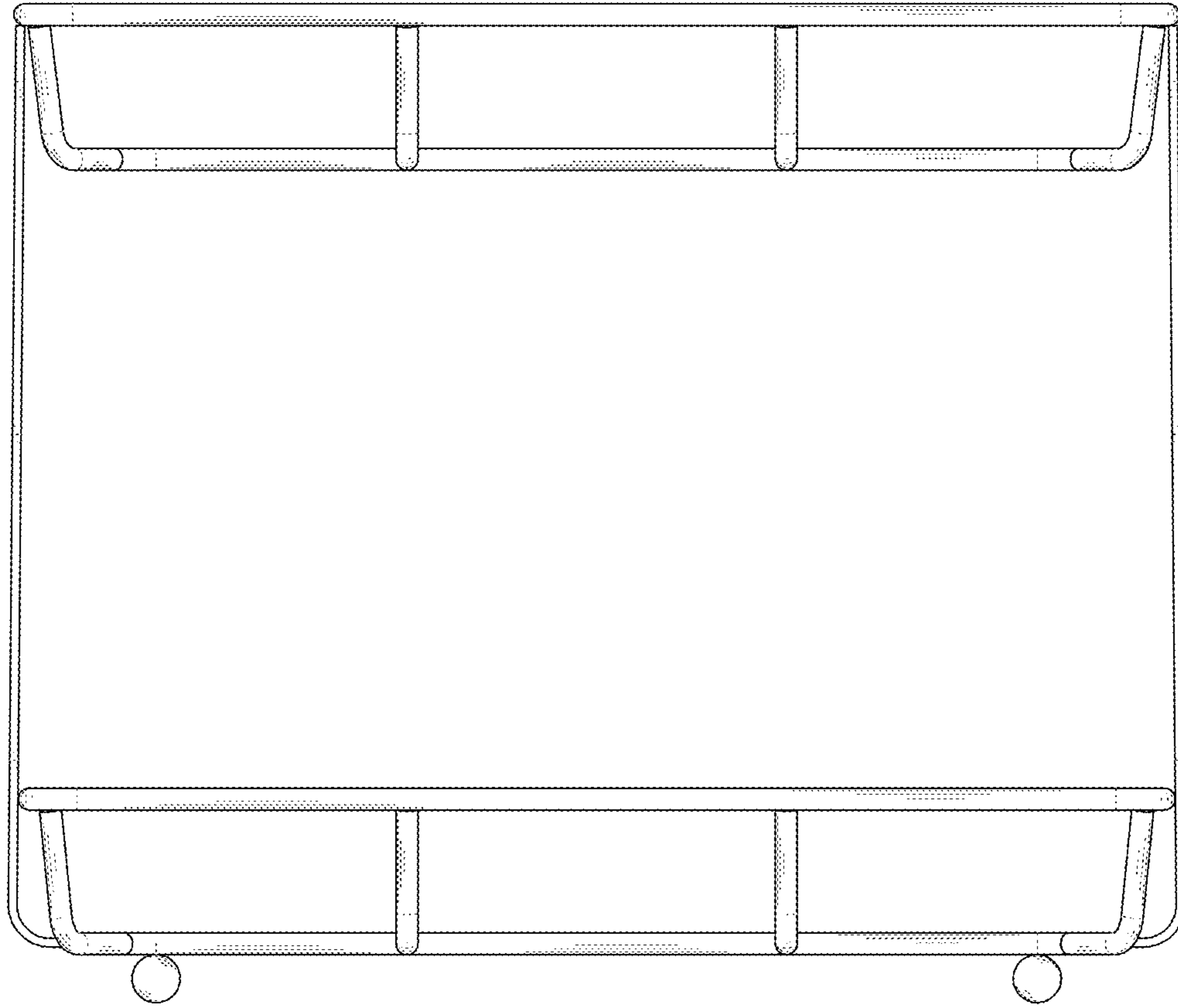
FIG. 1 is a front elevational view of a shelf showing my new design;

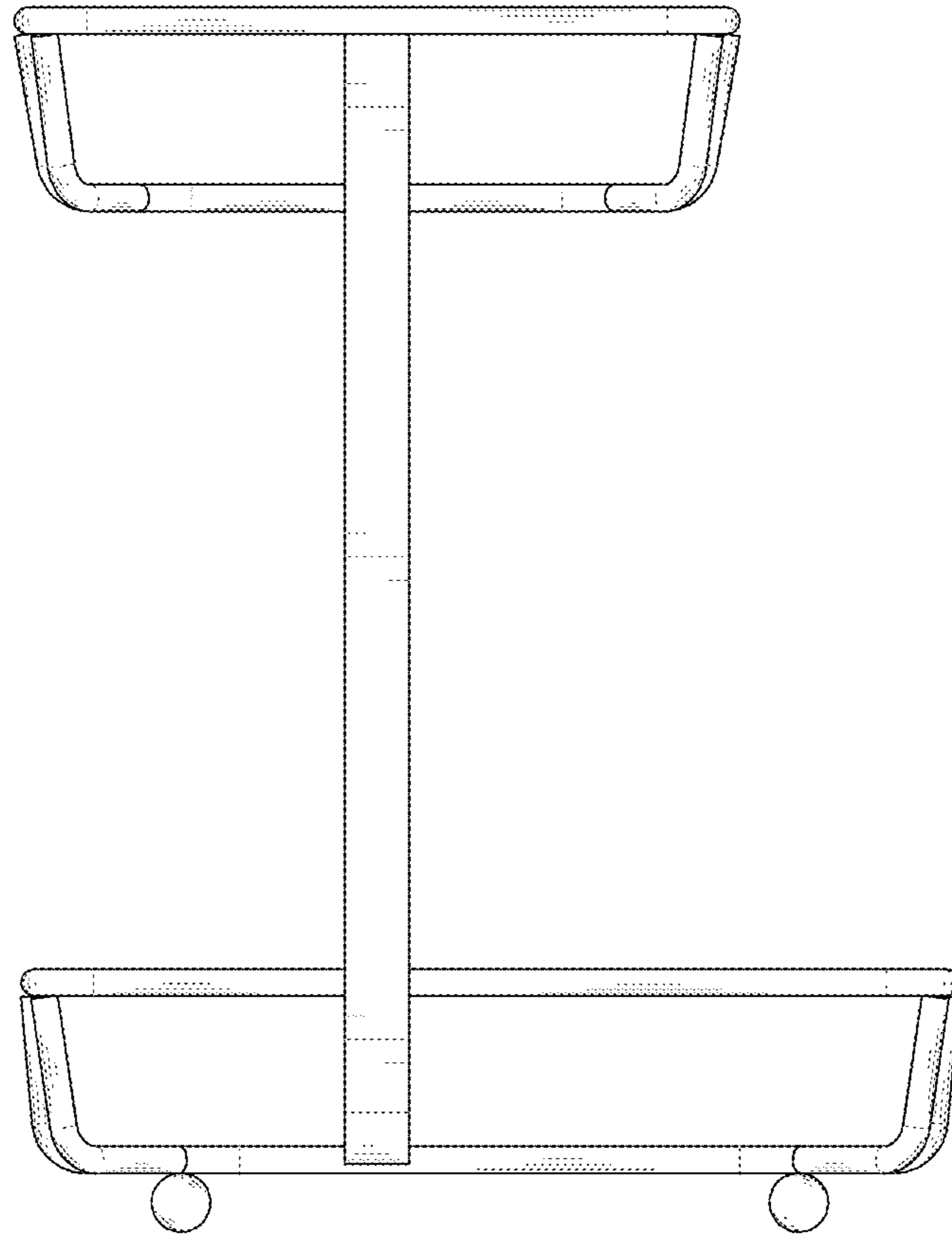




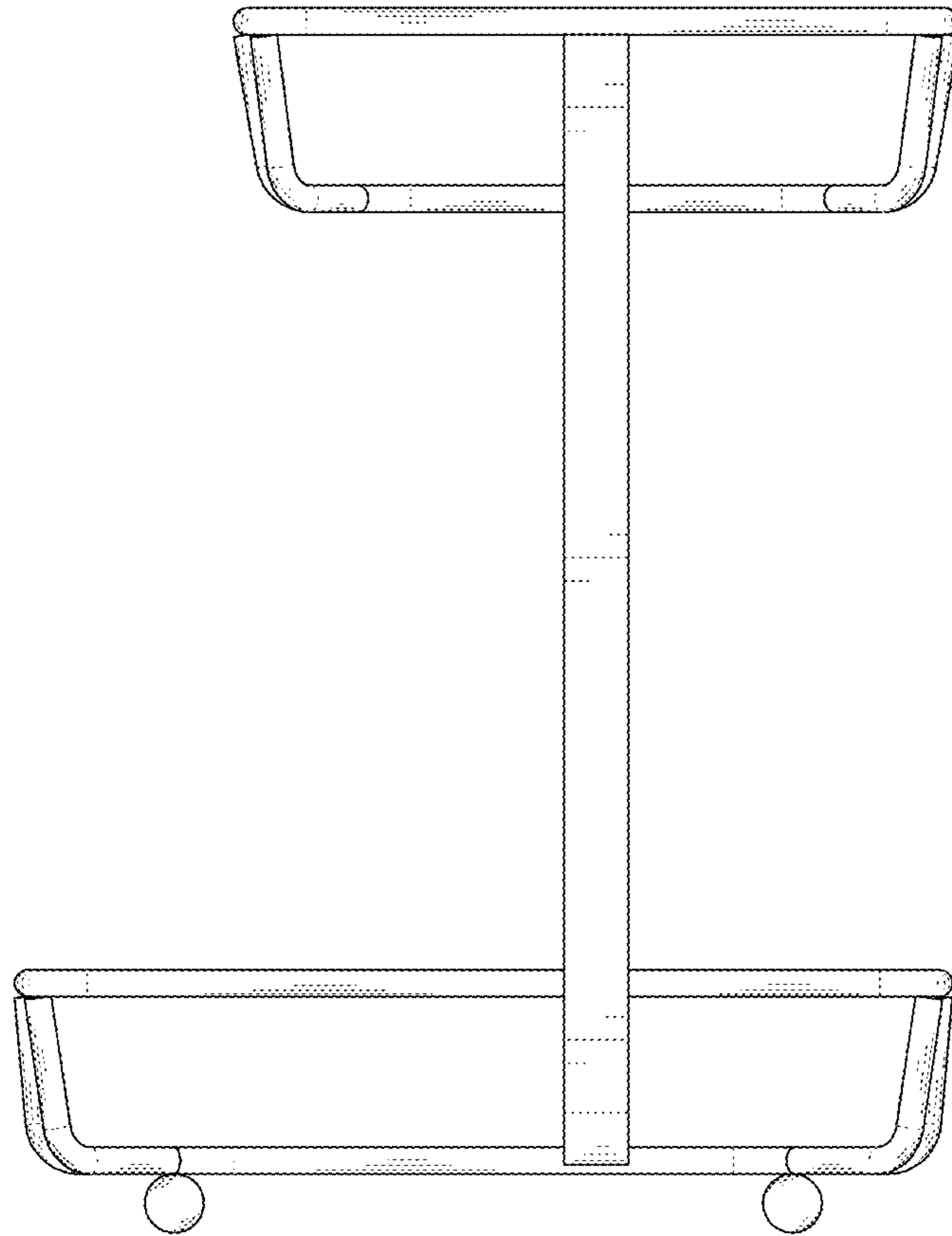

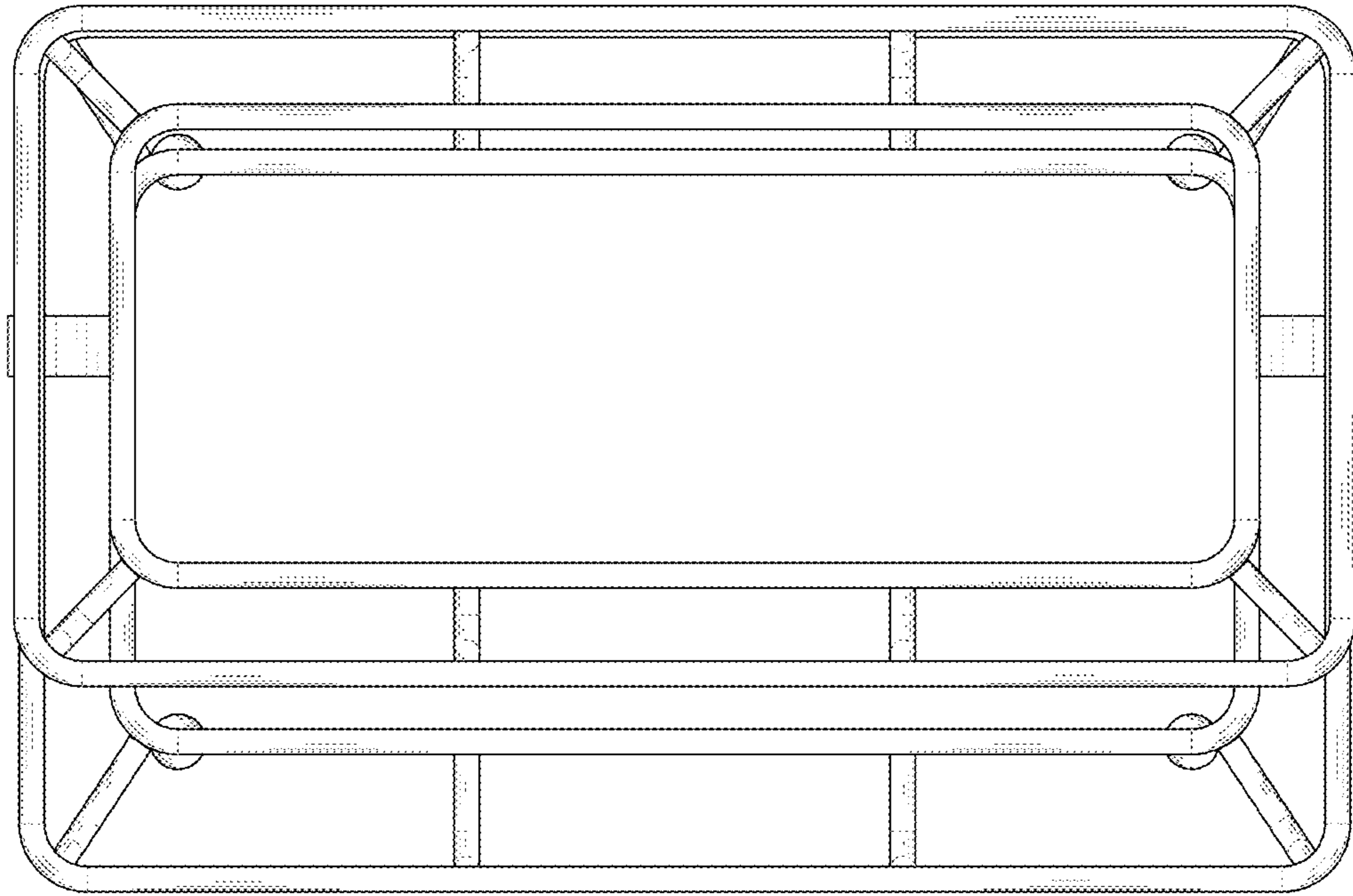

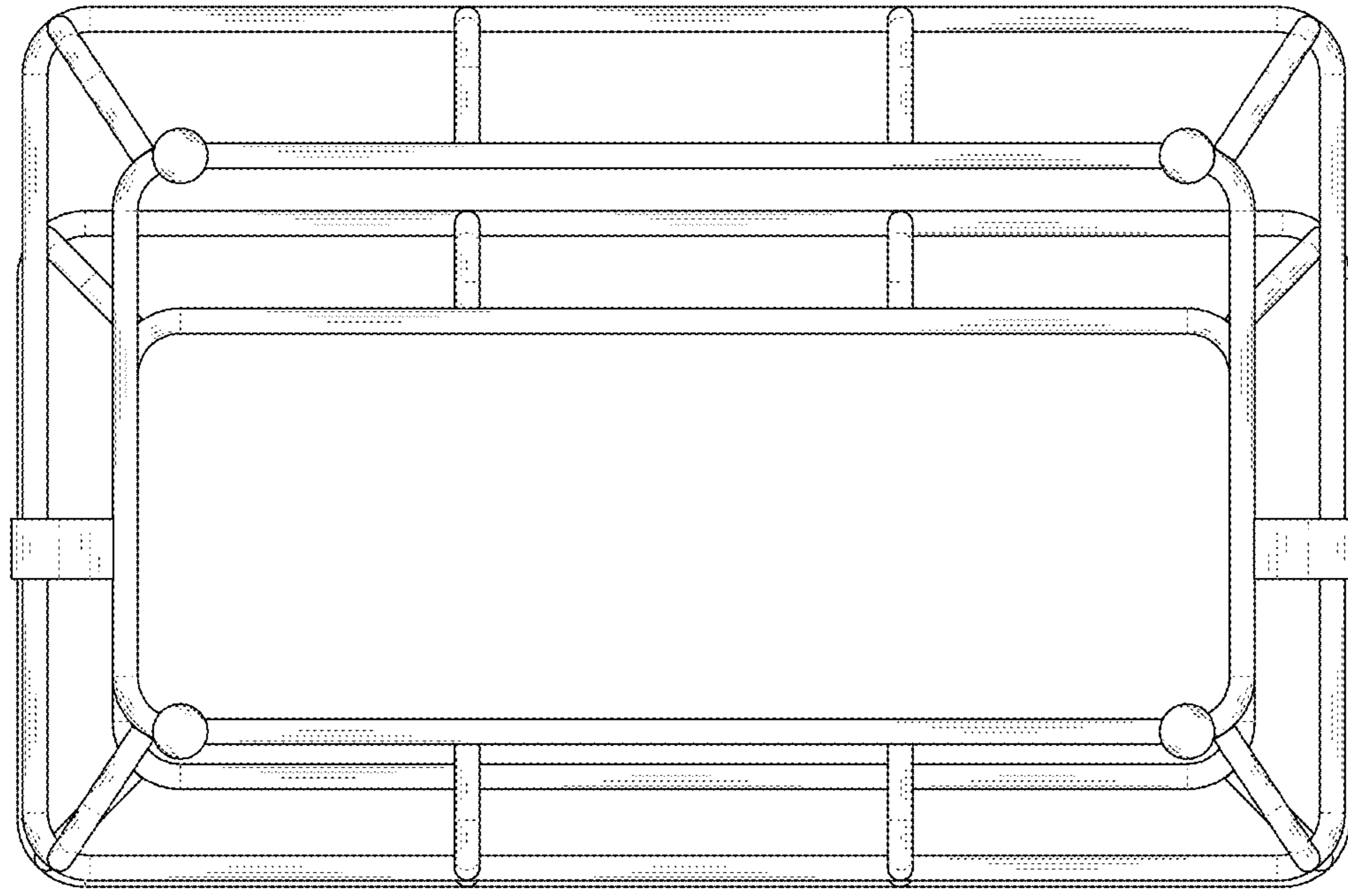
