DESCRIPTION

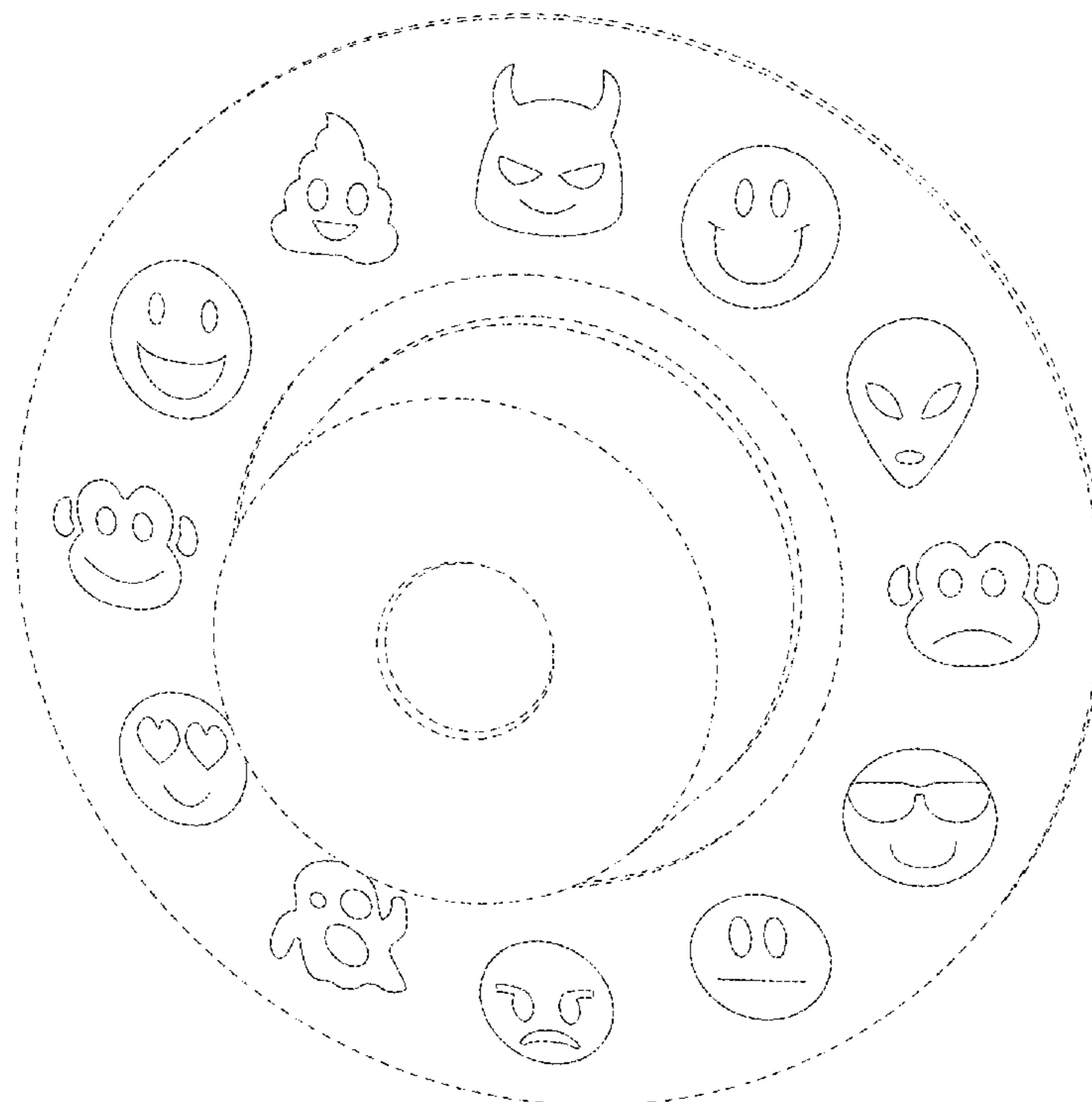
FIG. 1 is a perspective view of an image arrangement for an image lock;

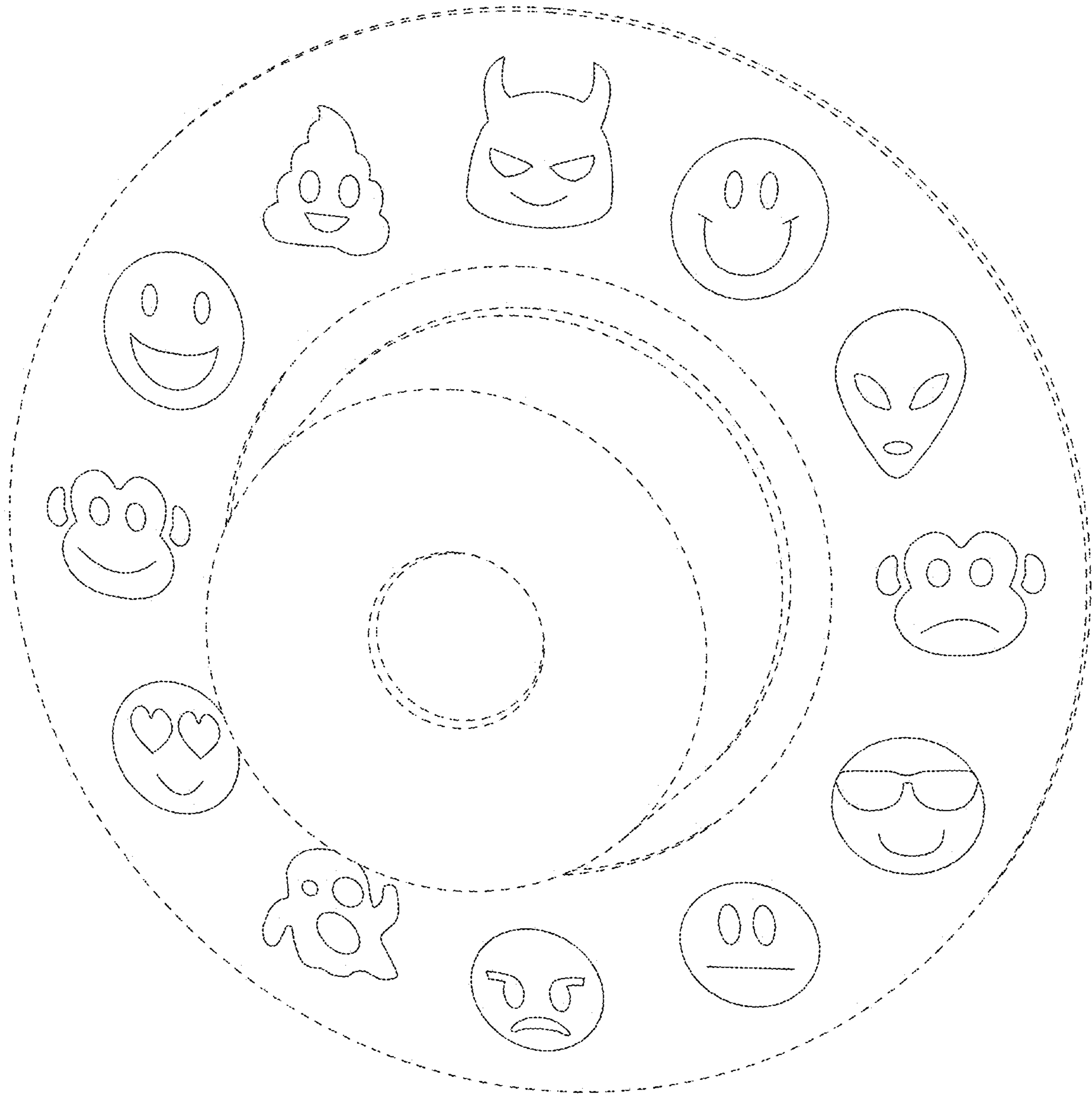

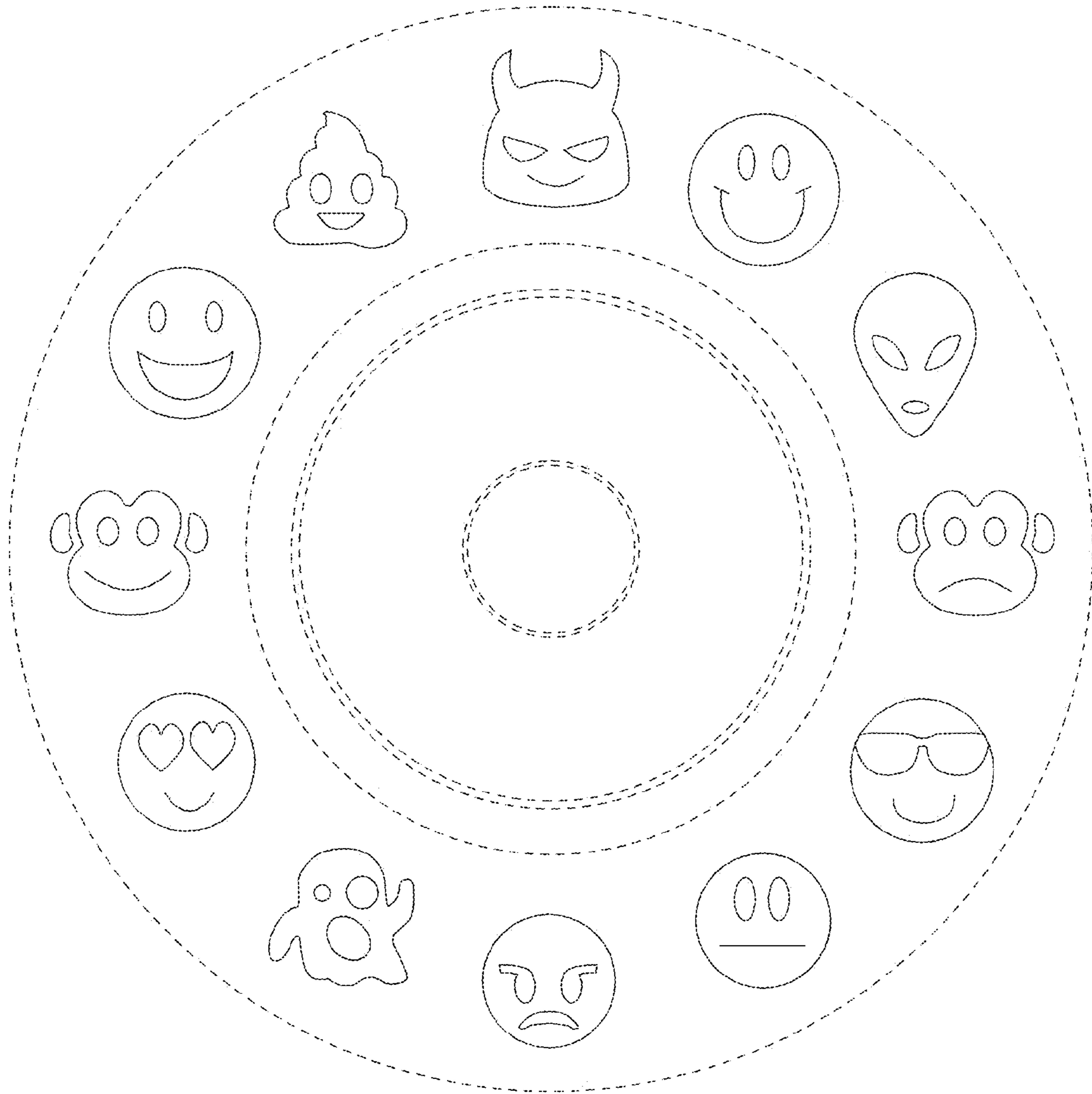

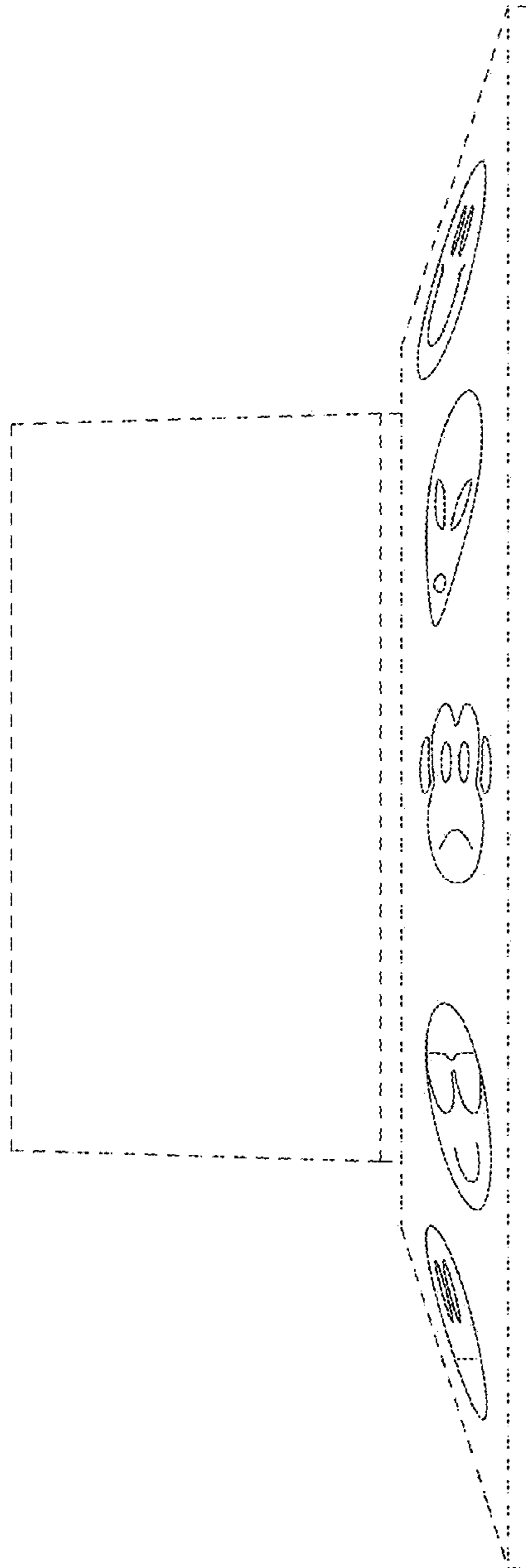

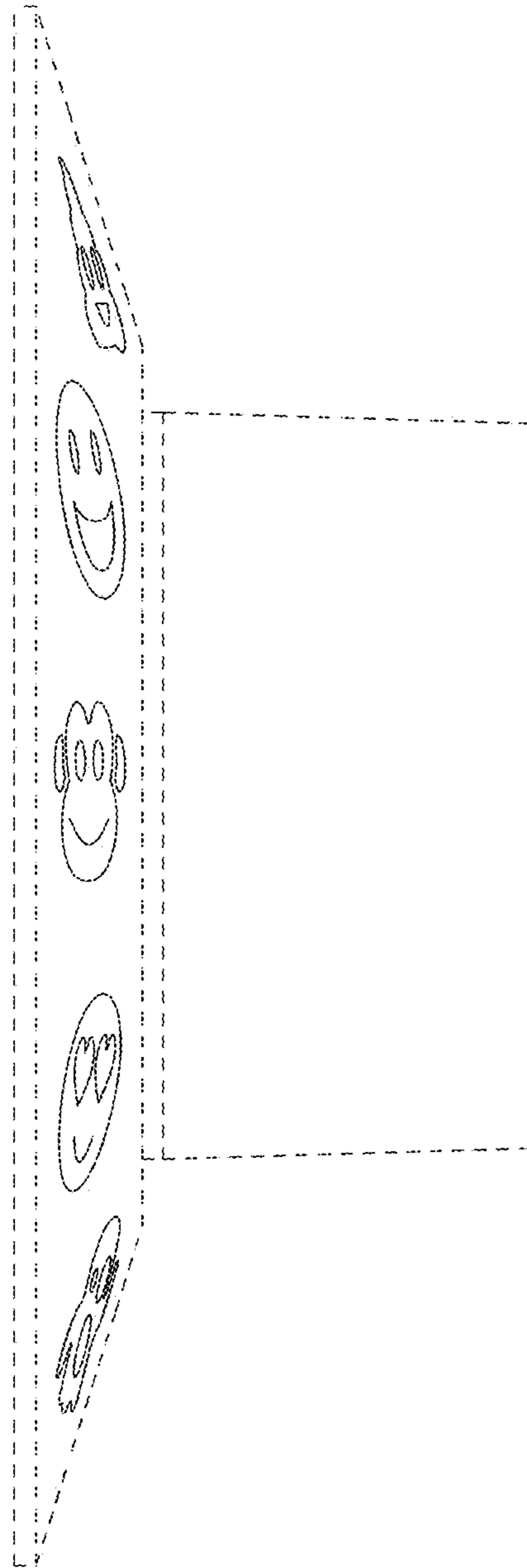

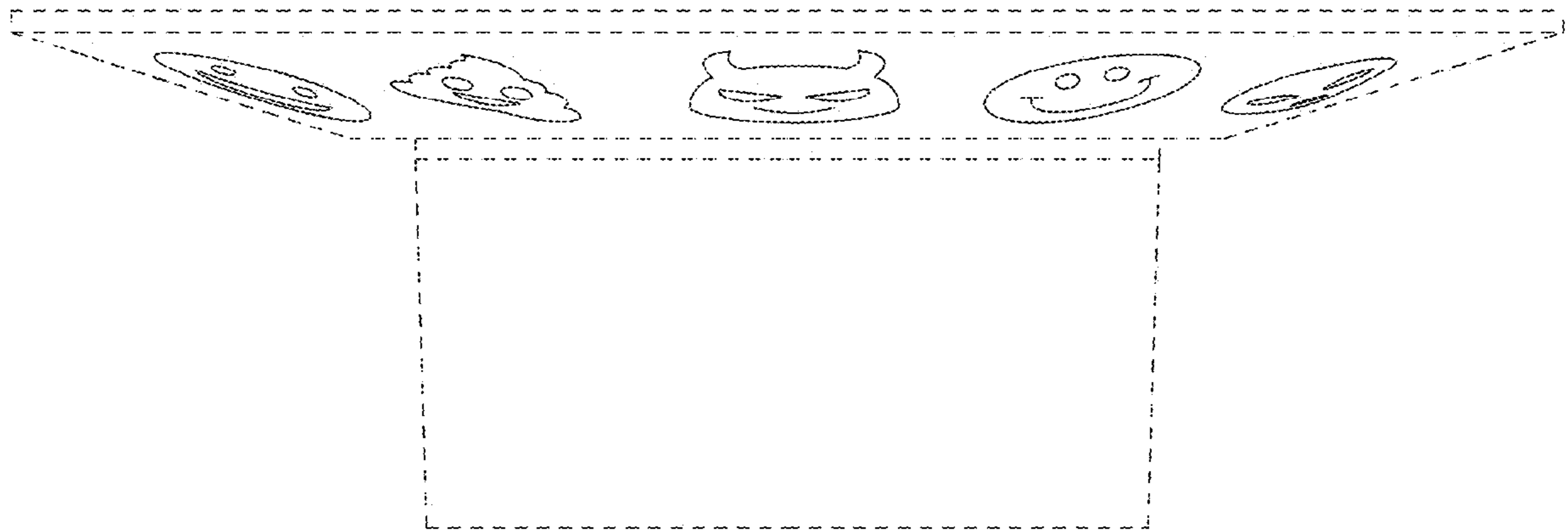

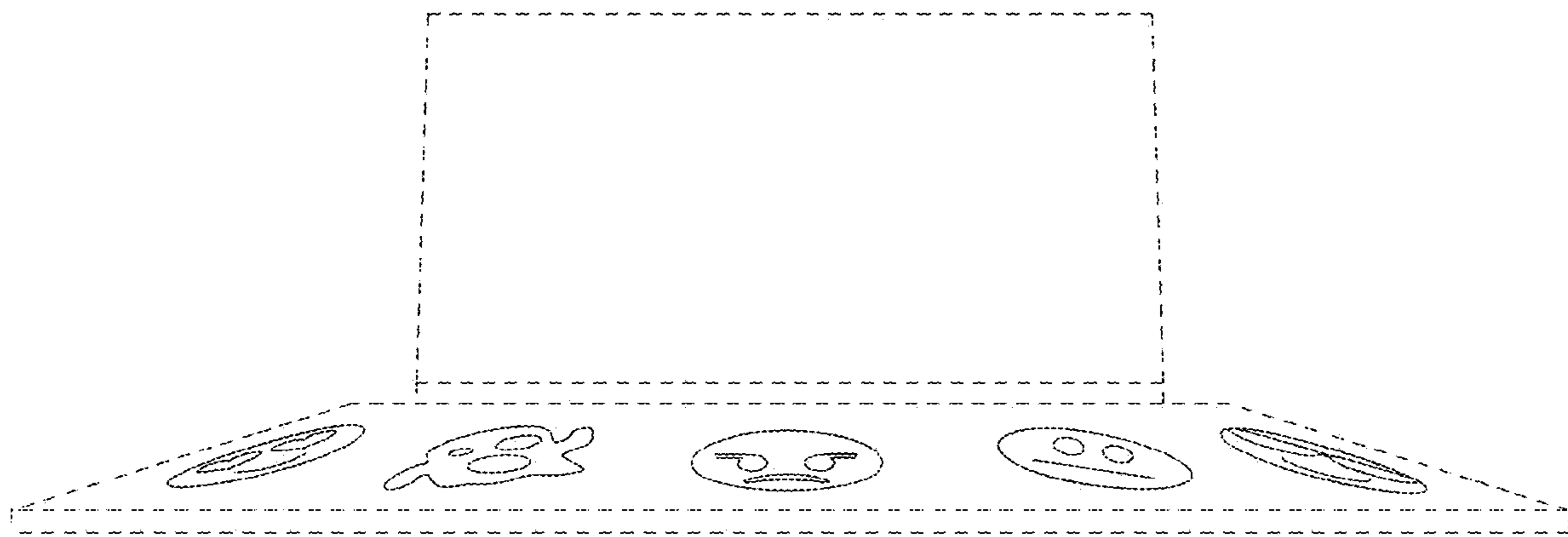
