(57) **CLAIM**

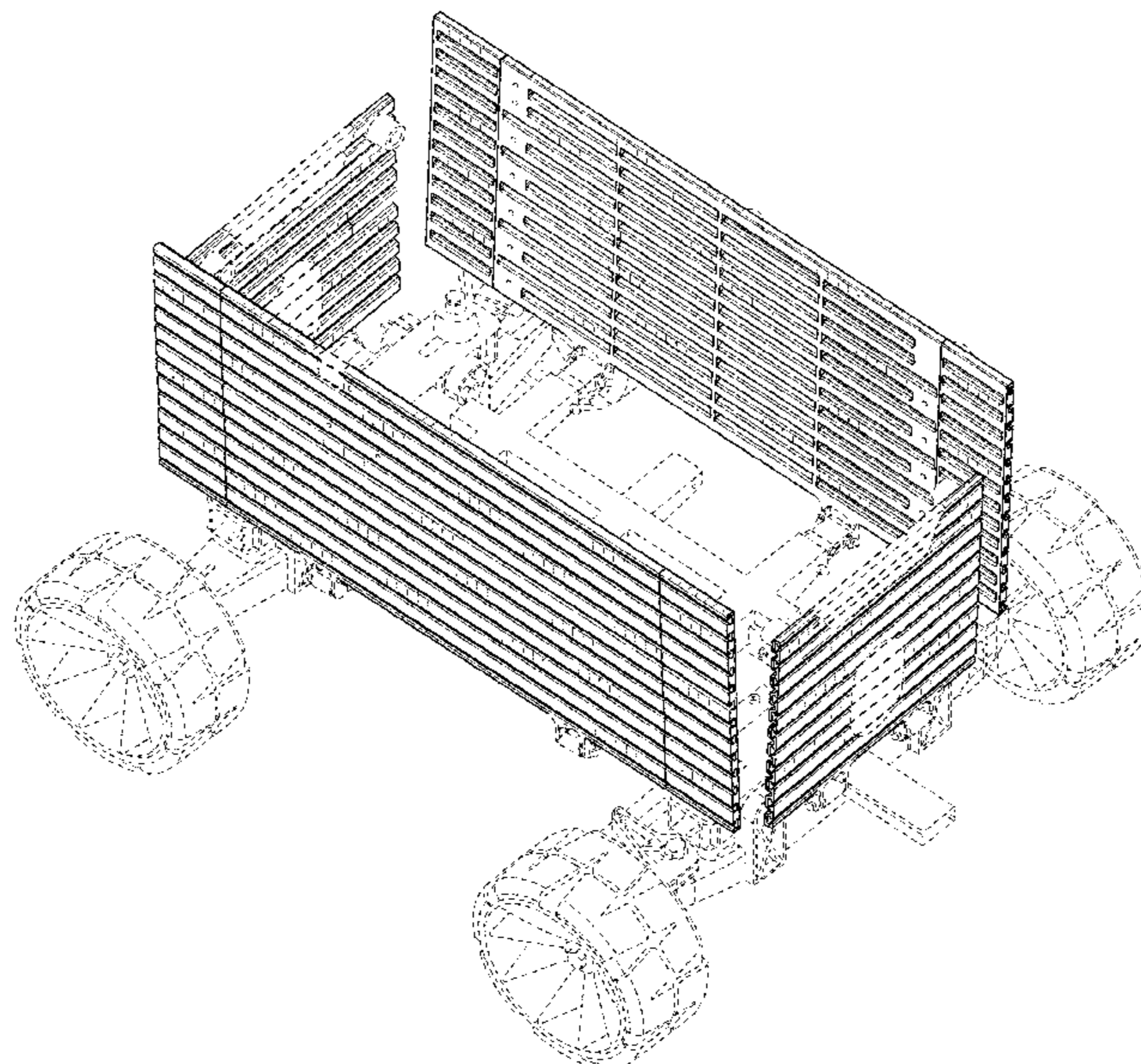
The ornamental design for an accessory attachment rack, as

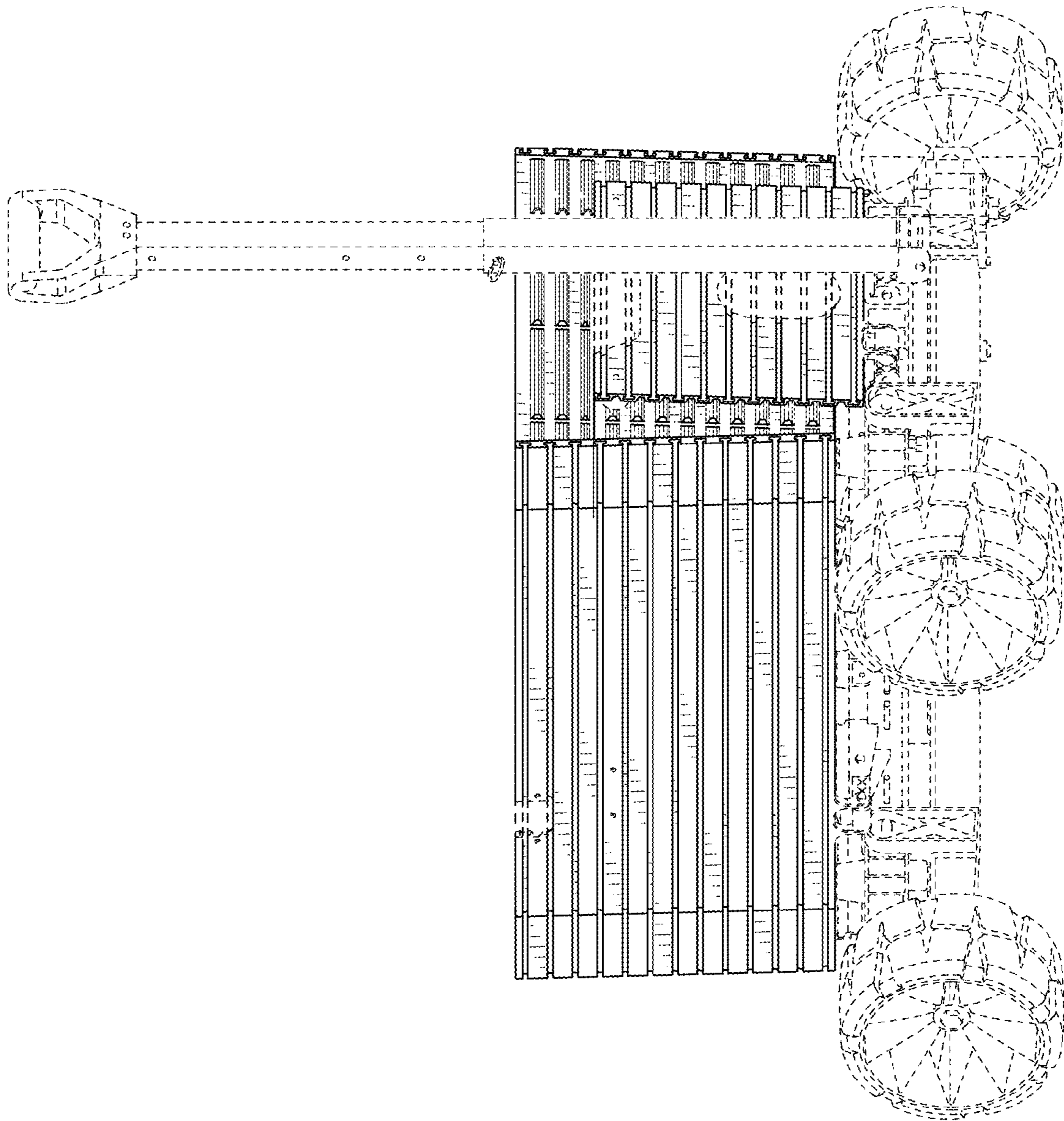

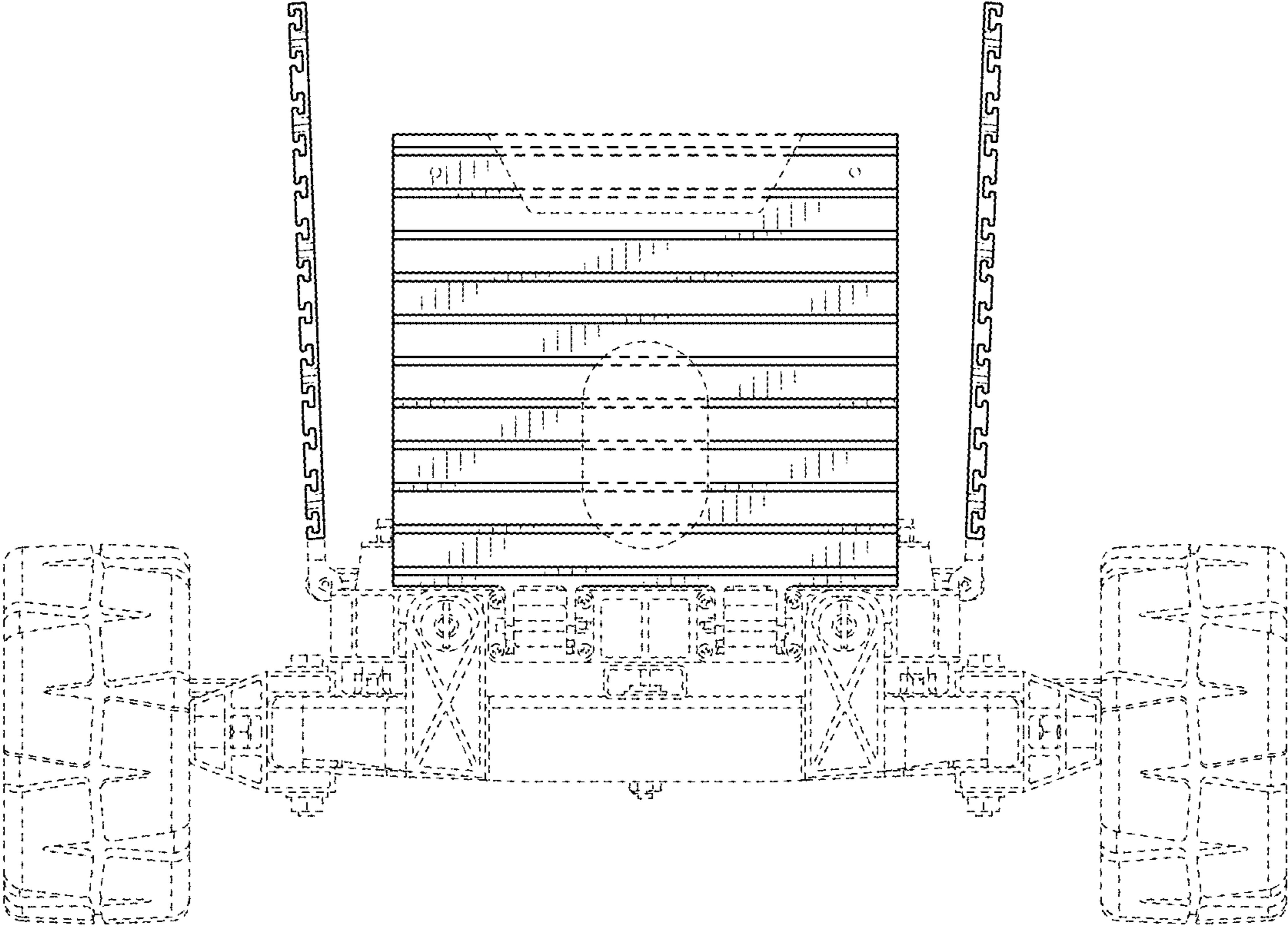

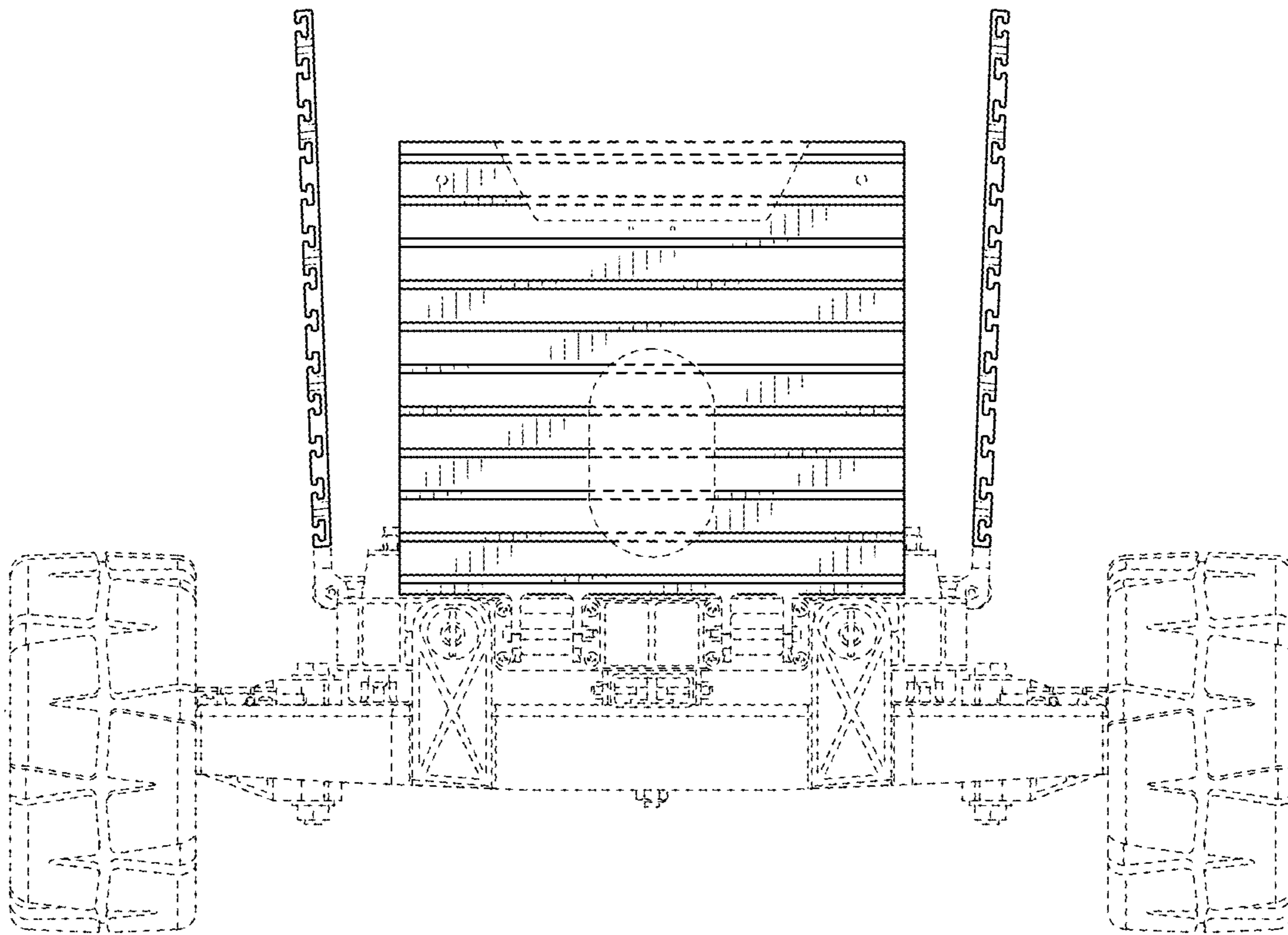

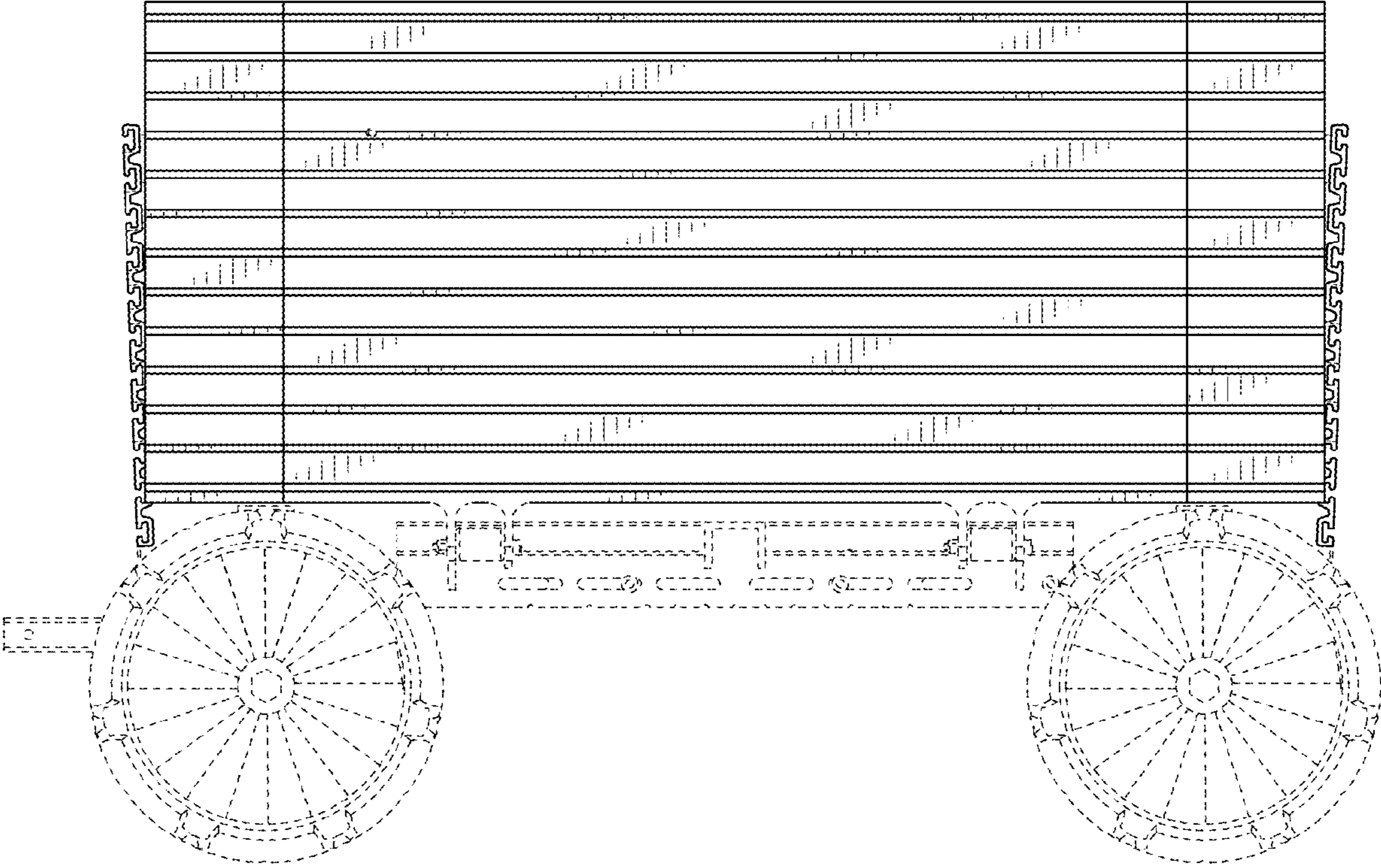

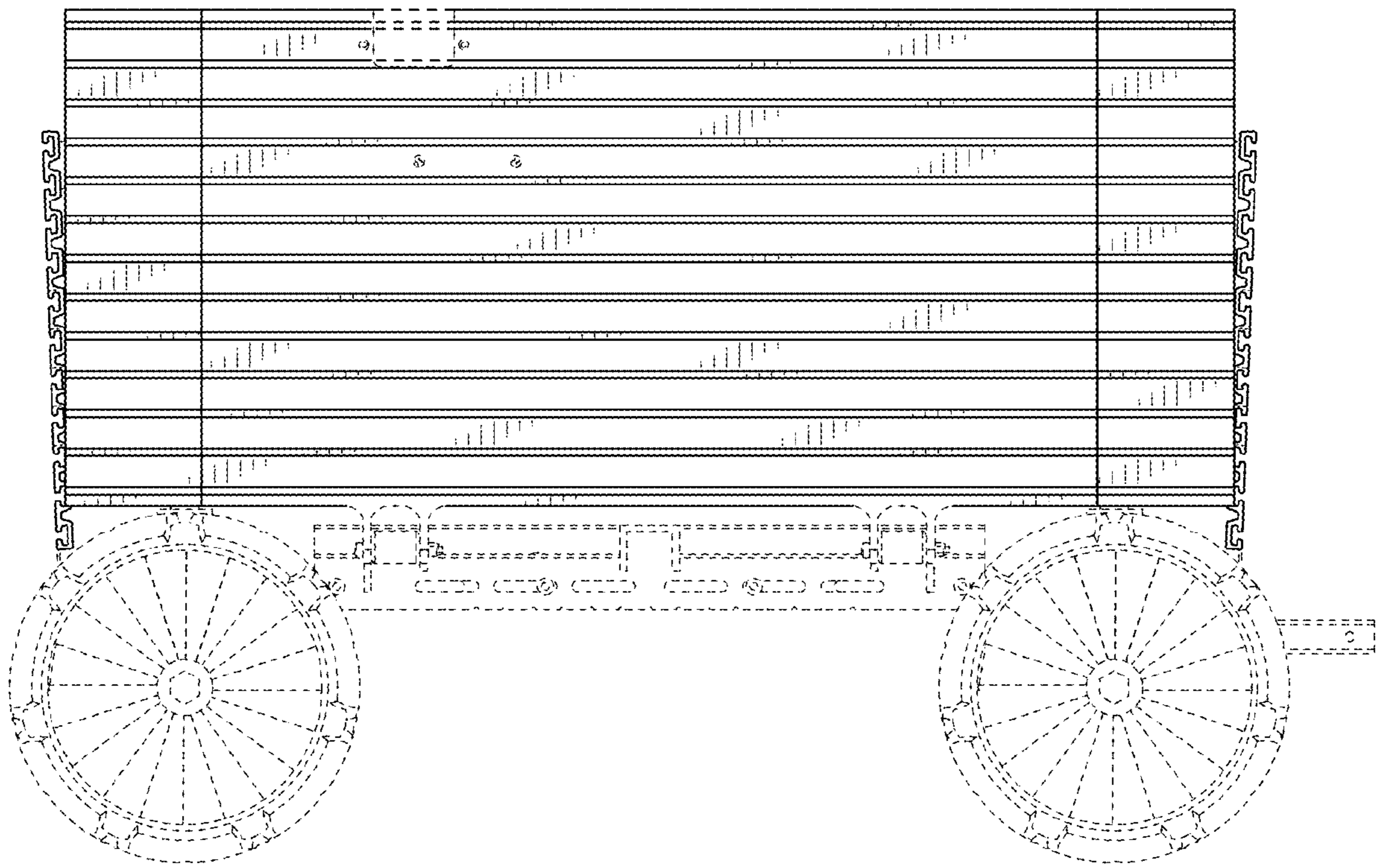

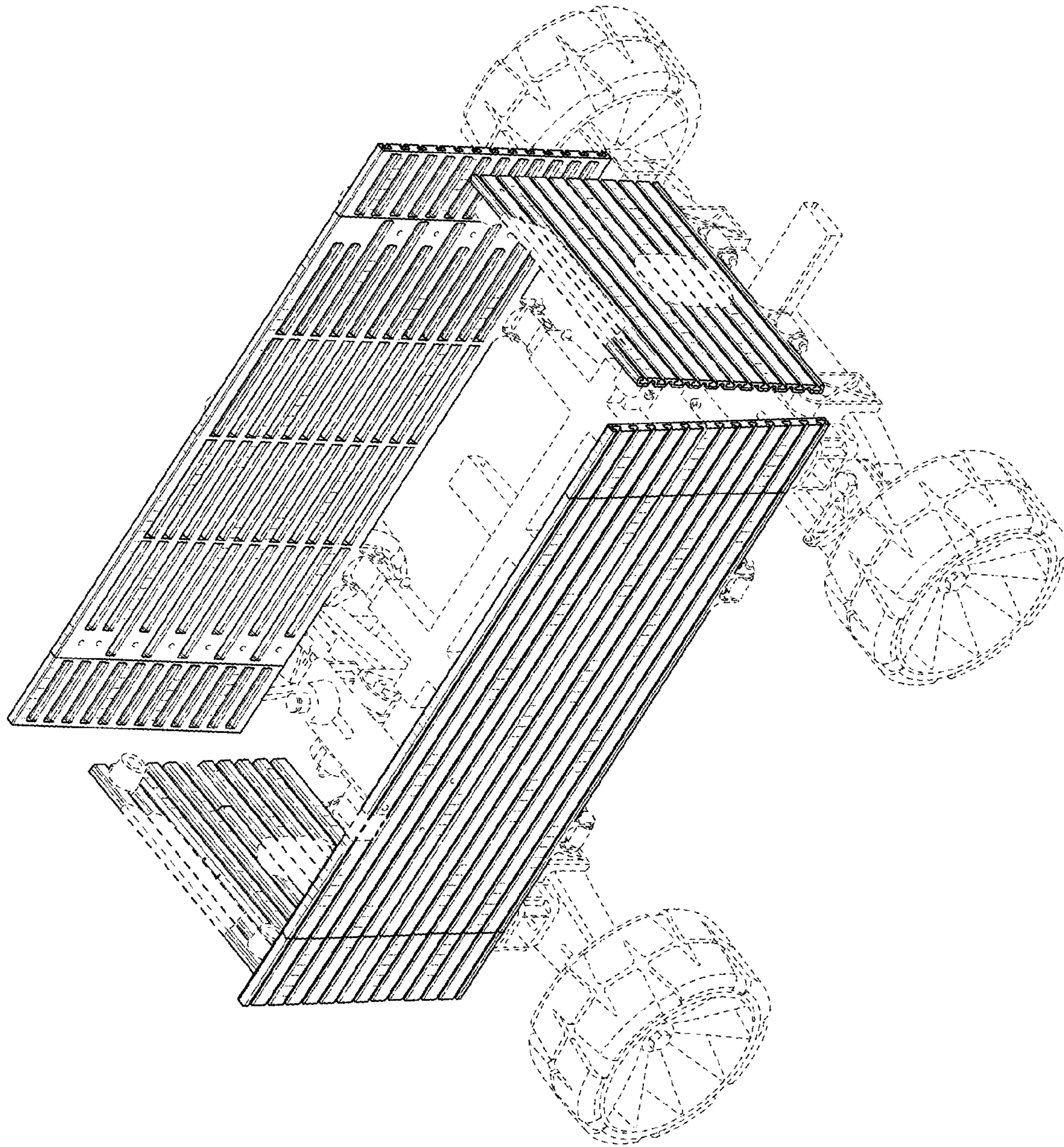

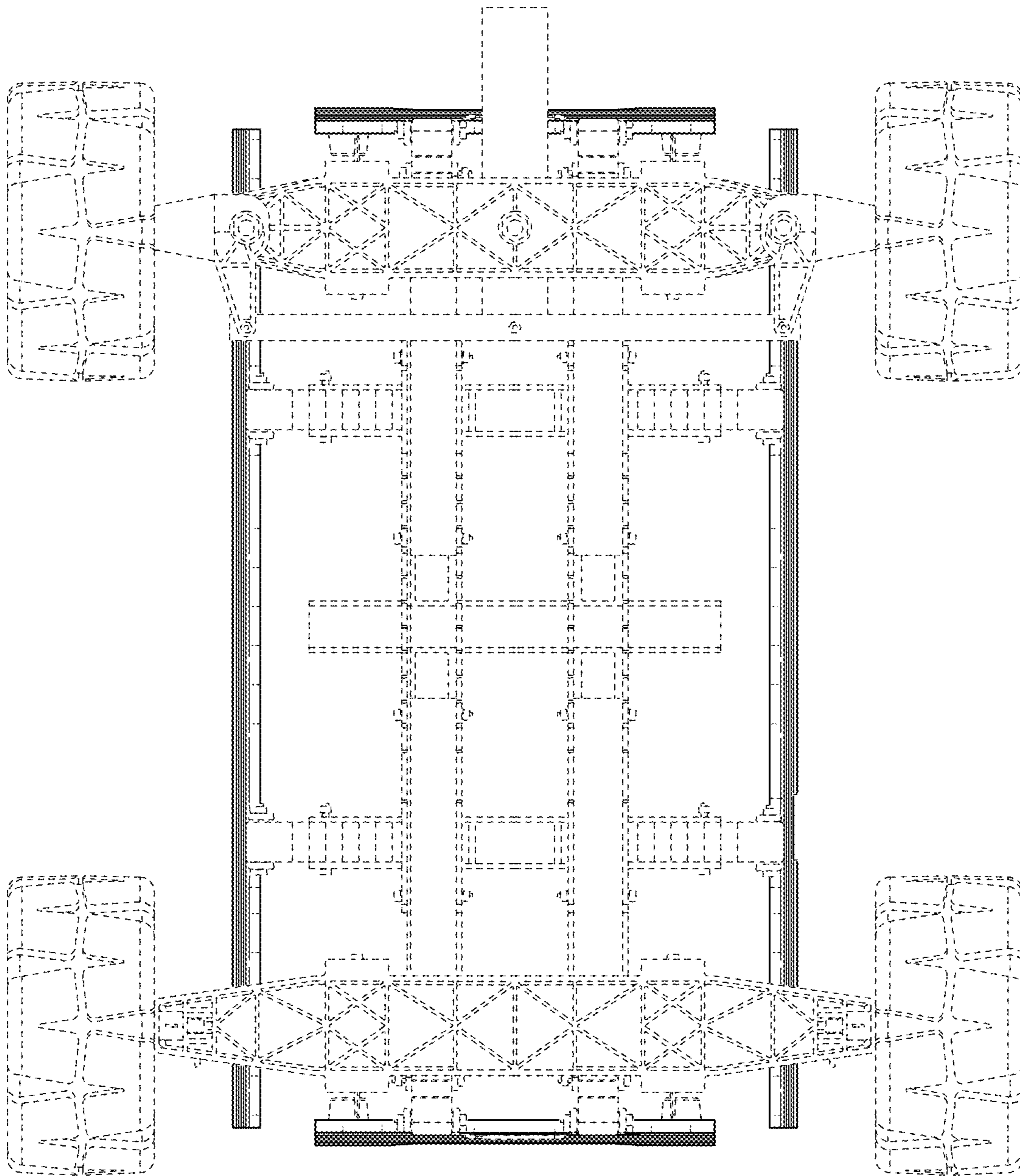

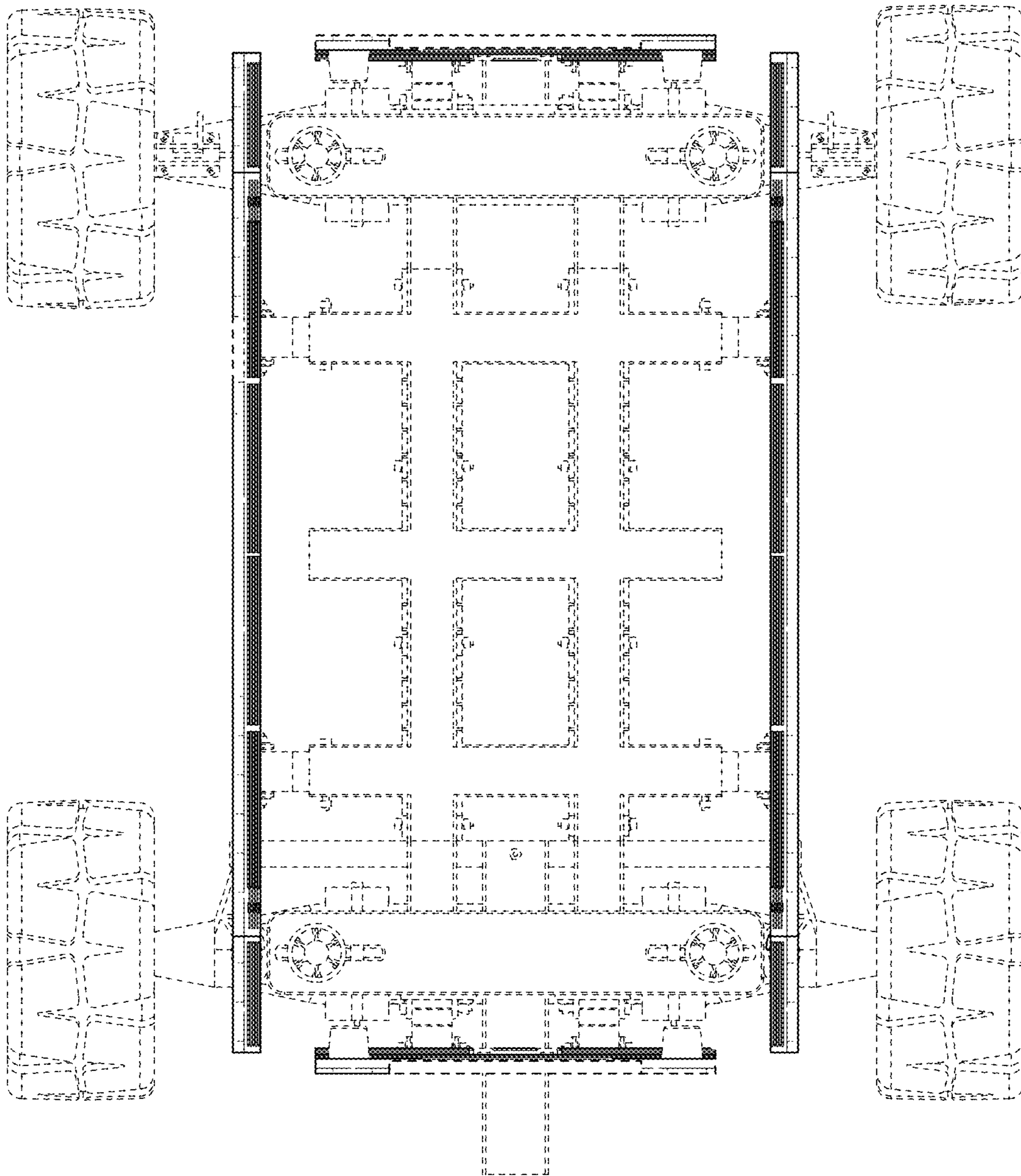
