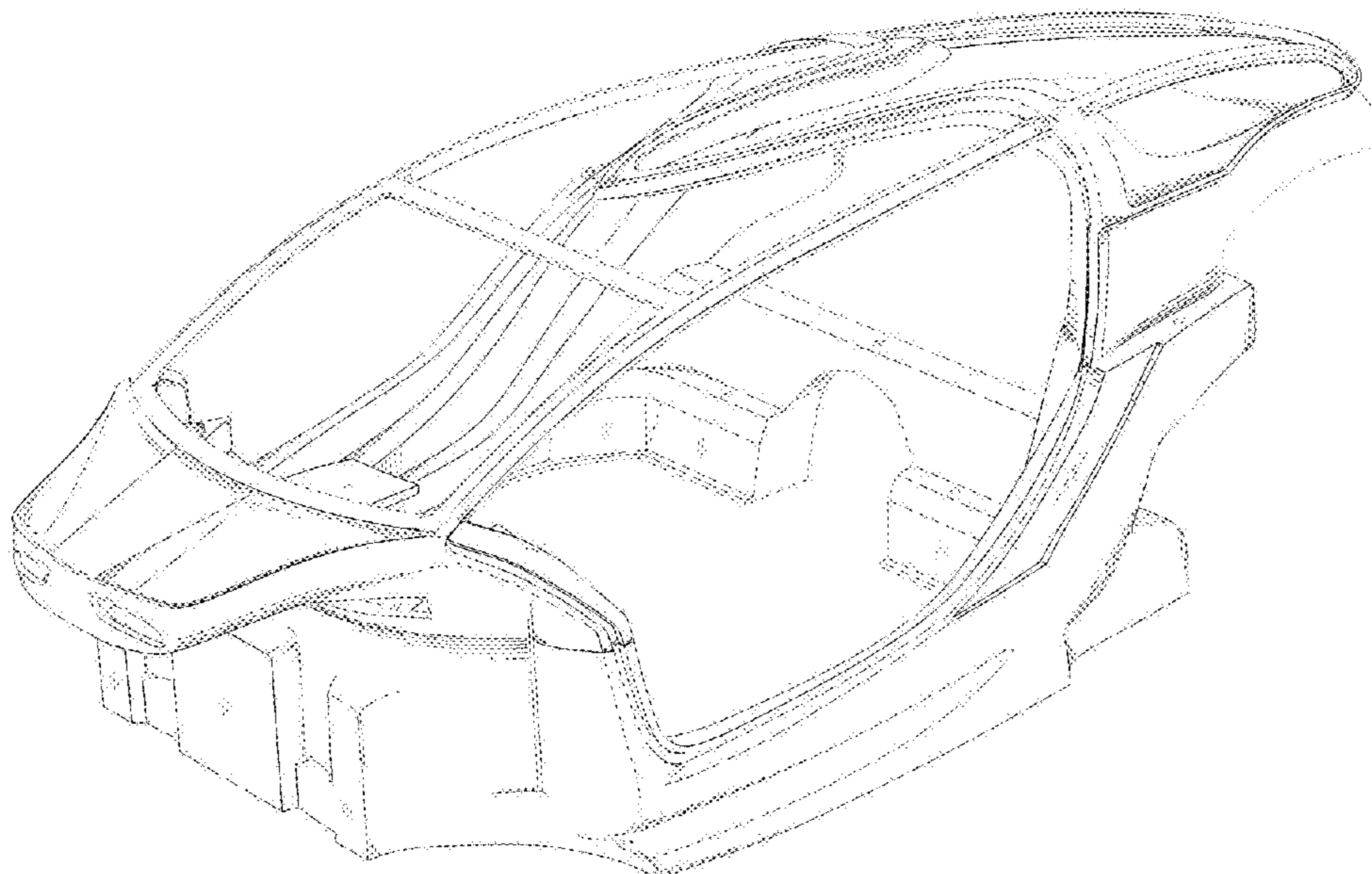

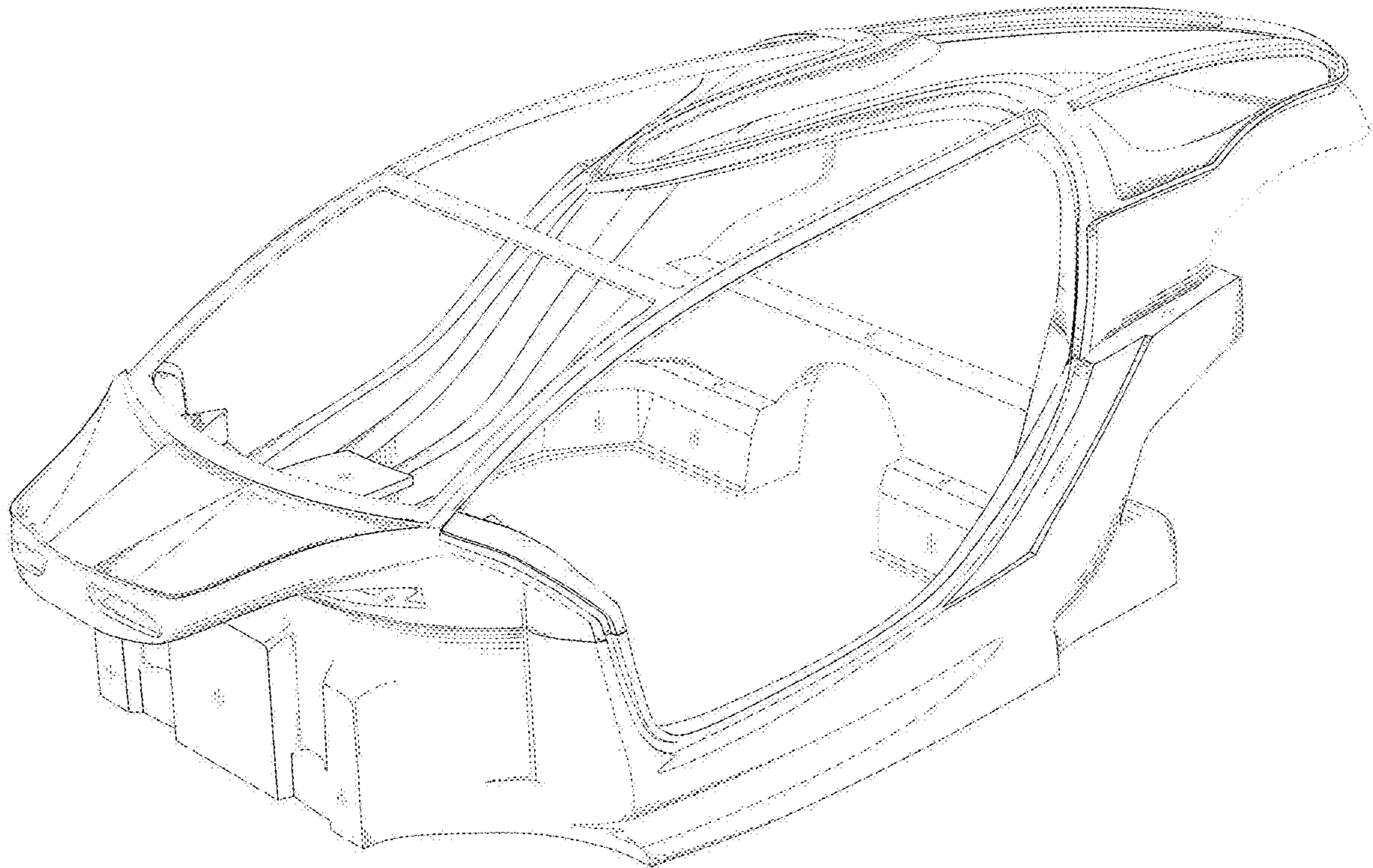
The ornamental design for a vehicle chassis, as shown and described.

**DESCRIPTION**

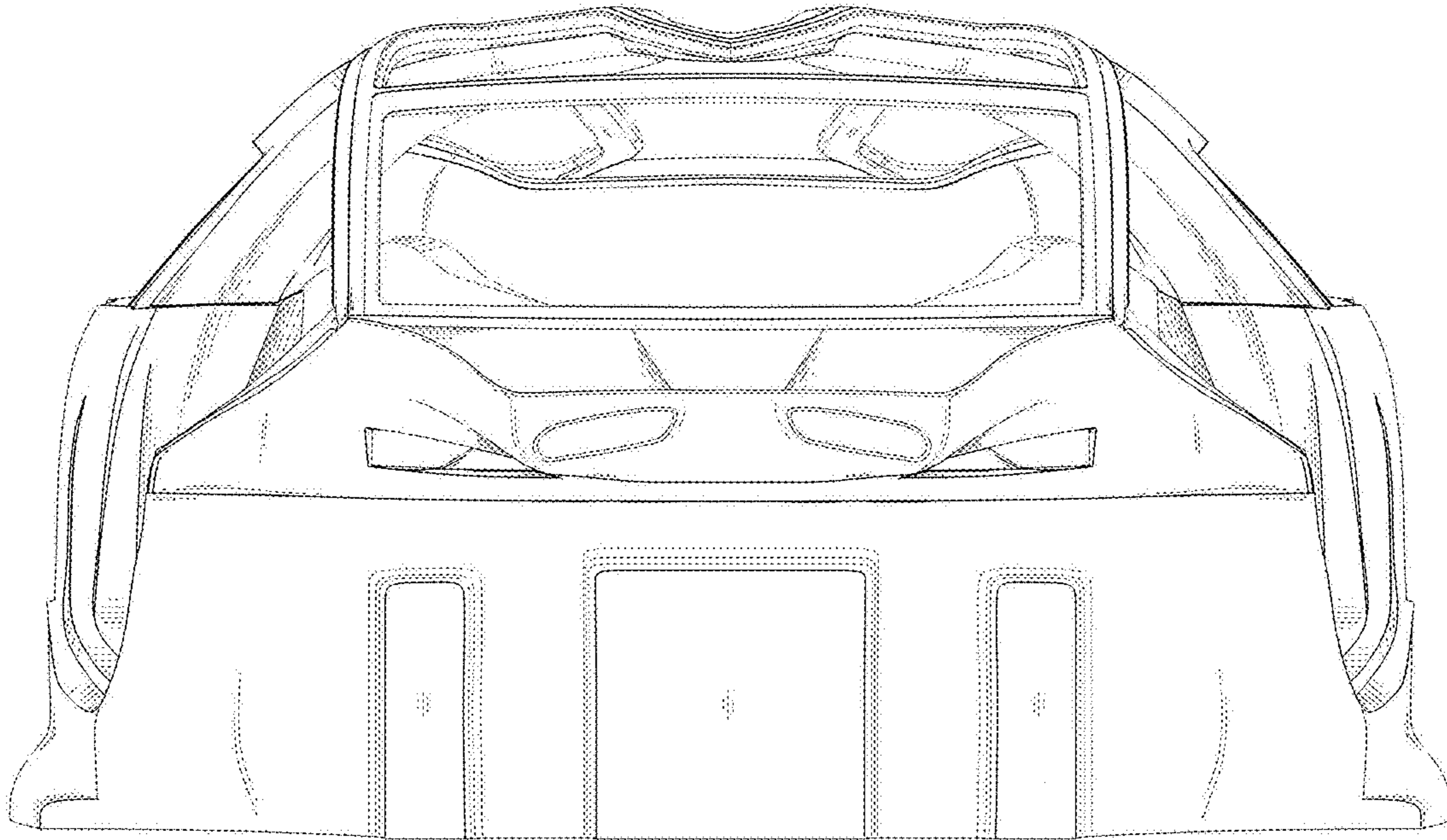
FIG. 1 is a front perspective view of the vehicle chassis showing our new design;

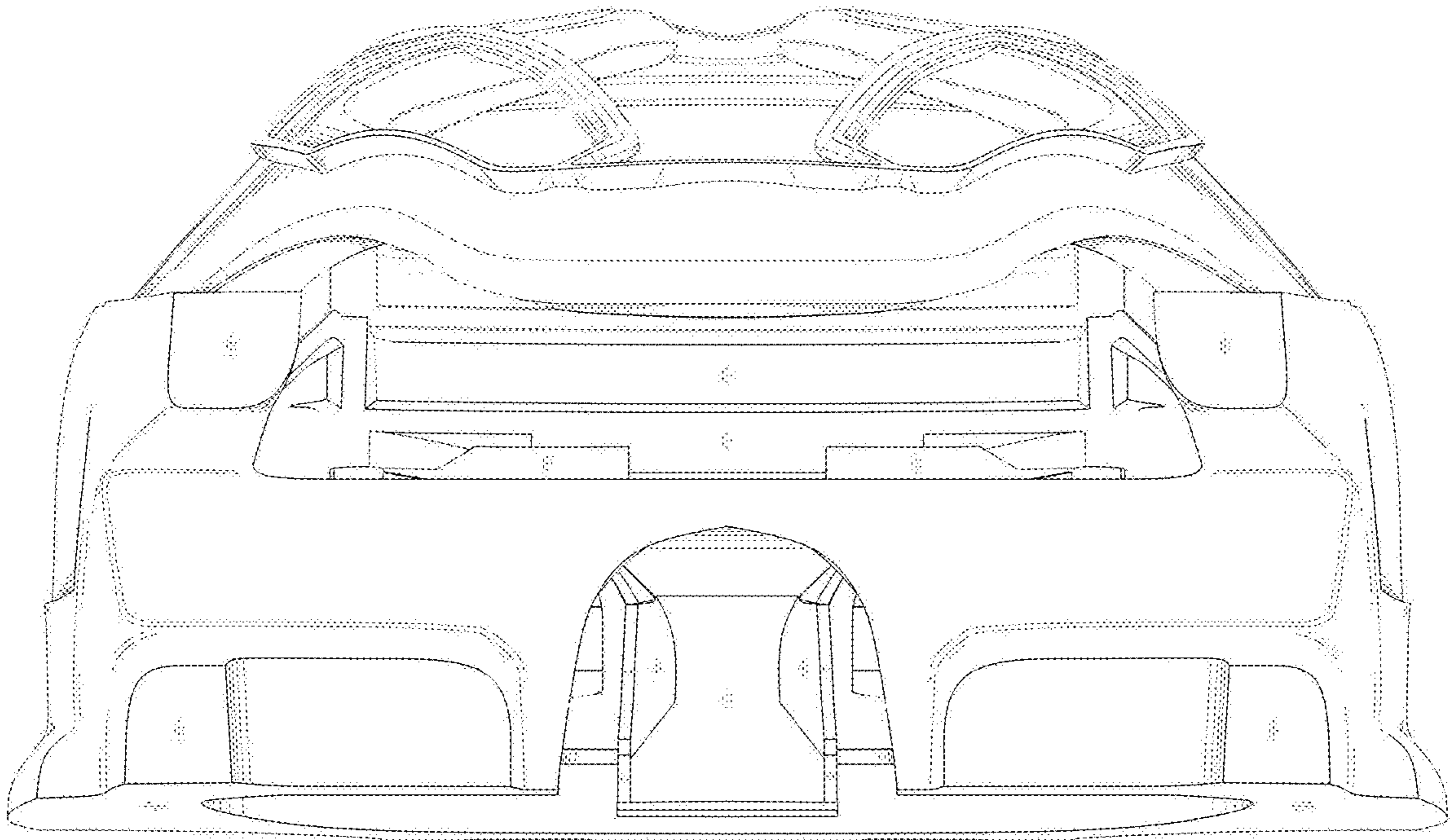




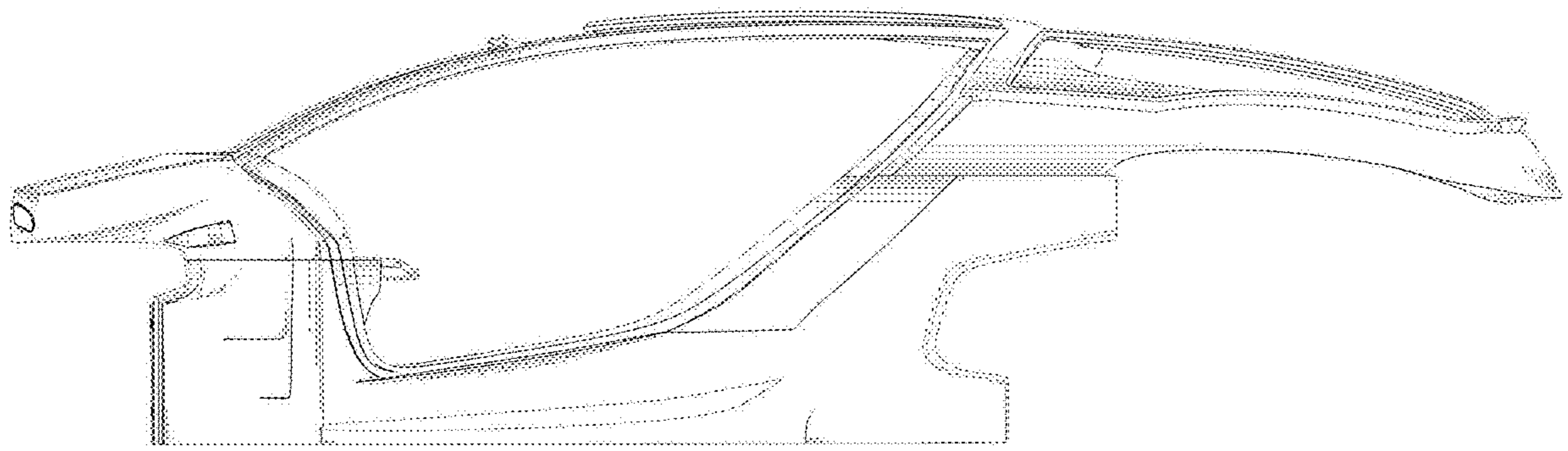

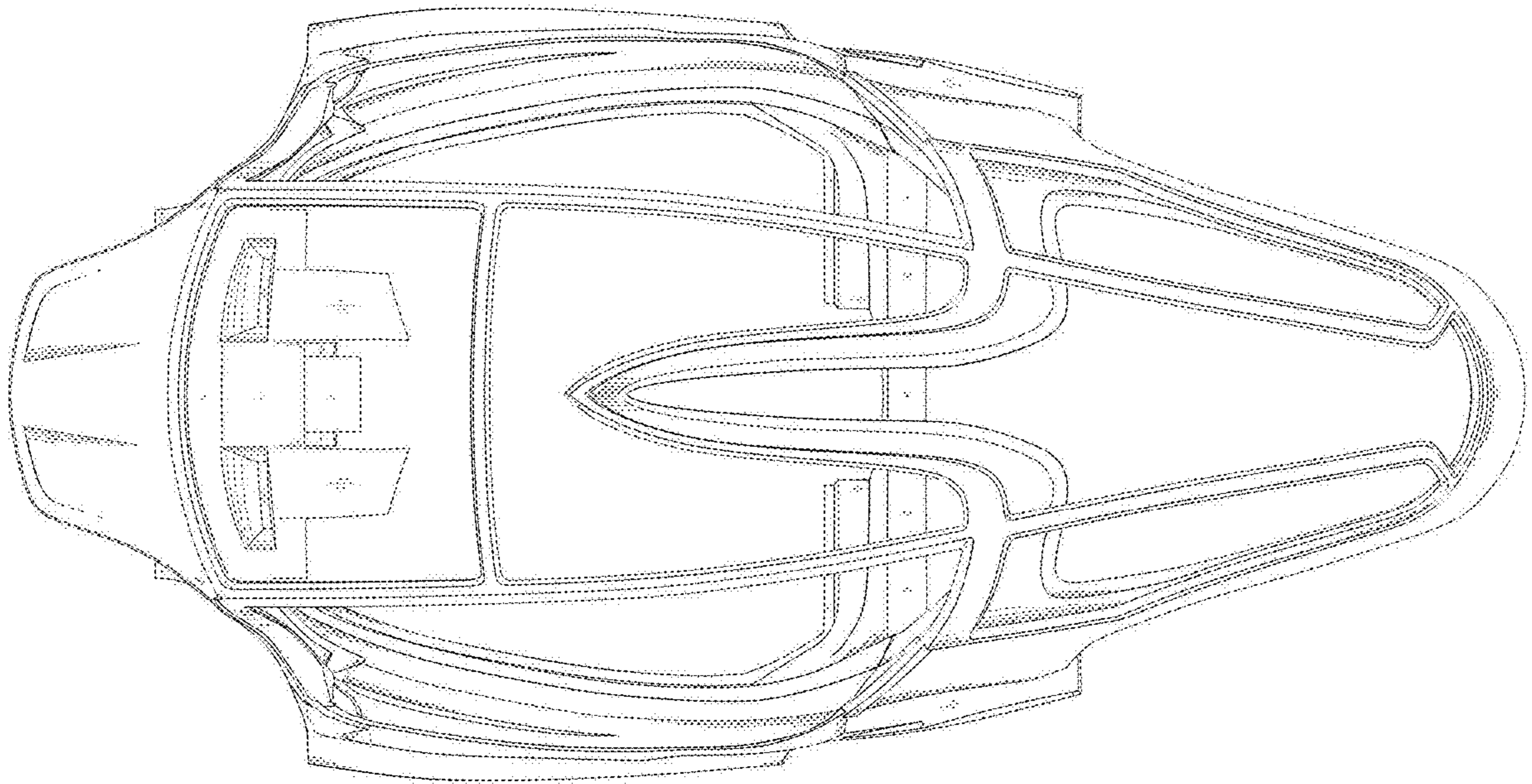

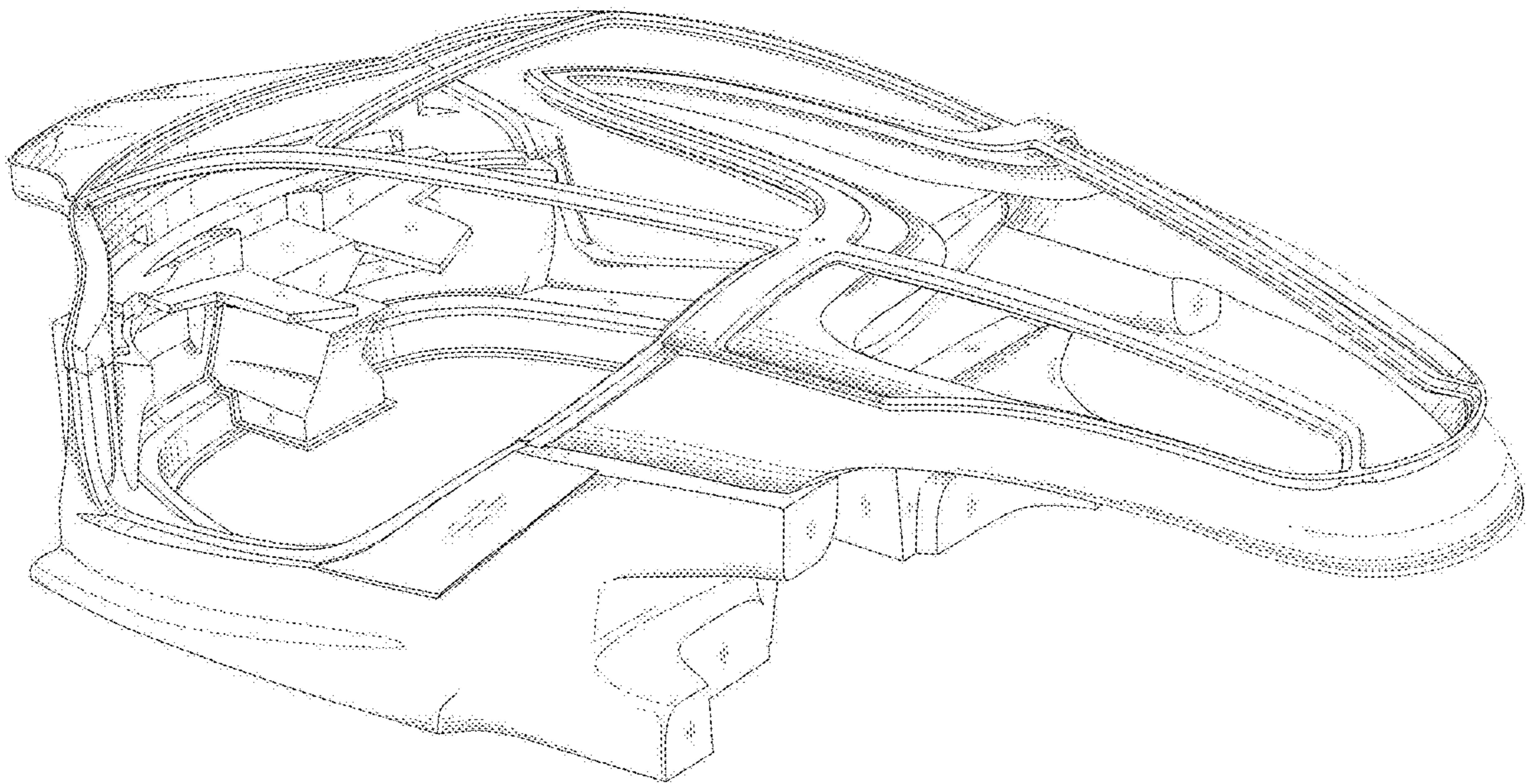
