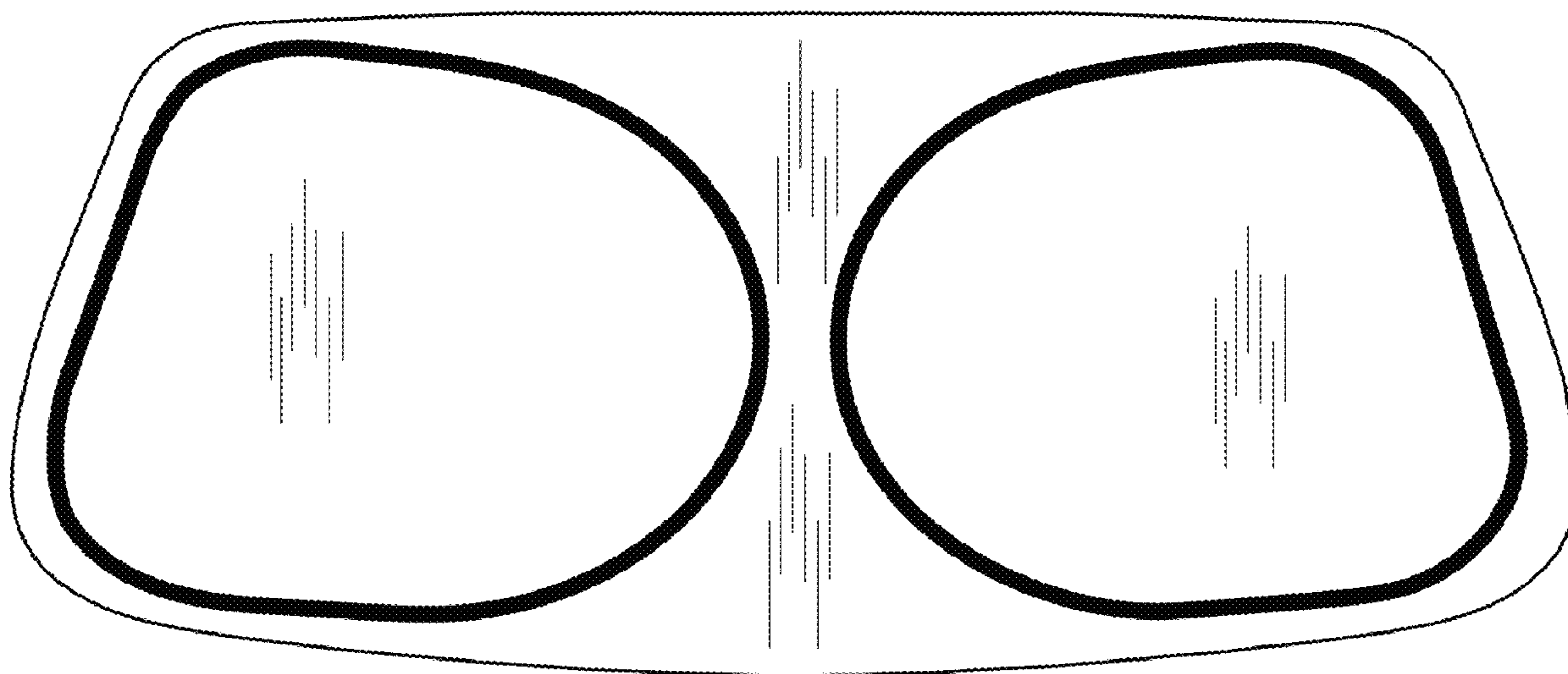
(57) **CLAIM**

I claim, the ornamental design for a sunshade for a vehicle, as shown and described.

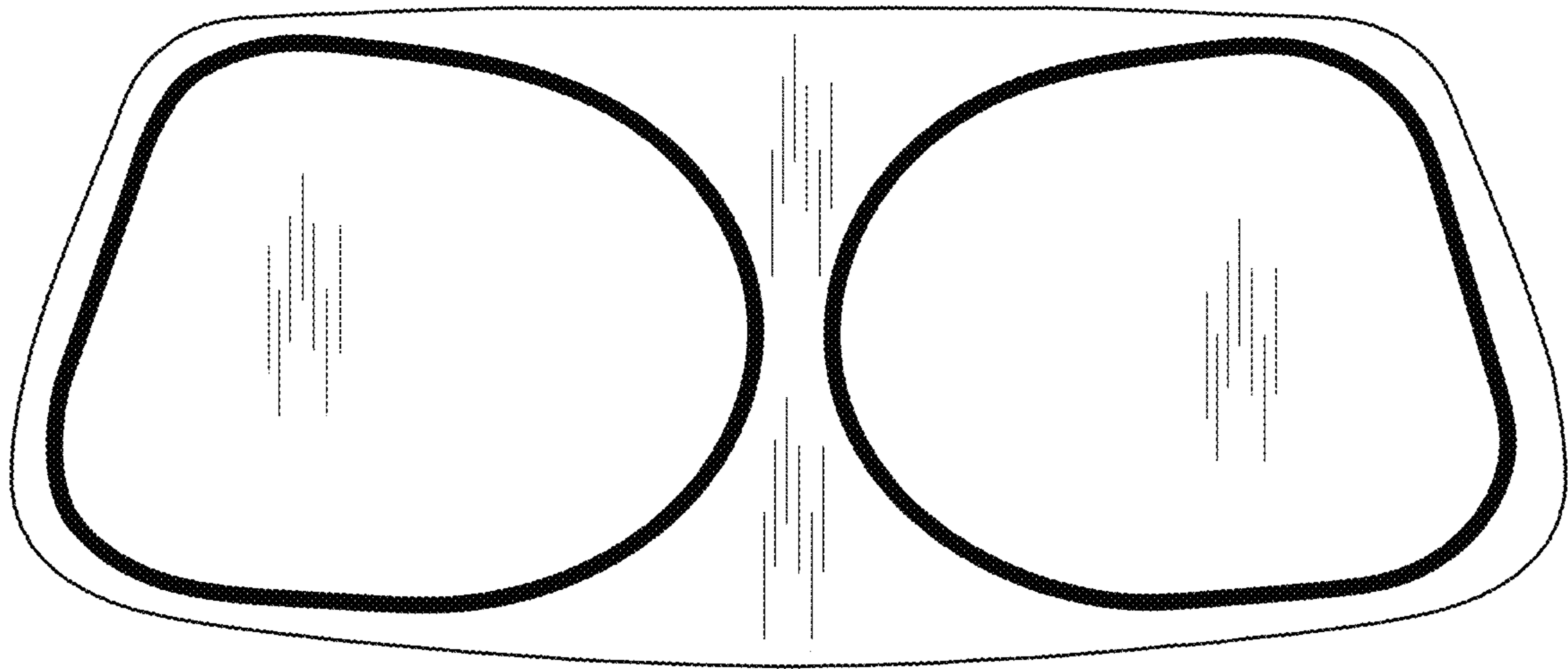

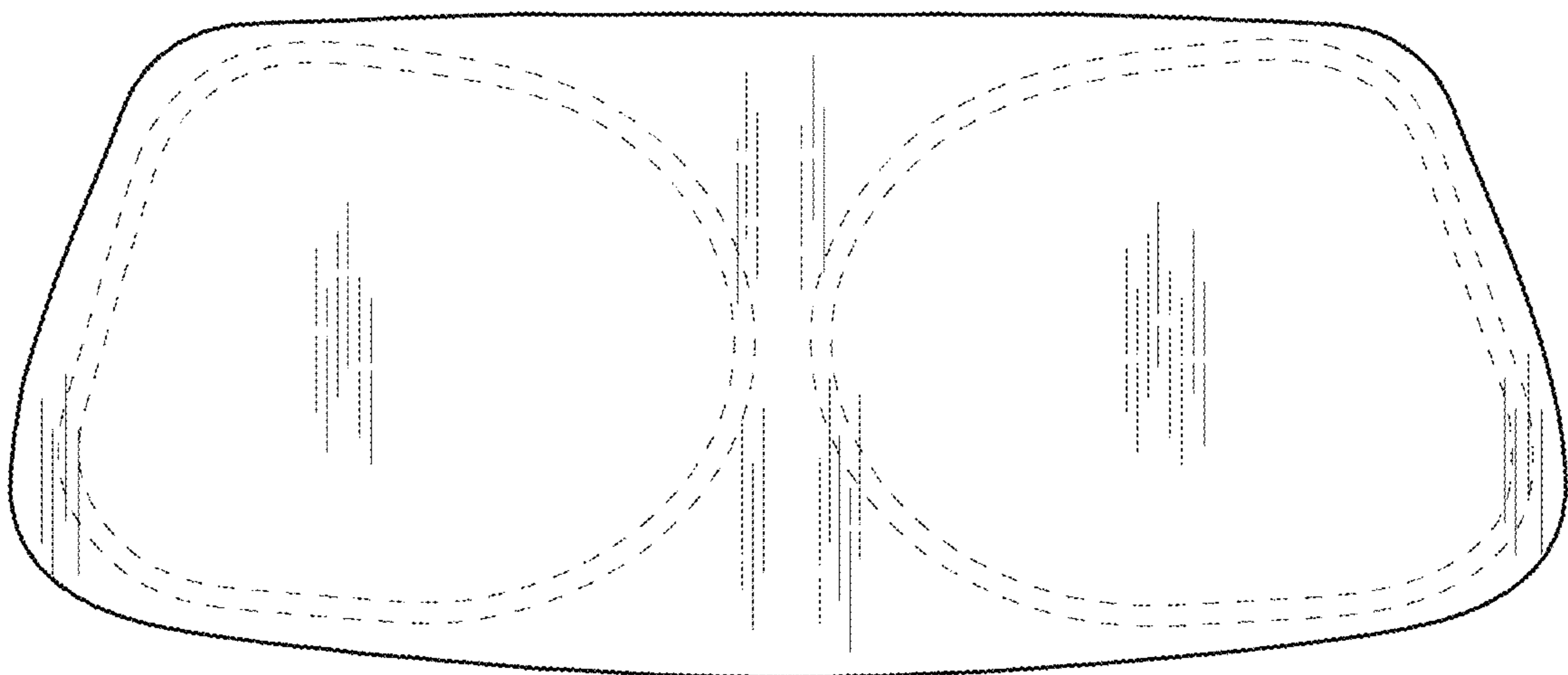
