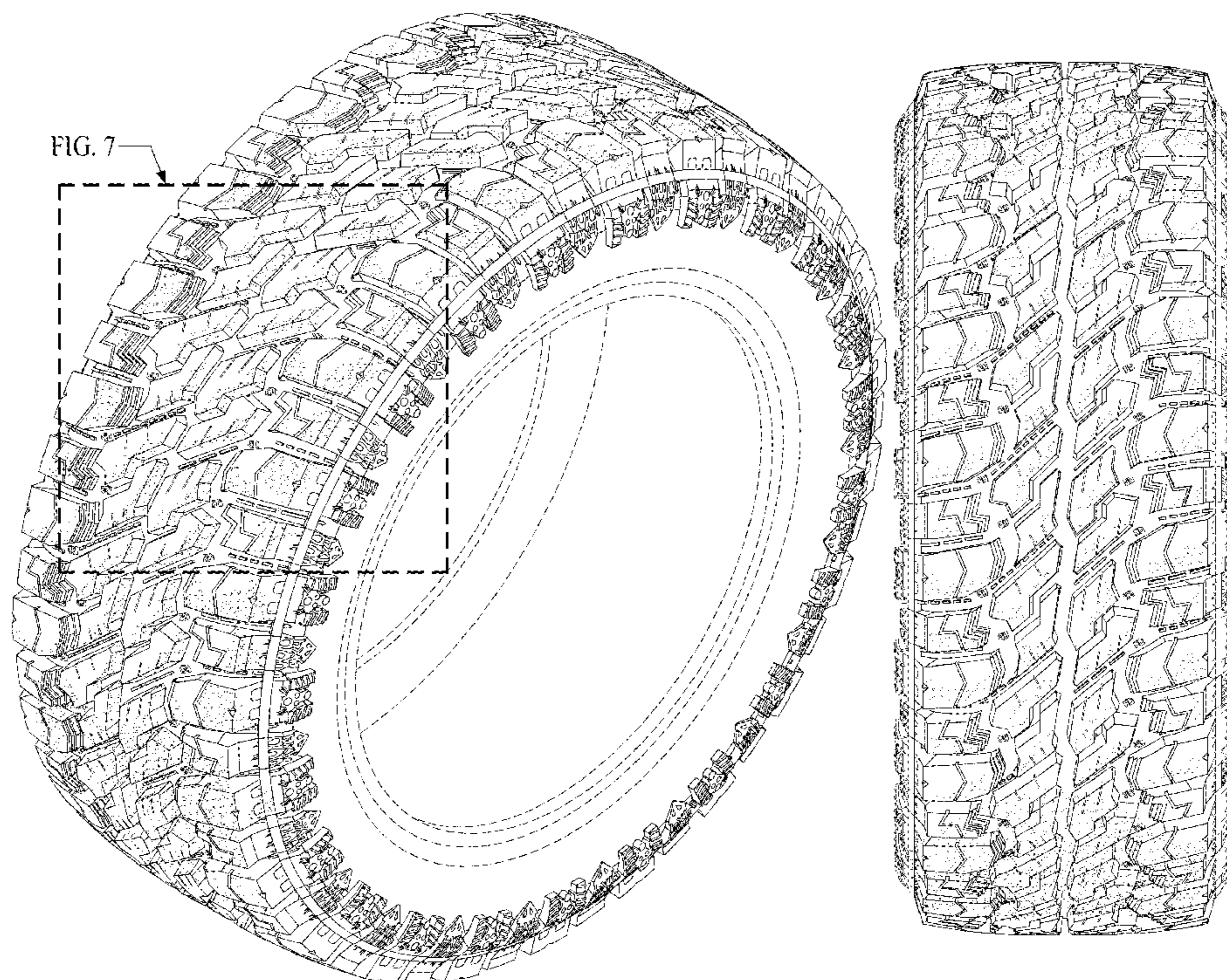
(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tire tread;
 FIG. 2 is a front elevational view of the tire tread of FIG. 1;
 FIG. 3 is a rear elevational view of the tire tread of FIG. 1;
 FIG. 4 is a right-side elevational view of the tire tread of FIG. 1;
 FIG. 5 is a top plan view of the tire tread of FIG. 1;
 FIG. 6 is a bottom plan view of the tire tread of FIG. 1;
 FIG. 7 is an enlarged perspective view of a portion of the tire tread of FIG. 1;
 FIG. 8 is an enlarged front elevational view of a portion of the tire tread of FIG. 2;
 FIG. 9 is an enlarged rear elevational view of a portion of the tire tread of FIG. 3; and,
 FIG. 10 is an enlarged right-side elevational view of a portion of the tire tread of FIG. 4.

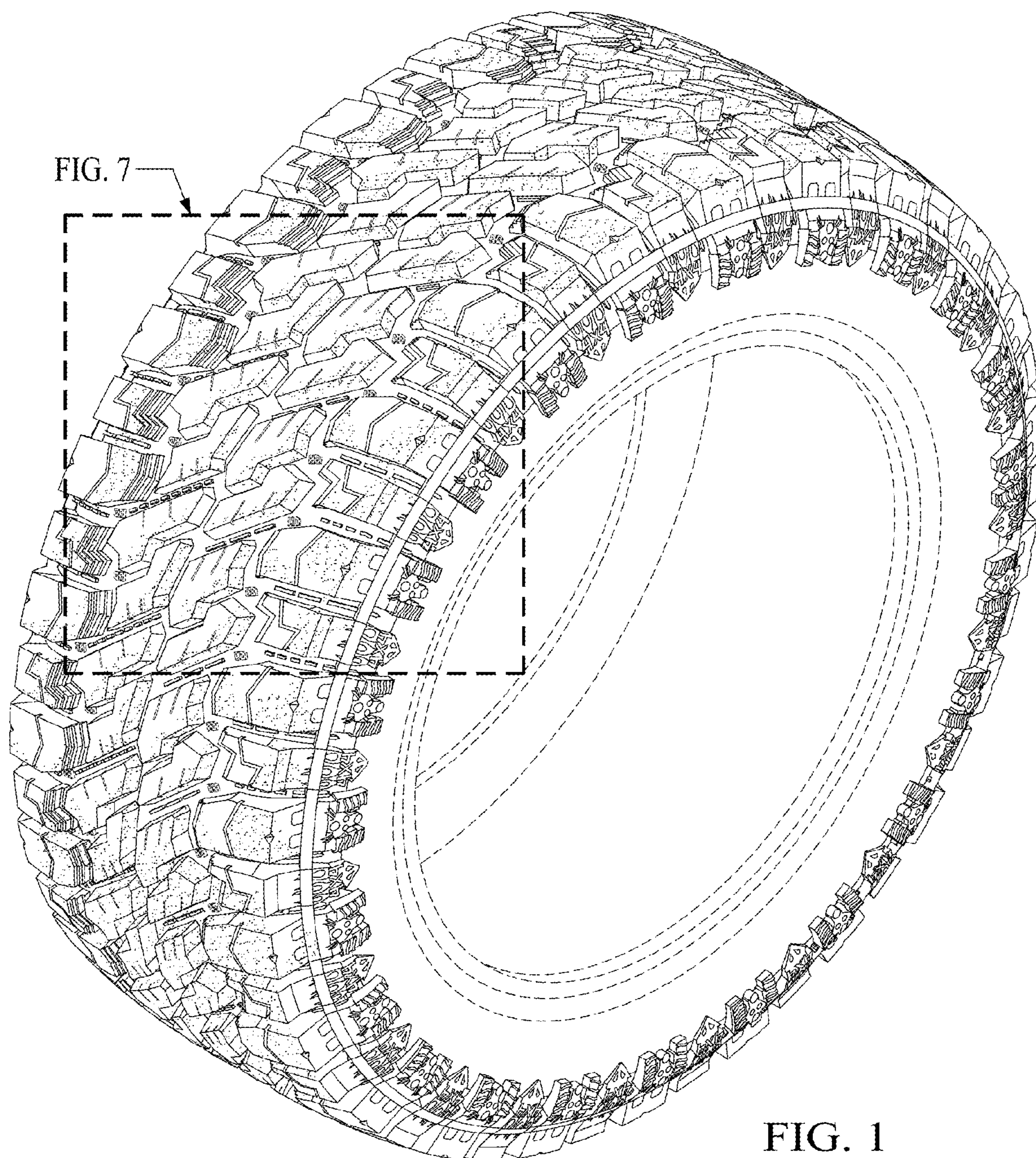

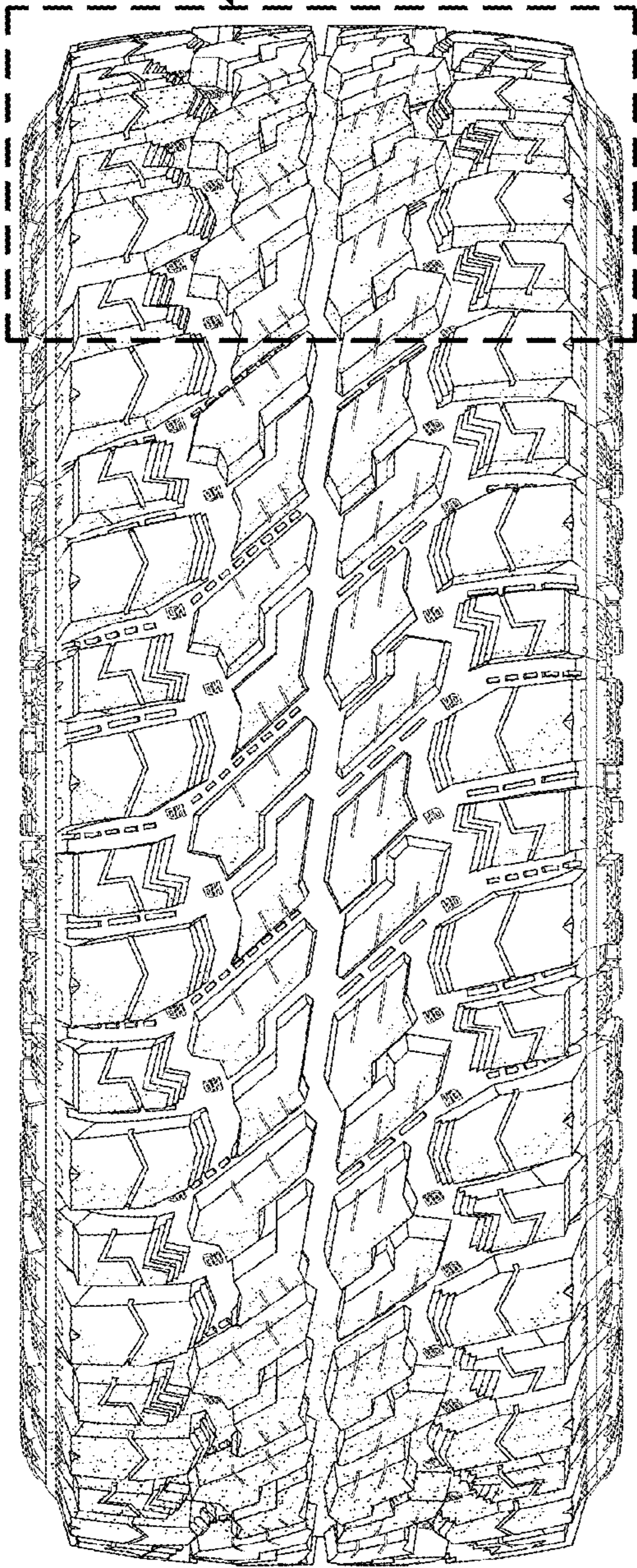

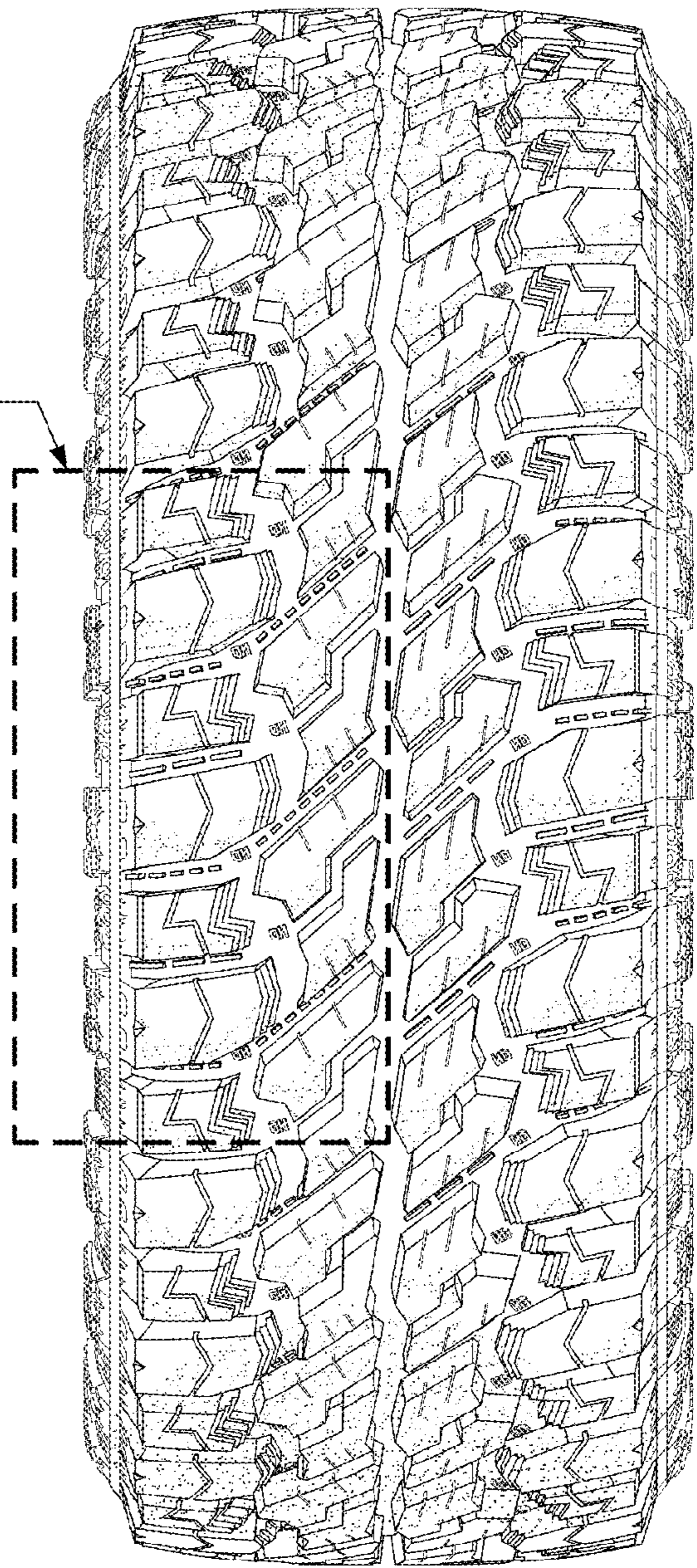

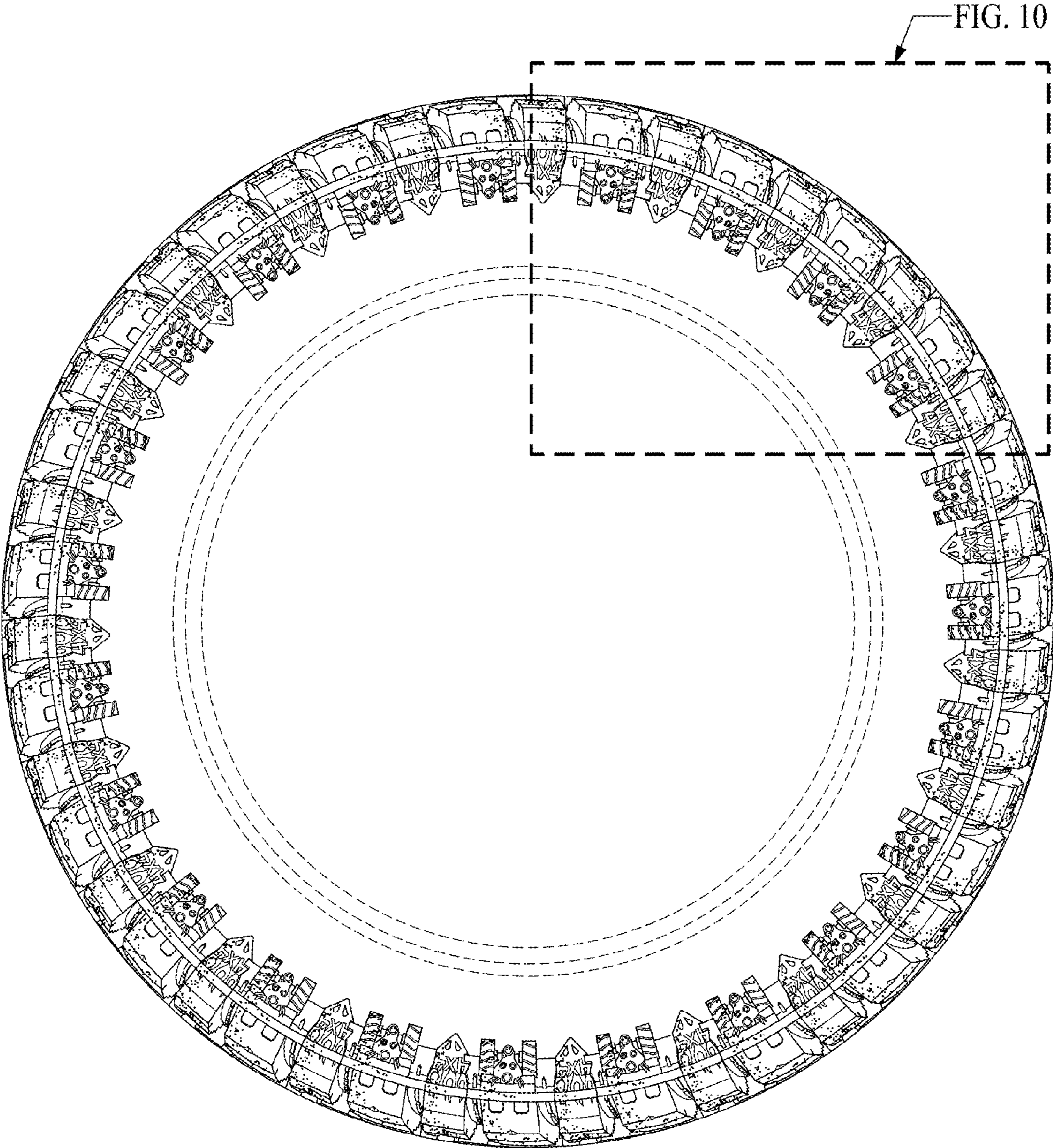

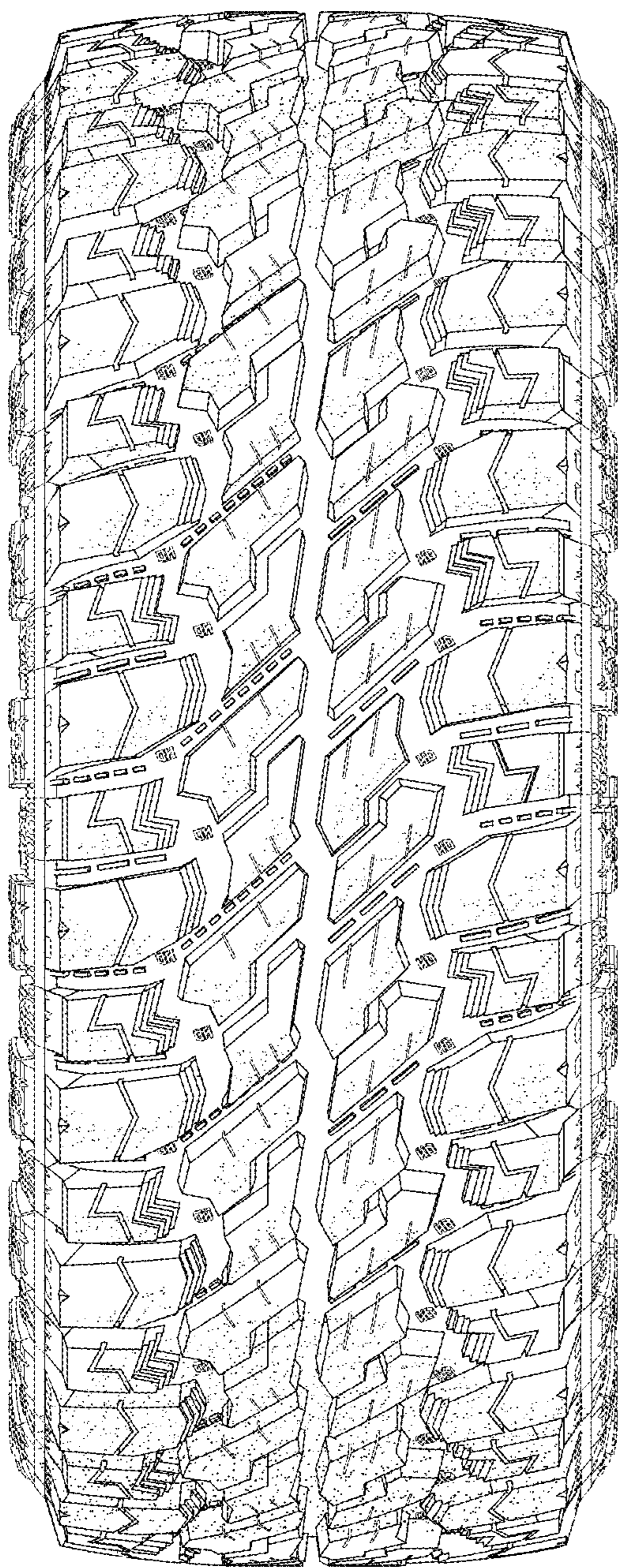

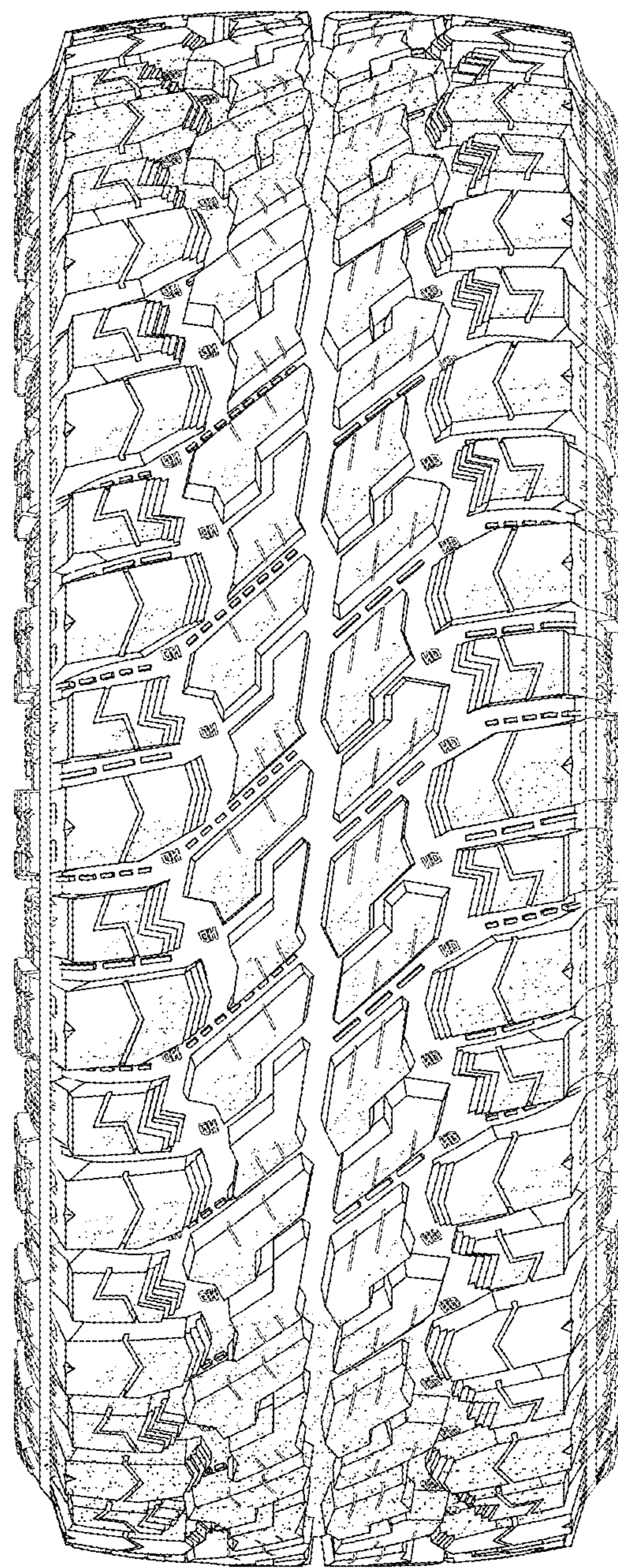

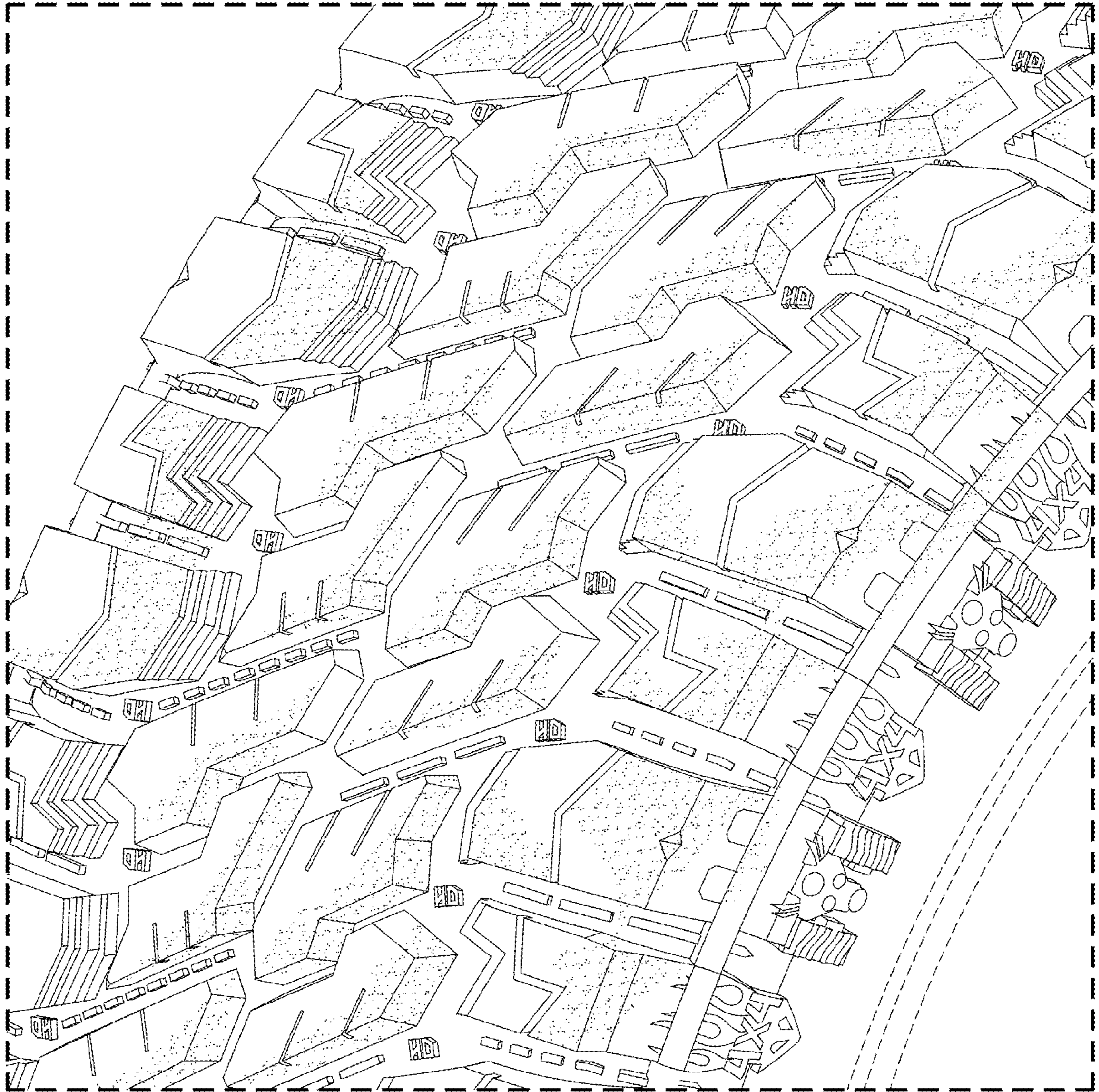

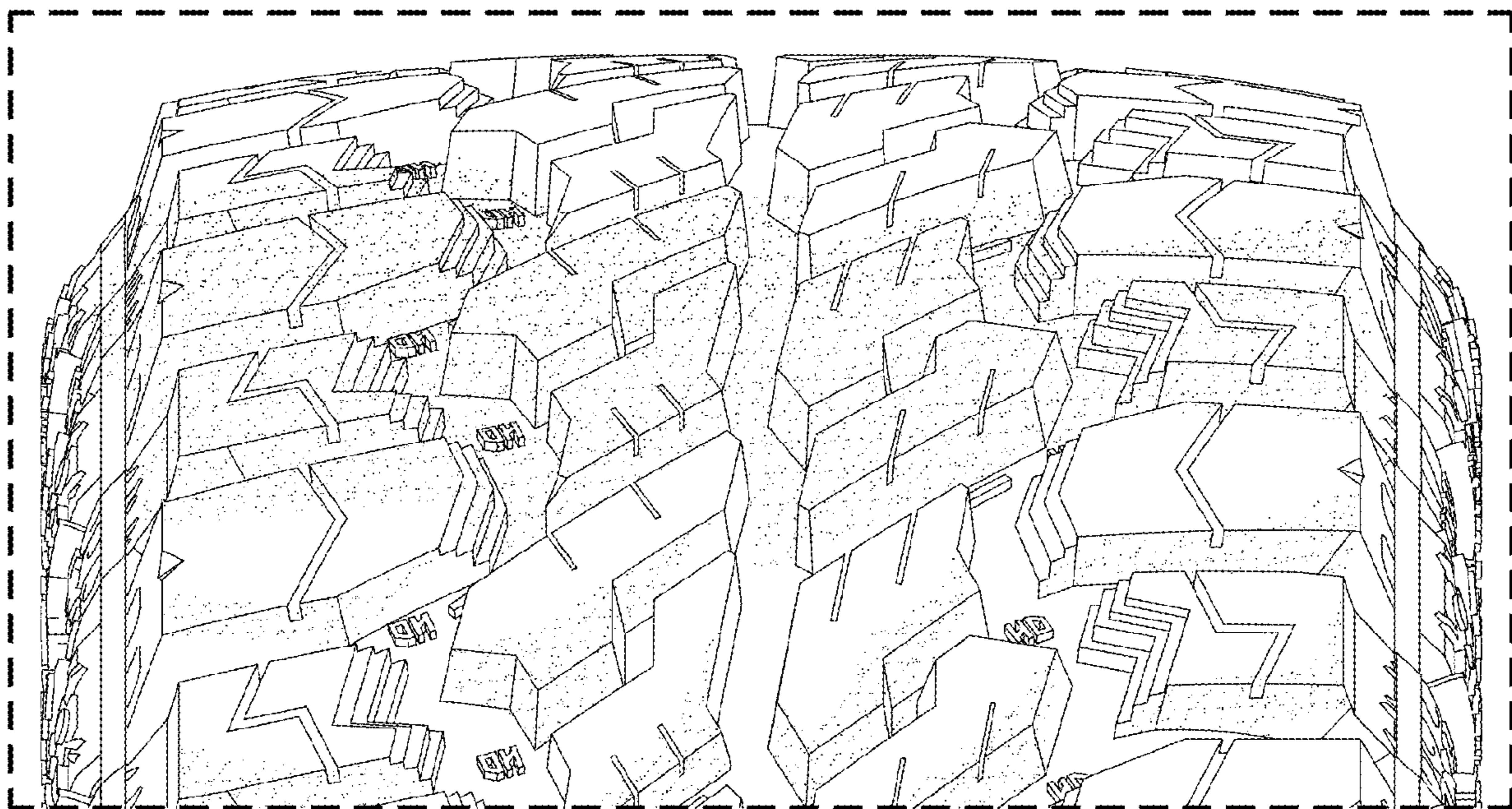

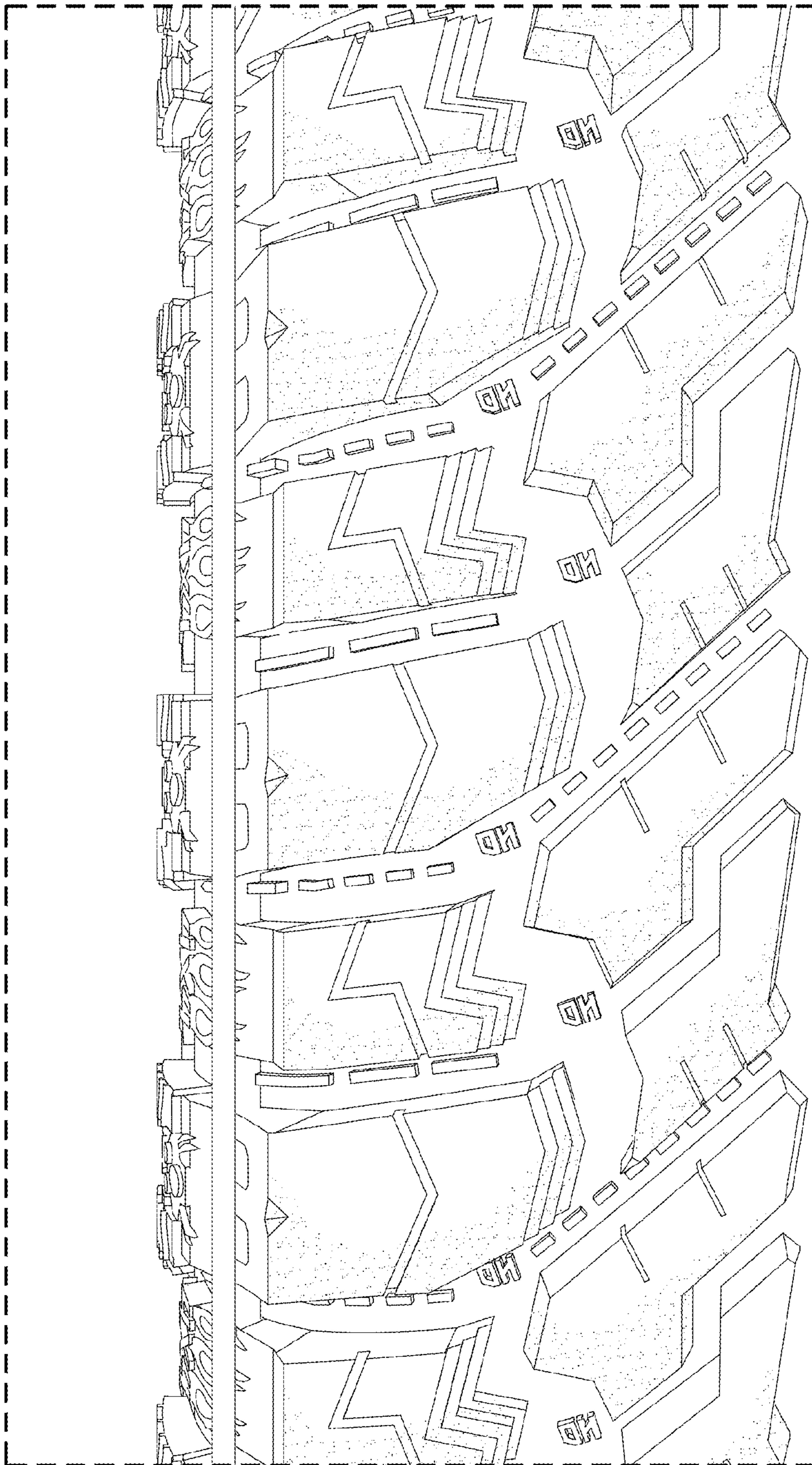
