**DESCRIPTION**

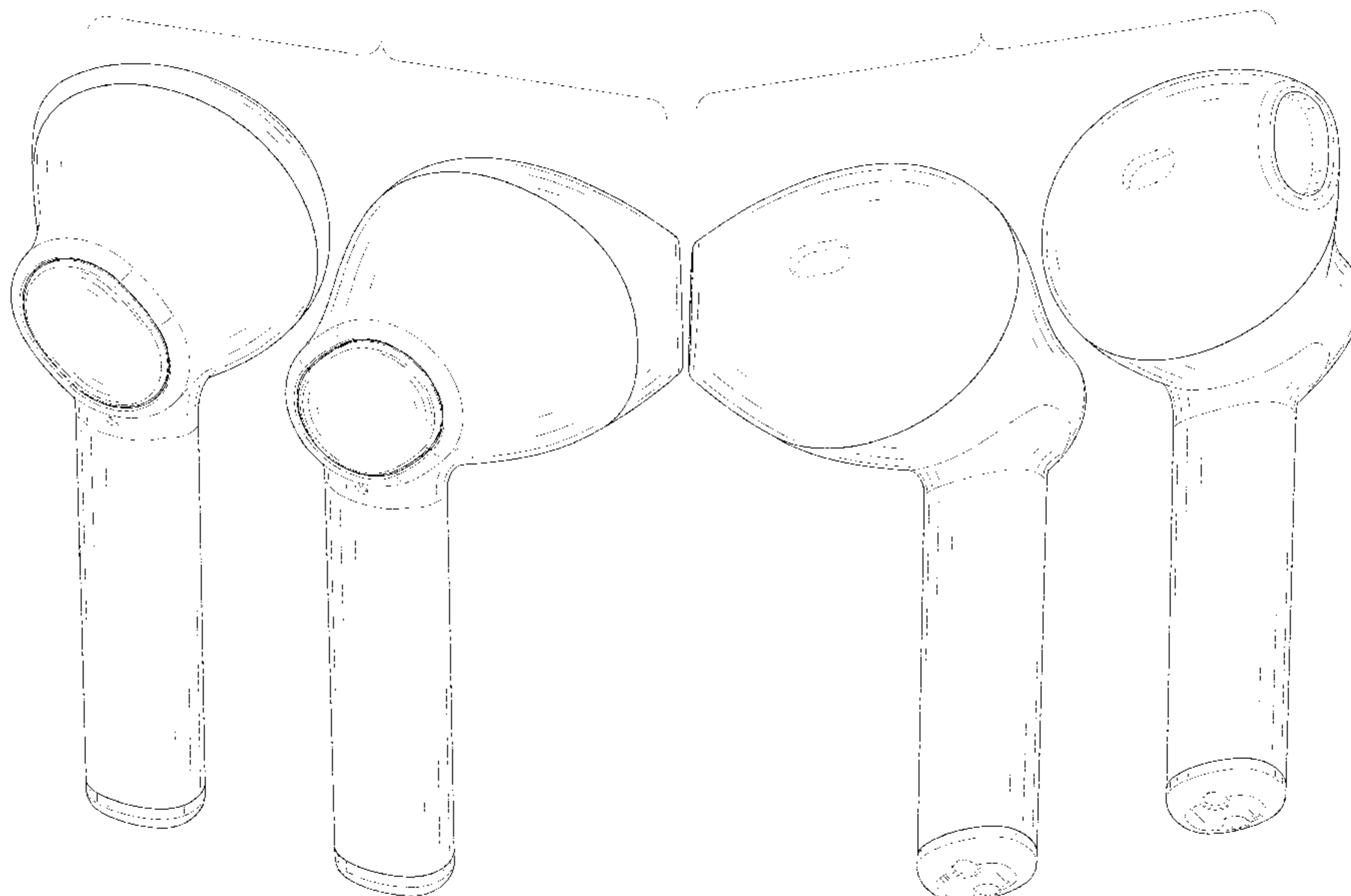
FIG. 1 is a perspective view of earphones showing my new design;

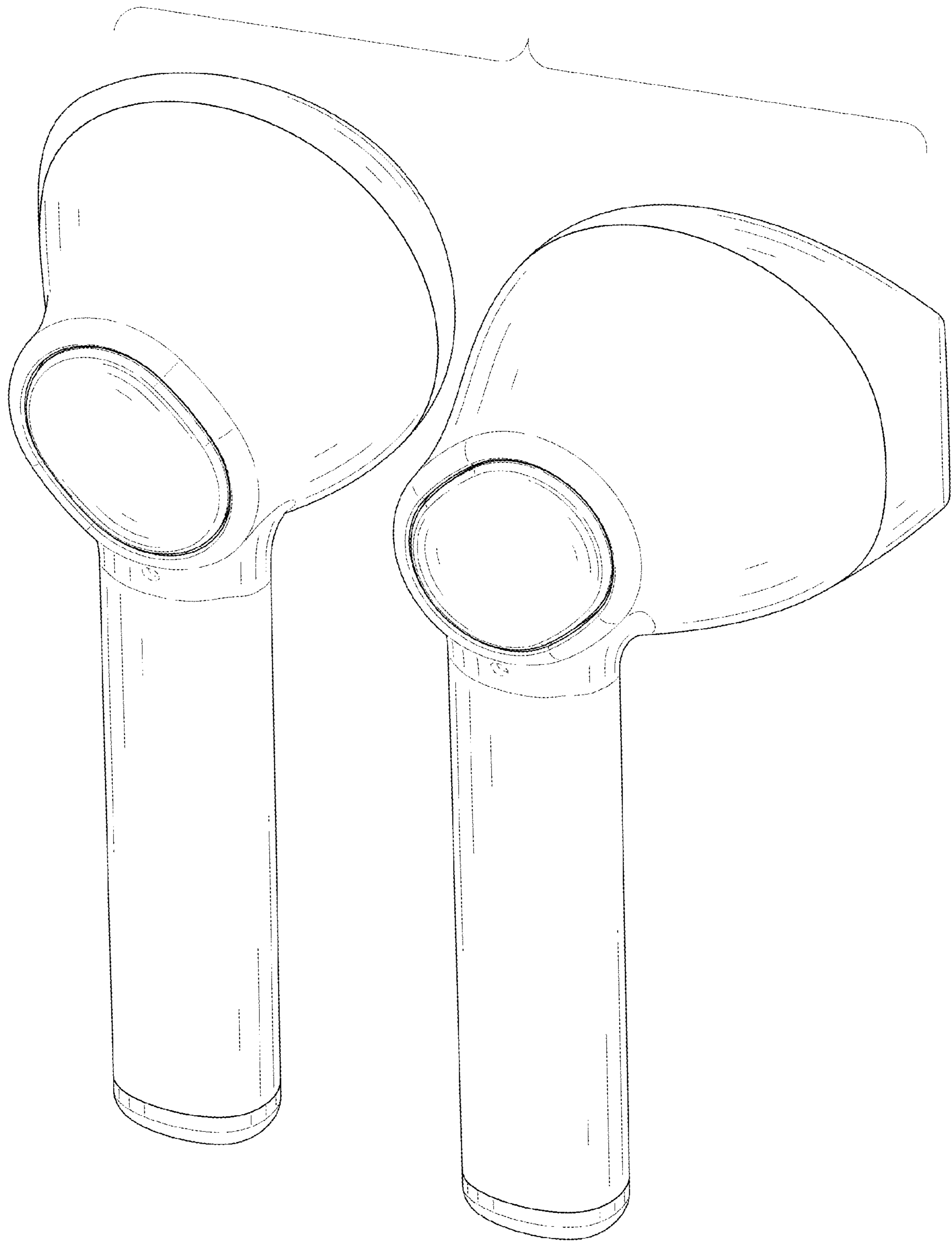

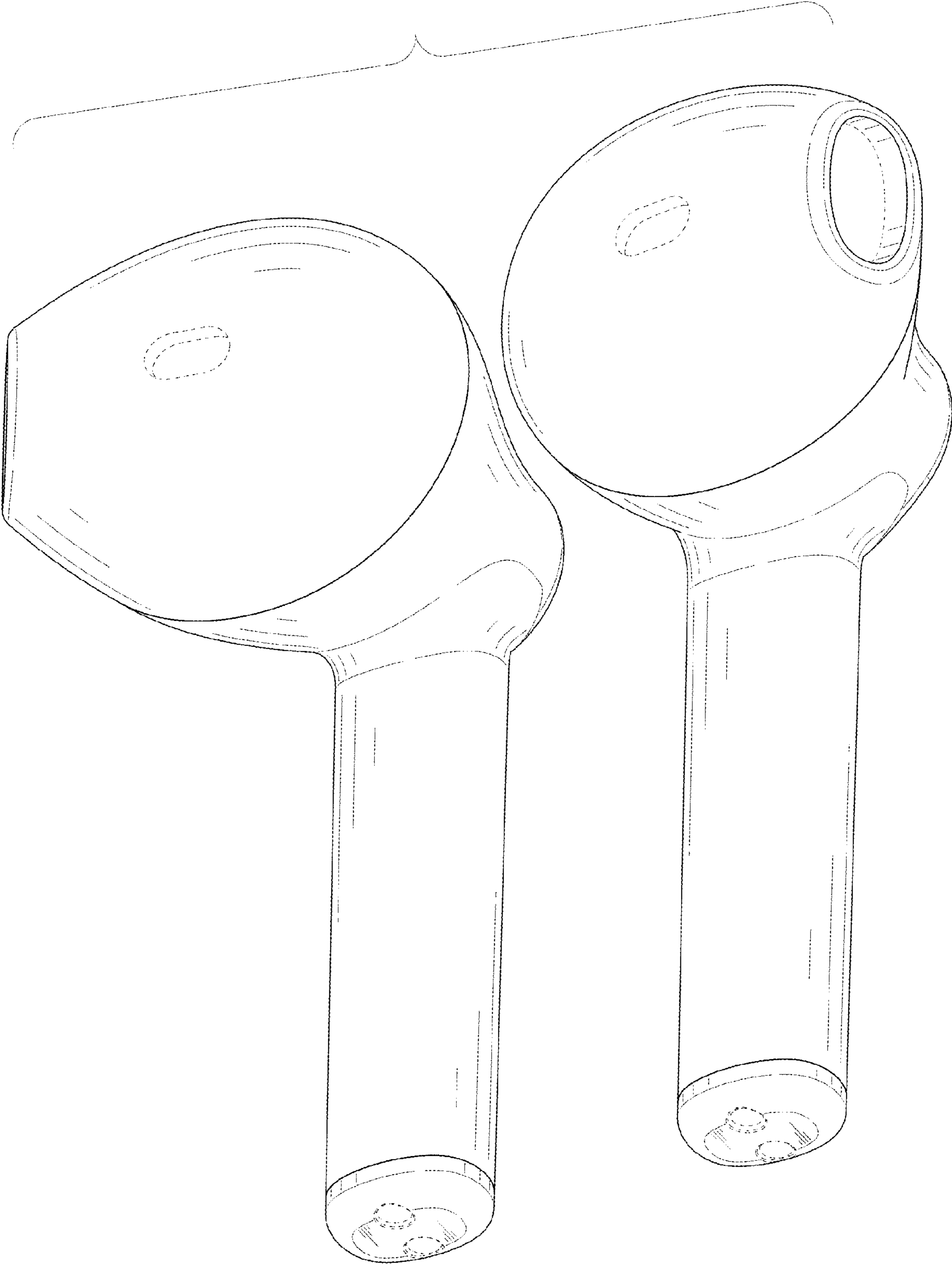

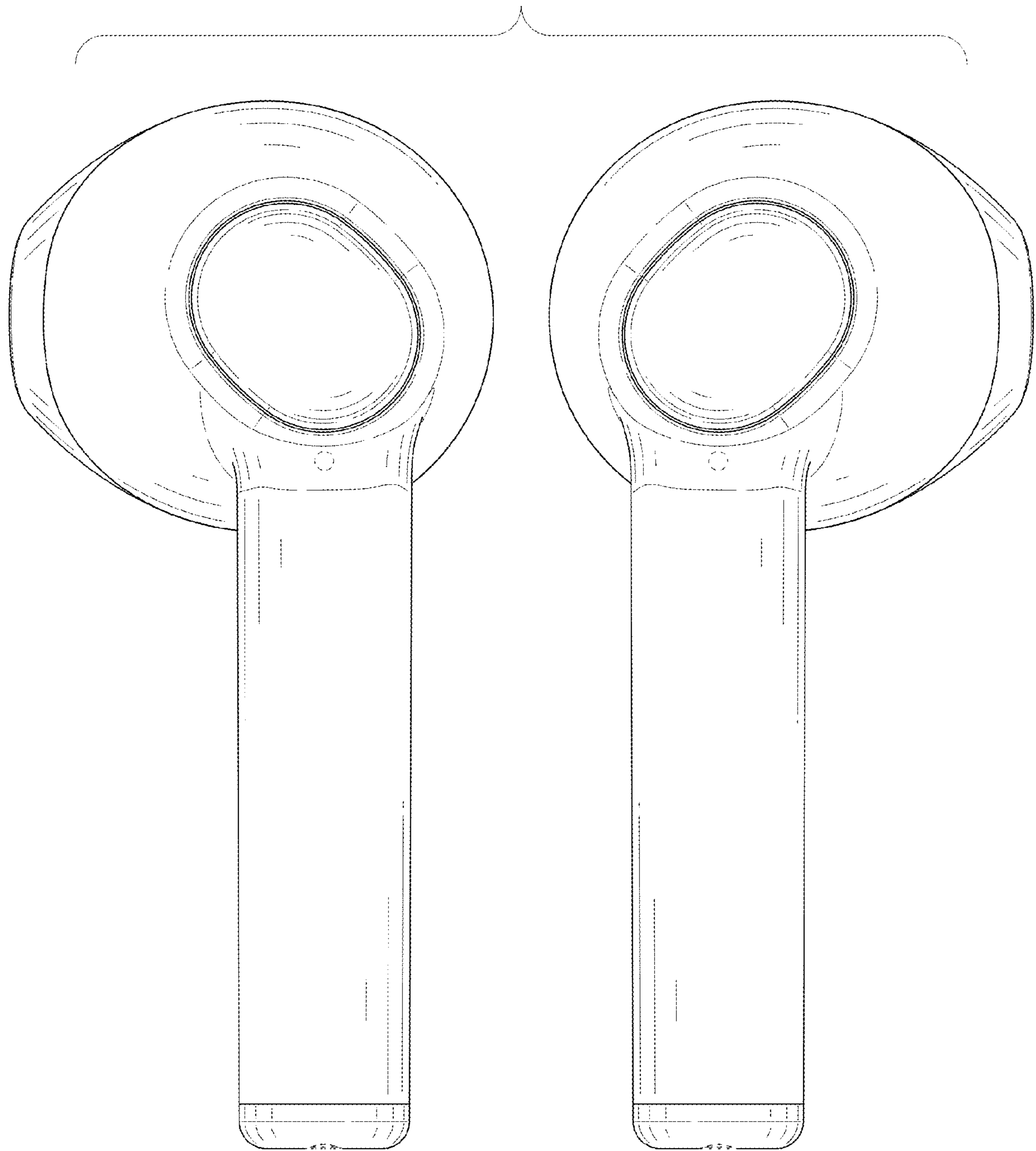

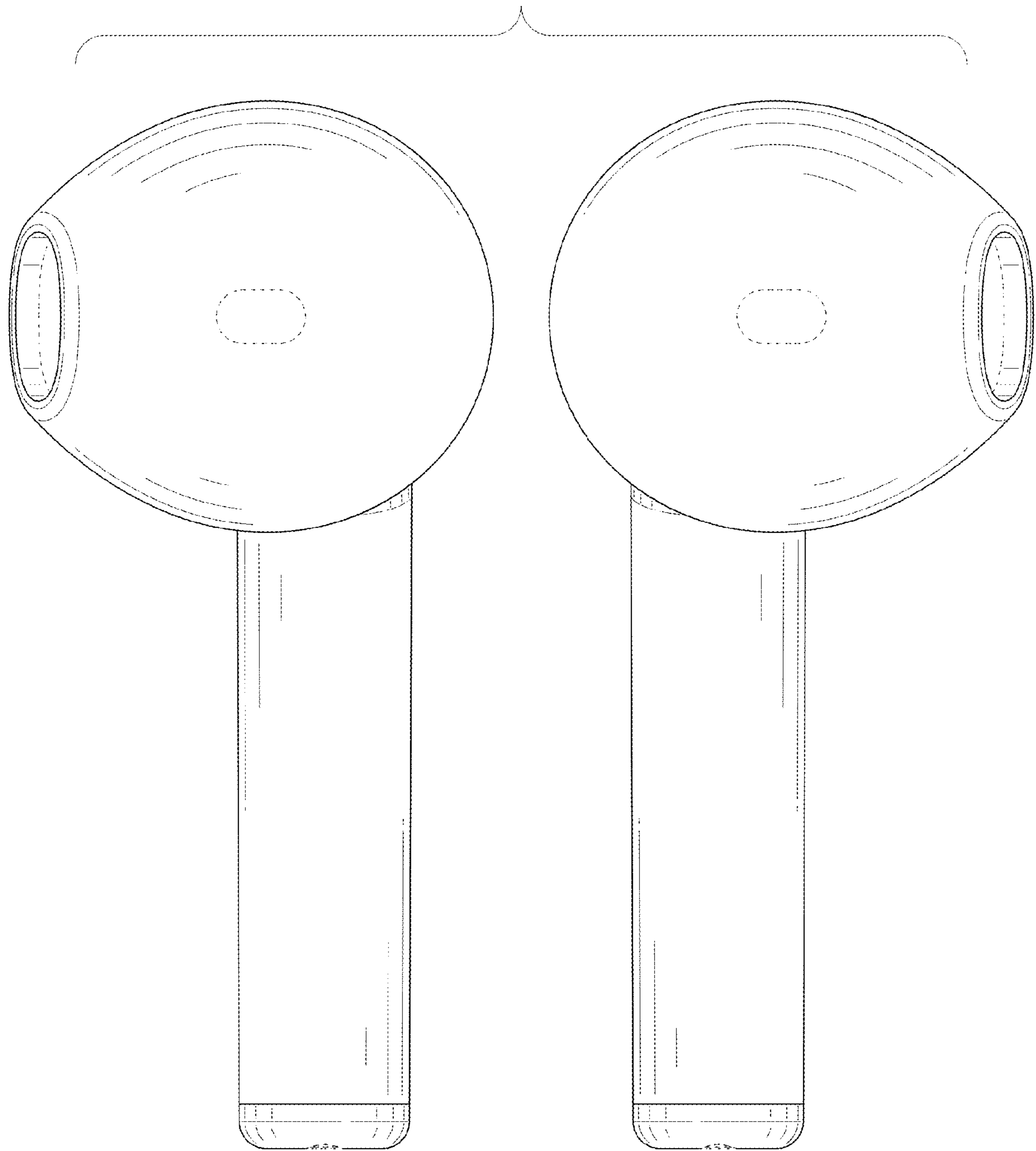

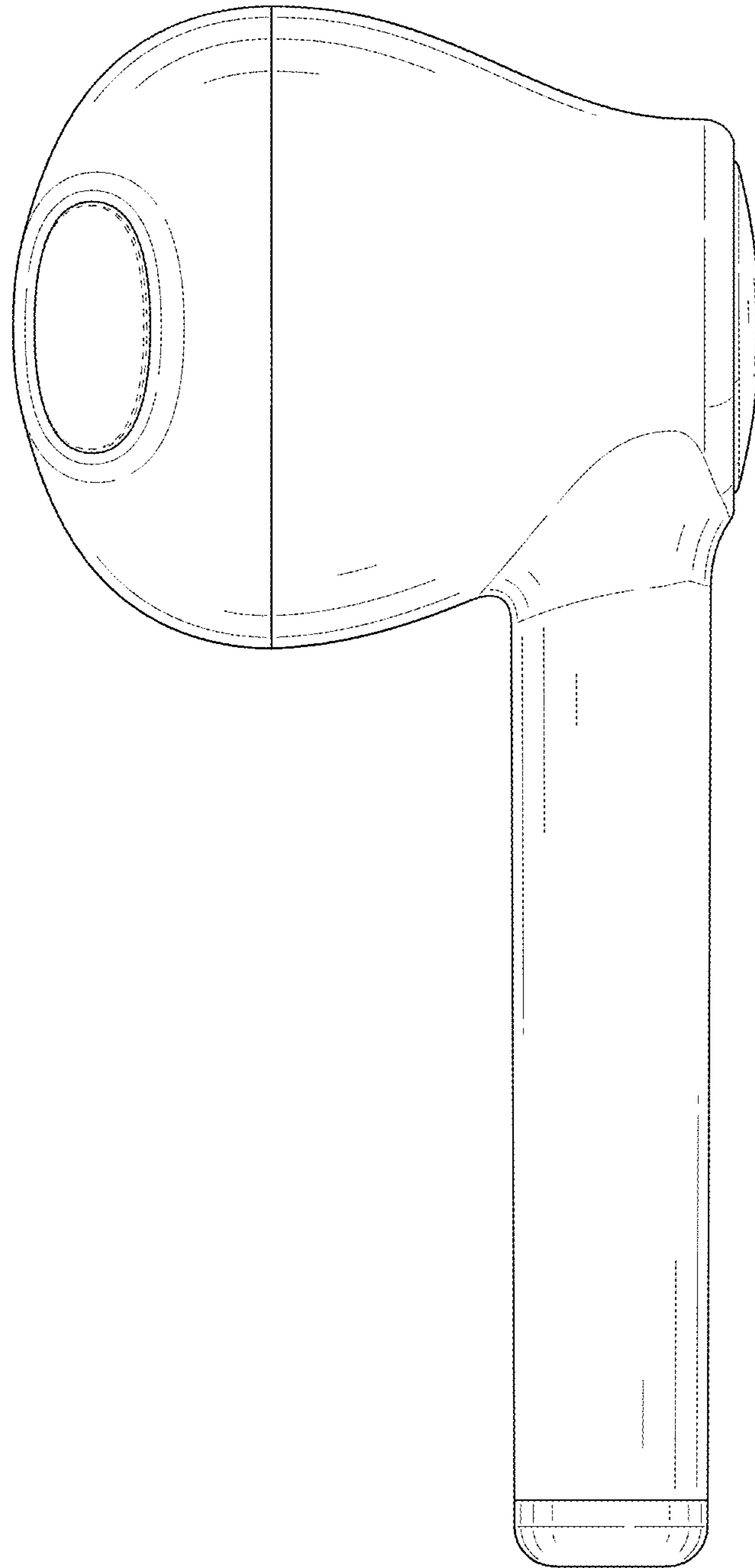

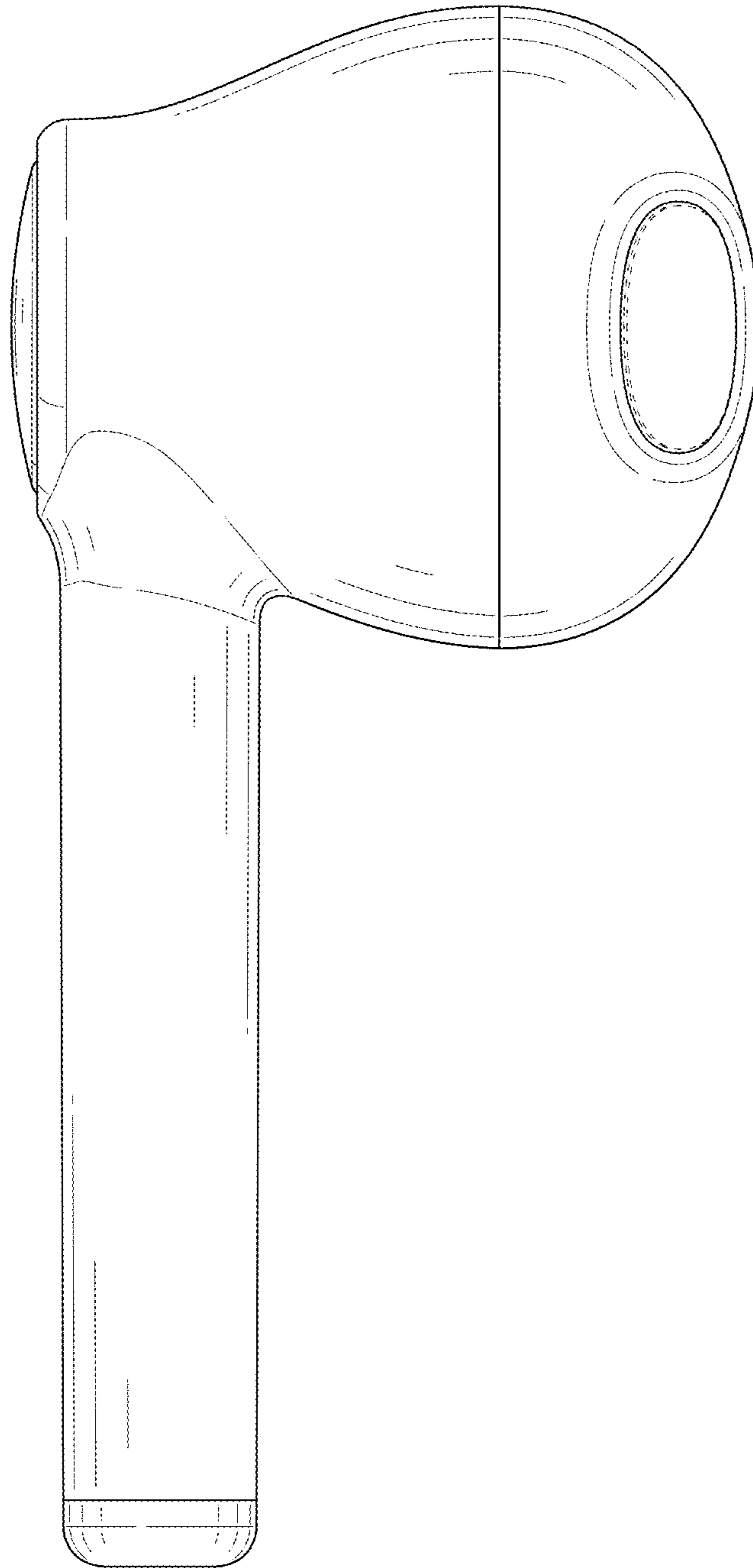

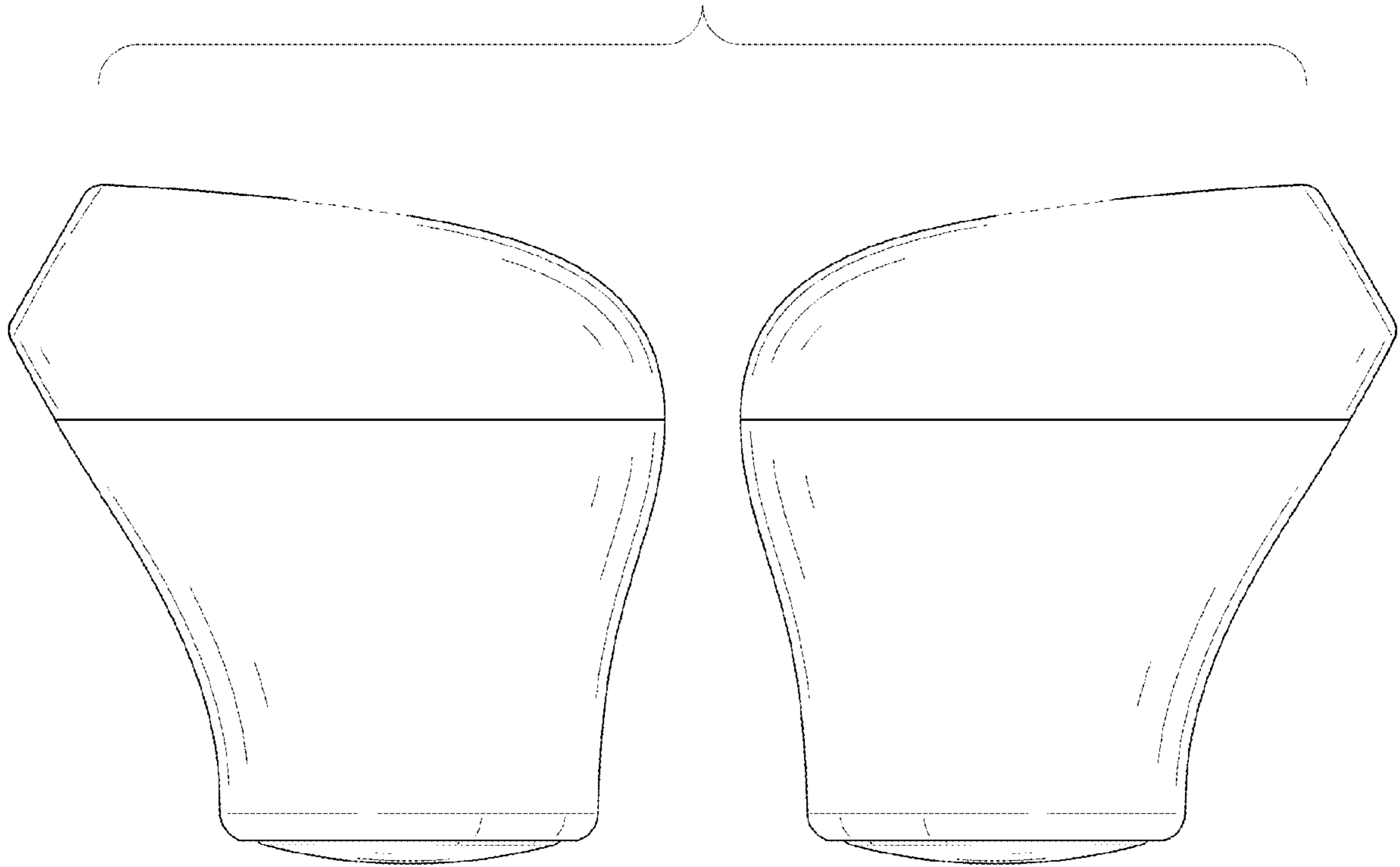

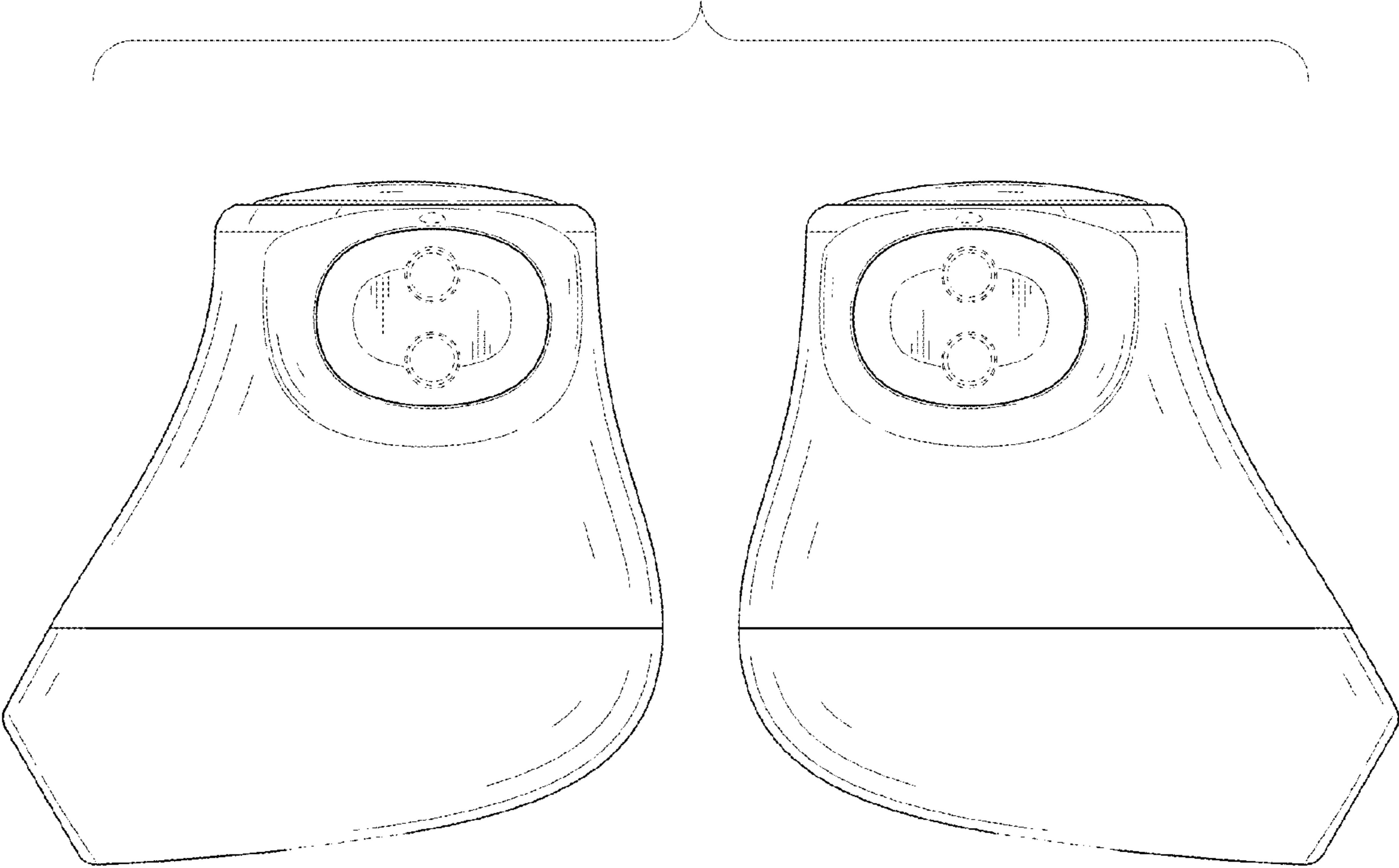
