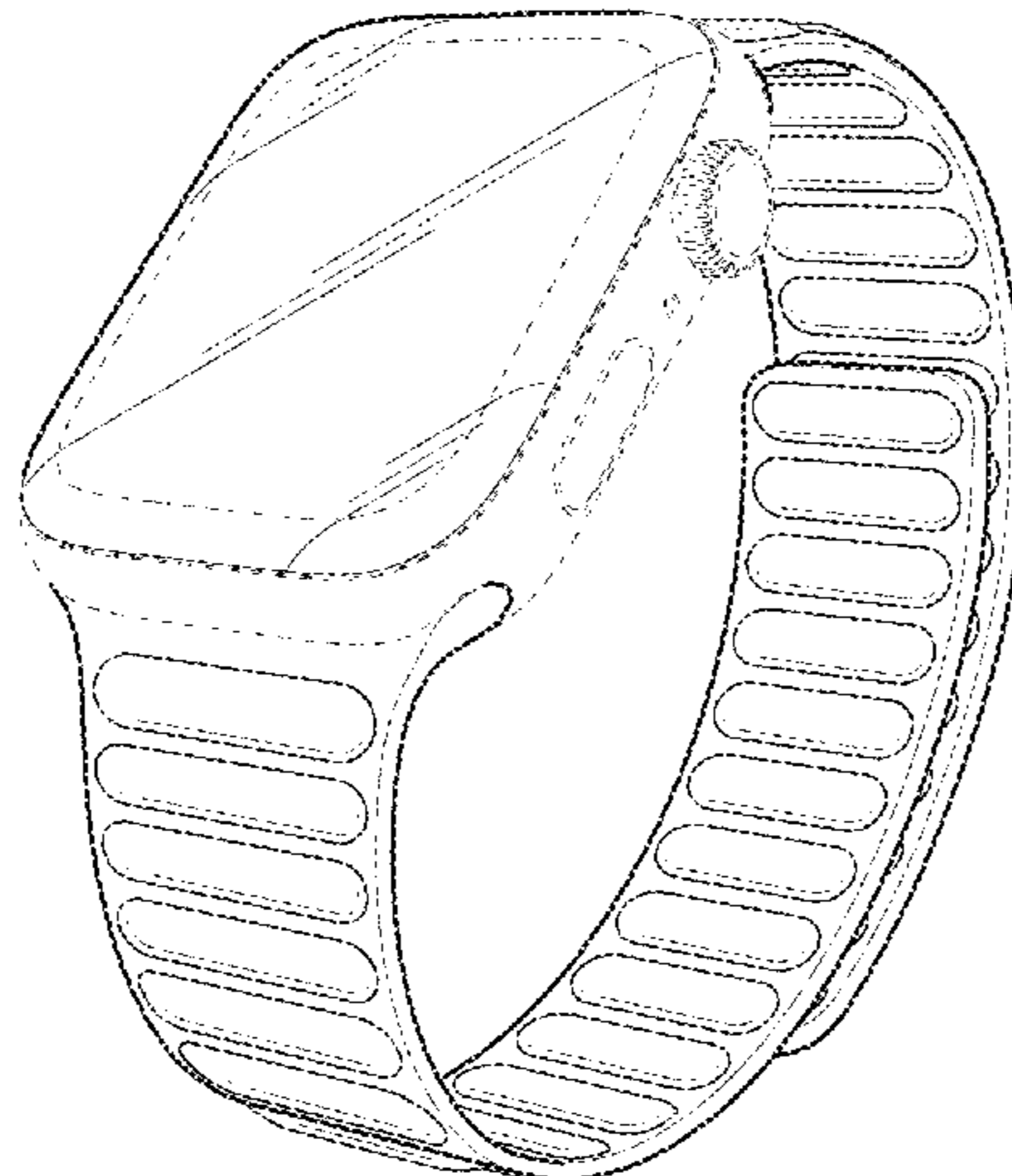

The ornamental design for a wearable device, as shown and described.

**DESCRIPTION**

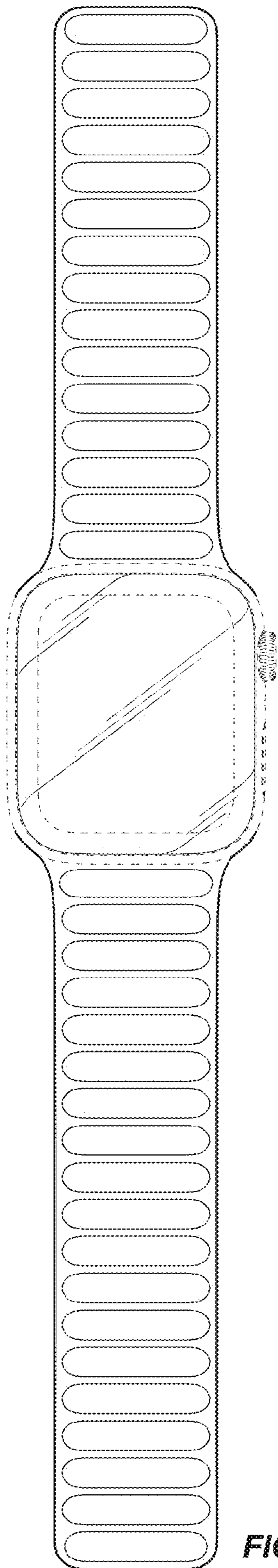

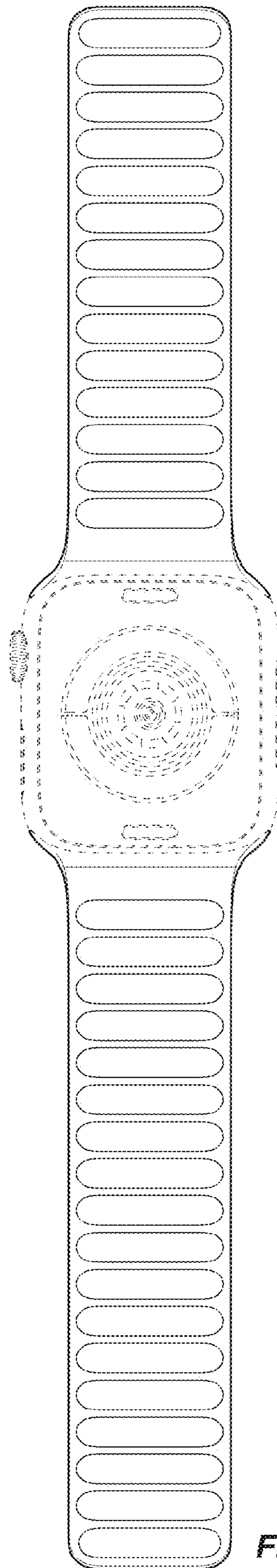

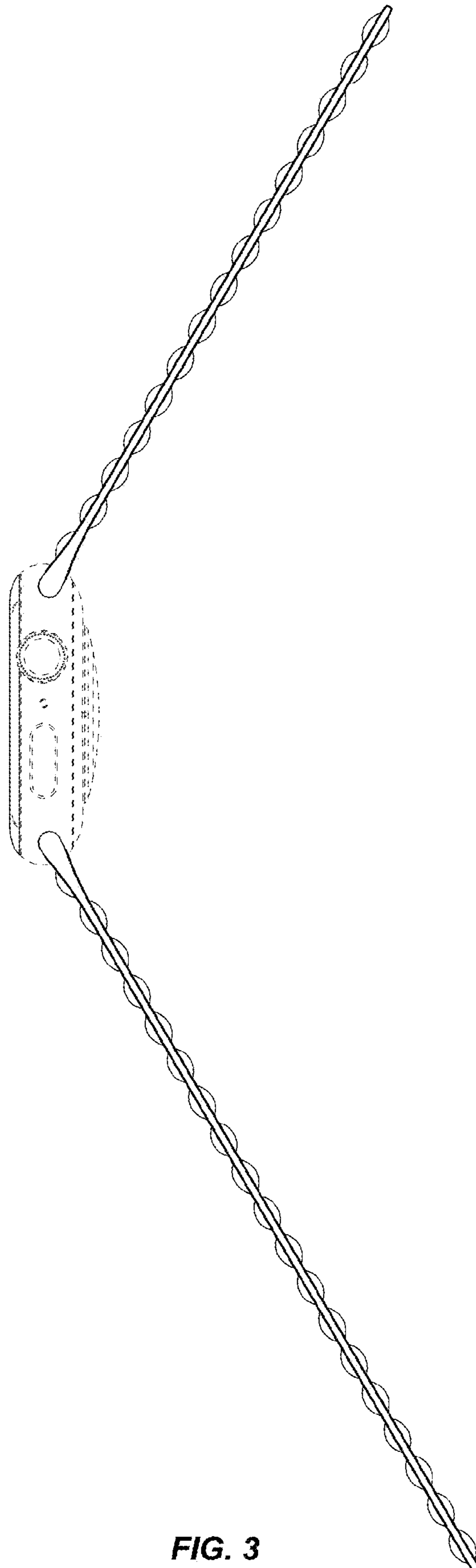

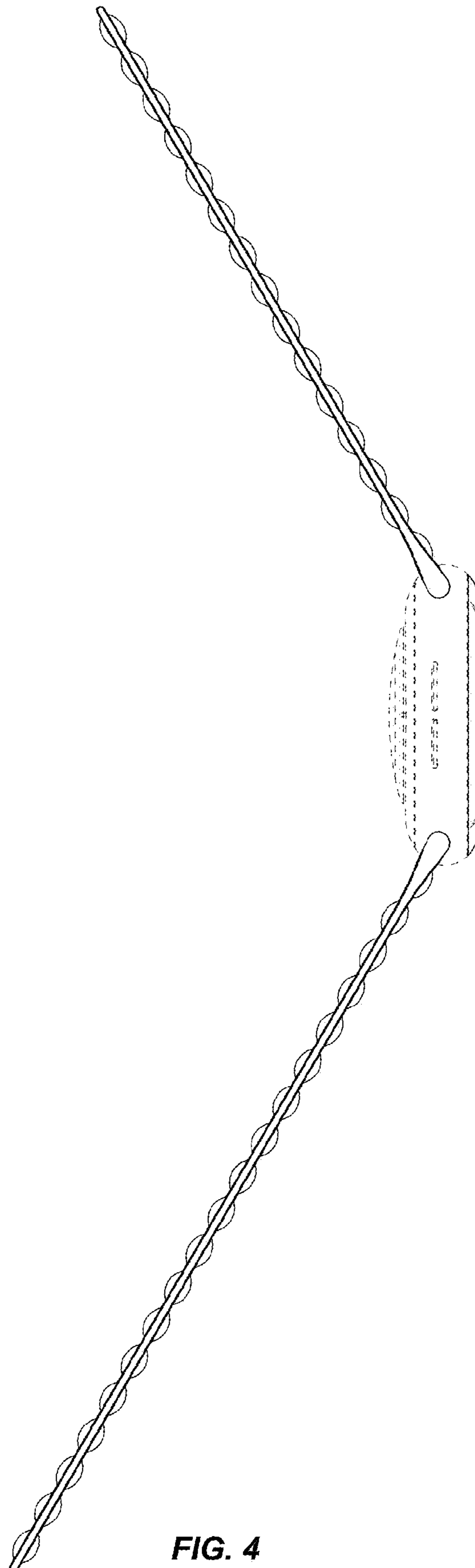
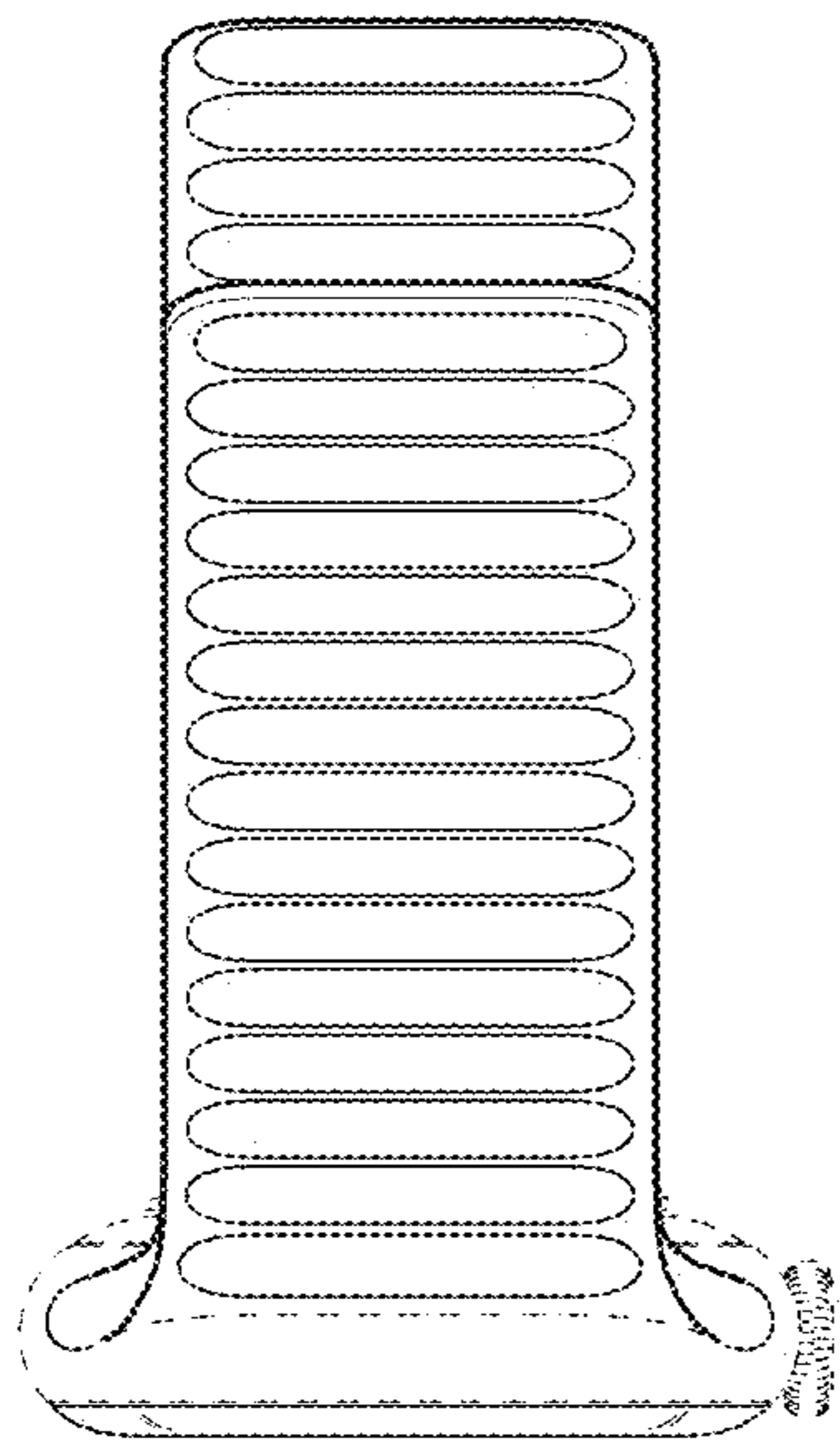
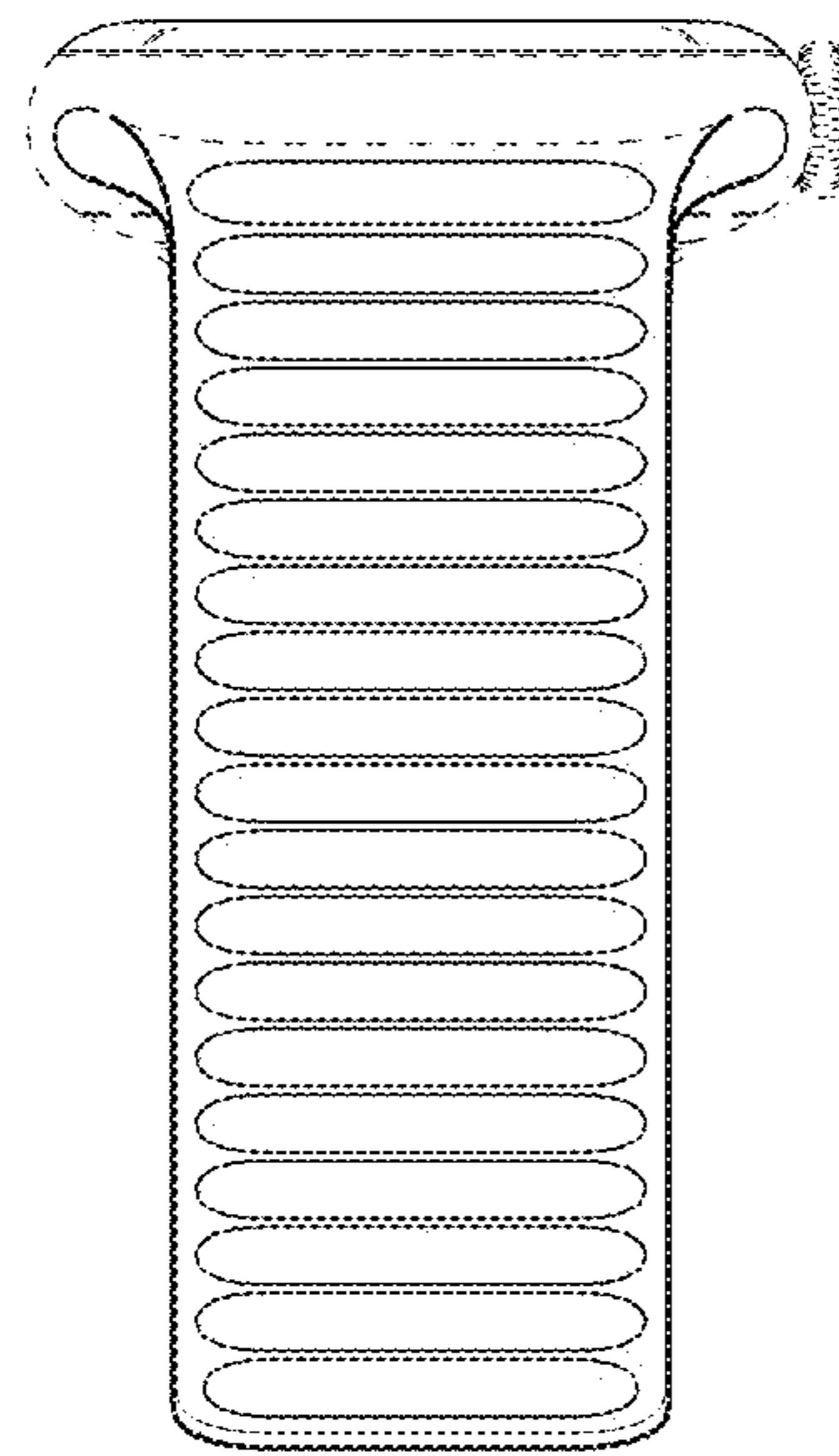

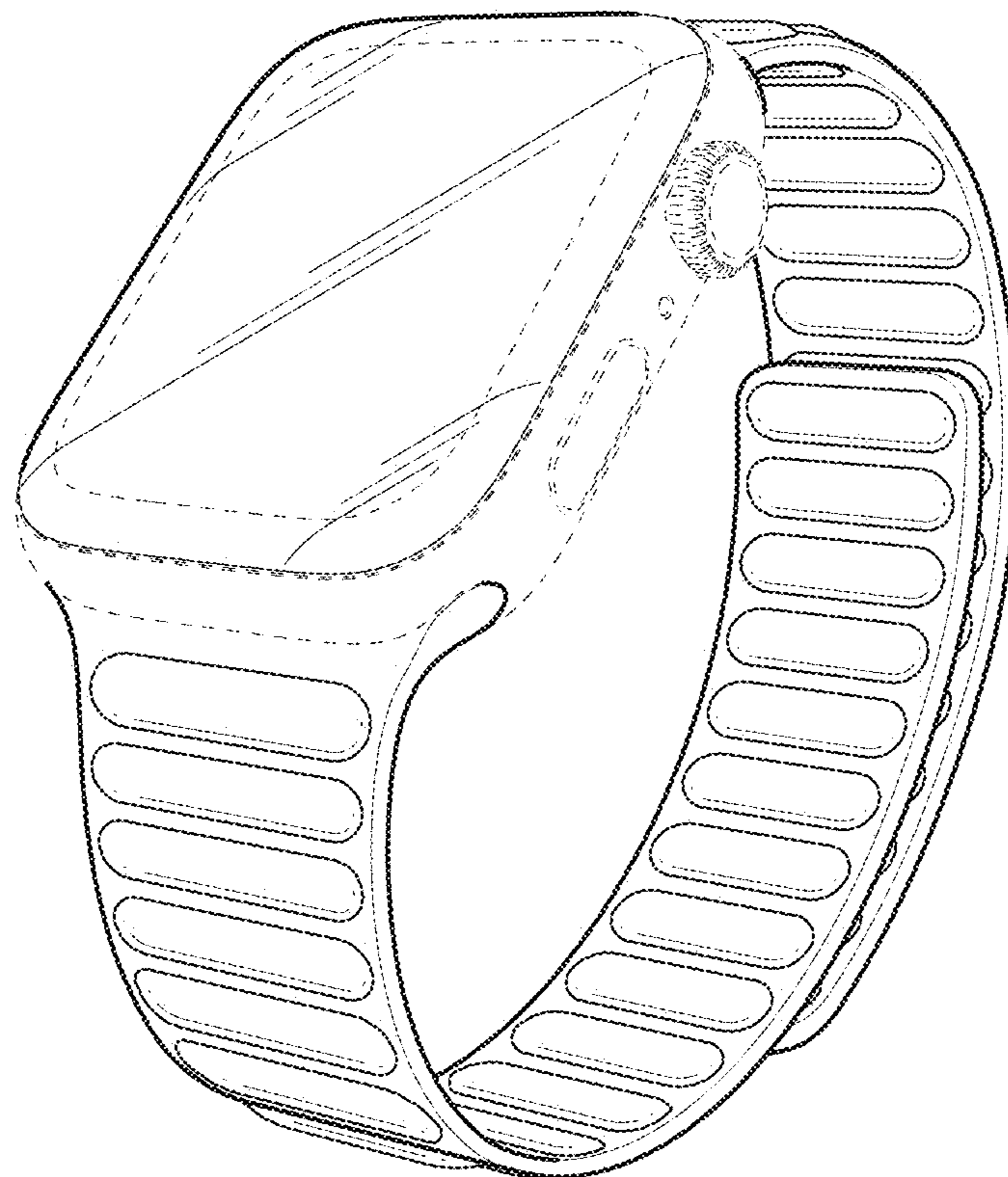
