DESCRIPTION

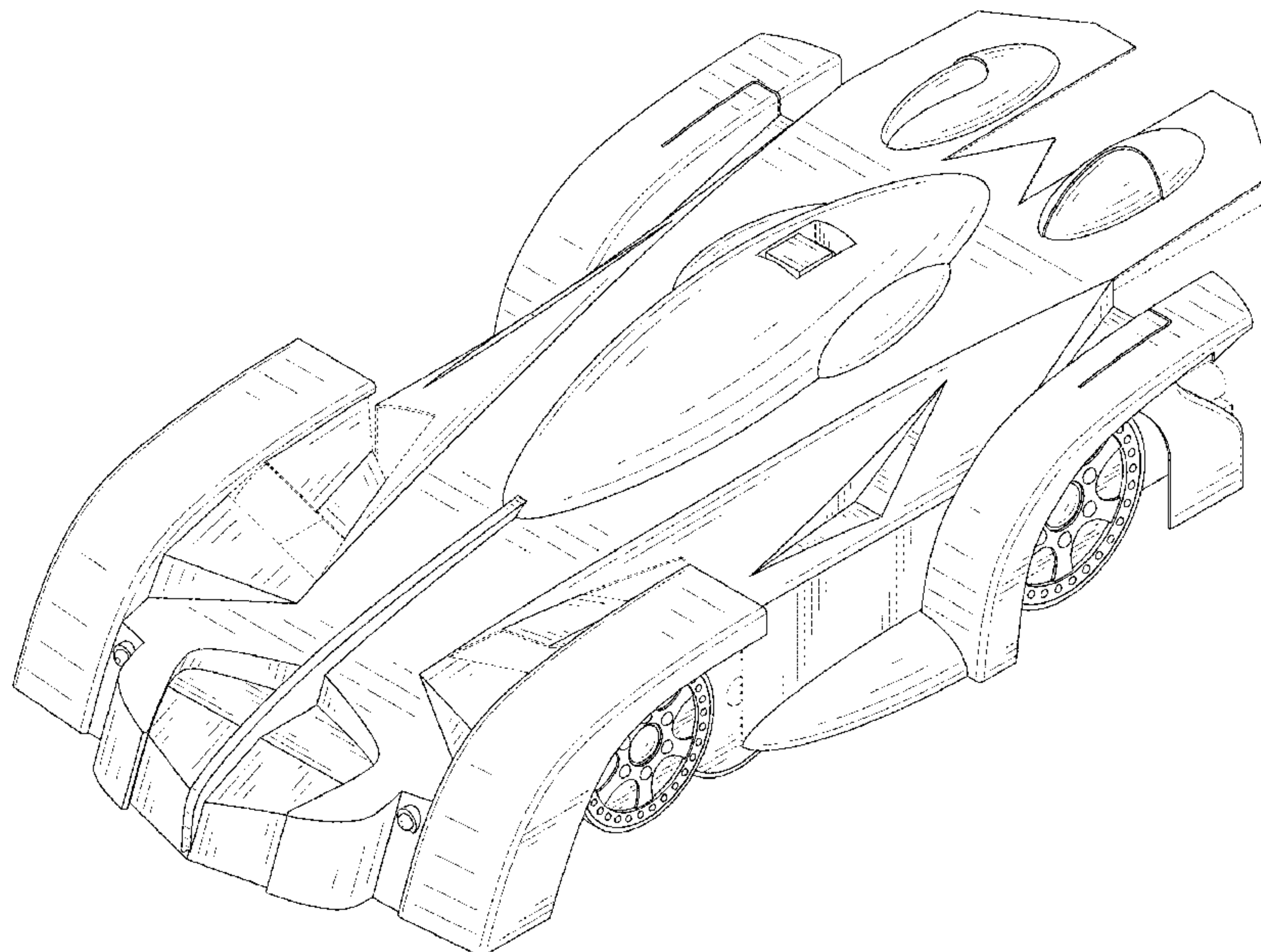
FIG. 1 is a first perspective view of a toy car showing my design;

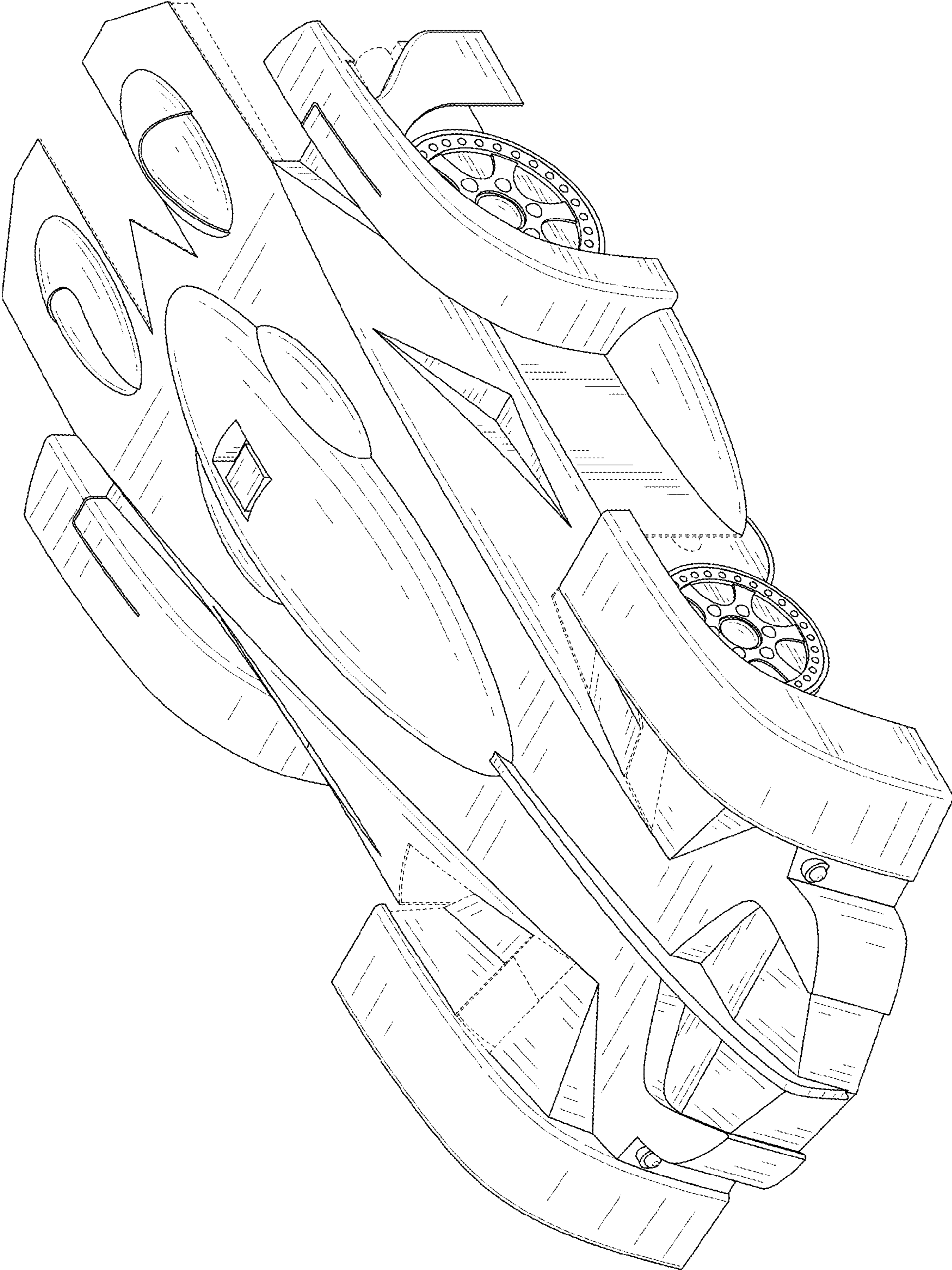

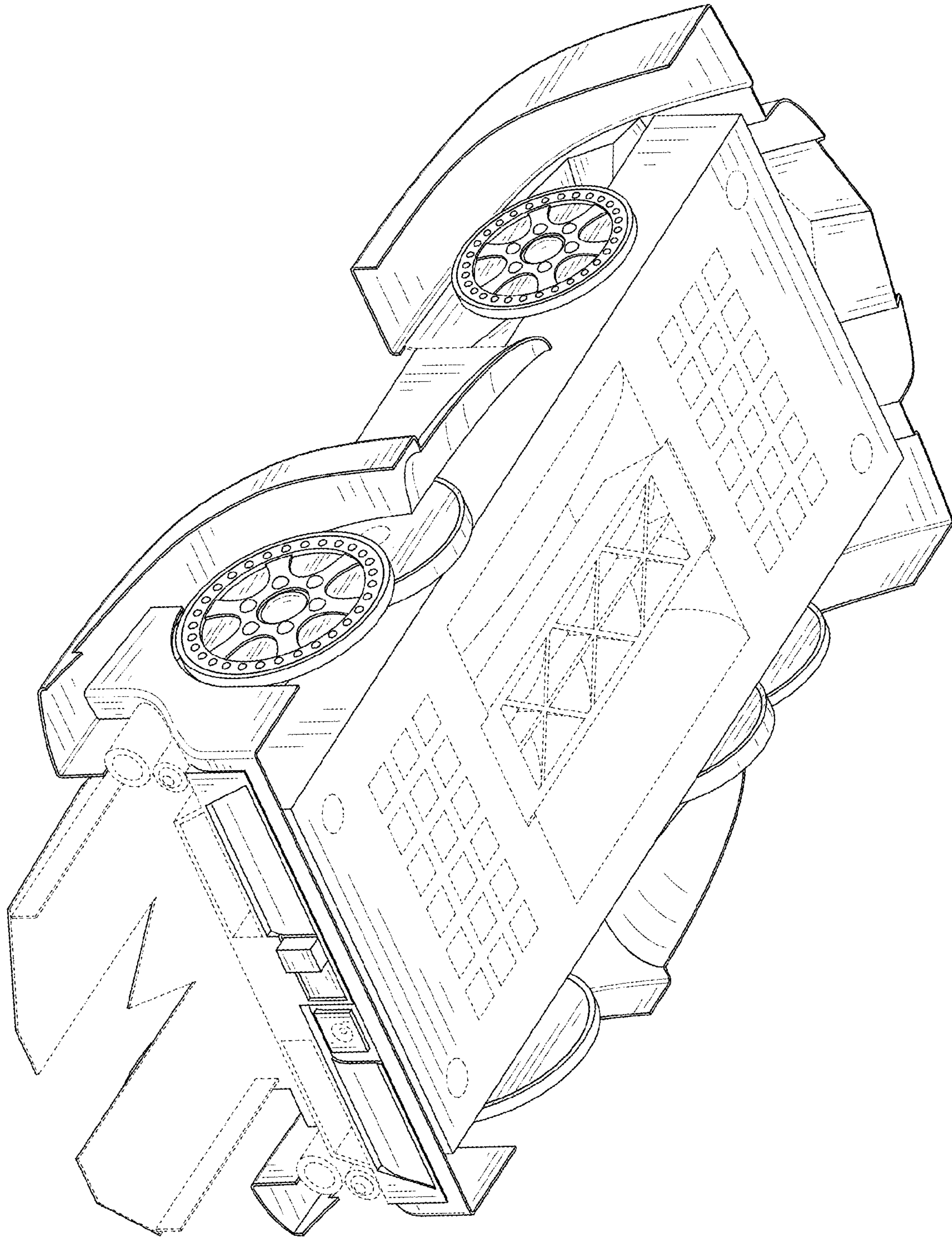

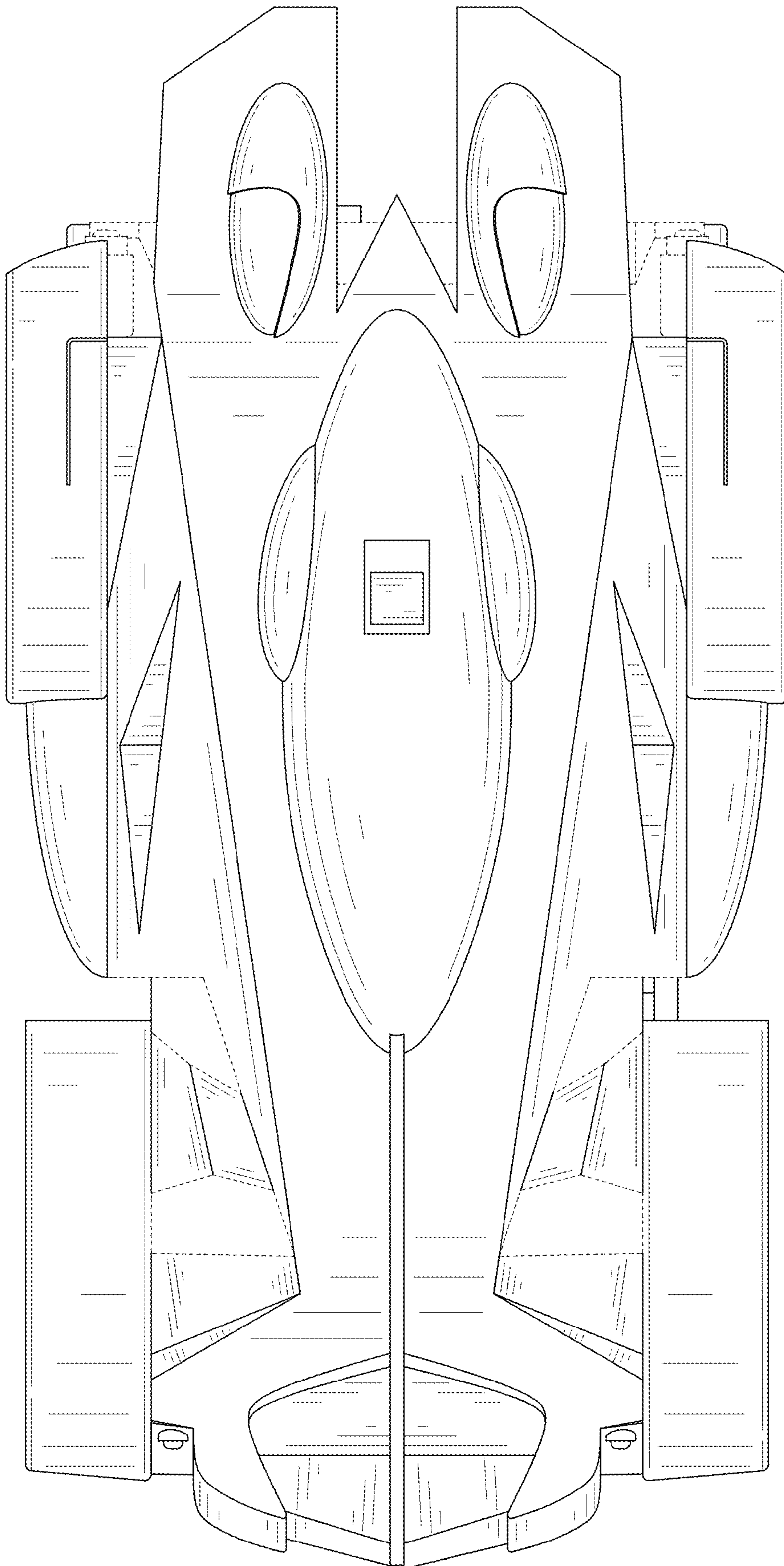

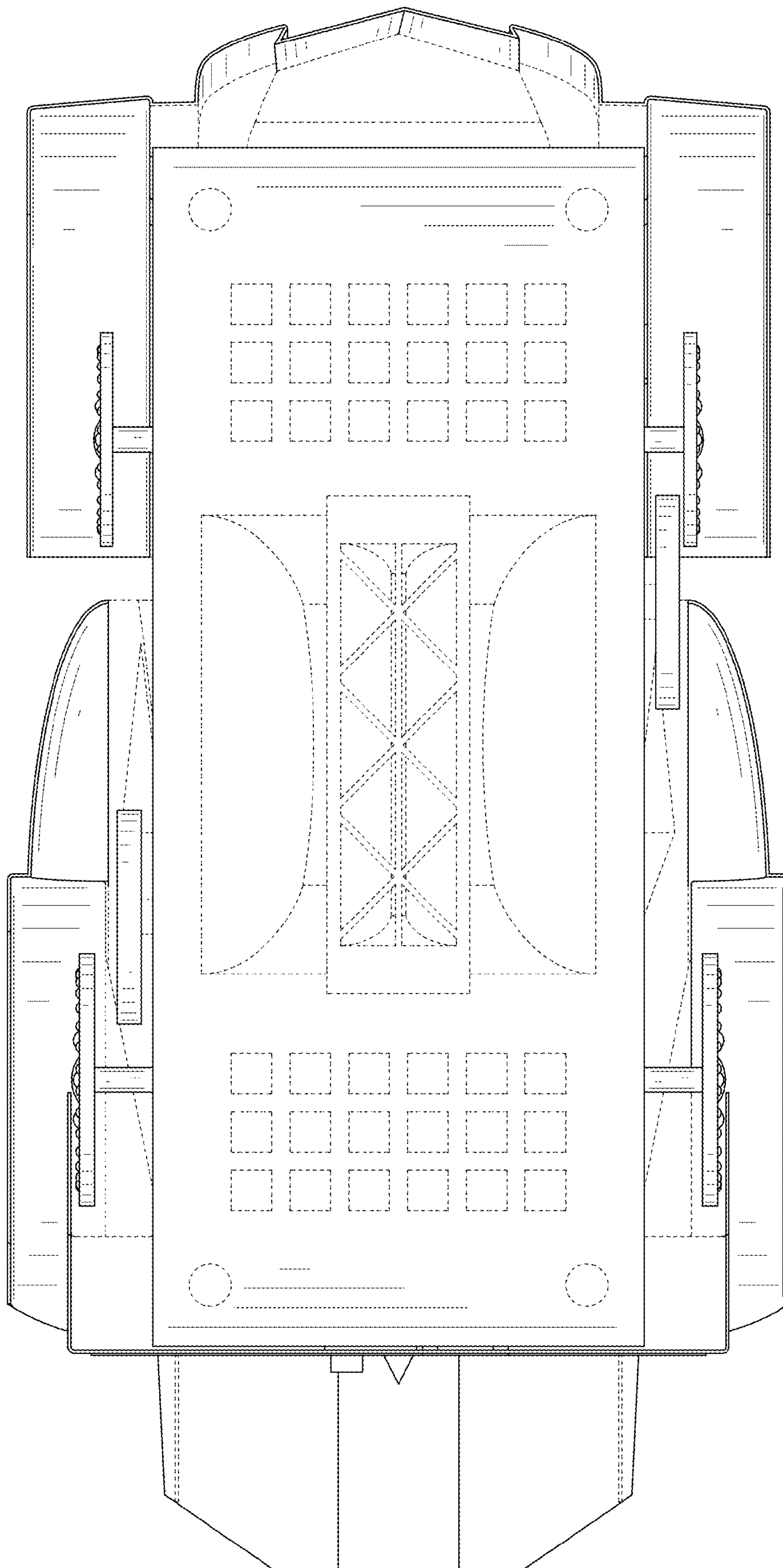

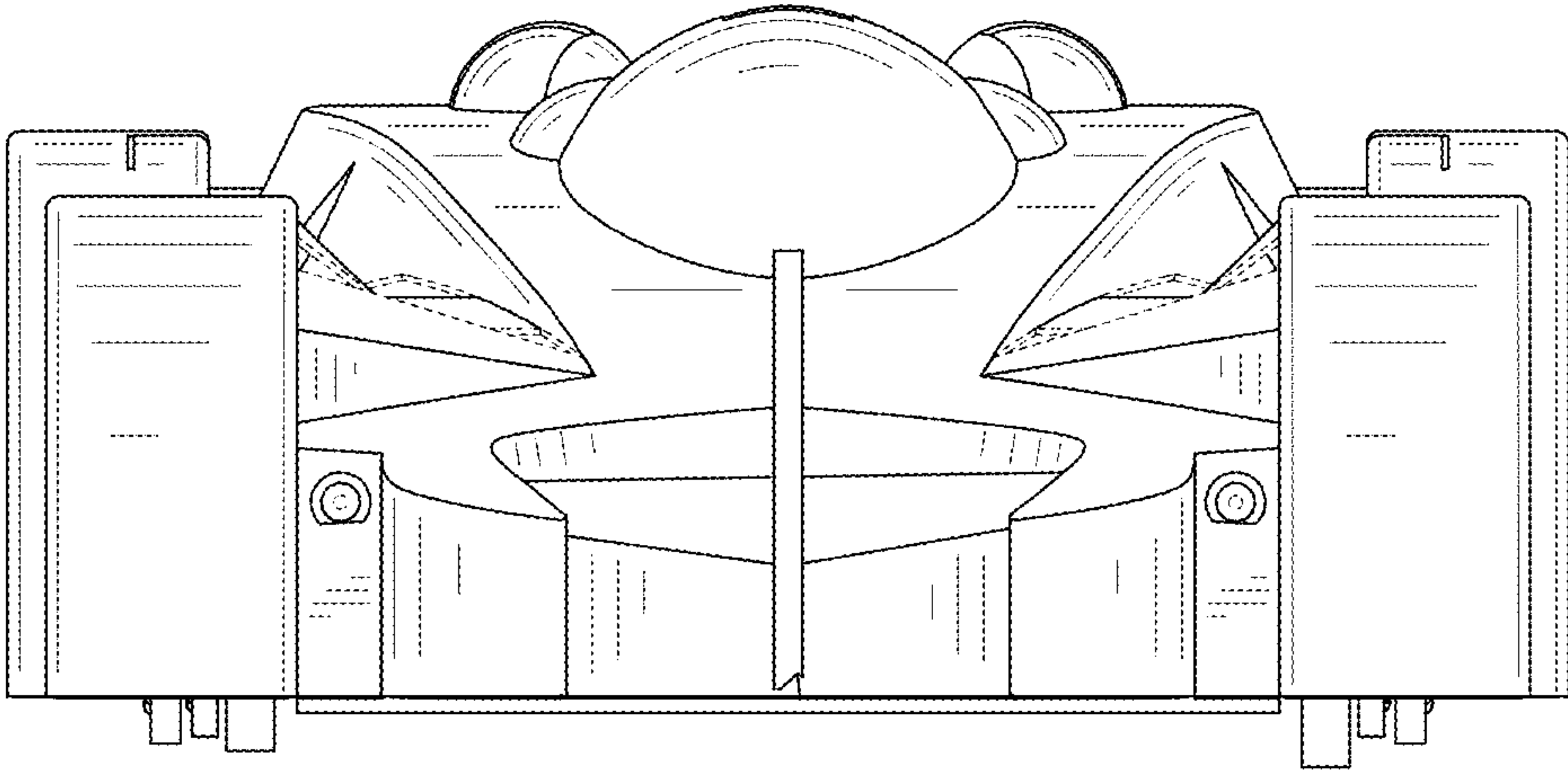

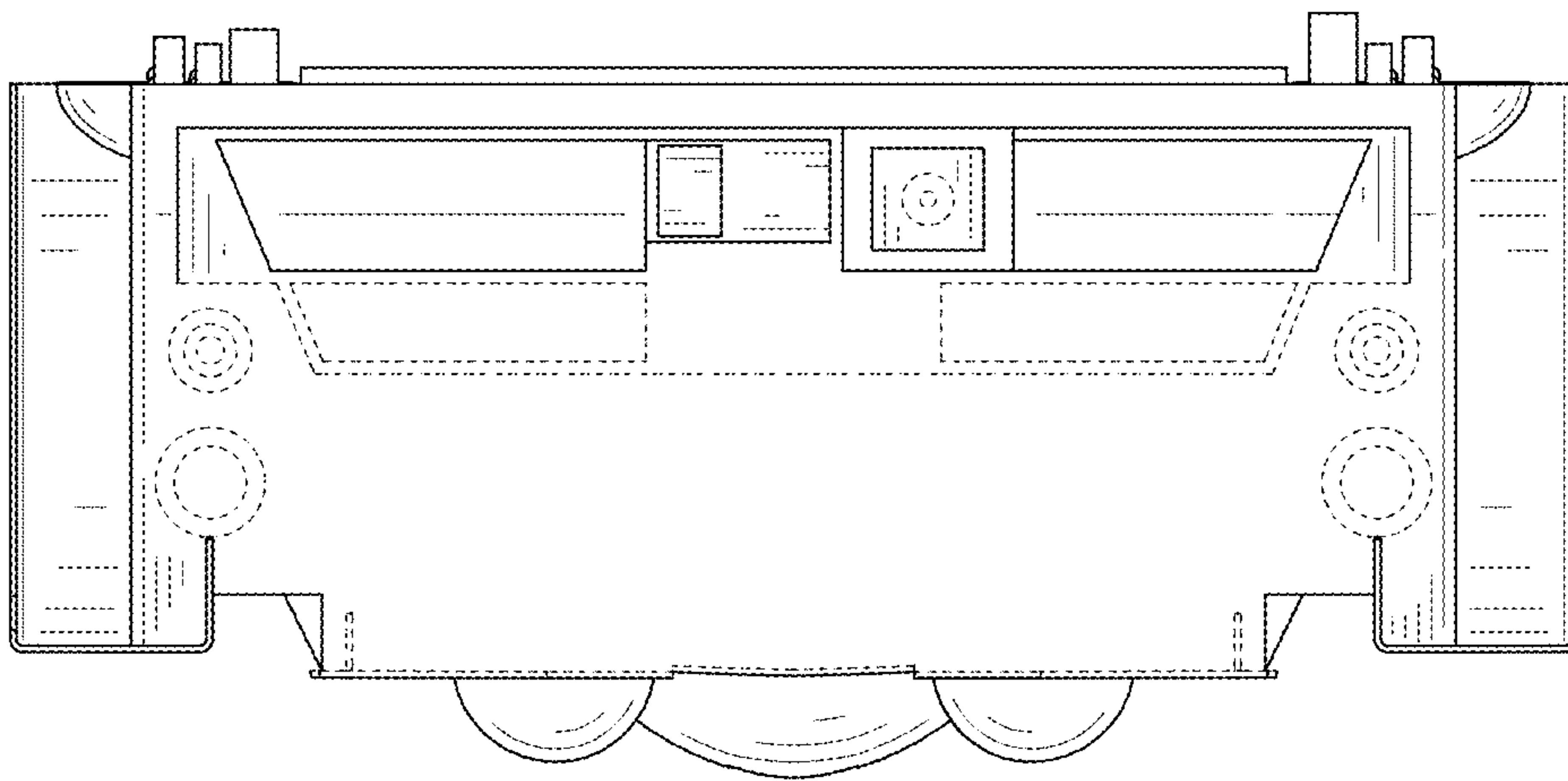

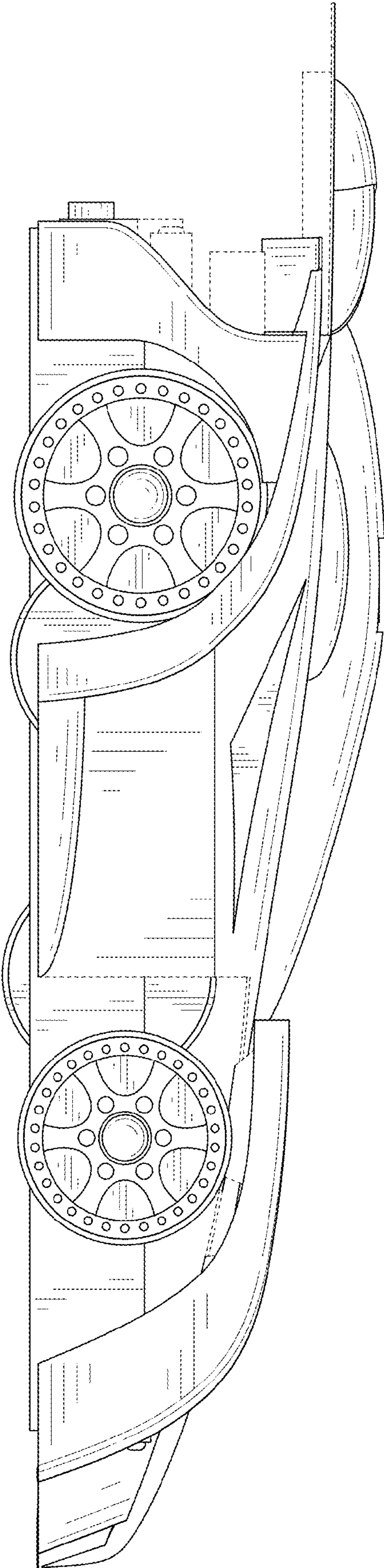

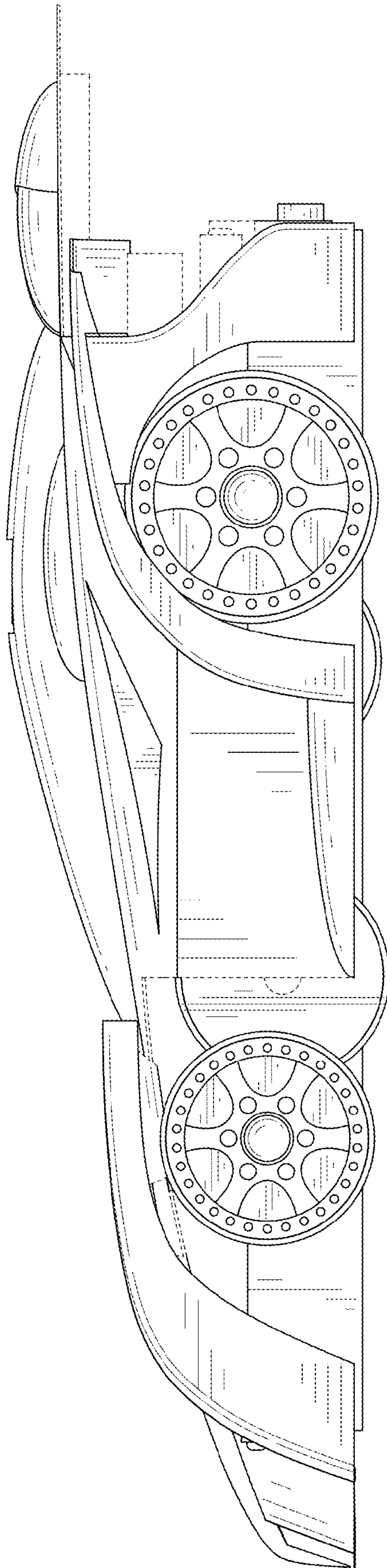
