FIG. 6 is a right side elevation thereof.

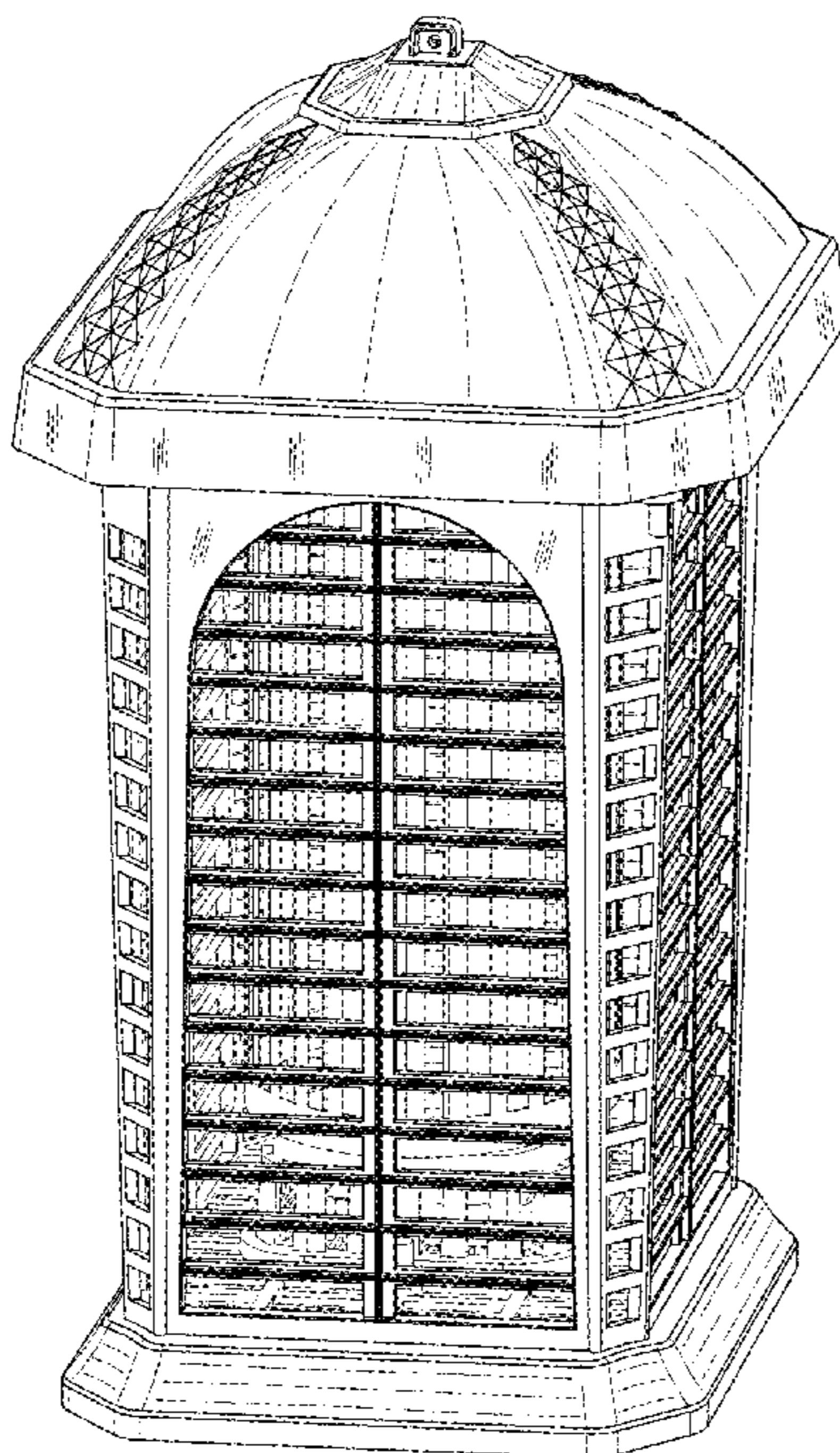
FIG. 7 is a top plan view thereof; and,

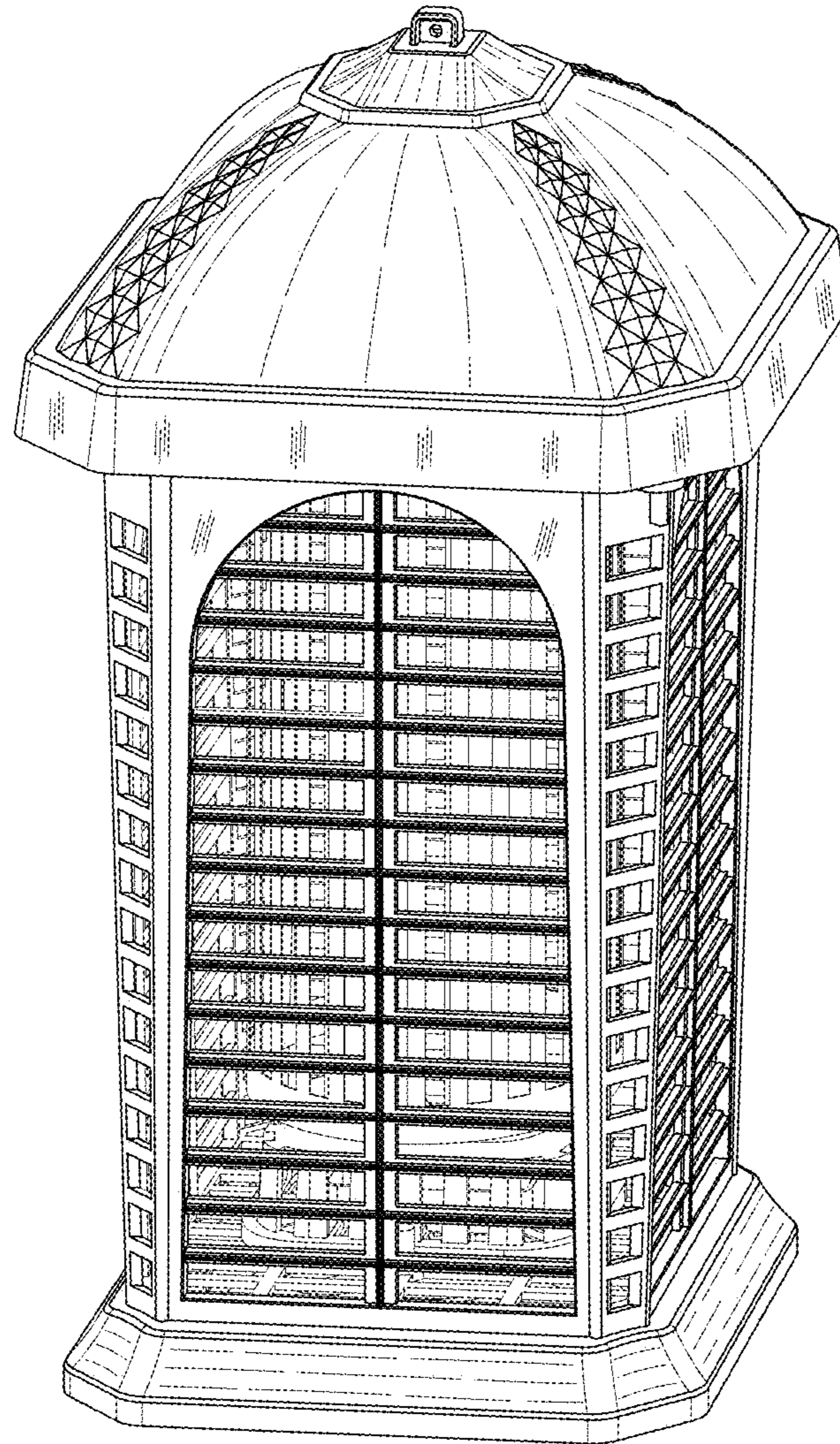

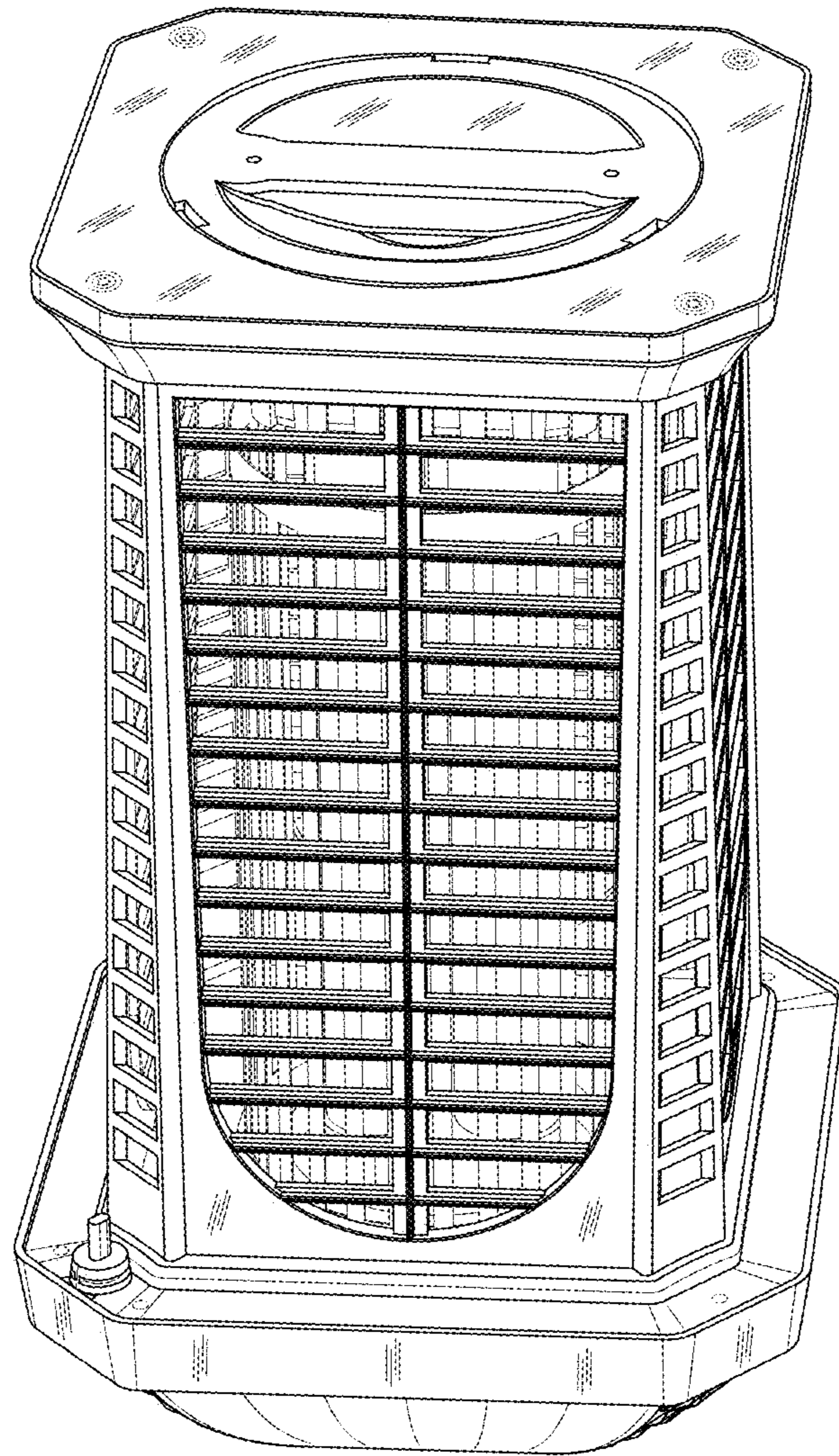

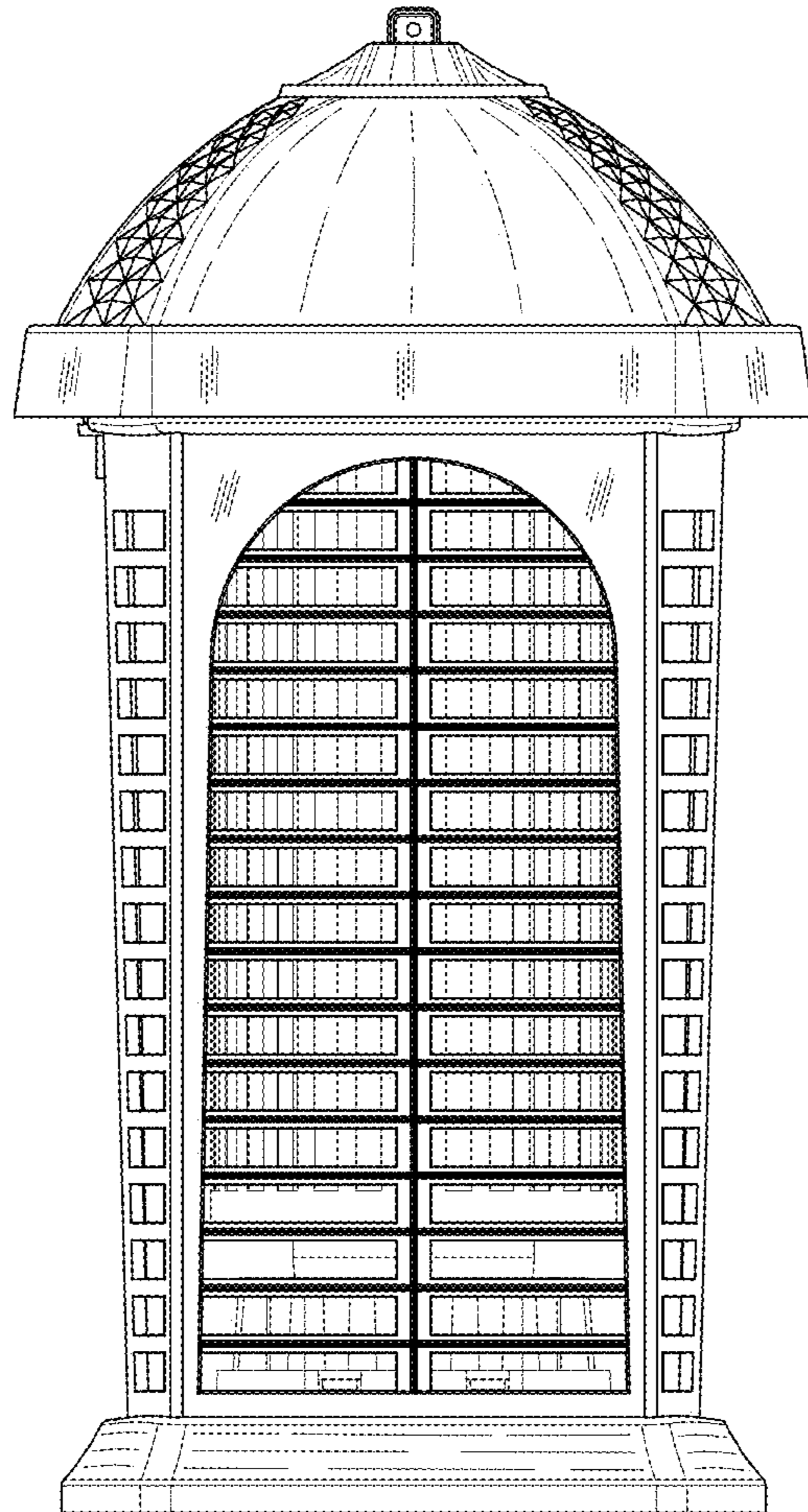

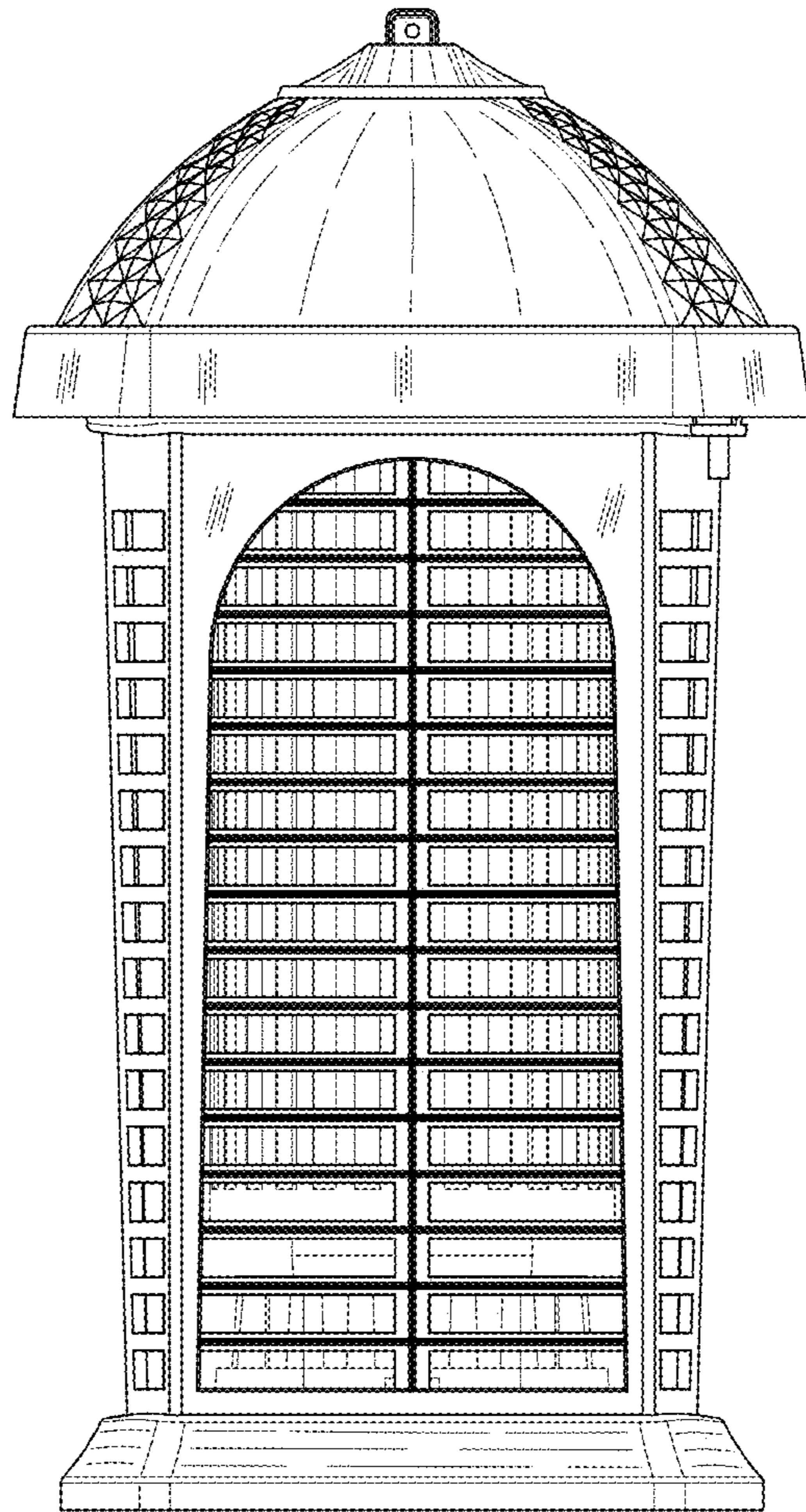

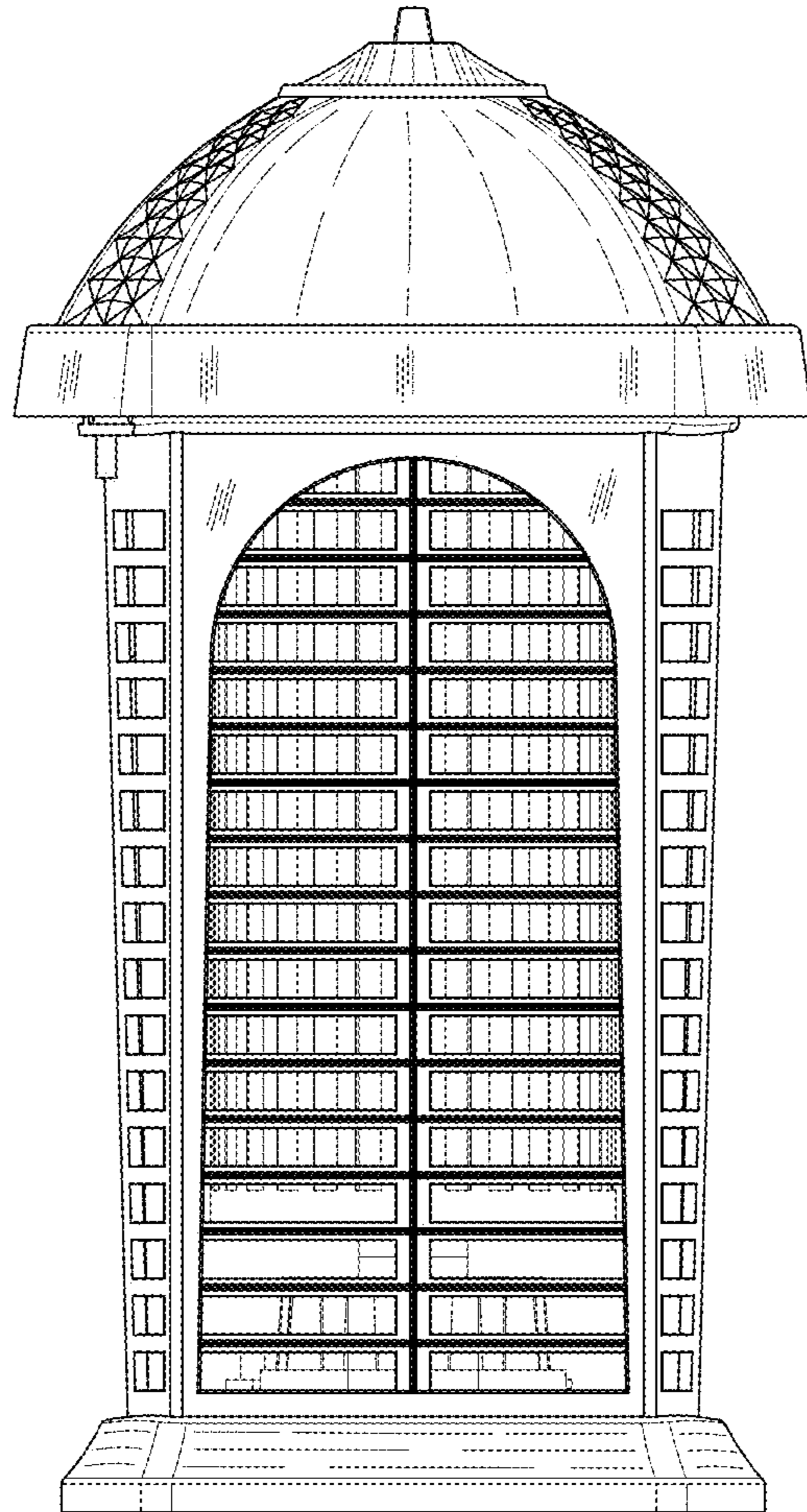

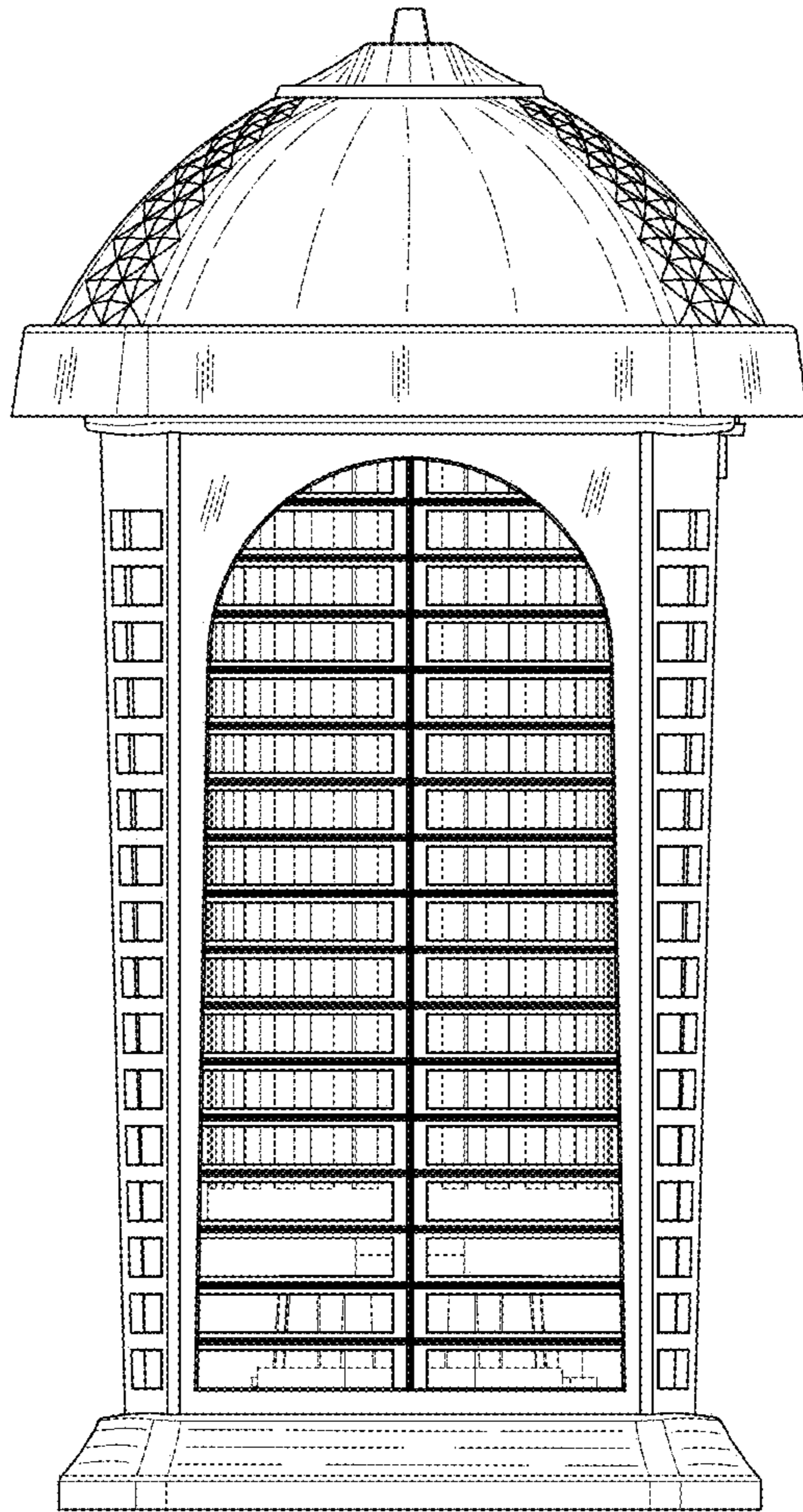

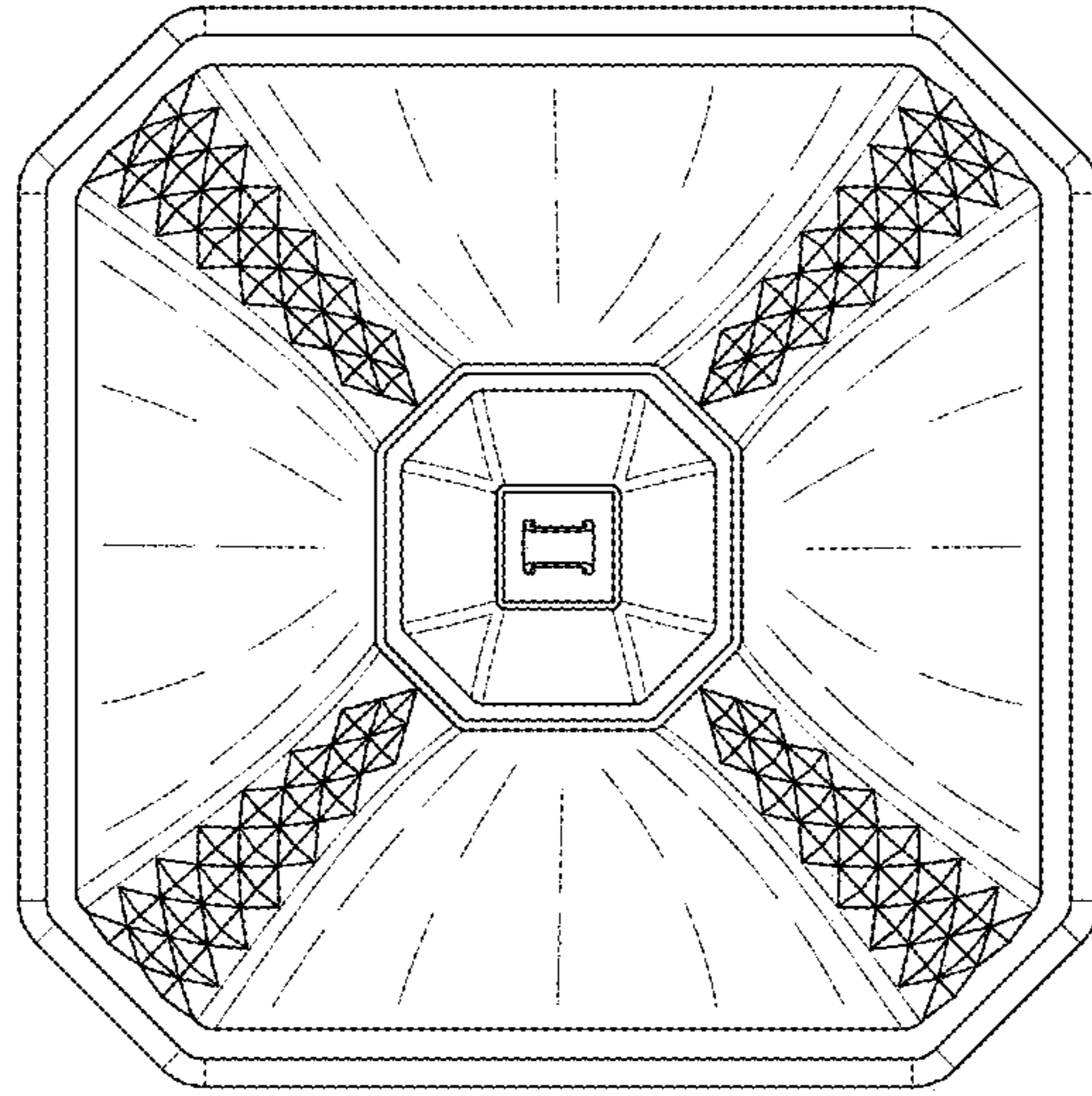

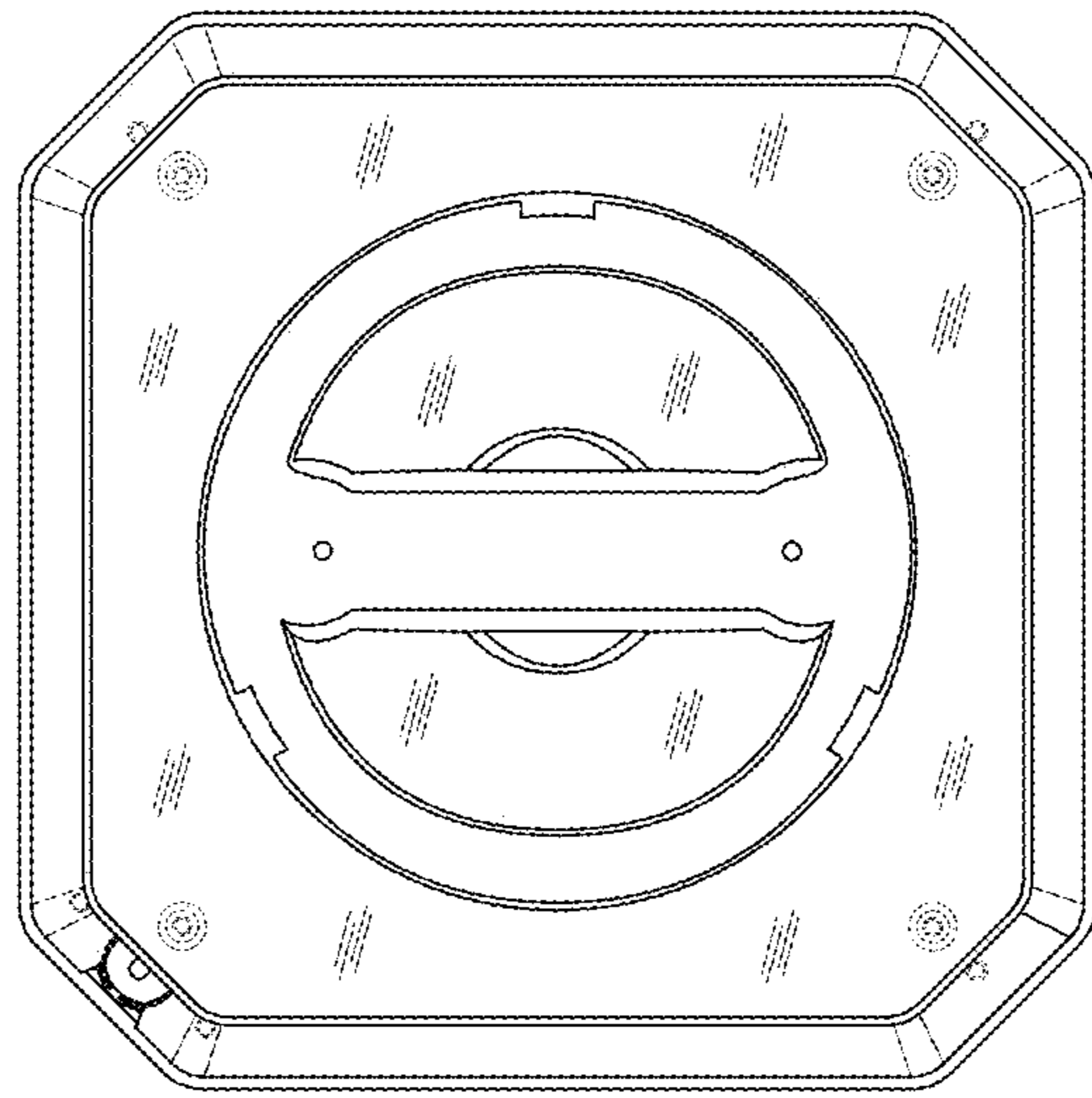
