DESCRIPTION

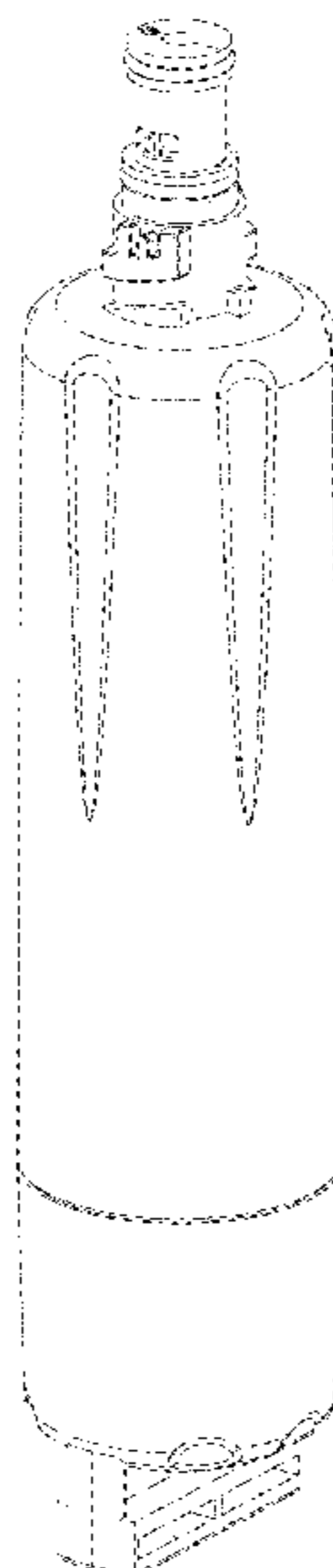
FIG. 1 is a top right perspective view showing filter, showing my new design;

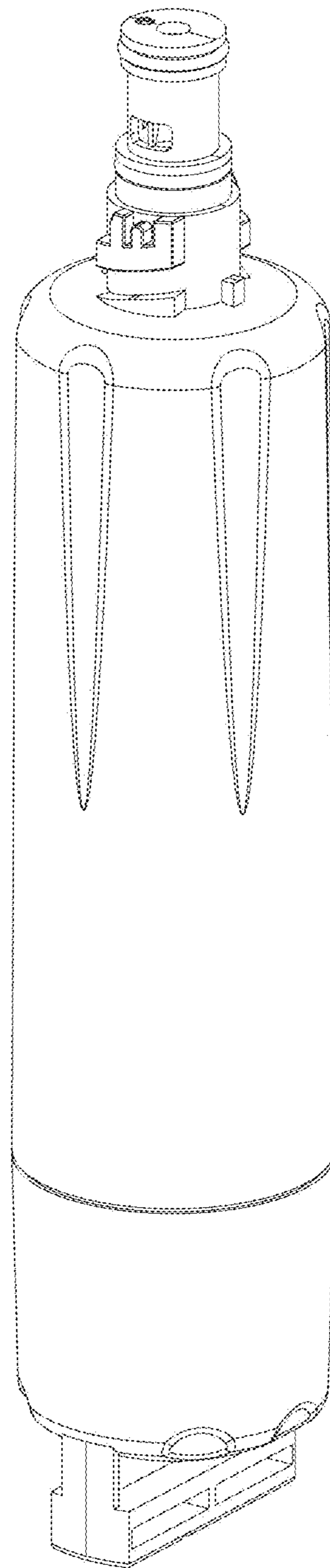

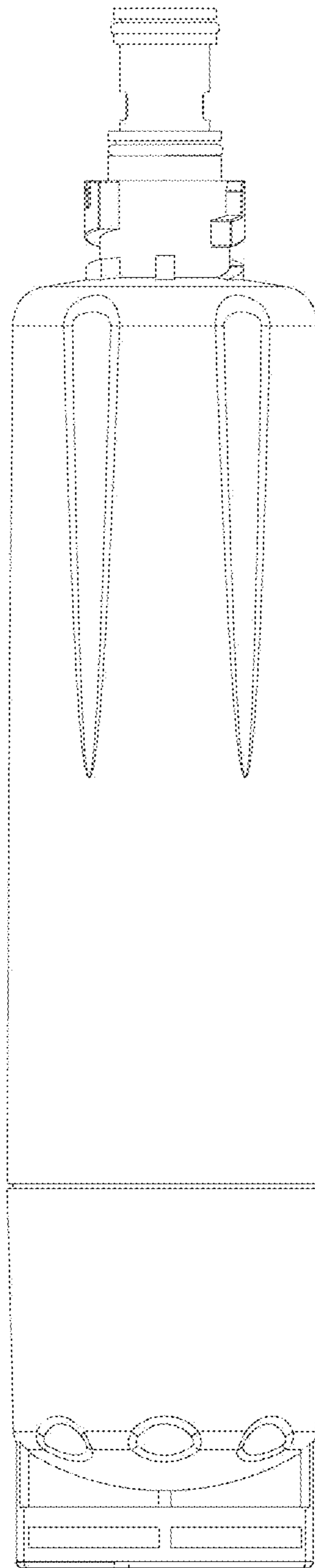

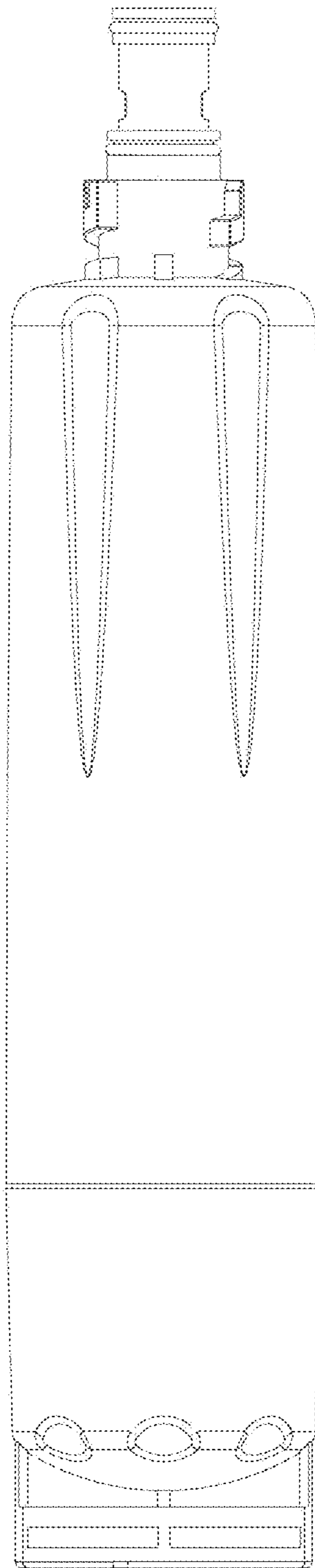

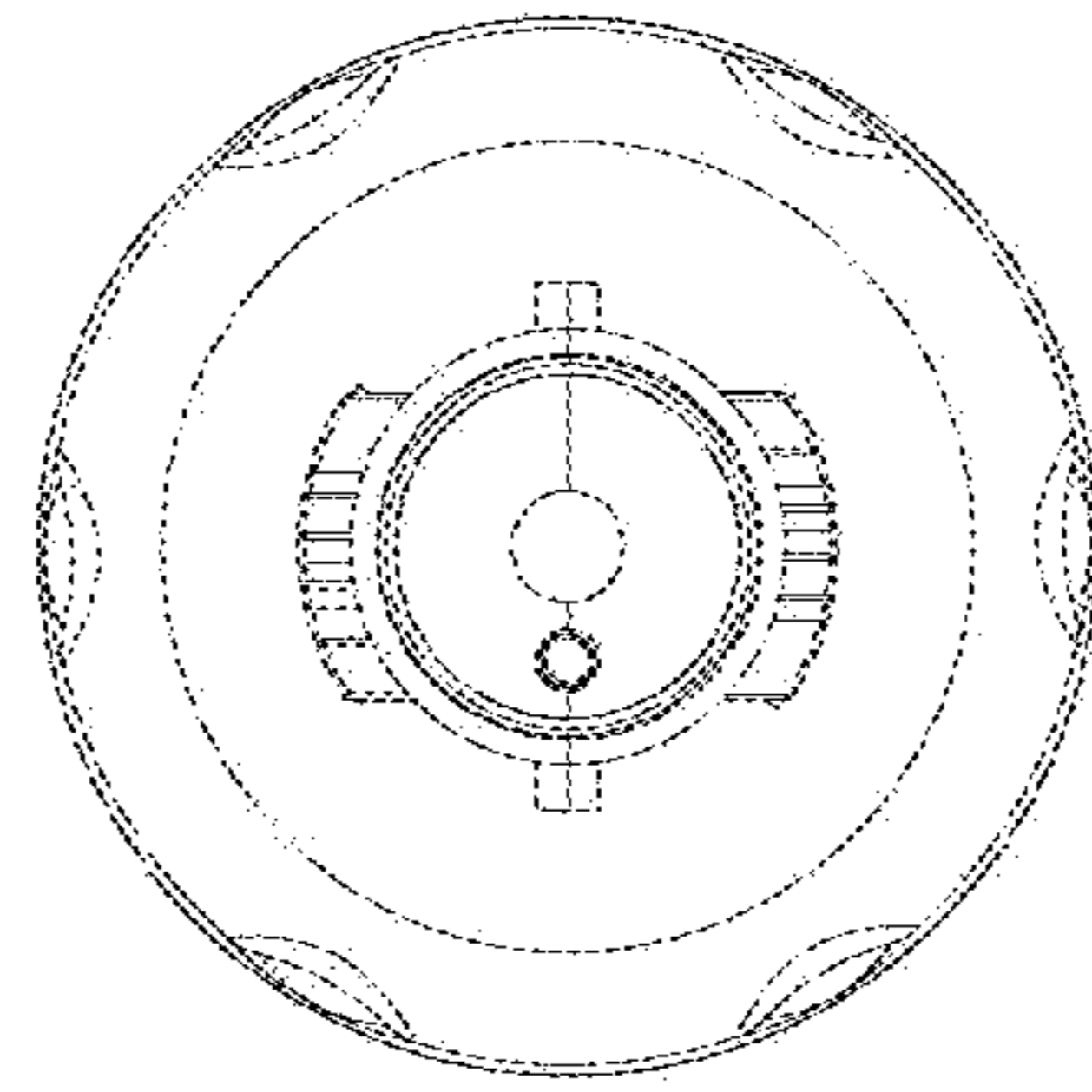

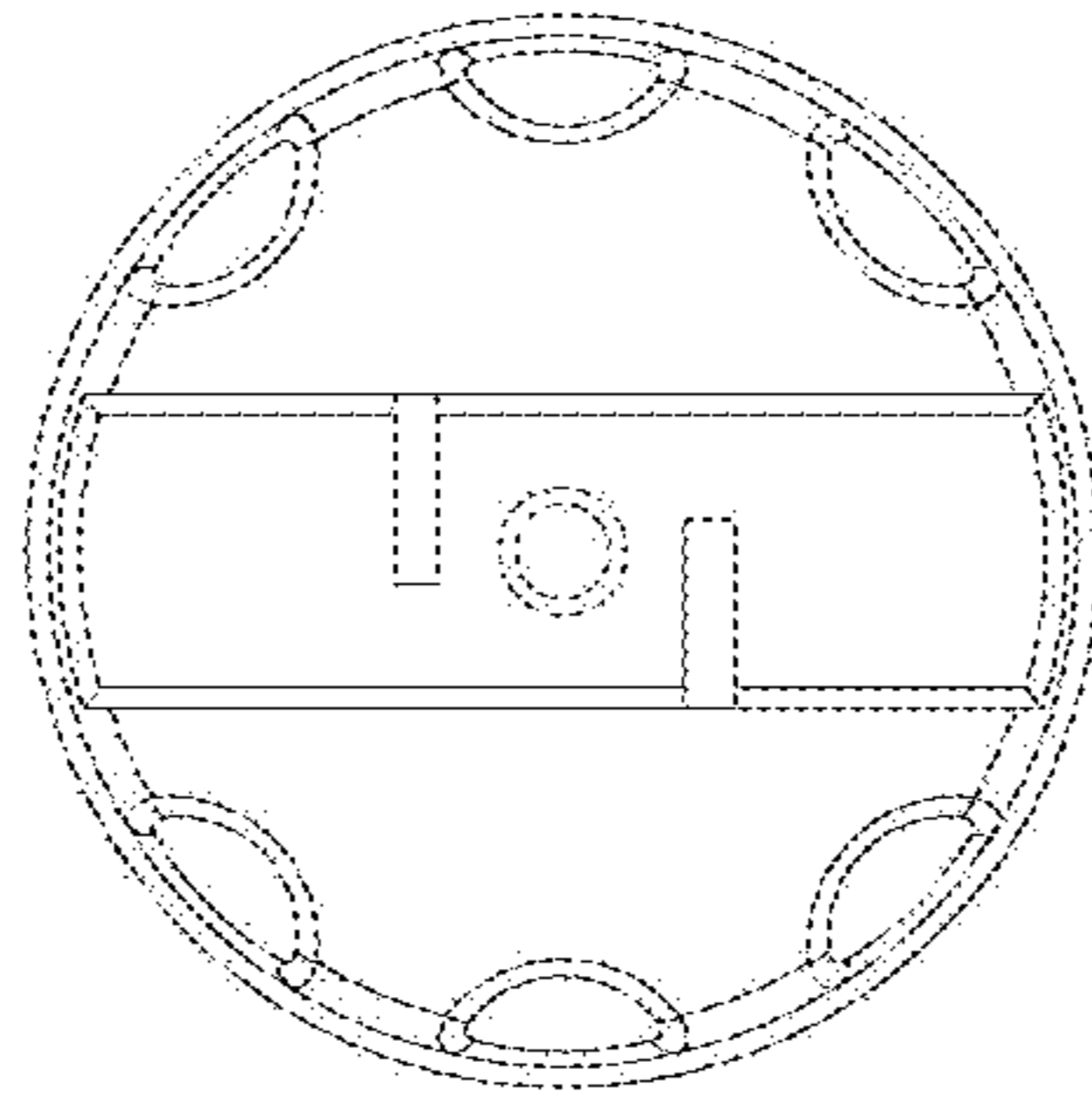

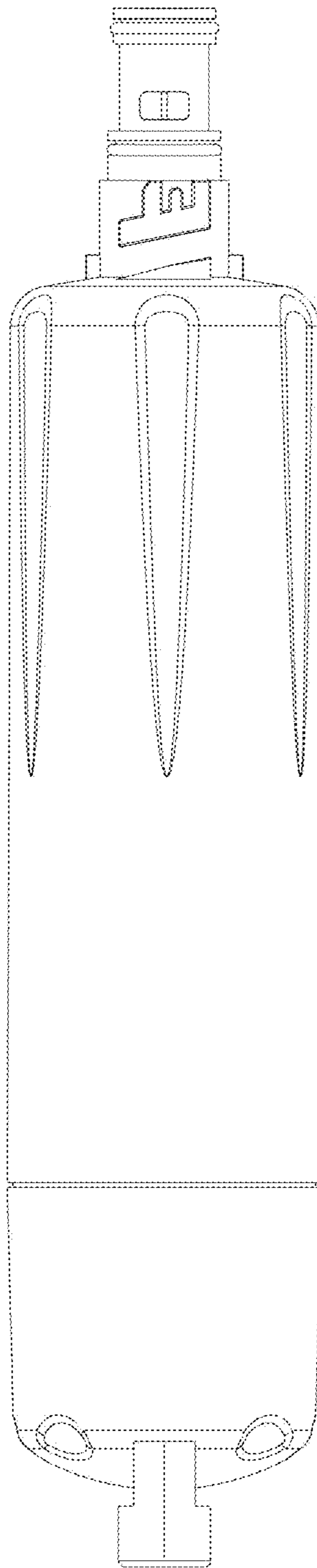

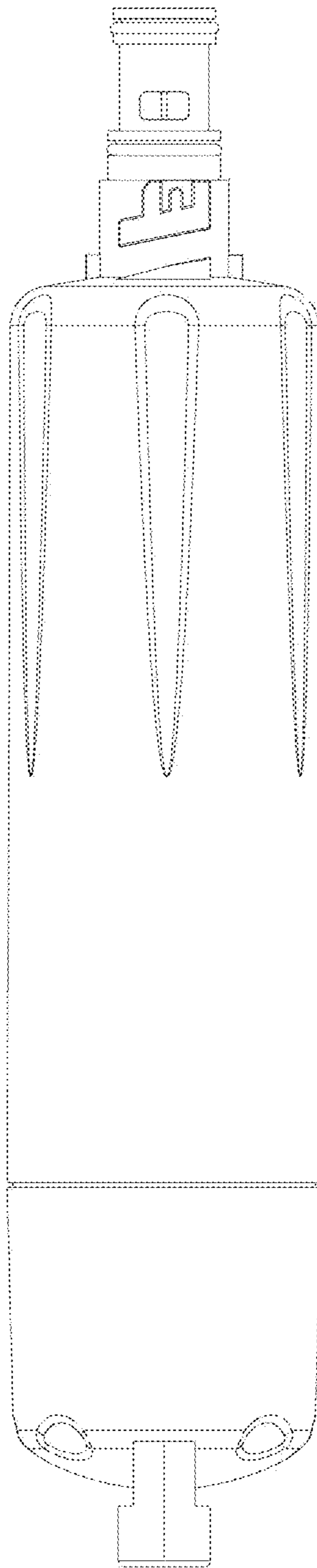
