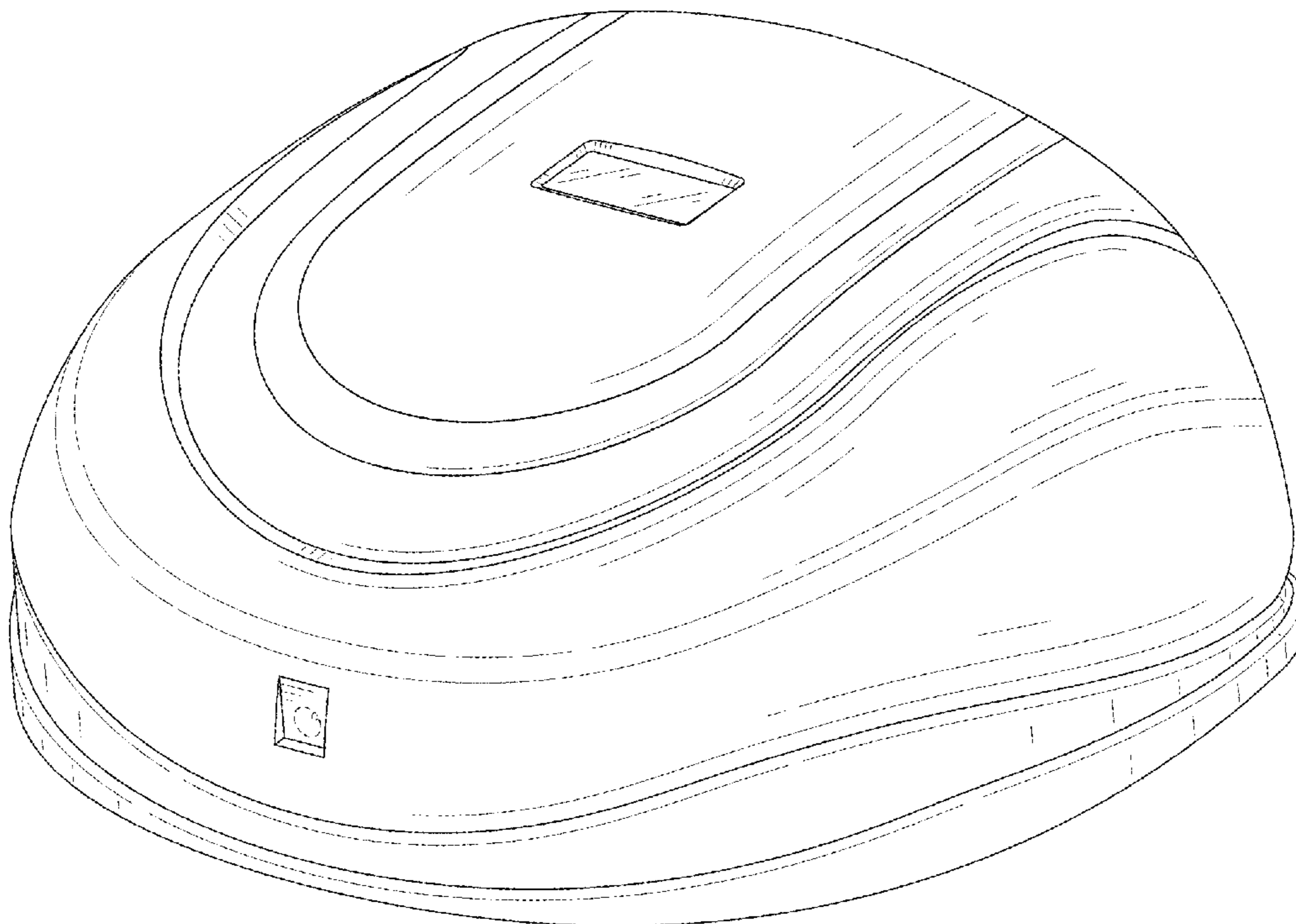
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of a nail dryer showing my new design;

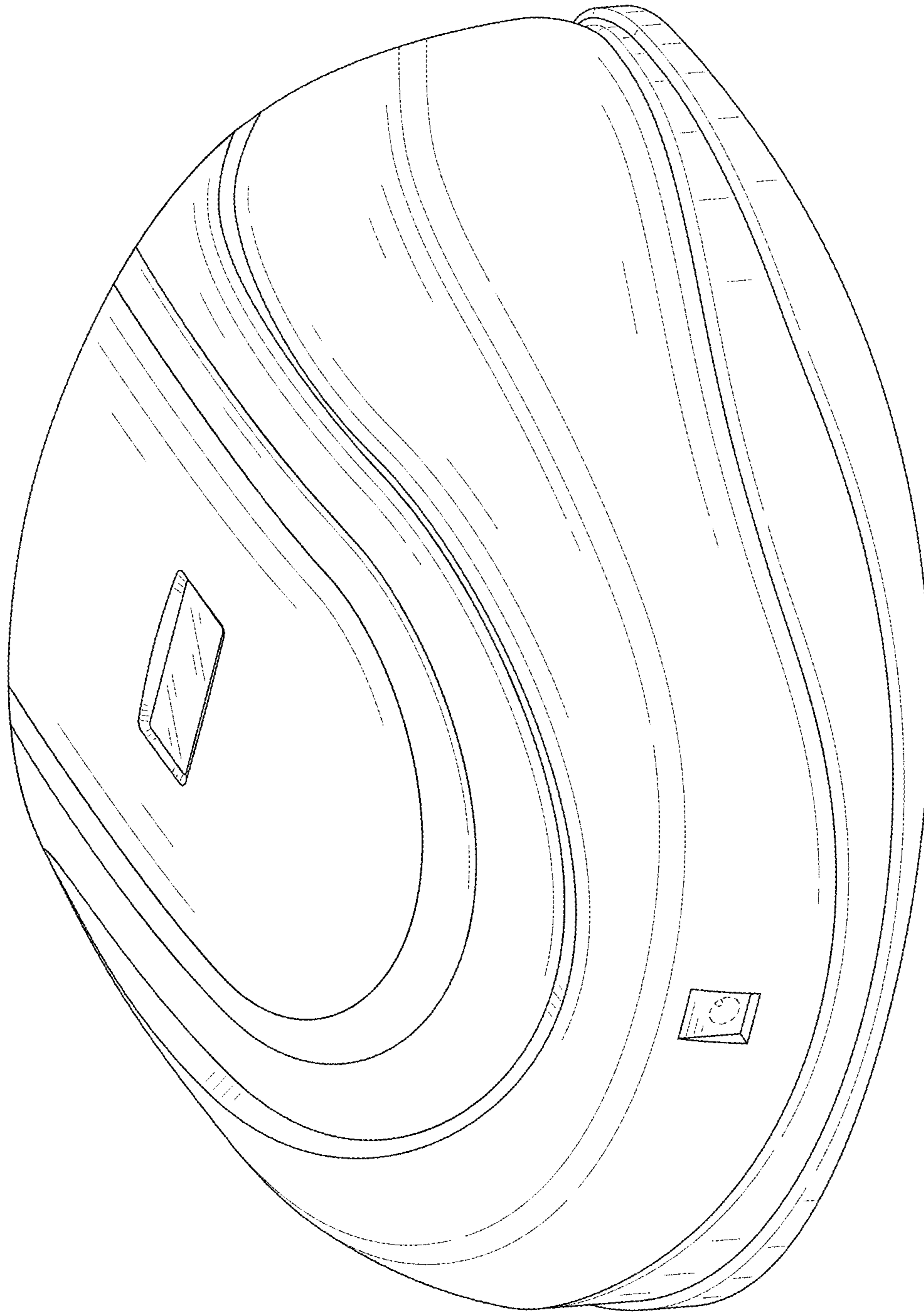

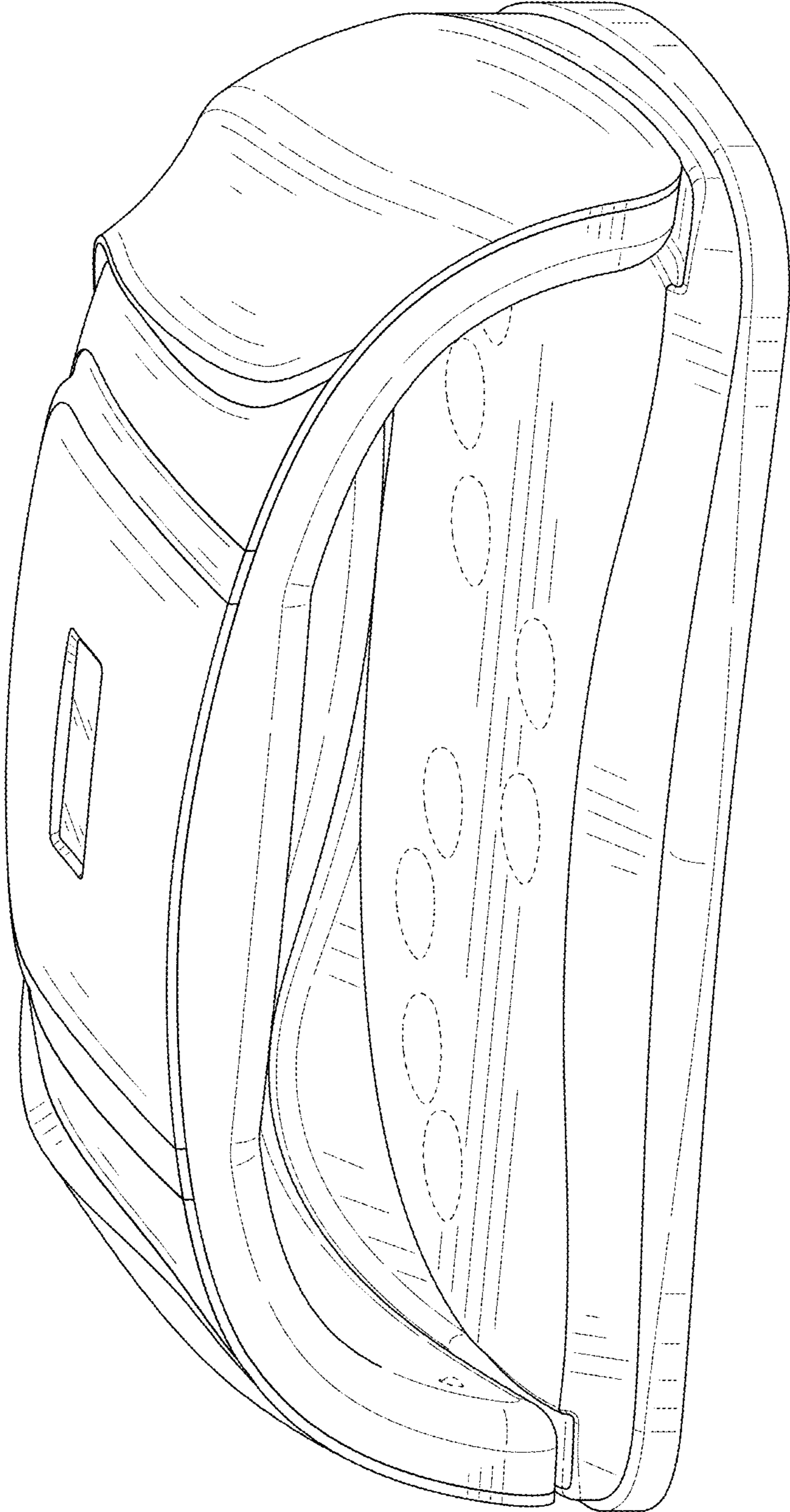

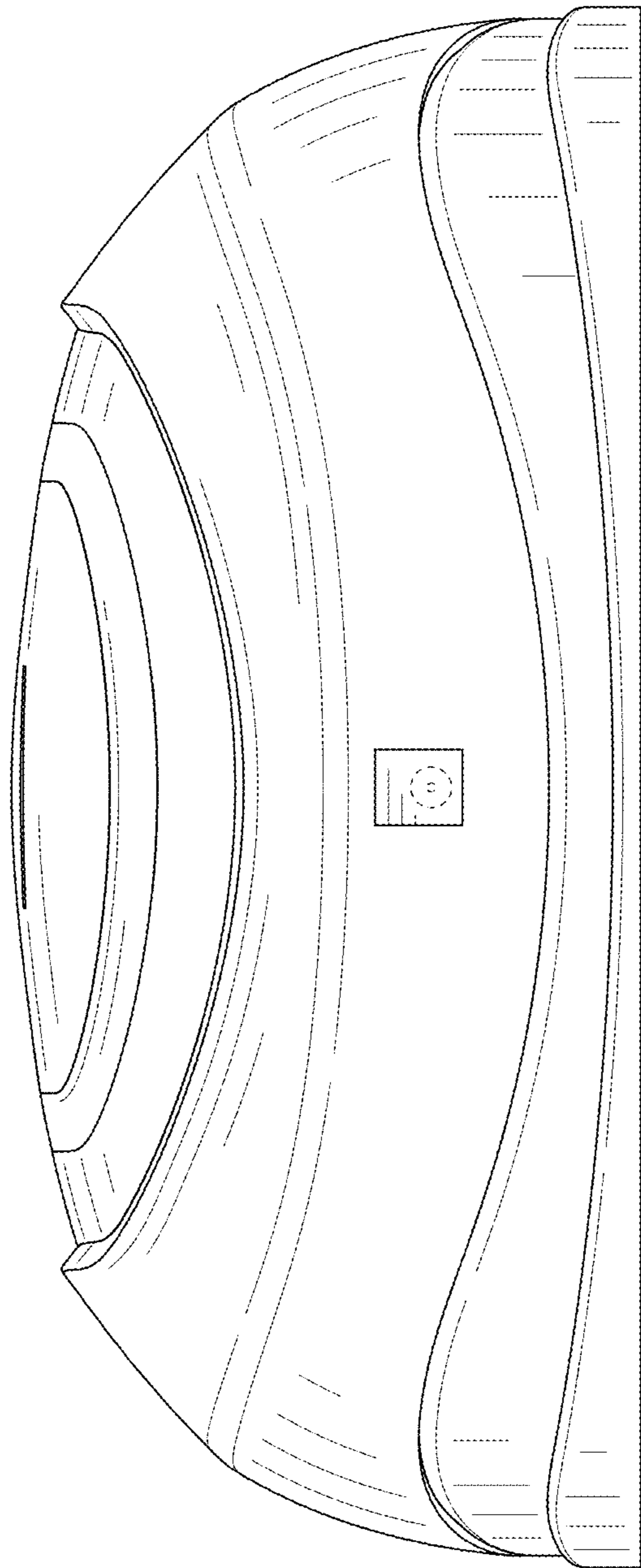

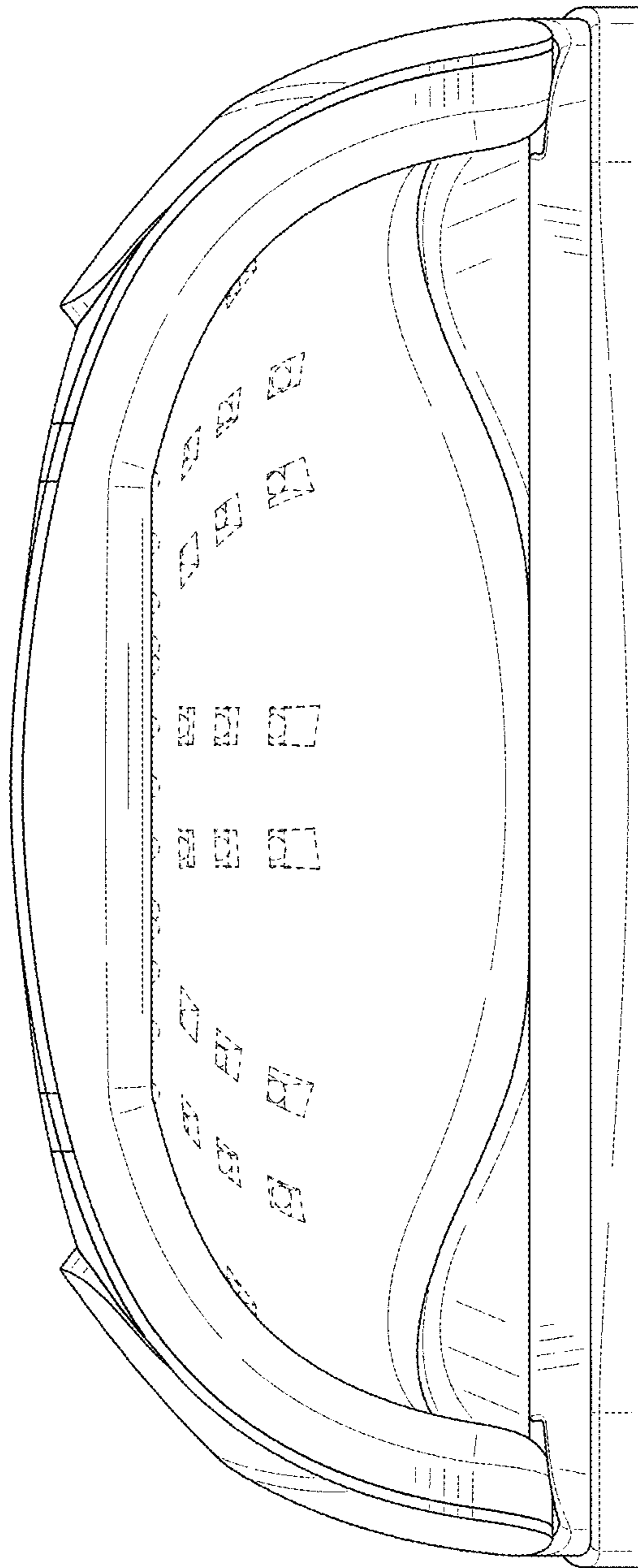

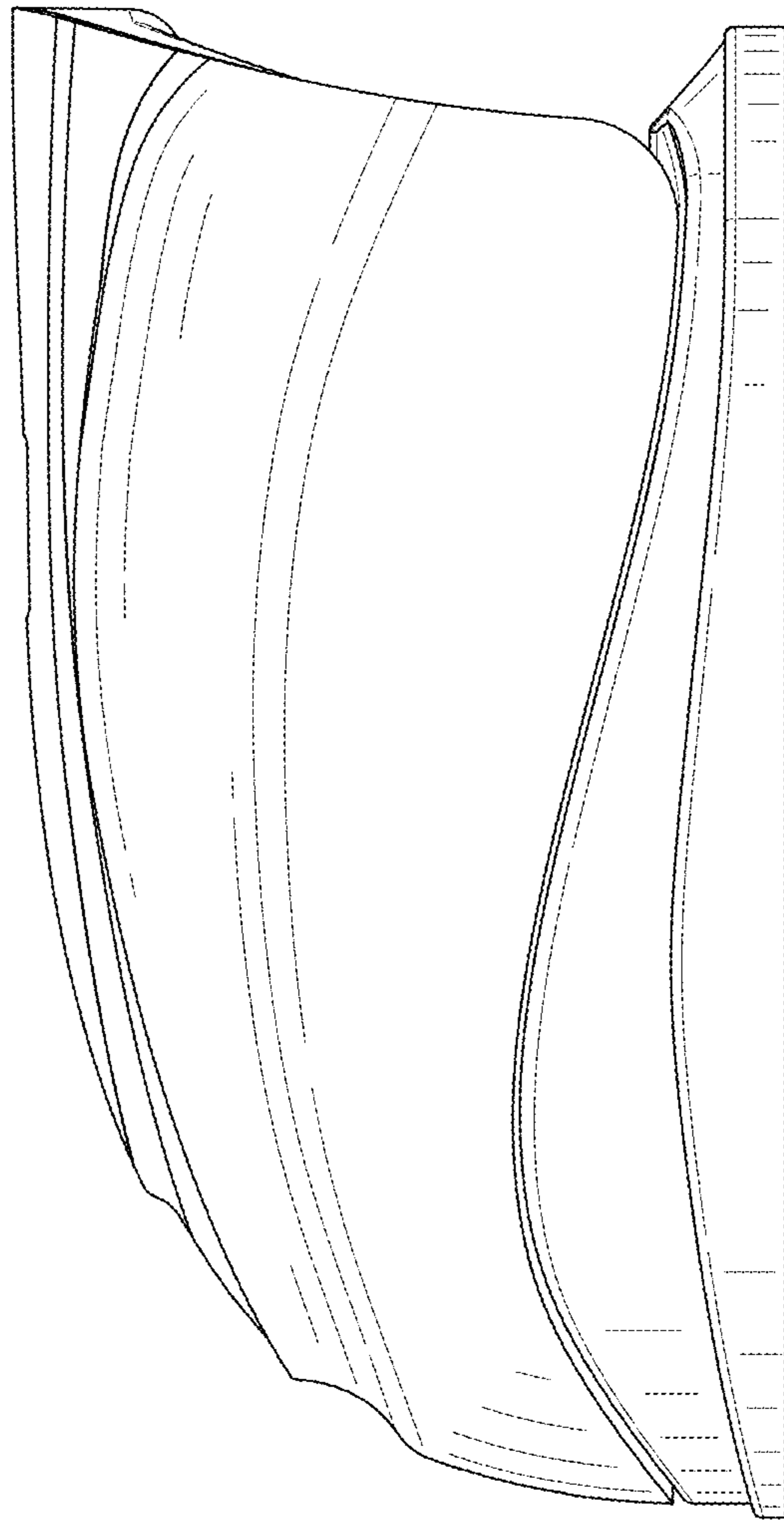

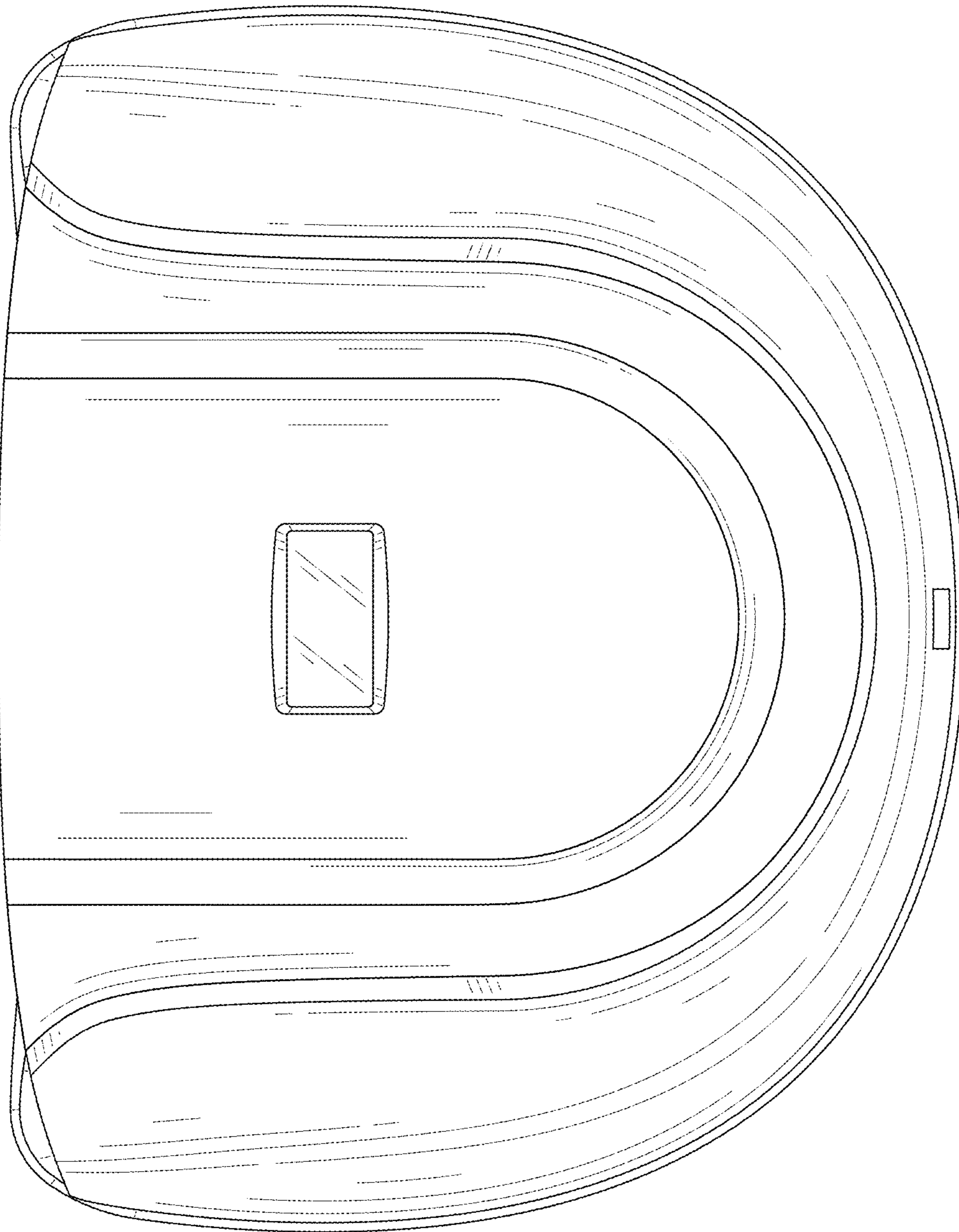

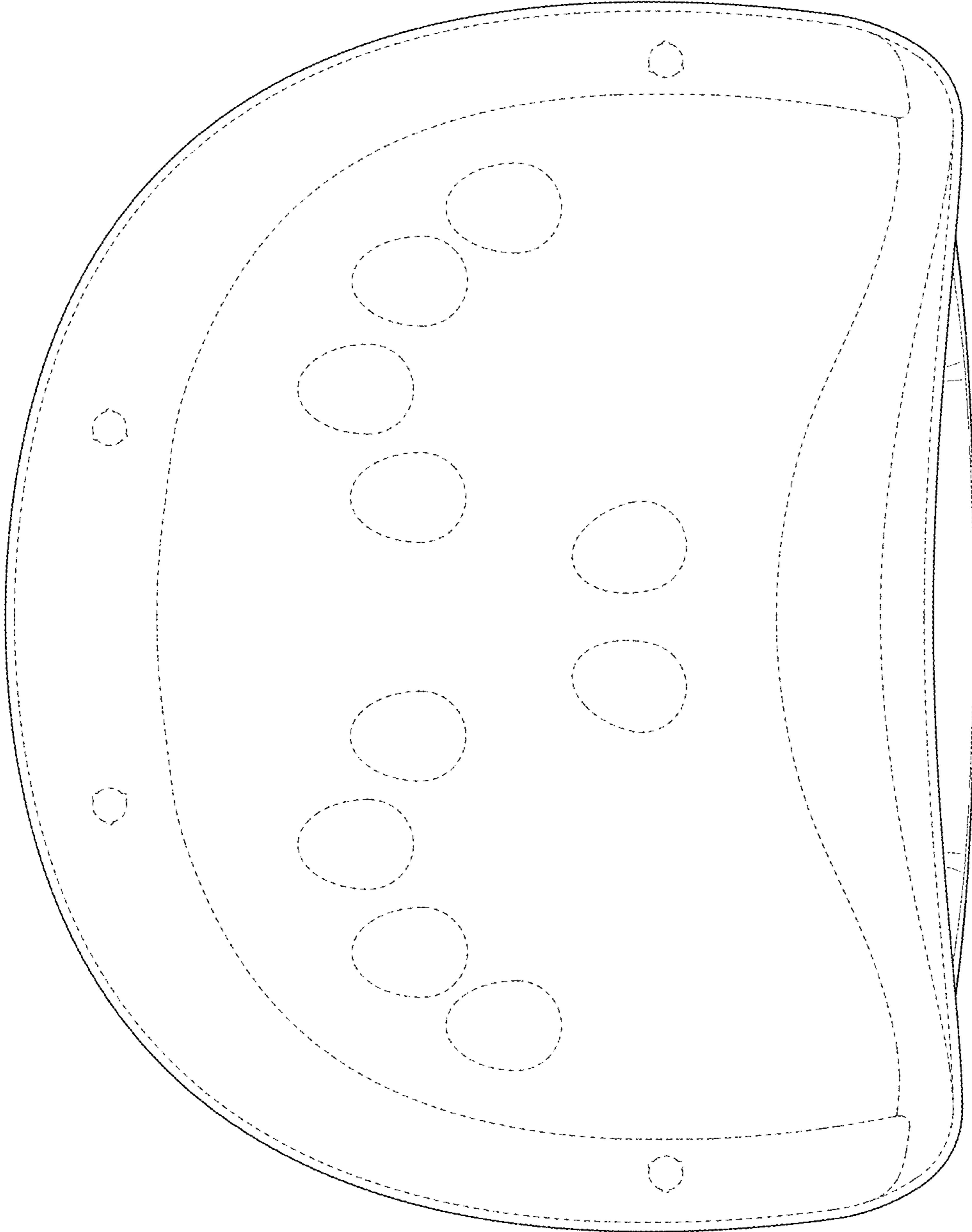
