The ornamental design for an urn, as shown and described.

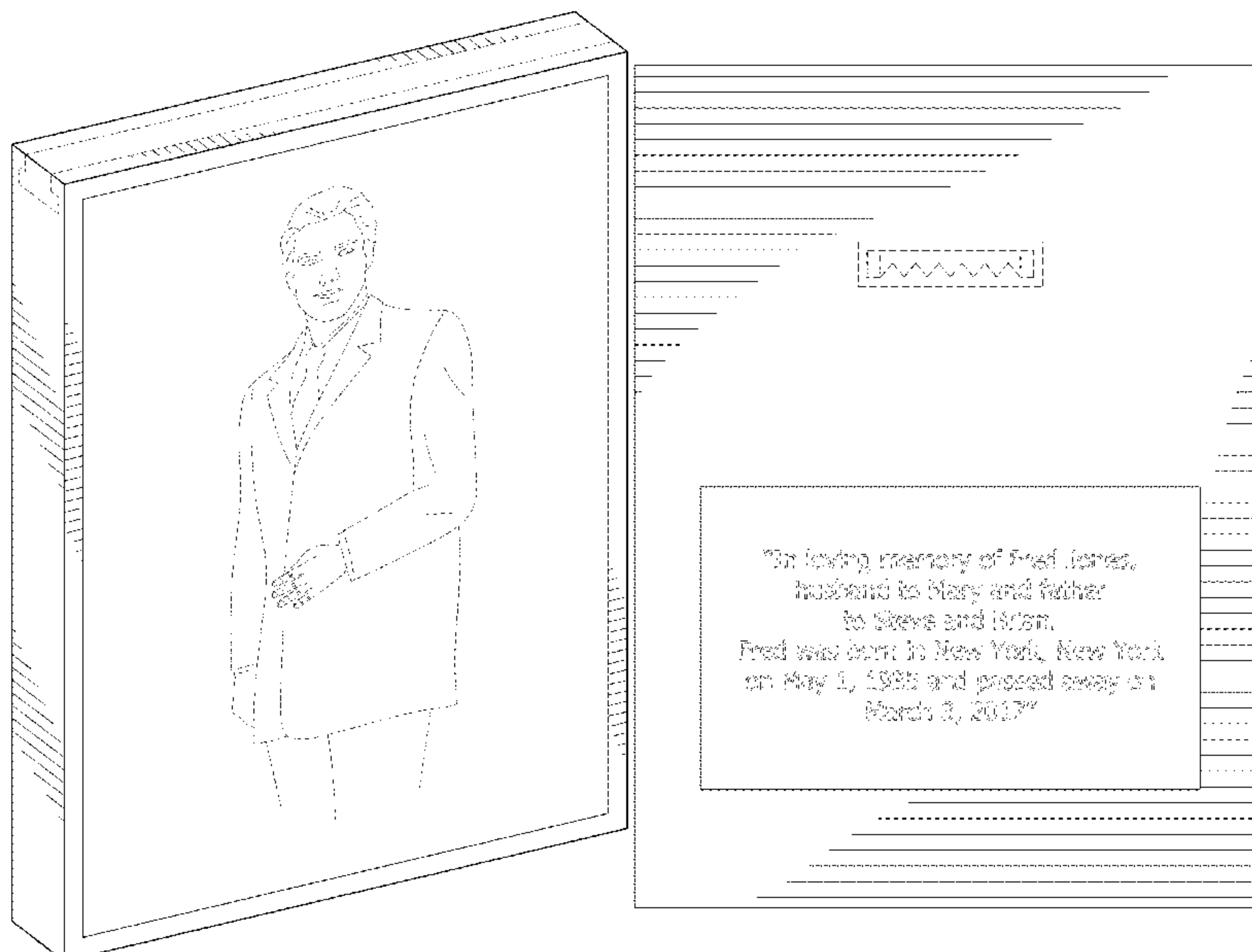
**DESCRIPTION**

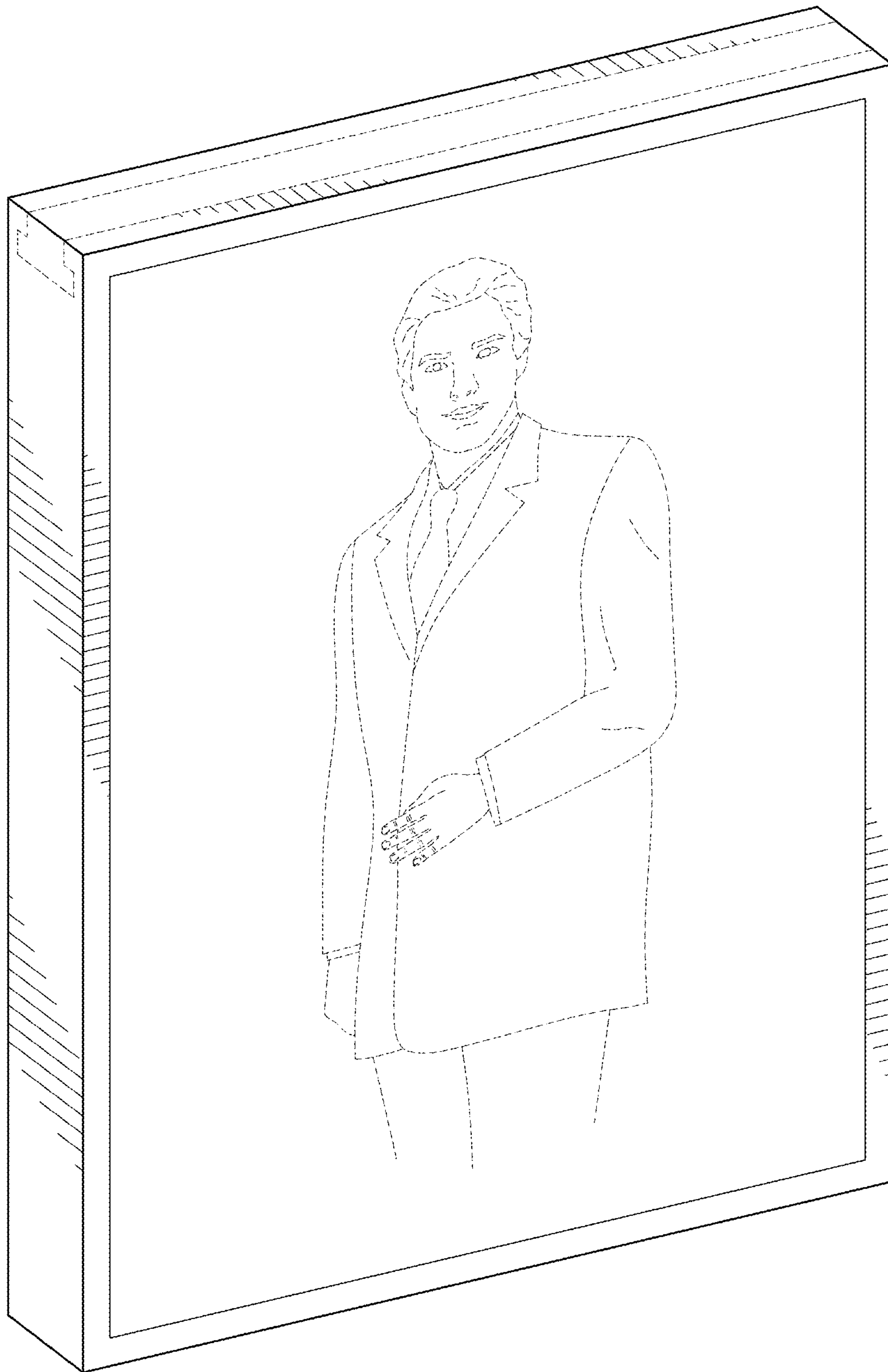

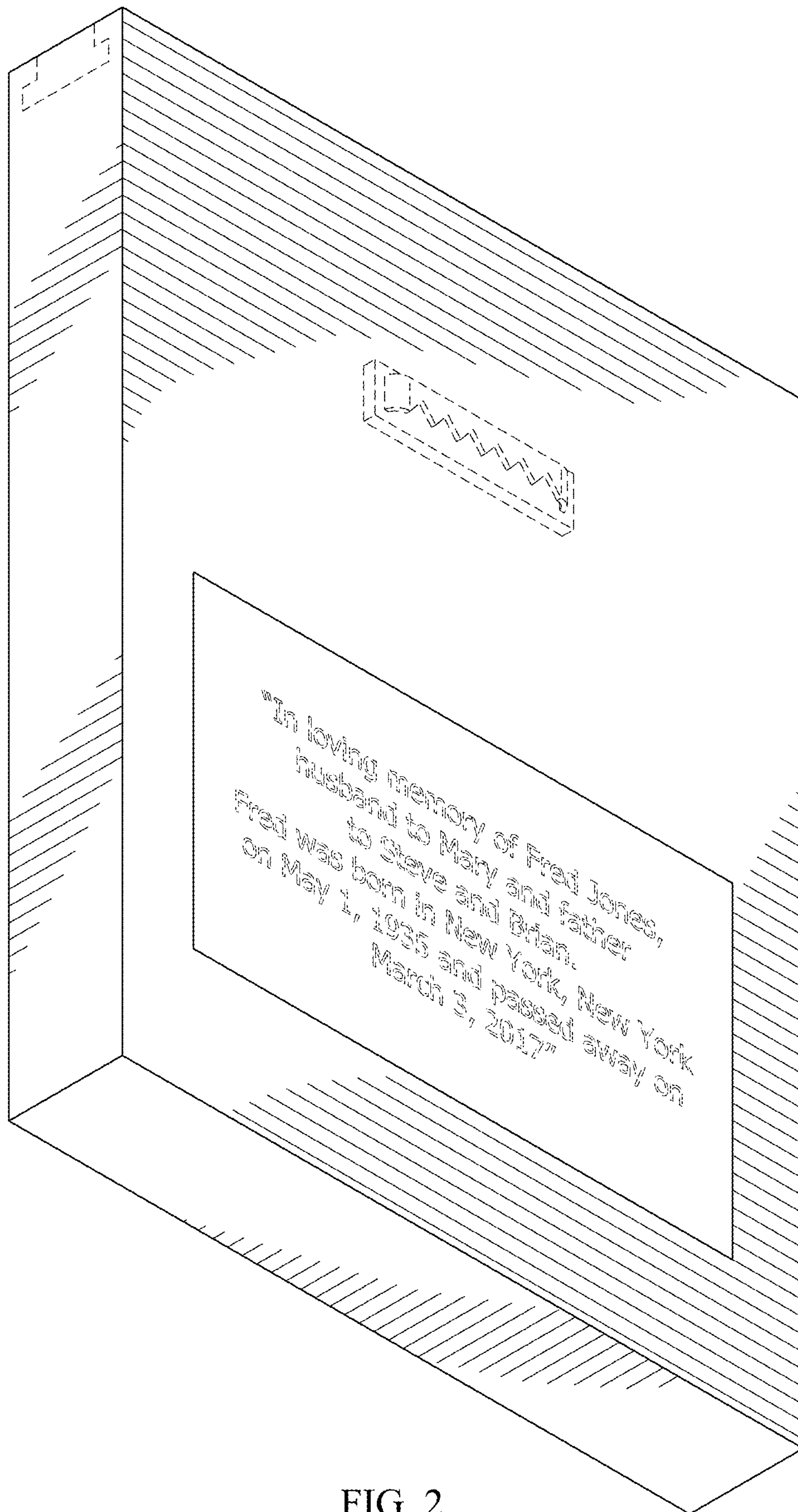

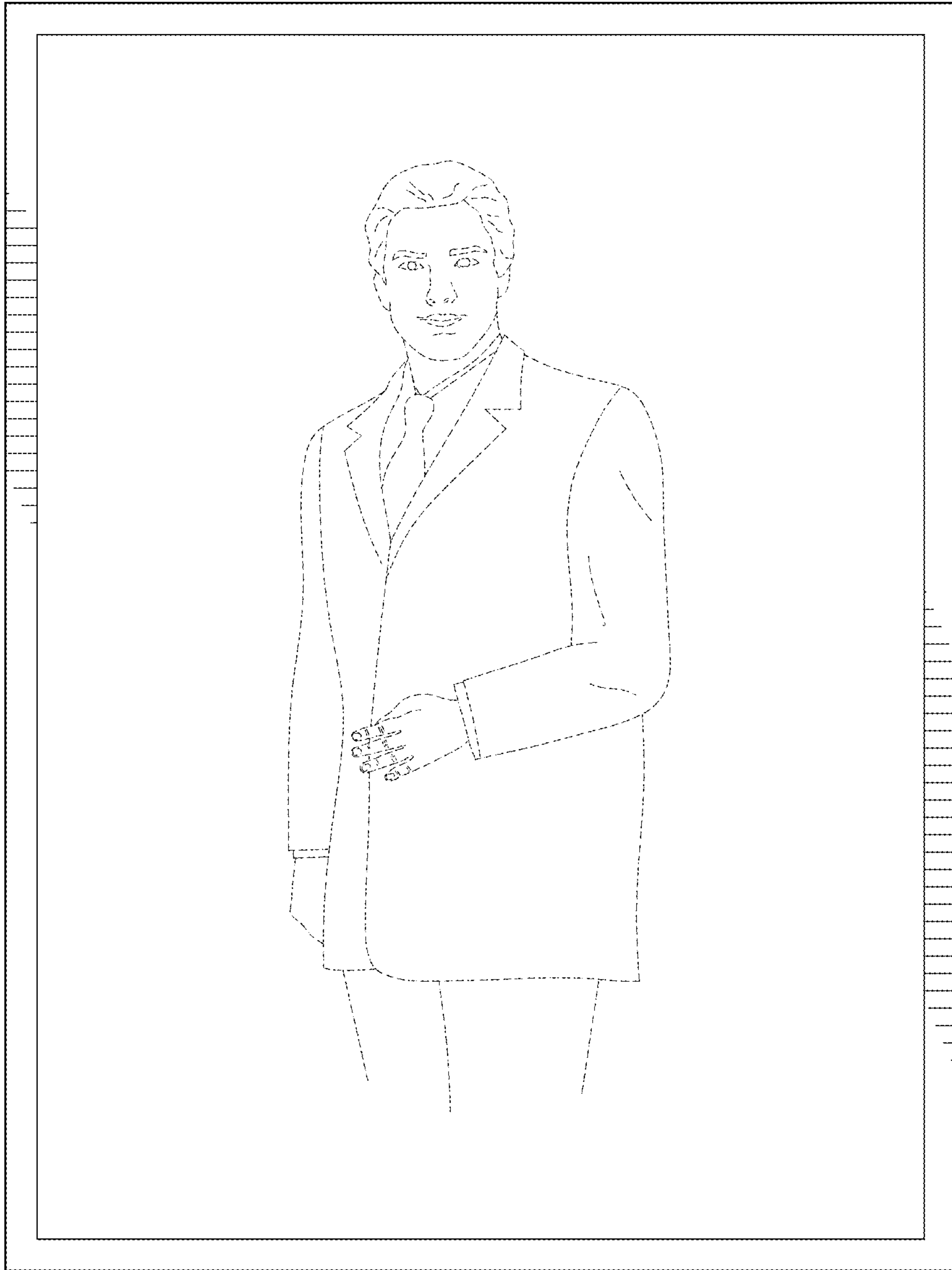

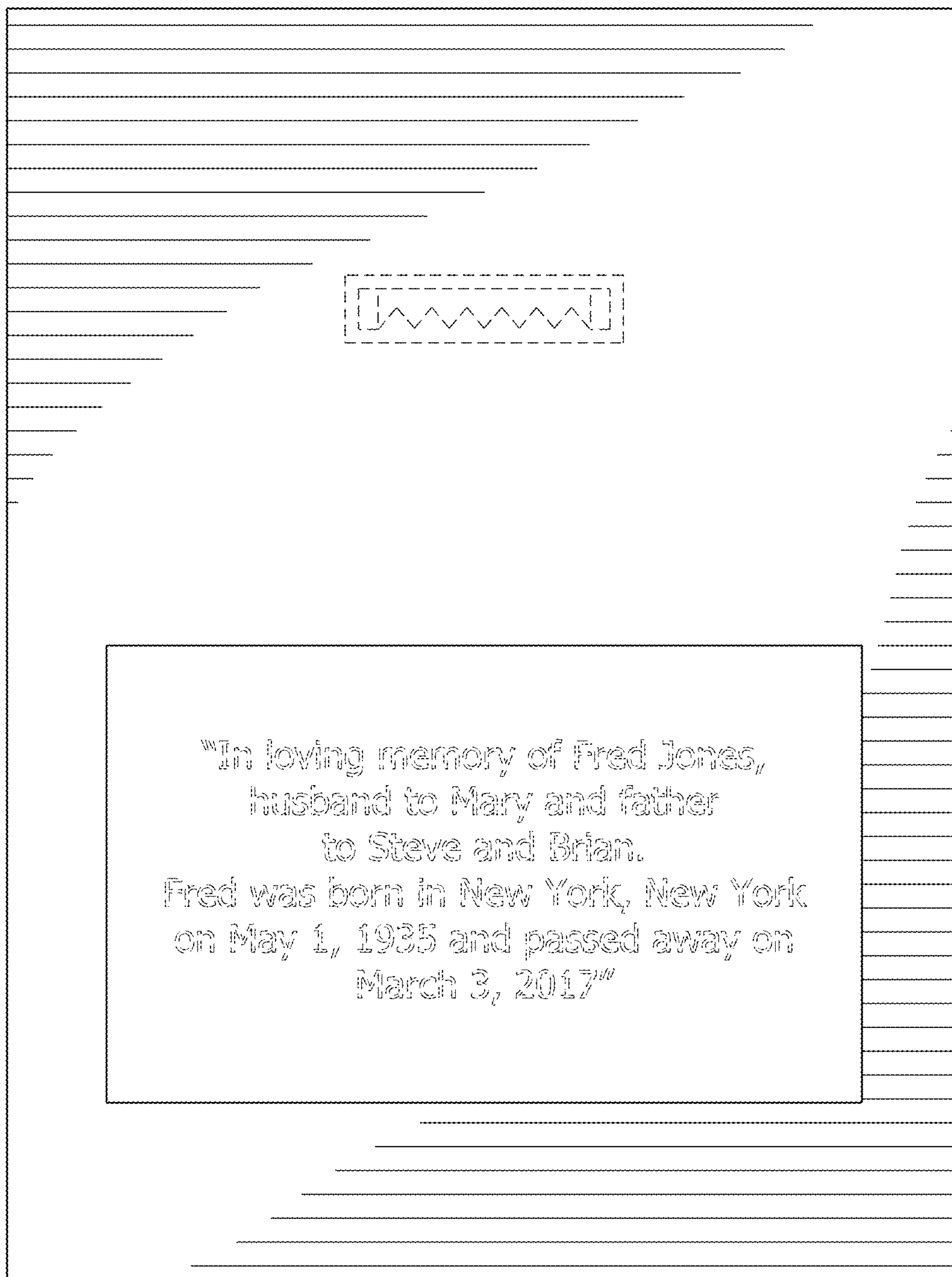

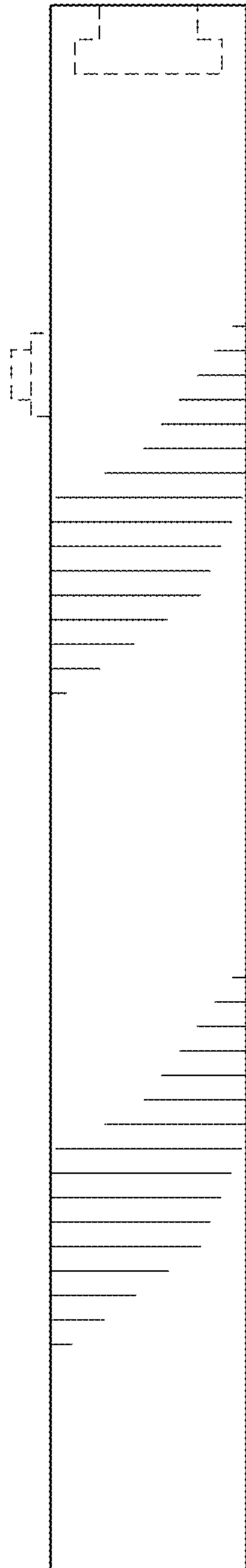

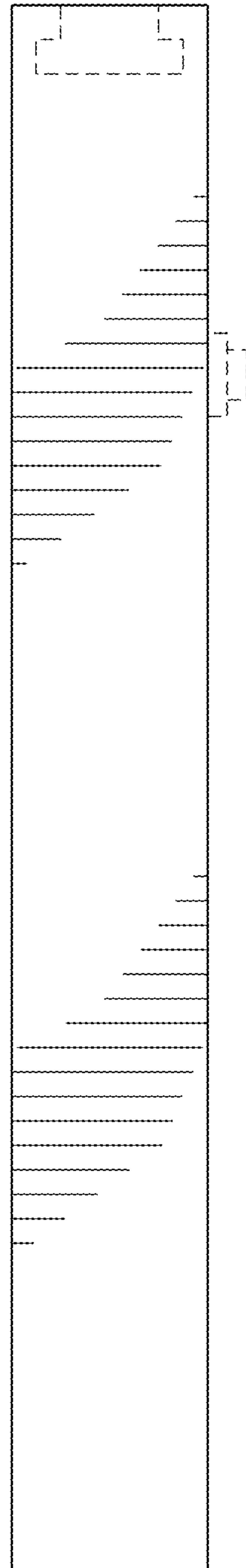

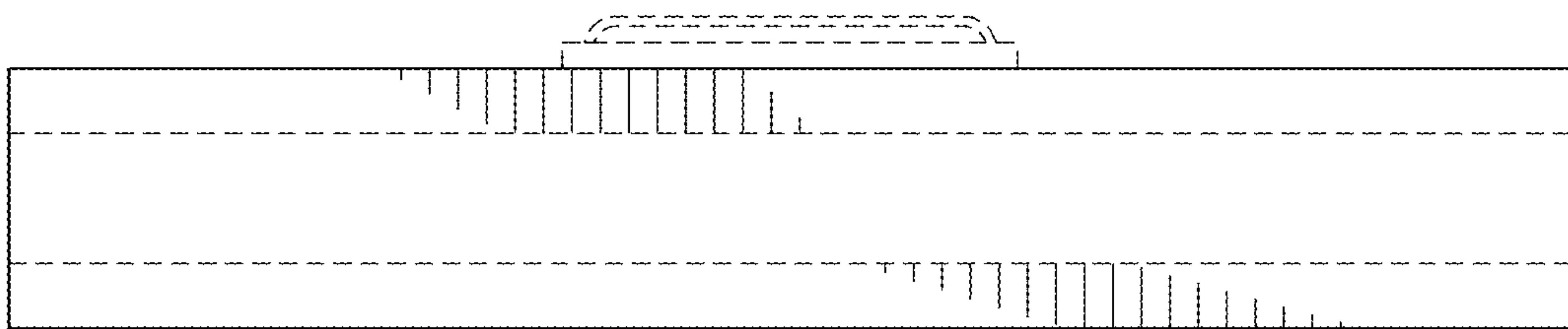

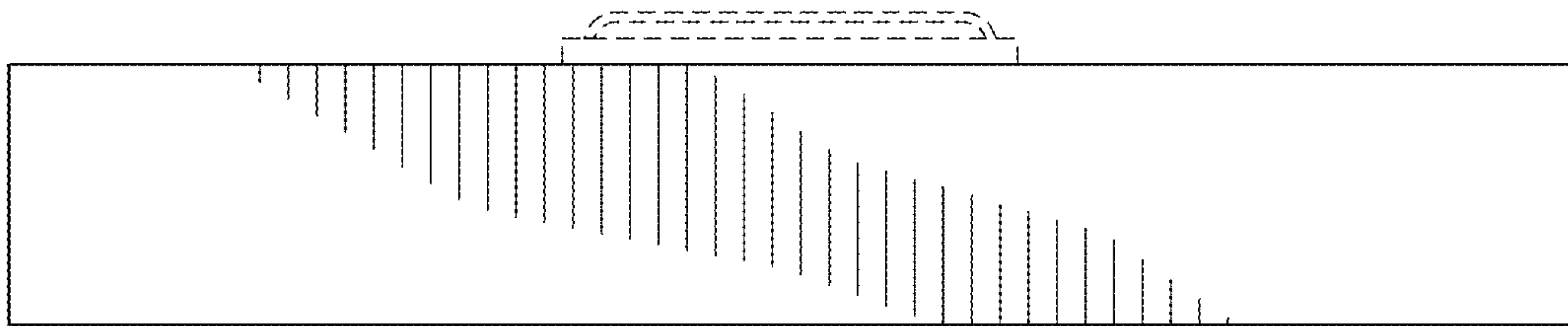

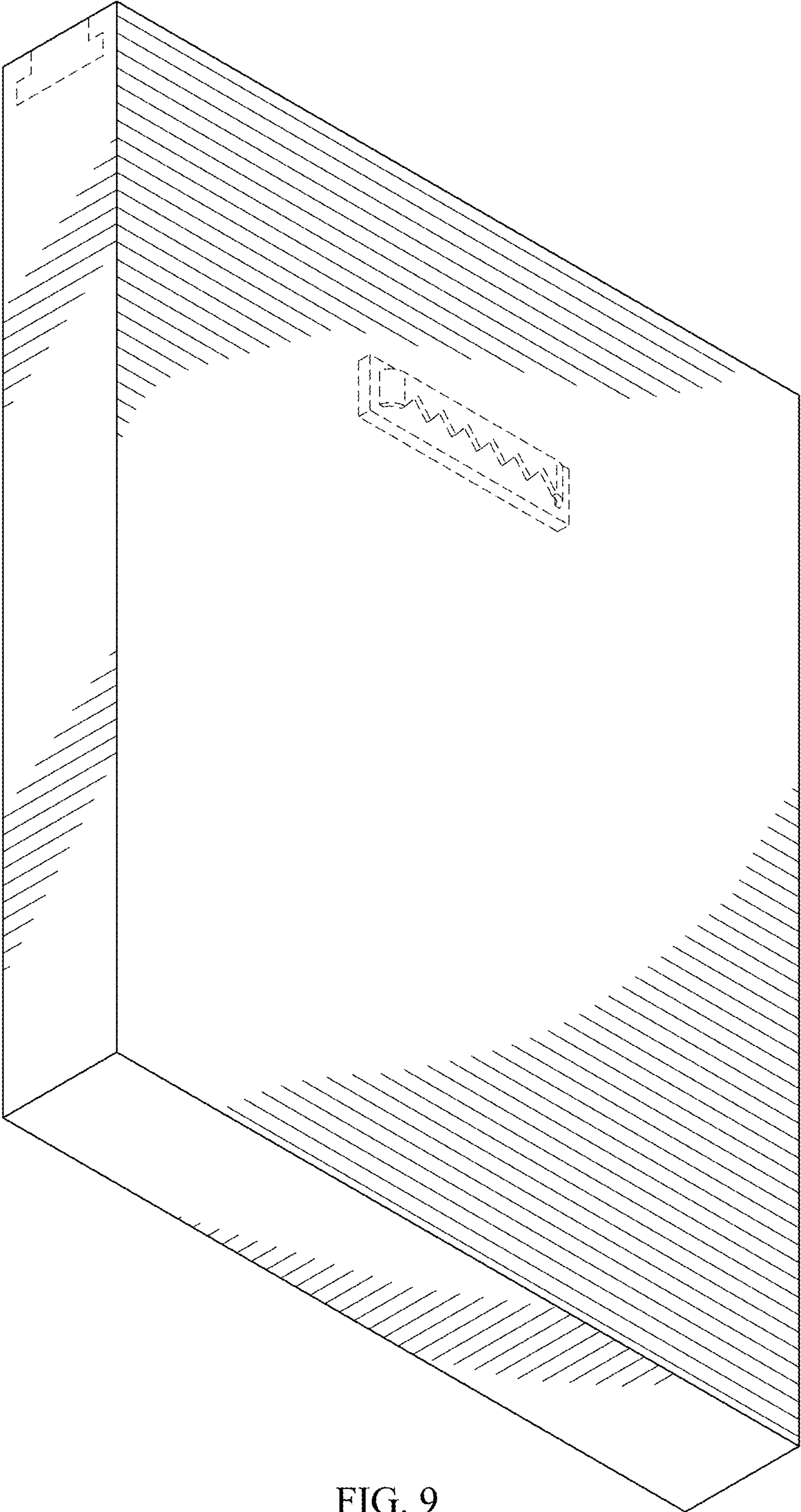

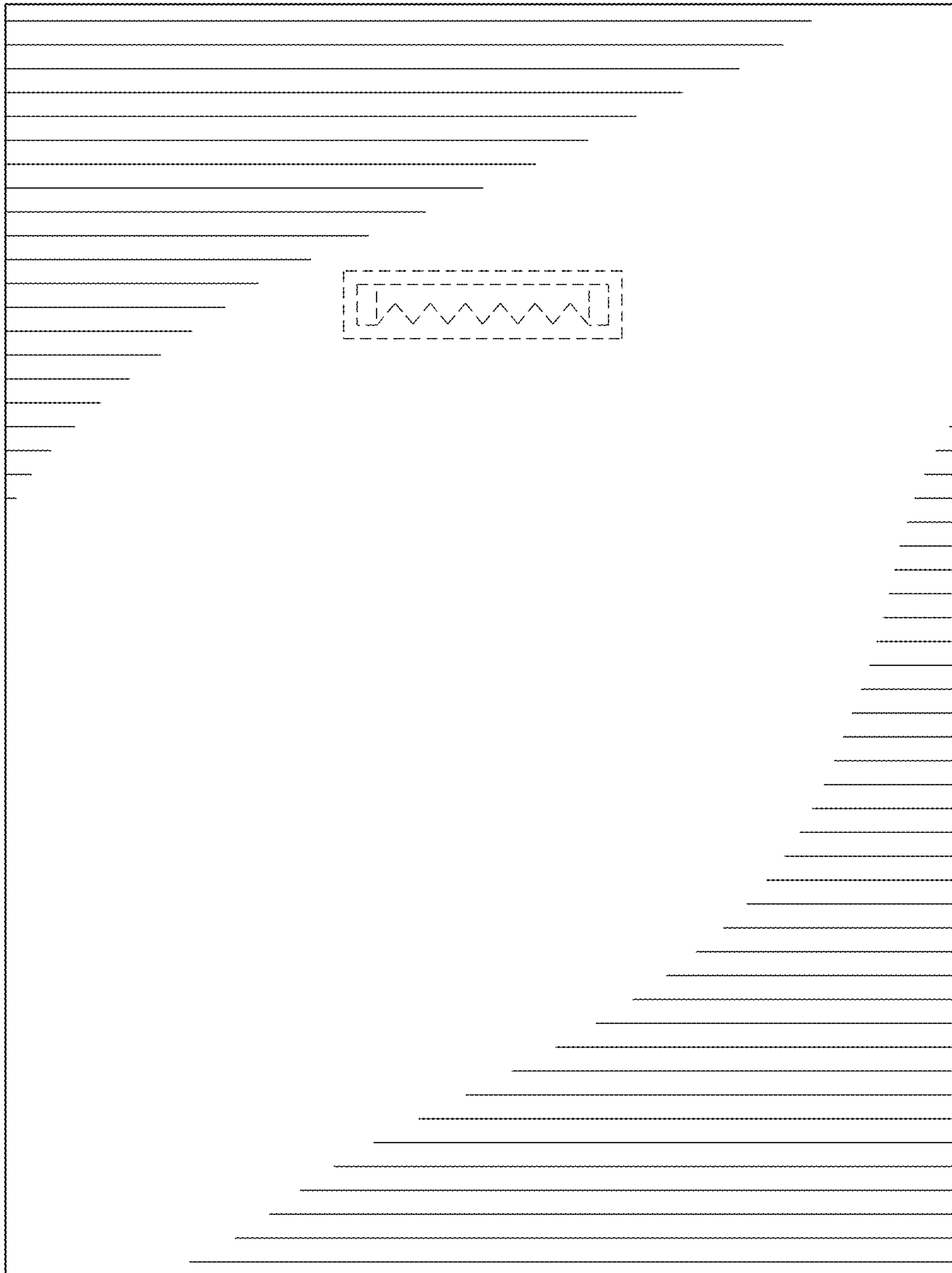

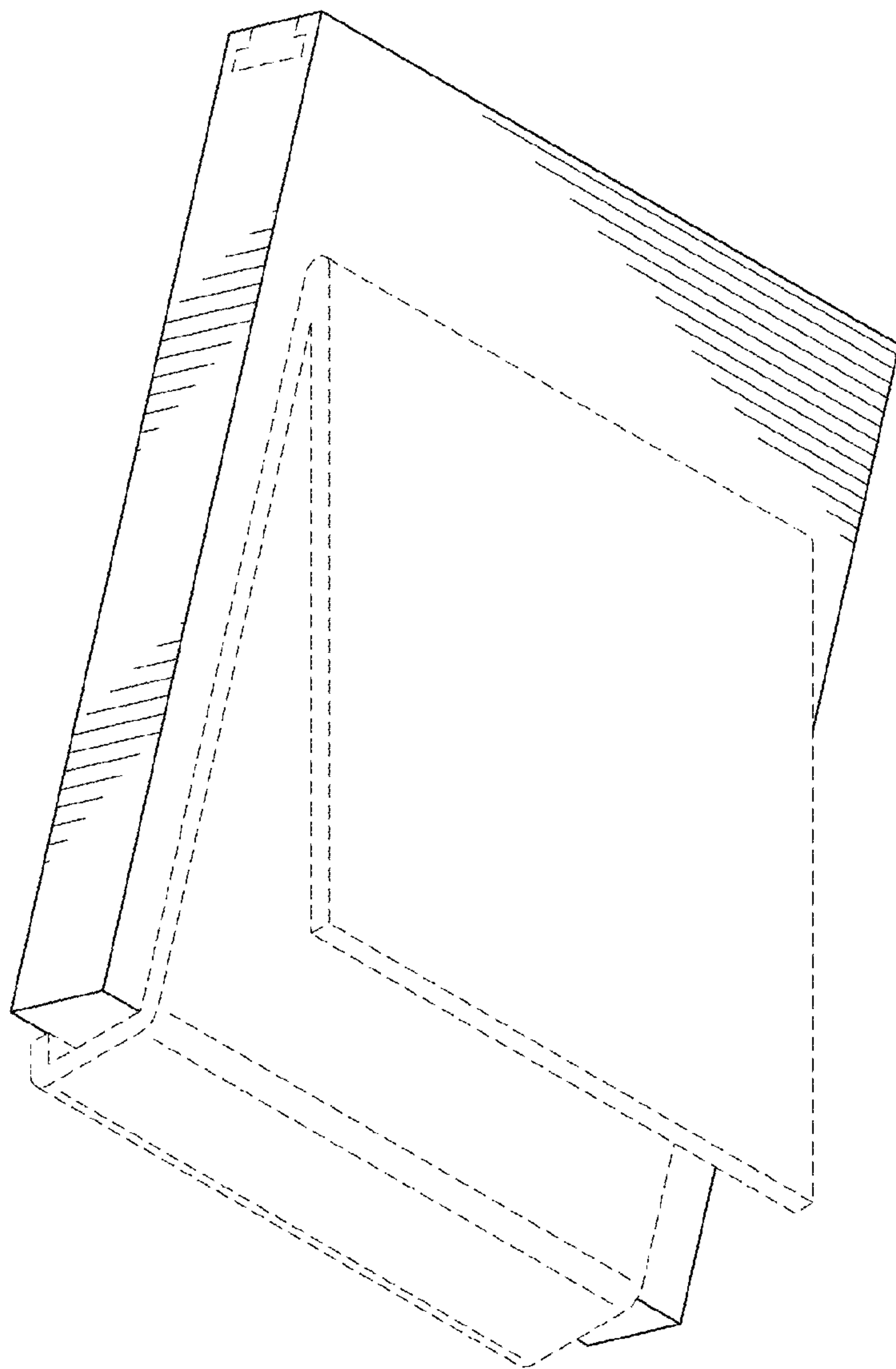

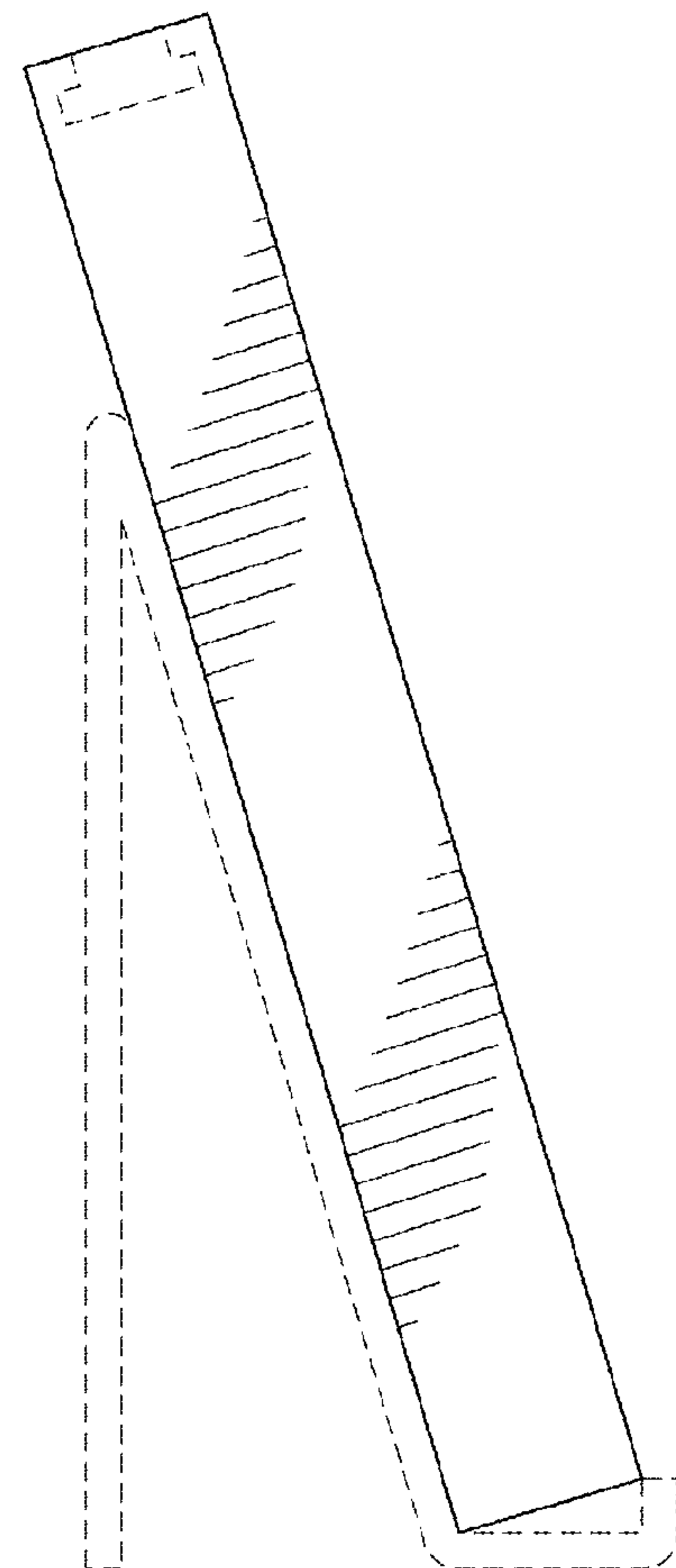

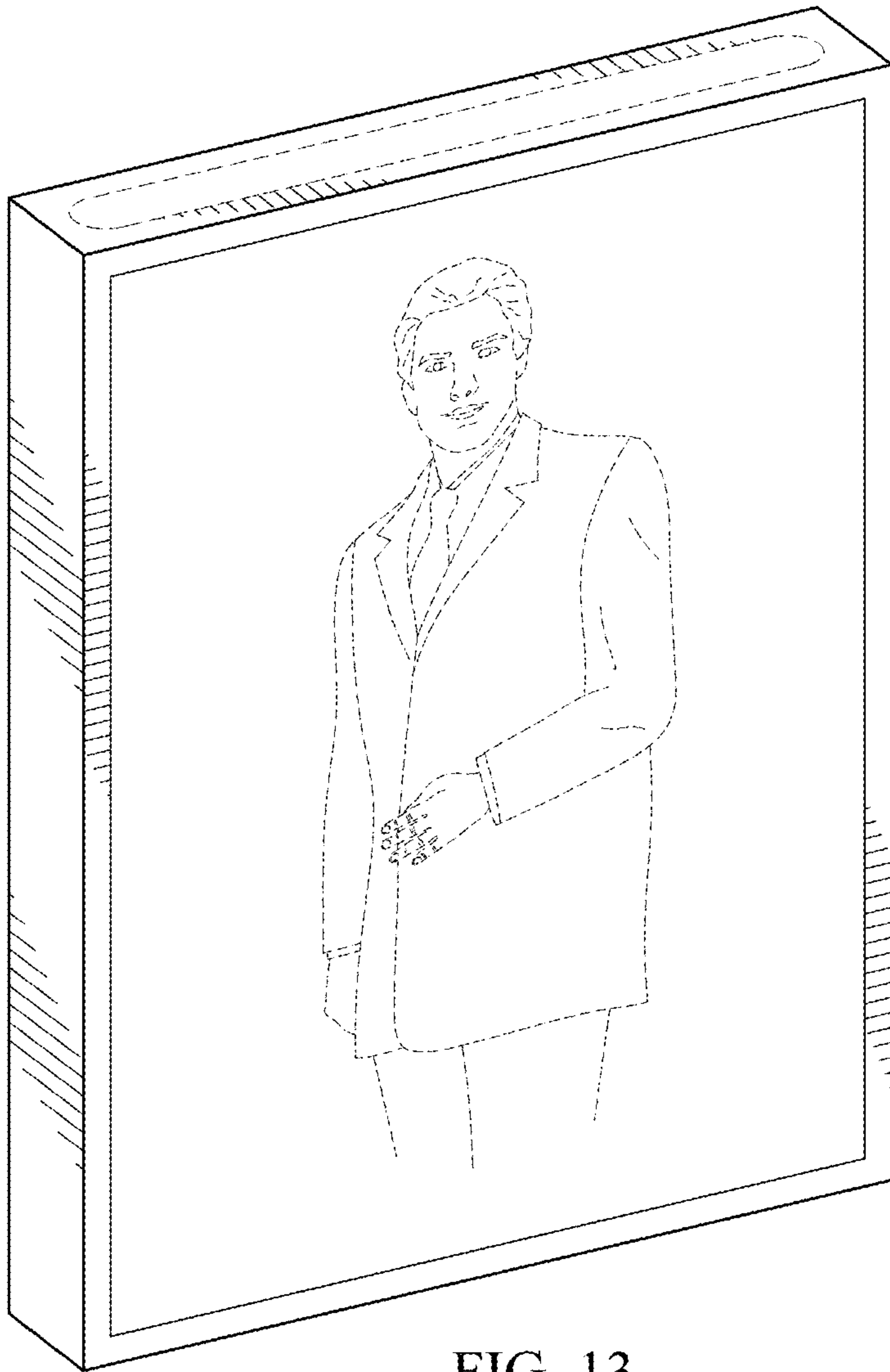

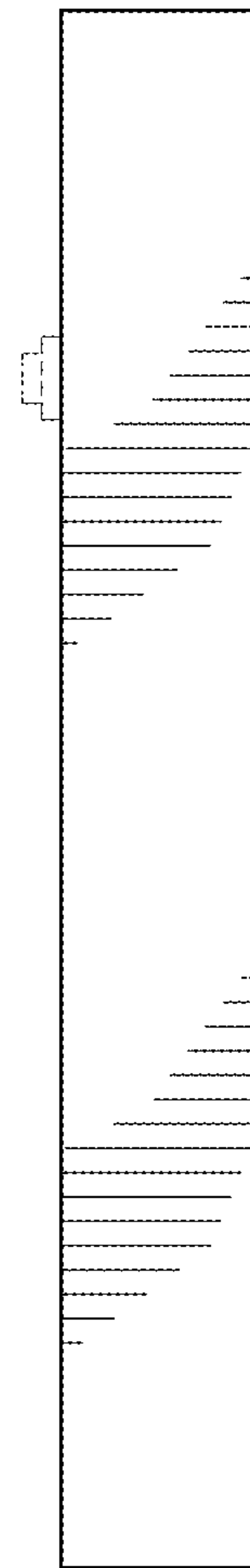

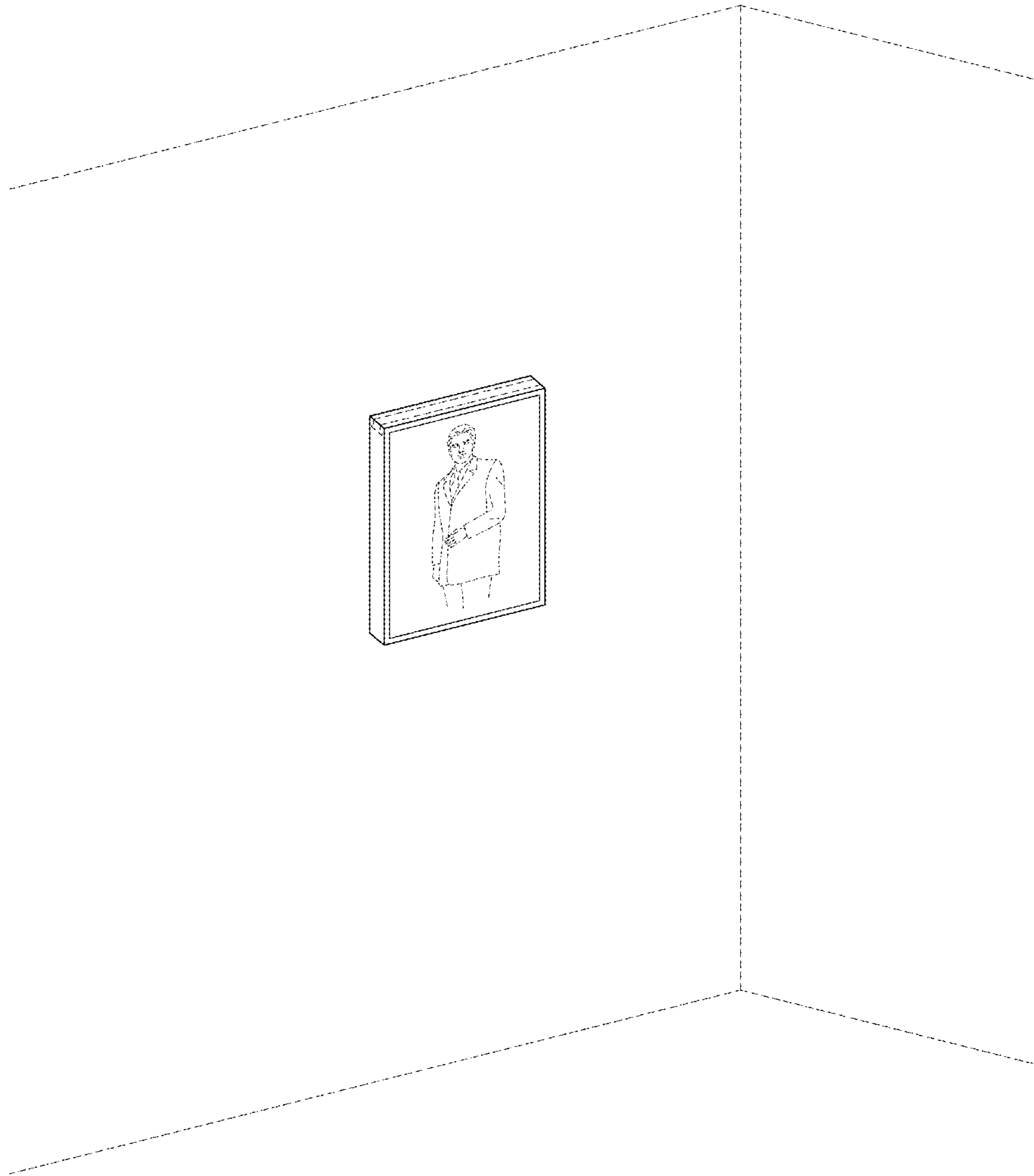

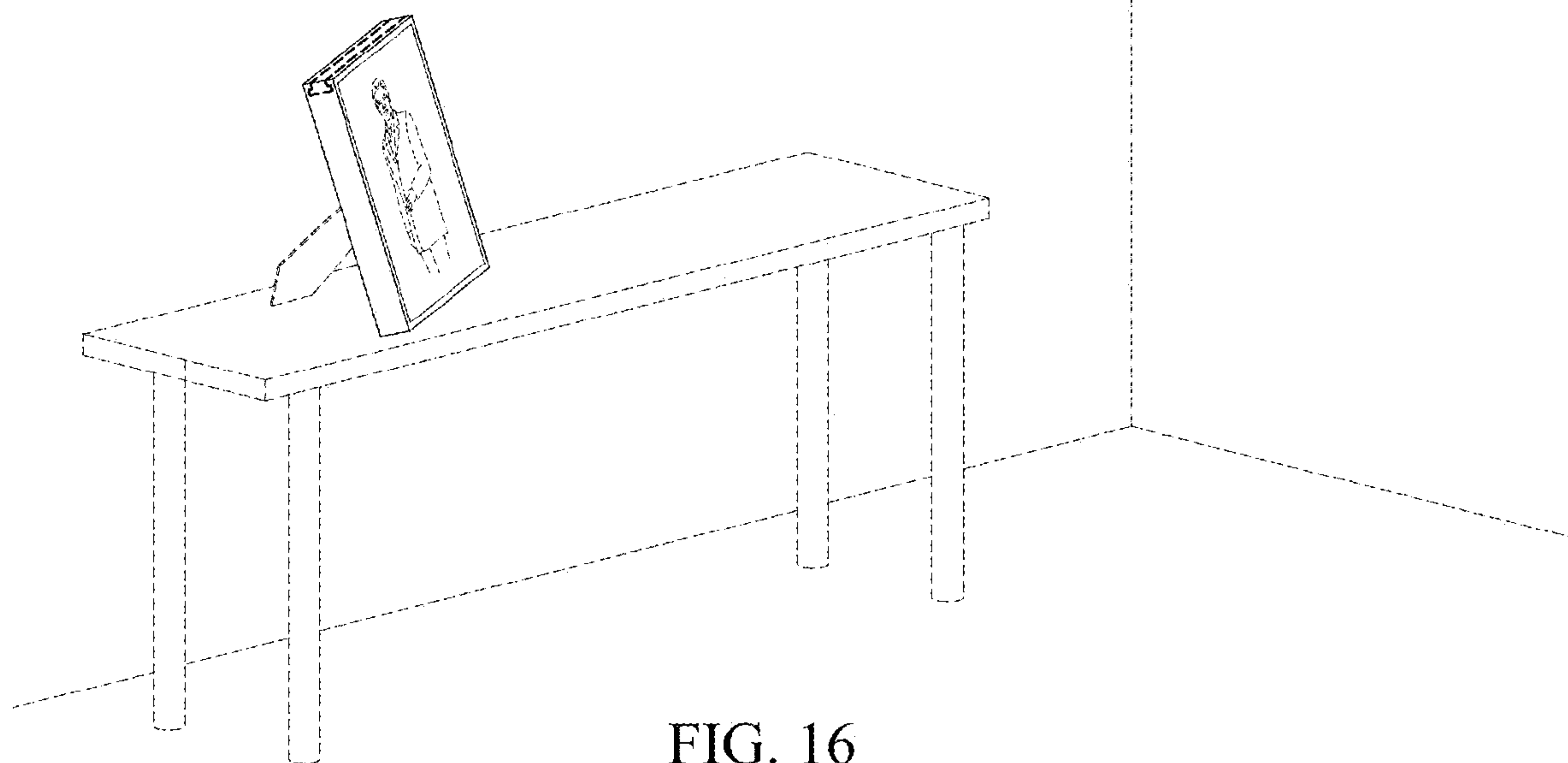

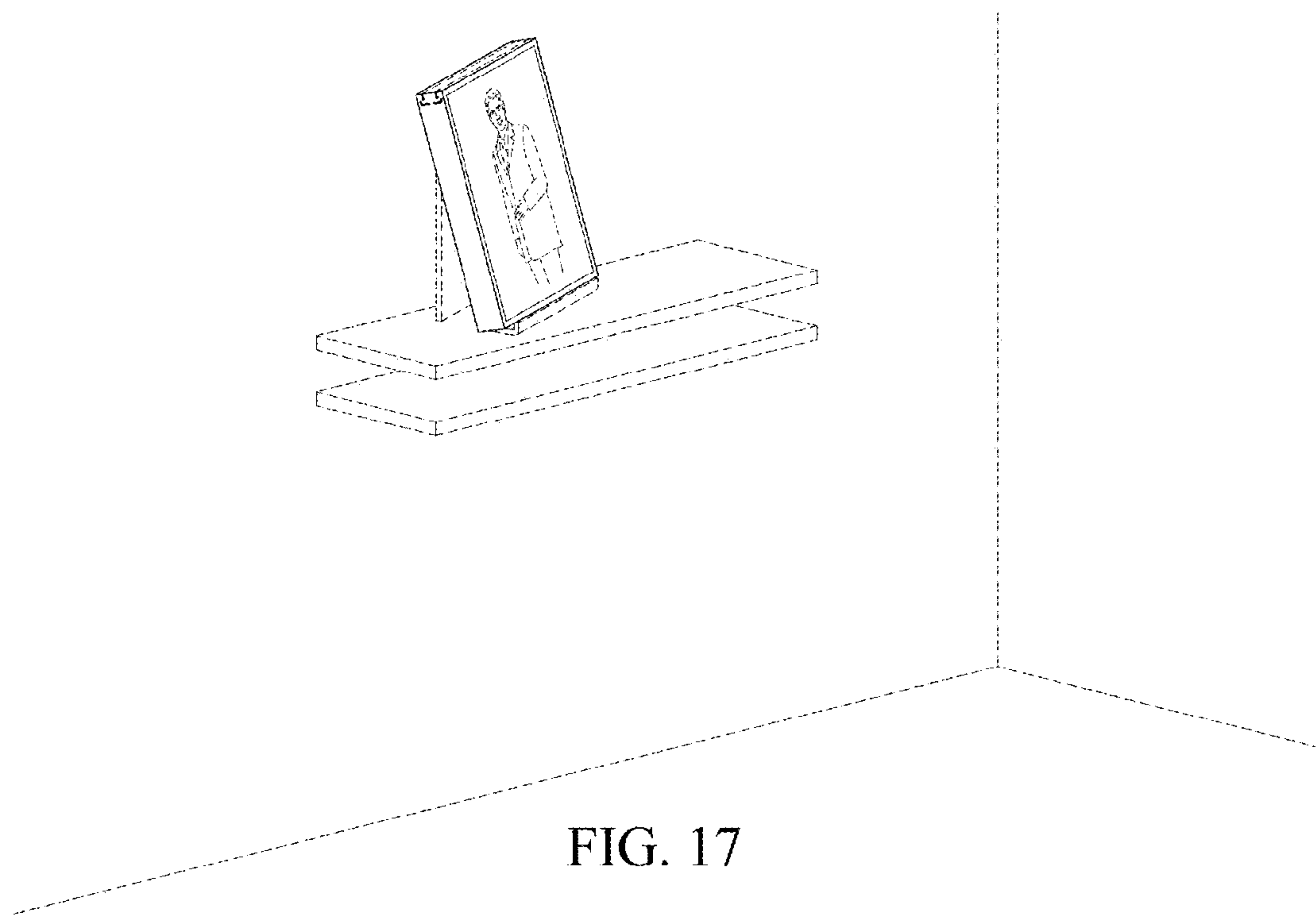

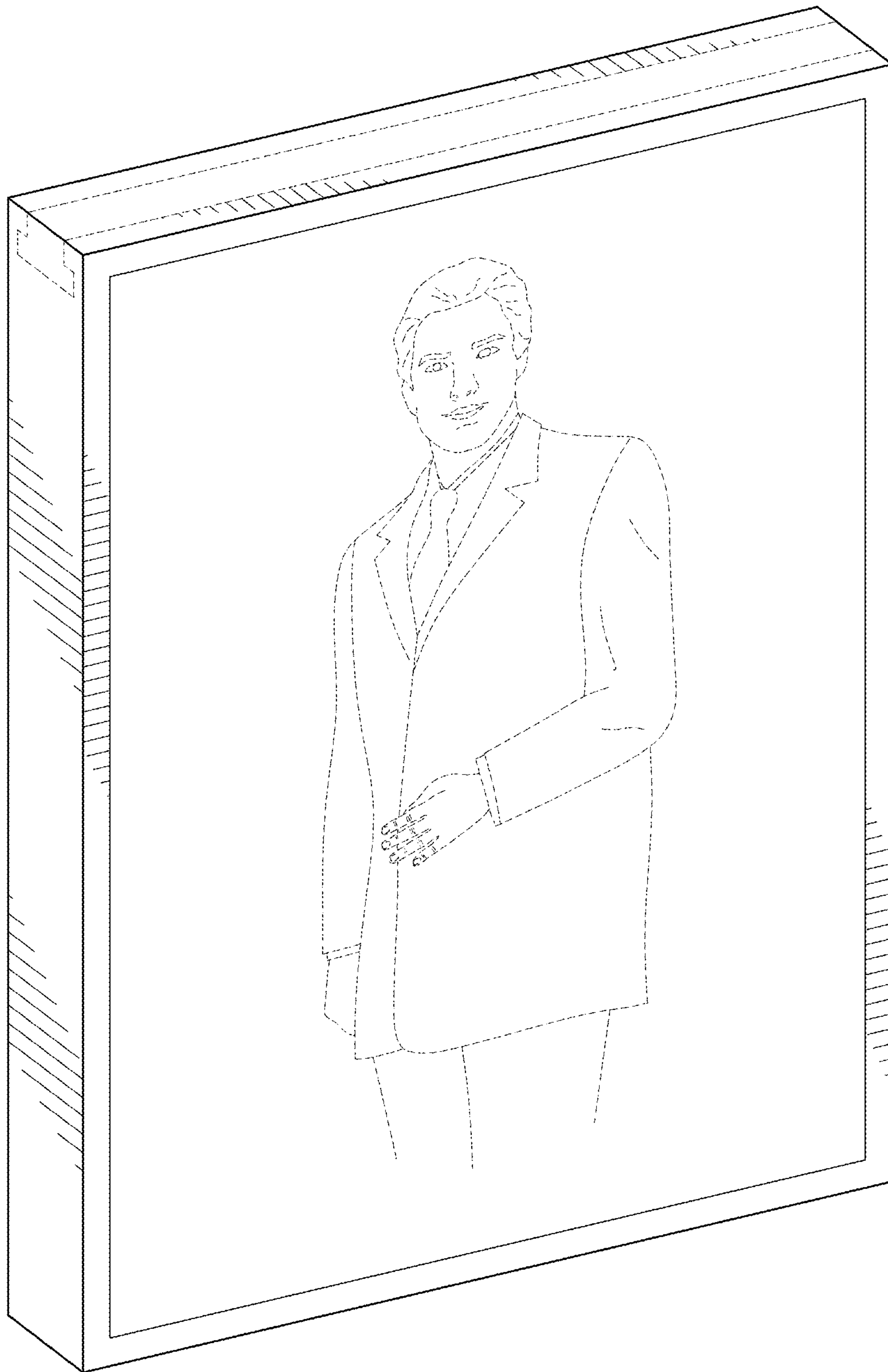

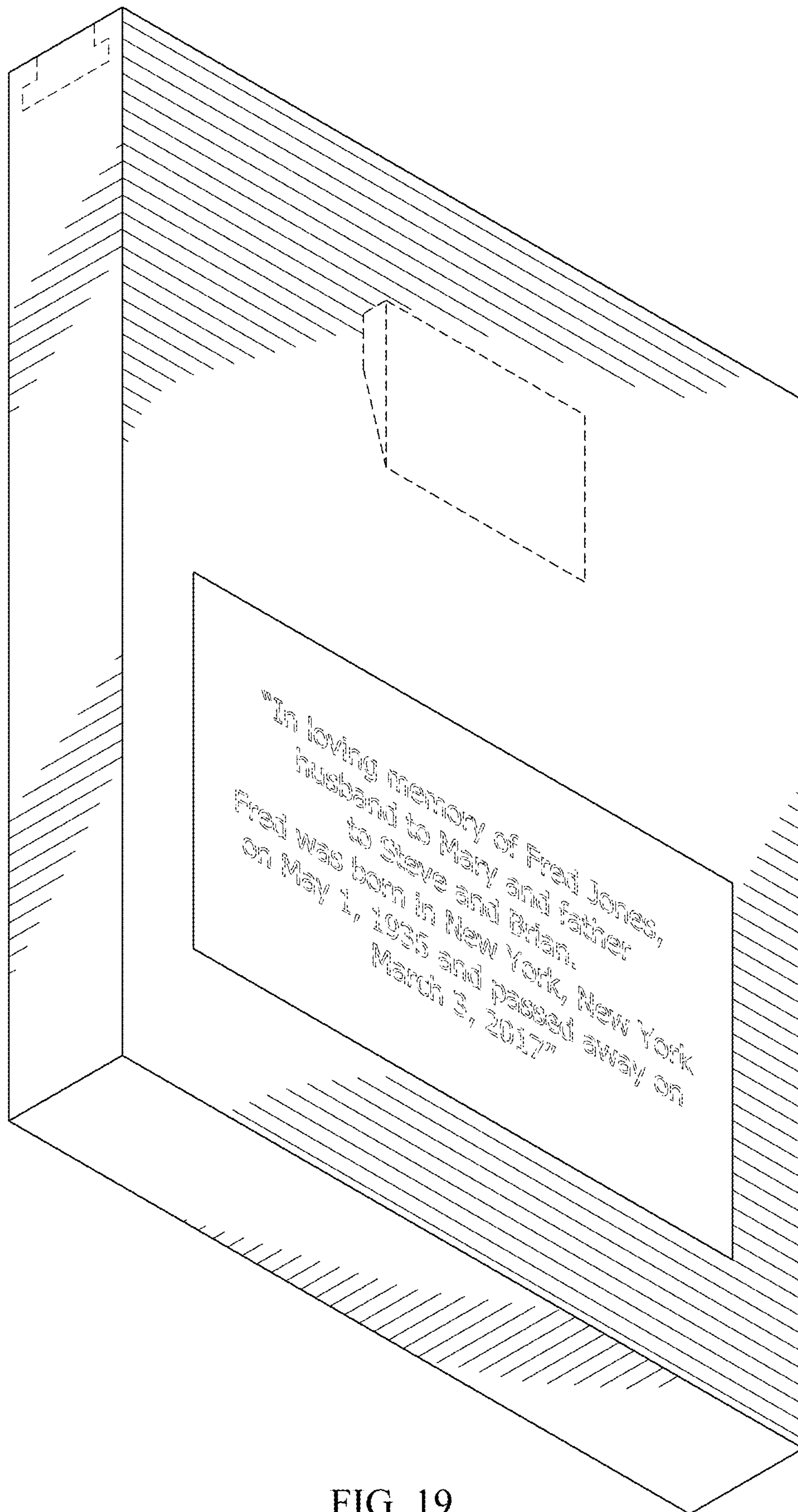

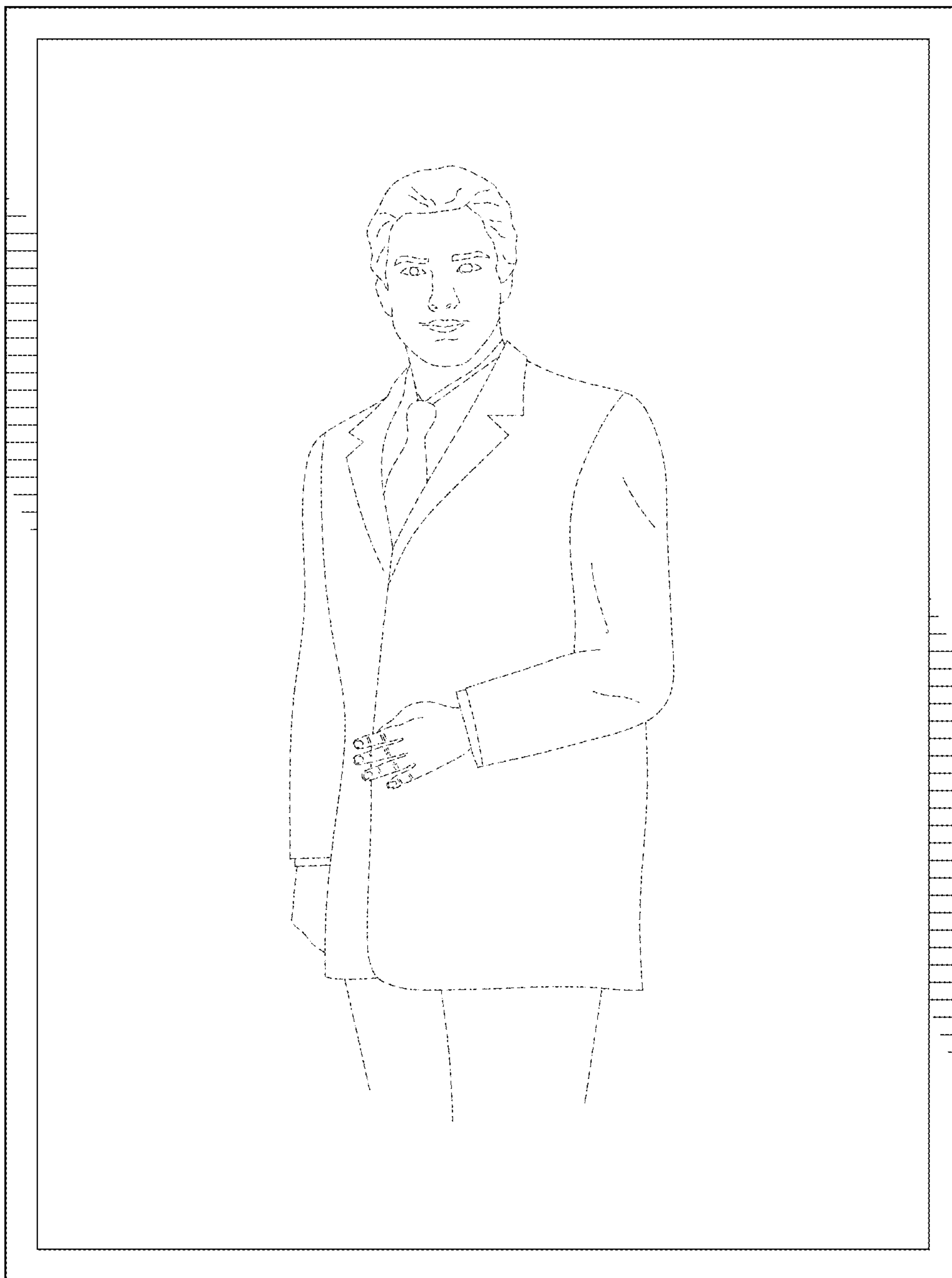

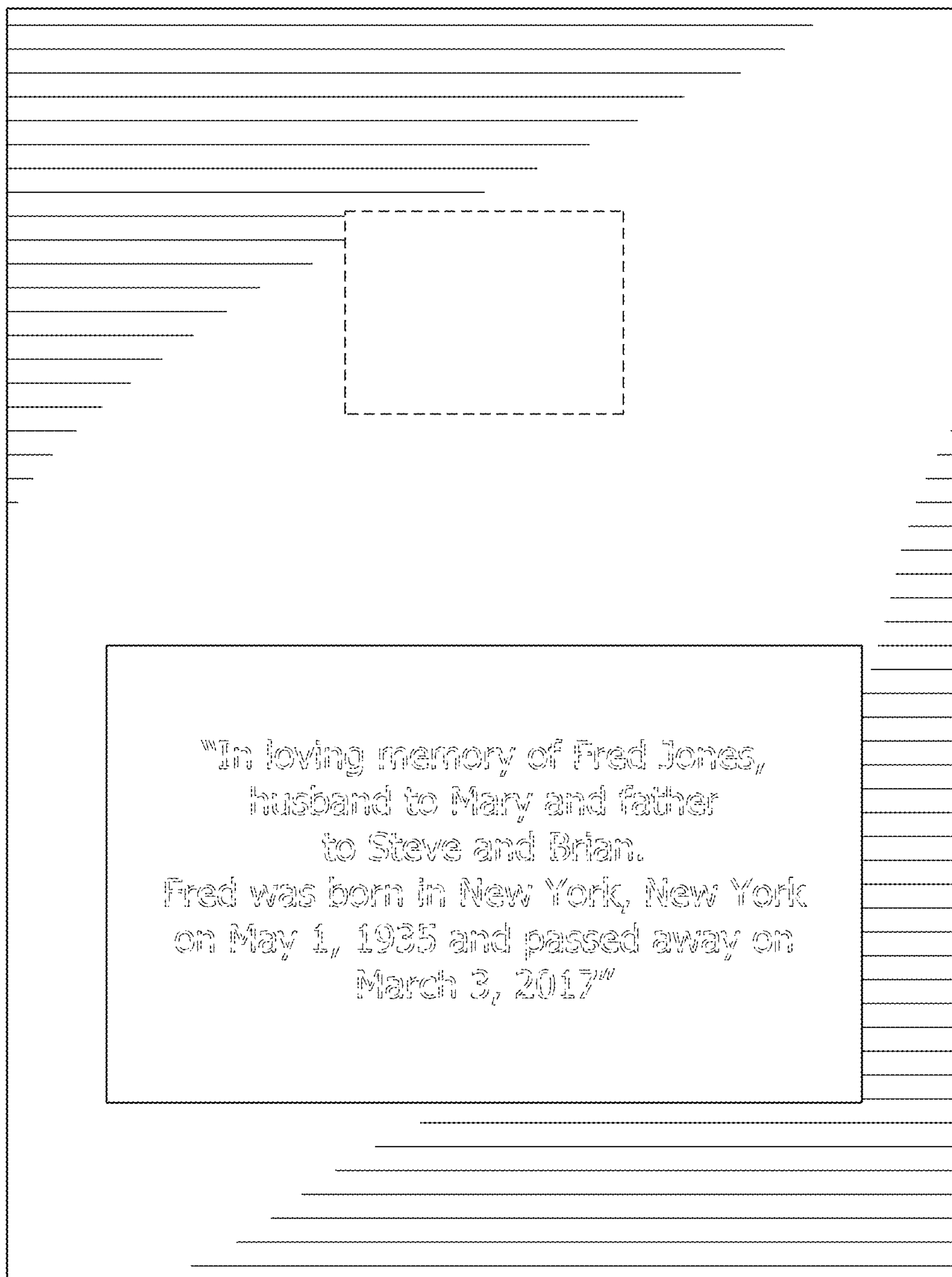

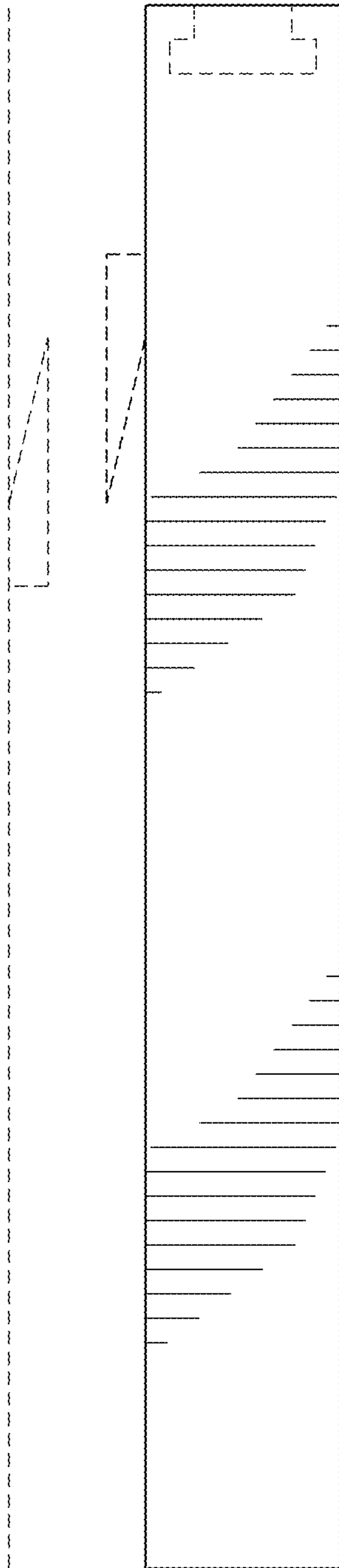

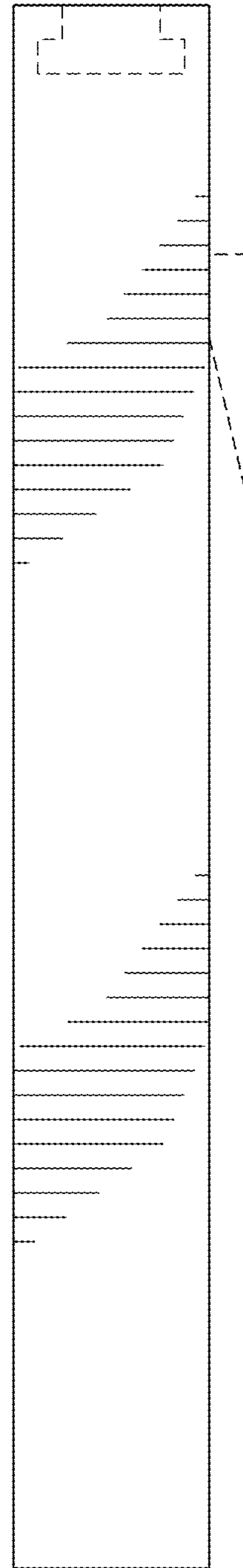

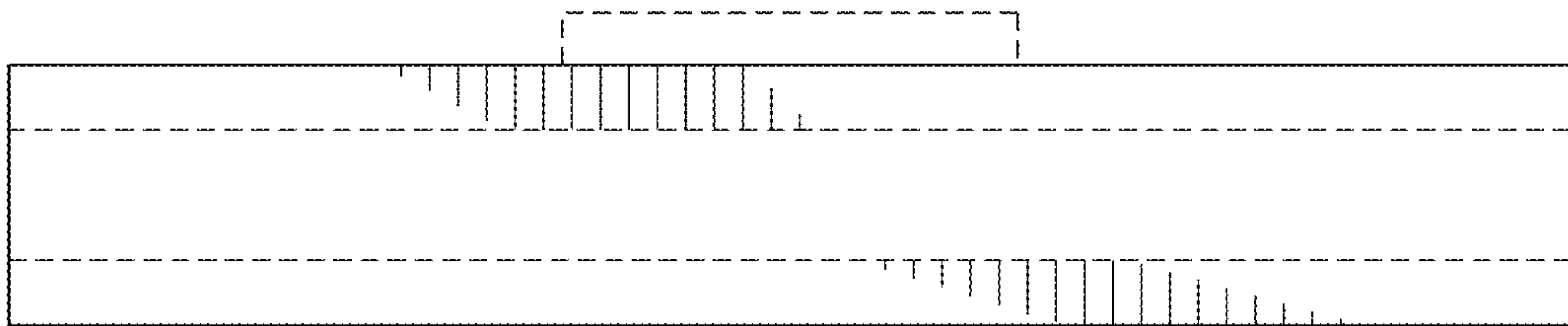

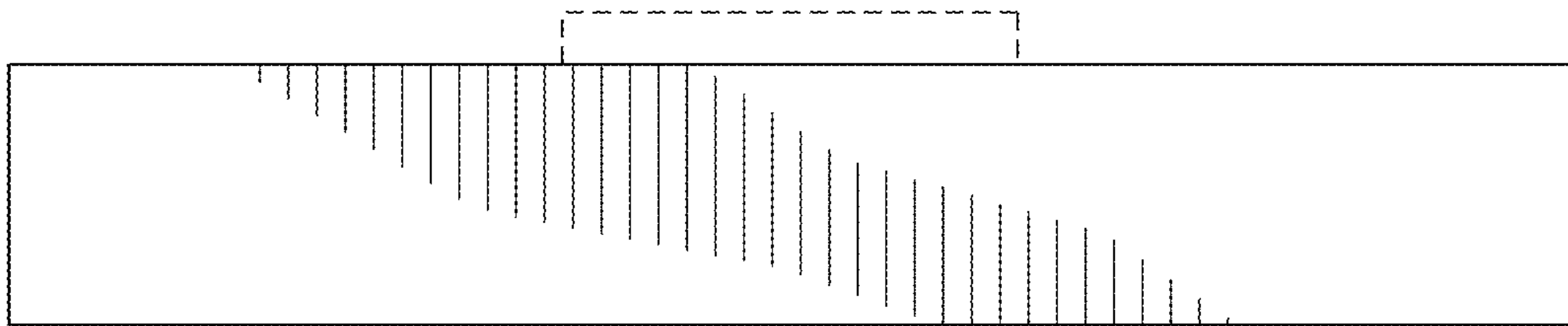
