DESCRIPTION

FIG. 1 is a front, bottom, right side perspective view of a first embodiment of a spiral sliced ham steak; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front, bottom, right side perspective view of a second embodiment of a spiral sliced ham steak; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines in the drawings illustrate portions of the spiral sliced ham steak that form no part of the claimed design.

The break lines shown in the middle portion of the spiral sliced ham steak in FIGS. 1, 4-8, and 11-14 indicate that the appearance of any portion of the article between the break lines forms no part of the claimed design.

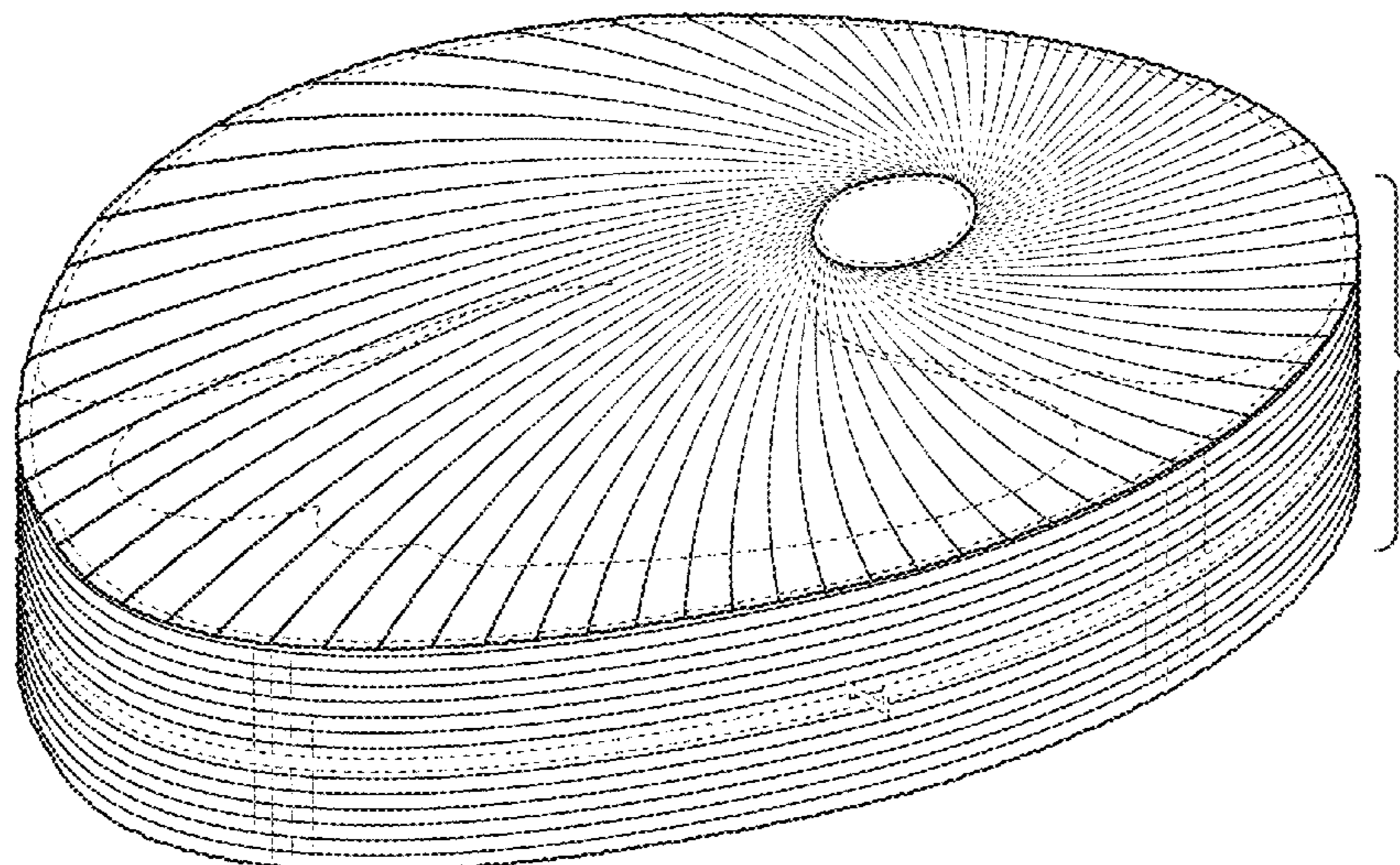

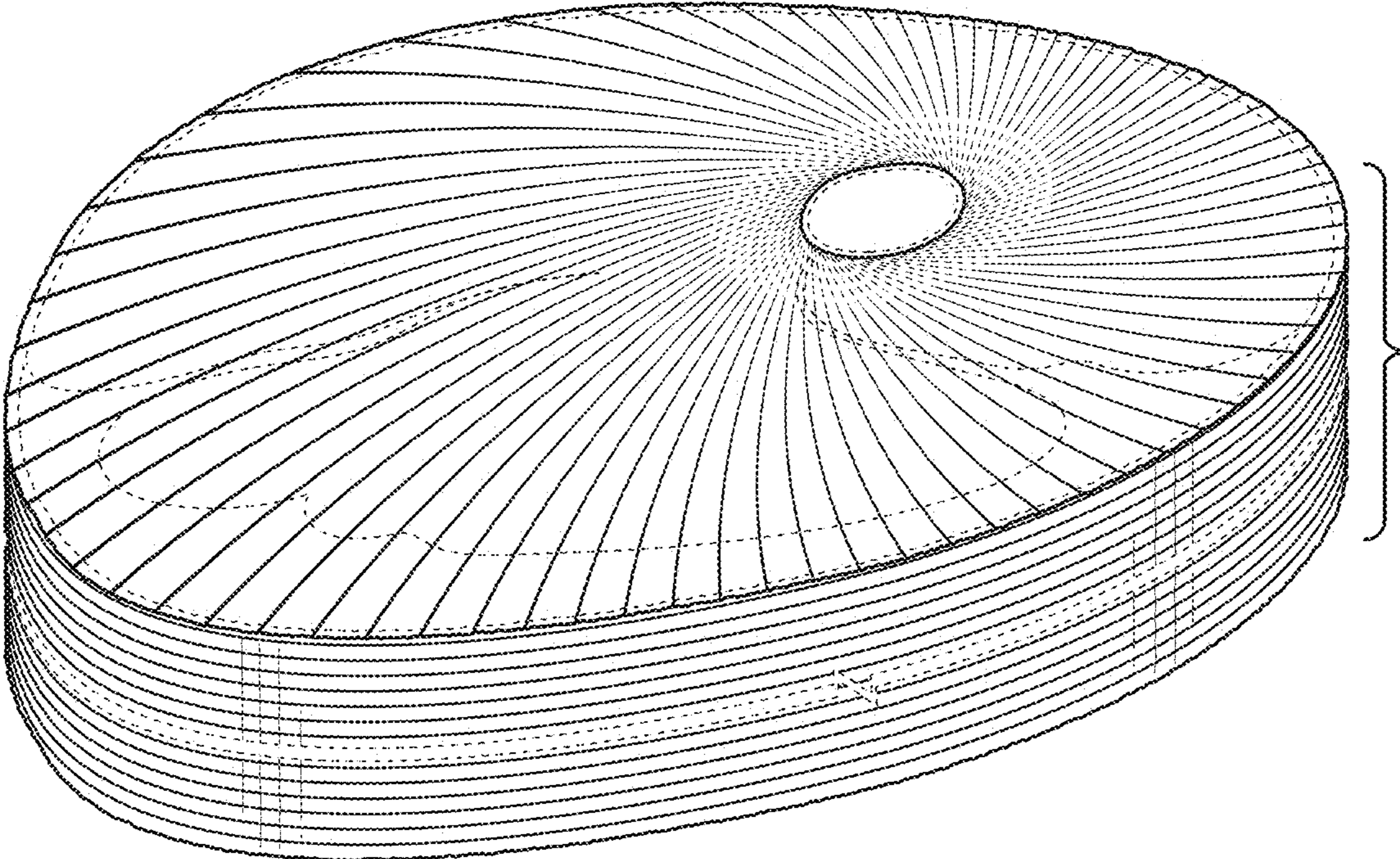

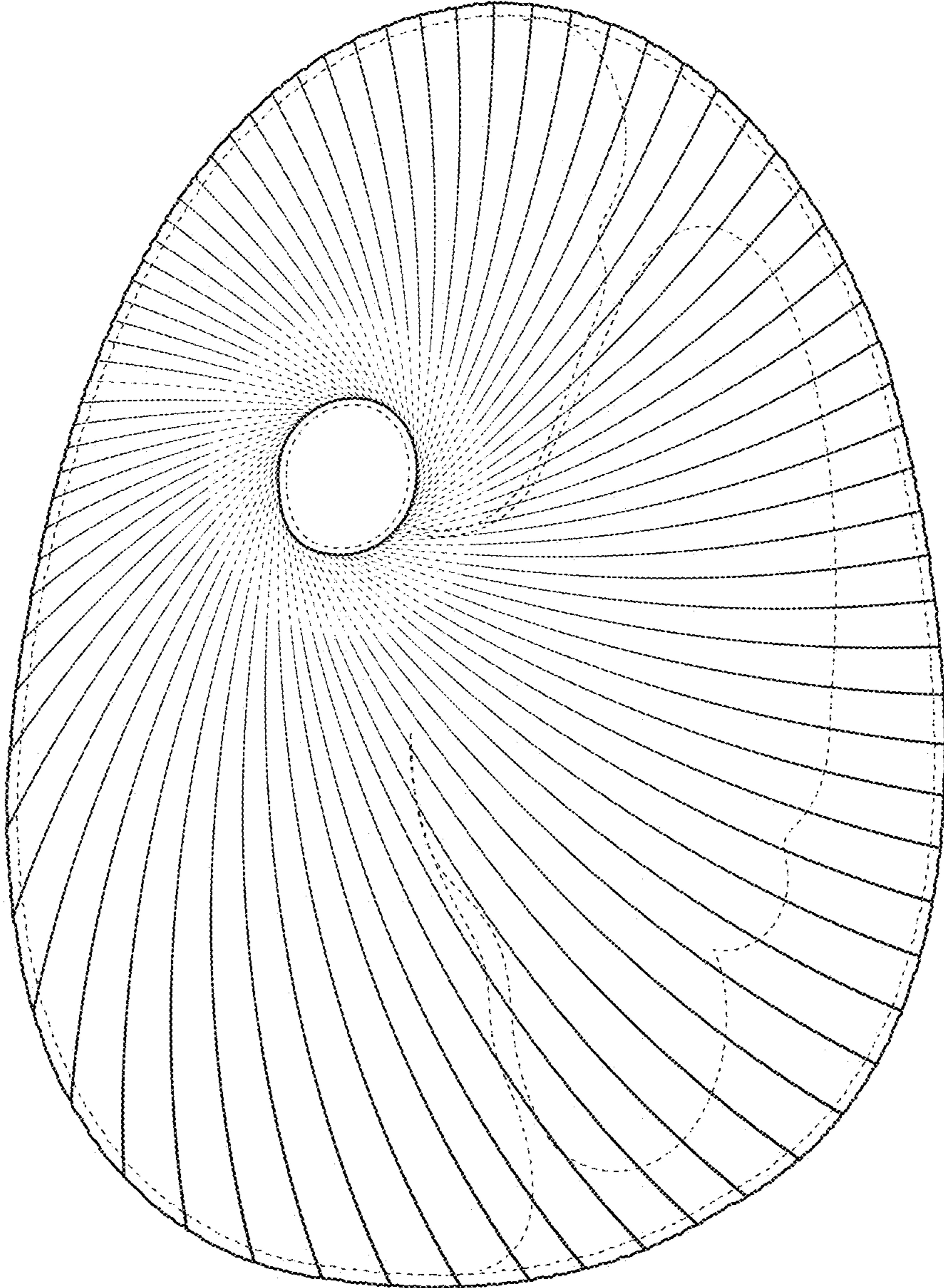

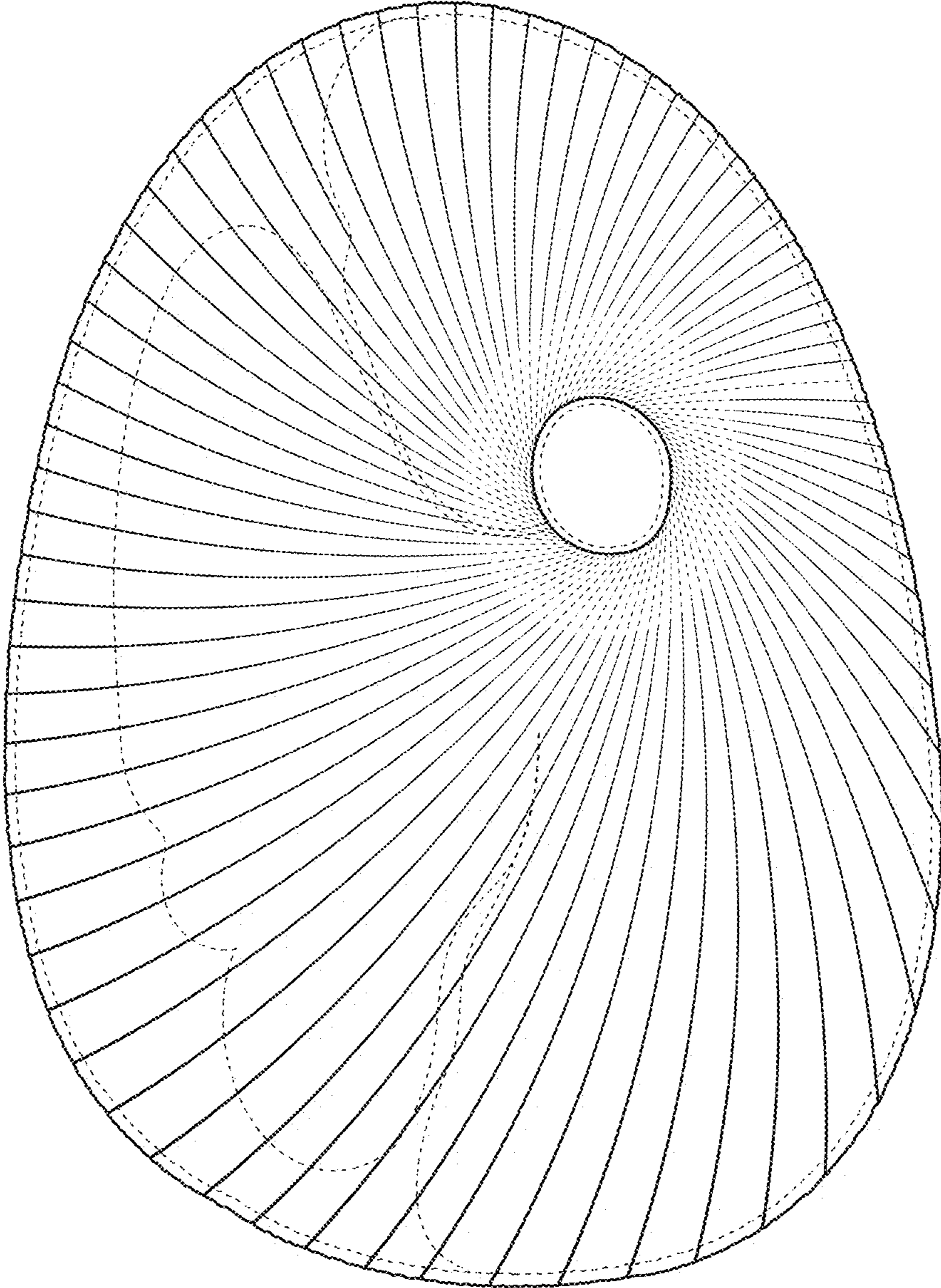

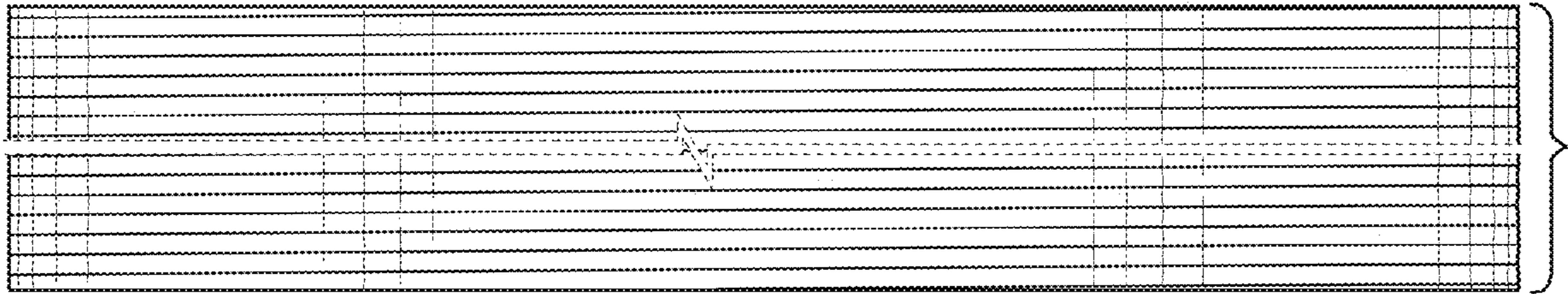

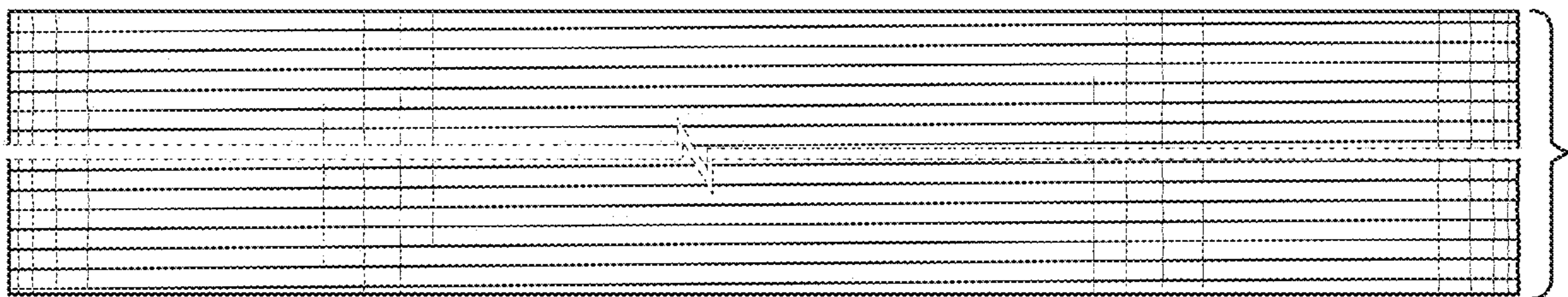

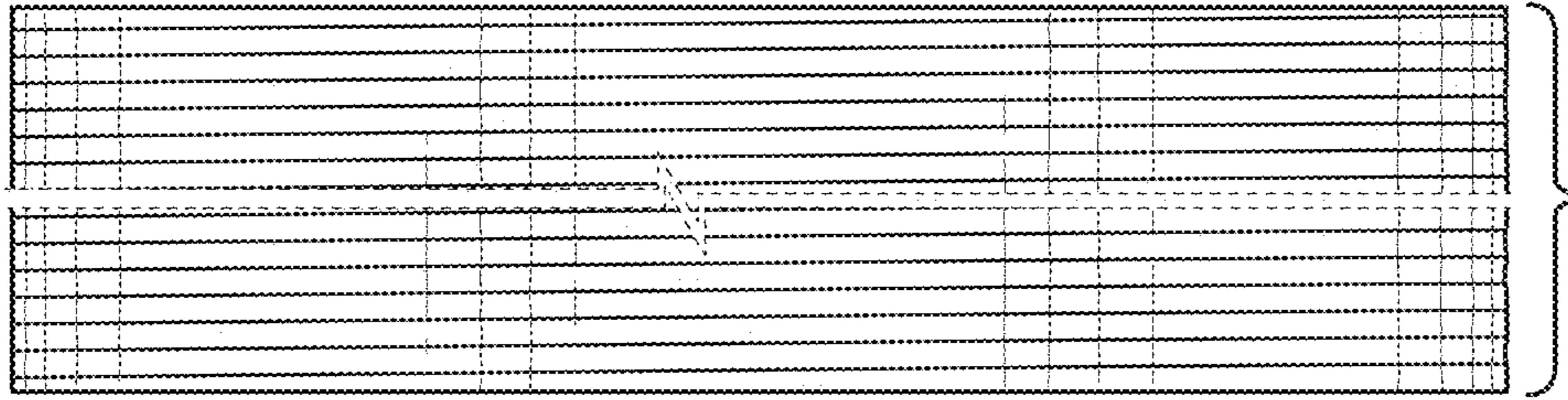

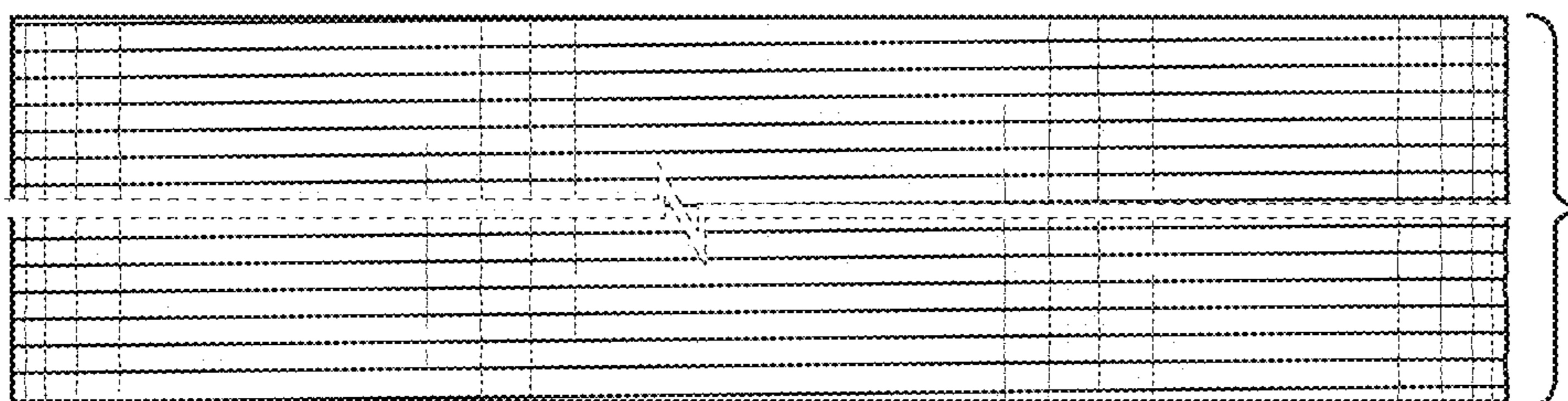

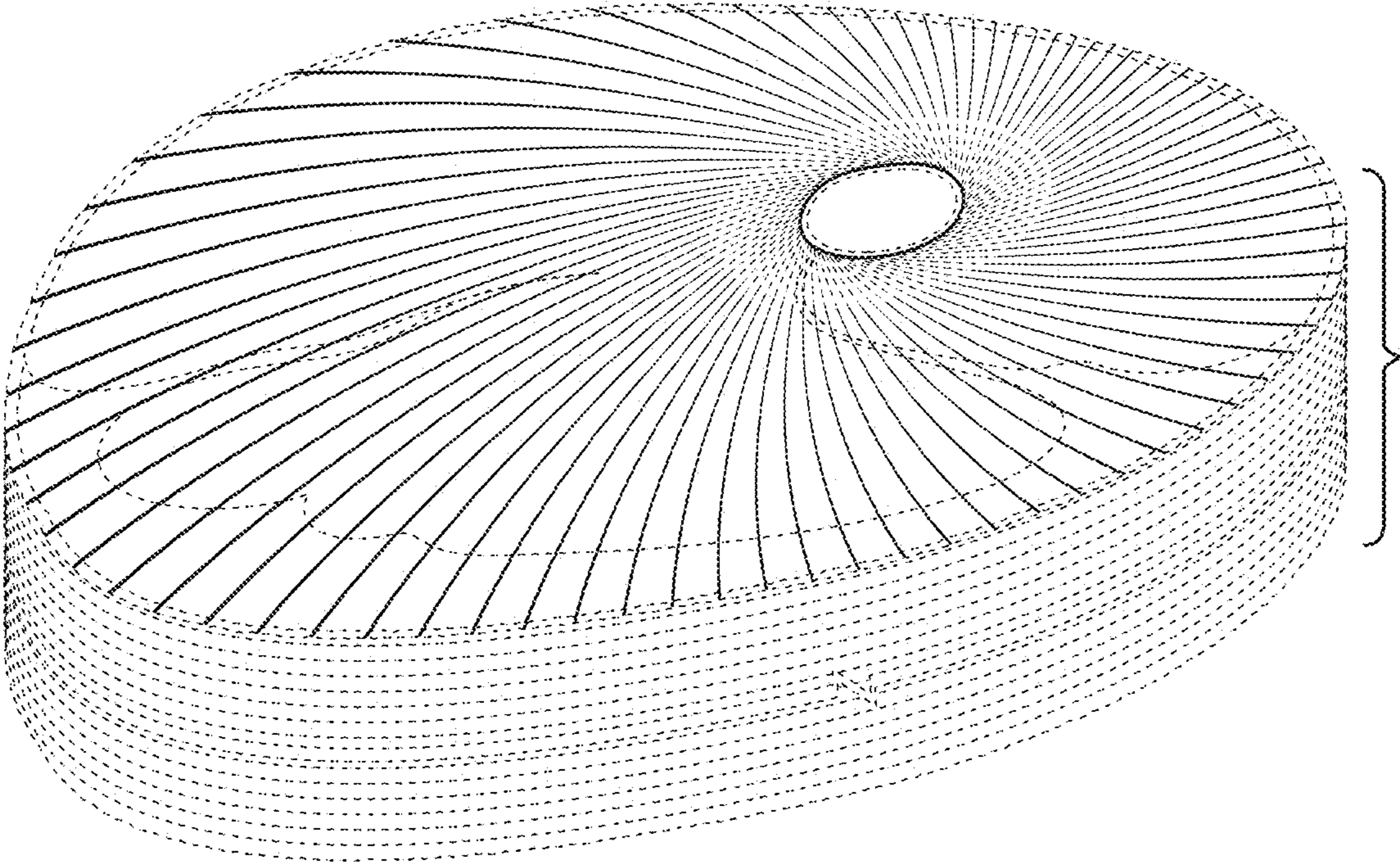

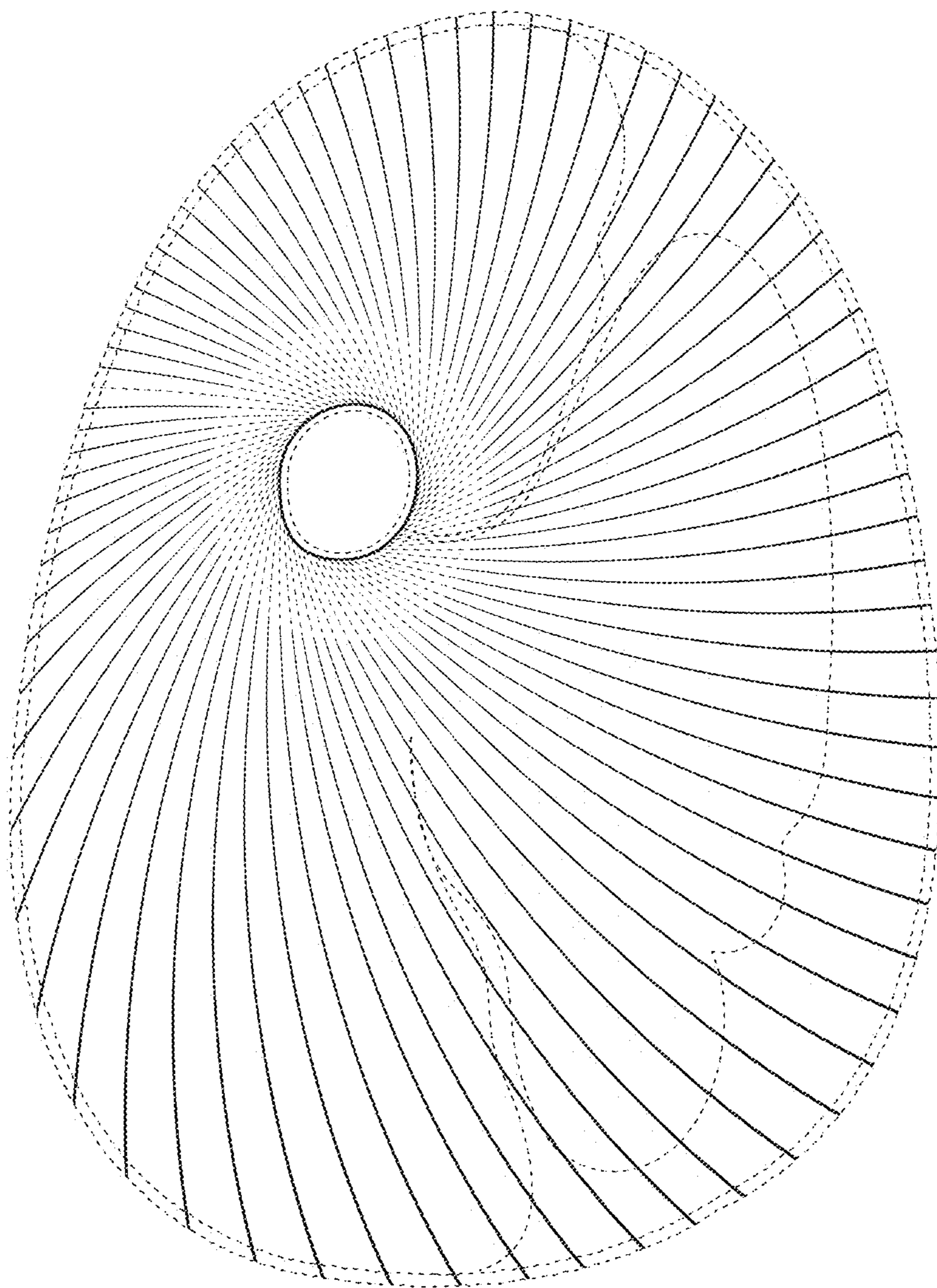

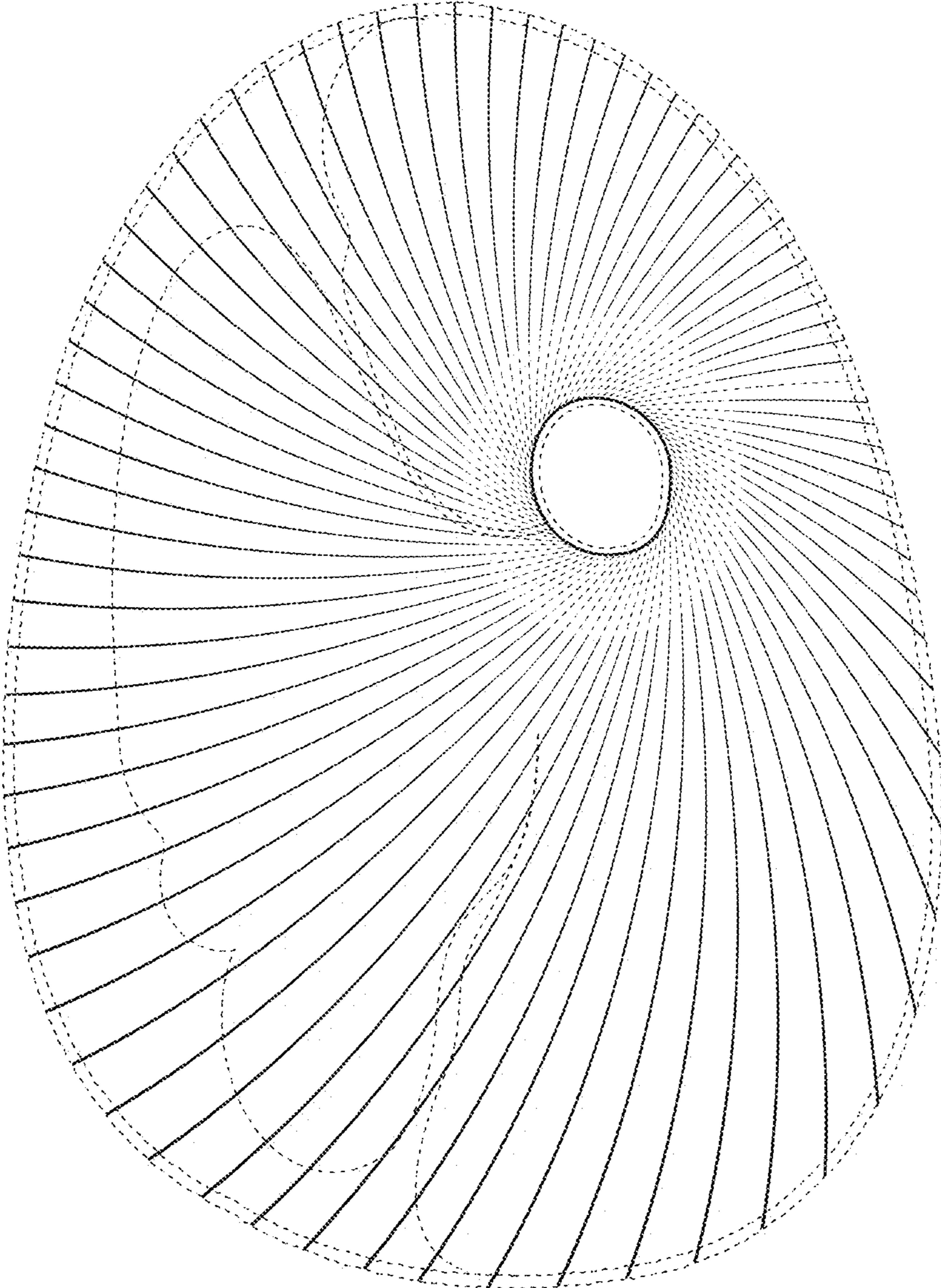

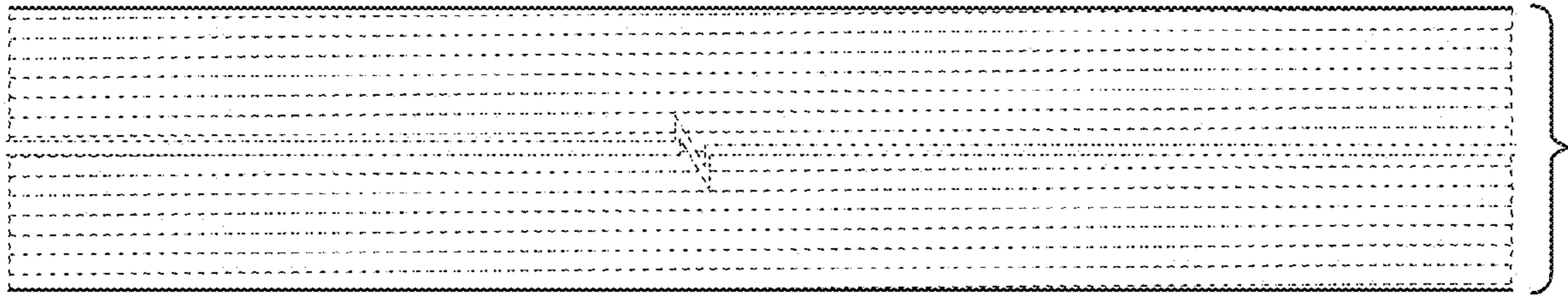

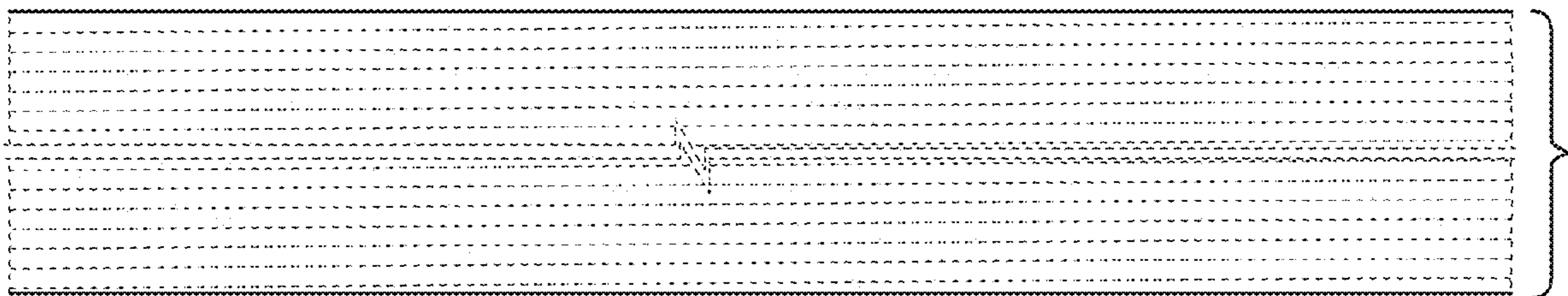

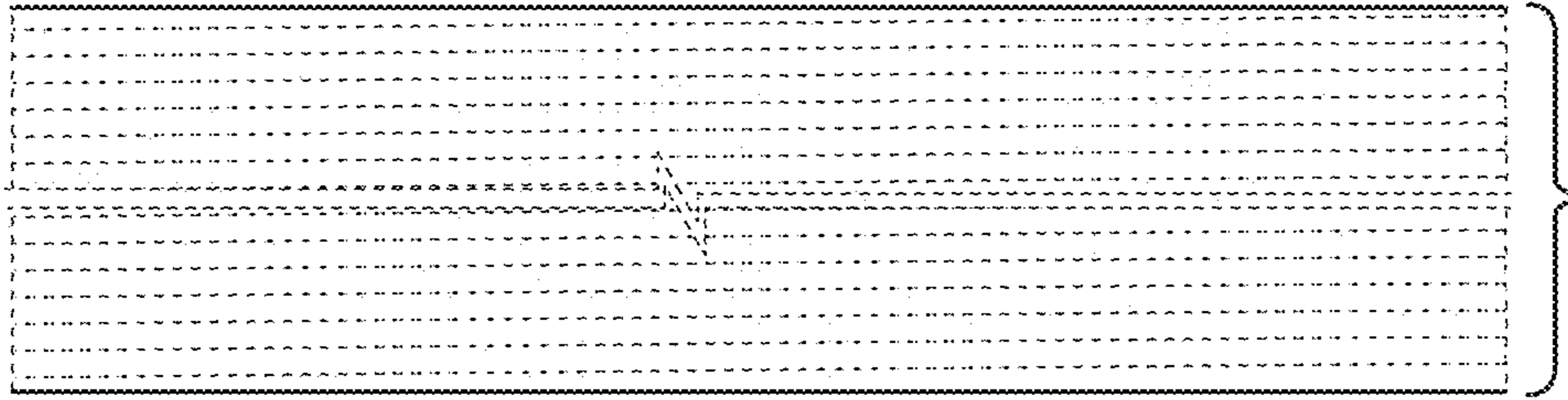

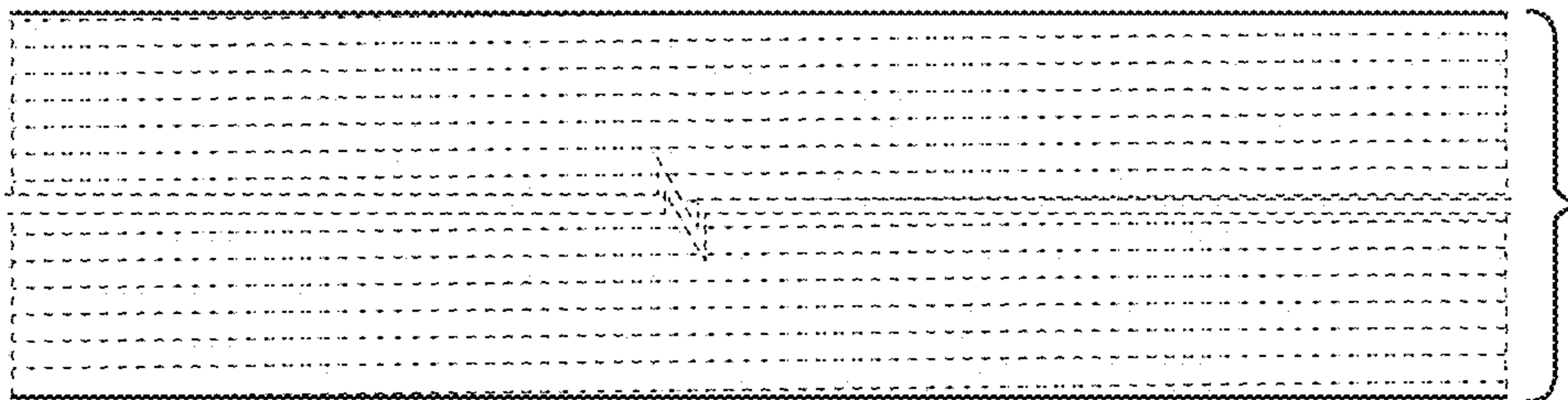
