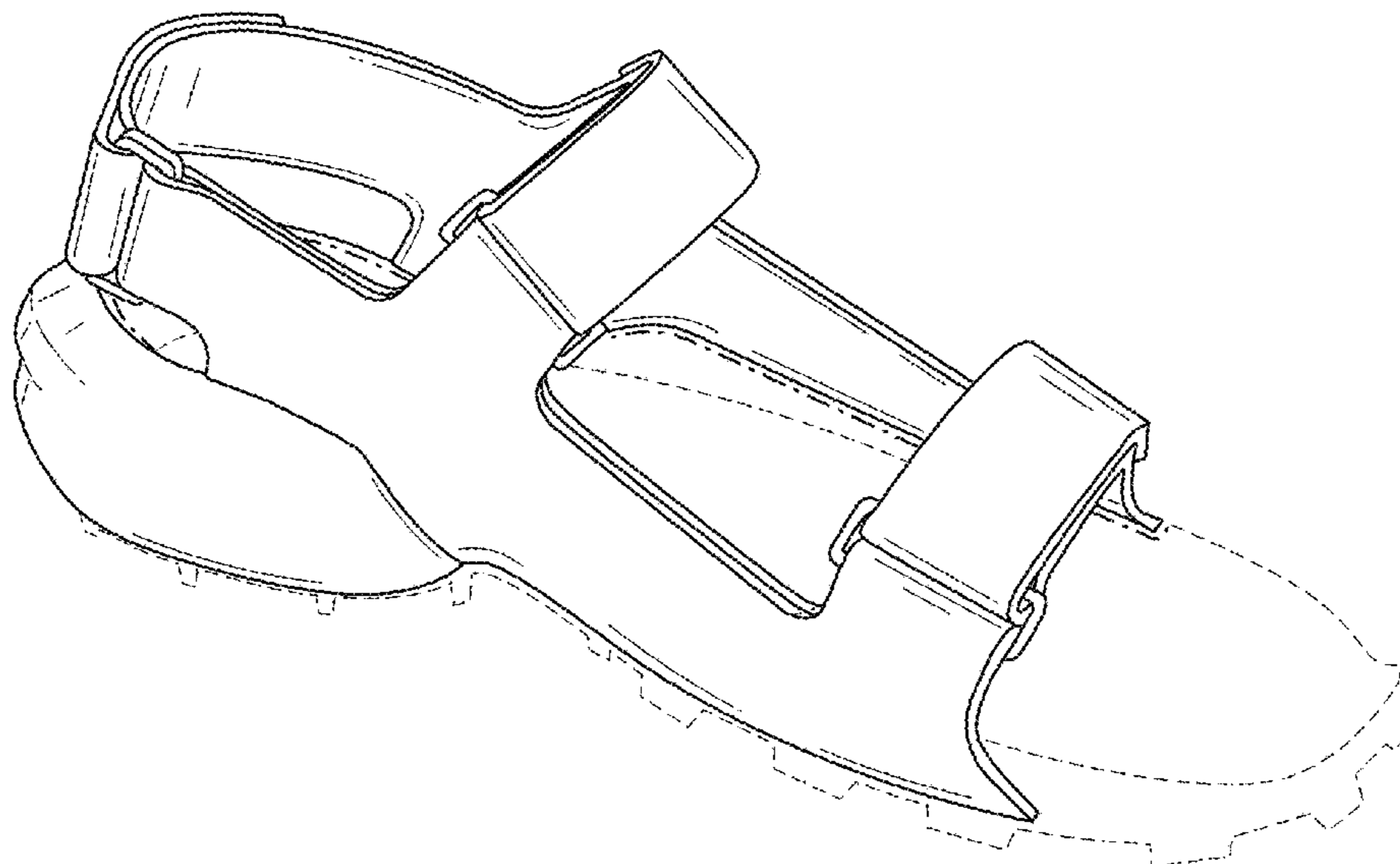
(57) **CLAIM**

The ornamental design for a sandal, as shown and described.

DESCRIPTION

FIG. 1 is a top, side perspective view of a sandal showing my new design;
FIG. 2 is a rear, side perspective view of the sandal of FIG. 1;
FIG. 3 is a first side view of the sandal of FIG. 1;
FIG. 4 is a second side view of the sandal of FIG. 1;
FIG. 5 is a front view of the sandal of FIG. 1;
FIG. 6 a rear view of the sandal of FIG. 1; and,
FIG. 7 is a top view of the sandal of FIG. 1.
The dot dashed broken lines in FIGS. 1, 2 and 7 depict the boundaries of the claimed design. The even dashed broken lines in FIGS. 1-7 are directed to environment and form no part of the claimed design.

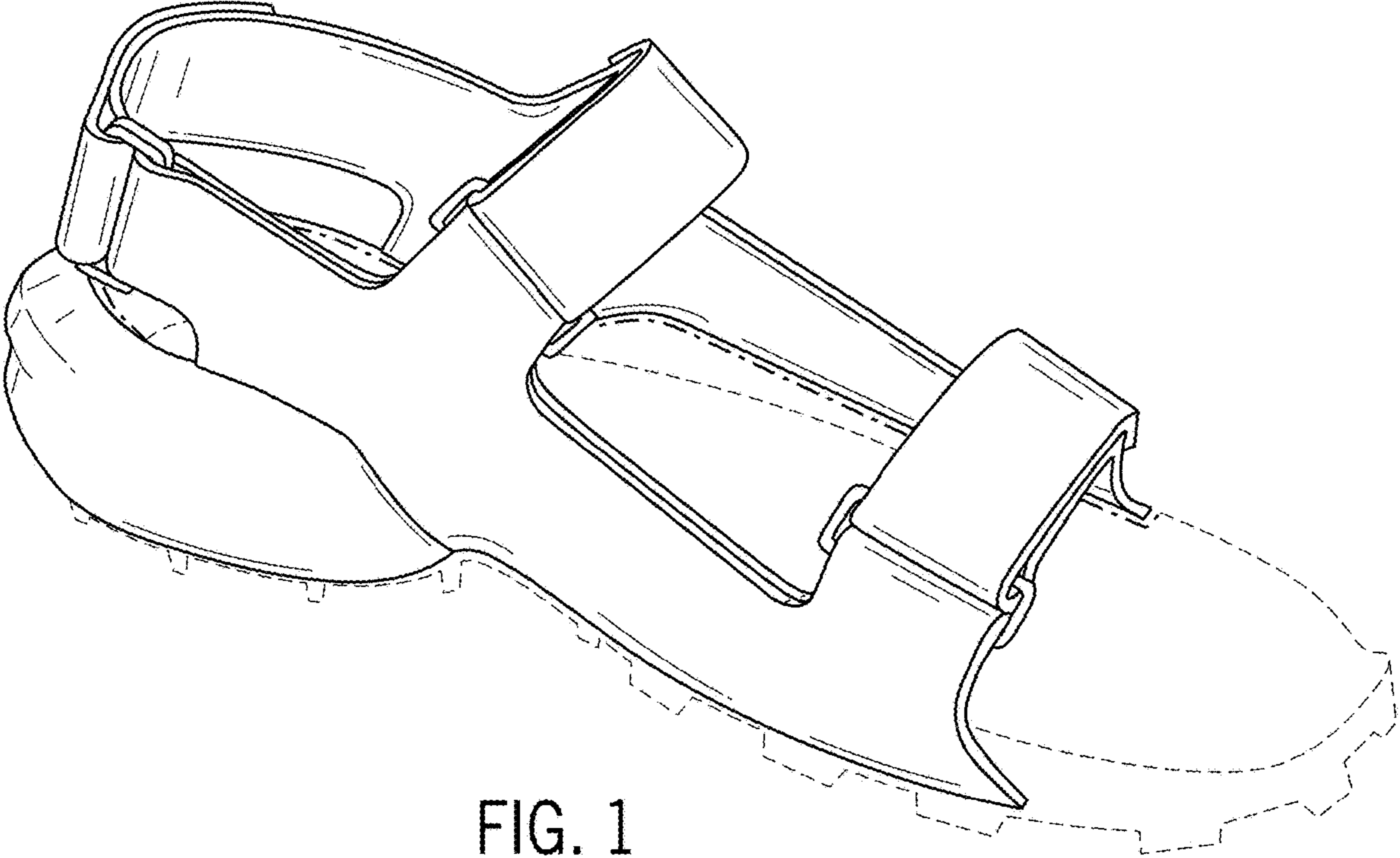

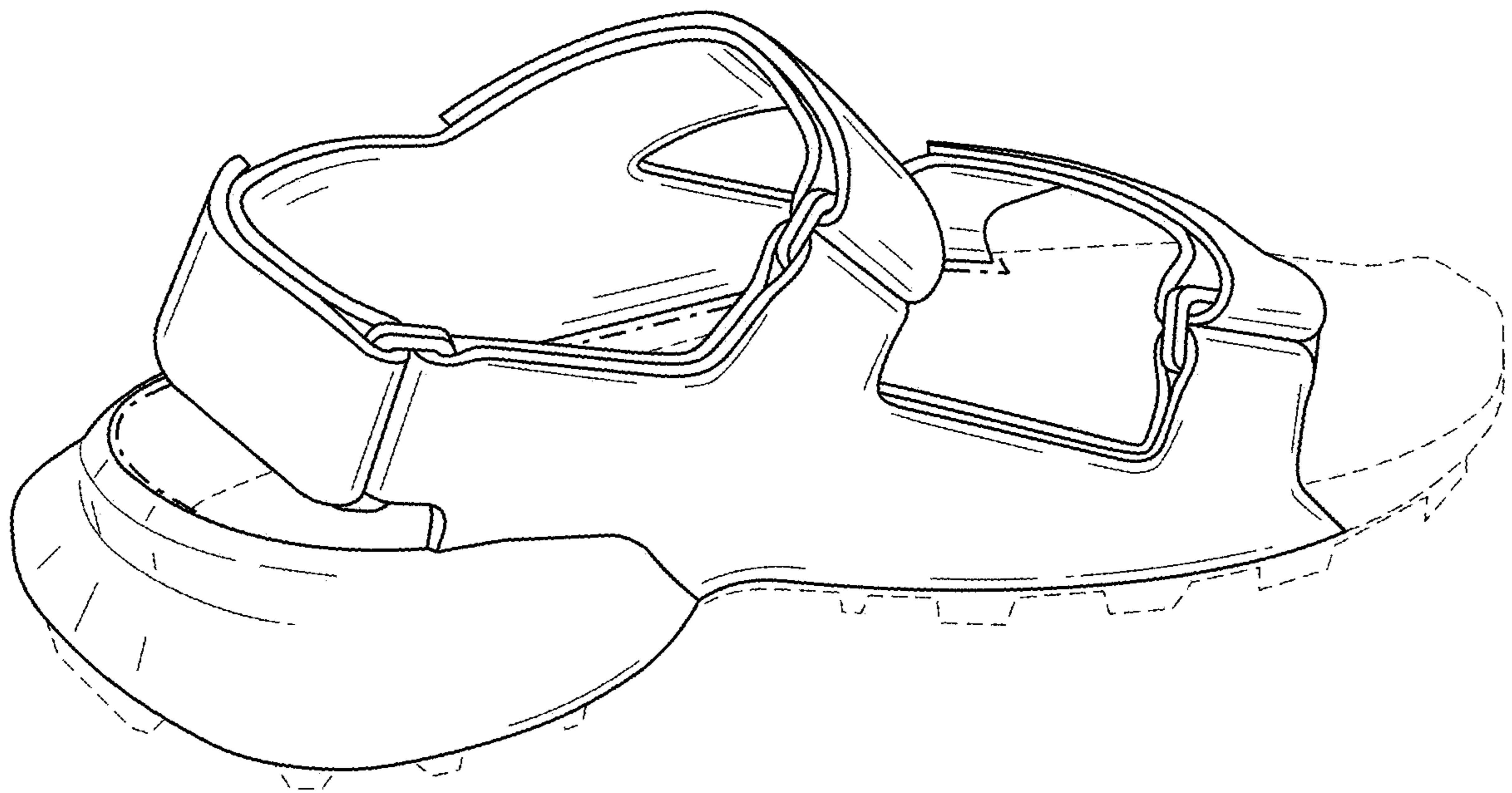

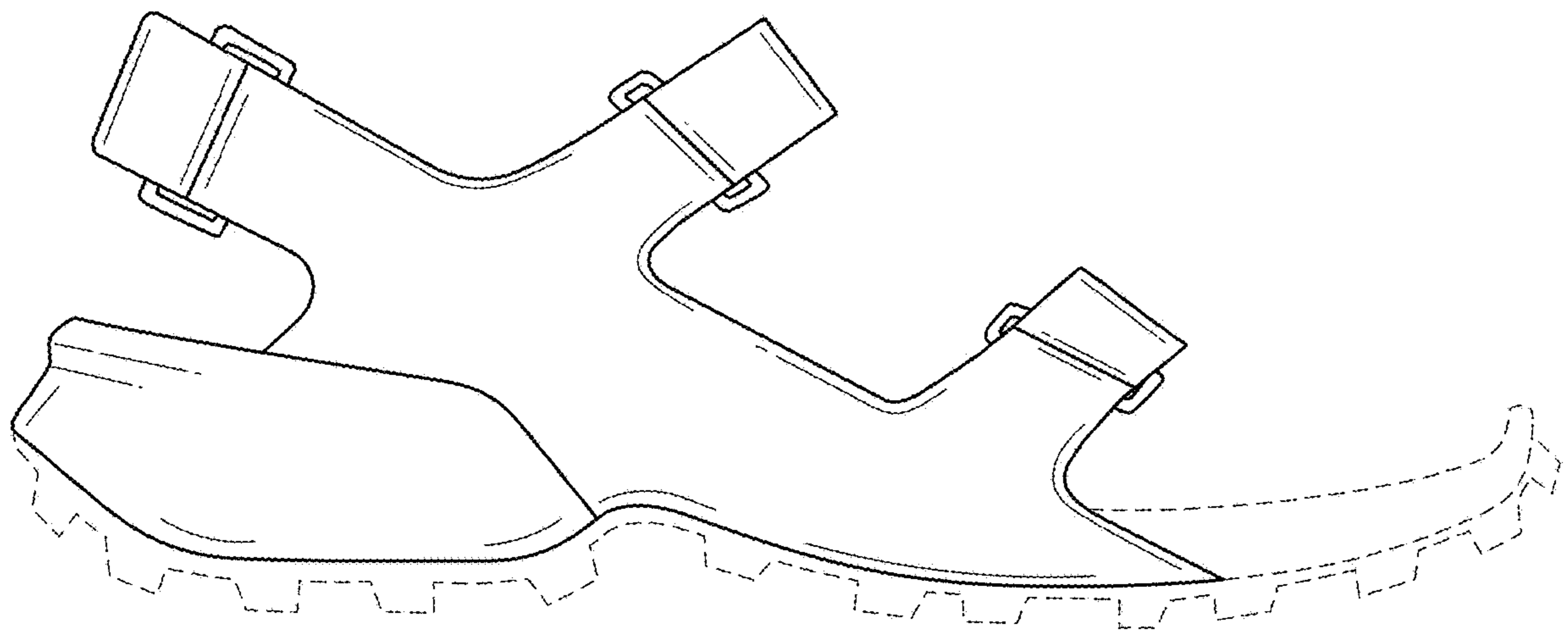

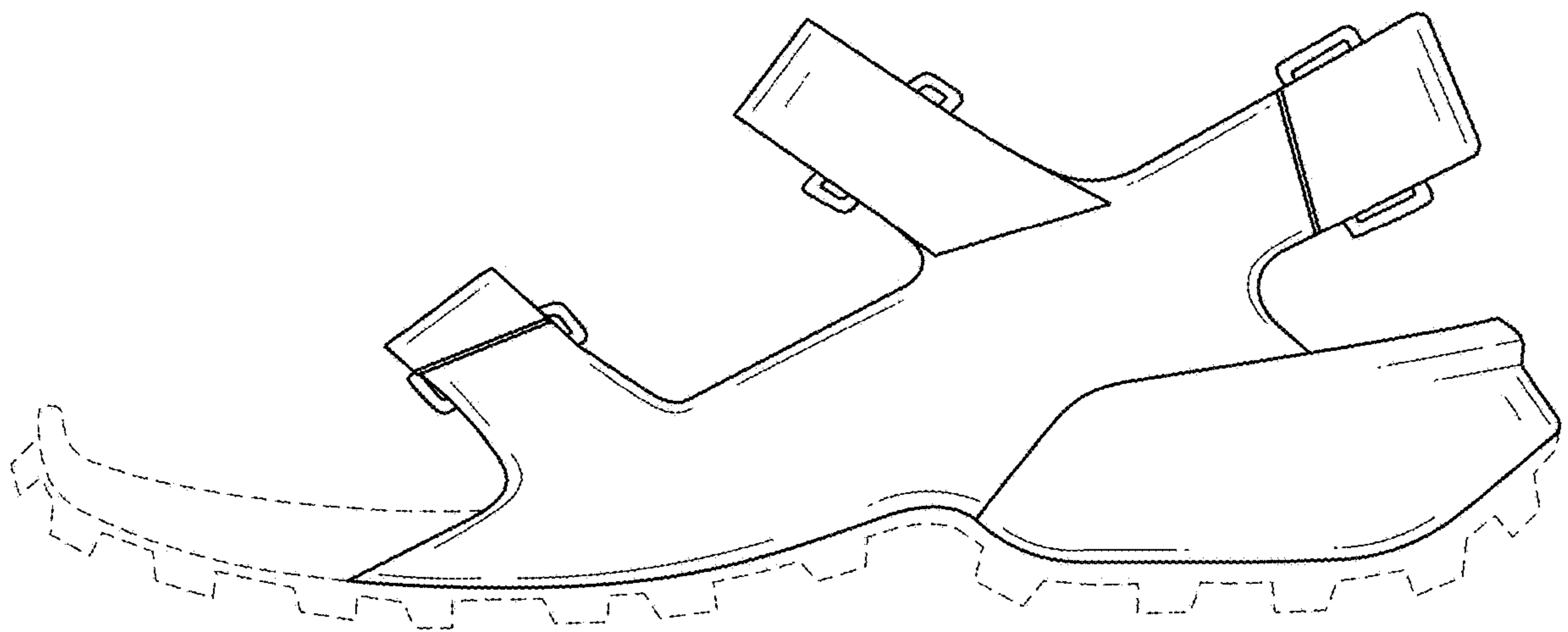

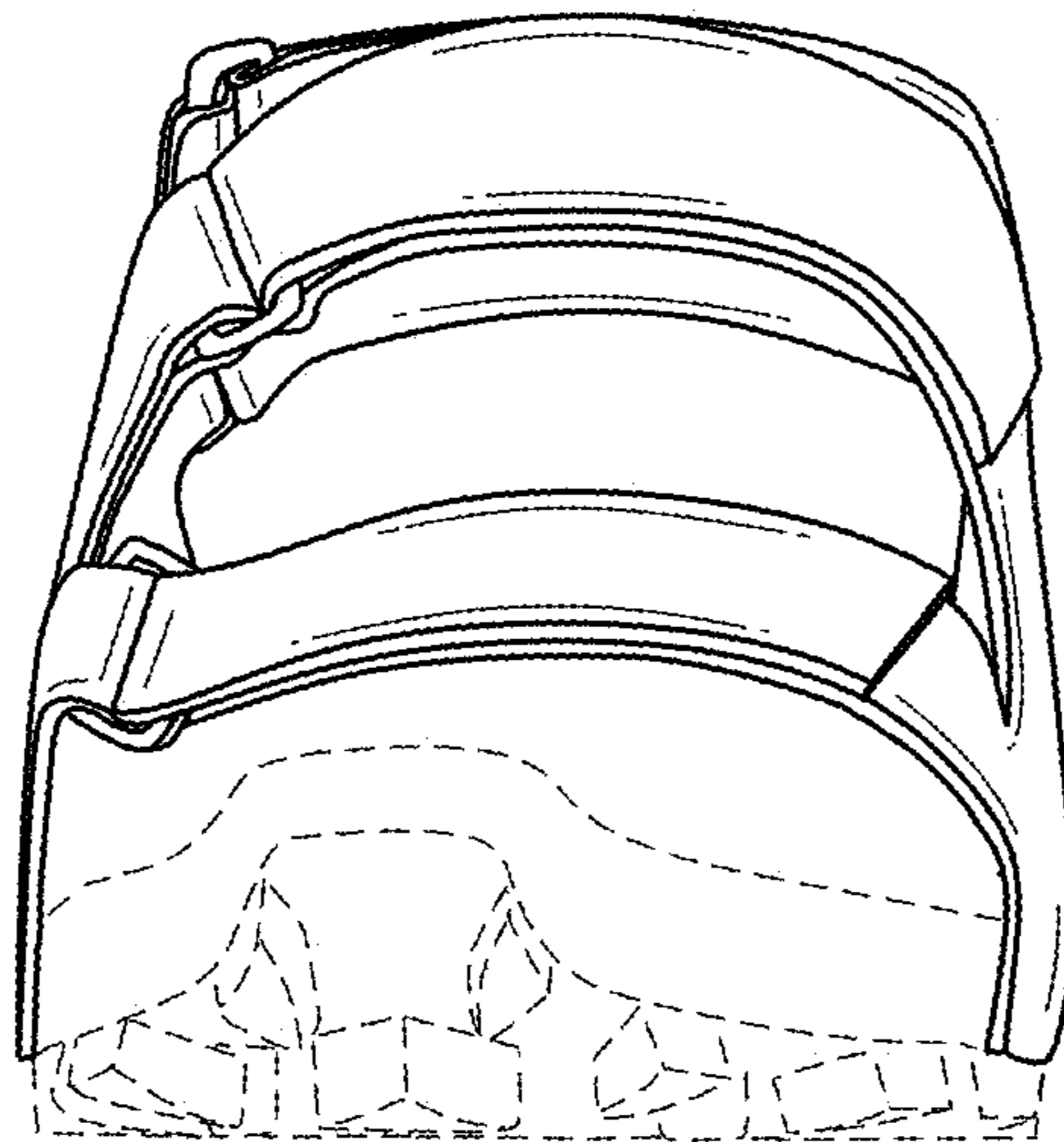

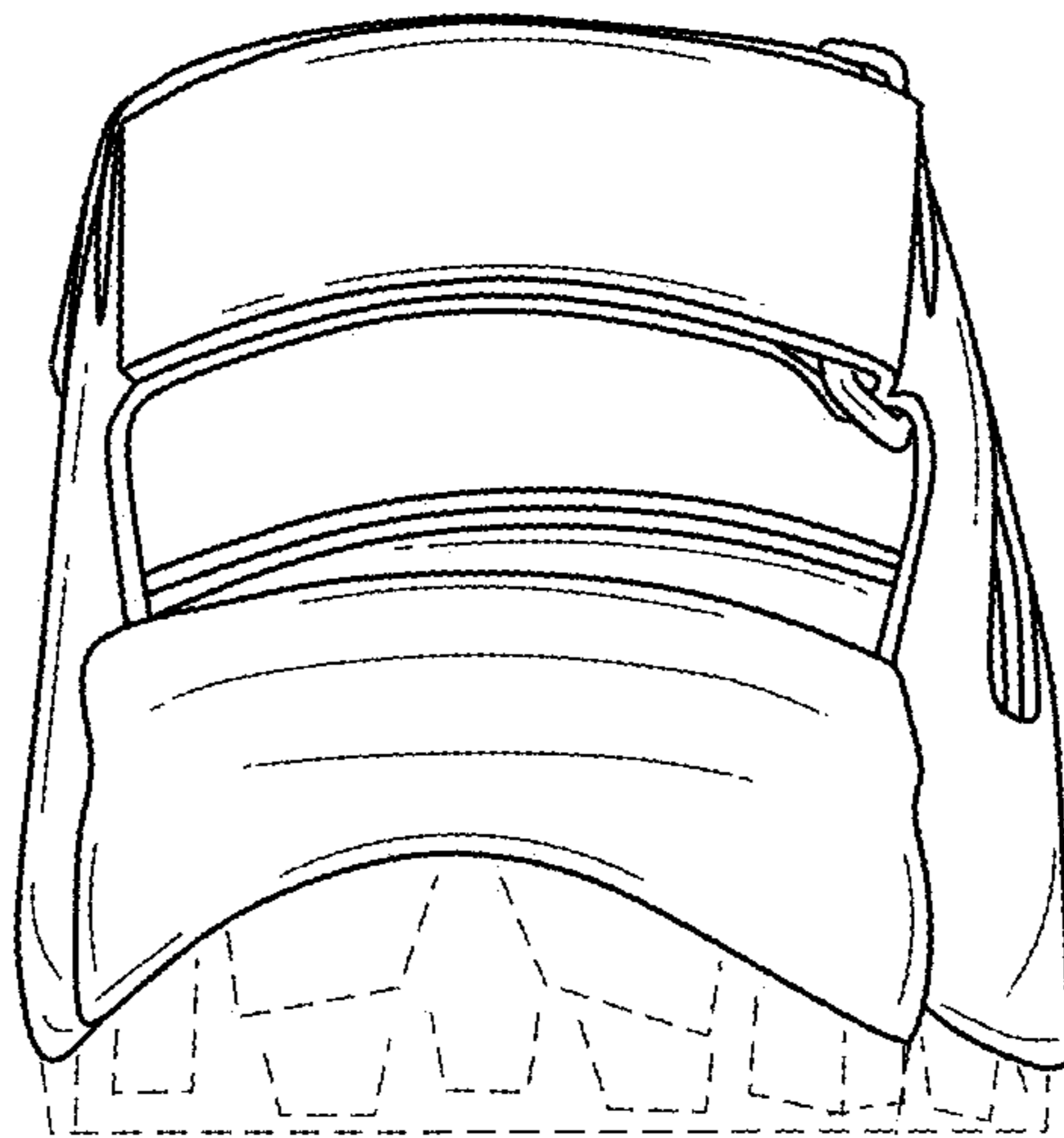

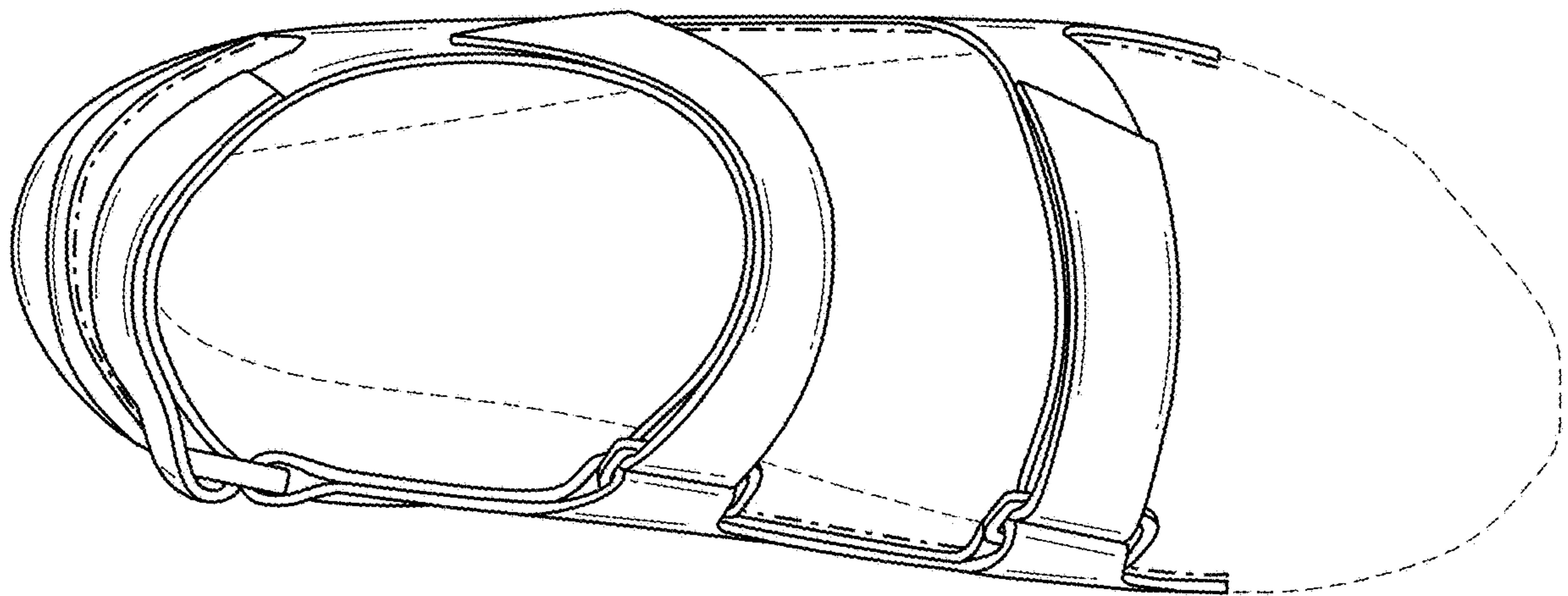
