DESCRIPTION

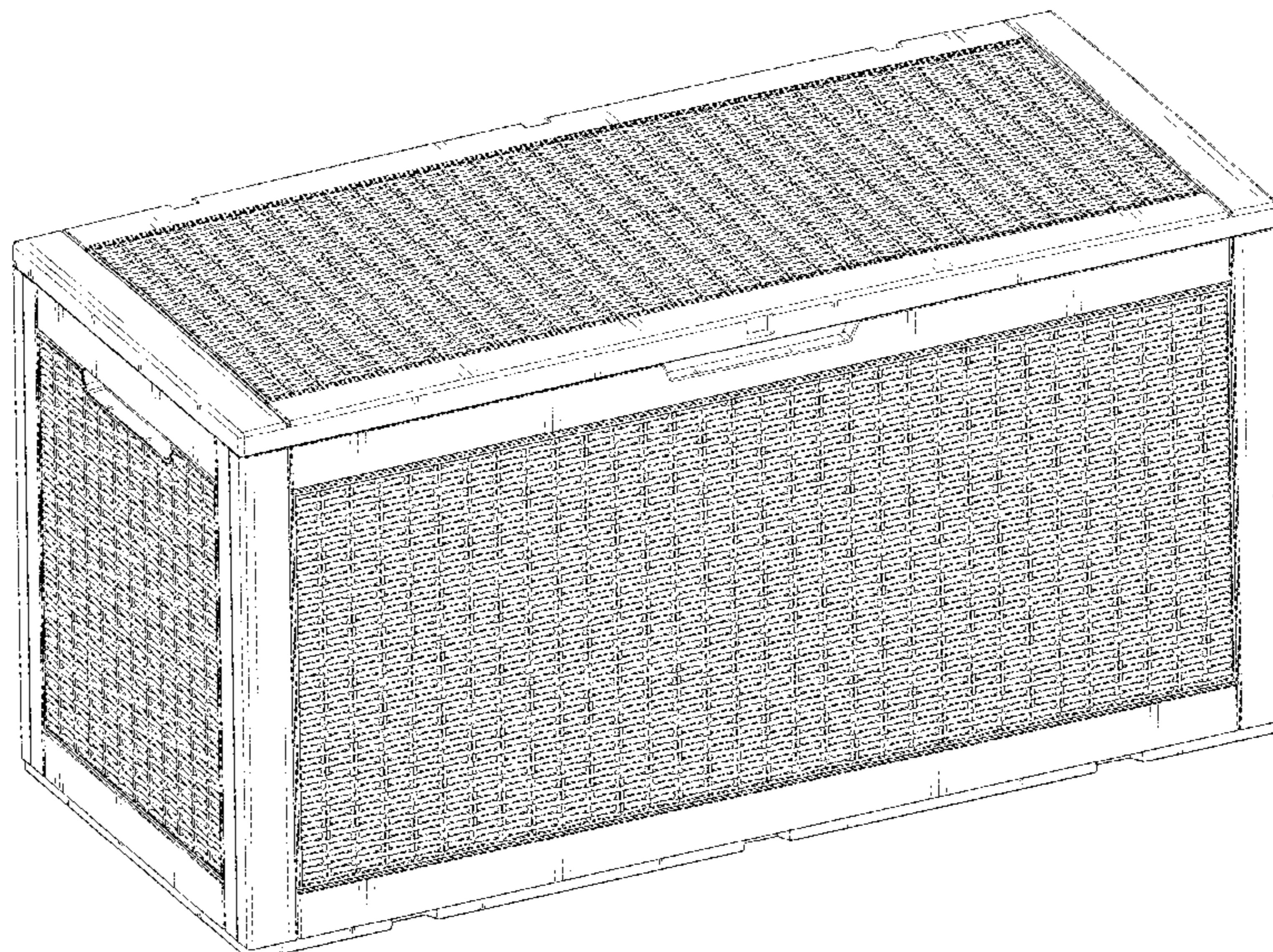

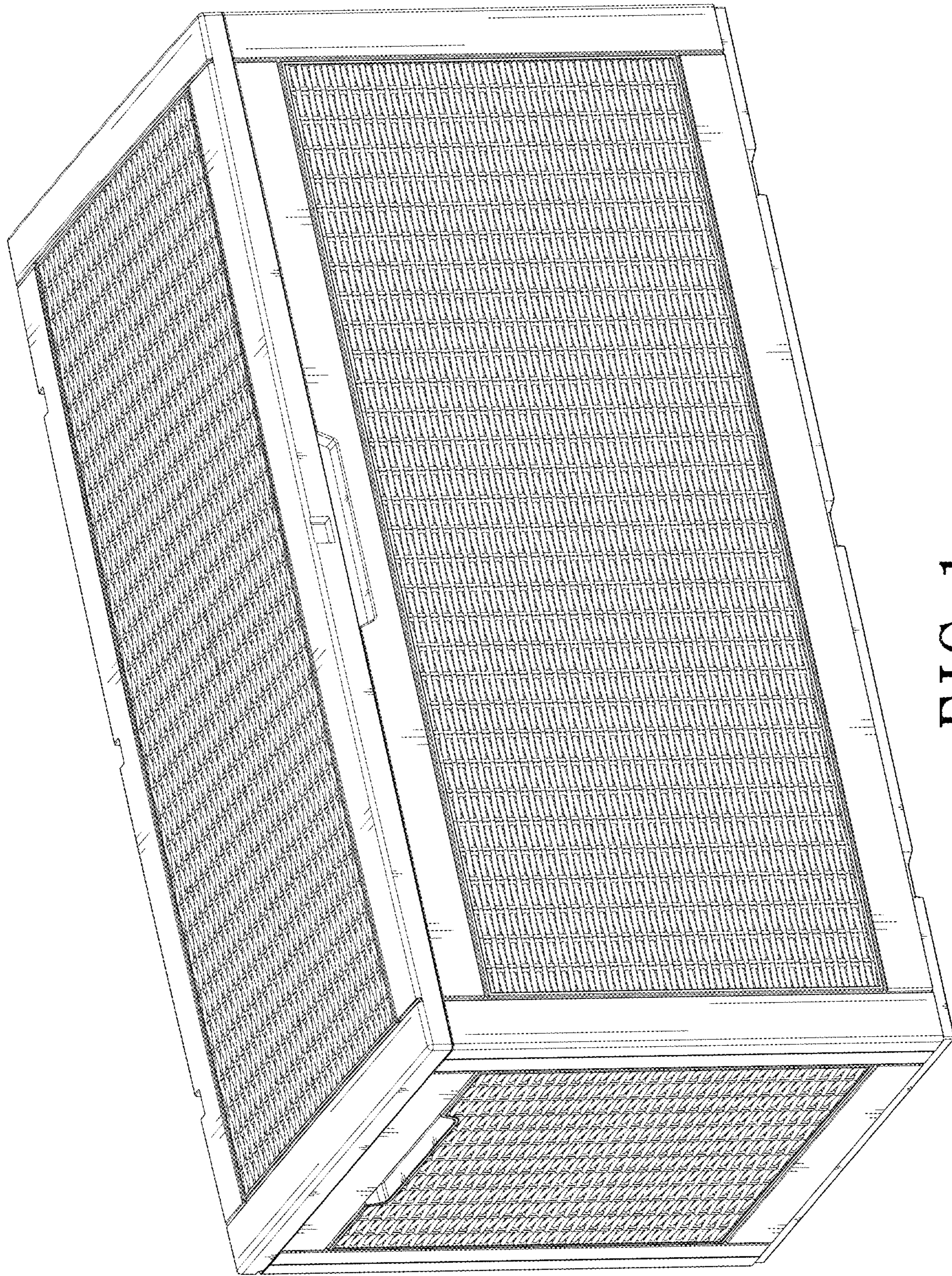

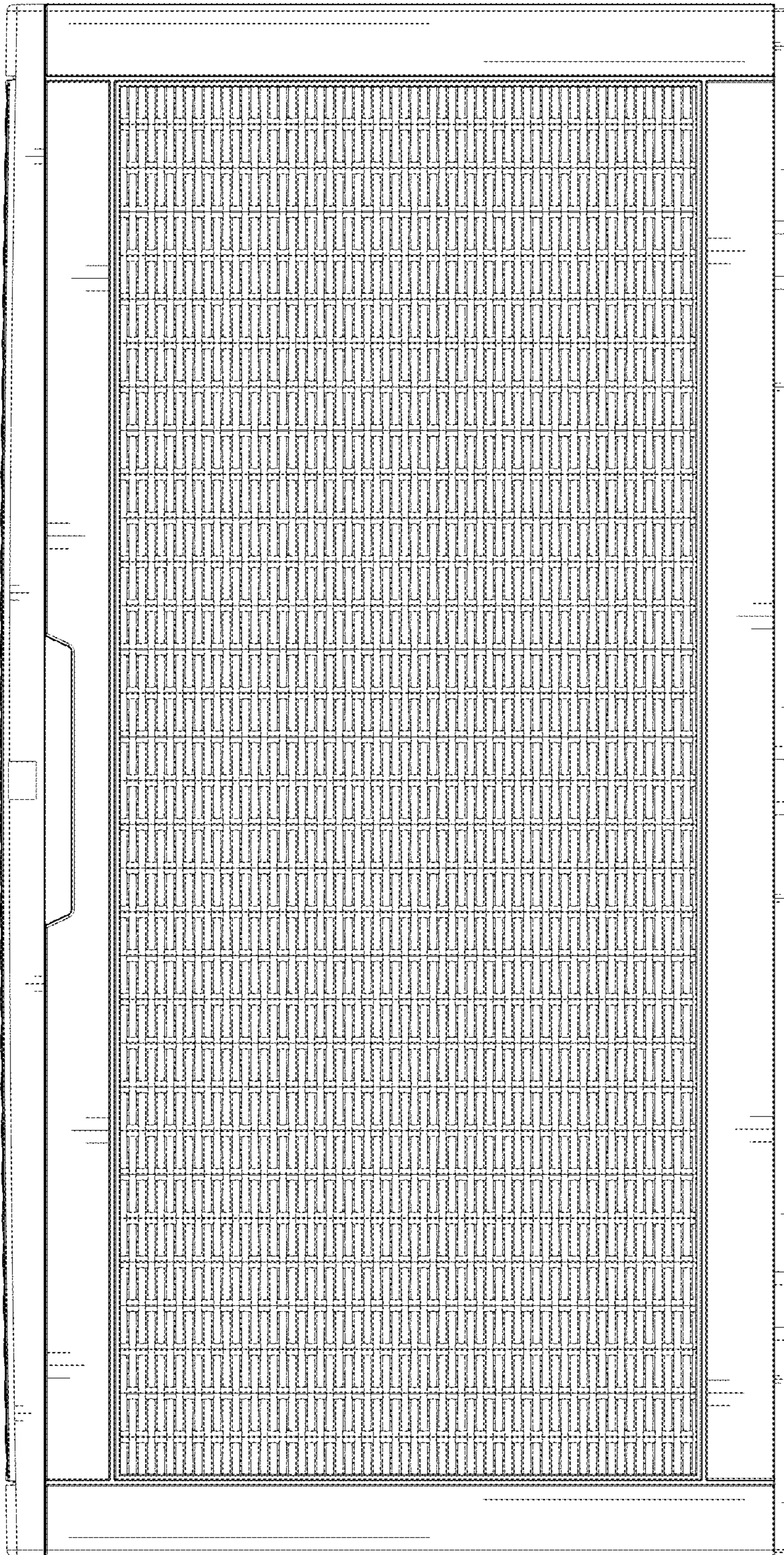

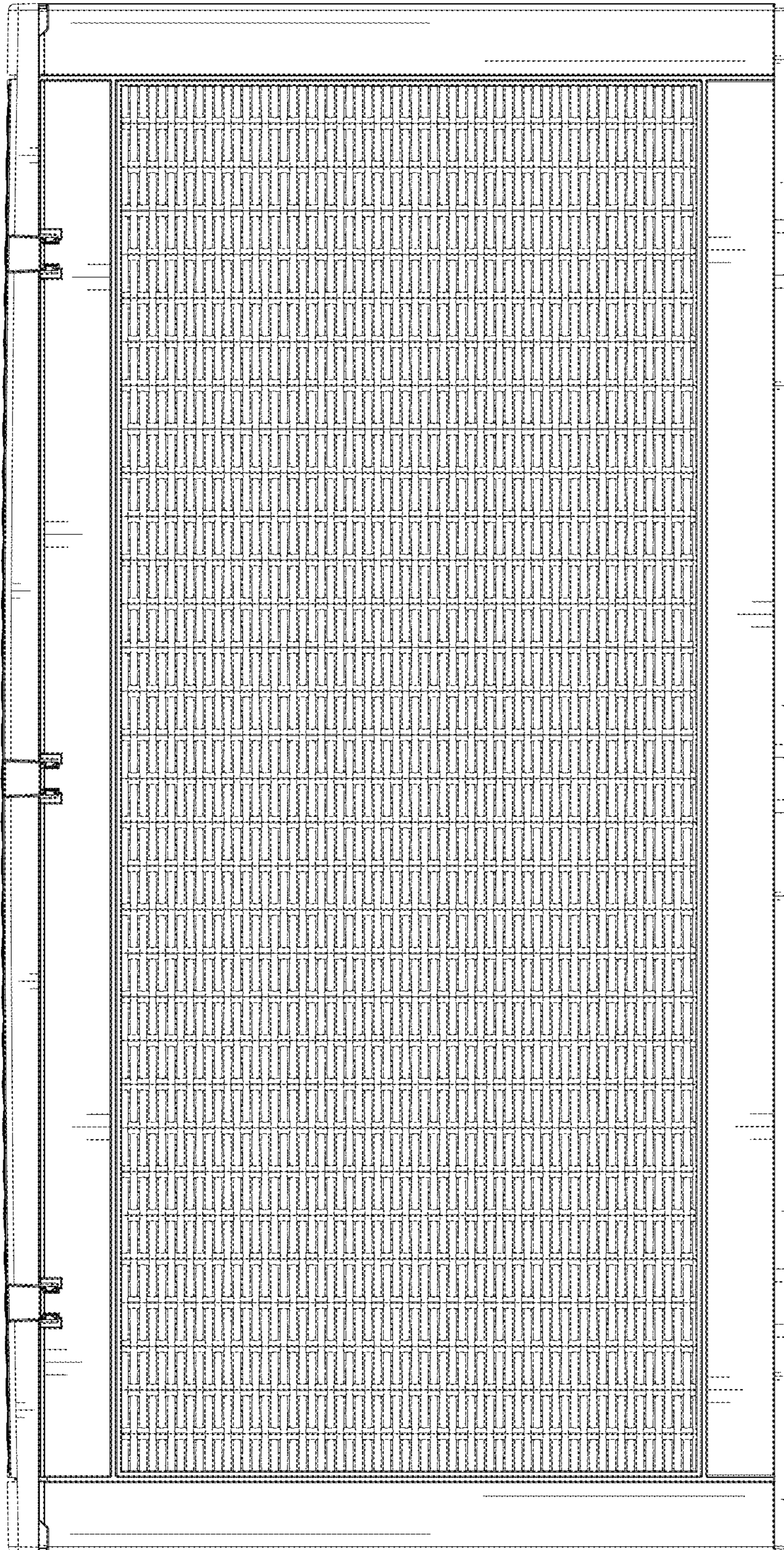

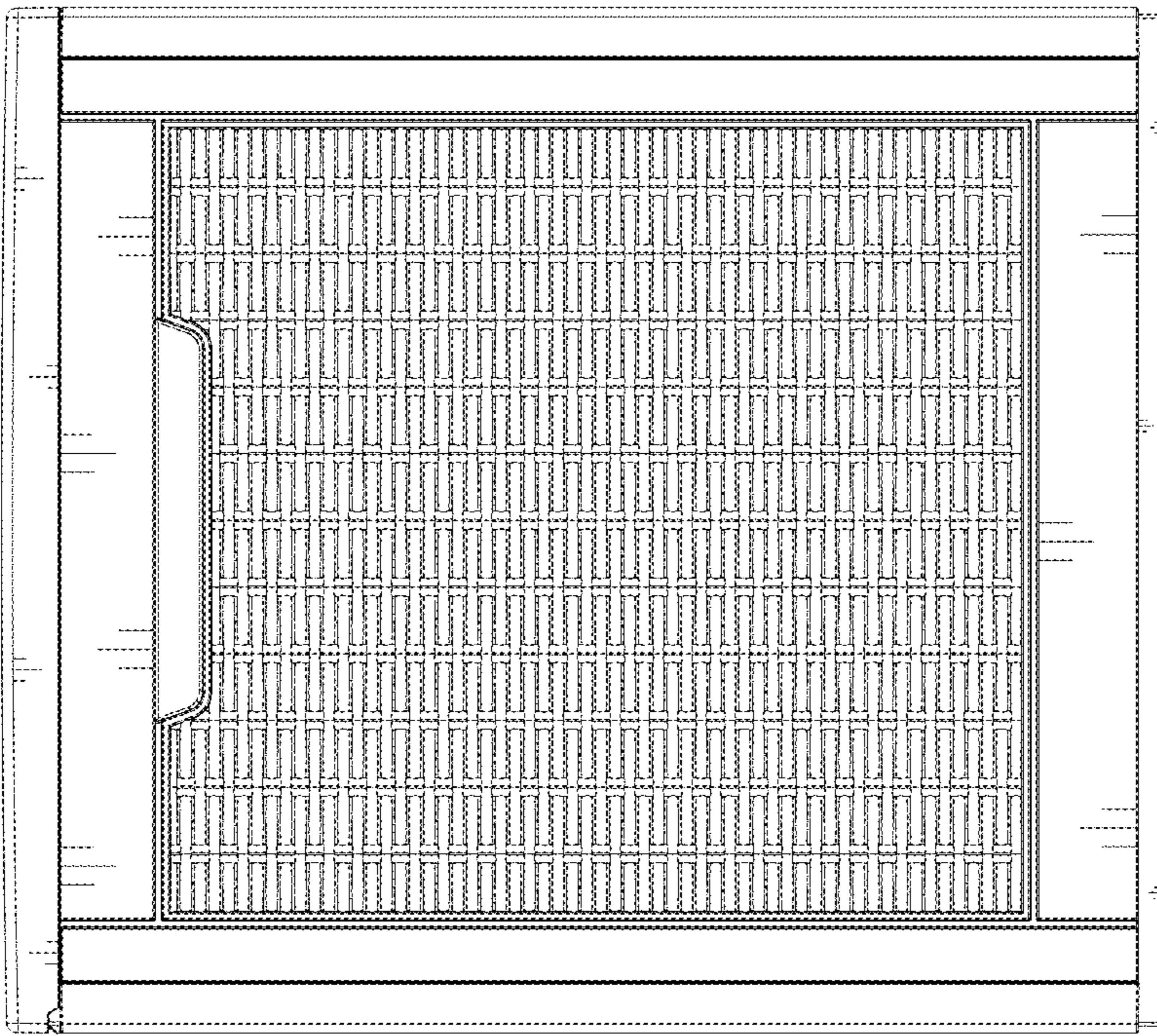

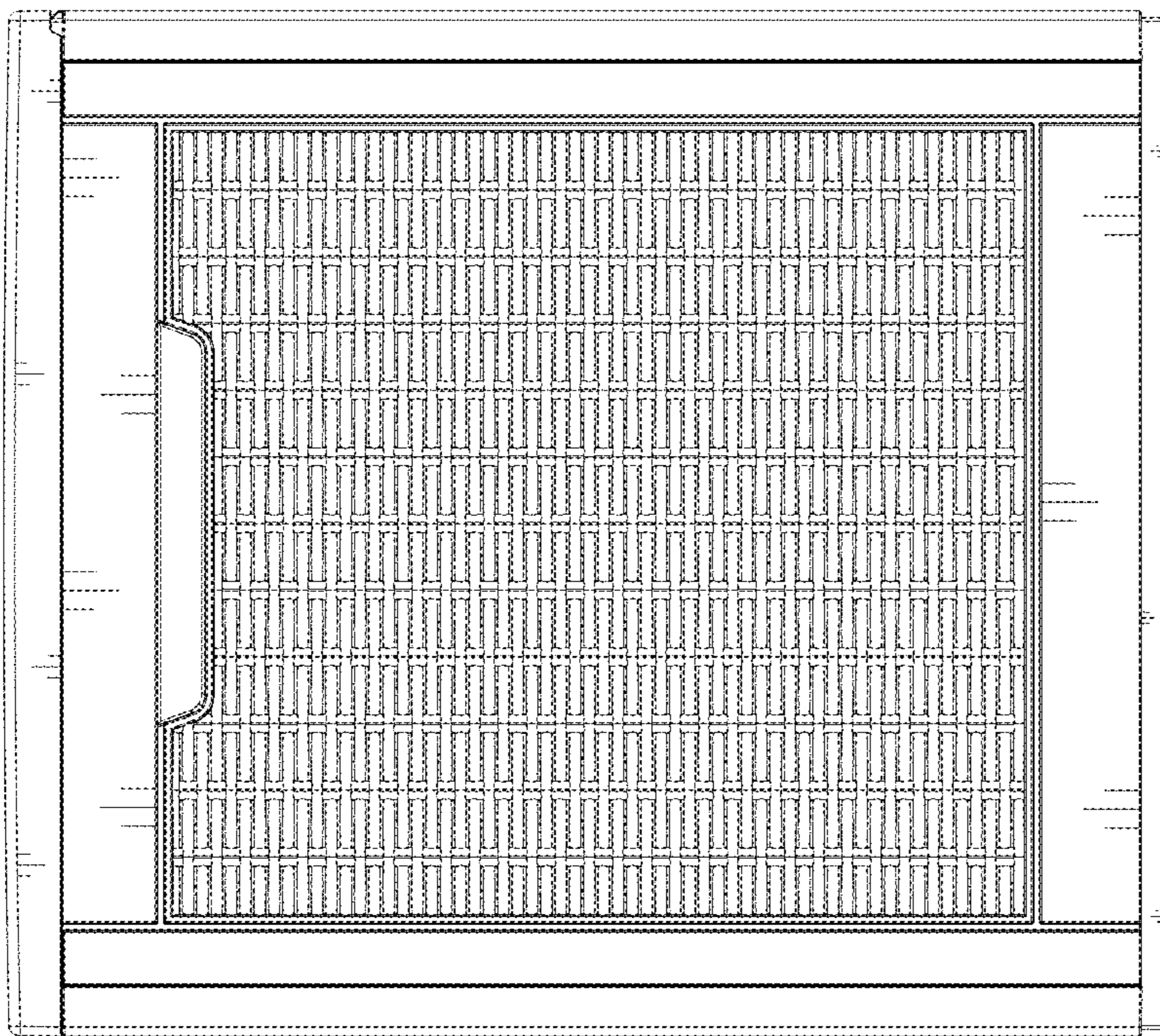

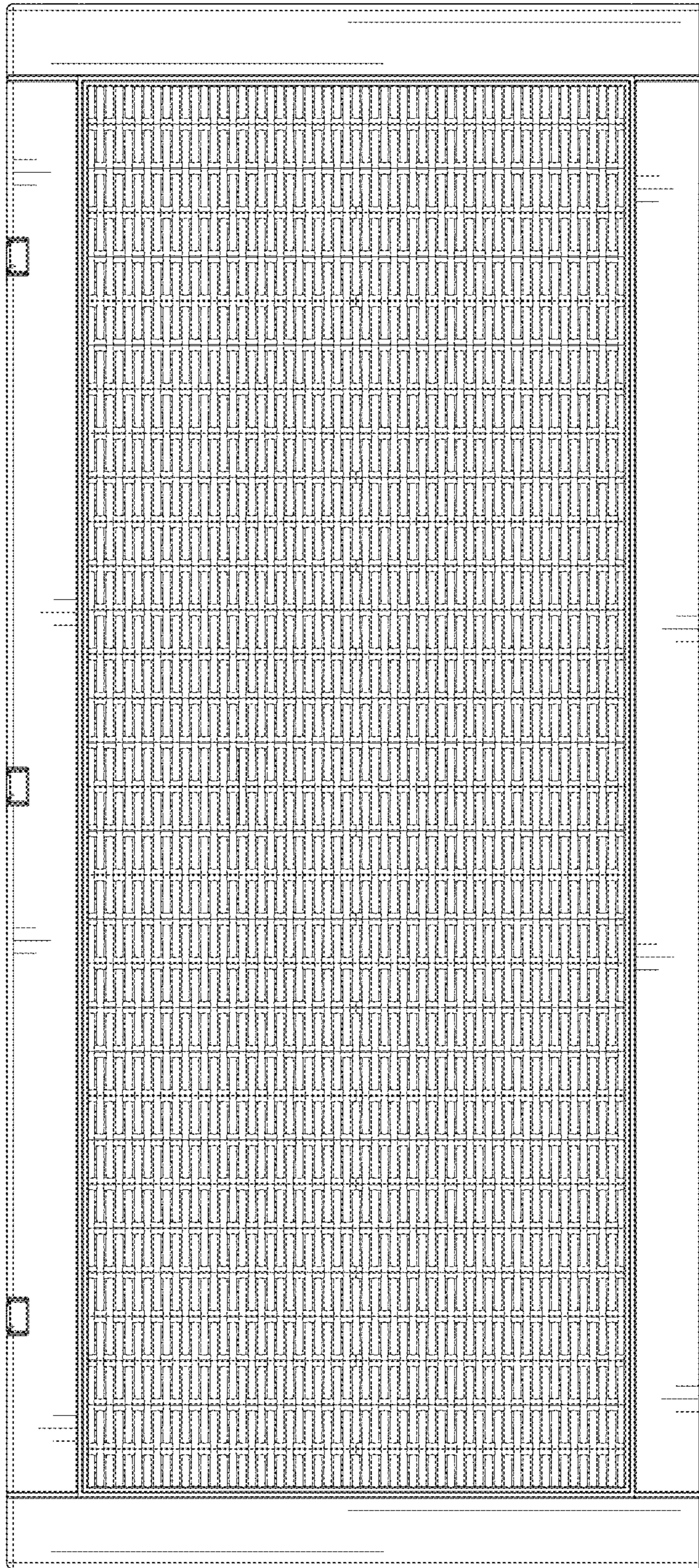

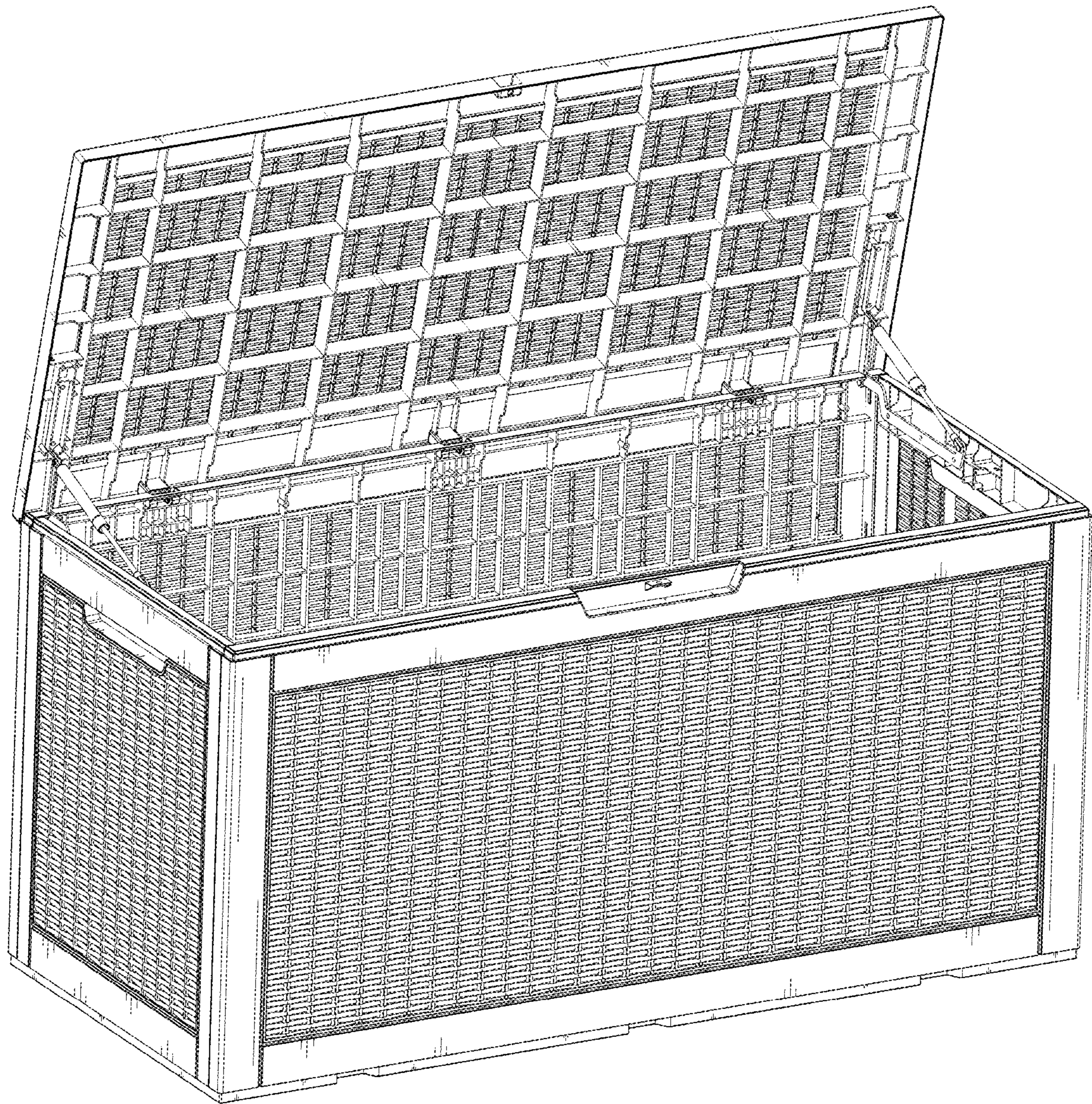

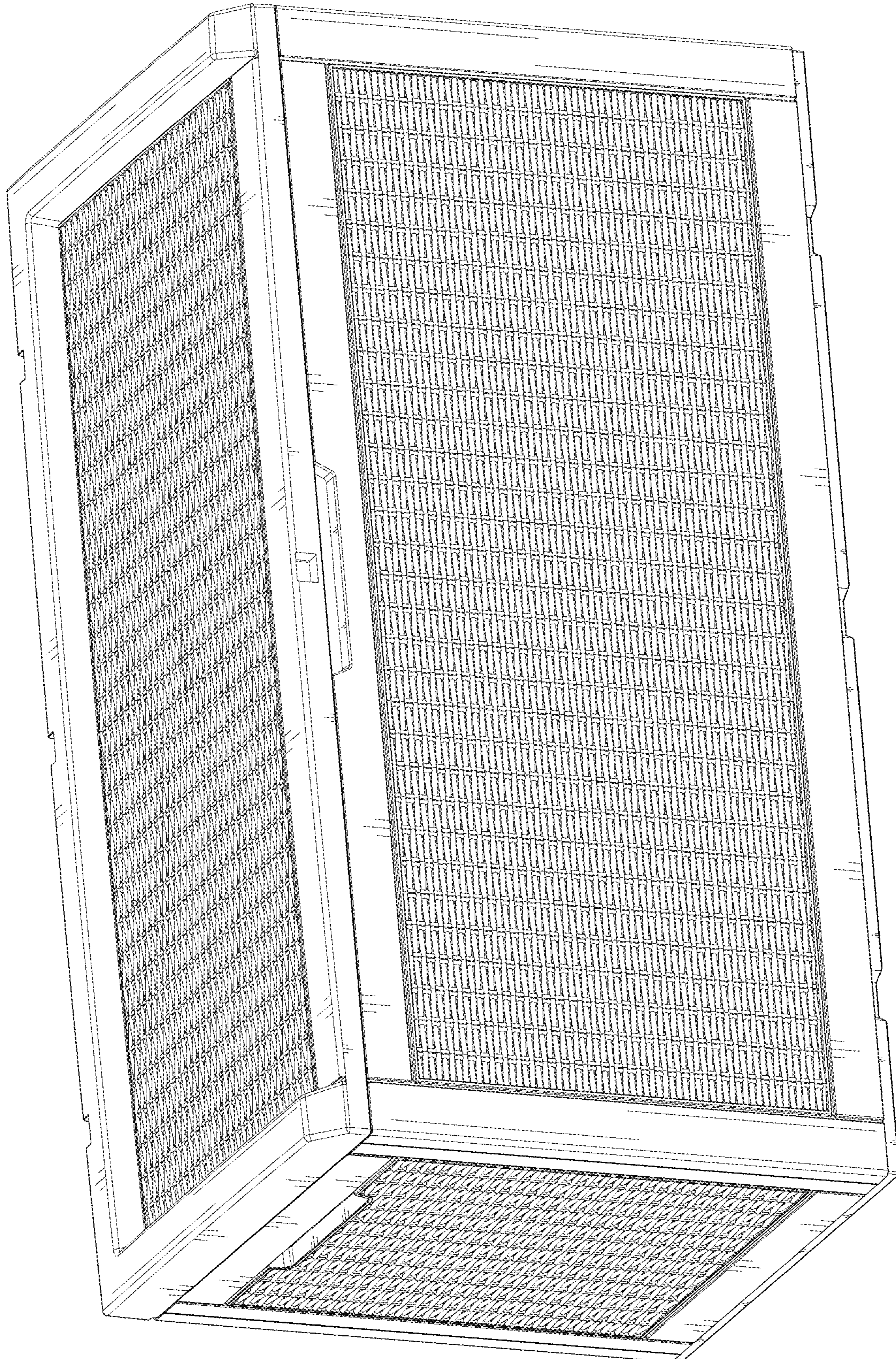

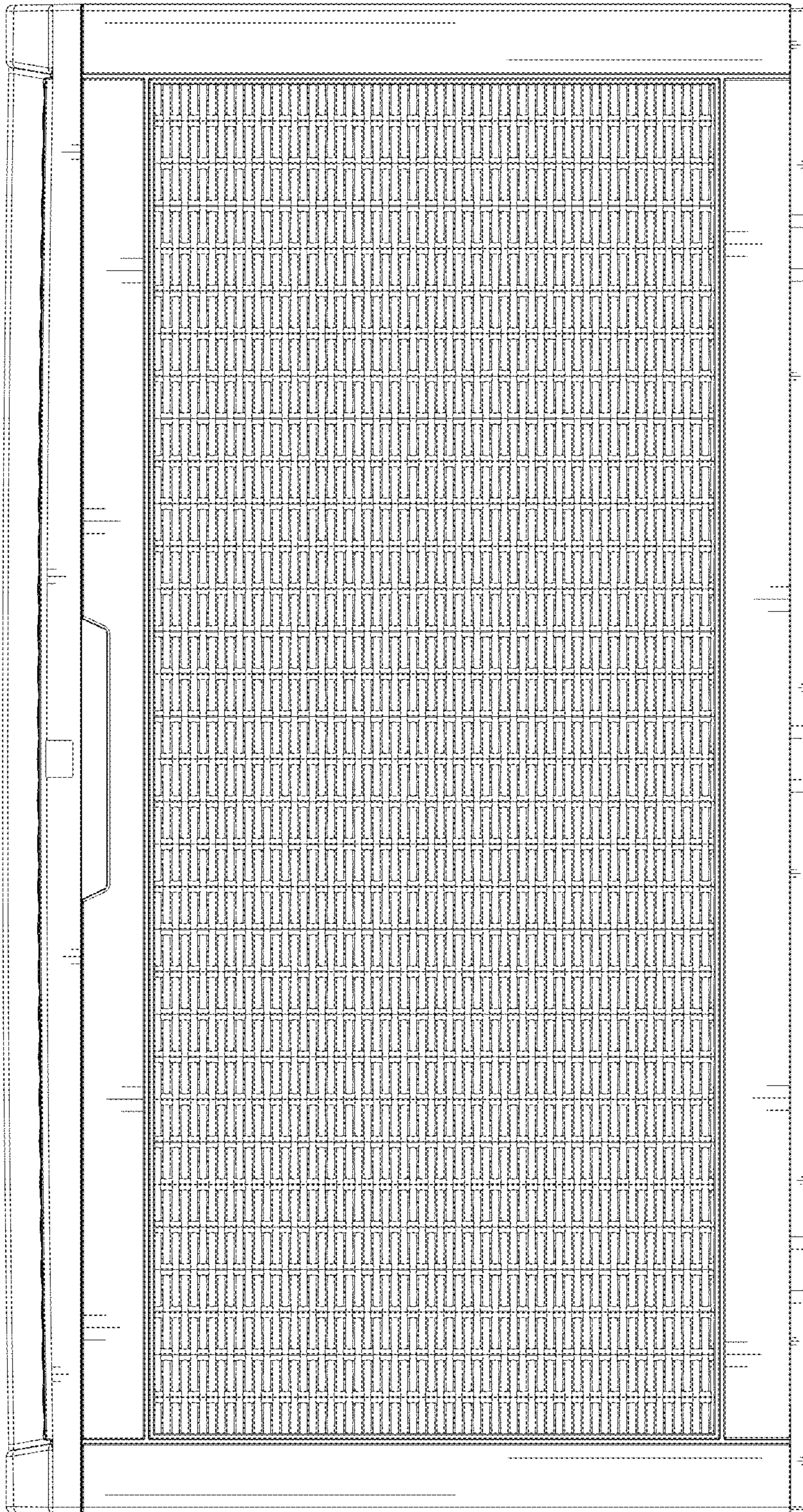

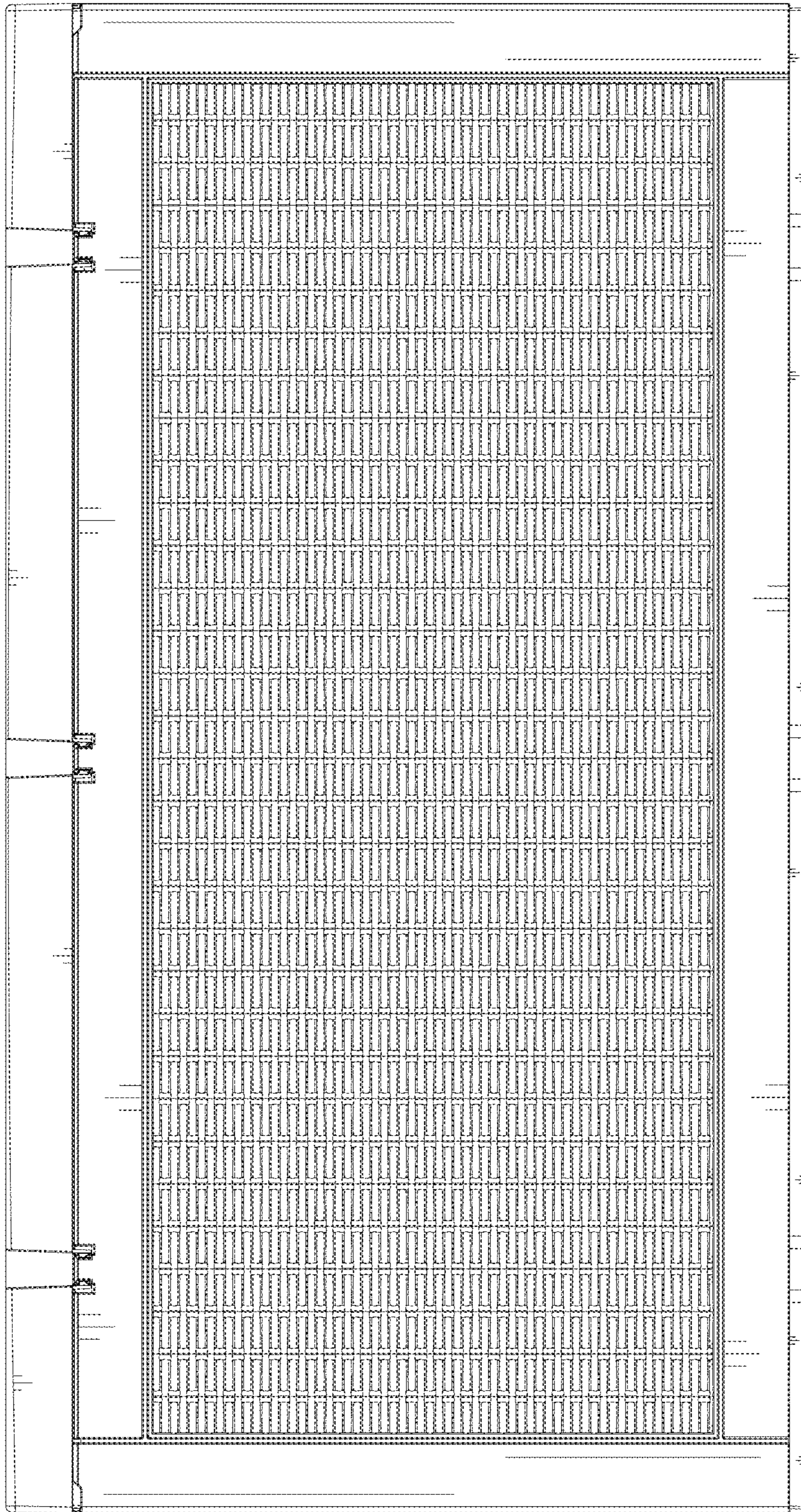

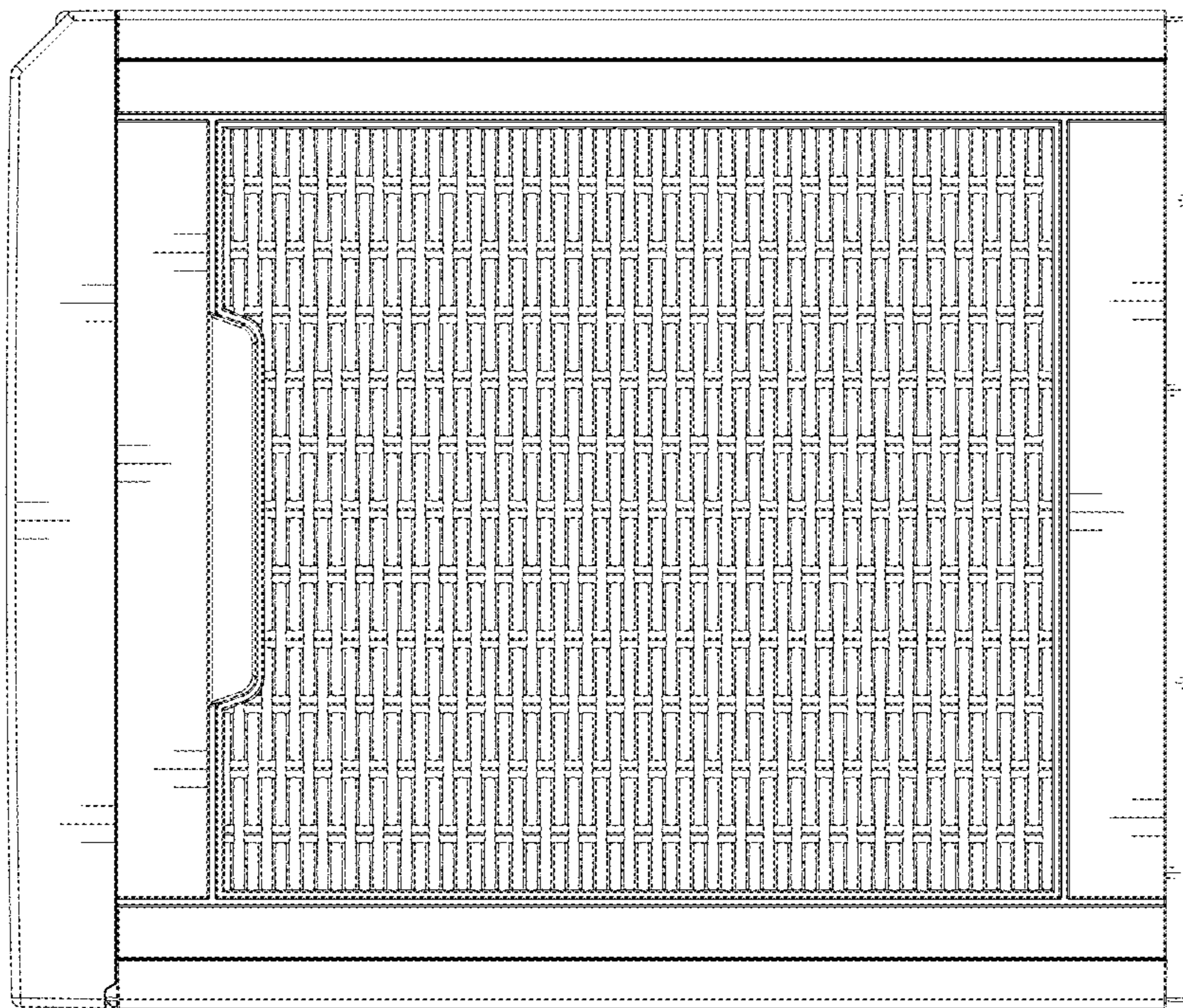

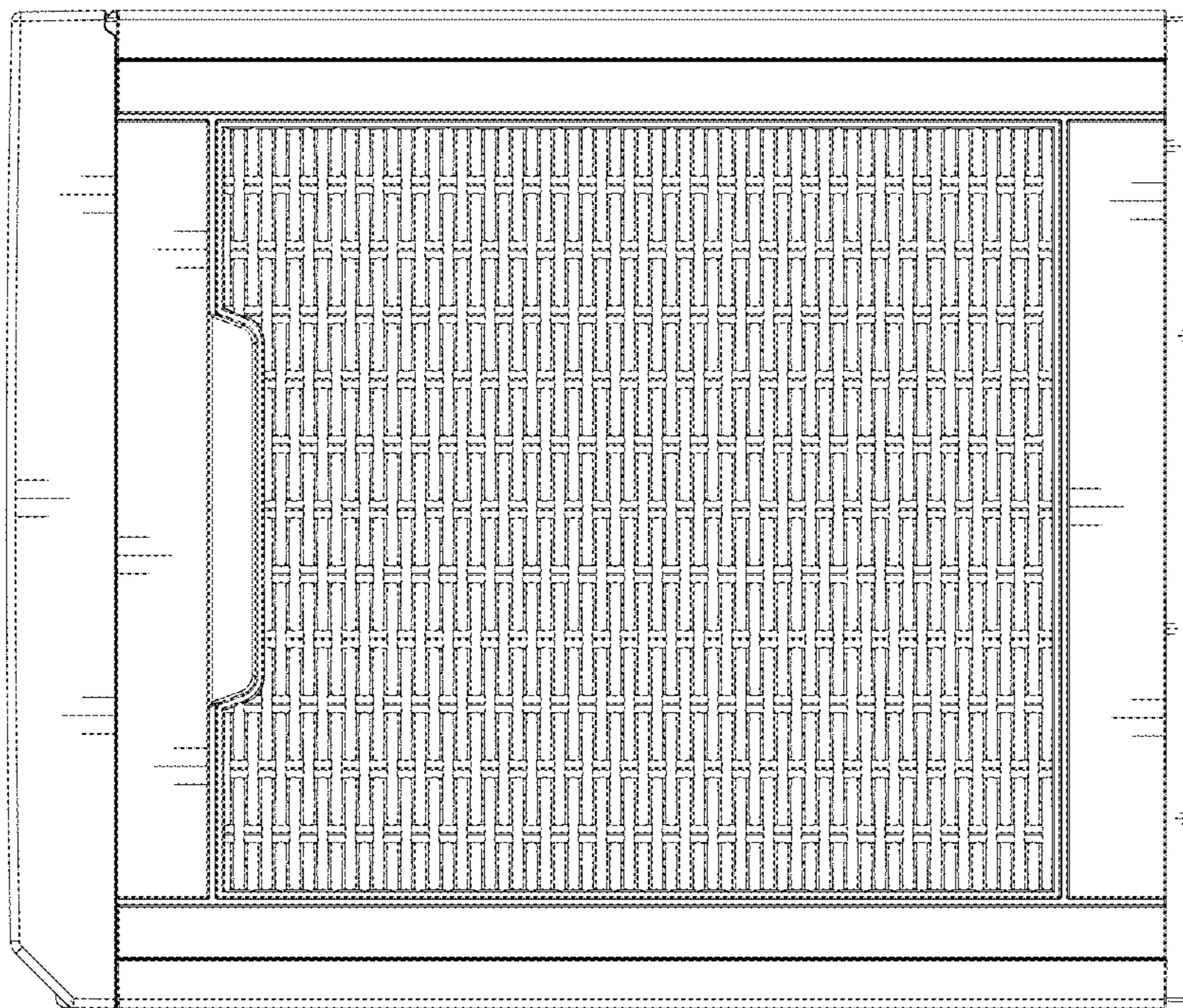

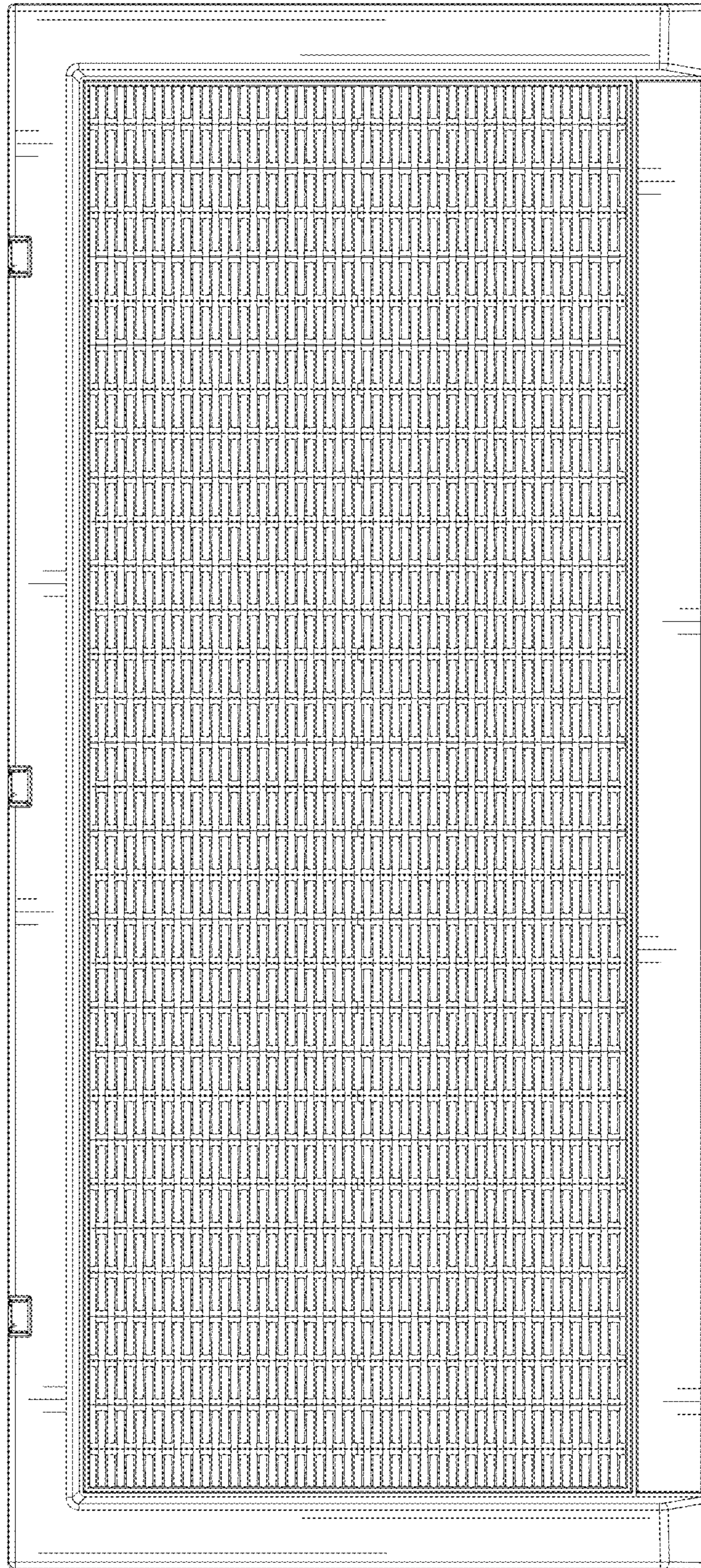

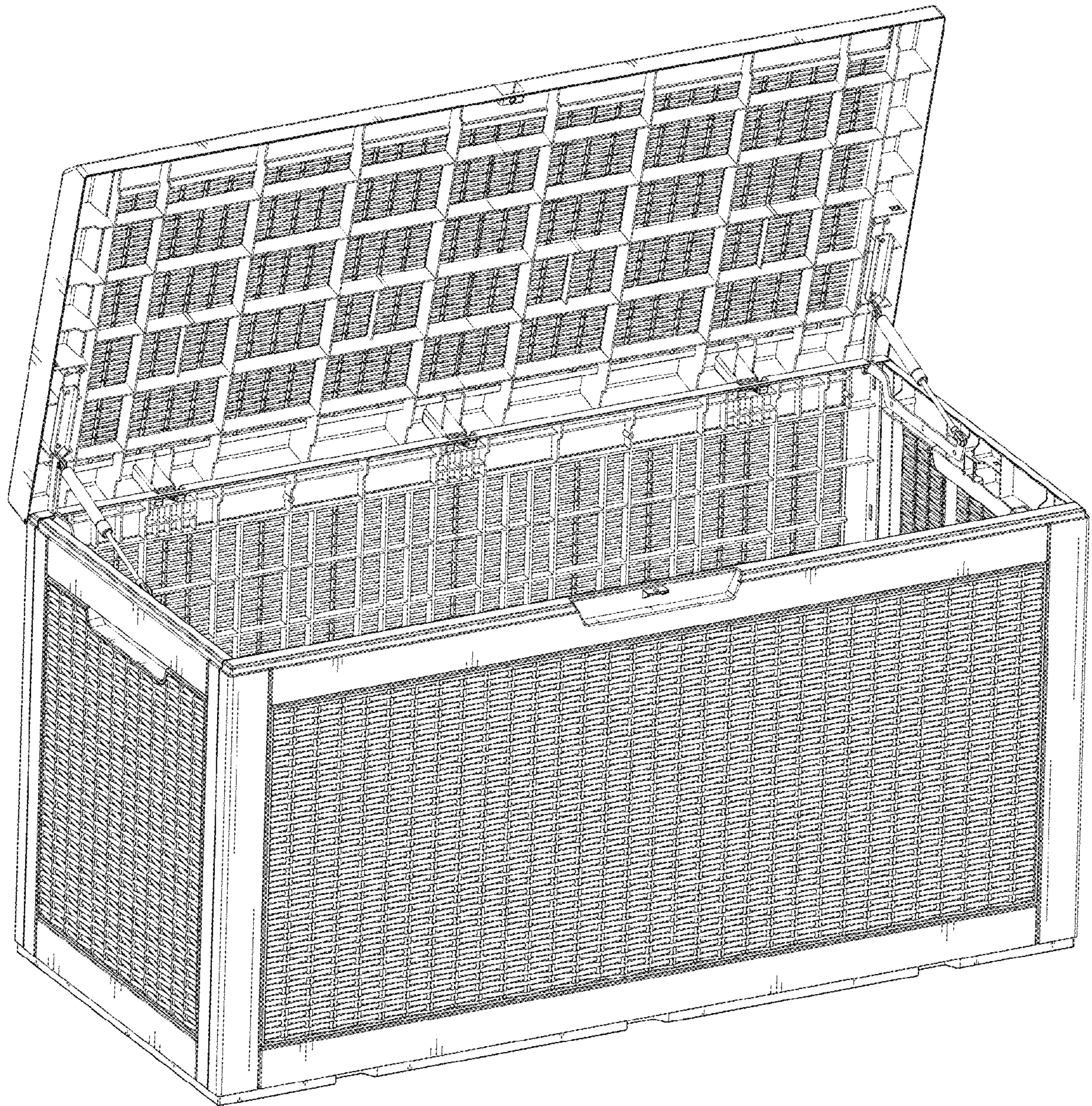
