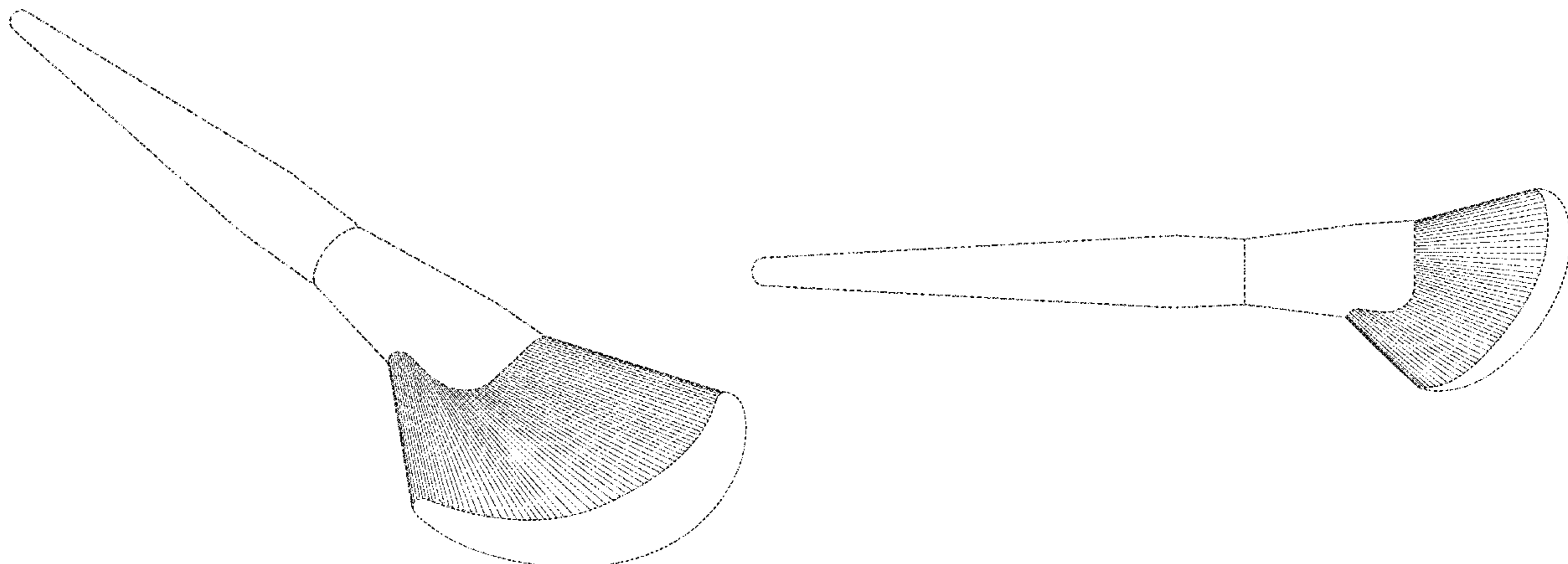
(57) **CLAIM**

I claim the ornamental design for a cosmetic brush having a fan-like shape, as shown and described.

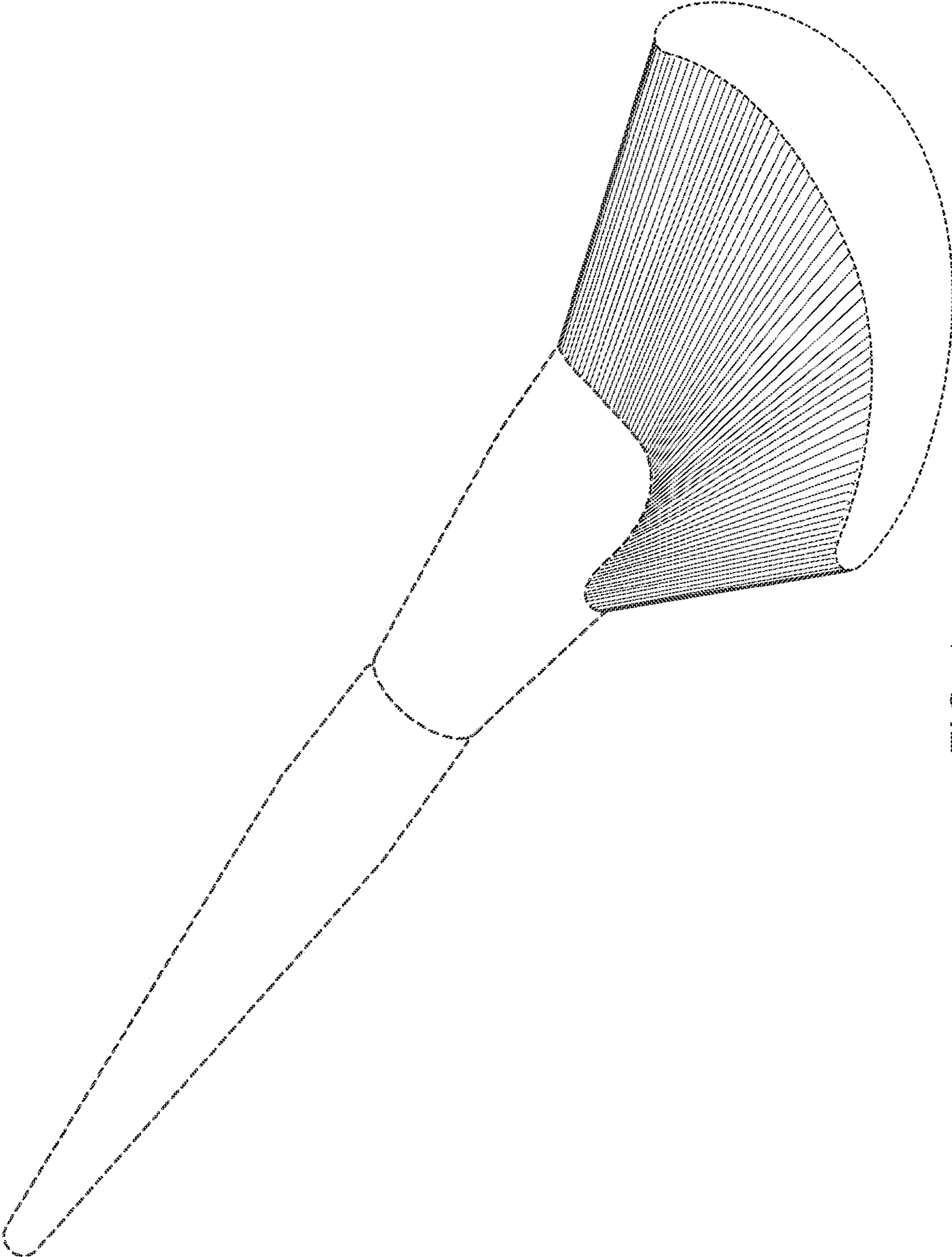

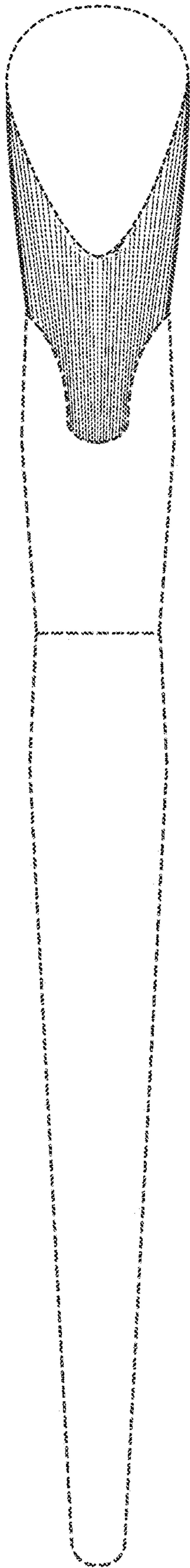

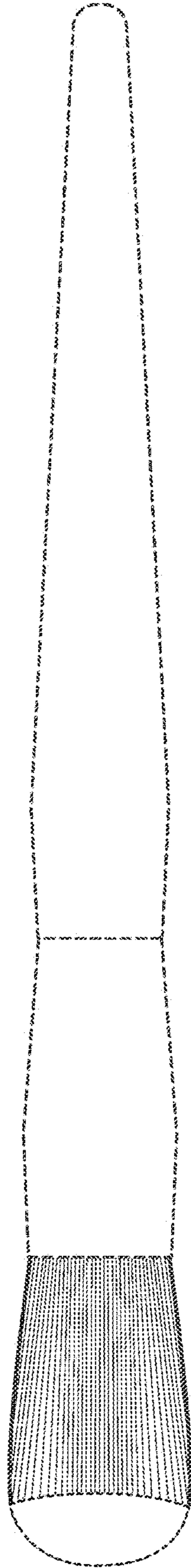

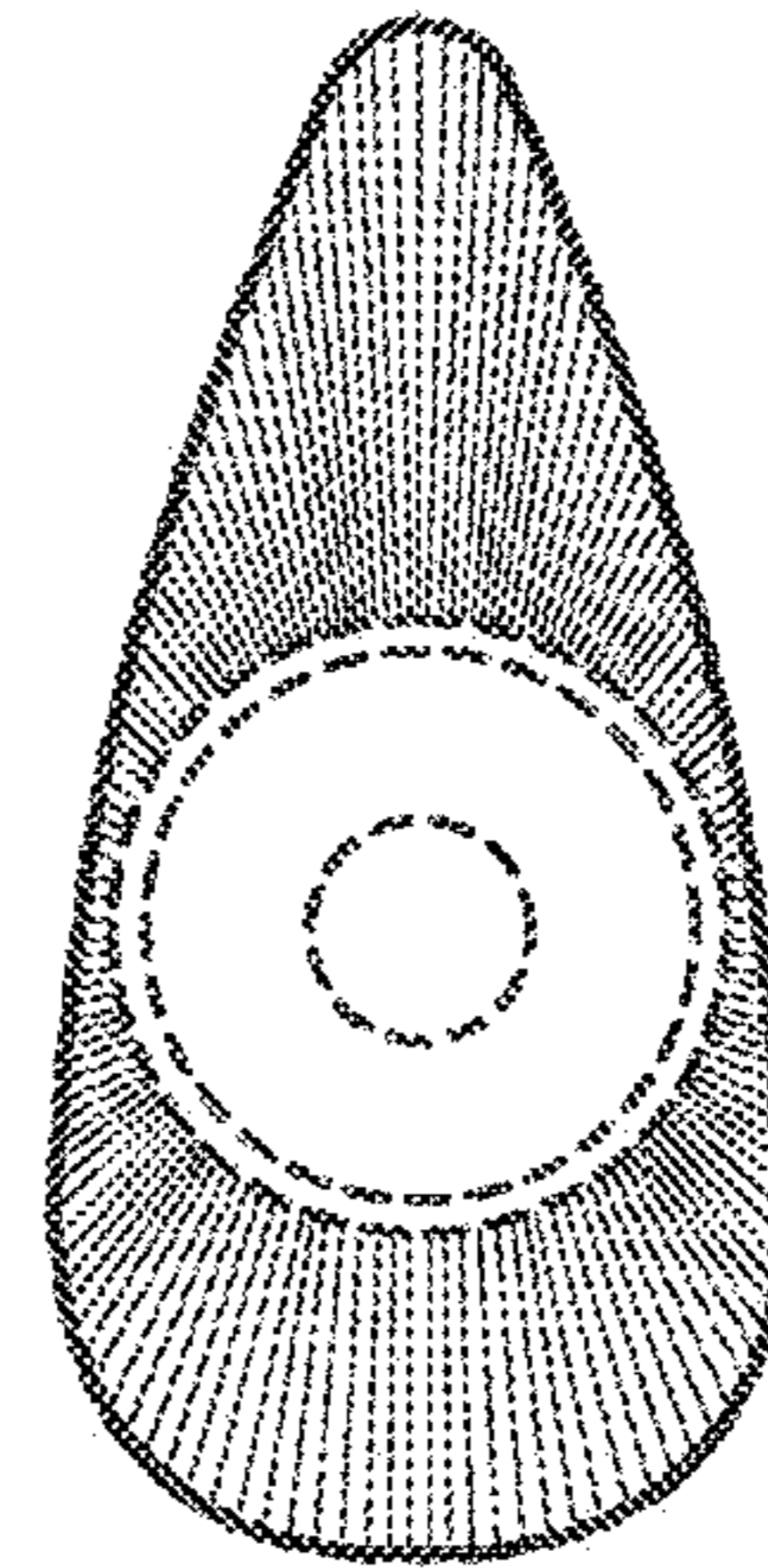

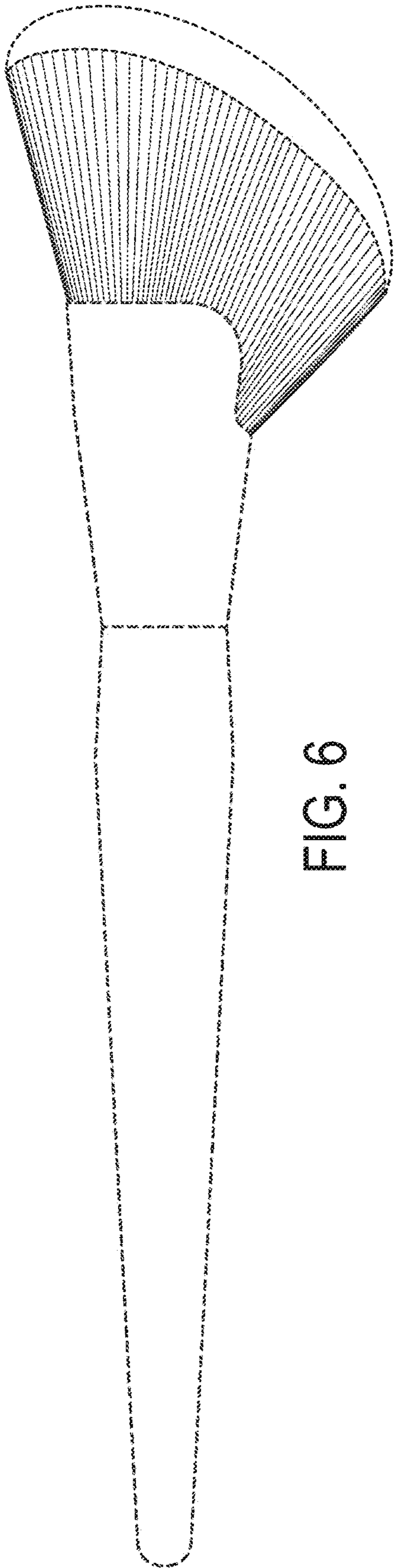

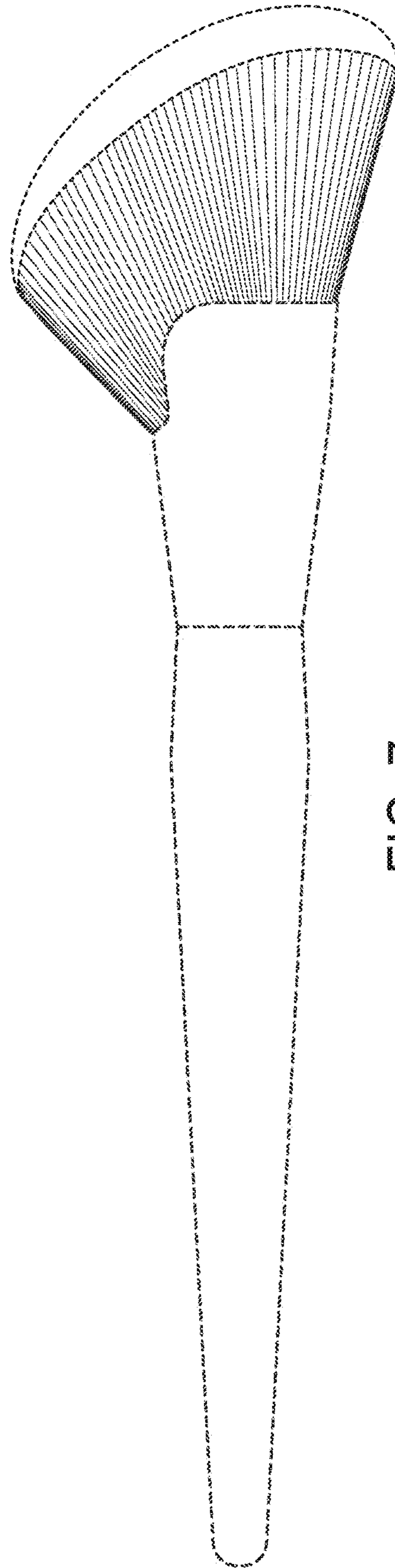
