(57) **CLAIM**

The ornamental design for a hanging tool for rhinestoning garments, as shown and described.

**DESCRIPTION**

FIG. 1 is a front bottom right-side perspective view for a hanging tool for rhinestoning garments, showing my new design;

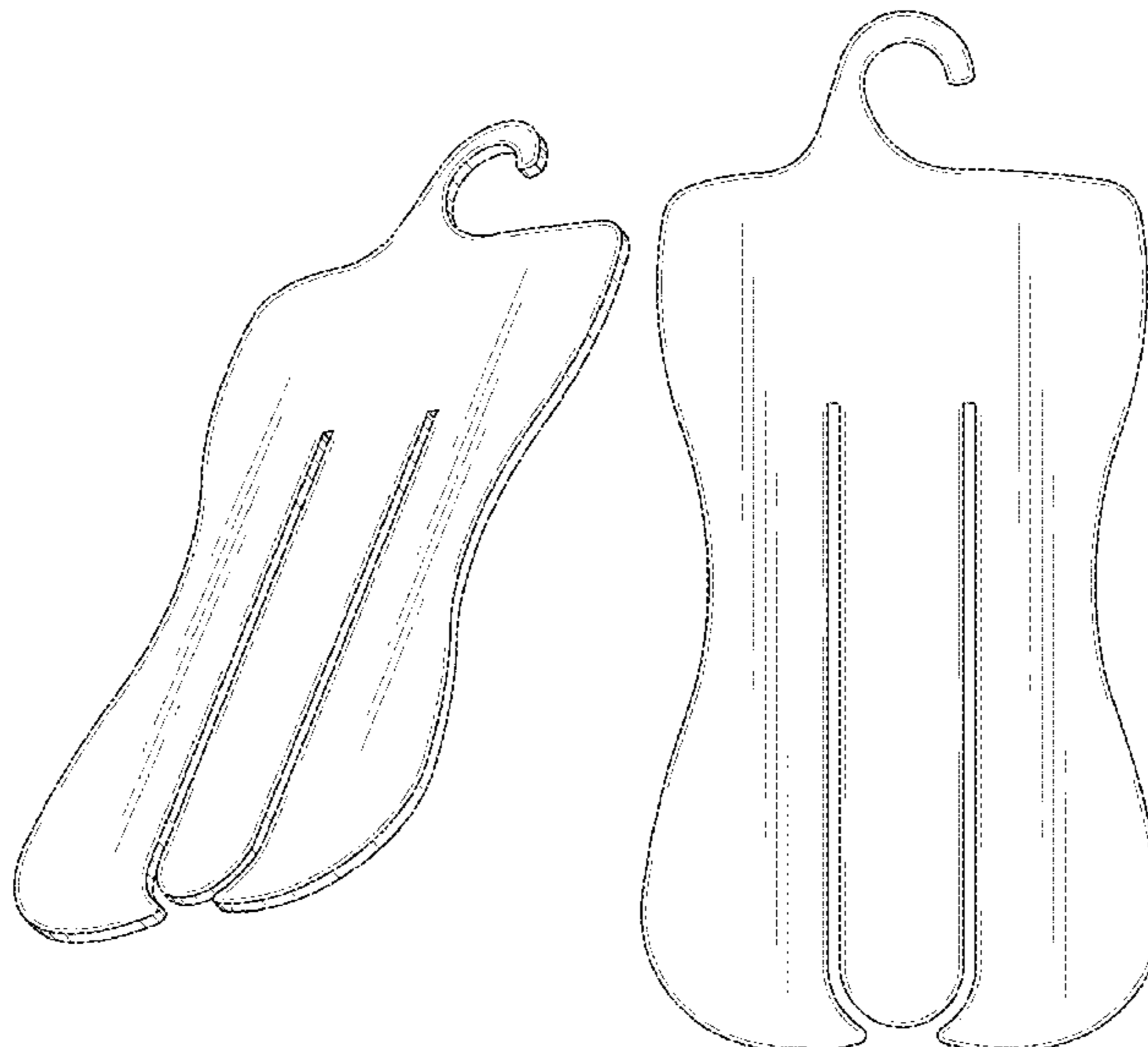
FIG. 4 is a left side elevational view of FIG. 1 thereof;

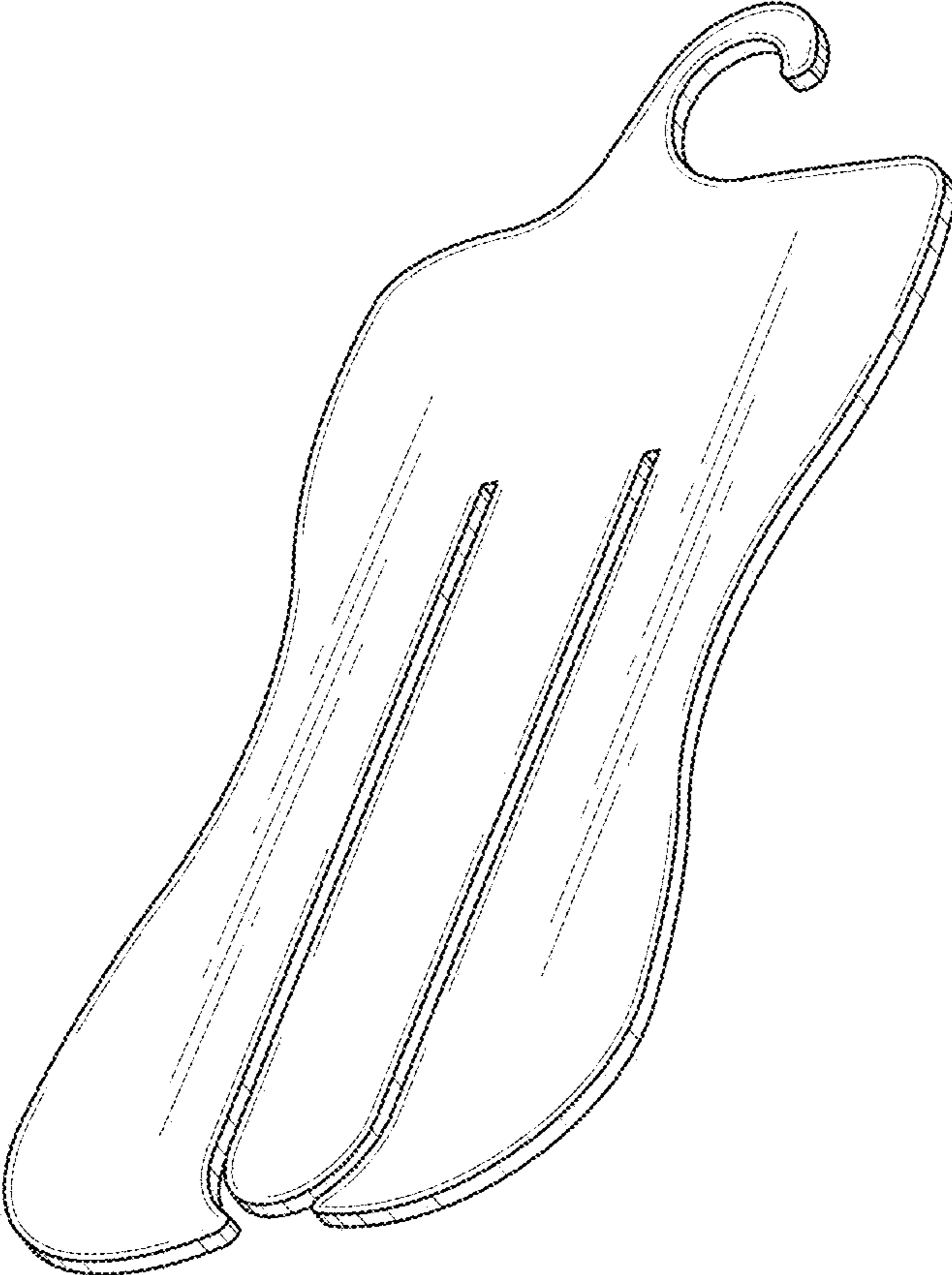
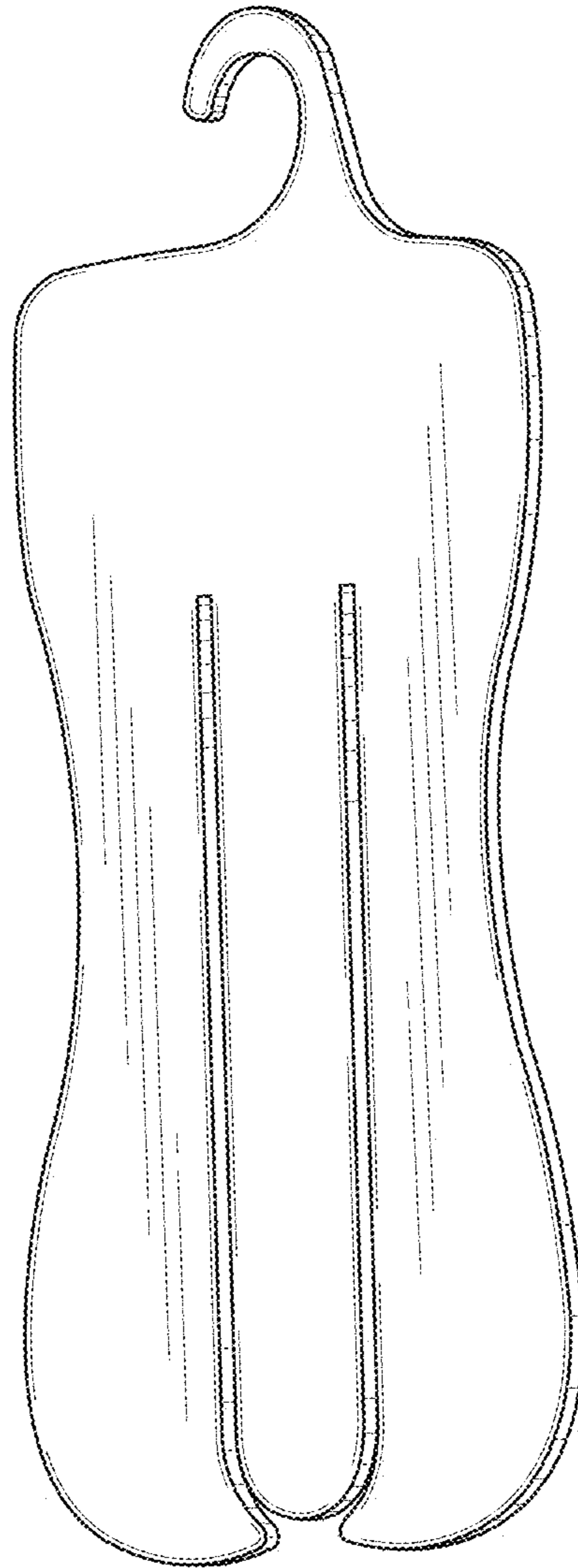
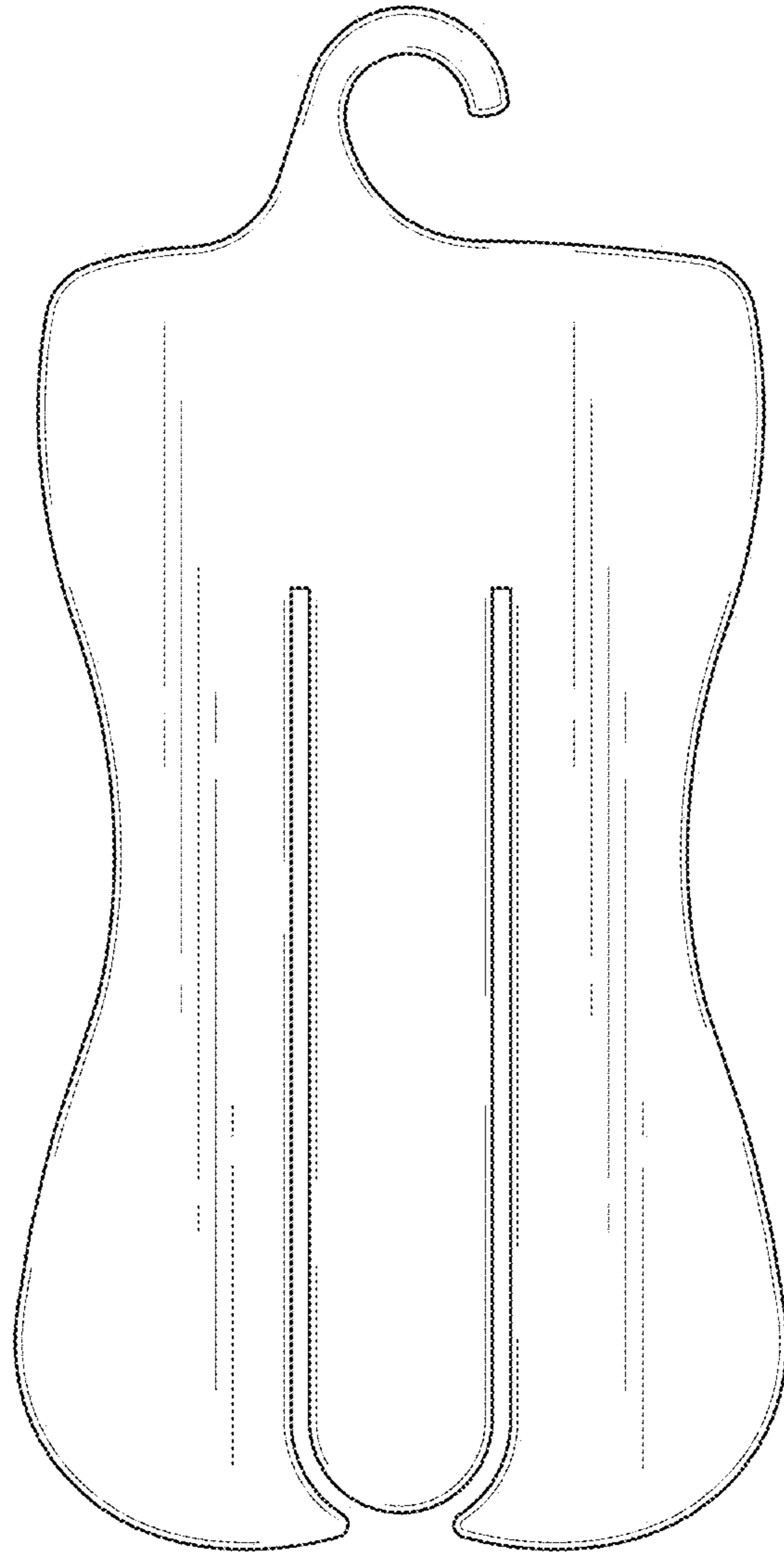

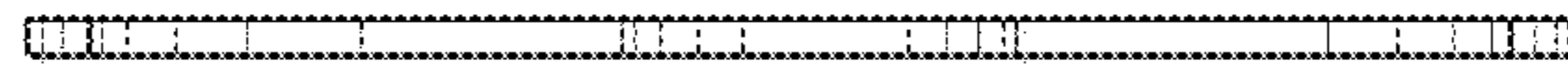

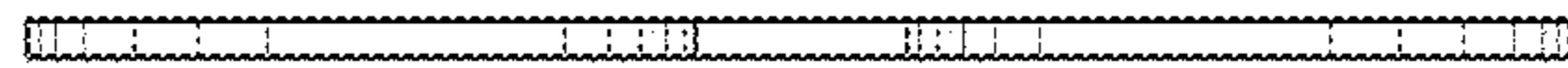
