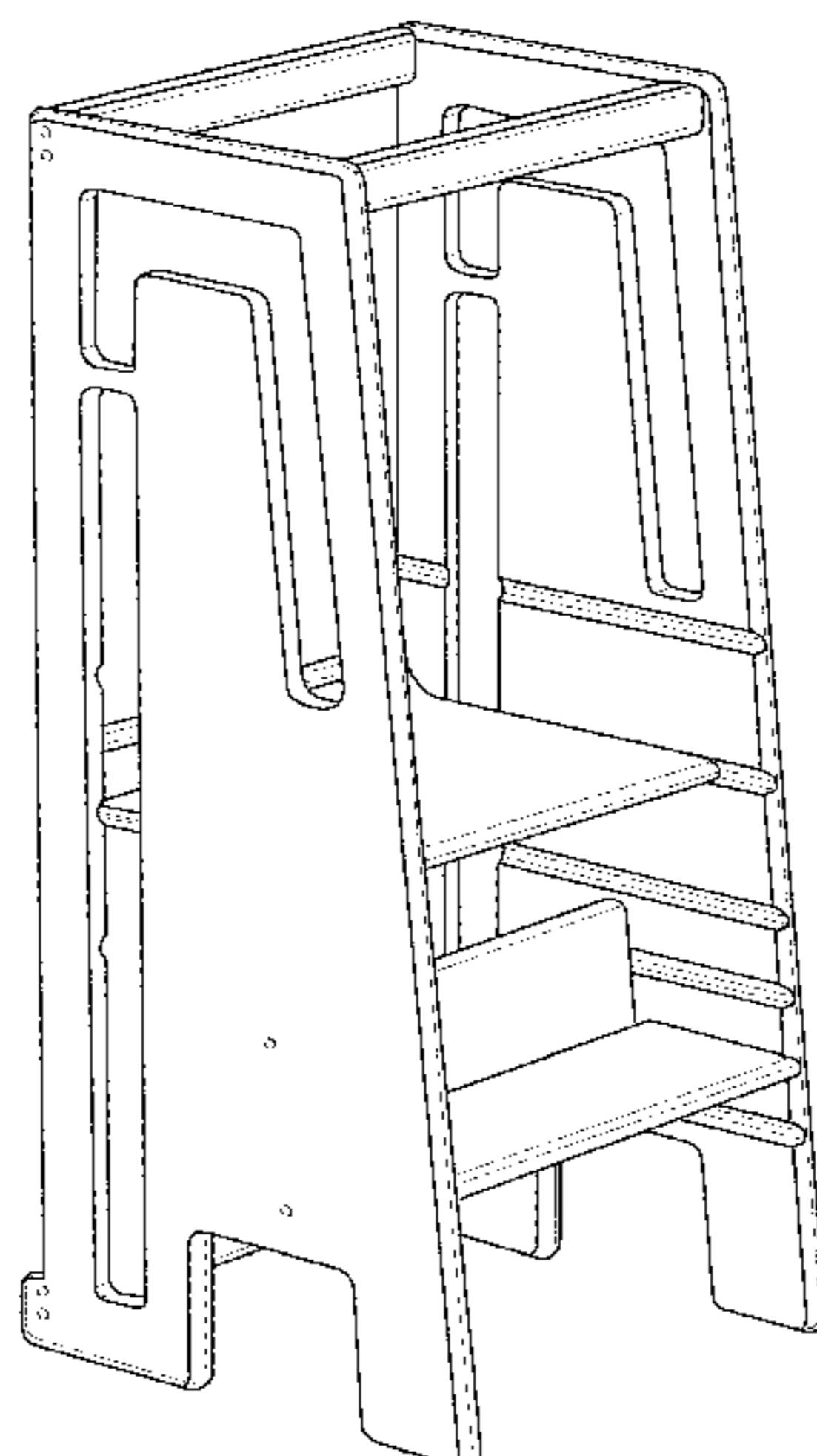

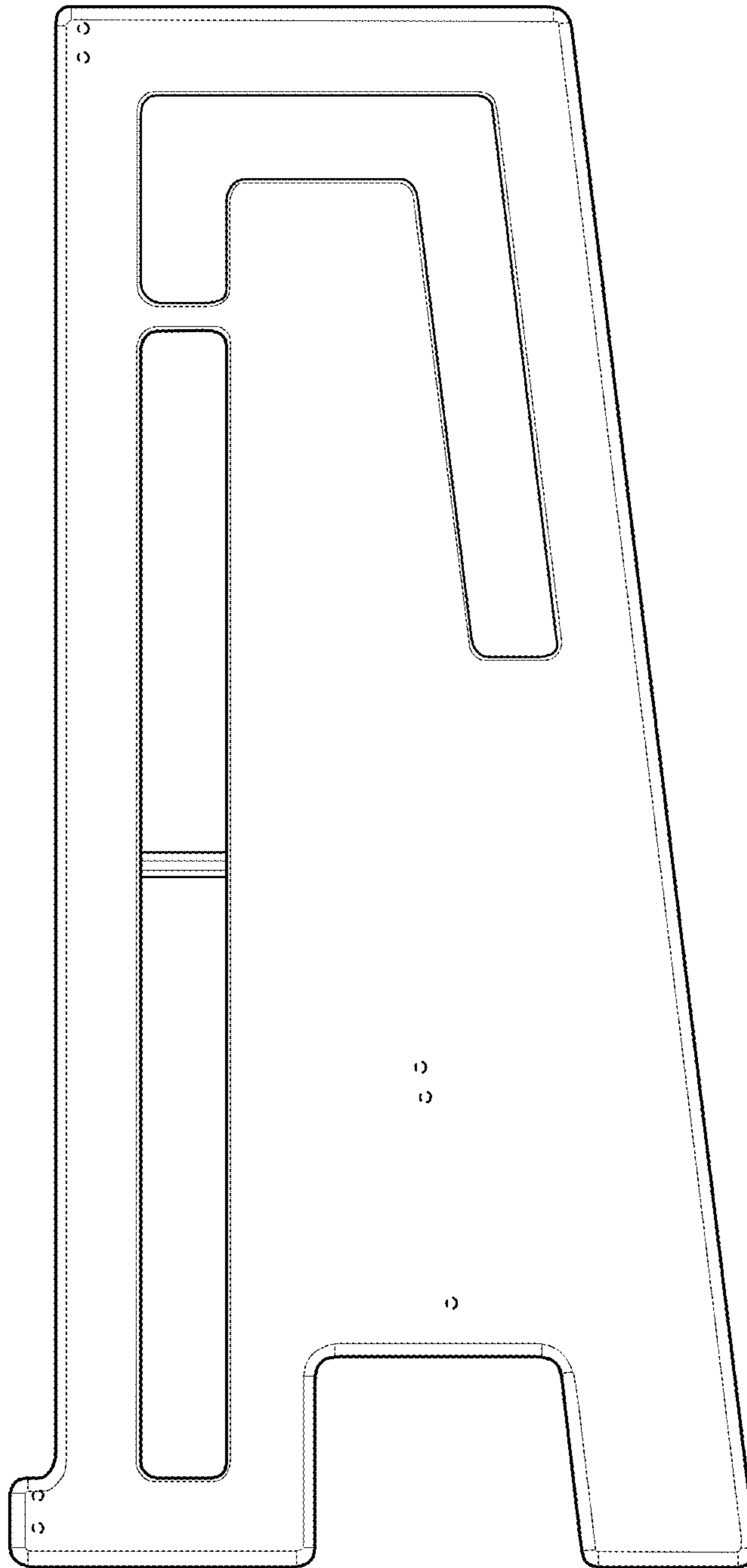


**1.2** : Front
