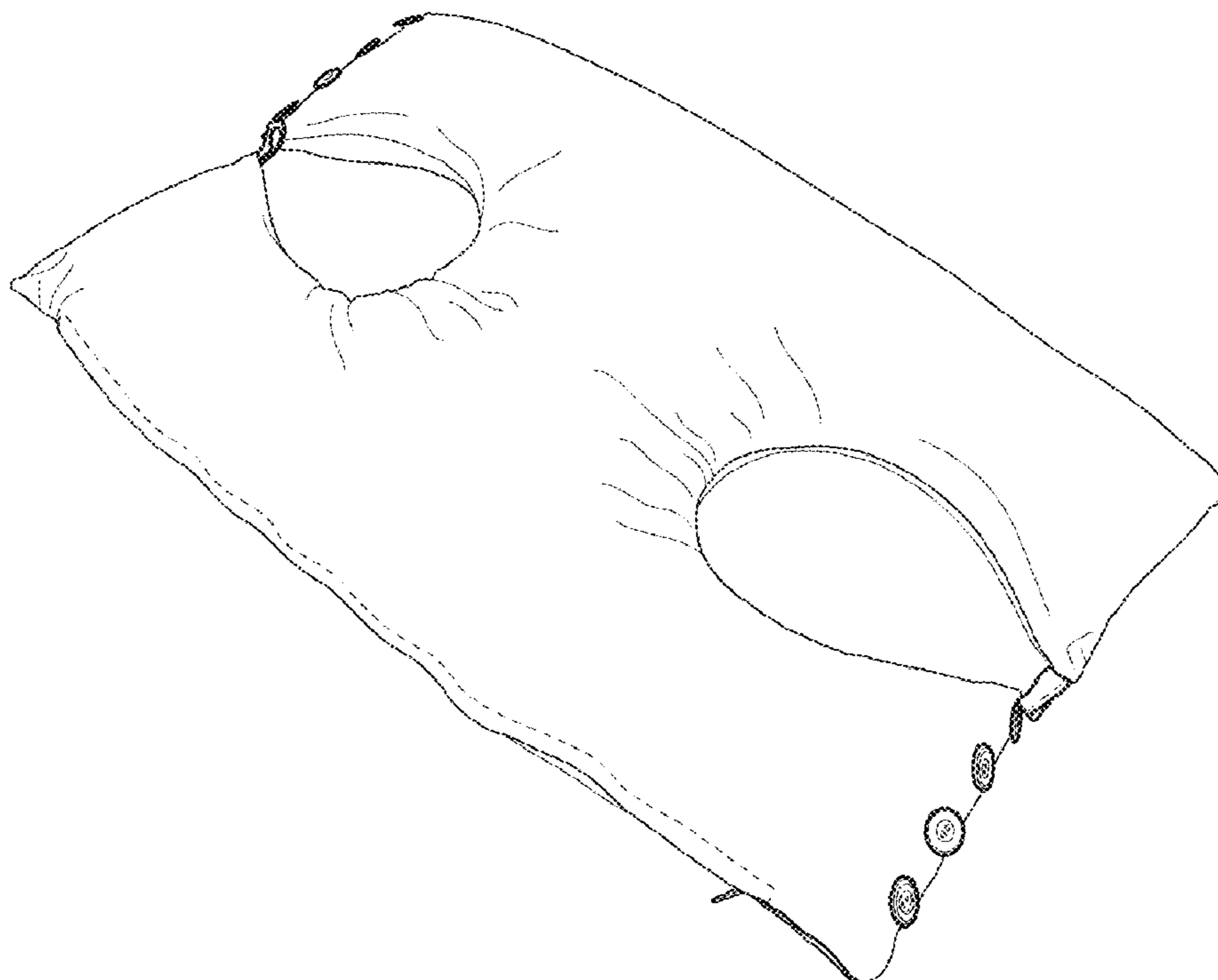
(57) **CLAIM**

The ornamental design for a pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the pillow showing my new design;
FIG. 2 is a top plan view thereof with left and right ends unbuttoned;
FIG. 3 is a top plan view thereof with left and right ends buttoned;
FIG. 4 is a first side plan view thereof showing the side with the zipper;
FIG. 5 is a top plan view thereof with the zippered side on the right; and,
FIG. 6 is a bottom plan view thereof with the zippered side on the left.
The broken lines shown in the drawings represent features of the pillow that form no part of the claim.

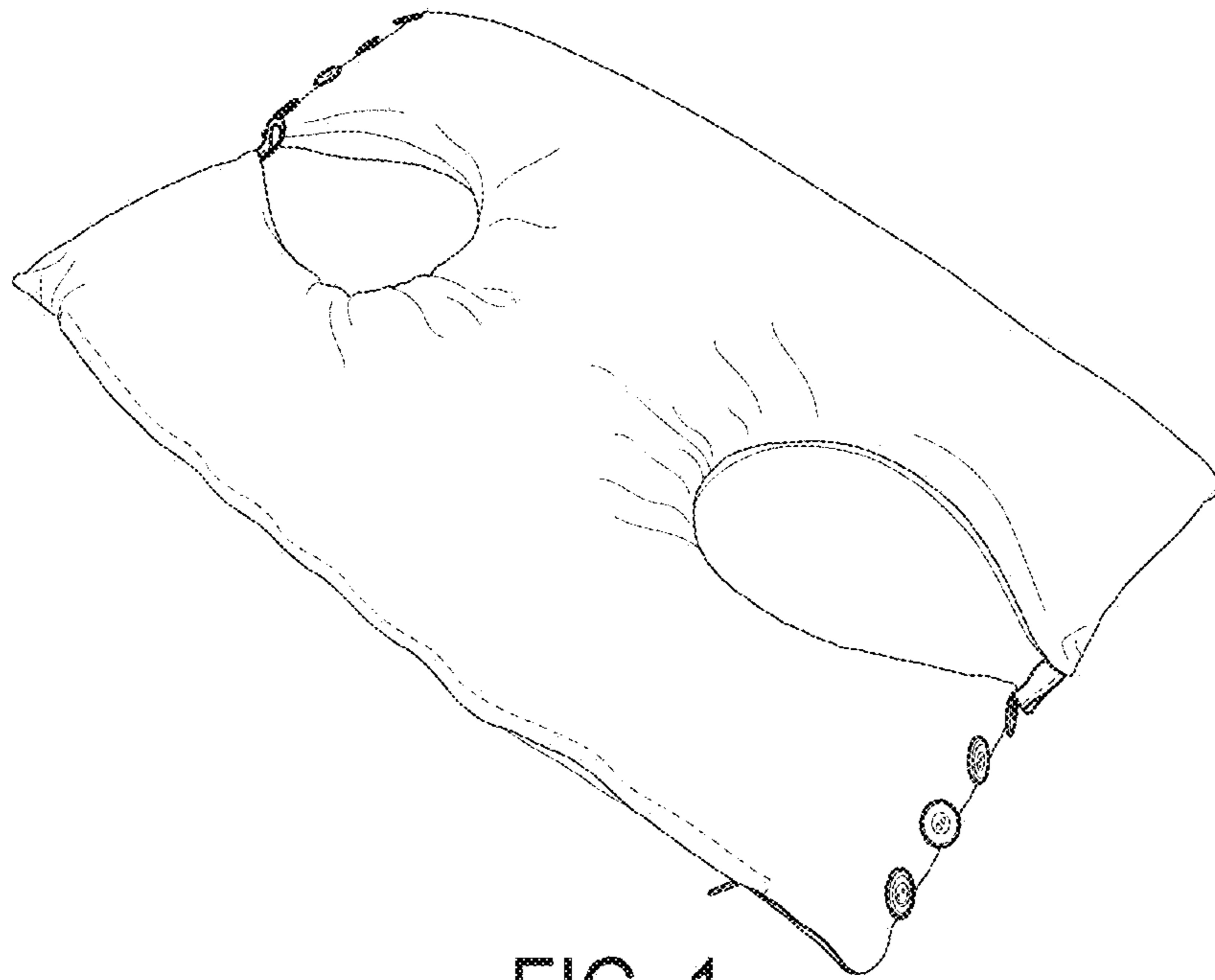

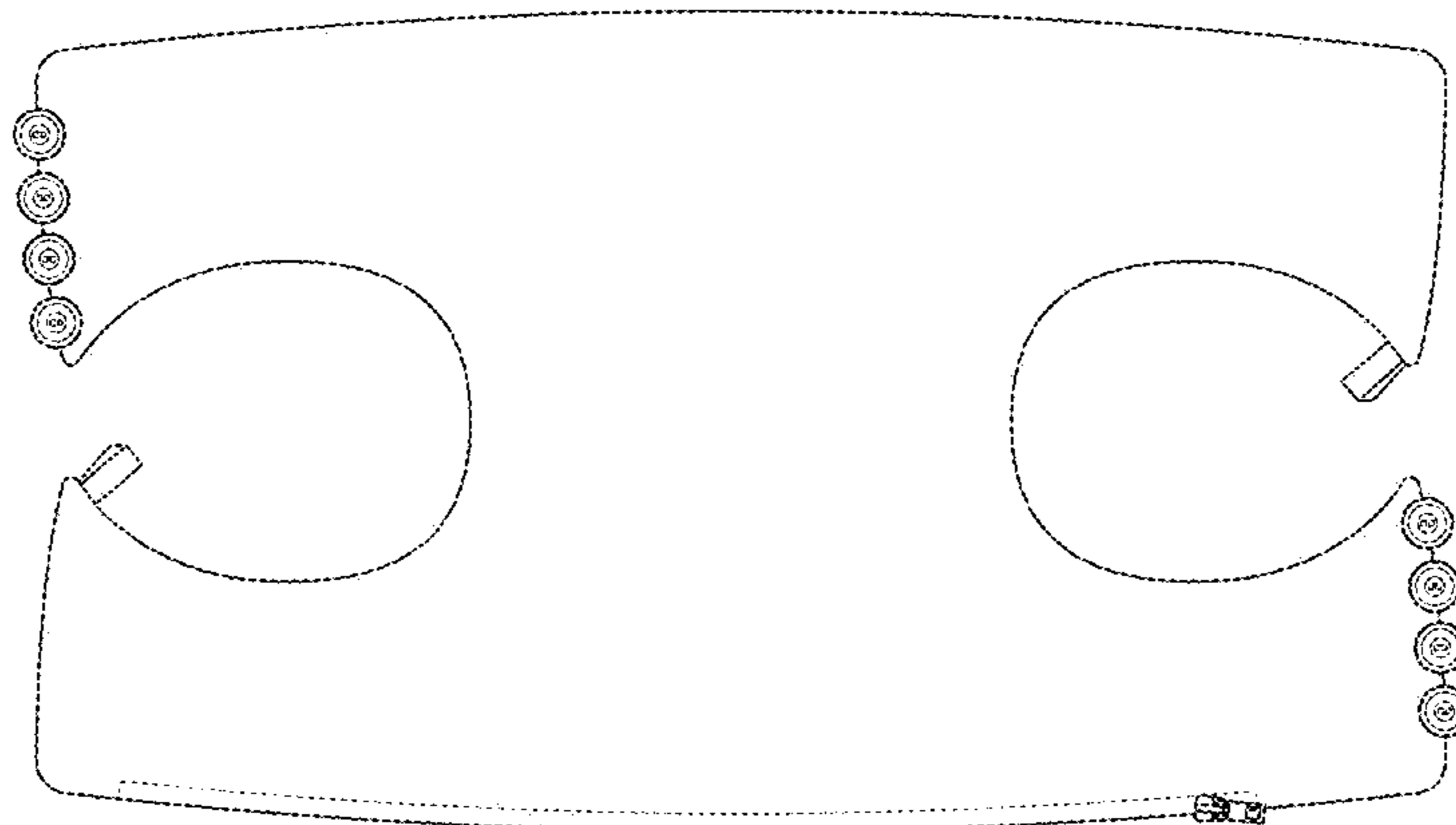

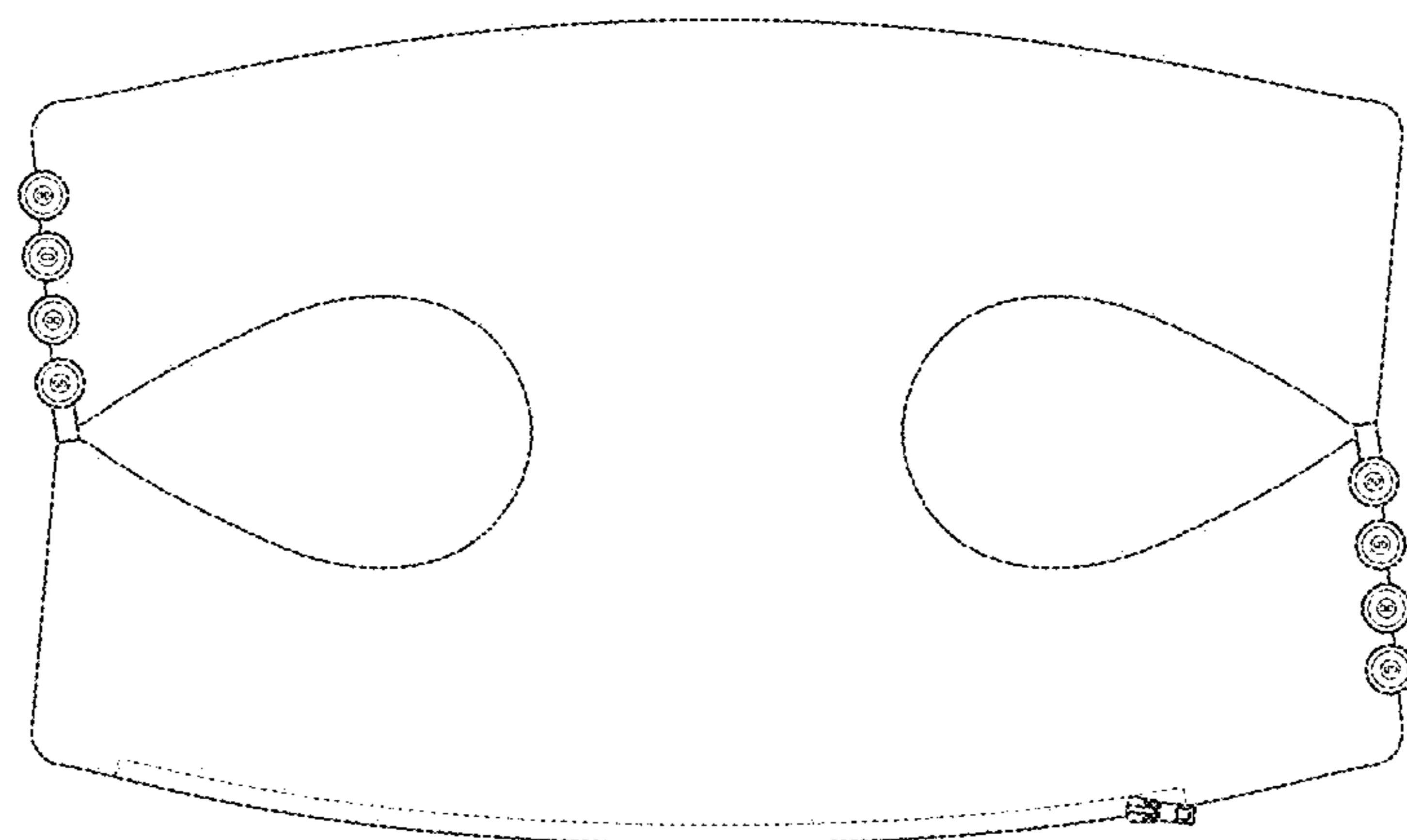

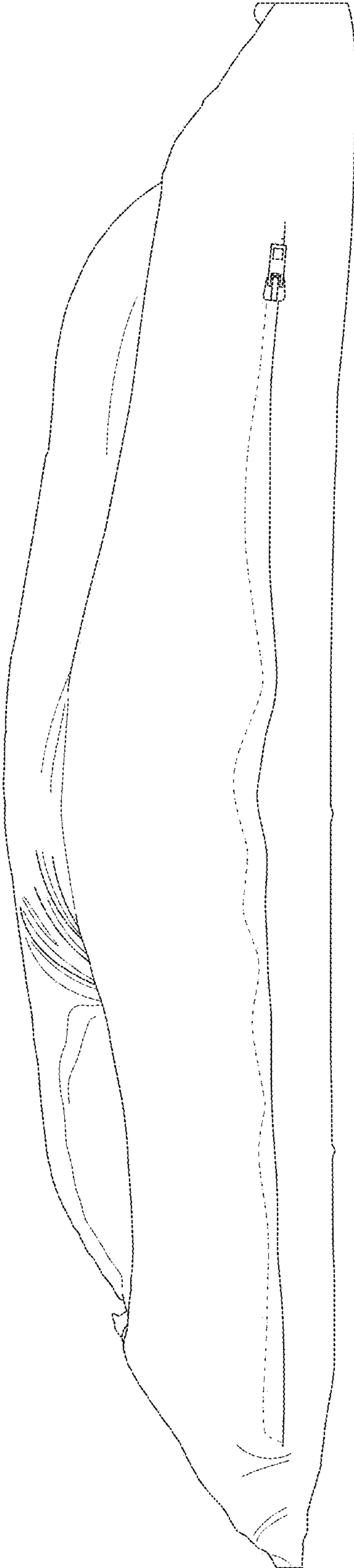

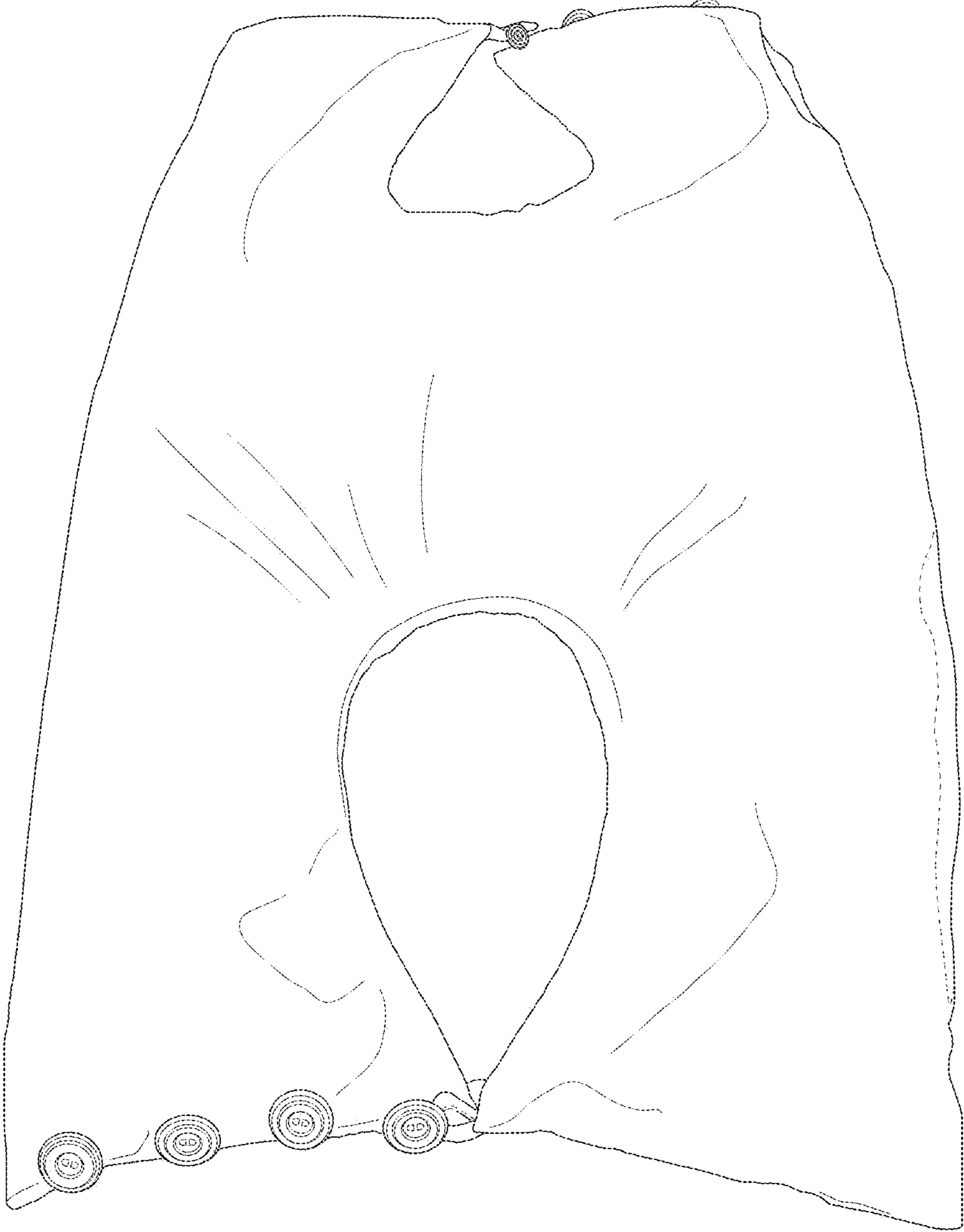

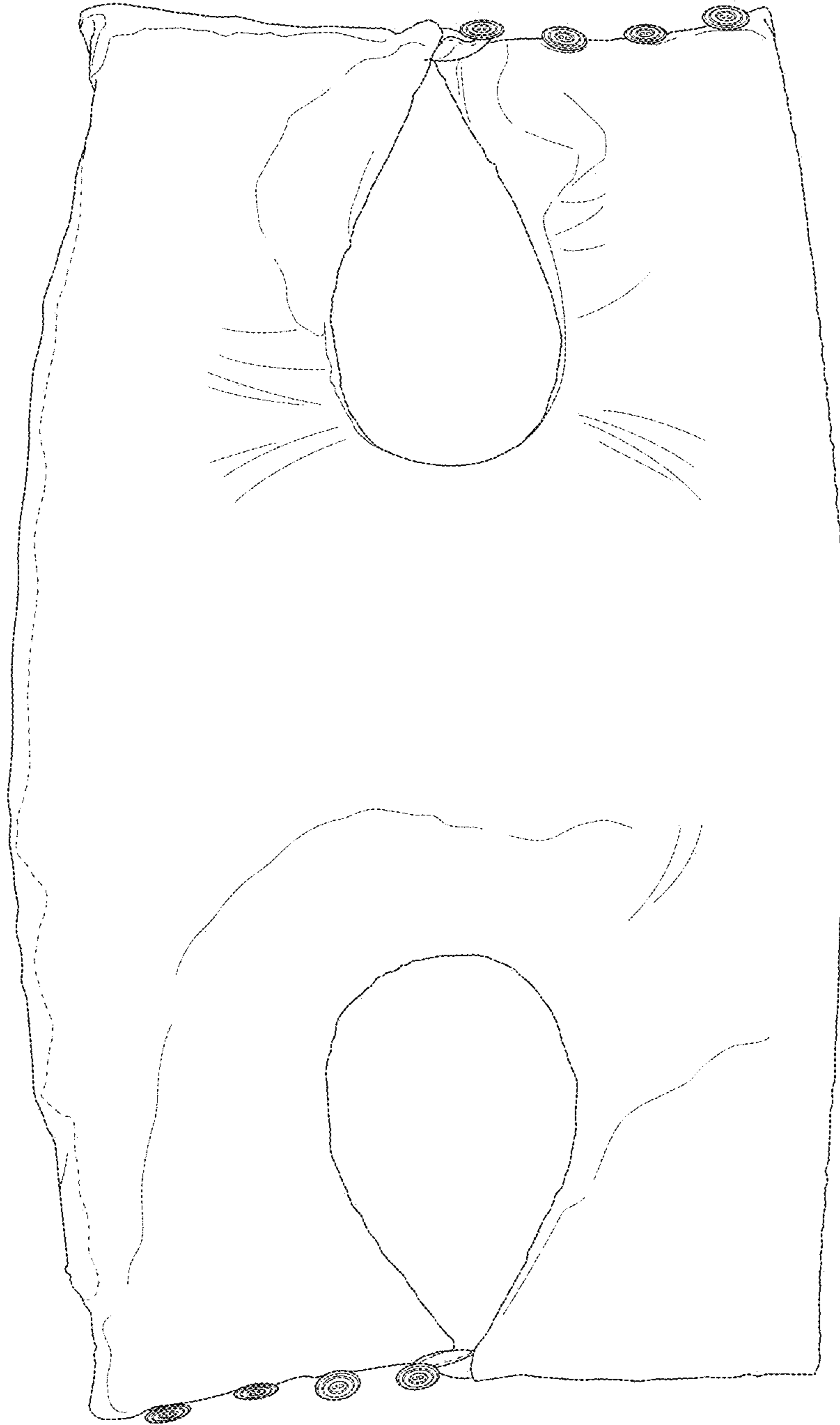
