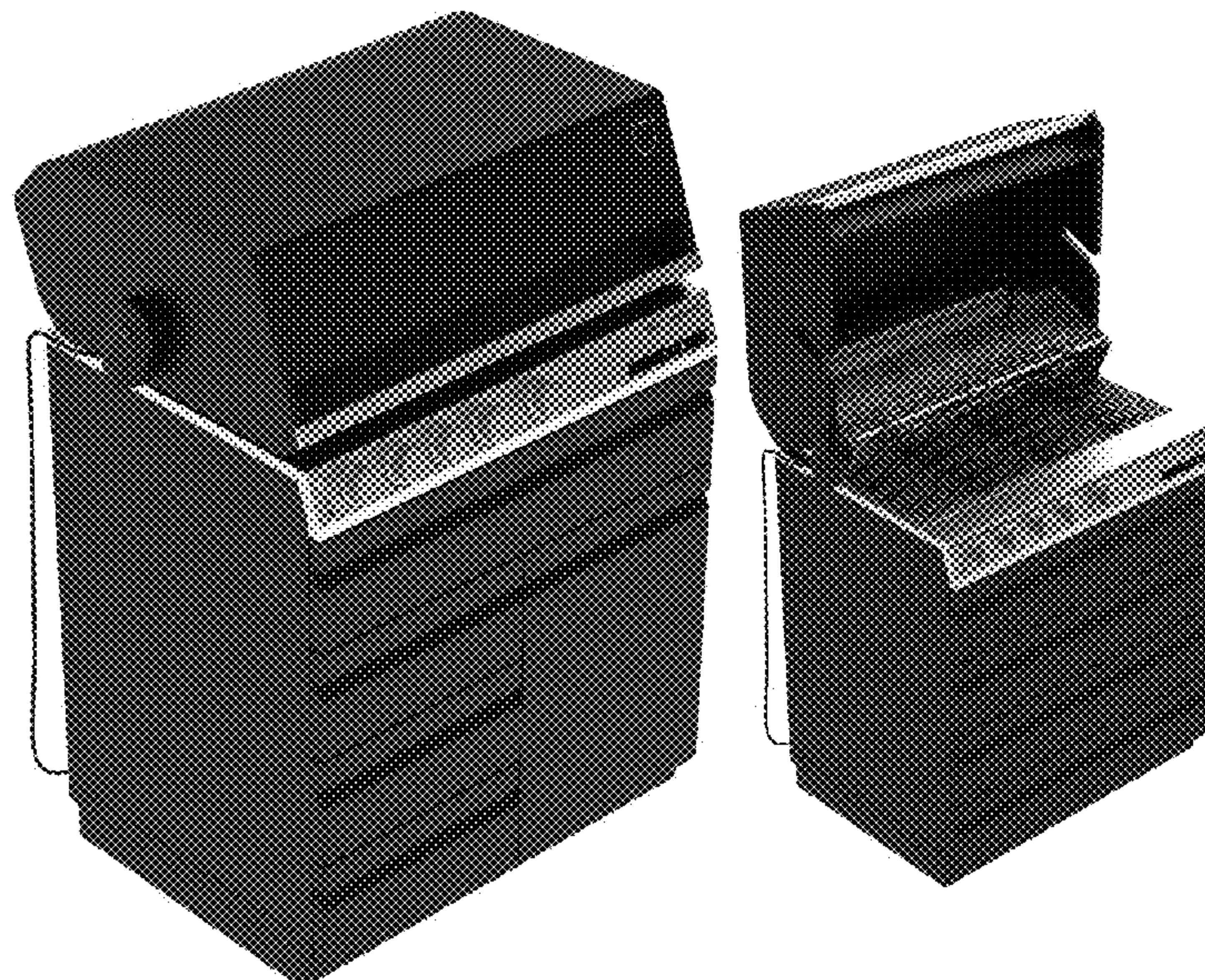
The ornamental design for a grill, as shown and described.

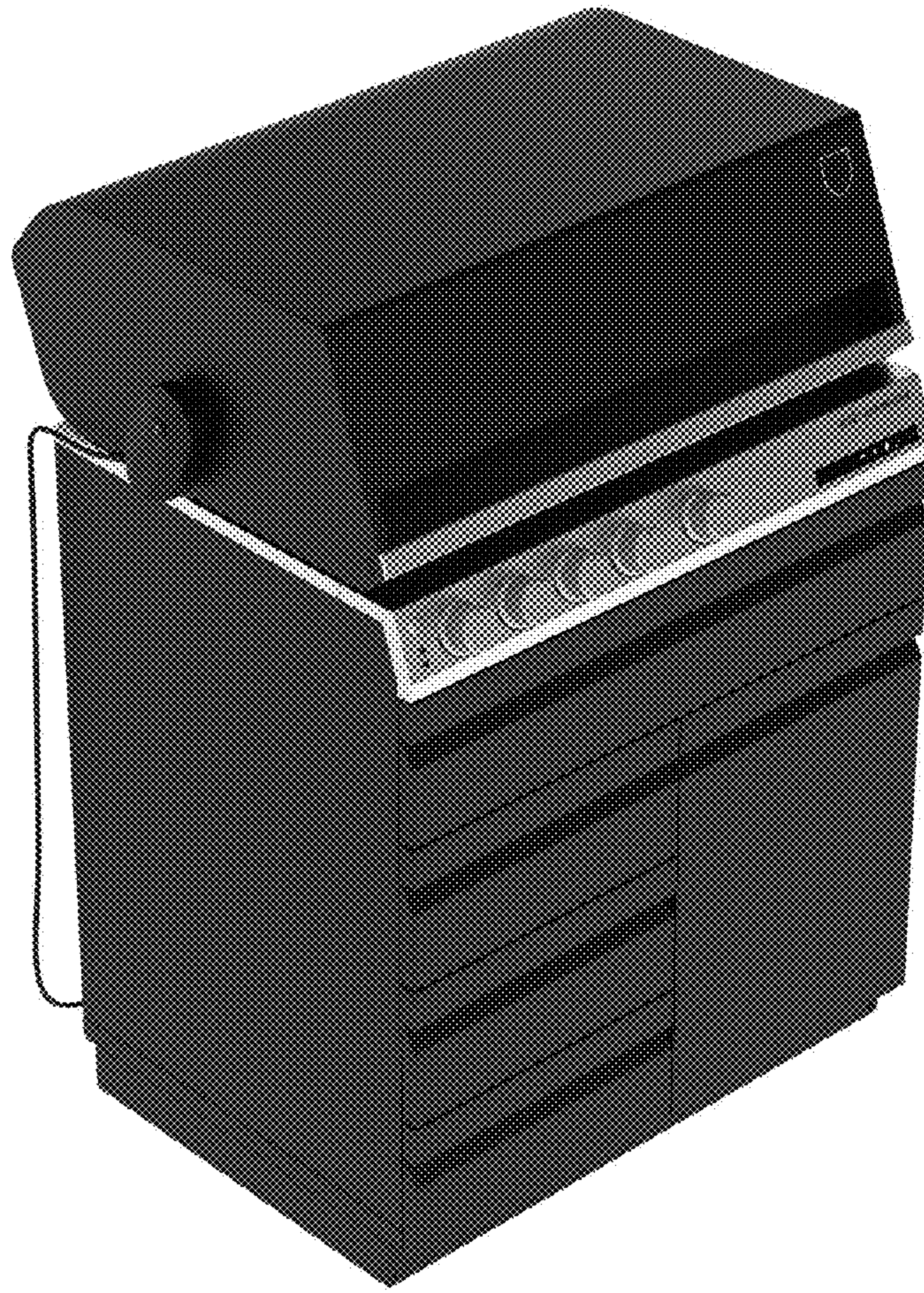

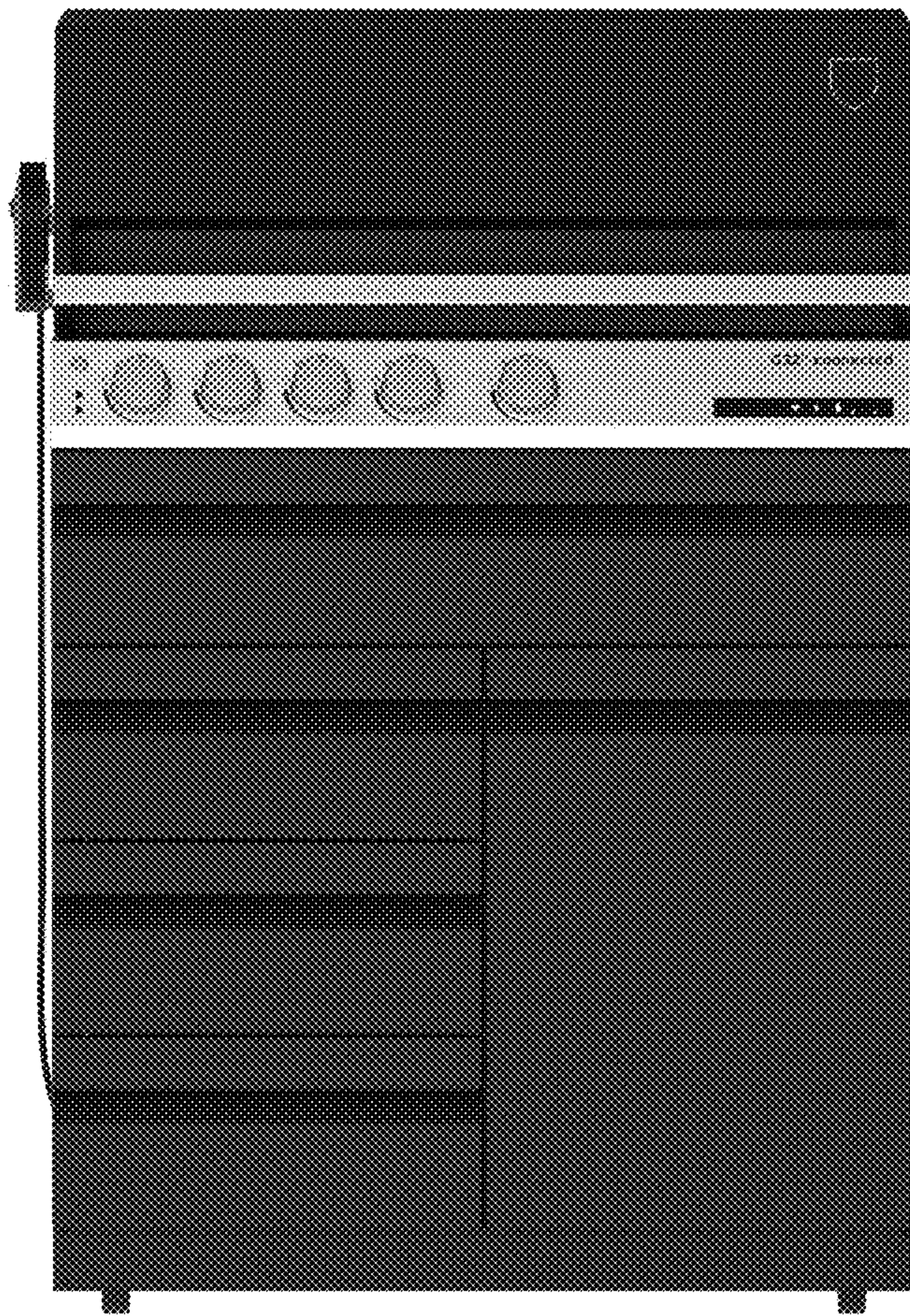

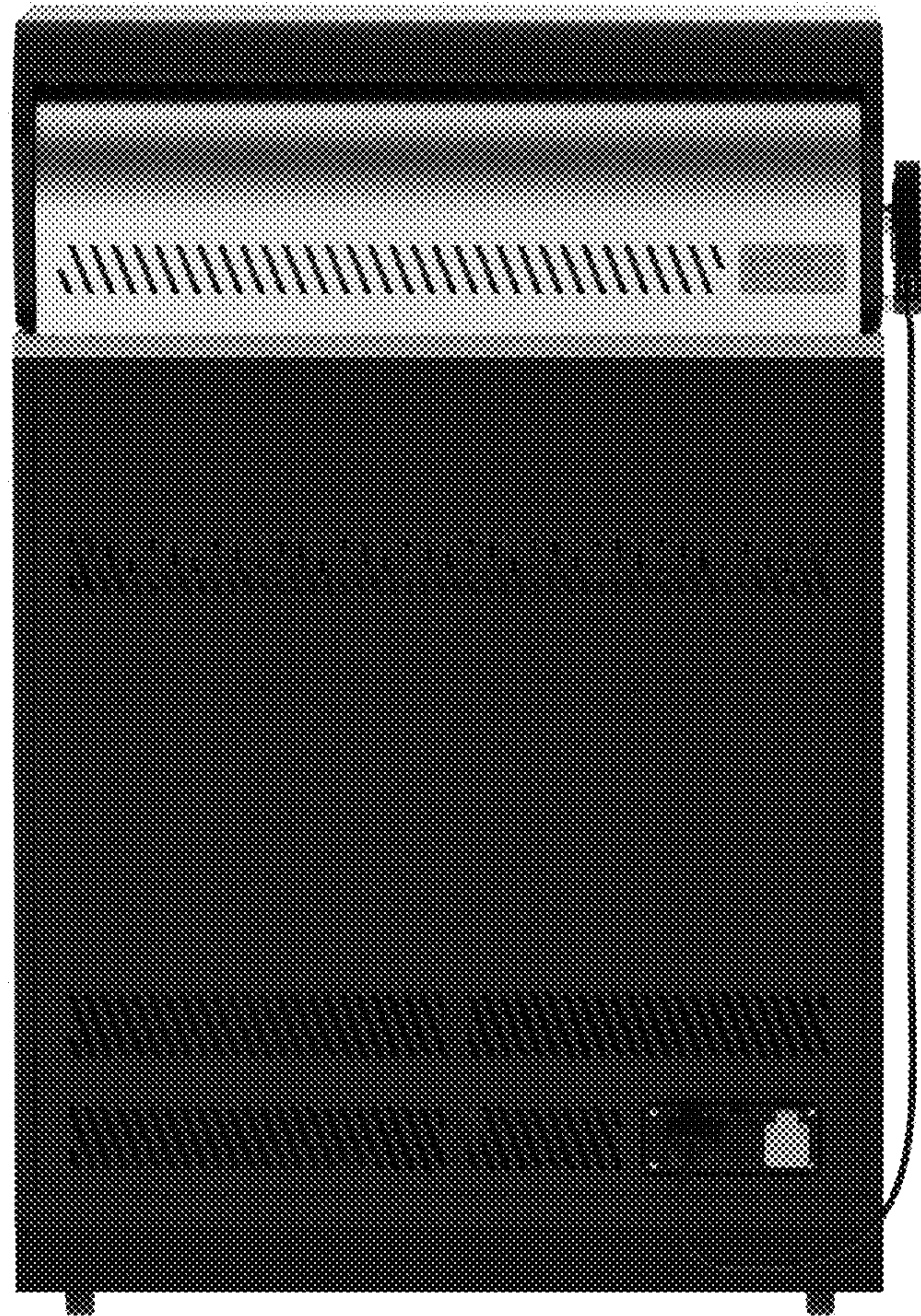

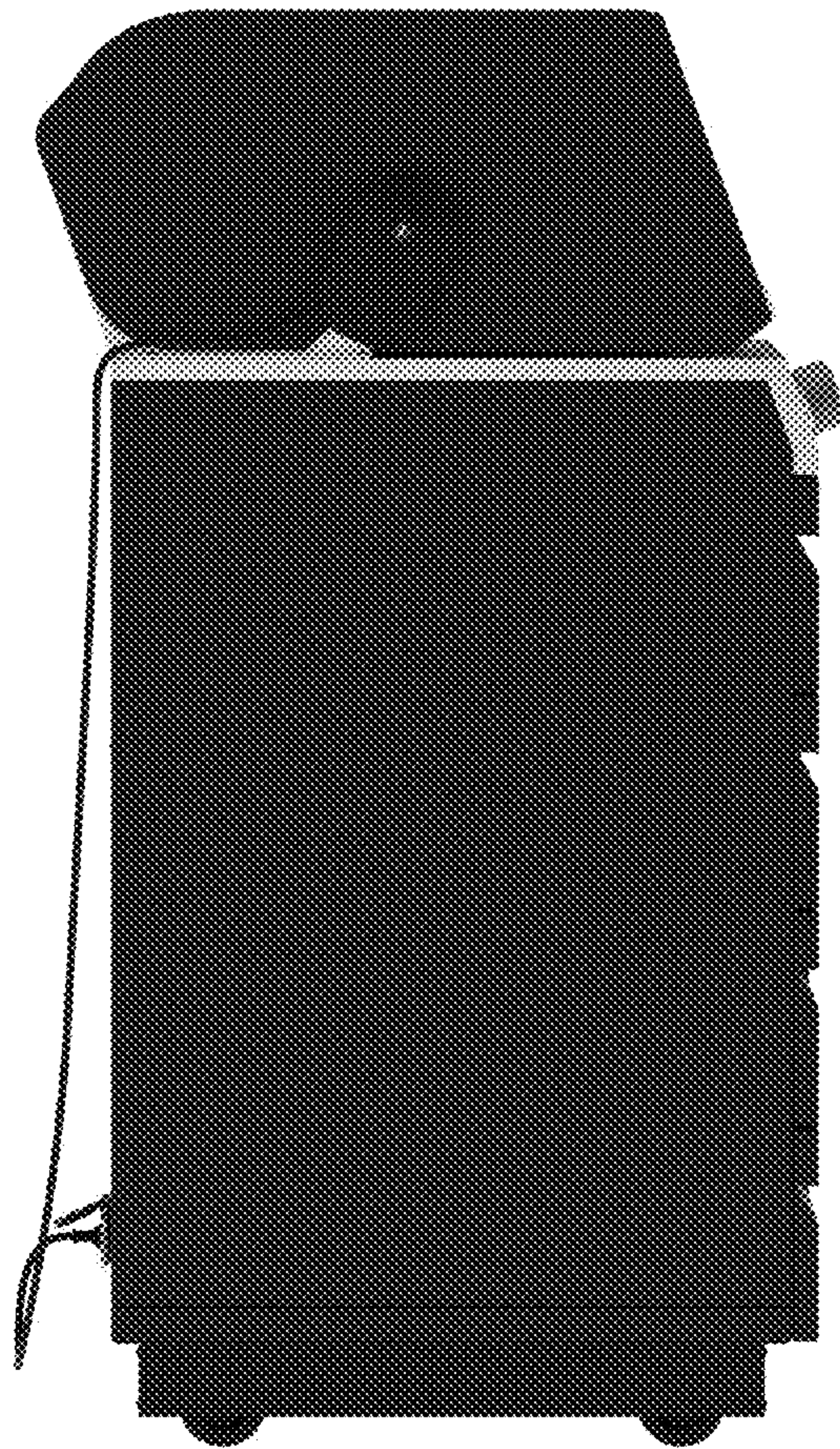

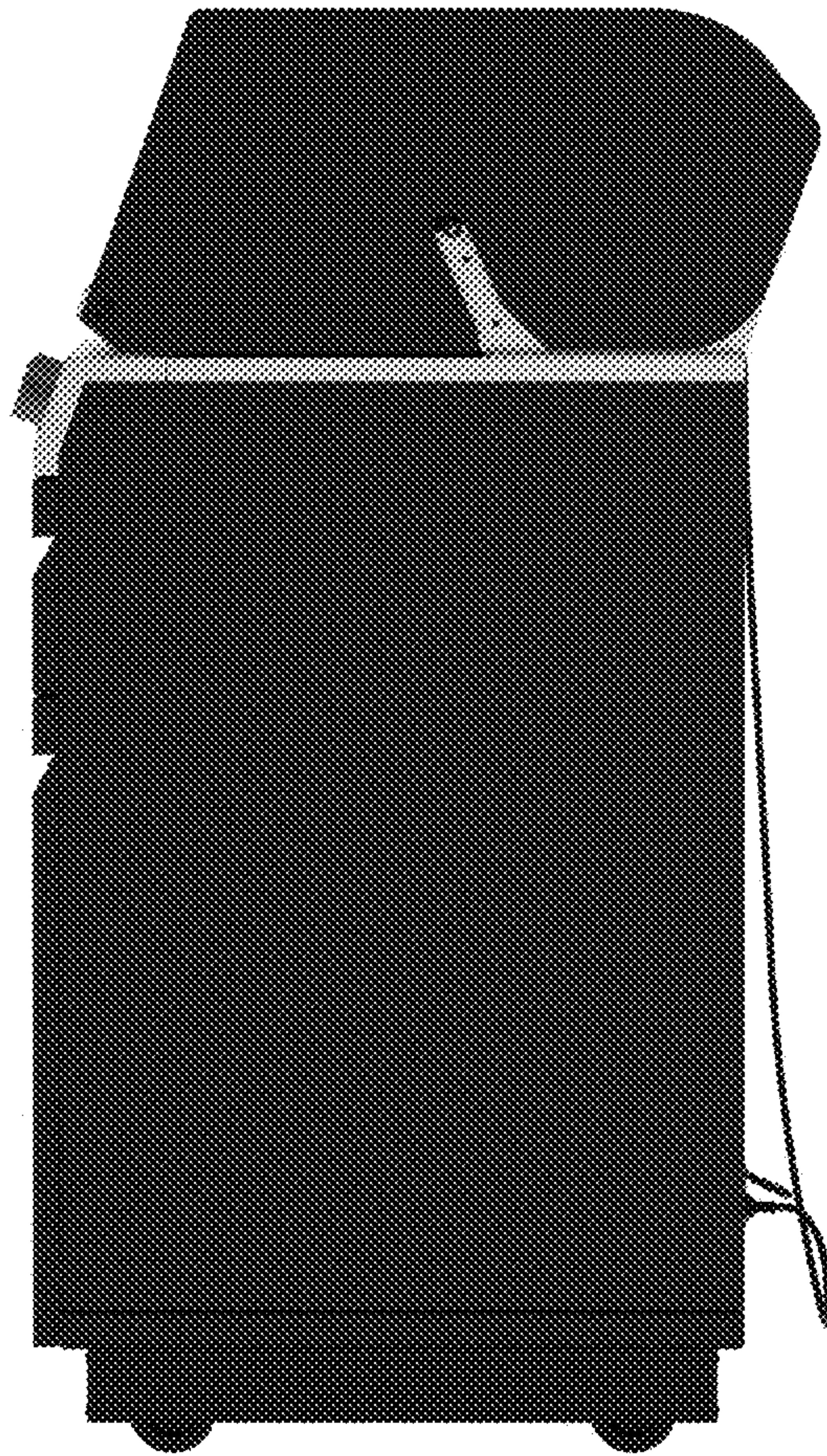

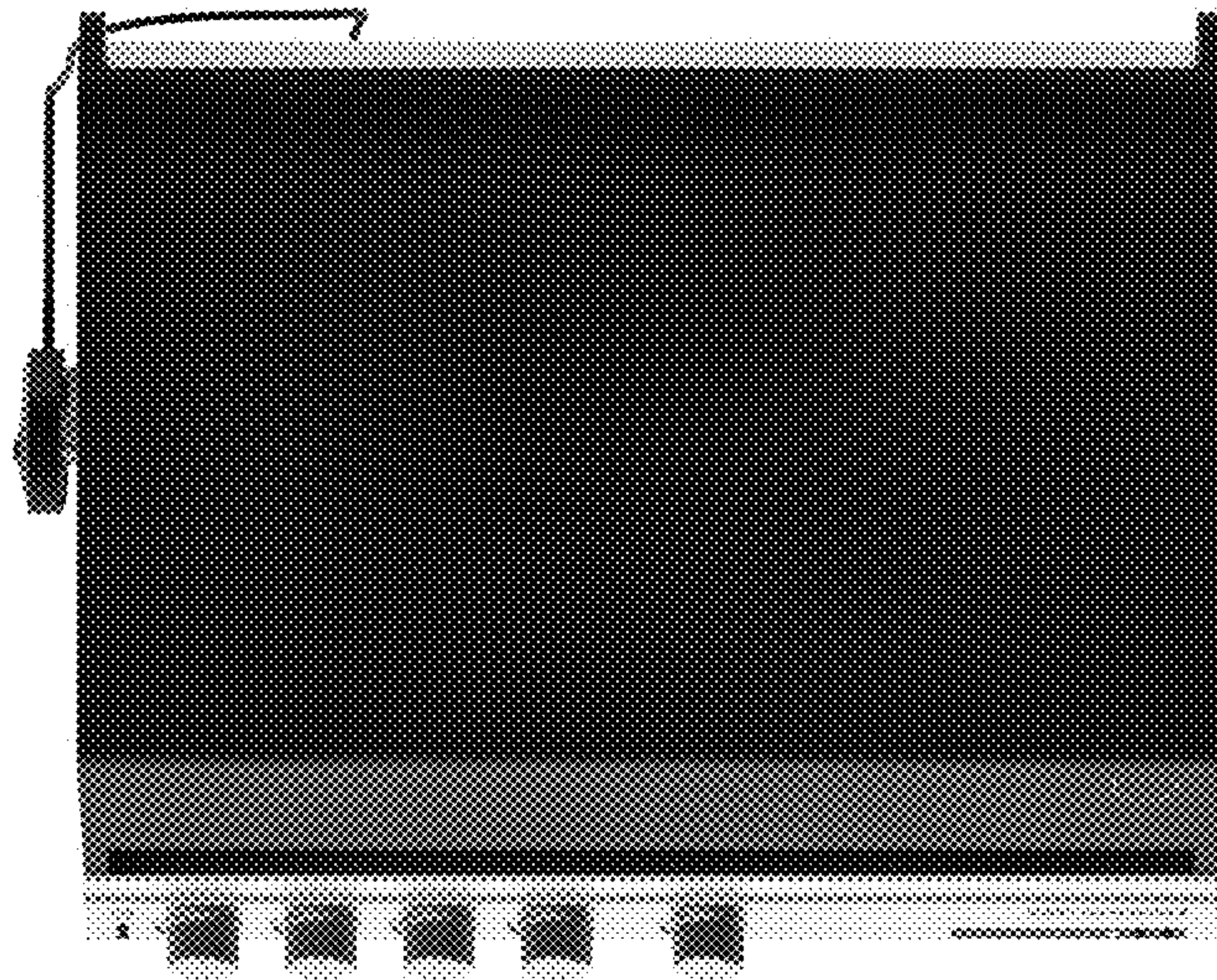

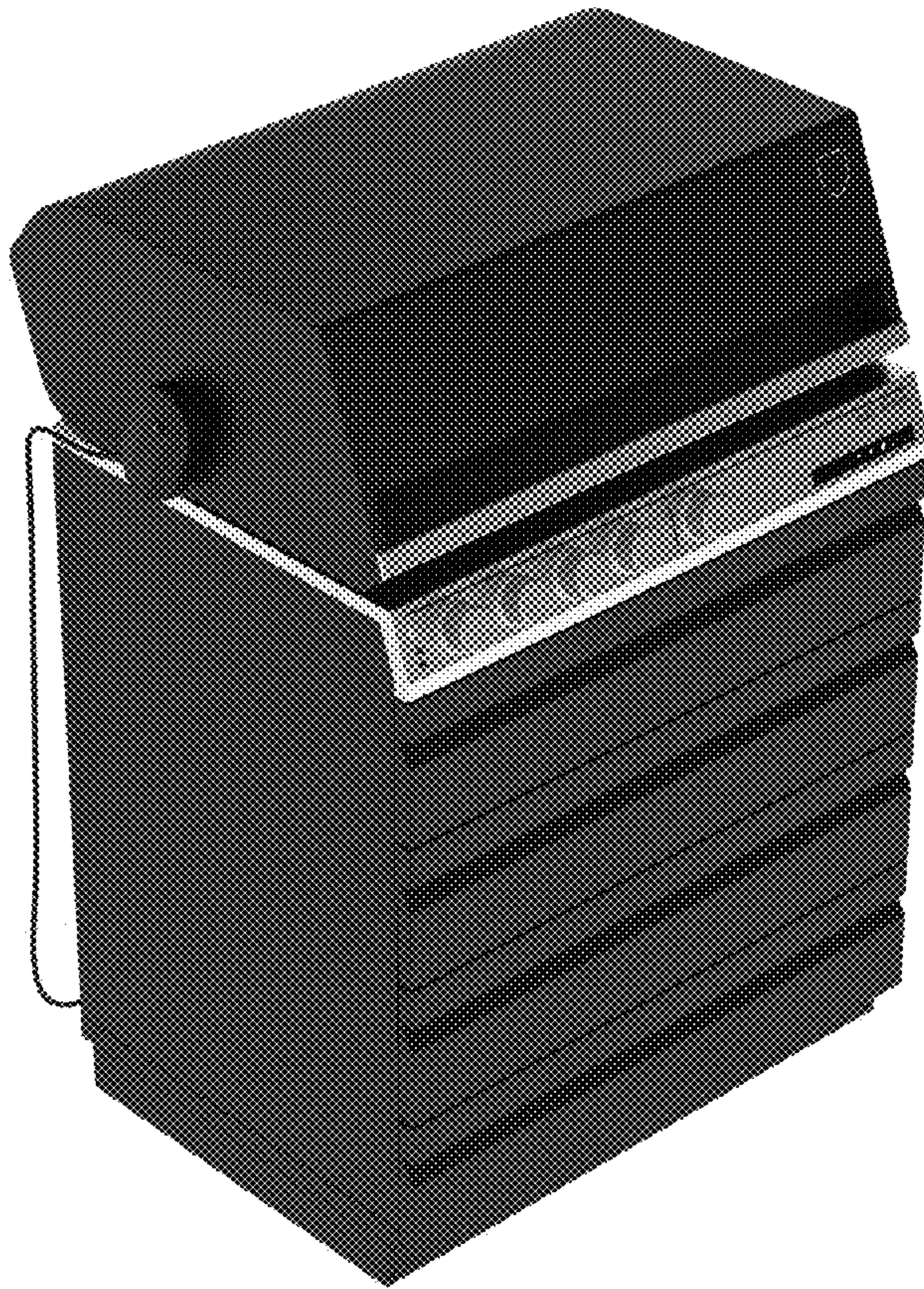

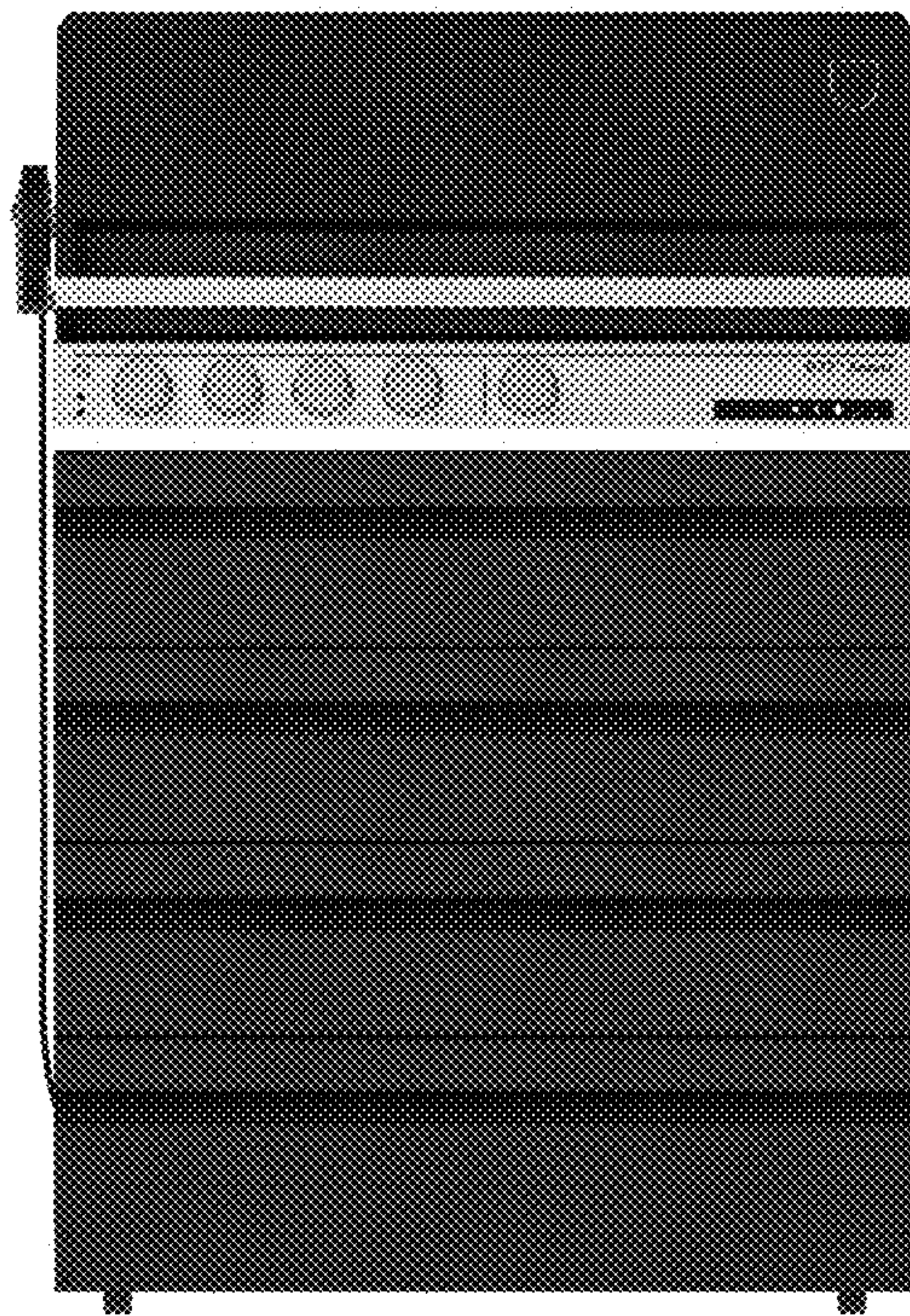

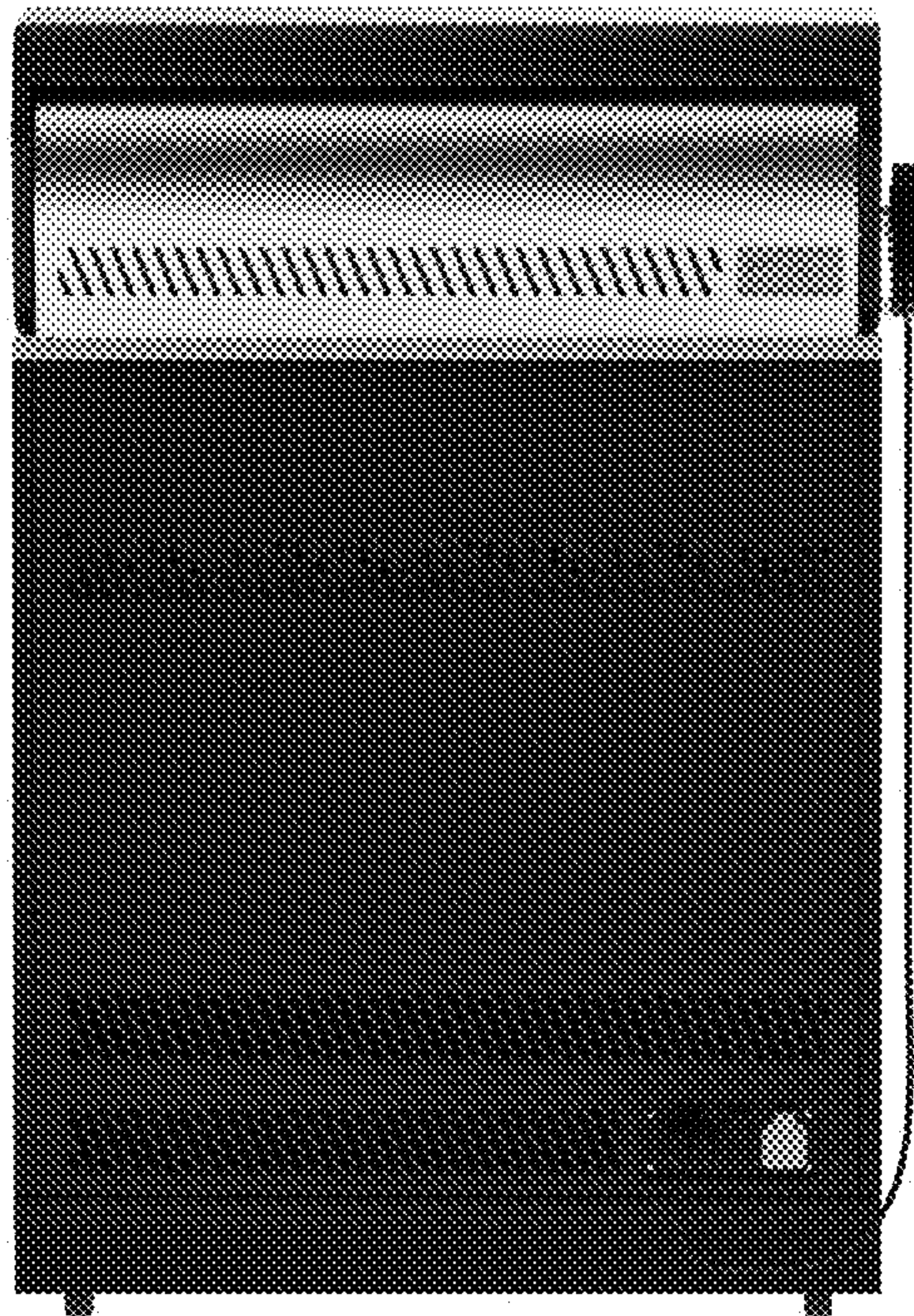

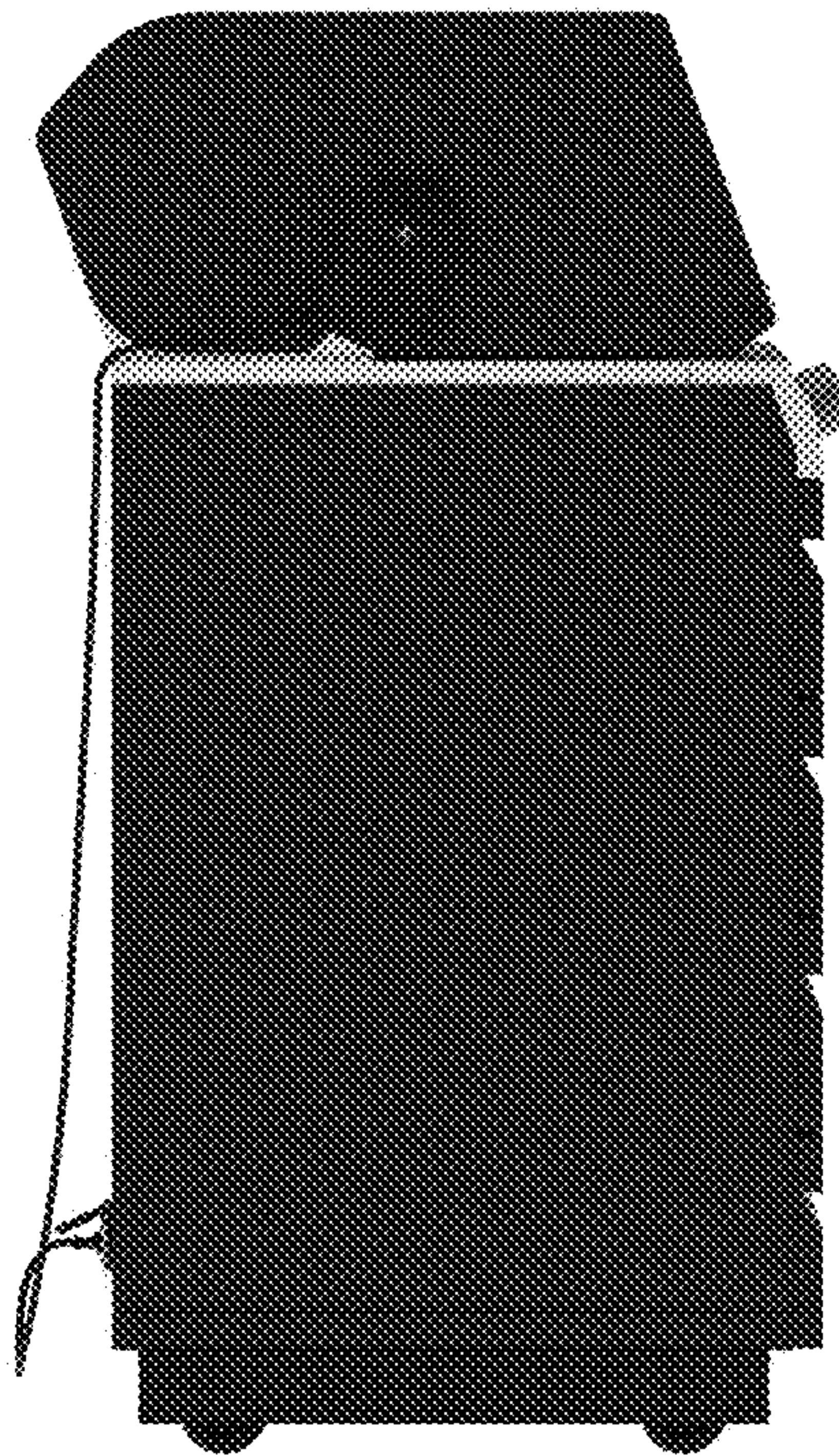

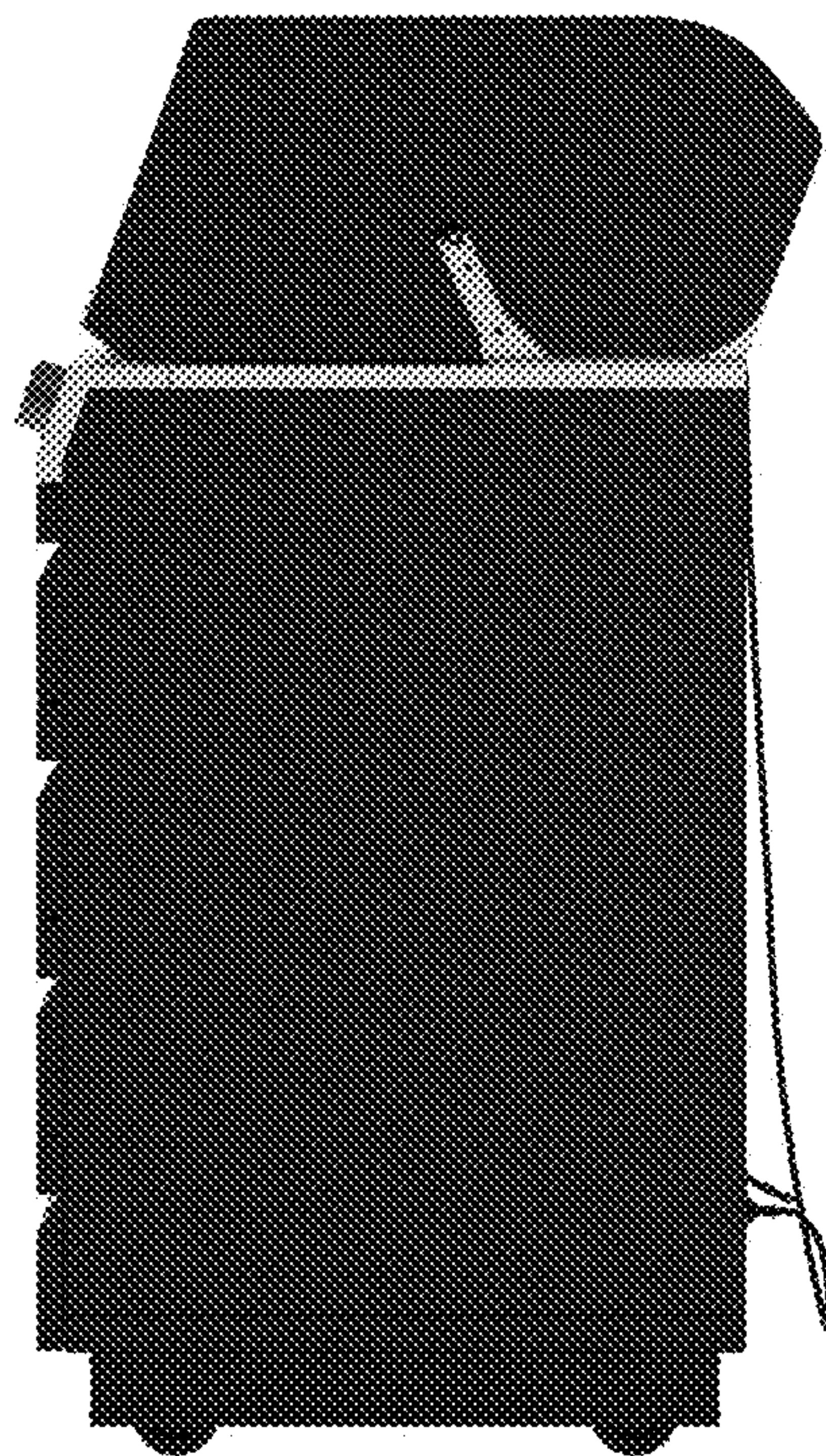

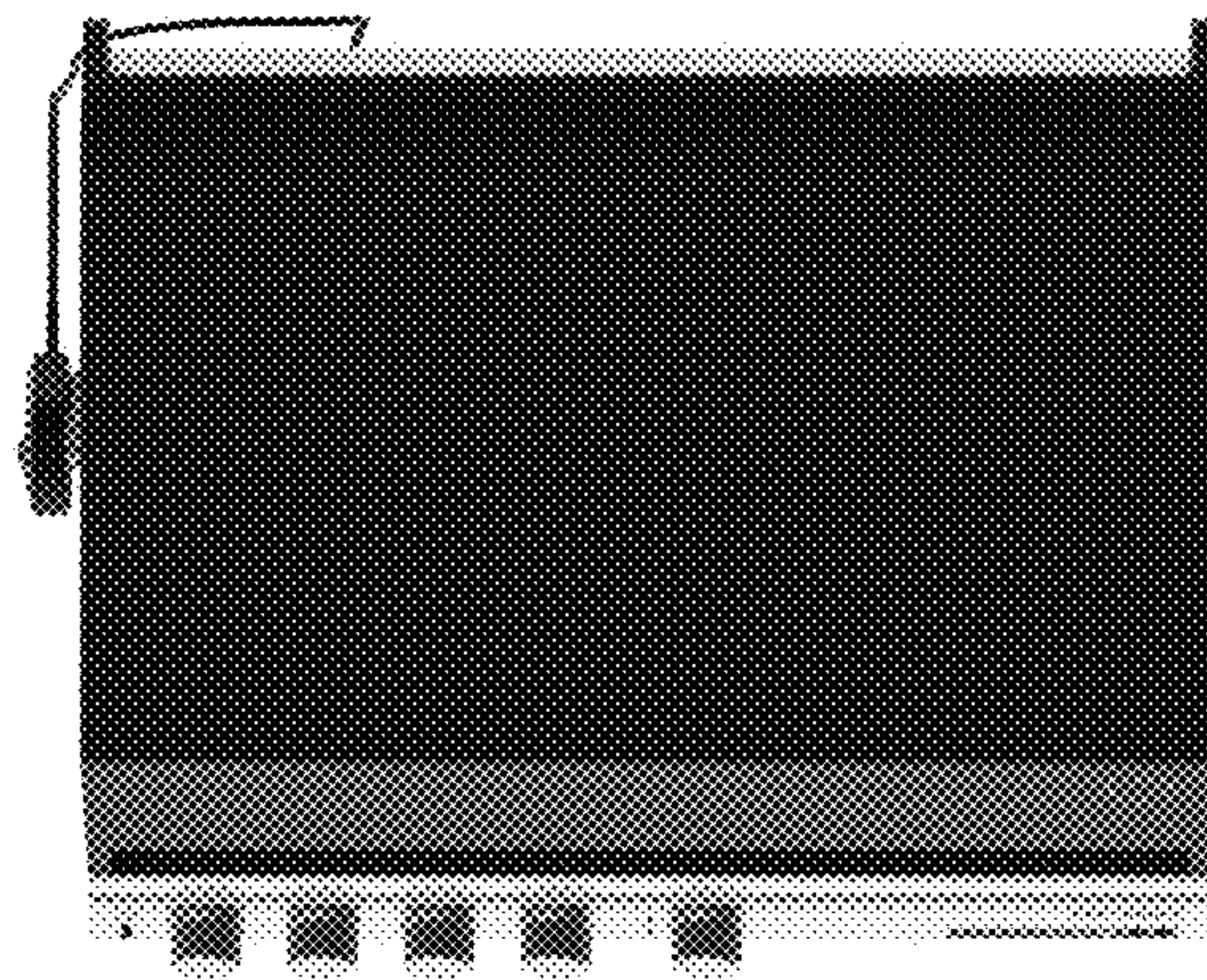
