DESCRIPTION

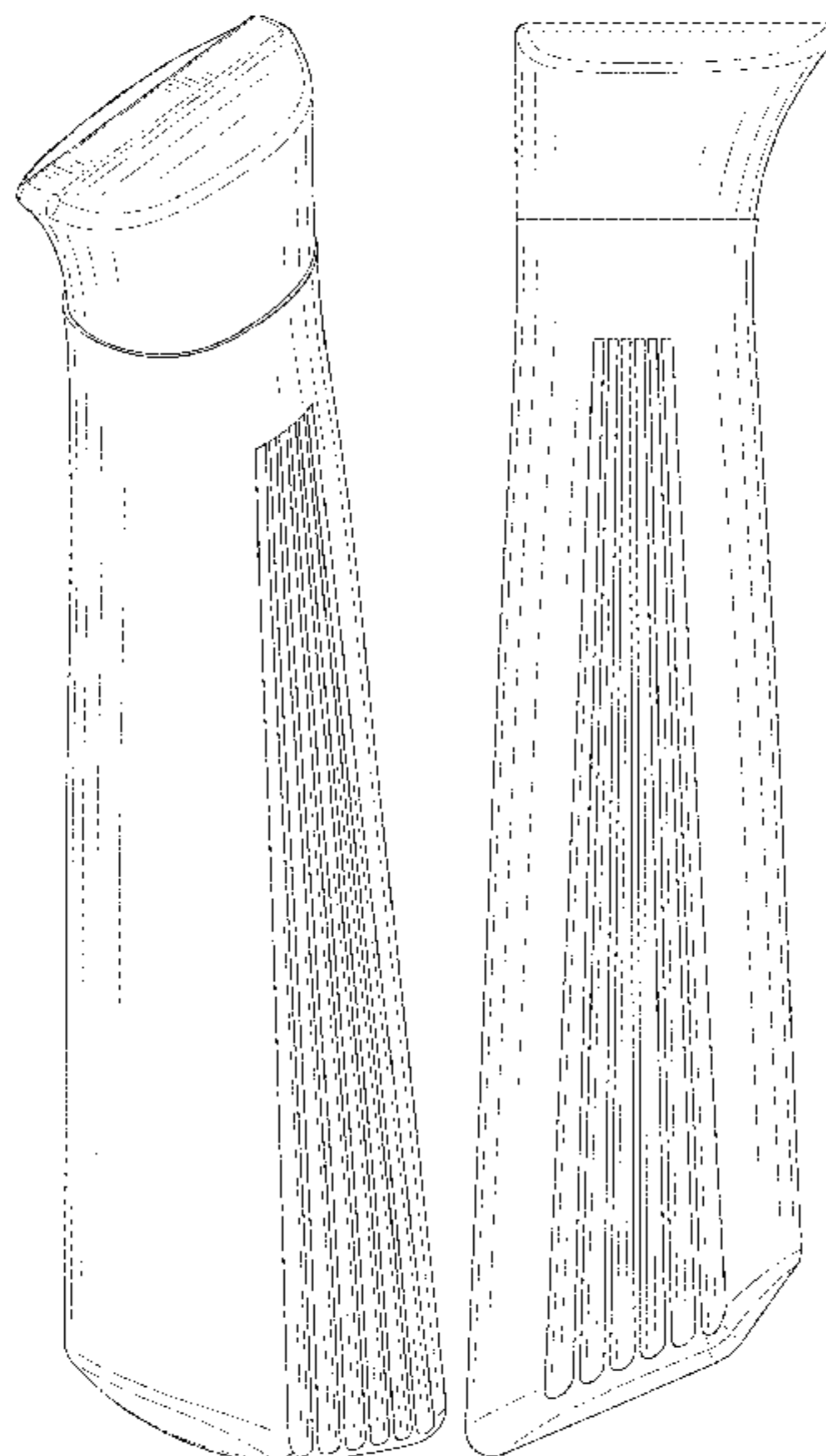
FIG. 1 is a perspective view of a knife handle showing my new design;

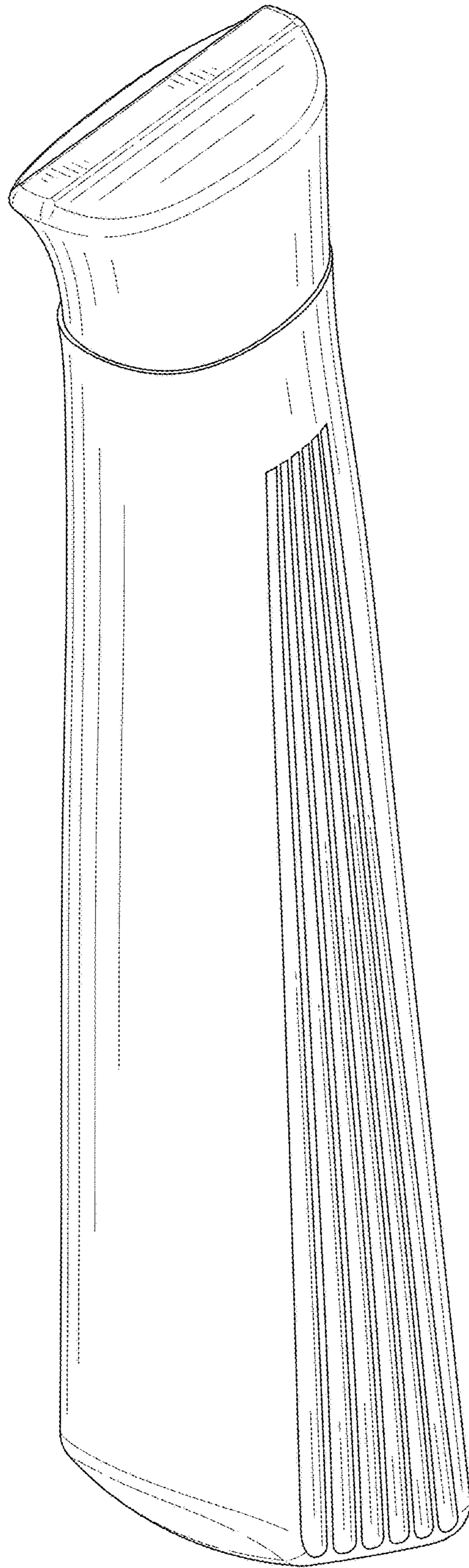

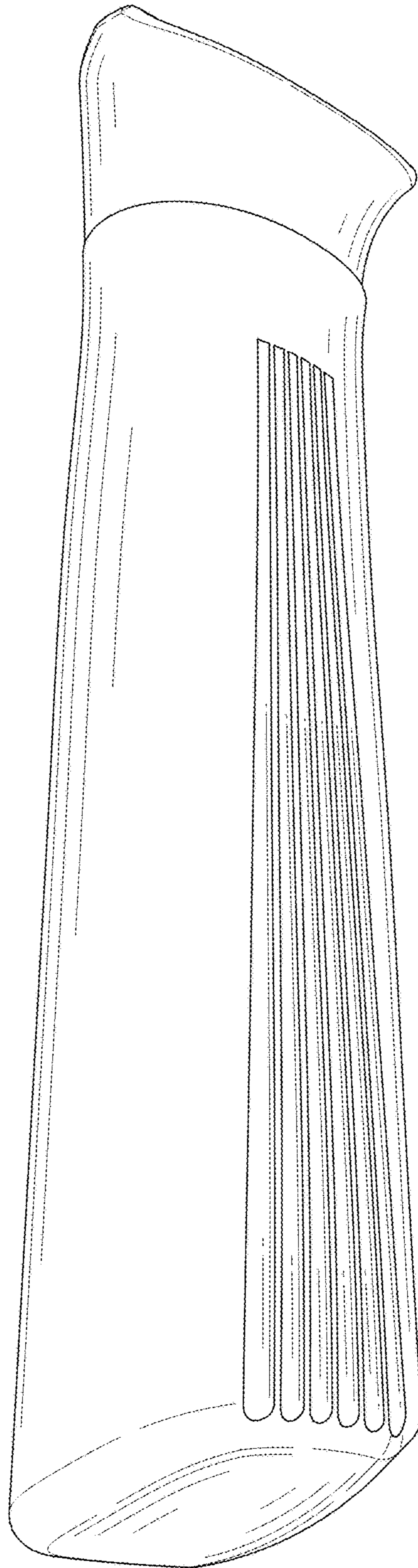

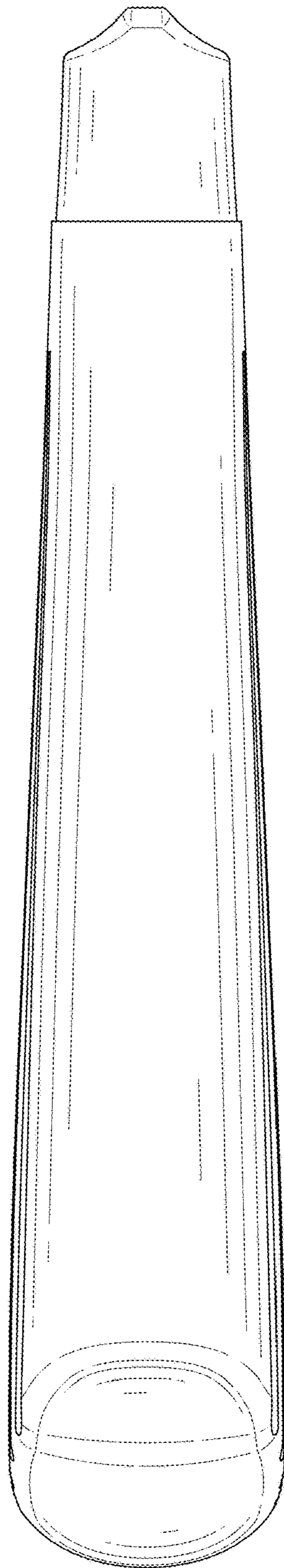

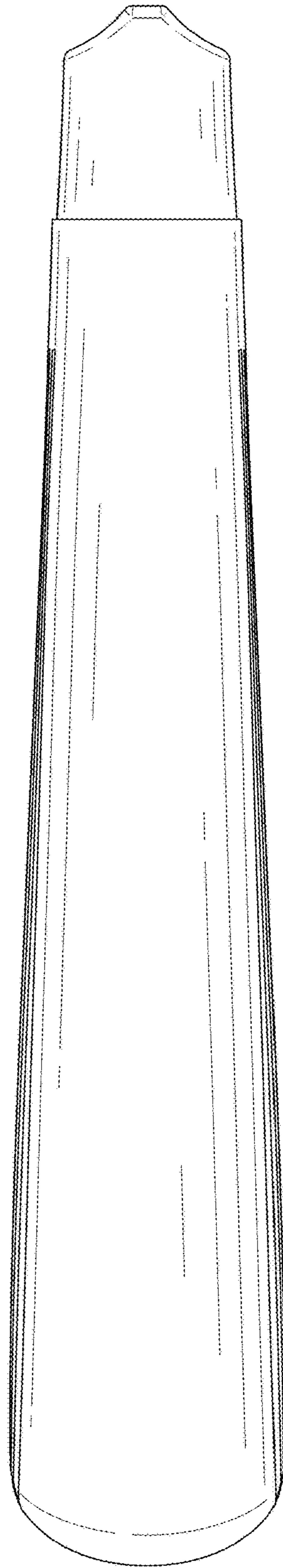

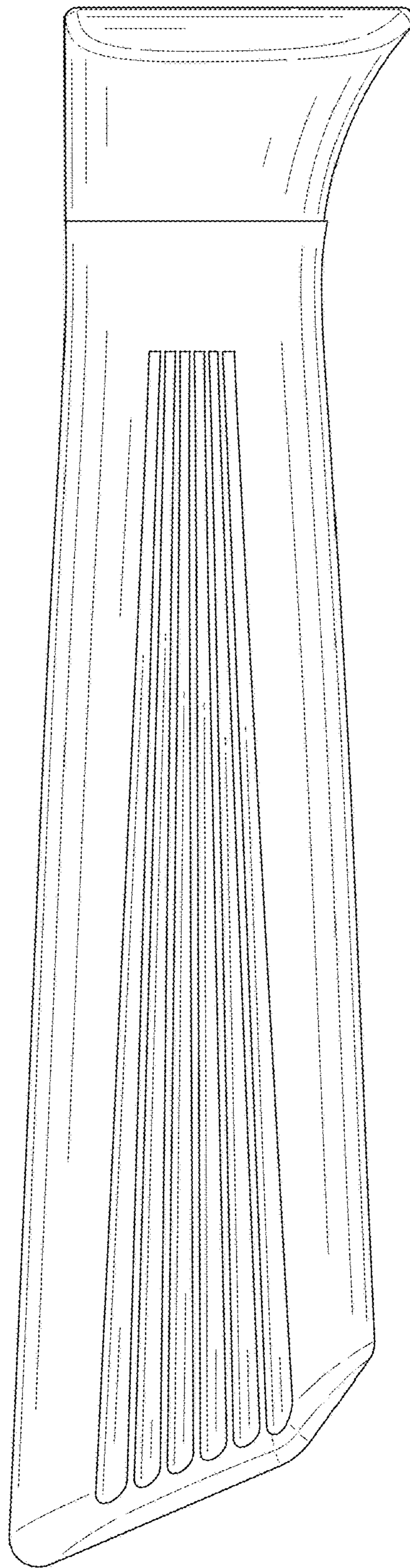

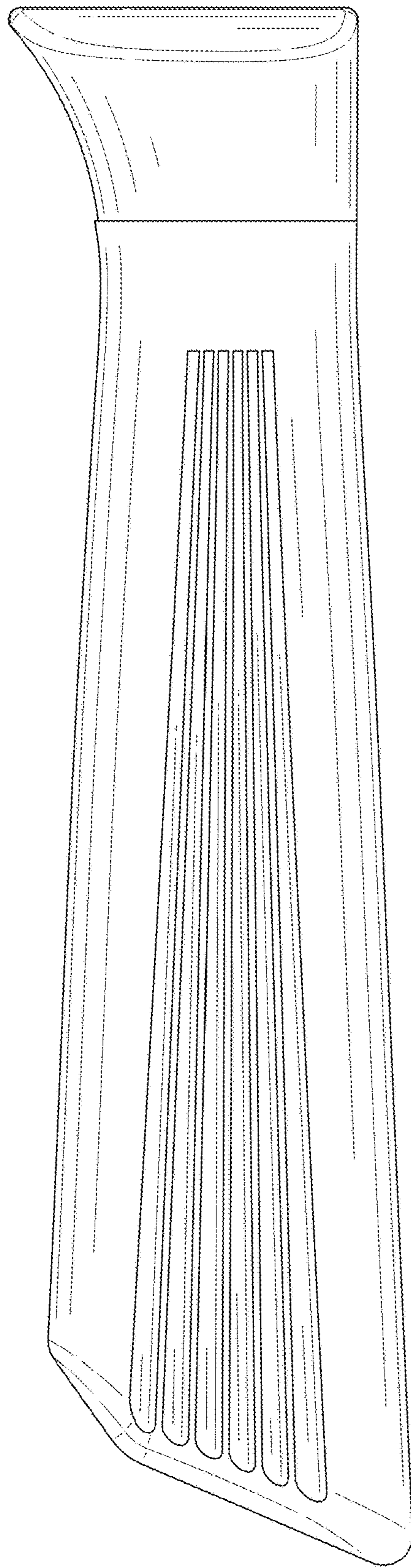

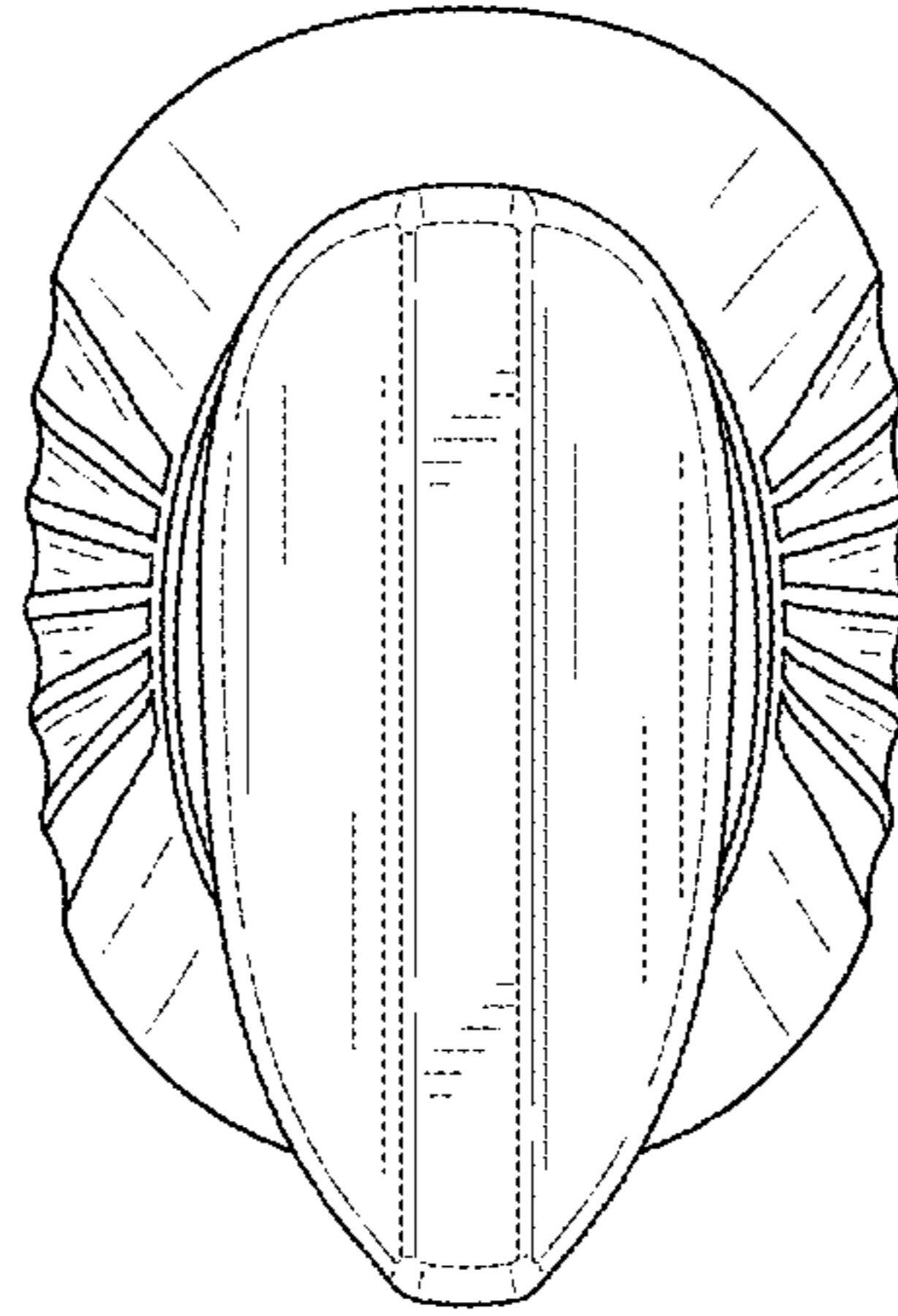

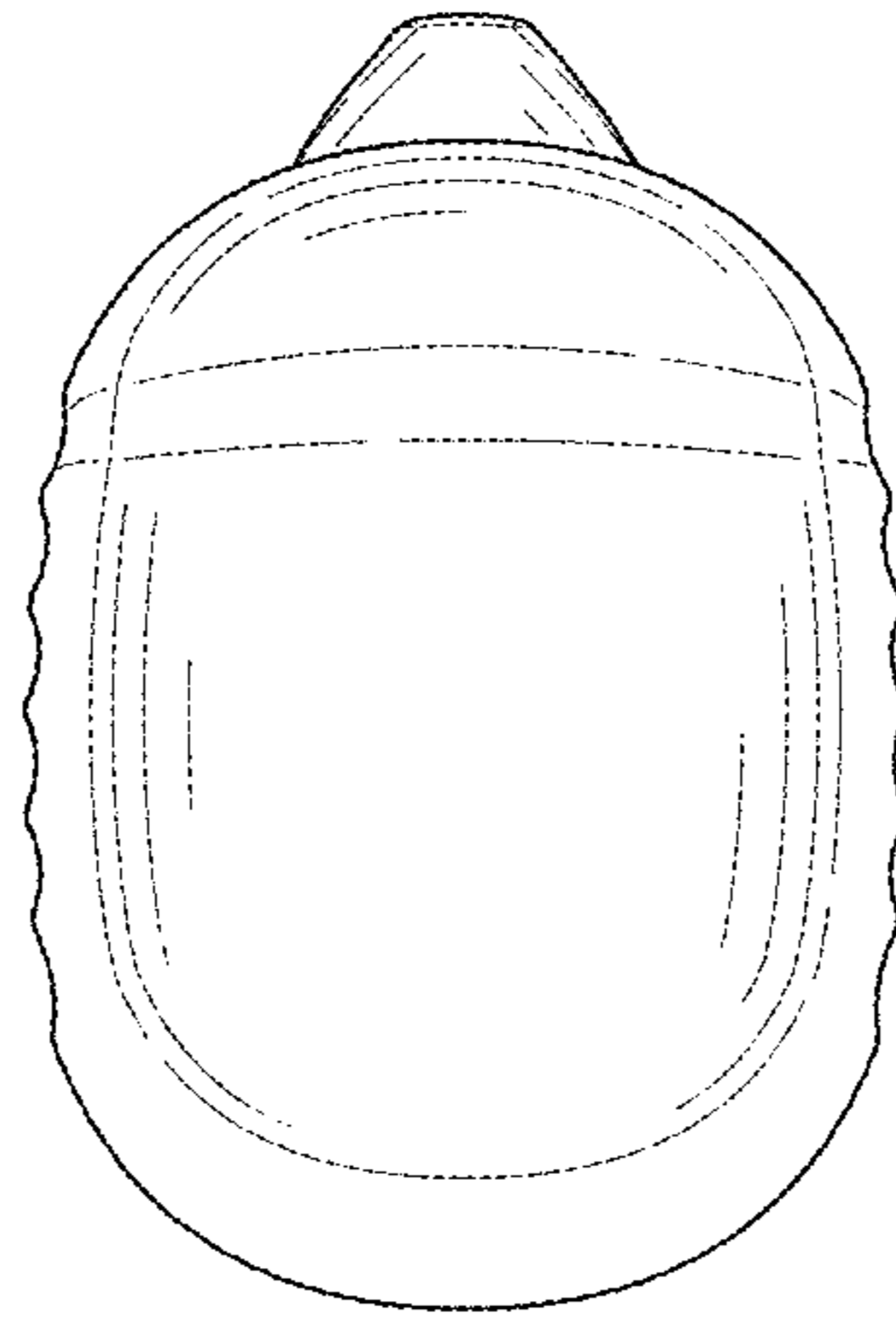
