The ornamental design for a carabiner, as shown and described.

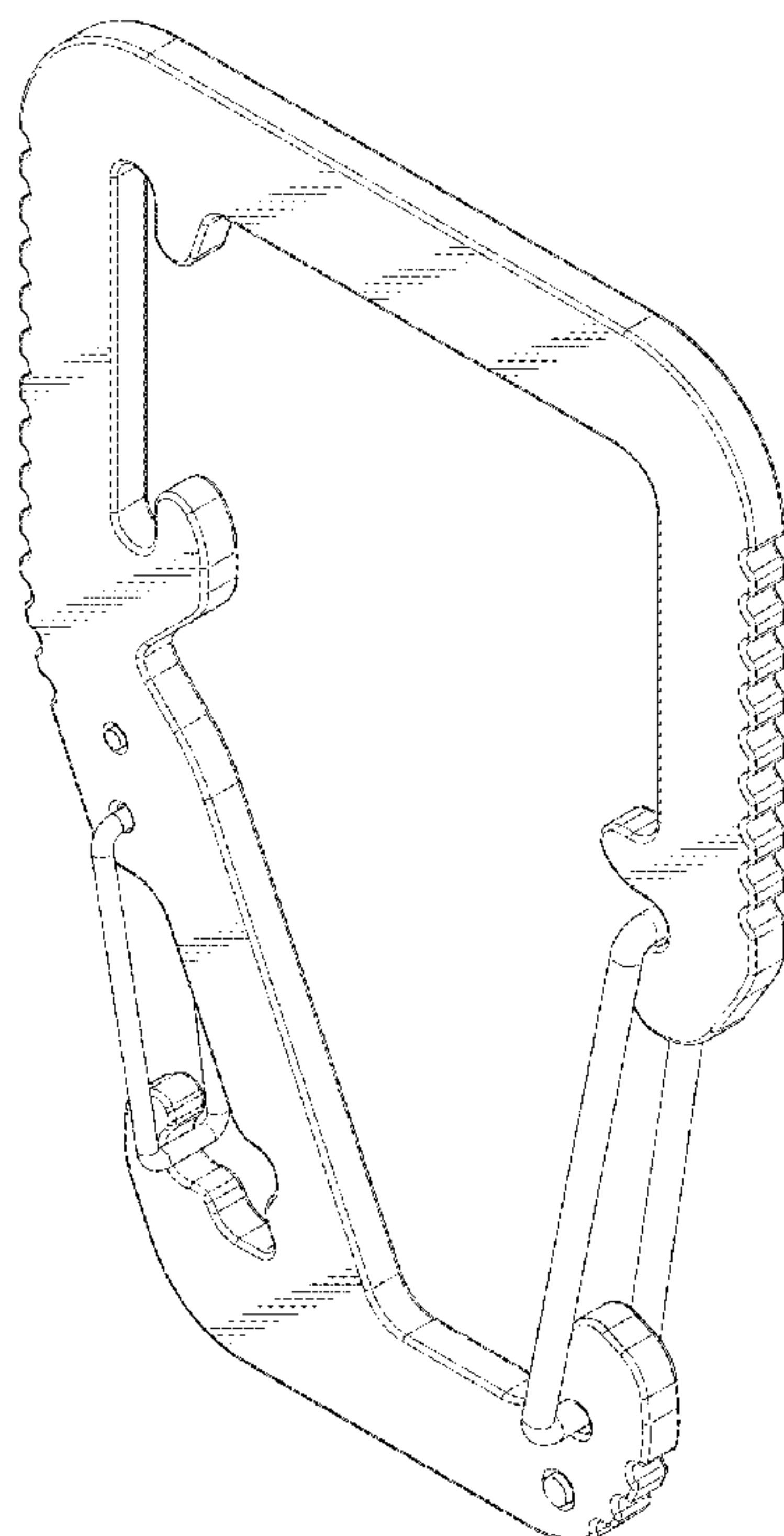
DESCRIPTION

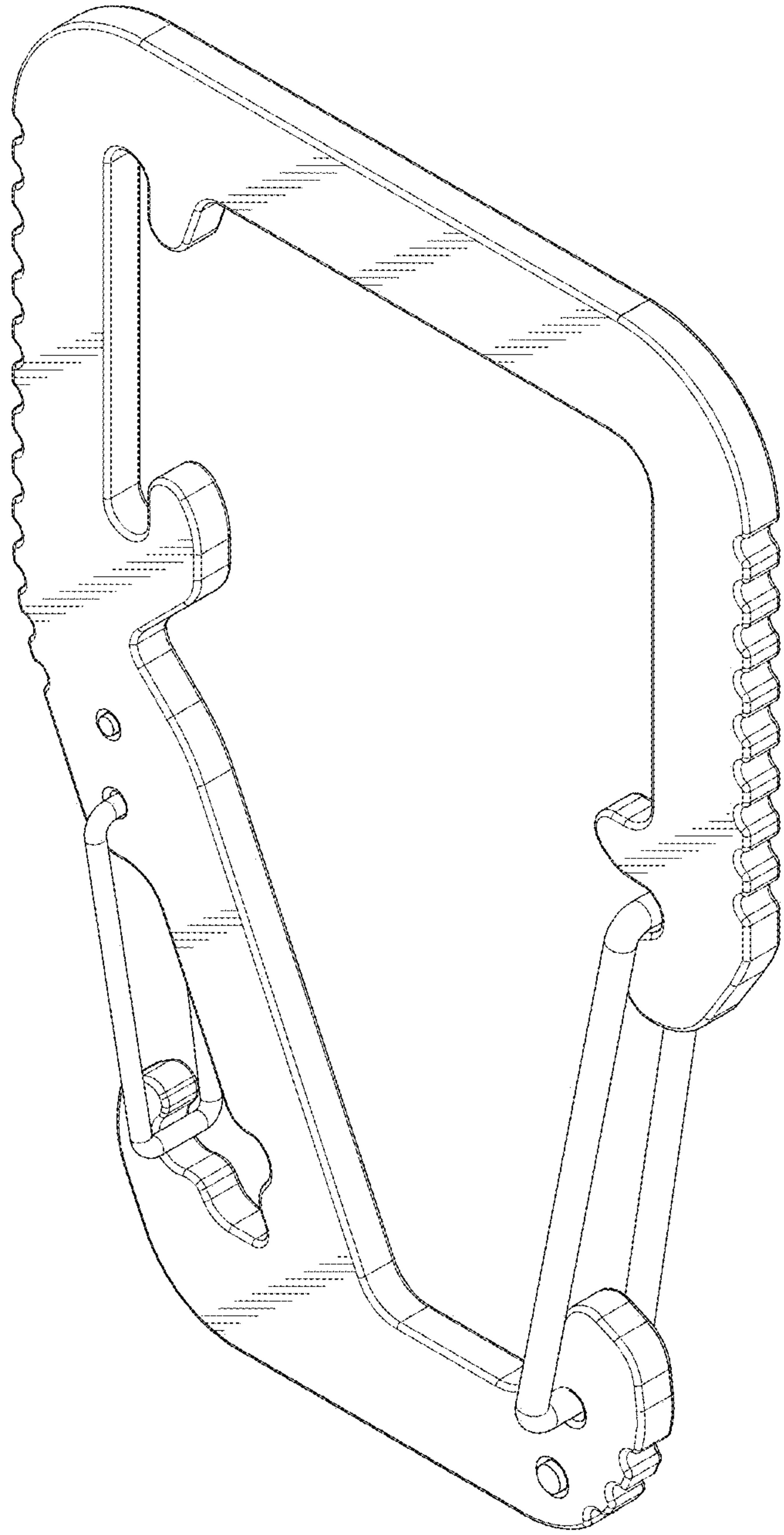

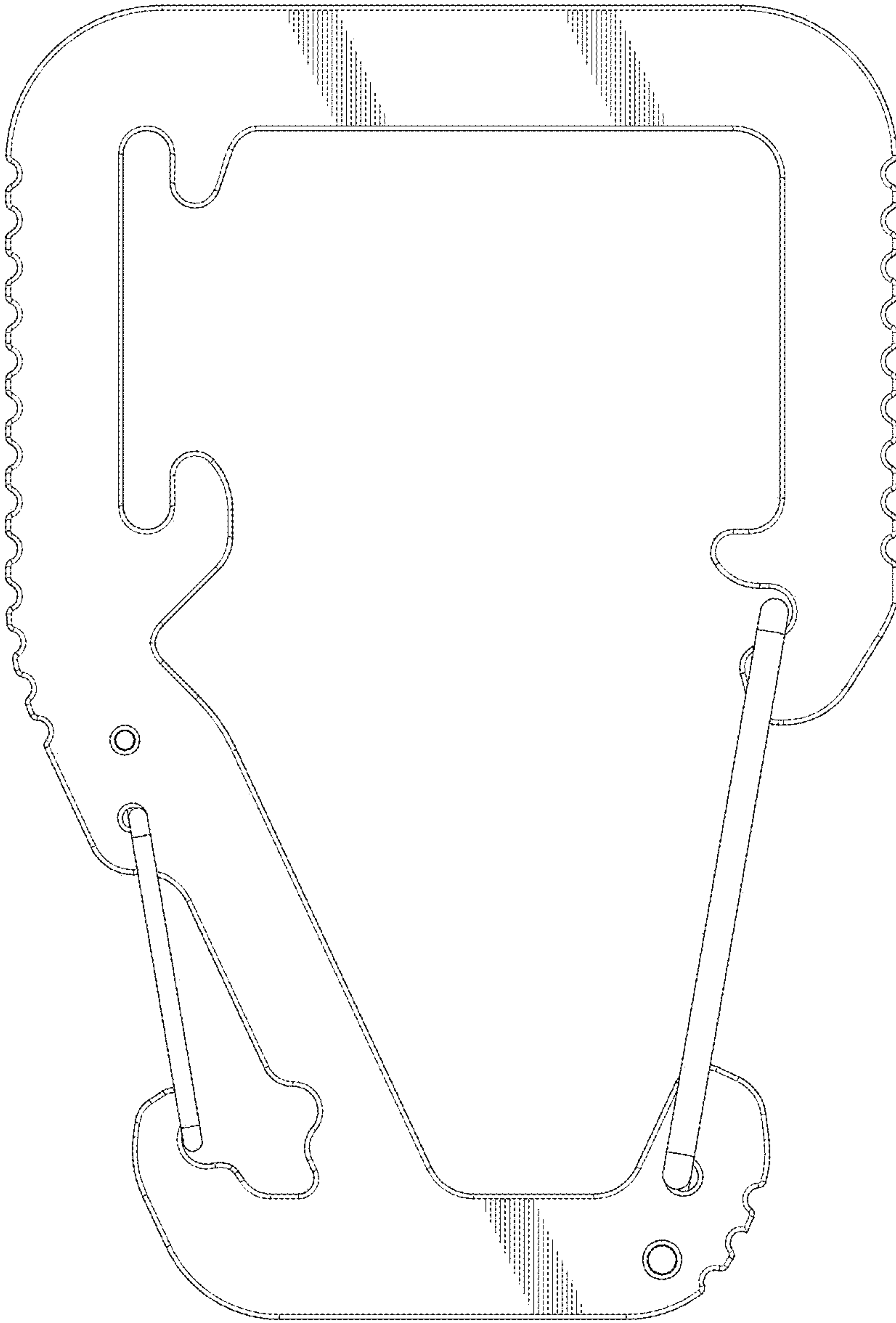

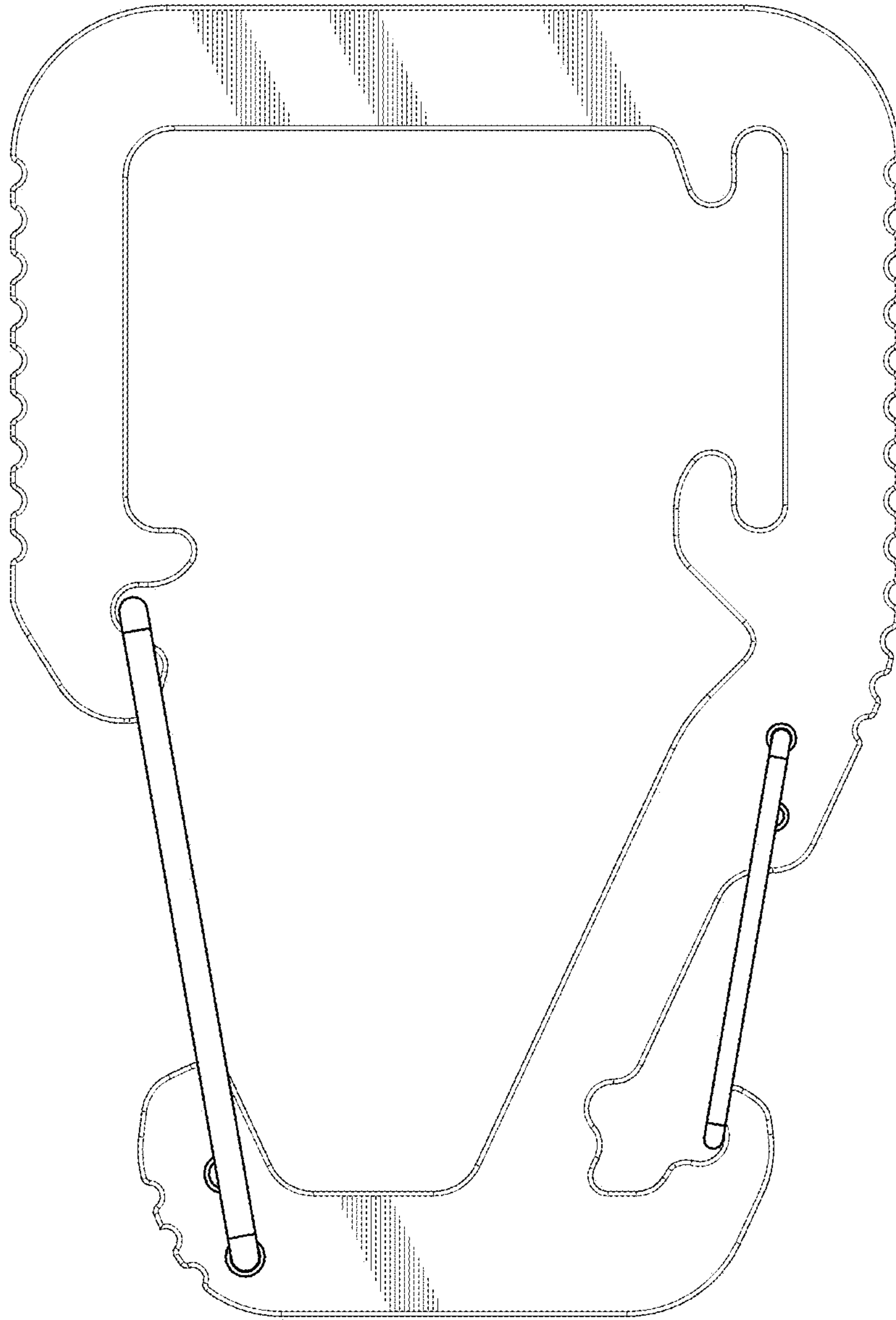

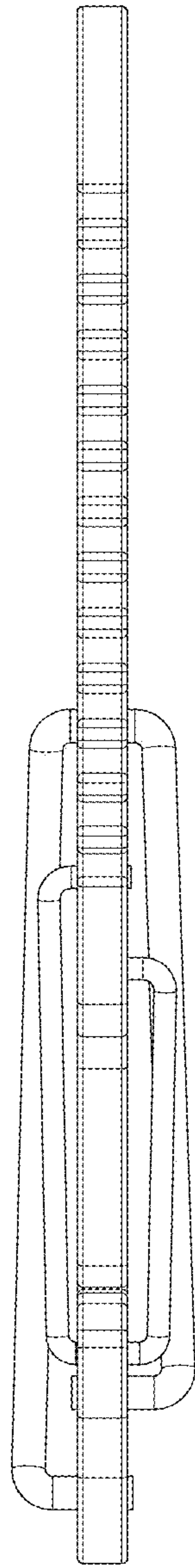

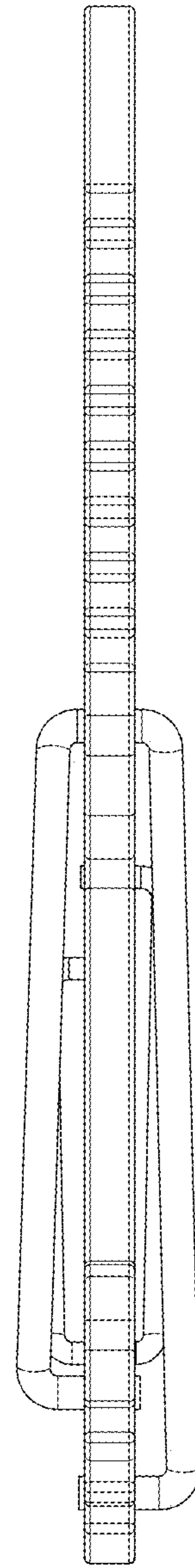

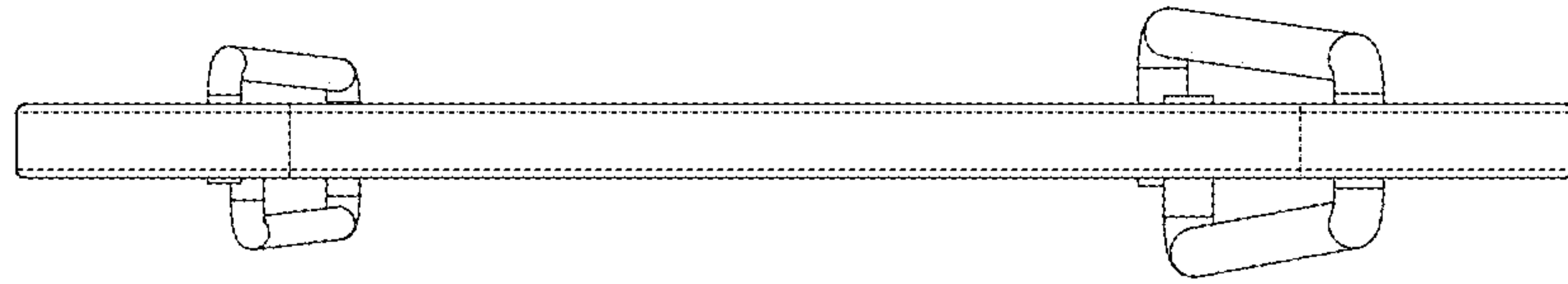

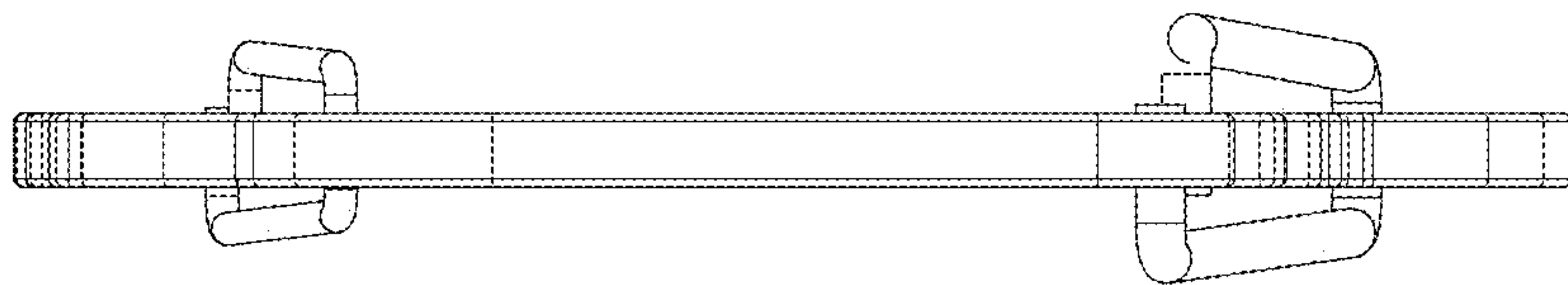
