**DESCRIPTION**

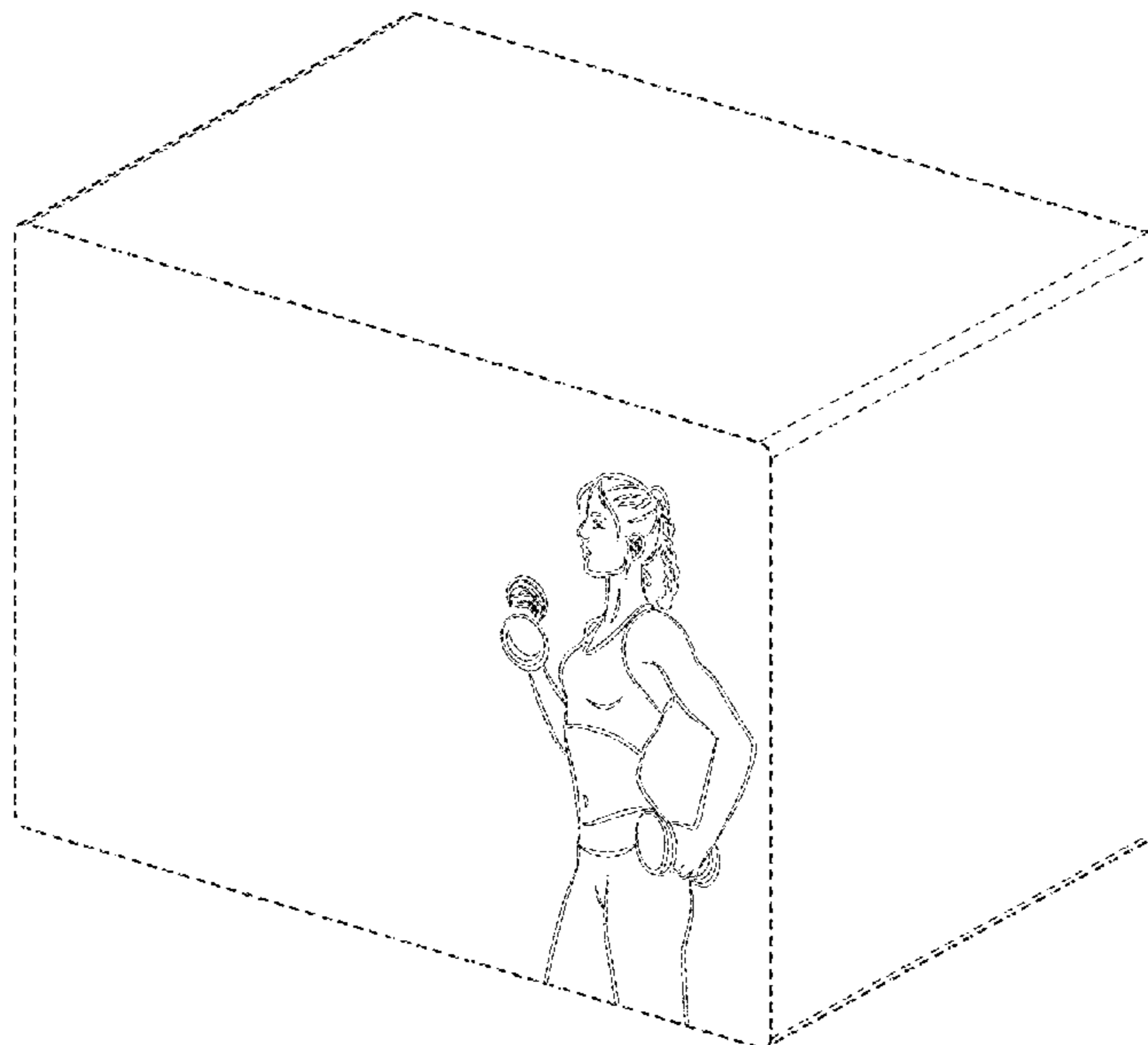
FIG. 1 is a perspective view of a new design for a package for absorbent articles;

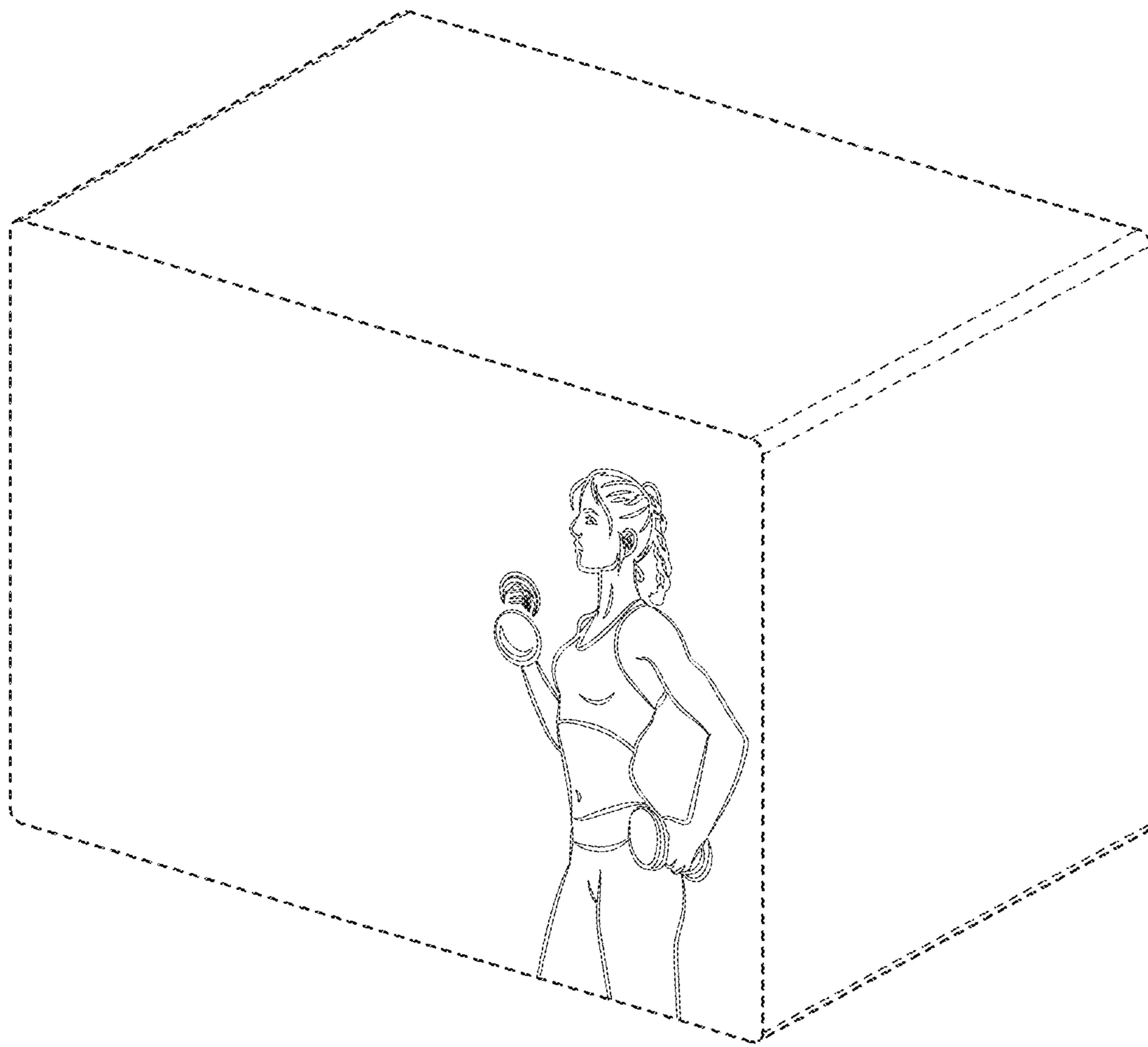

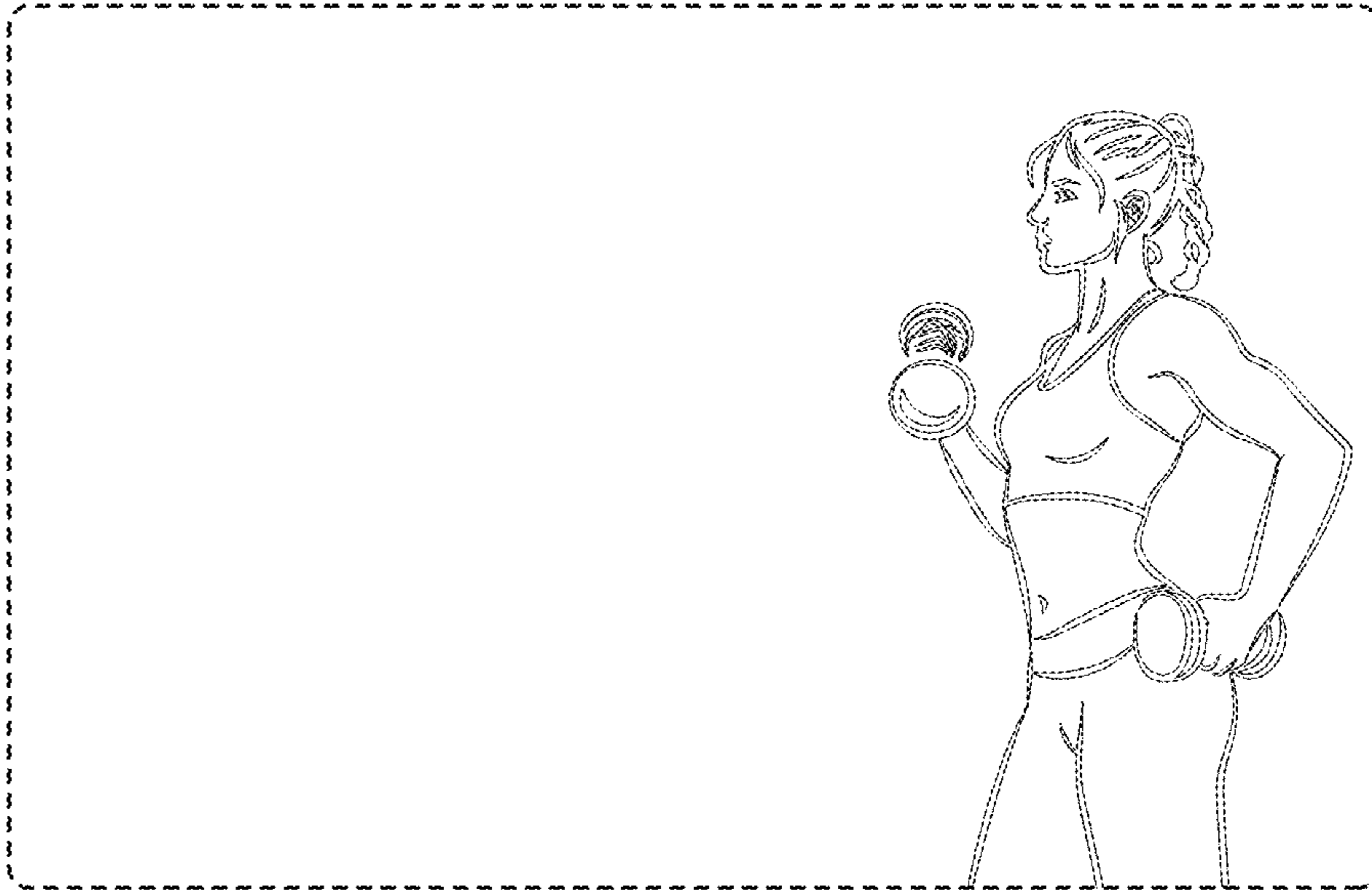

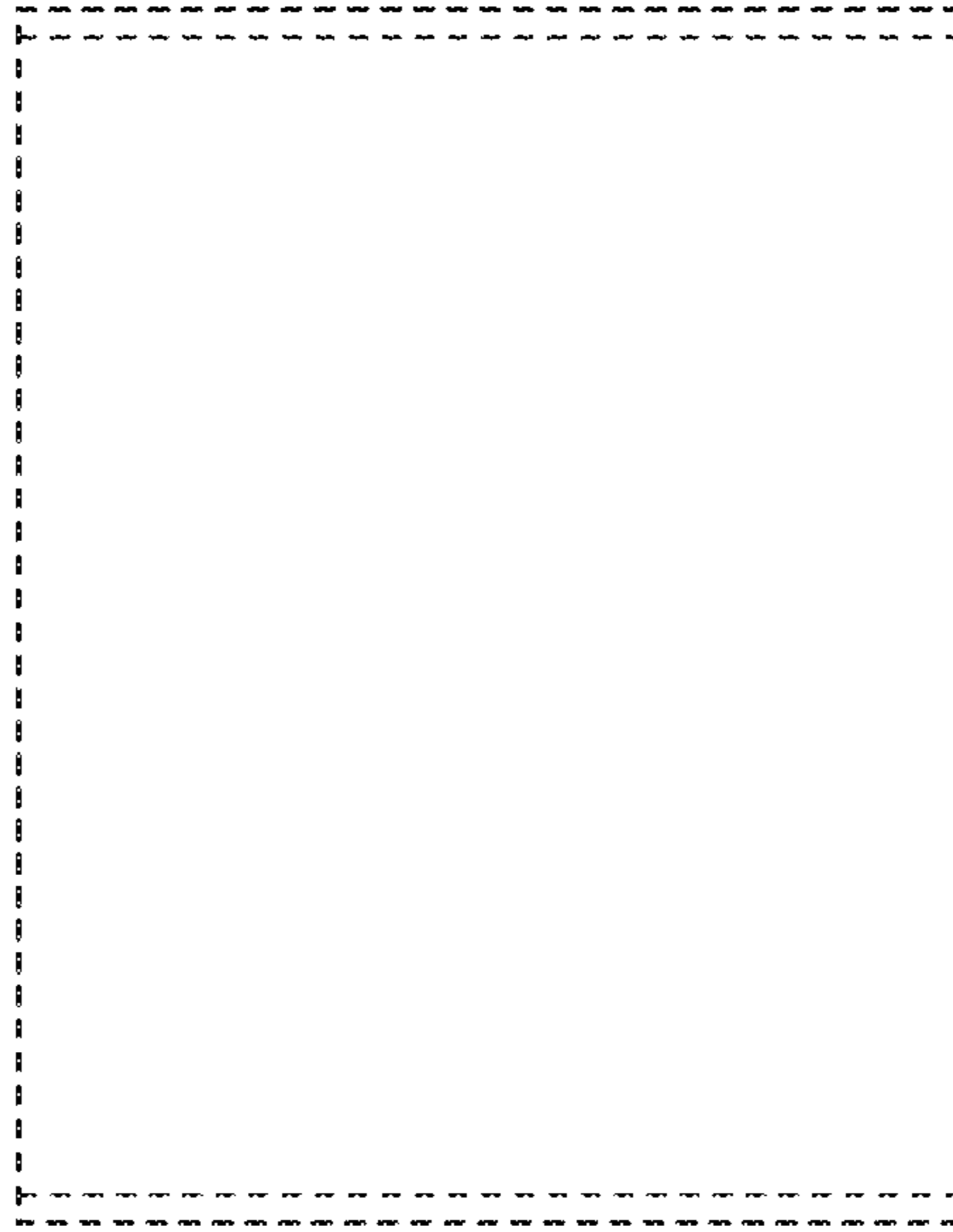

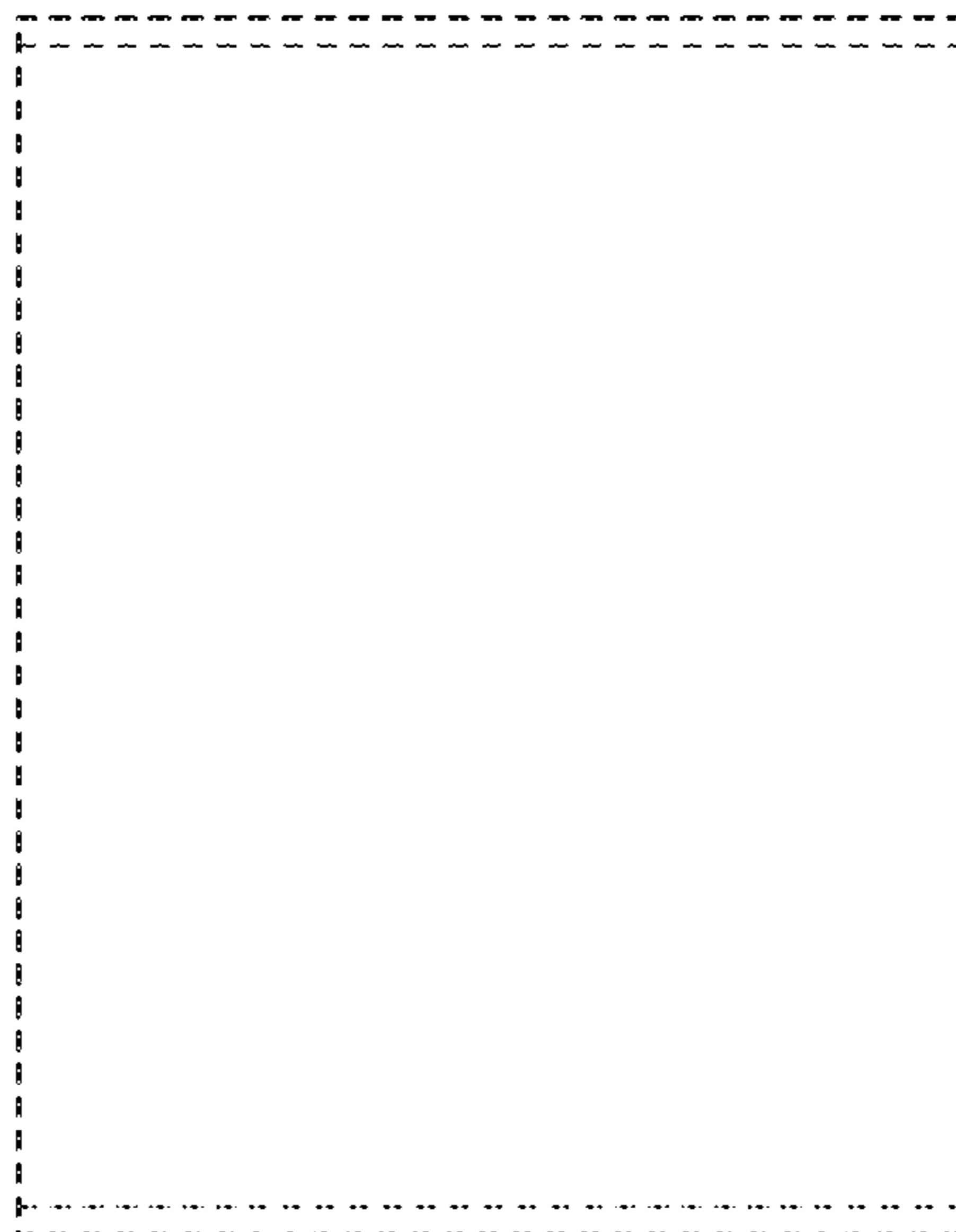
