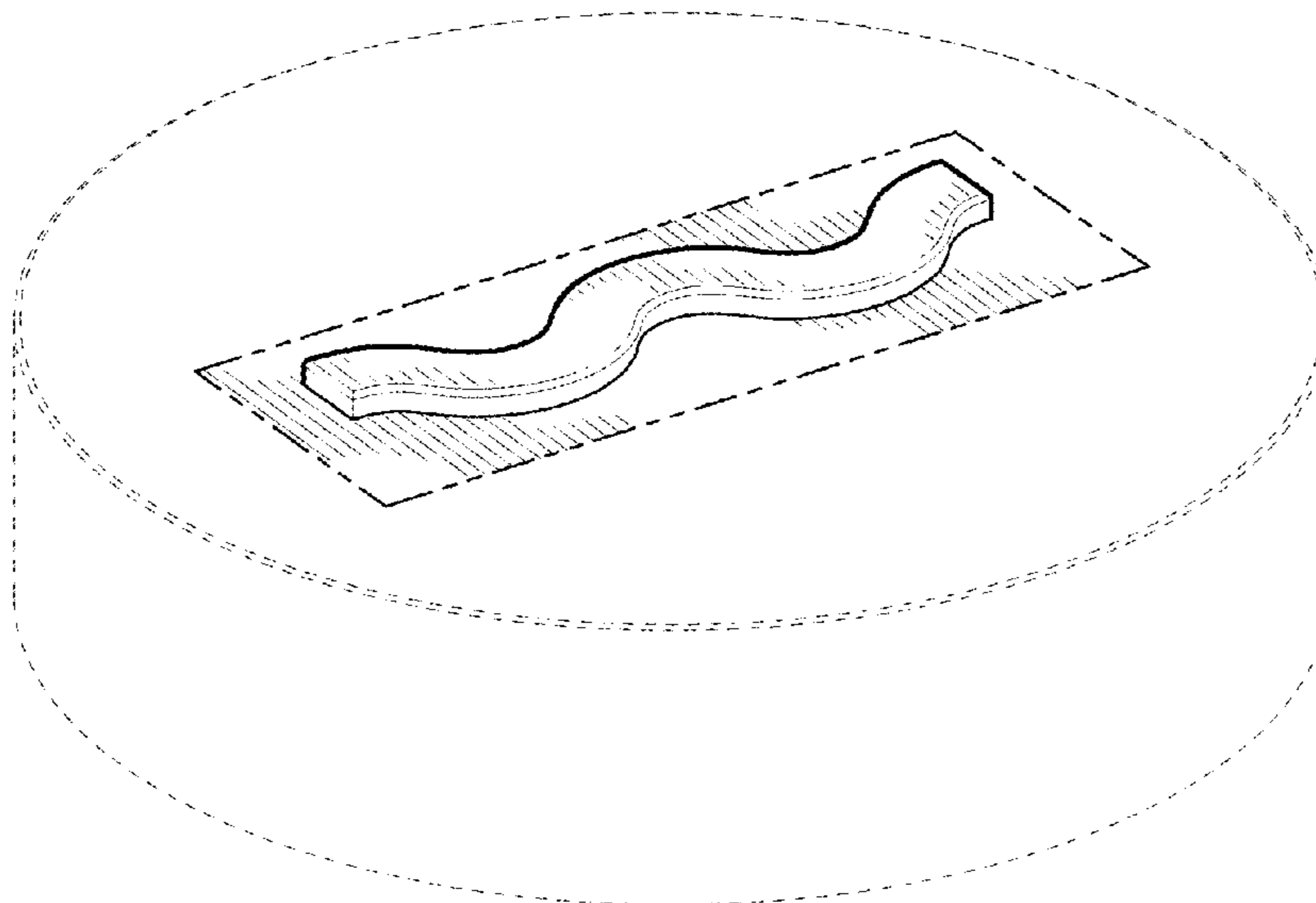
(57) **CLAIM**

The ornamental design for a container cap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a container cap, showing my new design;
FIG. 2 is a top plan view of the container cap shown in FIG. 1;
FIG. 3 is a front view of the container cap shown in FIG. 2;
FIG. 4 is a rear view of the container cap shown in FIG. 2;
FIG. 5 is a right side view of the container cap shown in FIG. 2;
FIG. 6 is a left side view of the container cap shown in FIG. 2;
FIG. 7 is a top perspective view of a second embodiment of a container cap, showing my new design; and,
FIG. 8 is another top perspective view as shown in FIG. 1, showing the container cap in a position of use with an exemplary container.
The evenly broken lines represent both parts of the article as well as environmental subject matter of an exemplary container. The dot-dot-dash lines represent the boundaries of the claim. None of the broken lines form part of the claimed design.

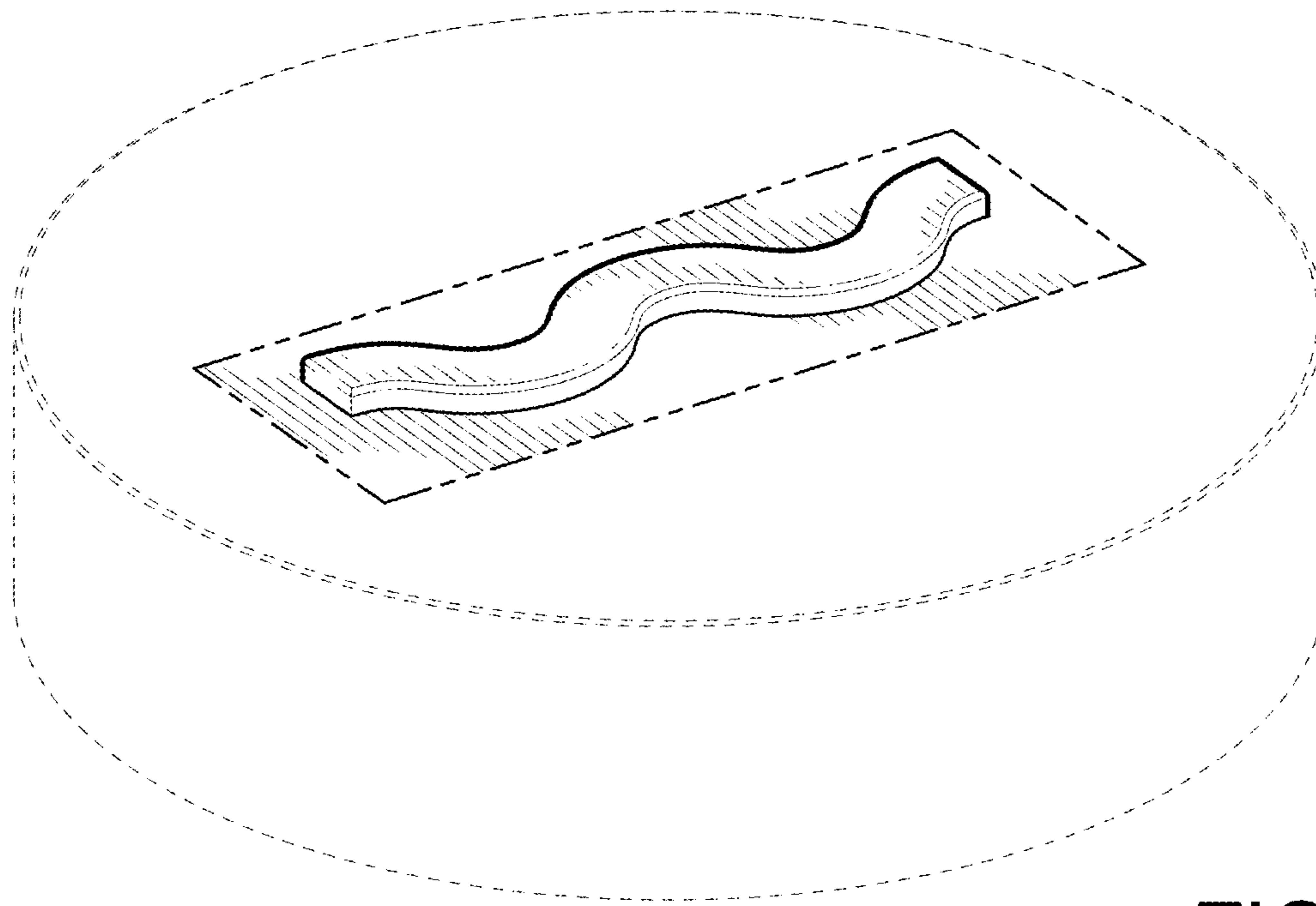

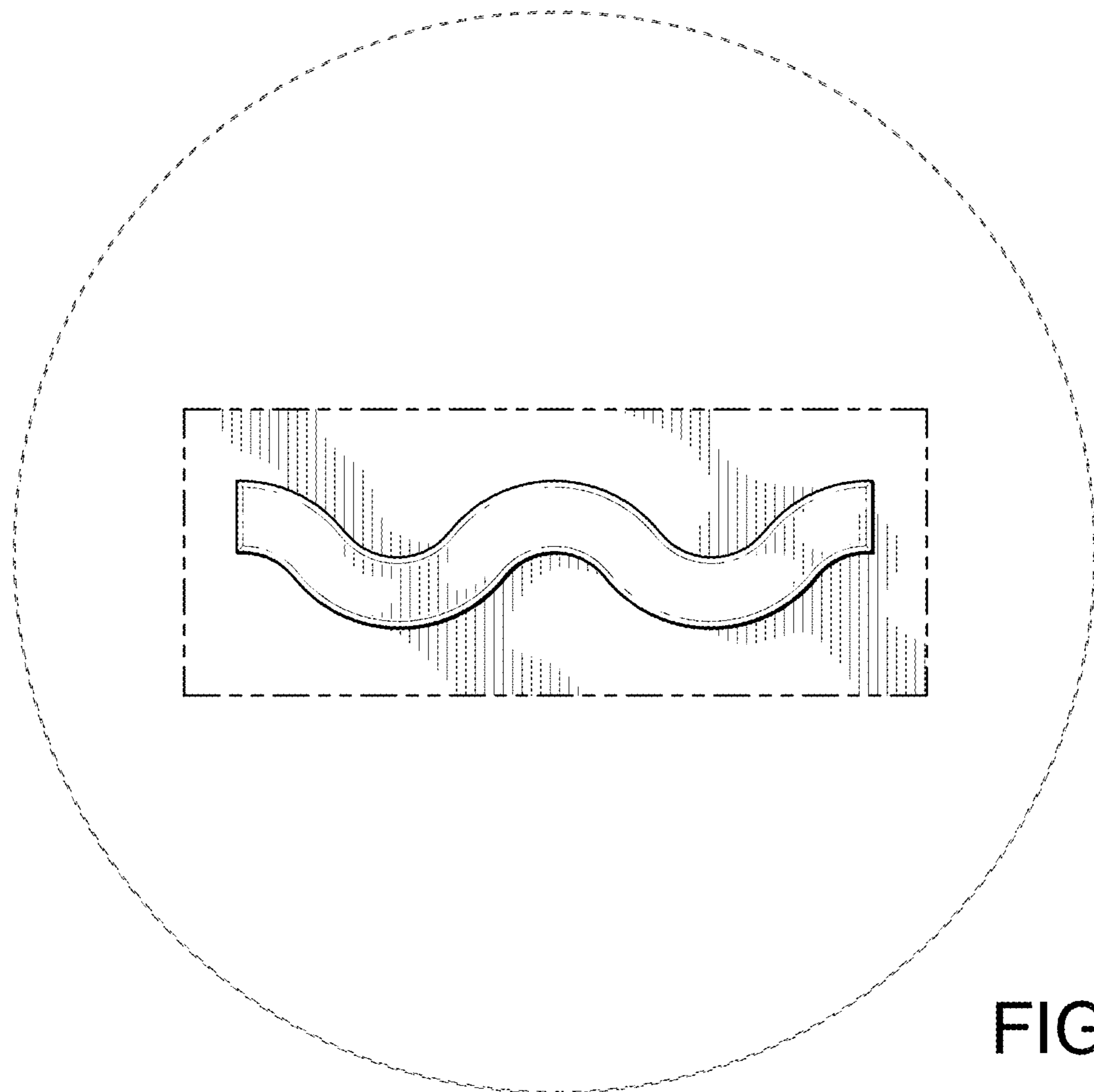

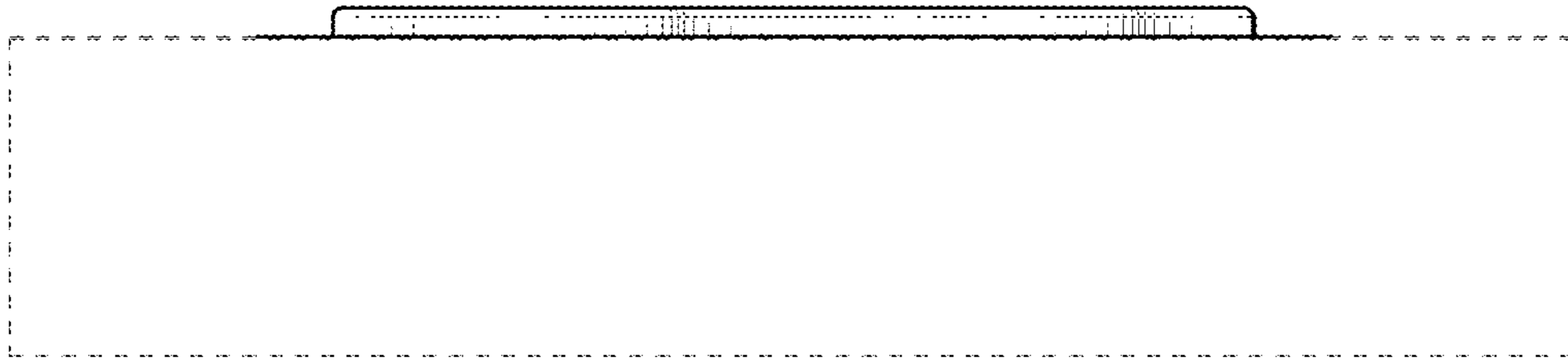

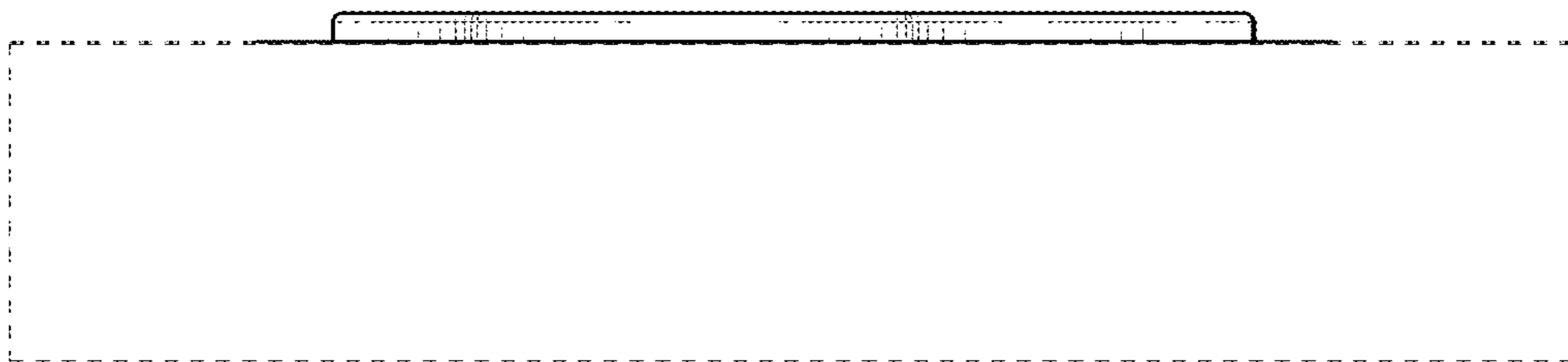

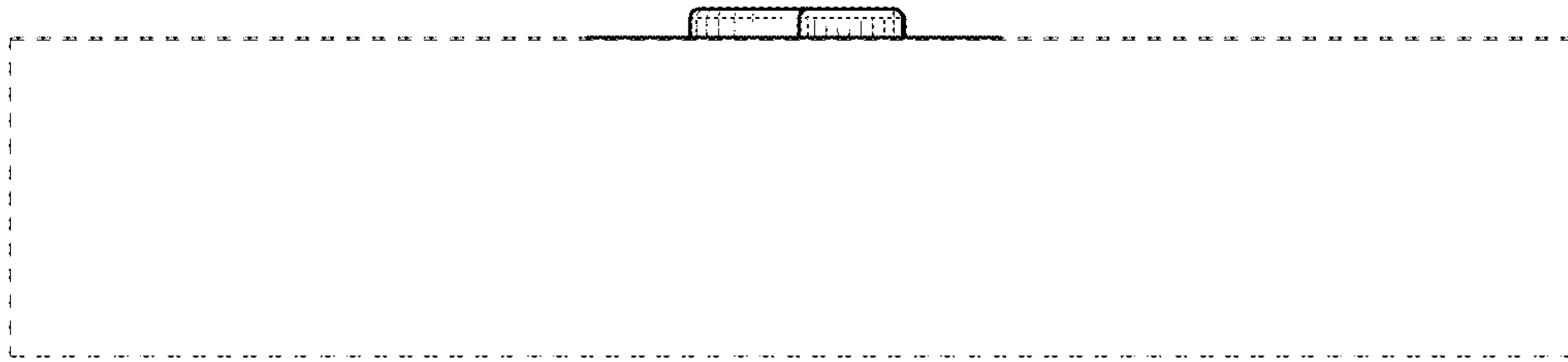

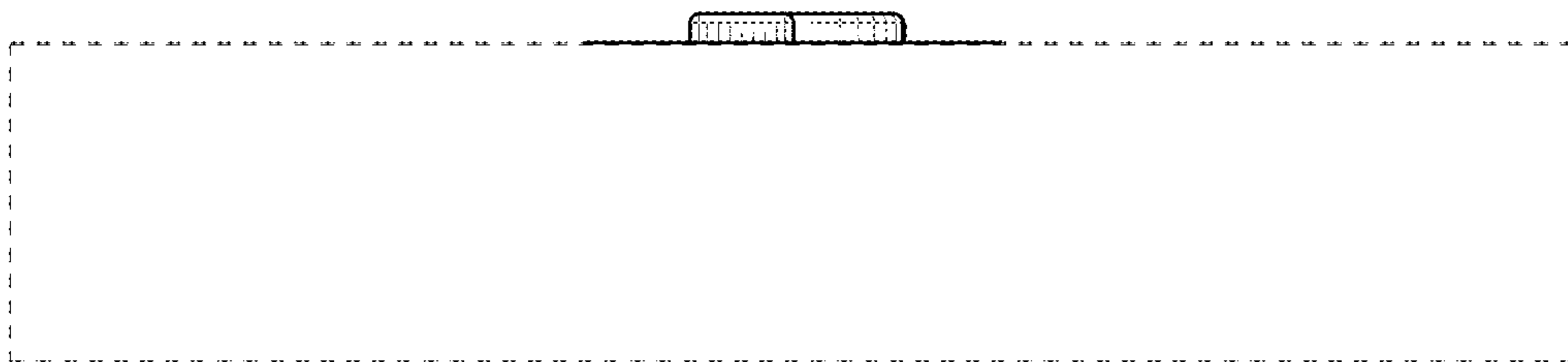

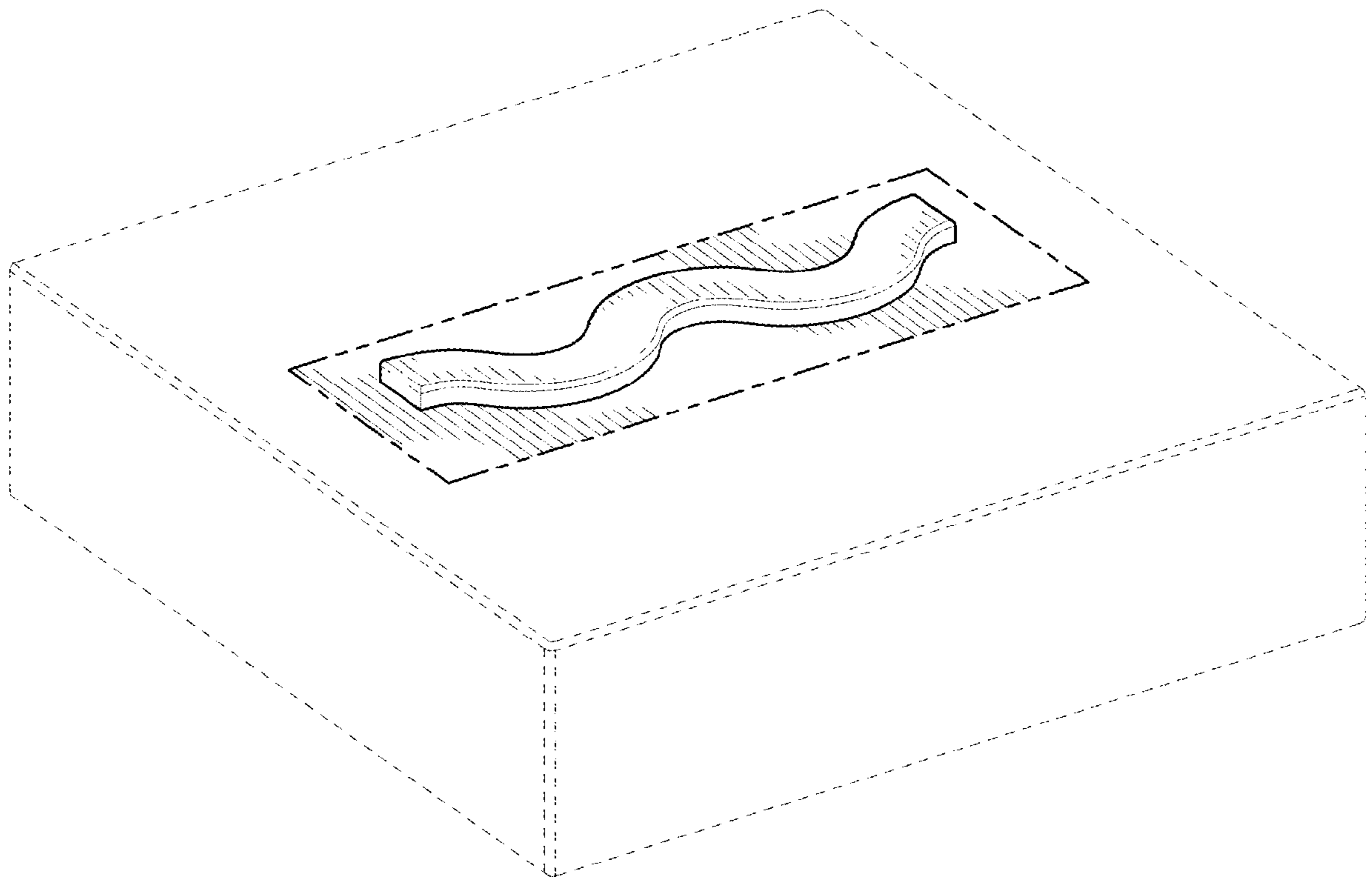

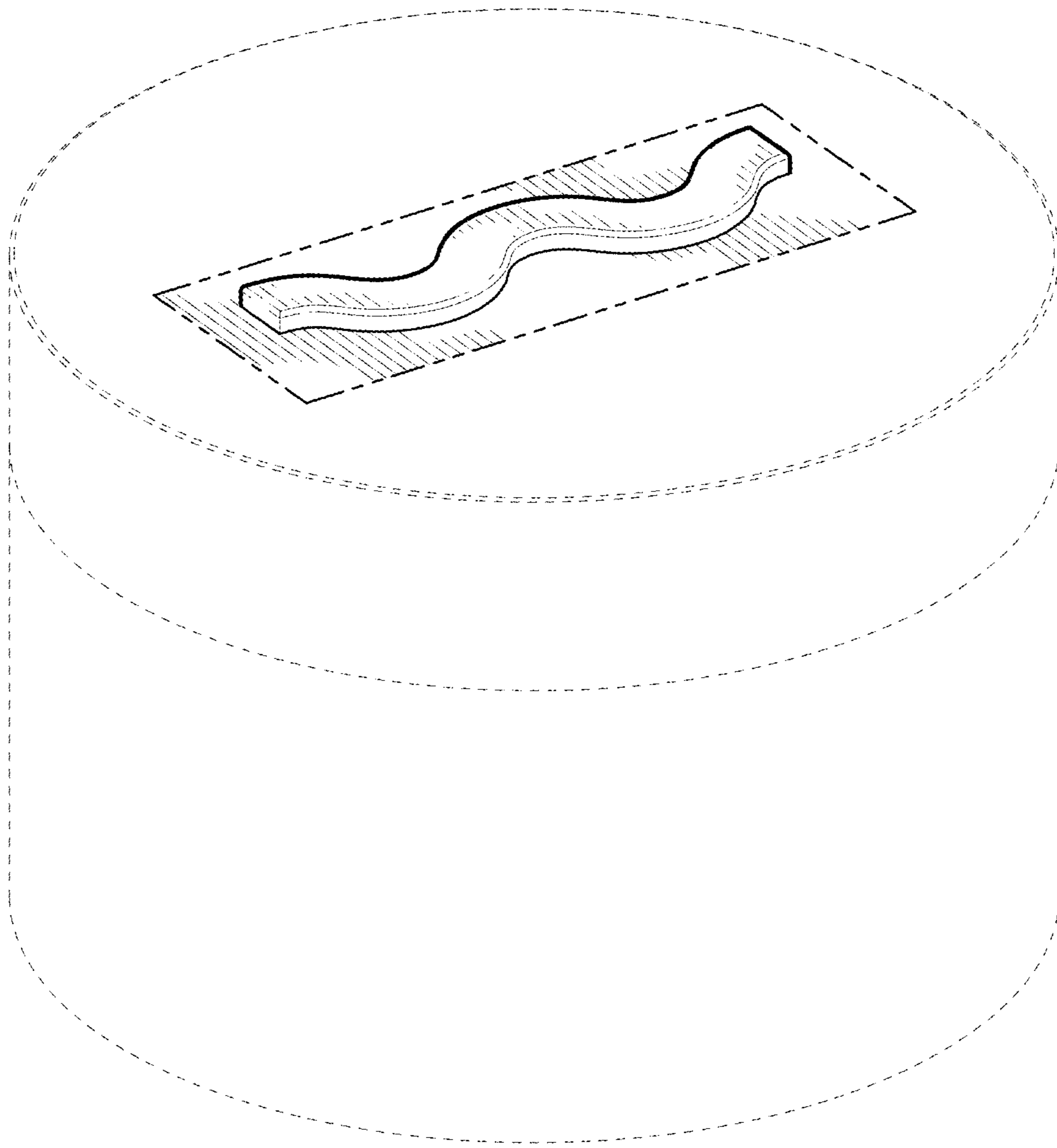
