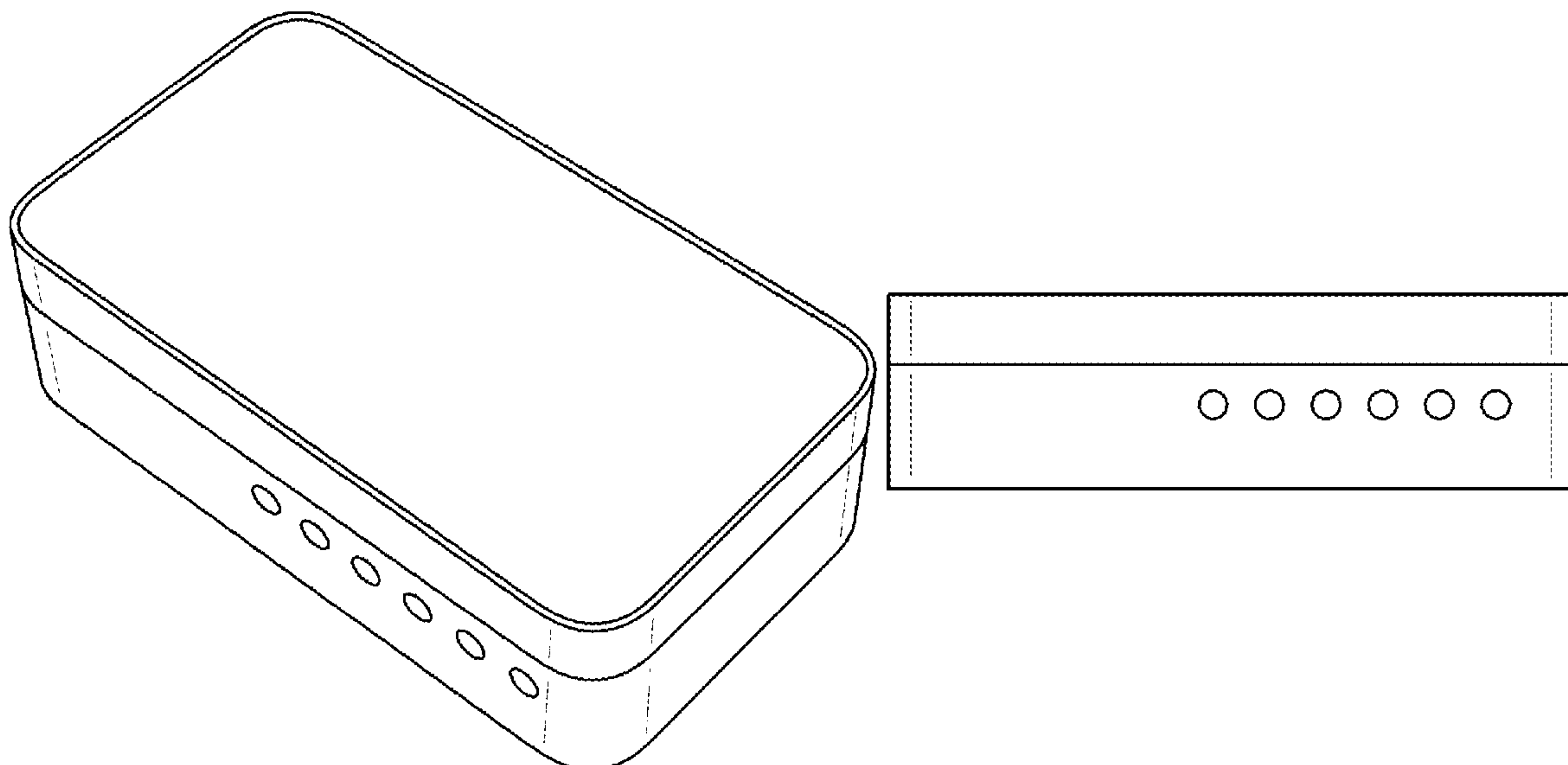
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front side perspective view of a chime unit for a video doorbell showing our new design;

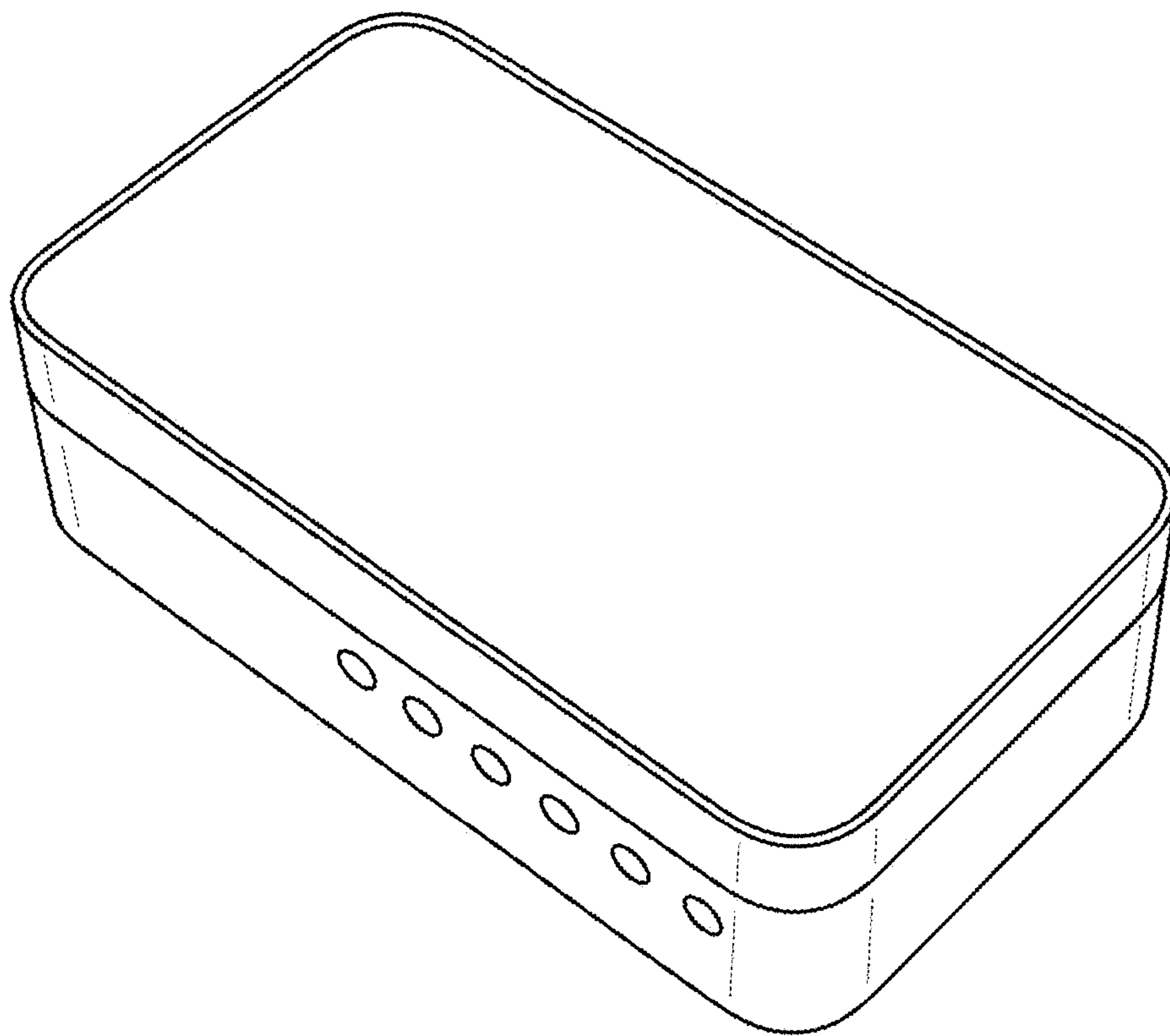

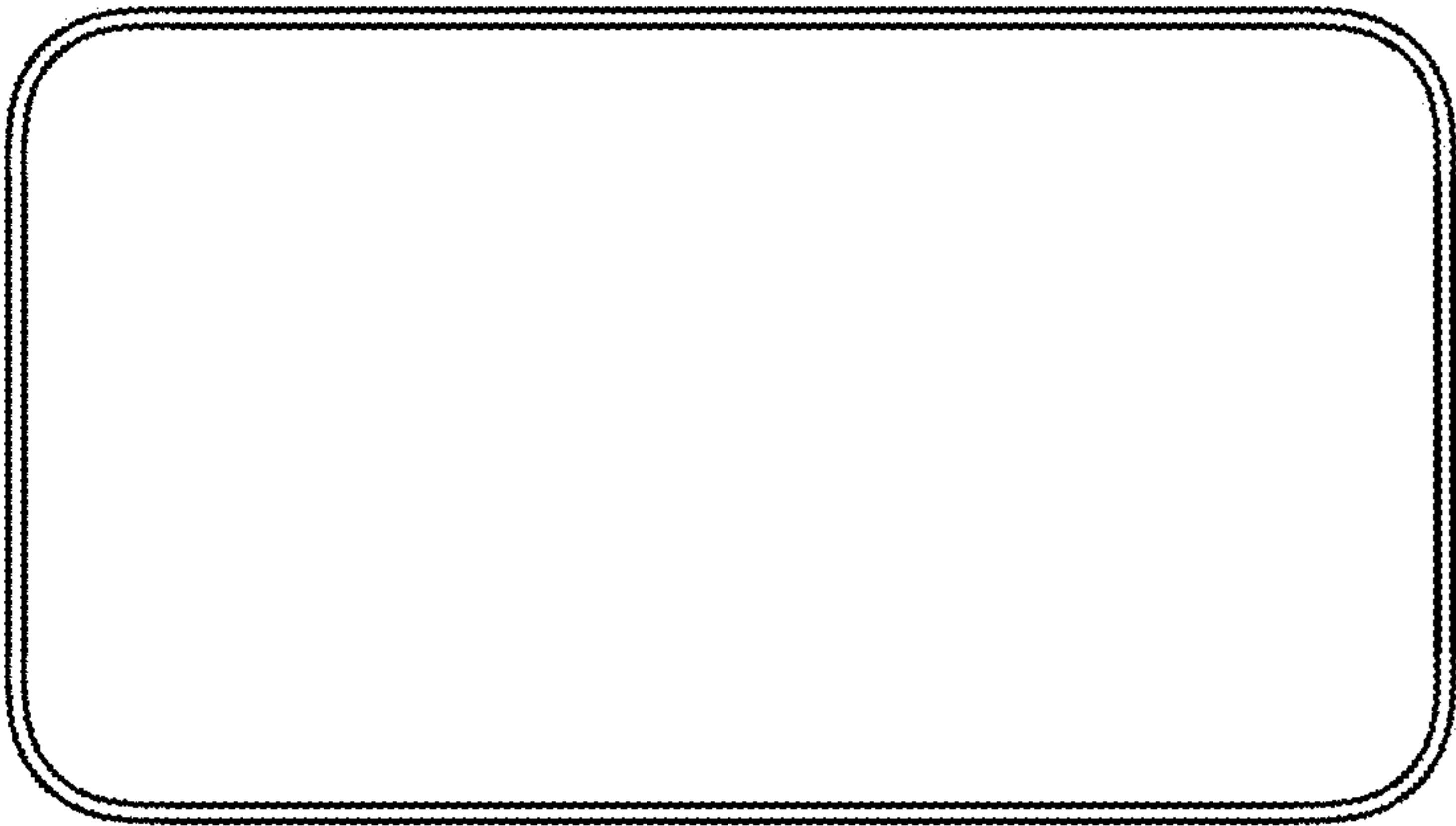

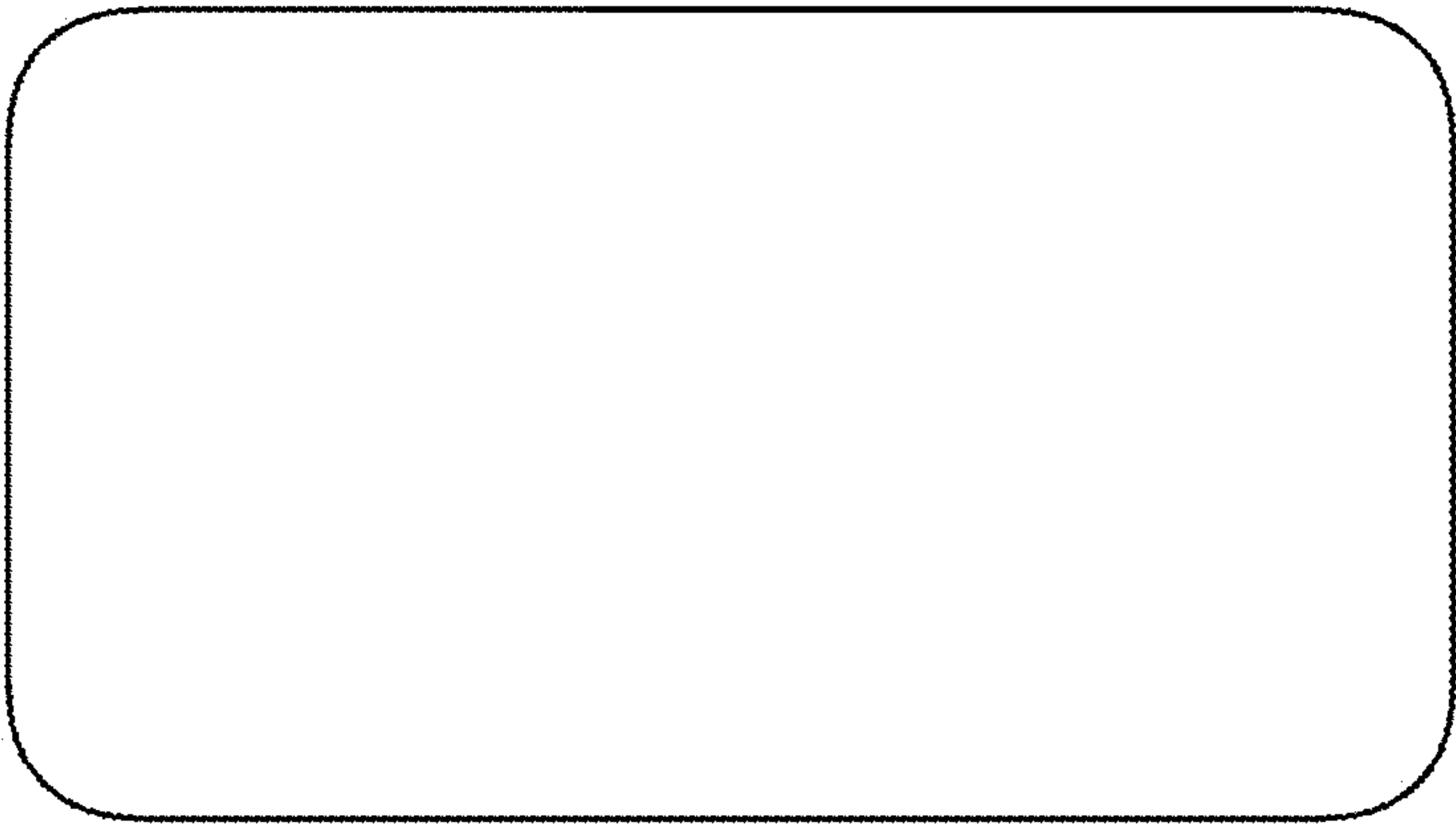

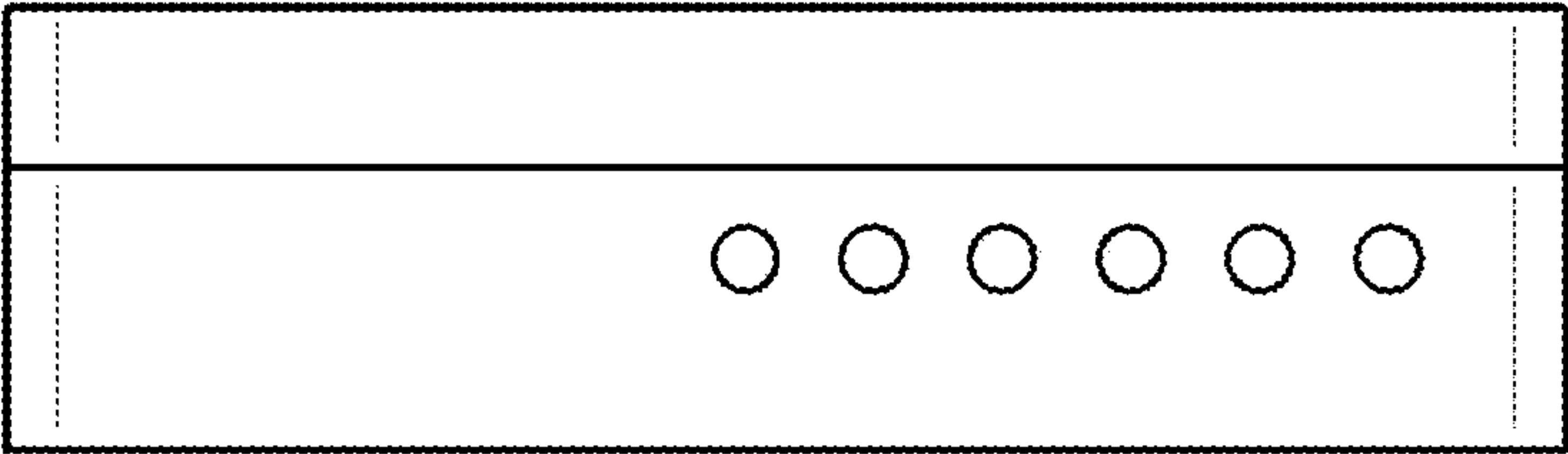

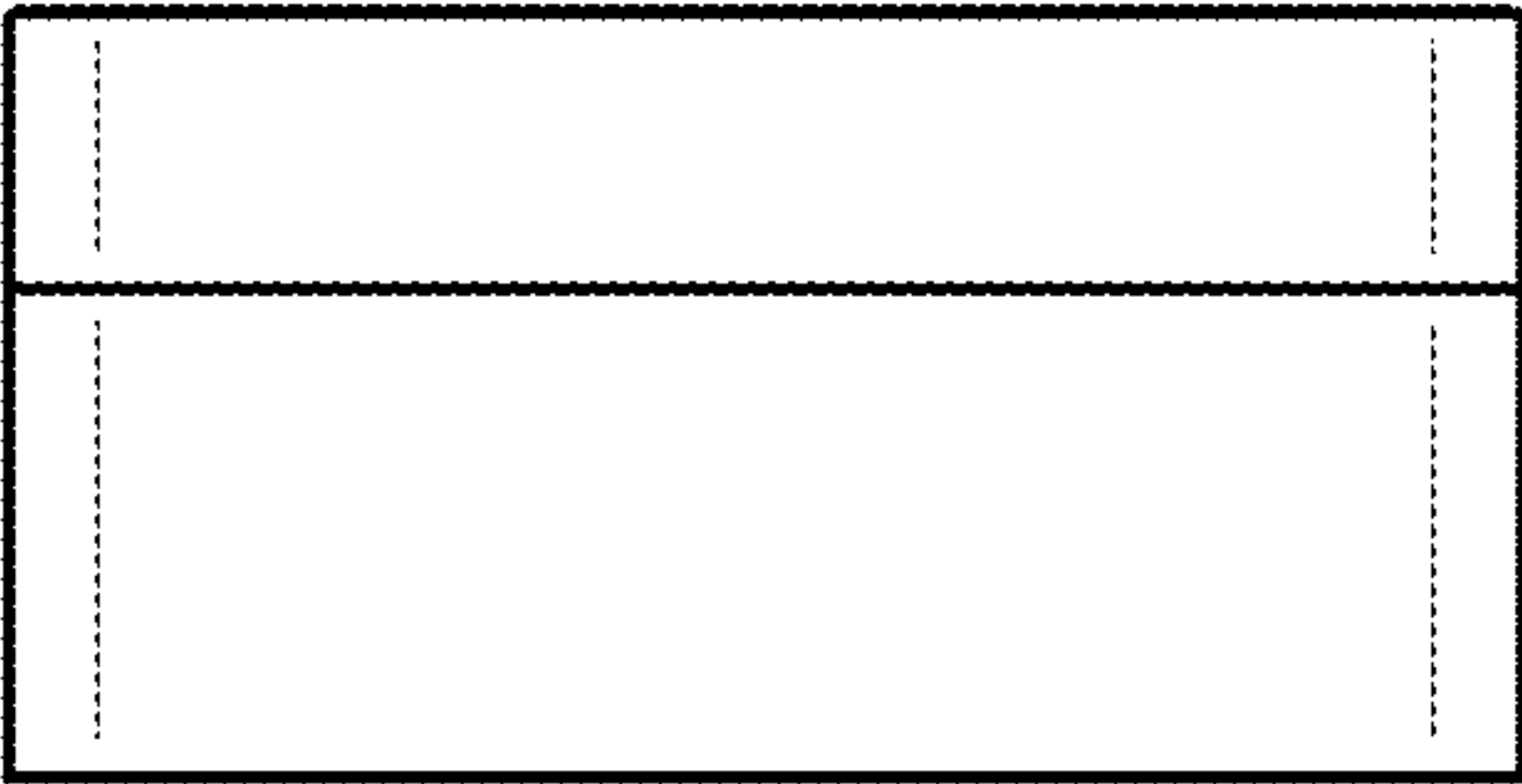

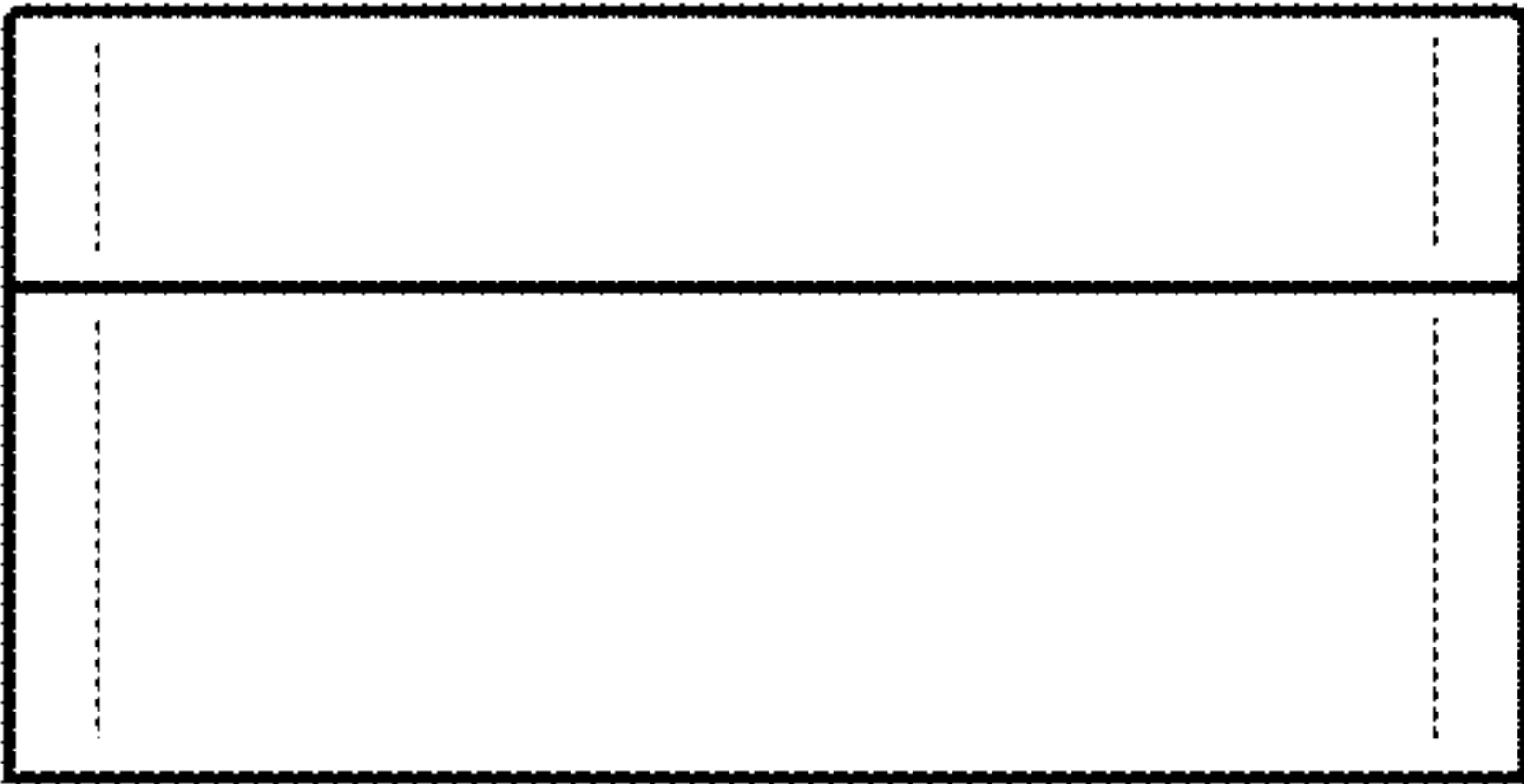
