(57) **CLAIM**

The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle wheel, toy vehicle wheel, and/or replicas thereof according to the design; FIG. 2 is an additional perspective view thereof; FIG. 3 is an additional perspective view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof in a lighter grey scale representing portions of the wheel that form no part of the claimed design; and, FIG. 6 is a side view thereof.

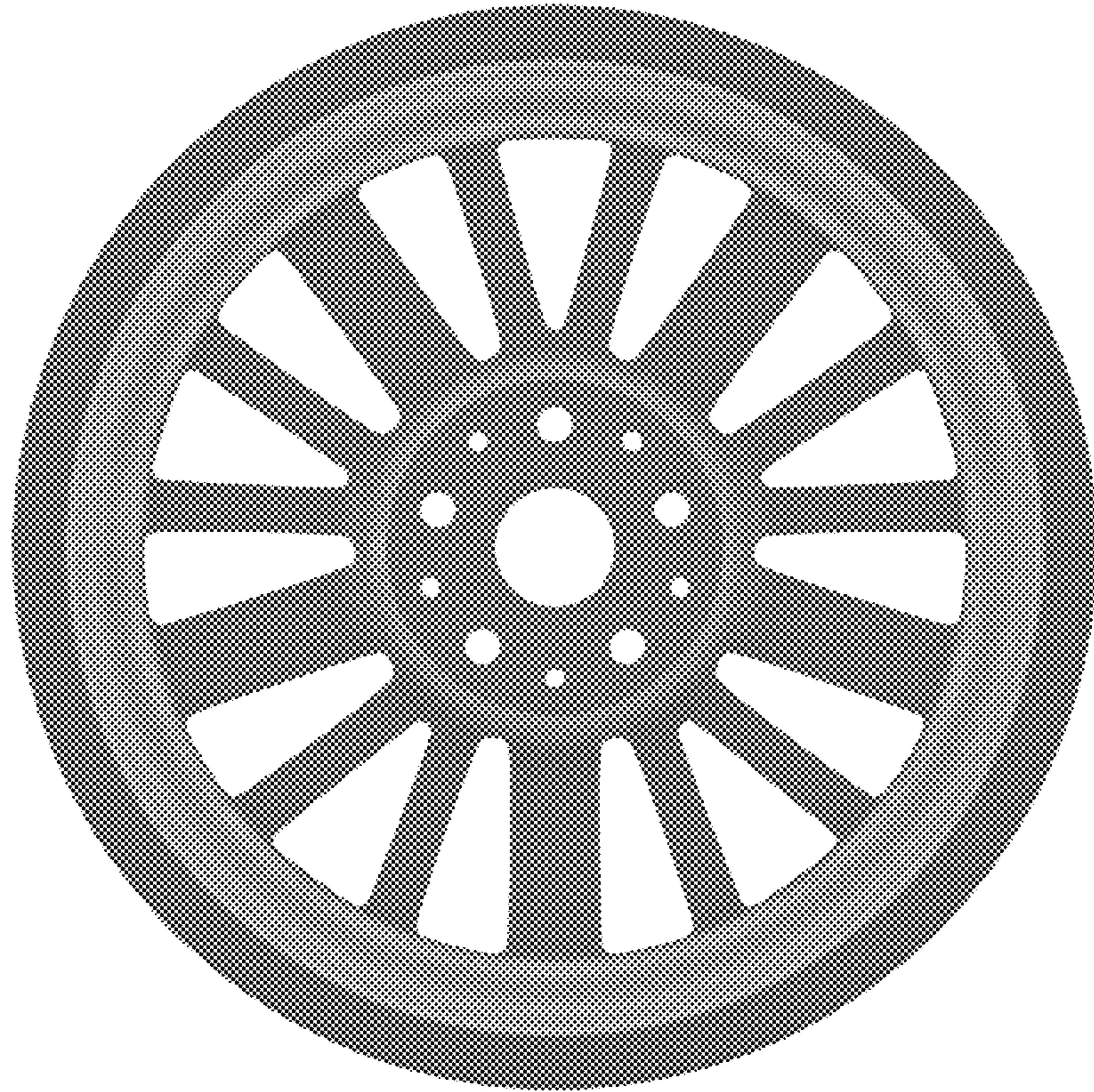

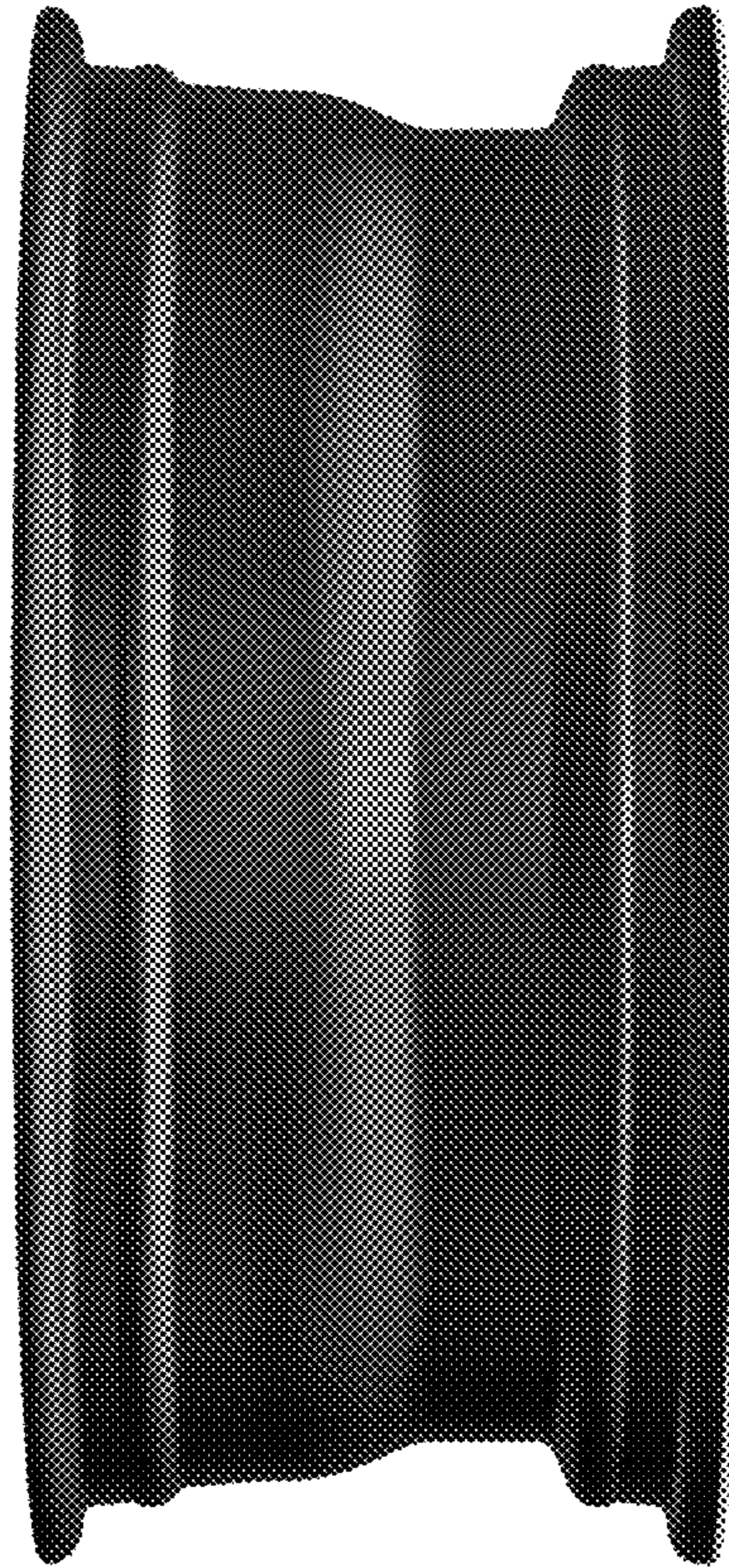
