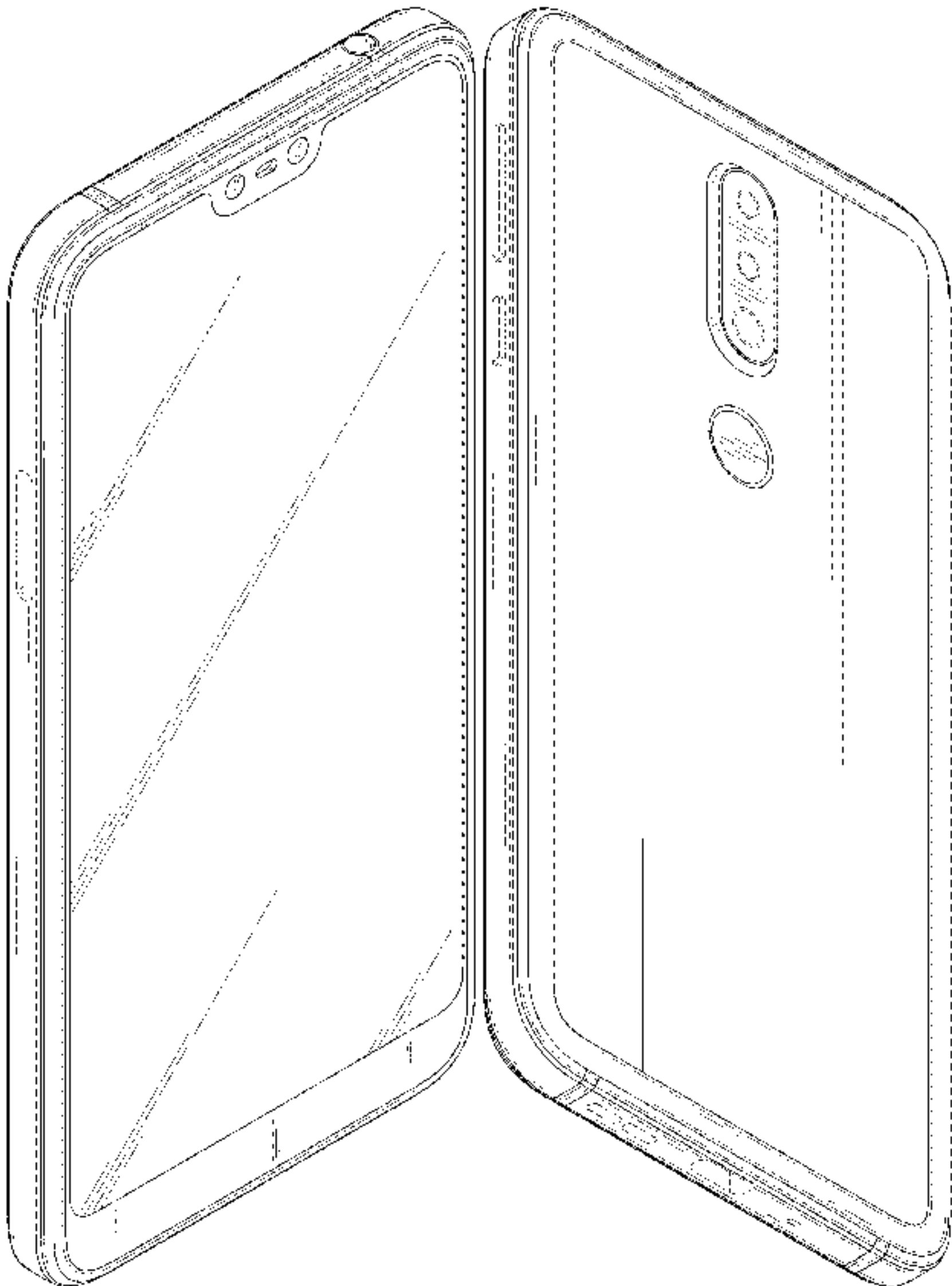
(57) CLAIM

We claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone, showing our new design.
FIG. 2 is a rear perspective view of the mobile phone shown in FIG. 1;
FIG. 3 is a front elevation view of the mobile phone shown in FIG. 1;
FIG. 4 is a rear elevation view of the mobile phone shown in FIG. 1;
FIG. 5 is a left side elevation view of the mobile phone shown in FIG. 1;
FIG. 6 is a right side elevation view of the mobile phone shown in FIG. 1;
FIG. 7 is a top plan view of the mobile phone shown in FIG. 1; and,
FIG. 8 is a bottom plan view of the mobile phone shown in FIG. 1.

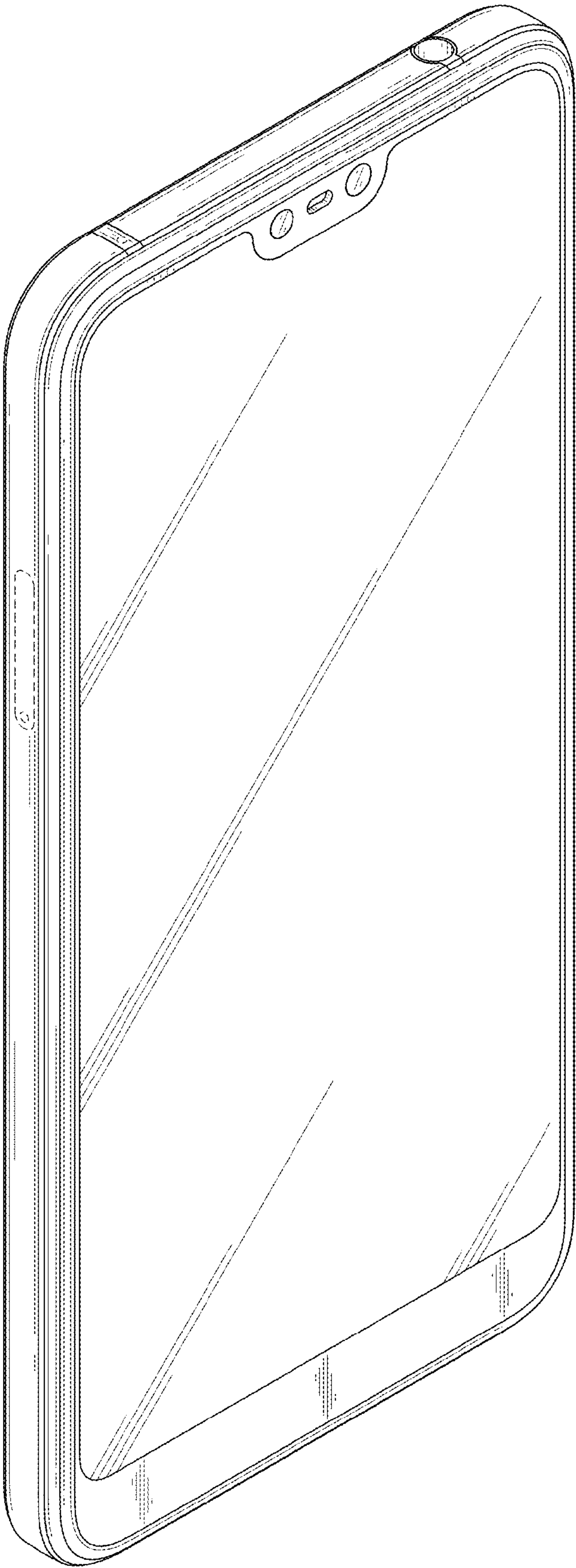

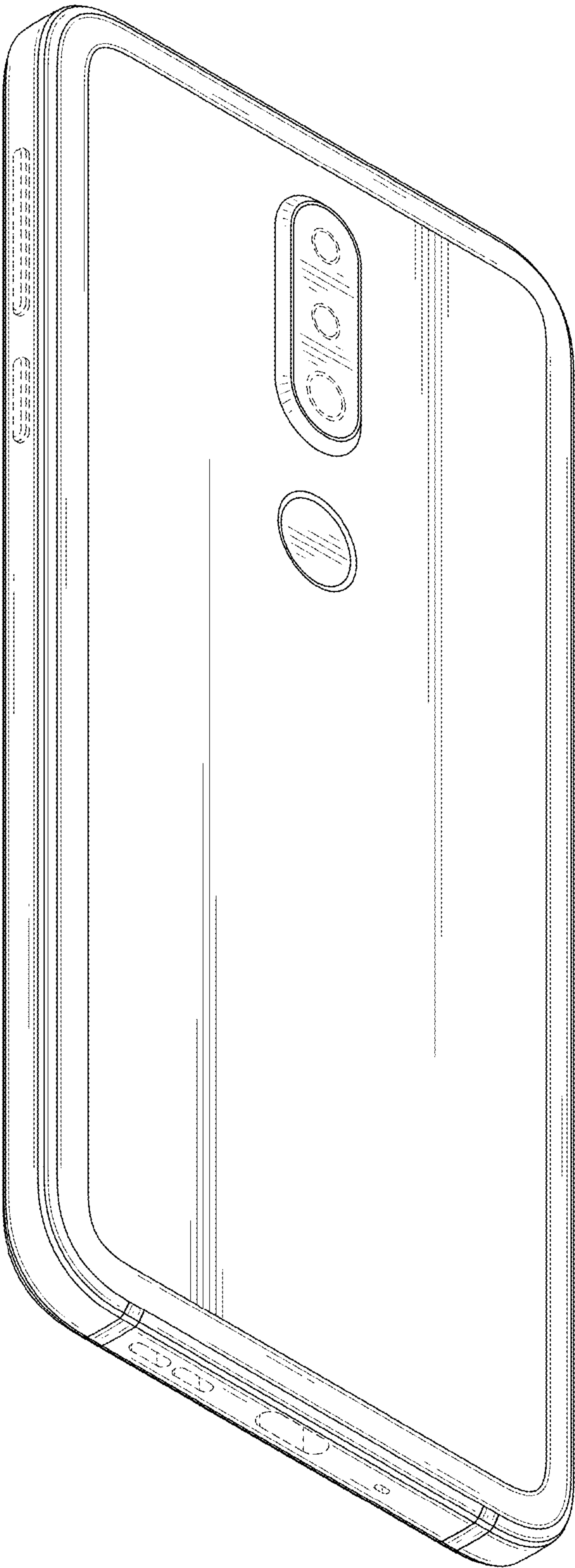

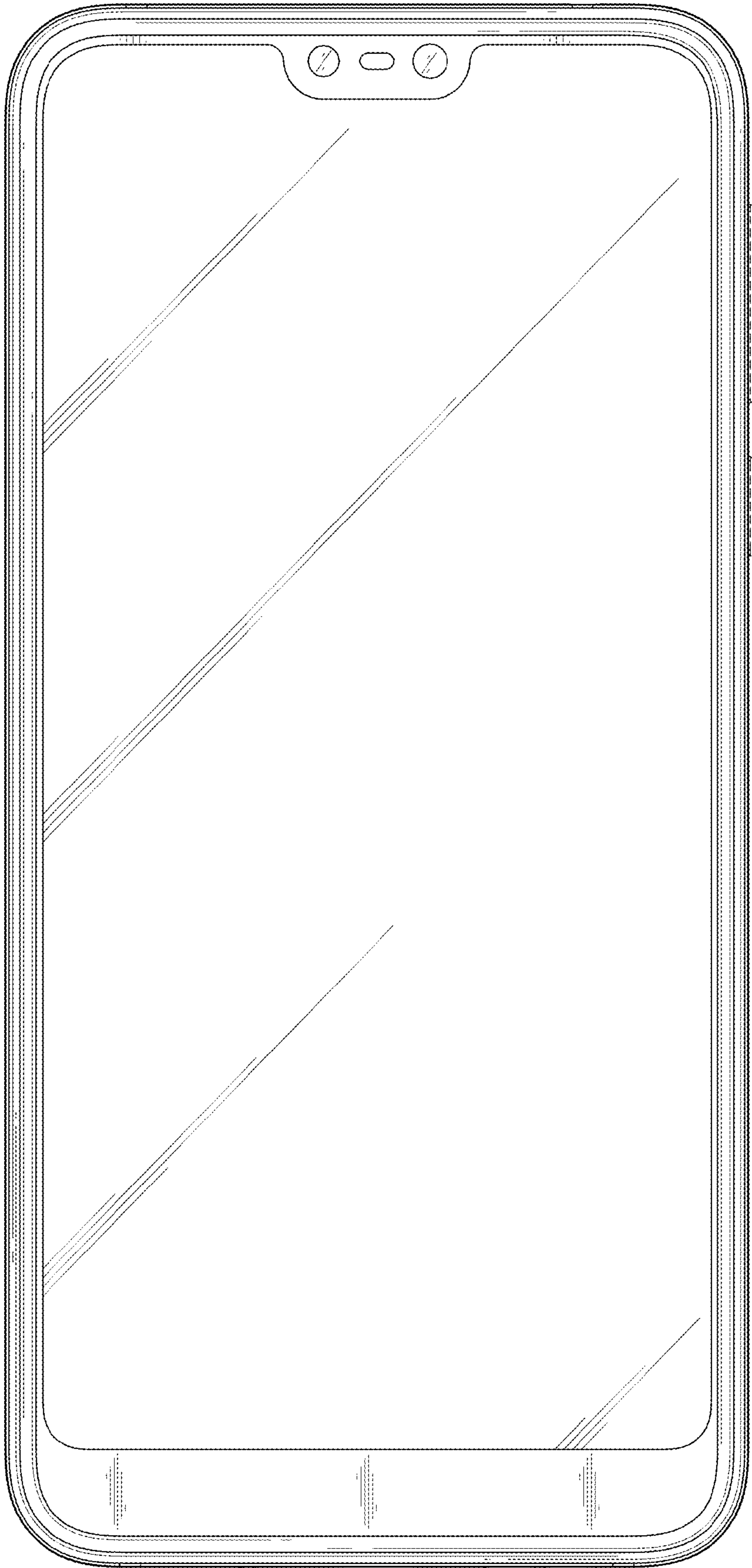

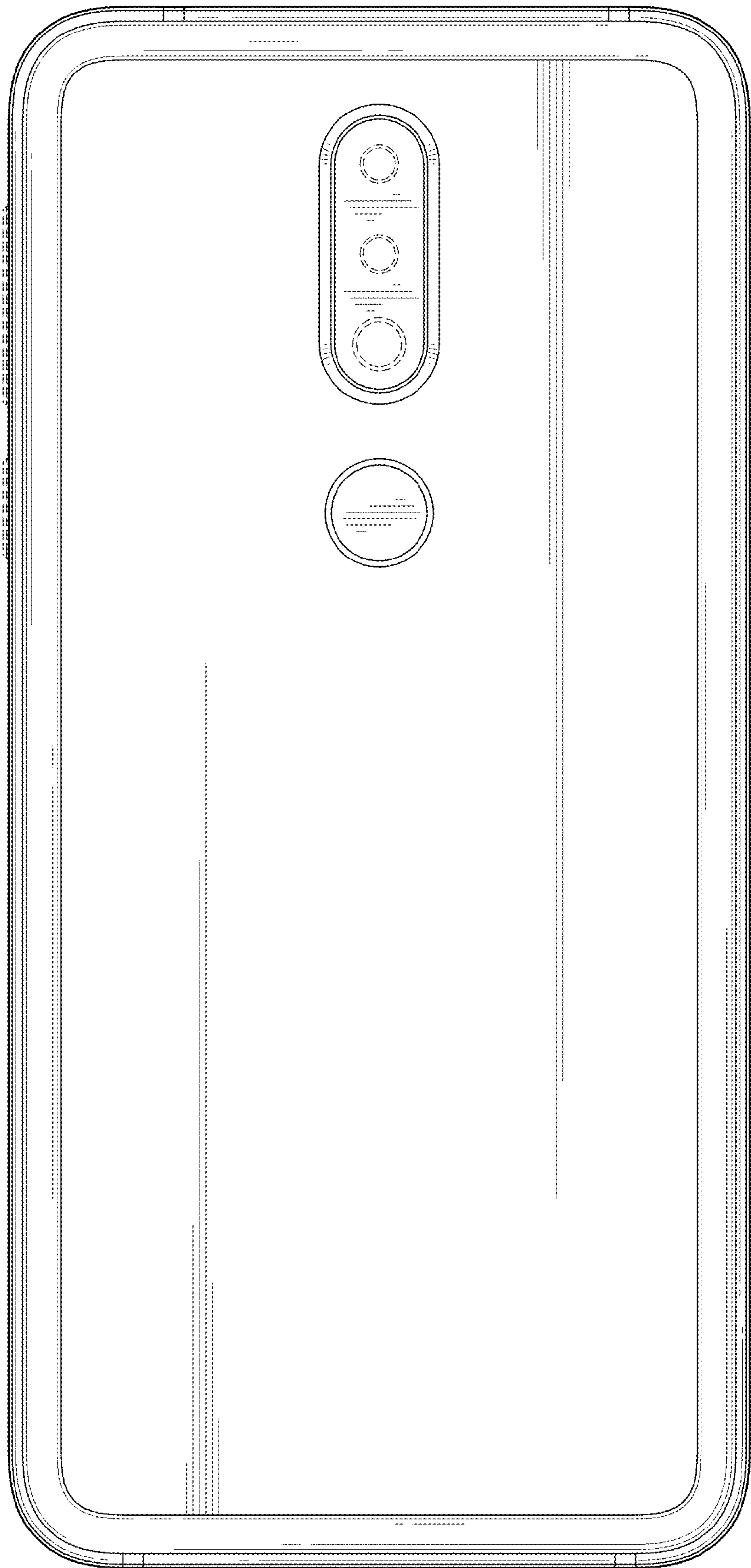

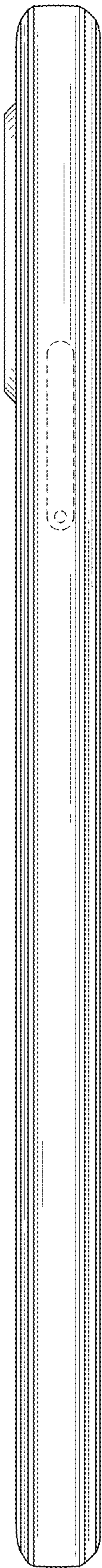

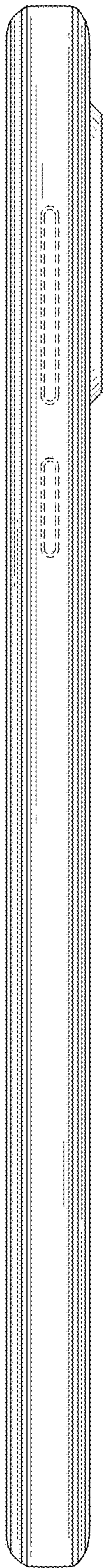

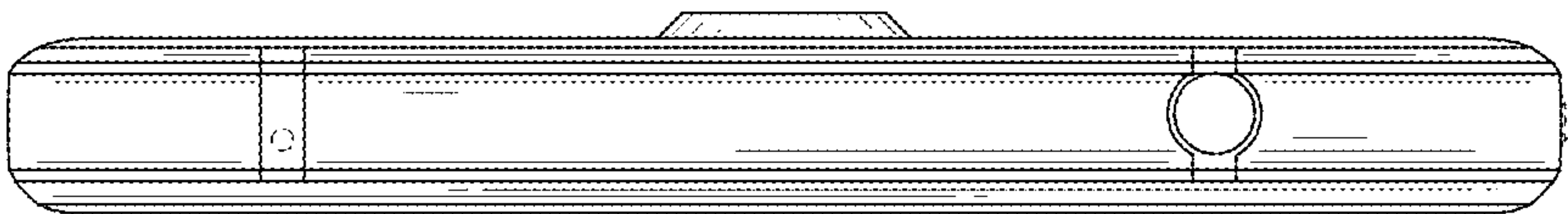

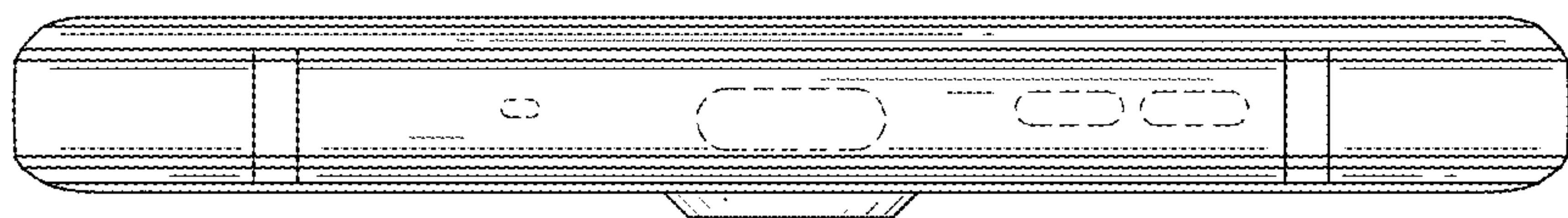
