The appearance of the transitional icon sequentially transitions between the images shown in FIGS. 1-10. The process or period in which one image transitions to another image forms no part of the claimed design.

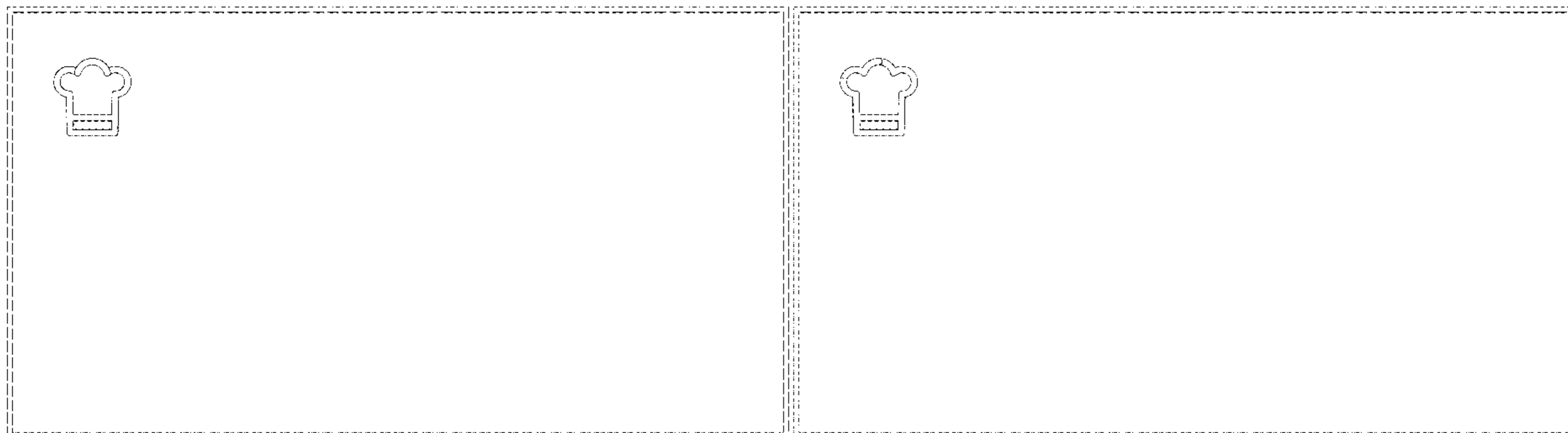

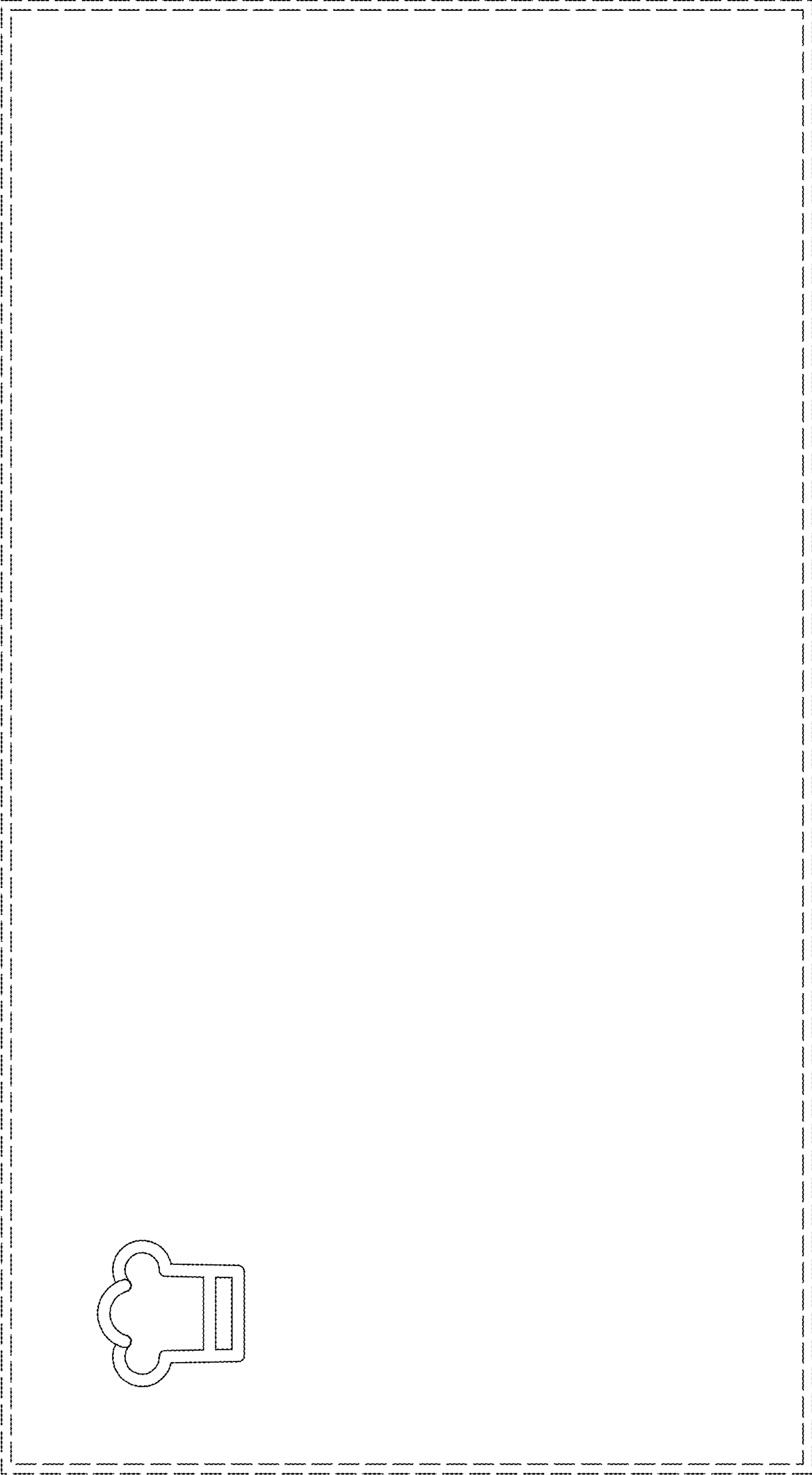

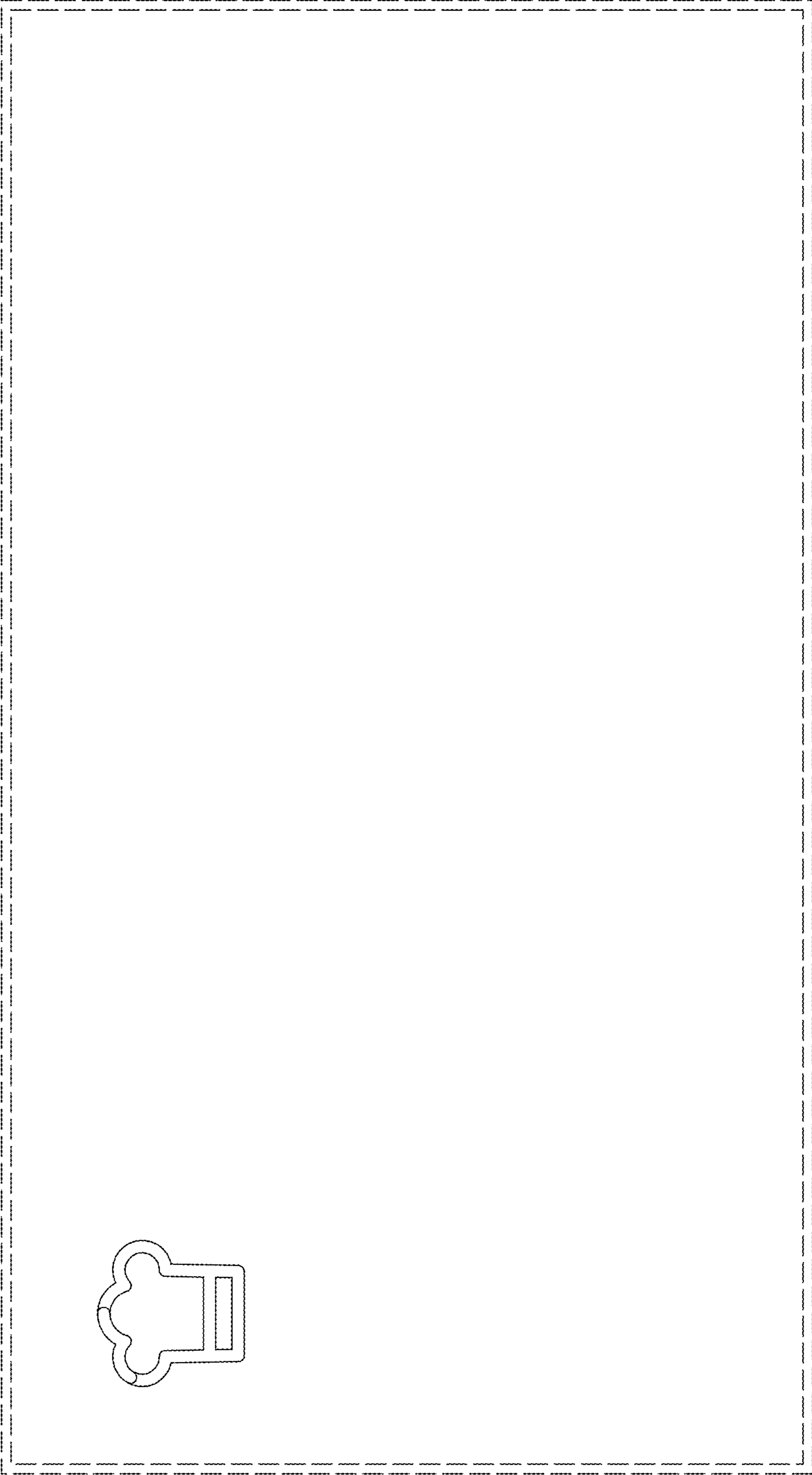

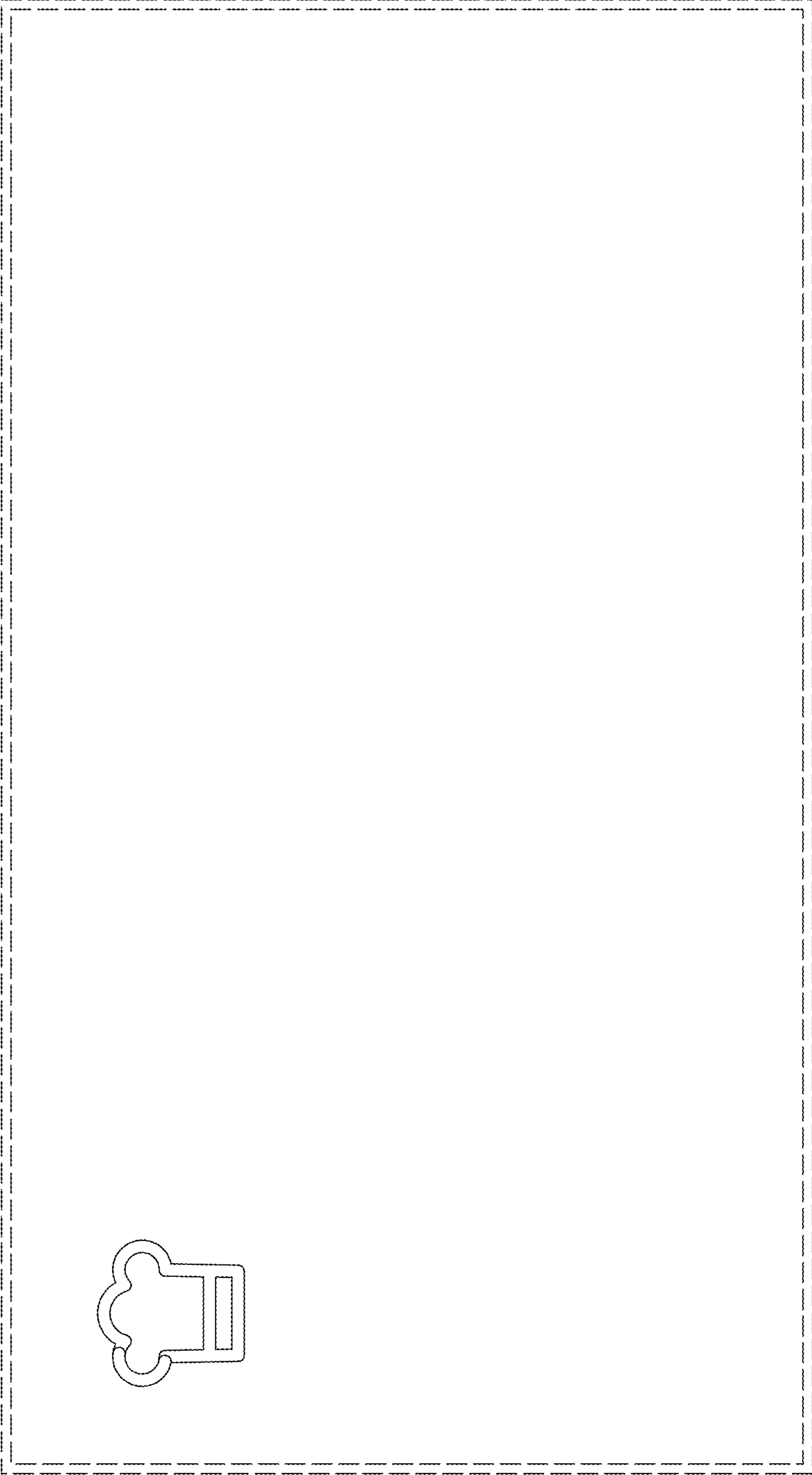

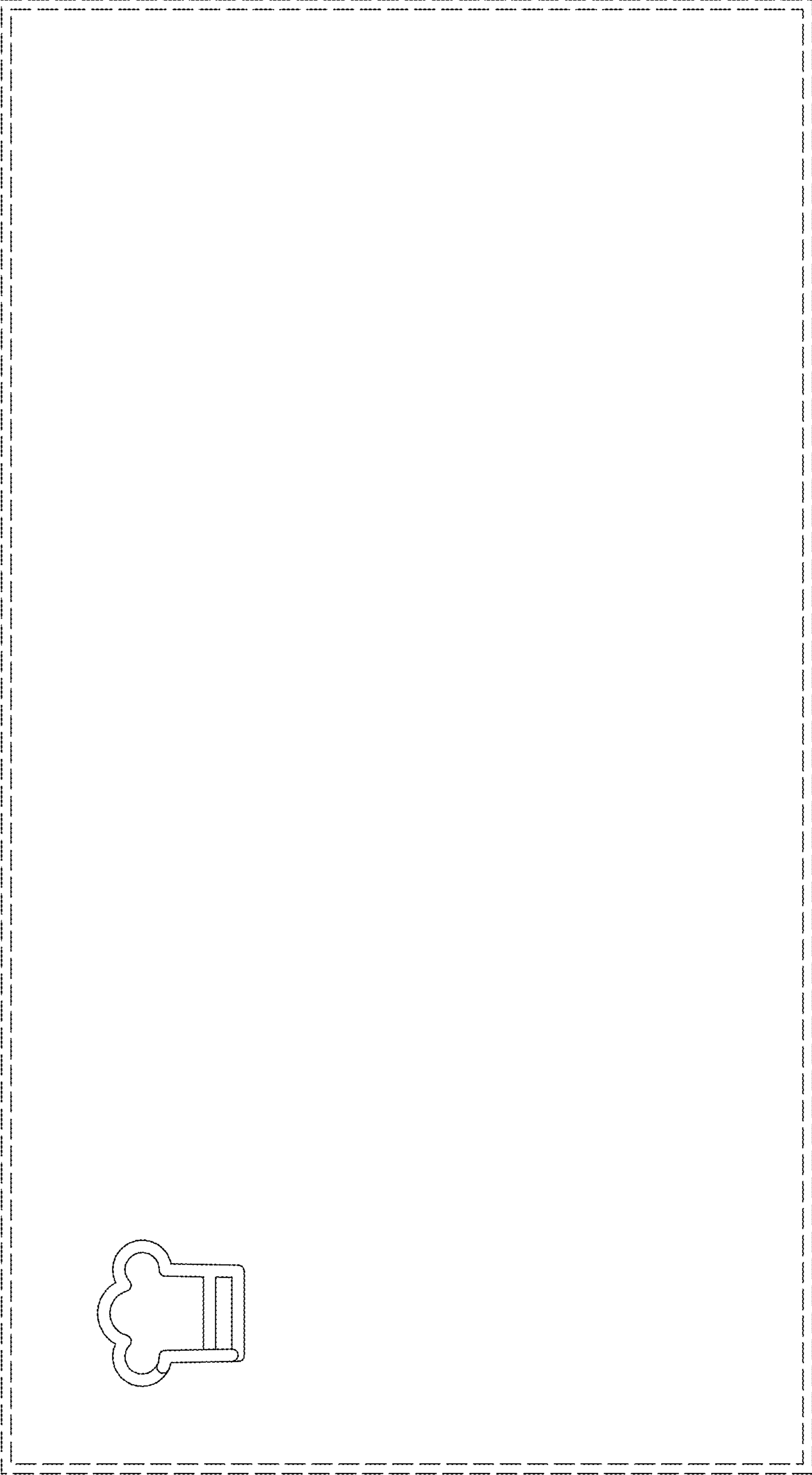

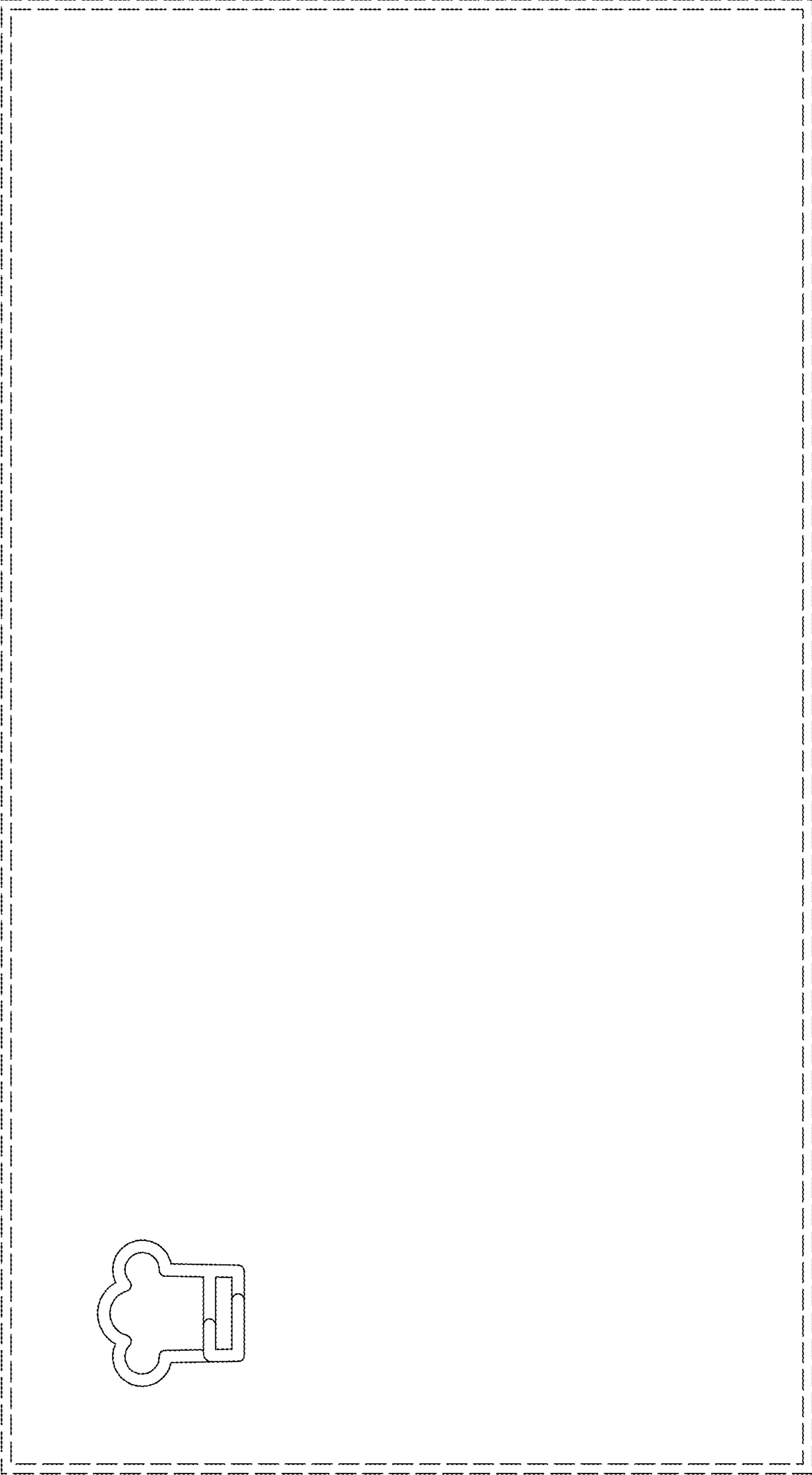

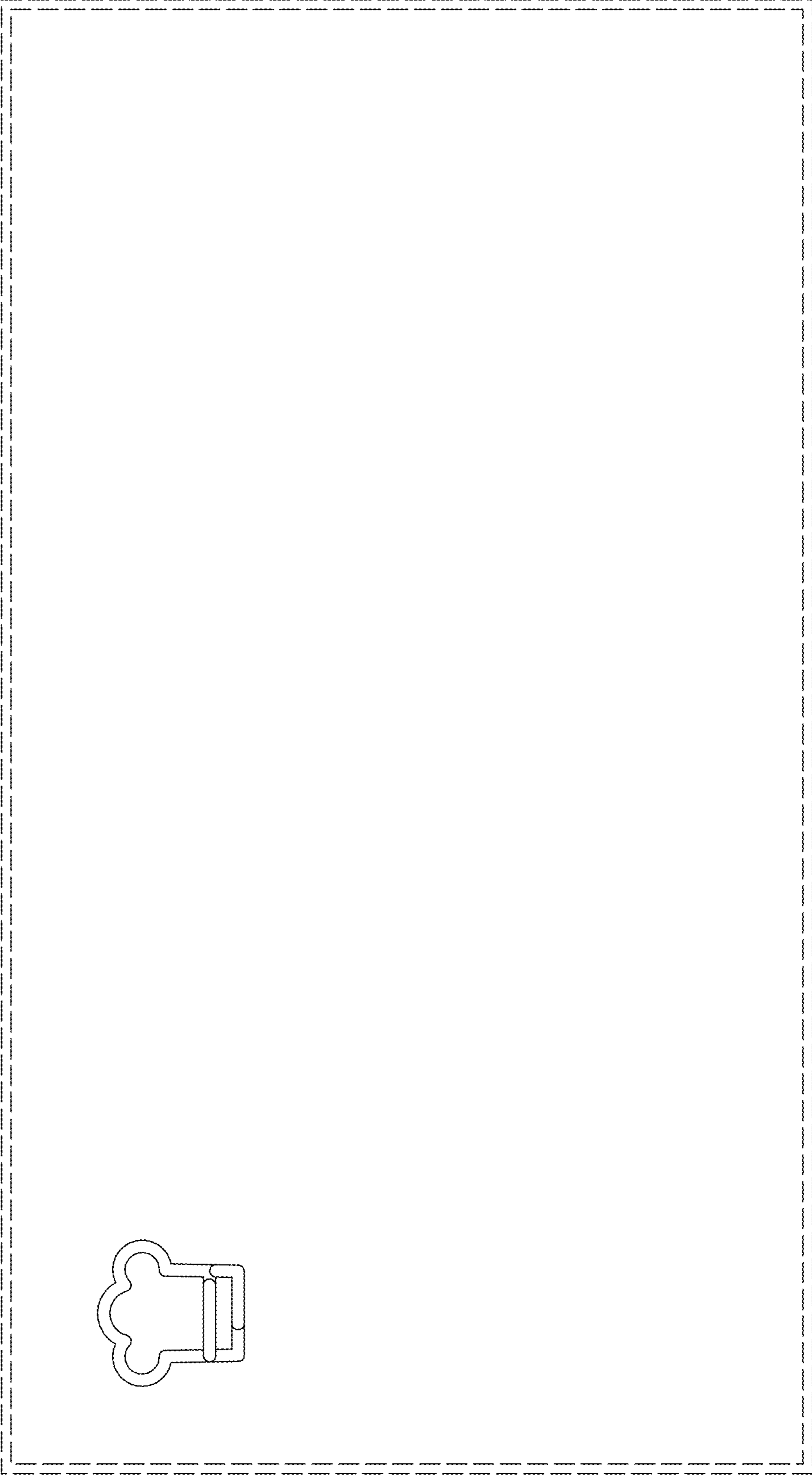

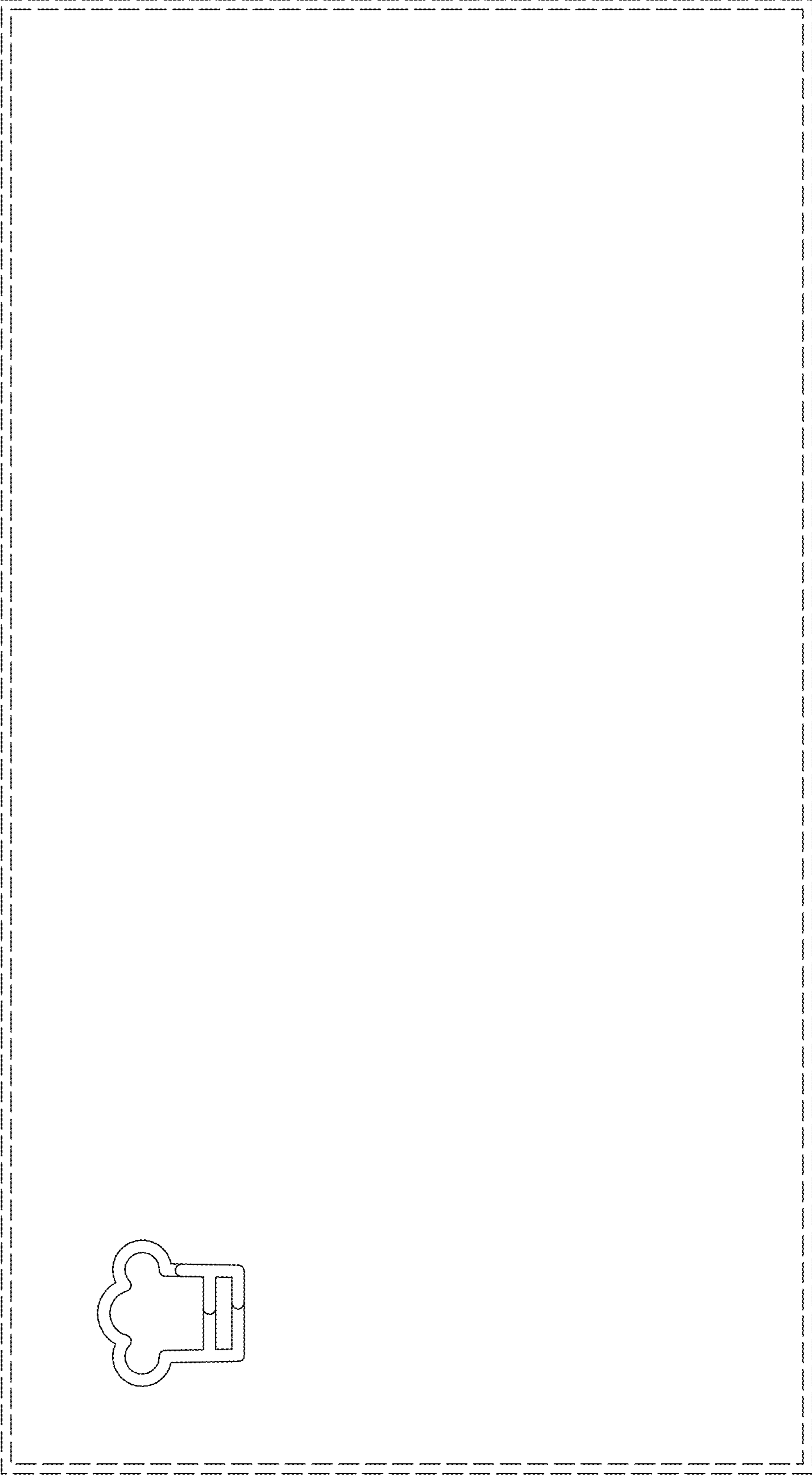

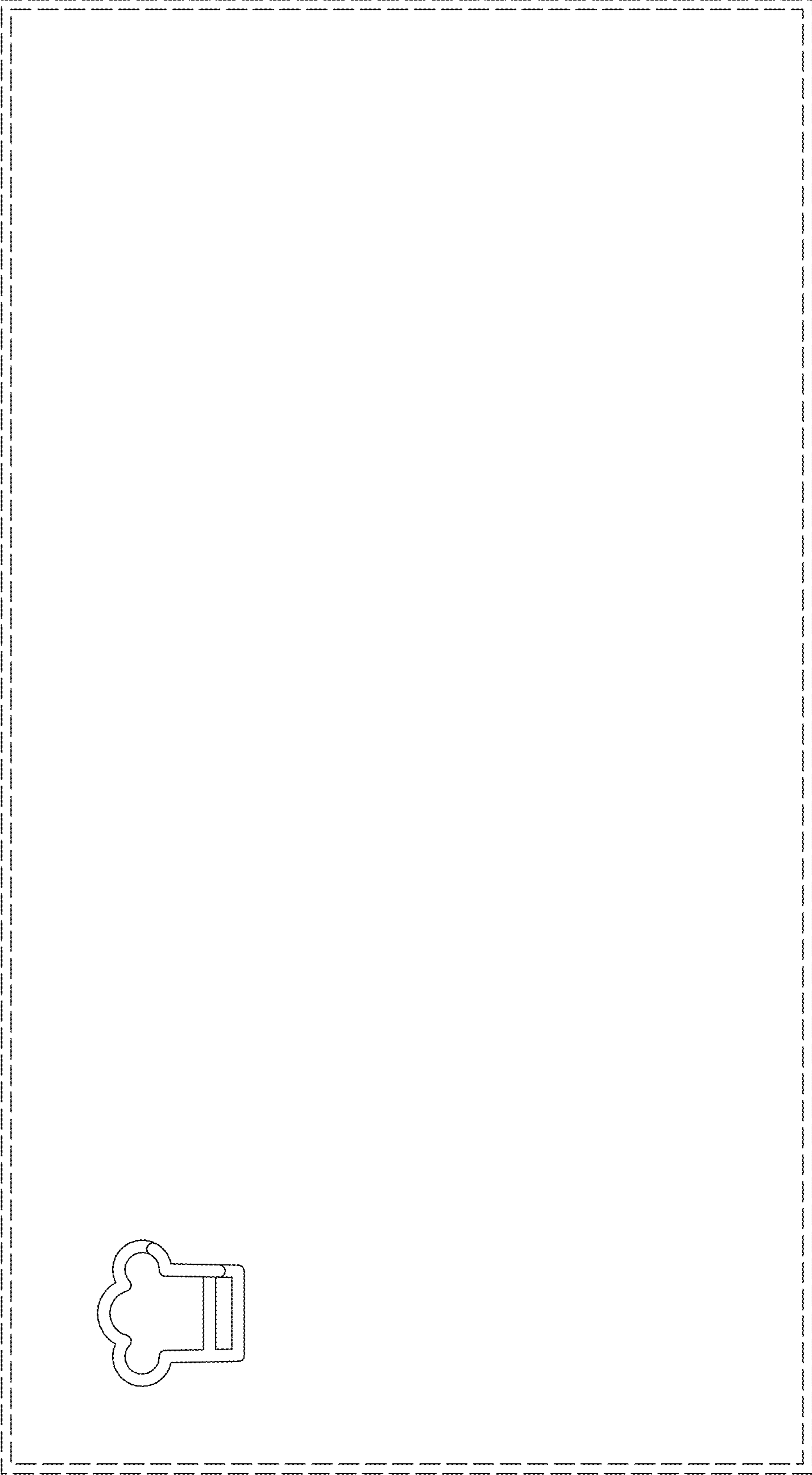

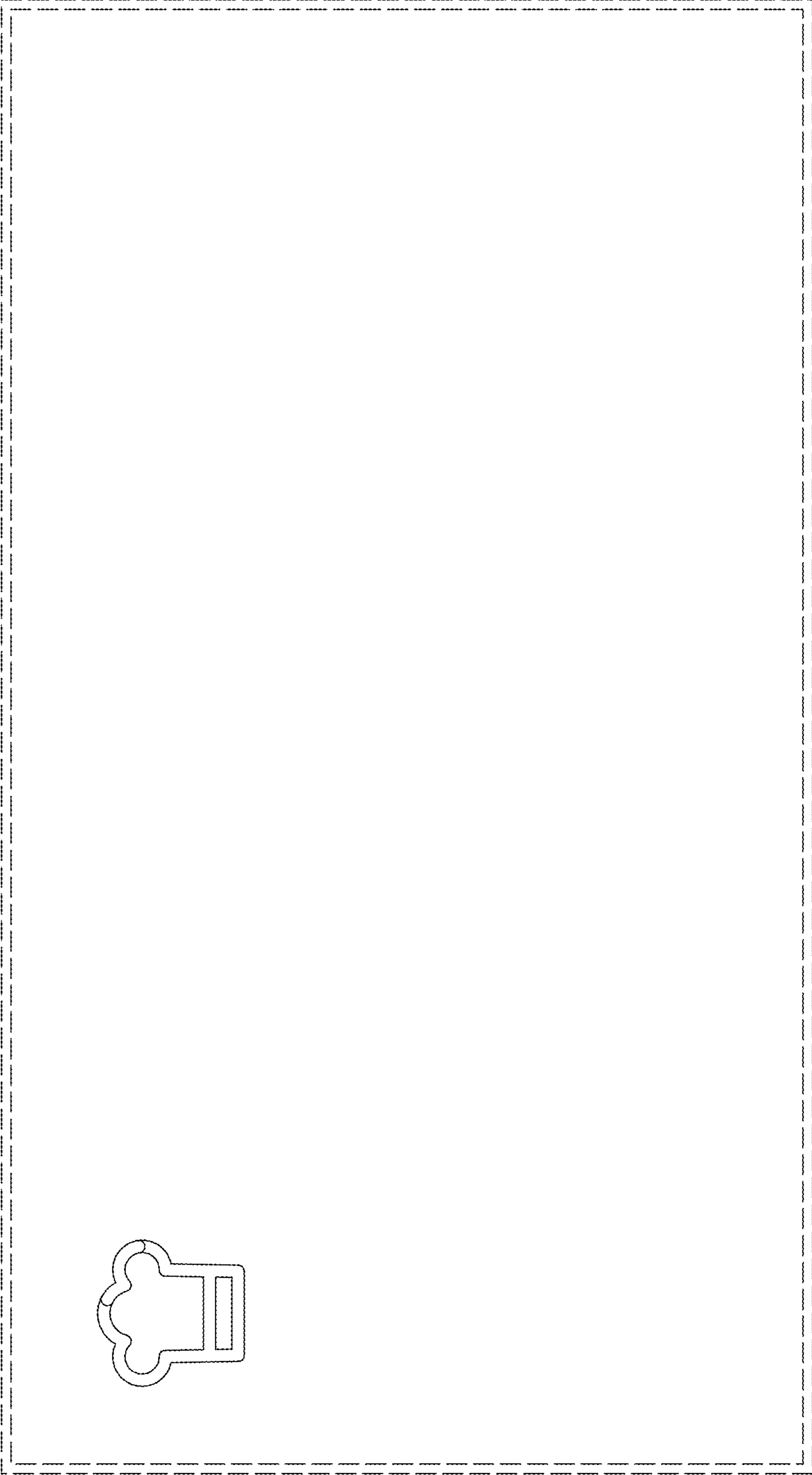
