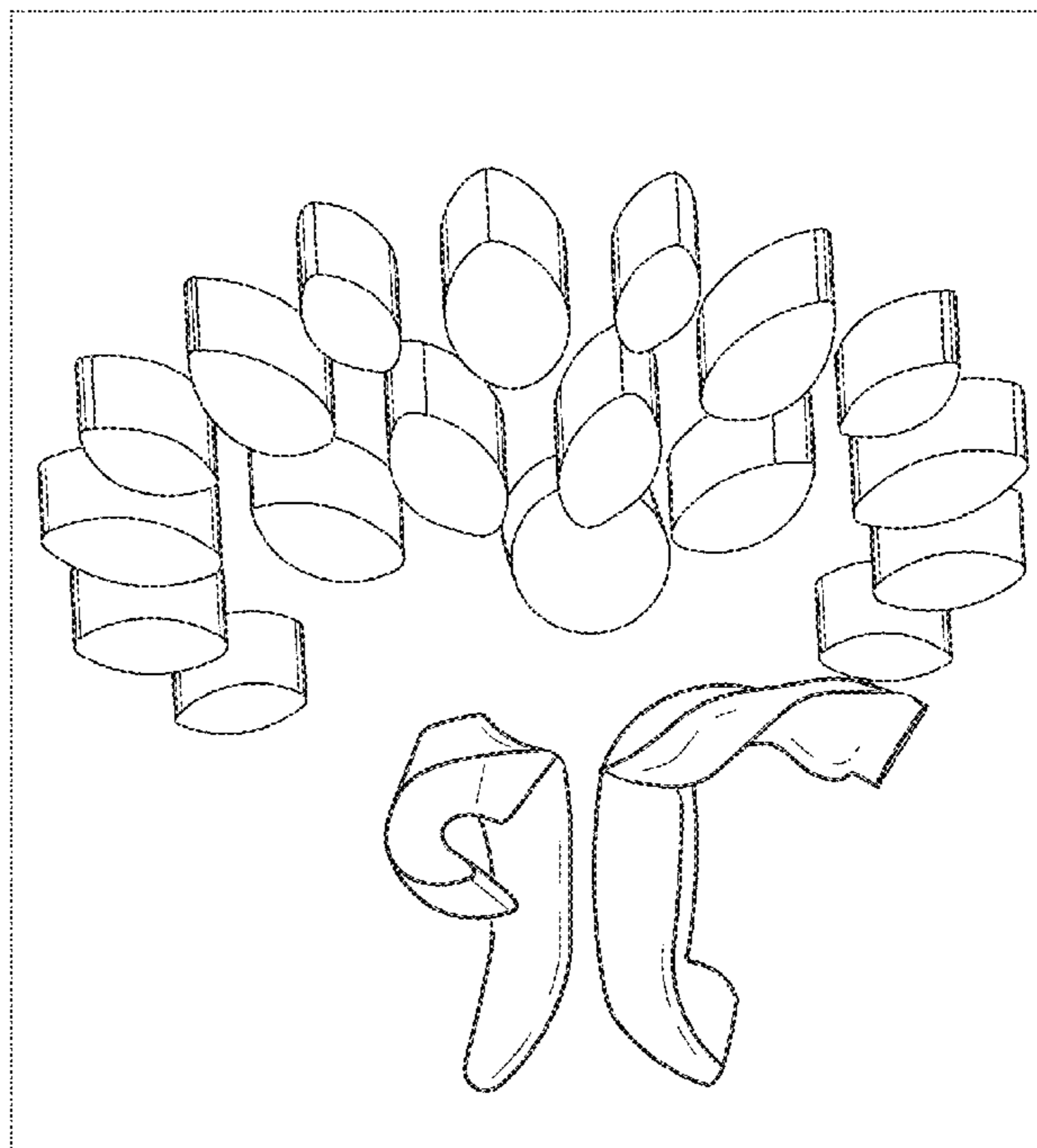
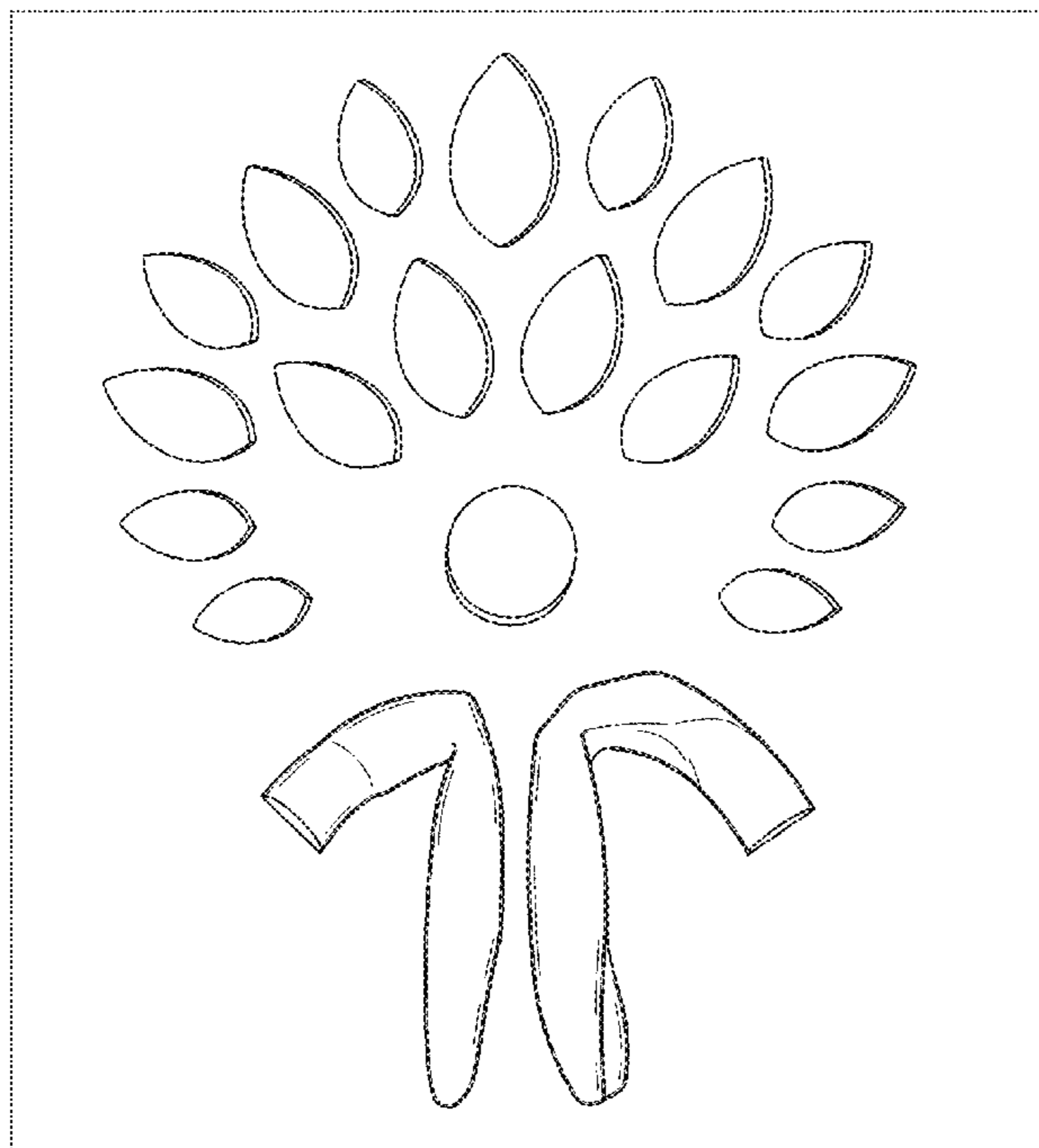
The ornamental design for a display screen with an animated icon, as shown and described.

DESCRIPTION

FIG. 1 illustrates the first image of a display screen with an animated icon according to a first embodiment; FIG. 2 illustrates the second image of the display screen with an animated icon according to the first embodiment; FIG. 3 illustrates the third image of the display screen with an animated icon according to the first embodiment; and, FIG. 4 illustrates the fourth image of the display screen with an animated icon according to the first embodiment.

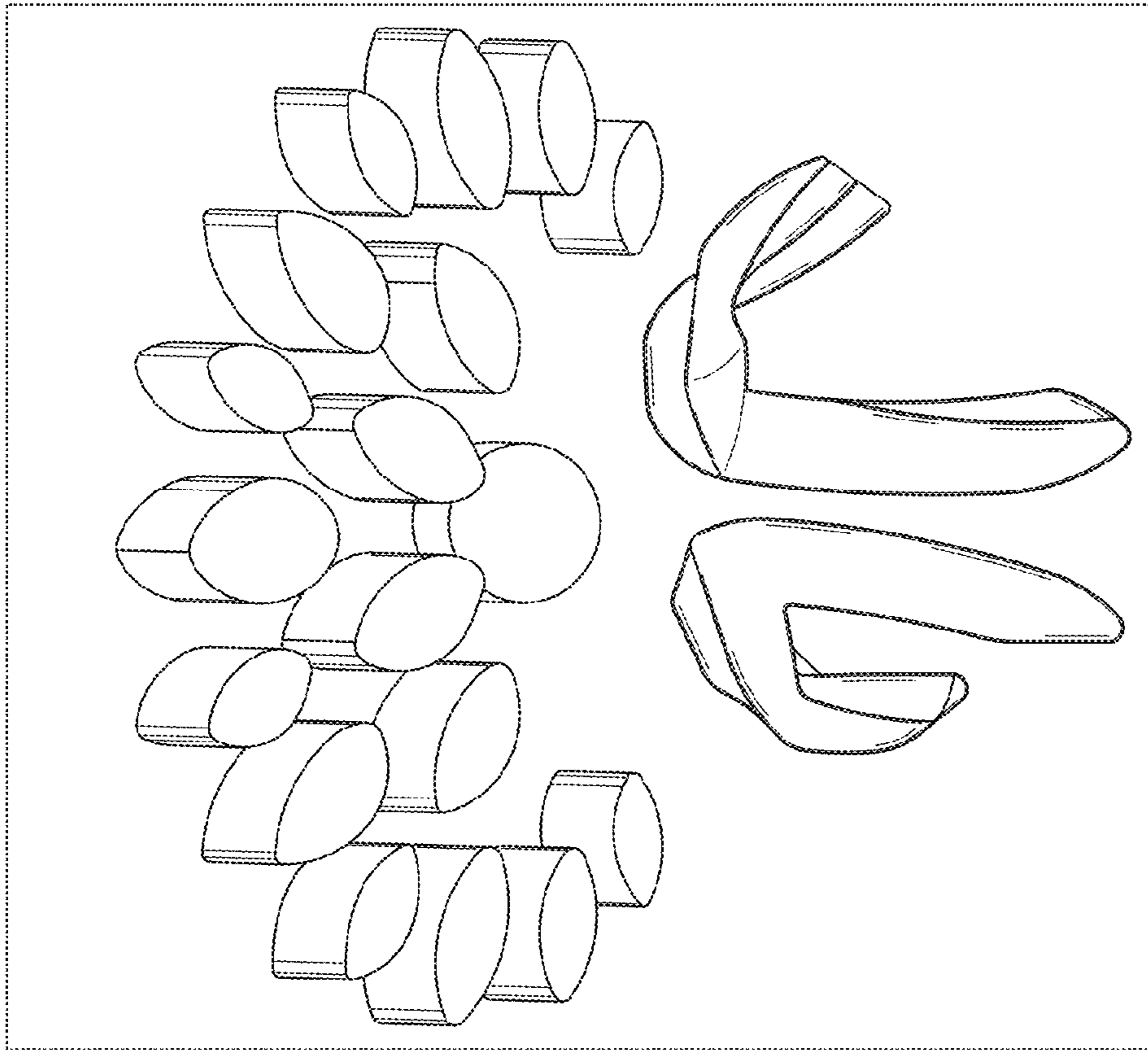

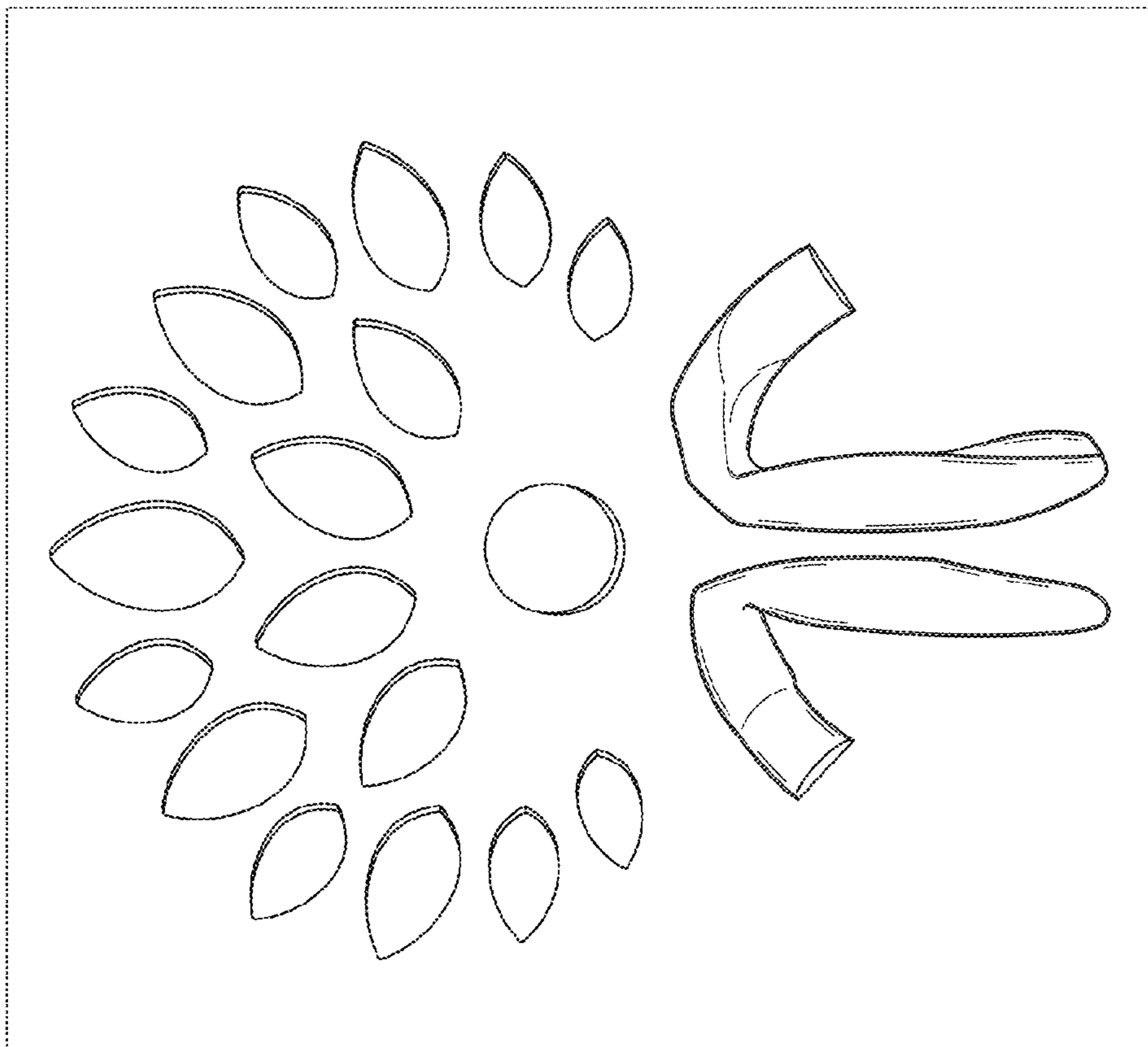

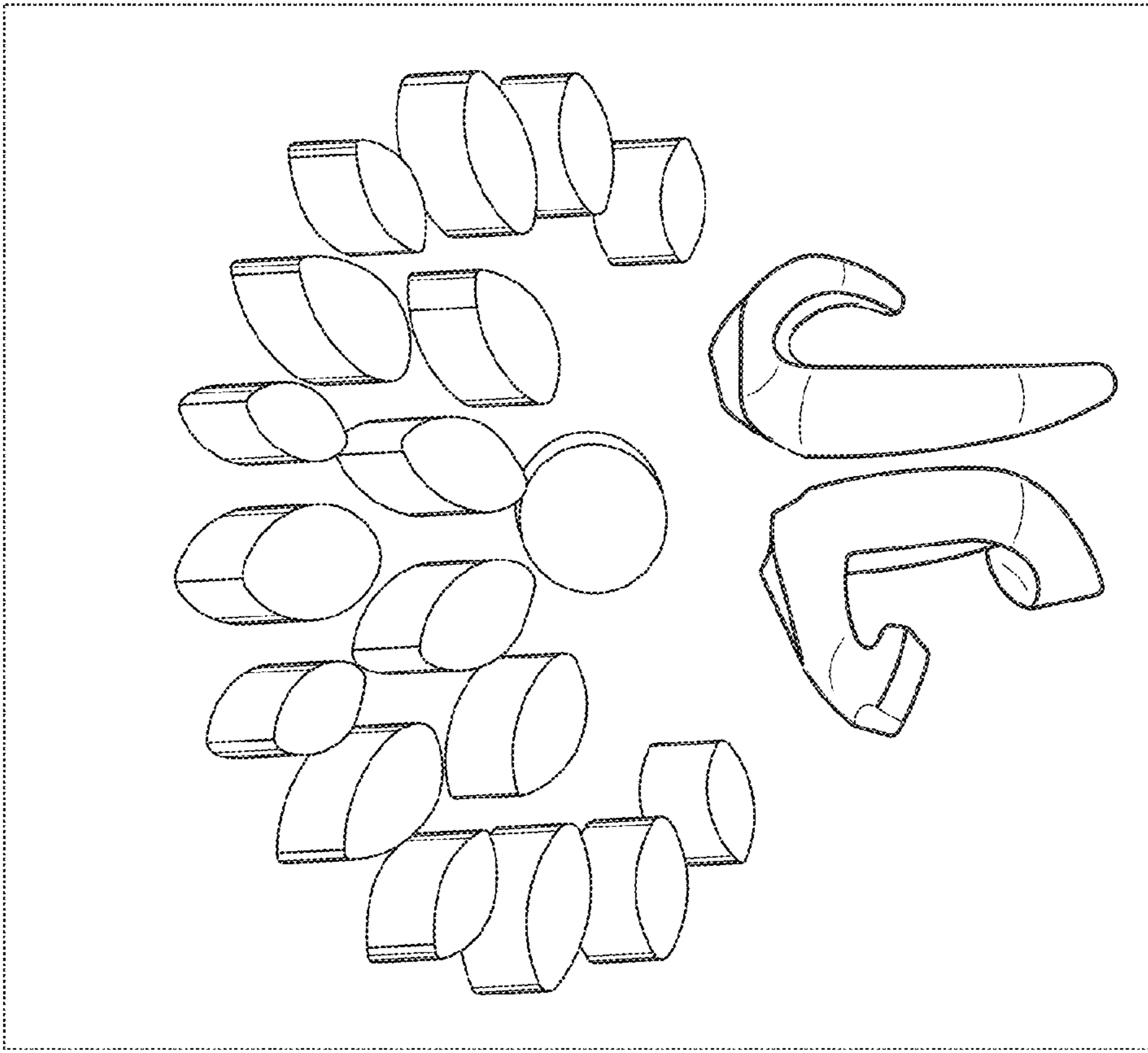

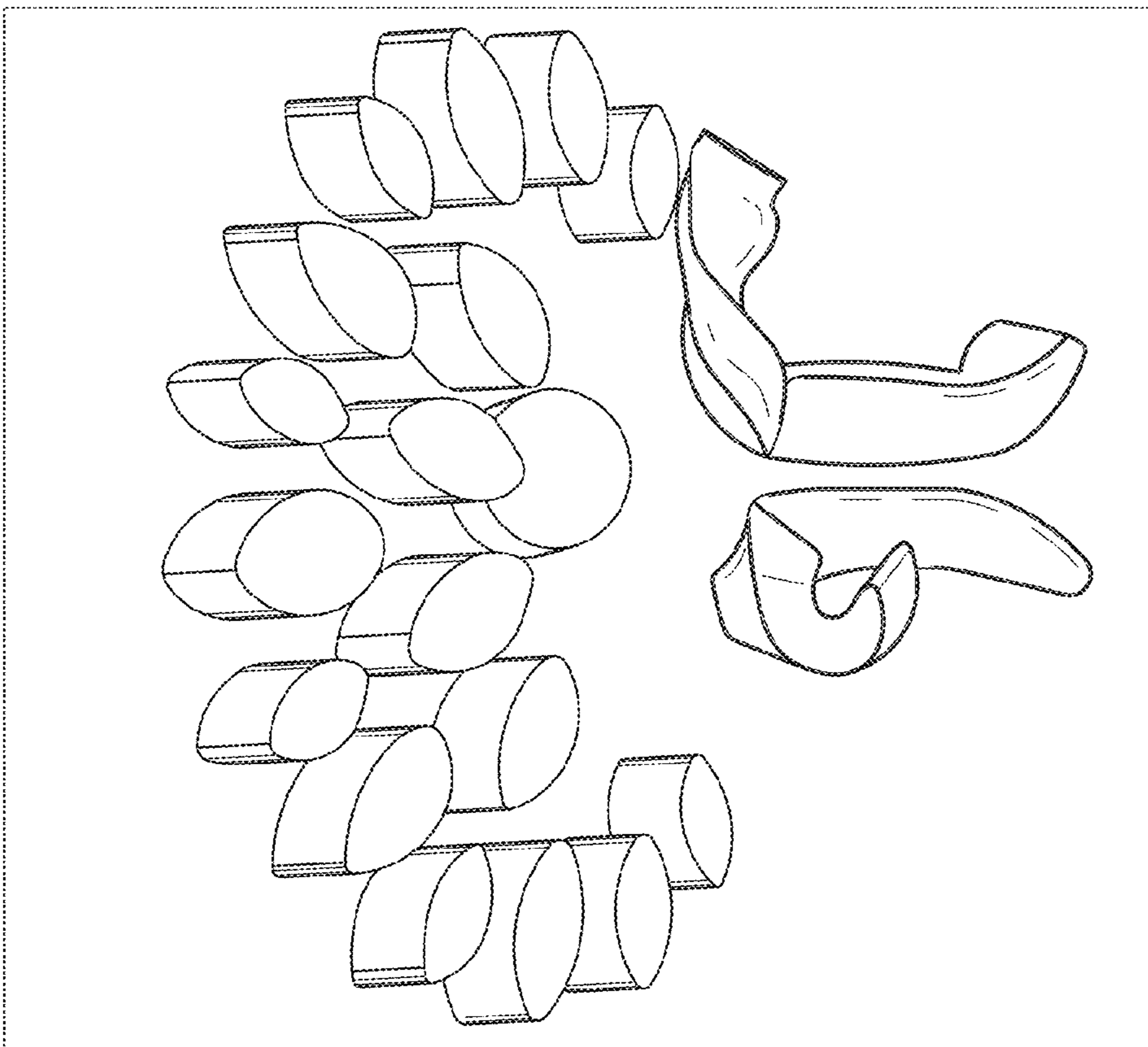
