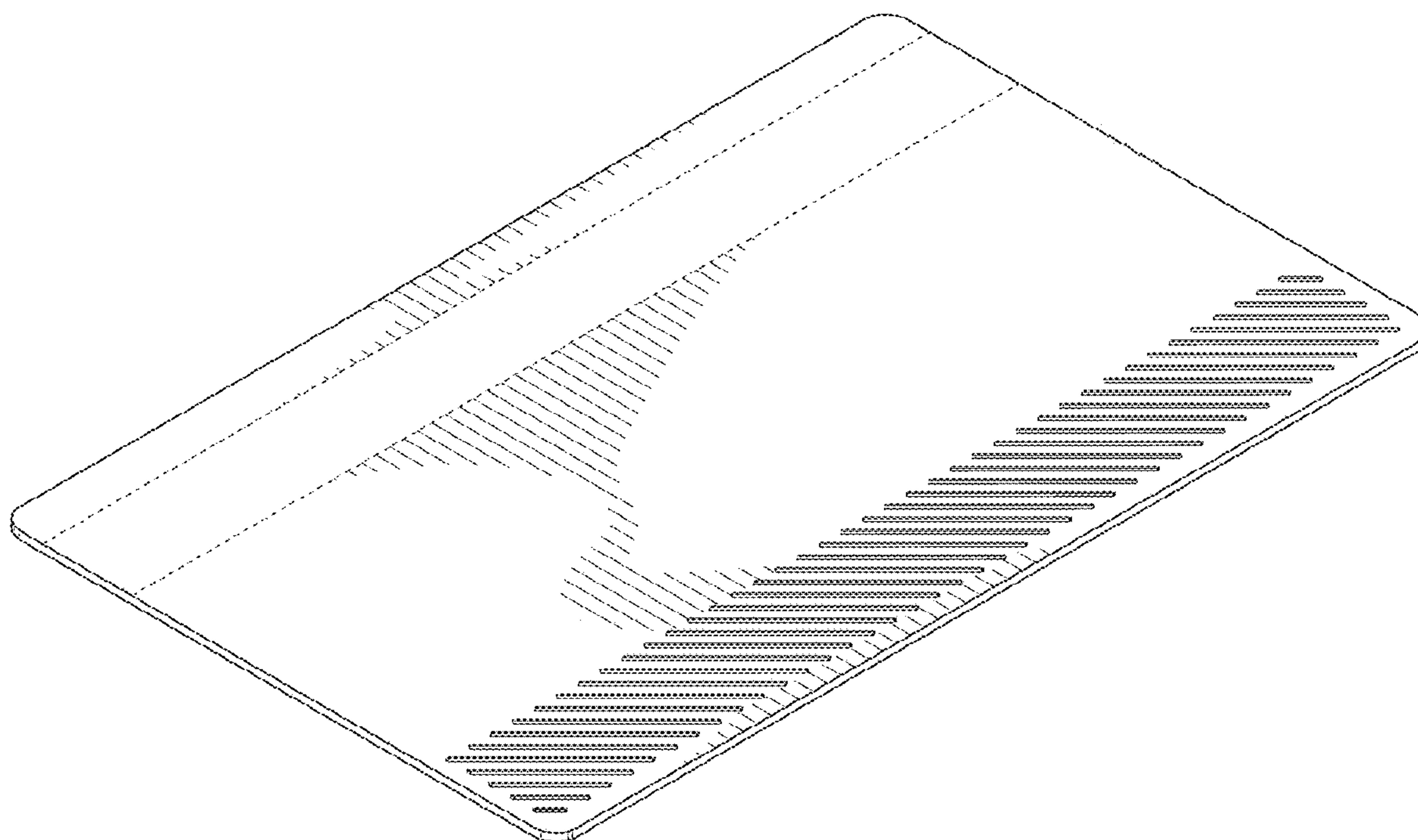
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of the card with textured grip, showing our new design;

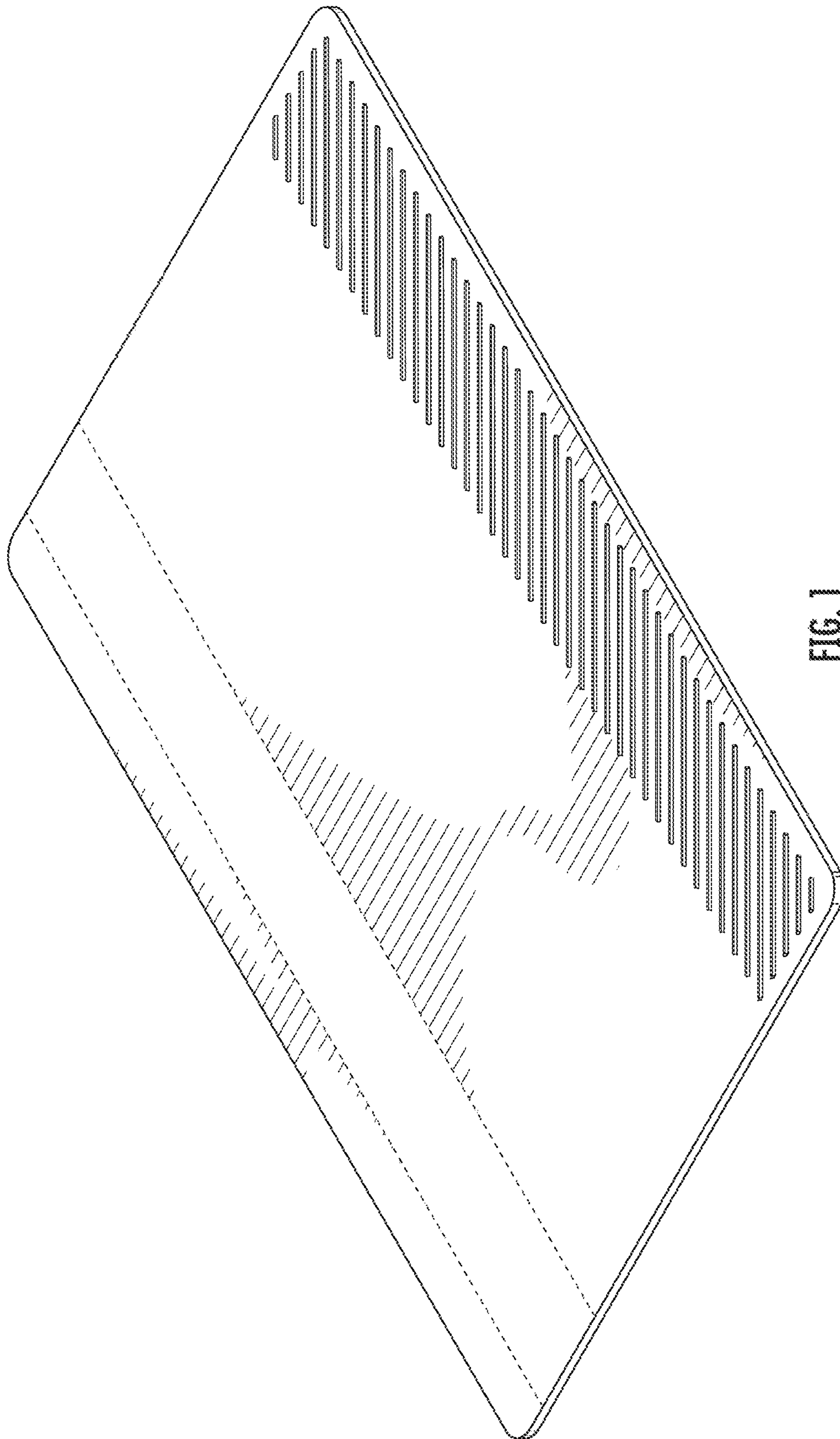

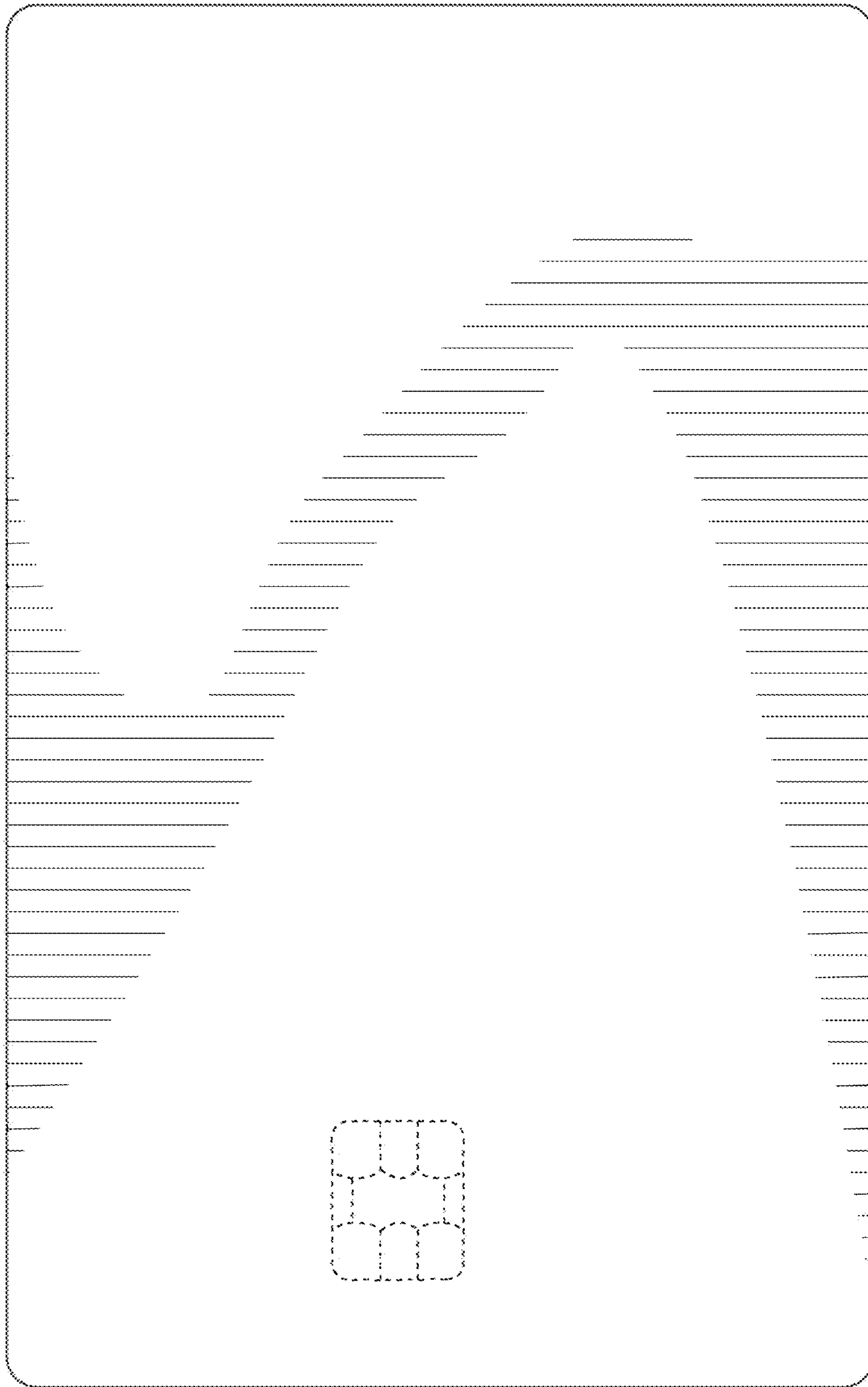

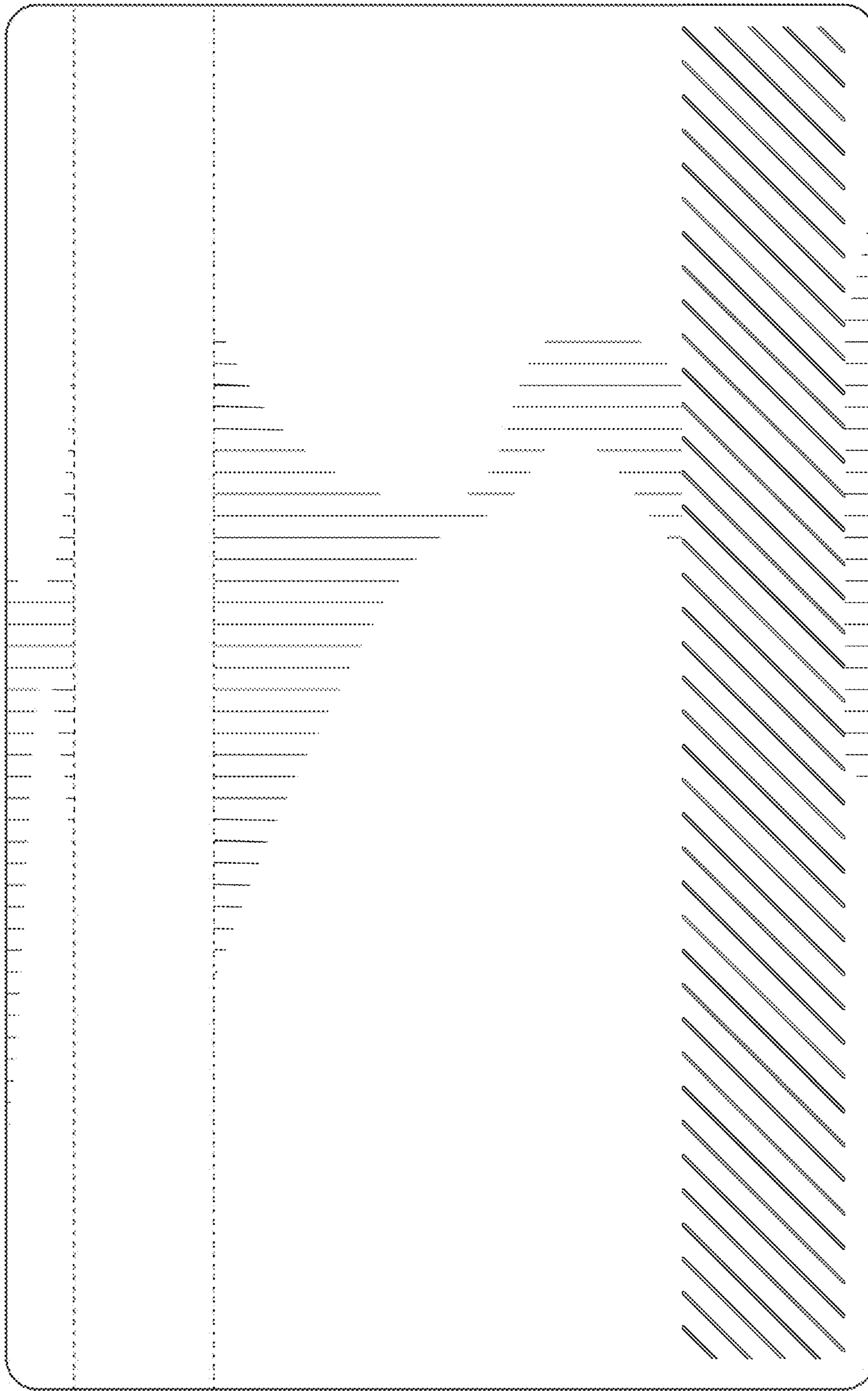

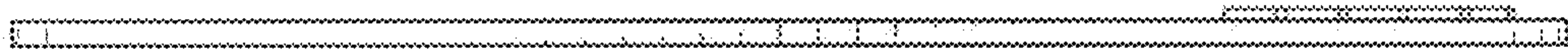

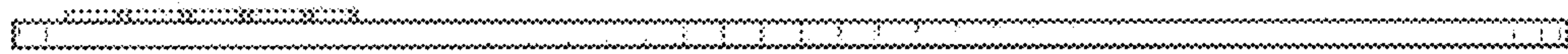

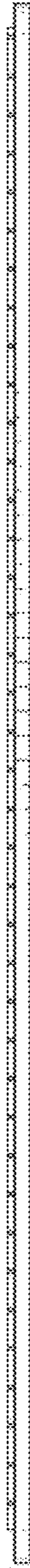
