The ornamental design for a golf putting device, as shown and described.

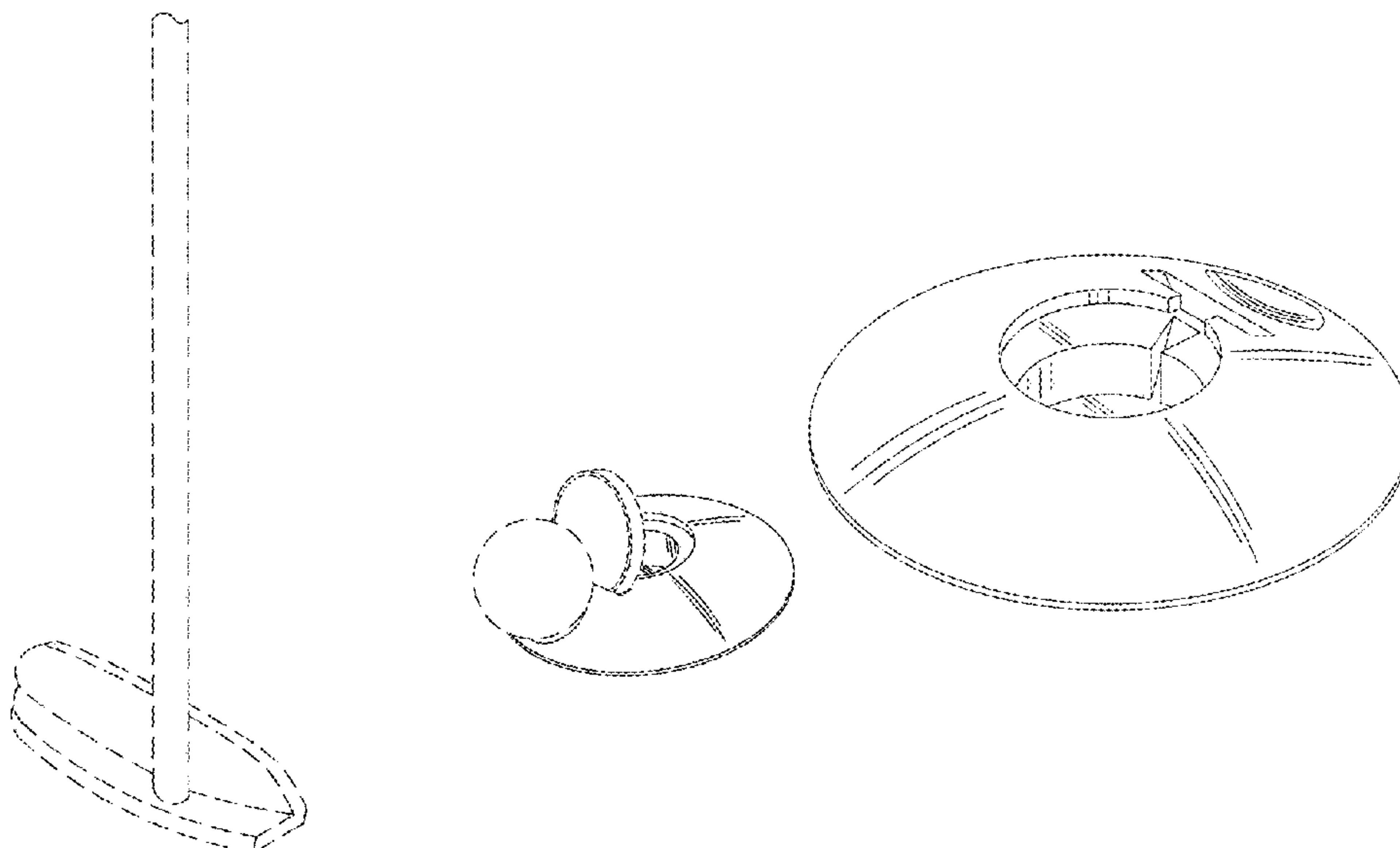
**DESCRIPTION**

FIG. 1 is a rear perspective view of a golf putting device, showing my new design in use;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a rear elevation view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a left side elevation view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a sectional view thereof taken along line 7-7 of FIG. 4;  
 FIG. 8 is a front perspective view thereof; and,  
 FIG. 9 is an exploded front perspective view thereof shown in use.

The broken lines shown in the drawings of FIGS. 6 and 7 illustrate a boundary that forms no part of the claimed design.

The broken lines in FIGS. 1 and 9 showing the golf putting device in use illustrate environment and forms no part of the claim.

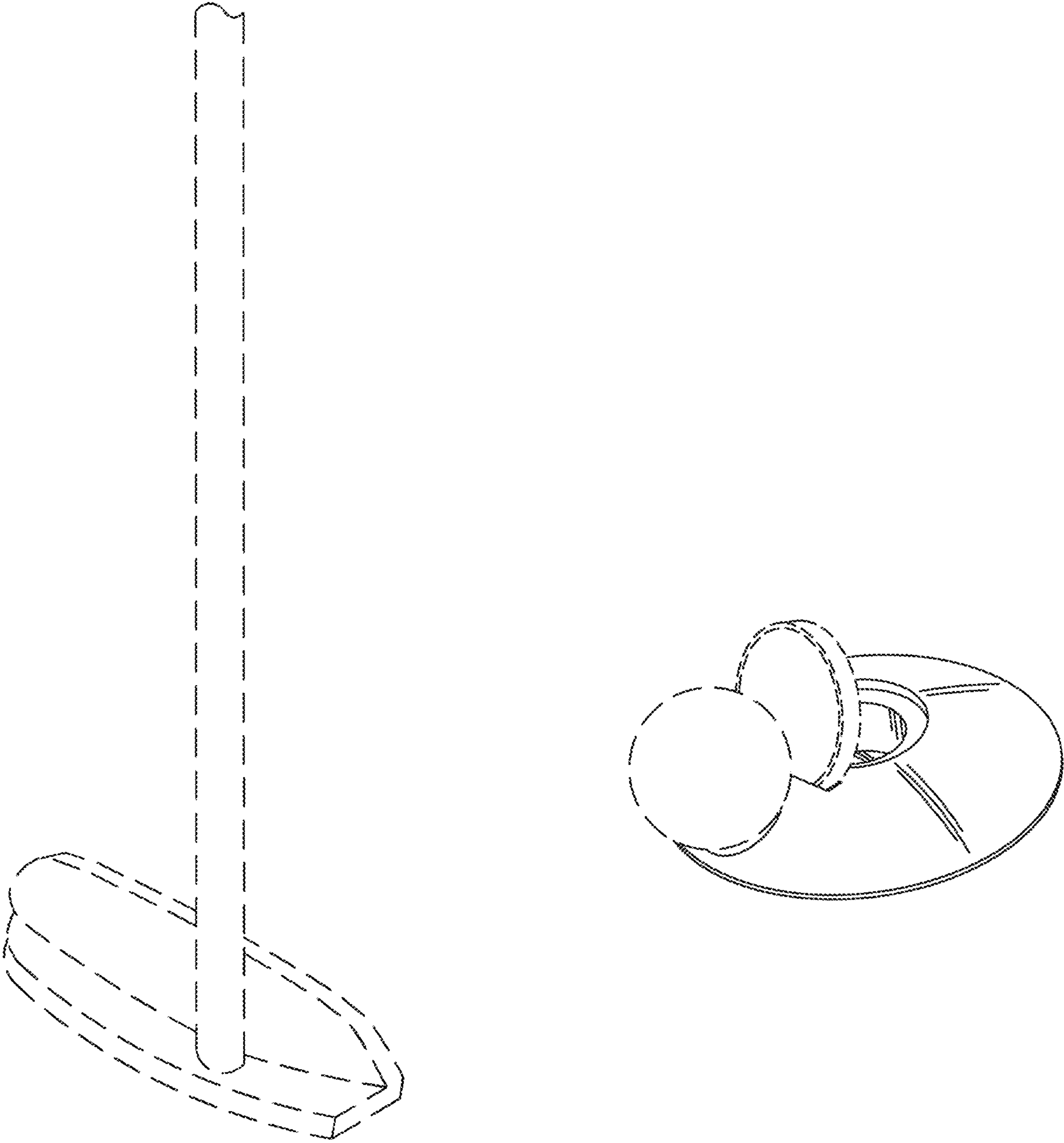

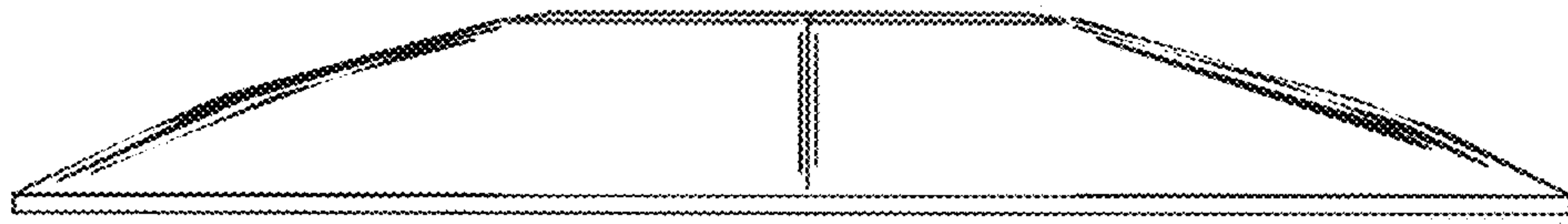

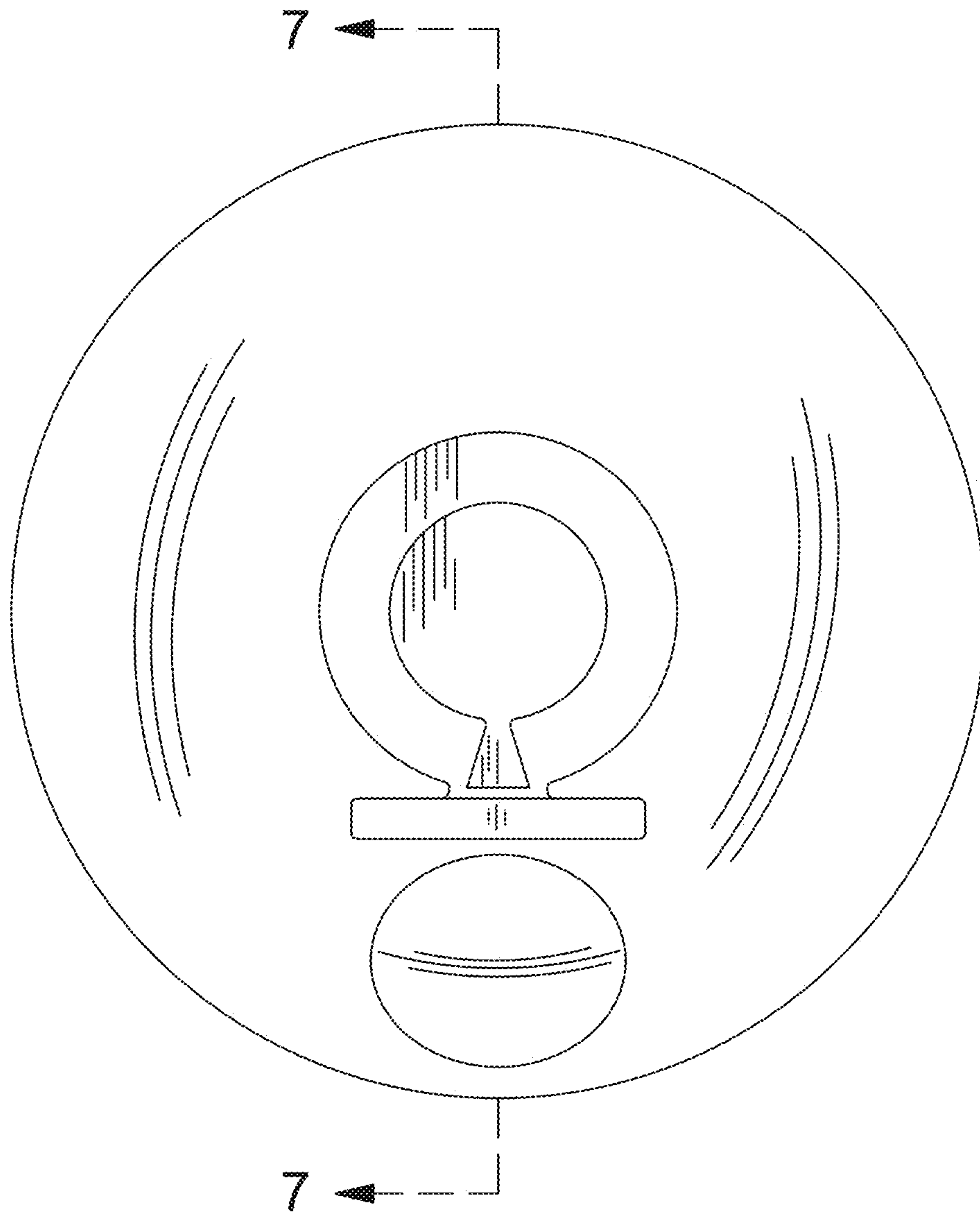

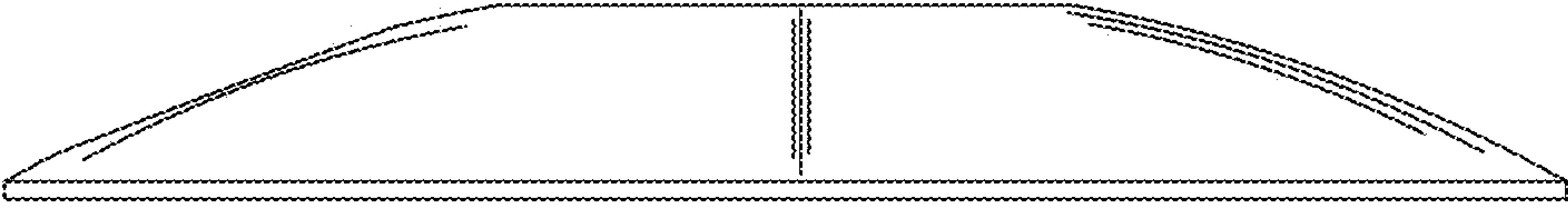

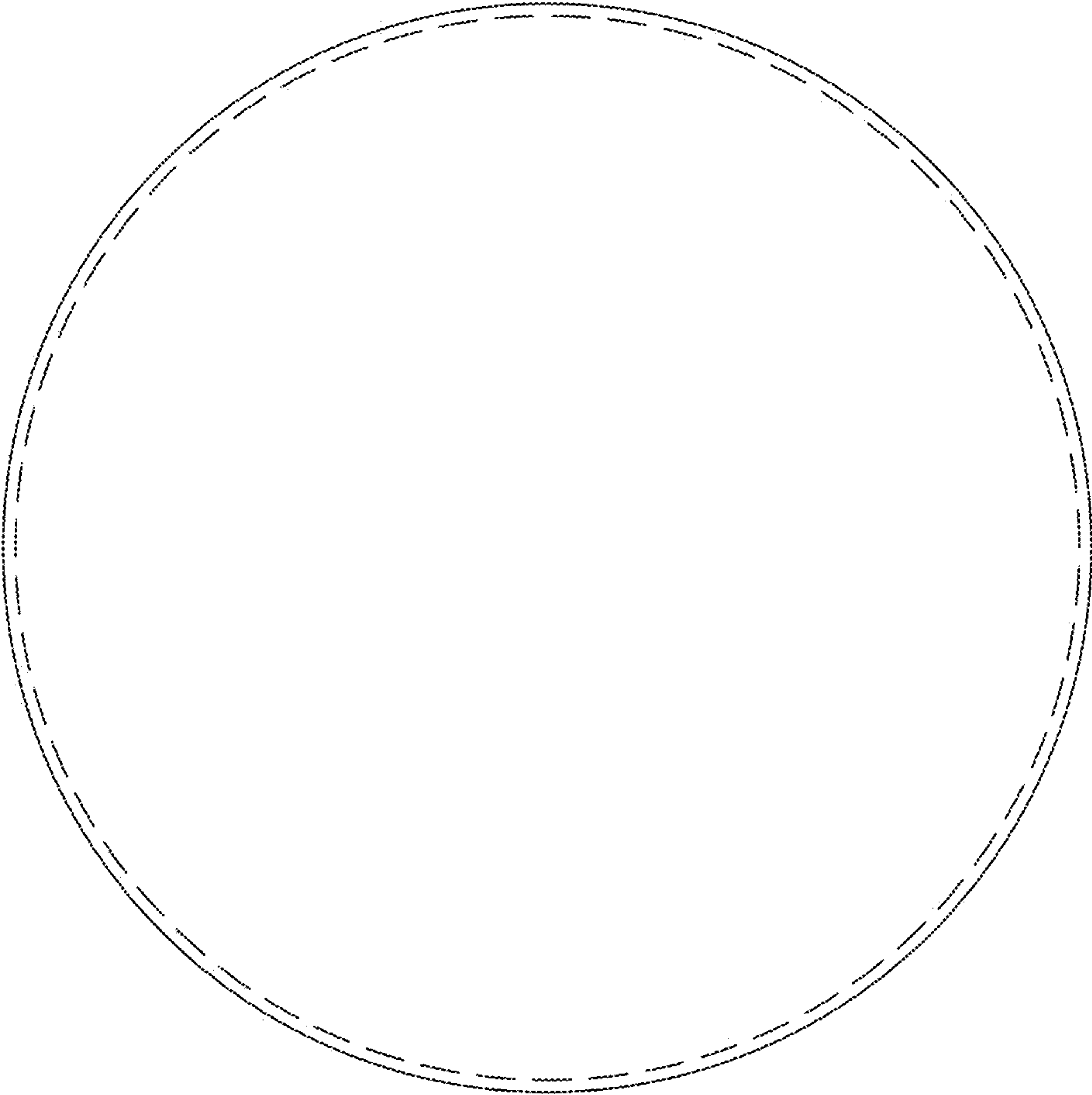

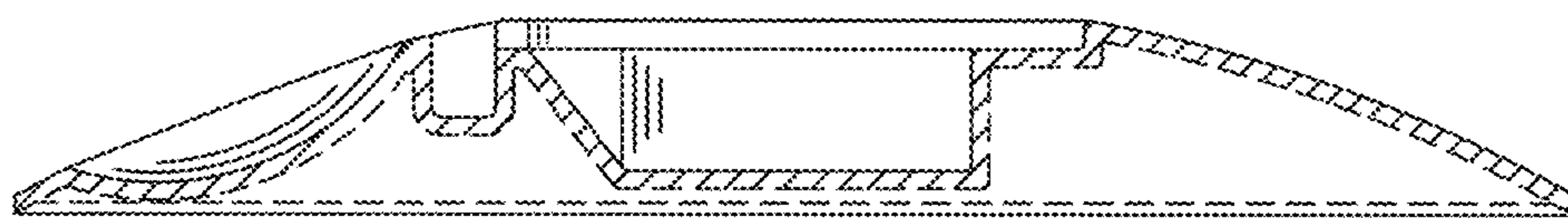

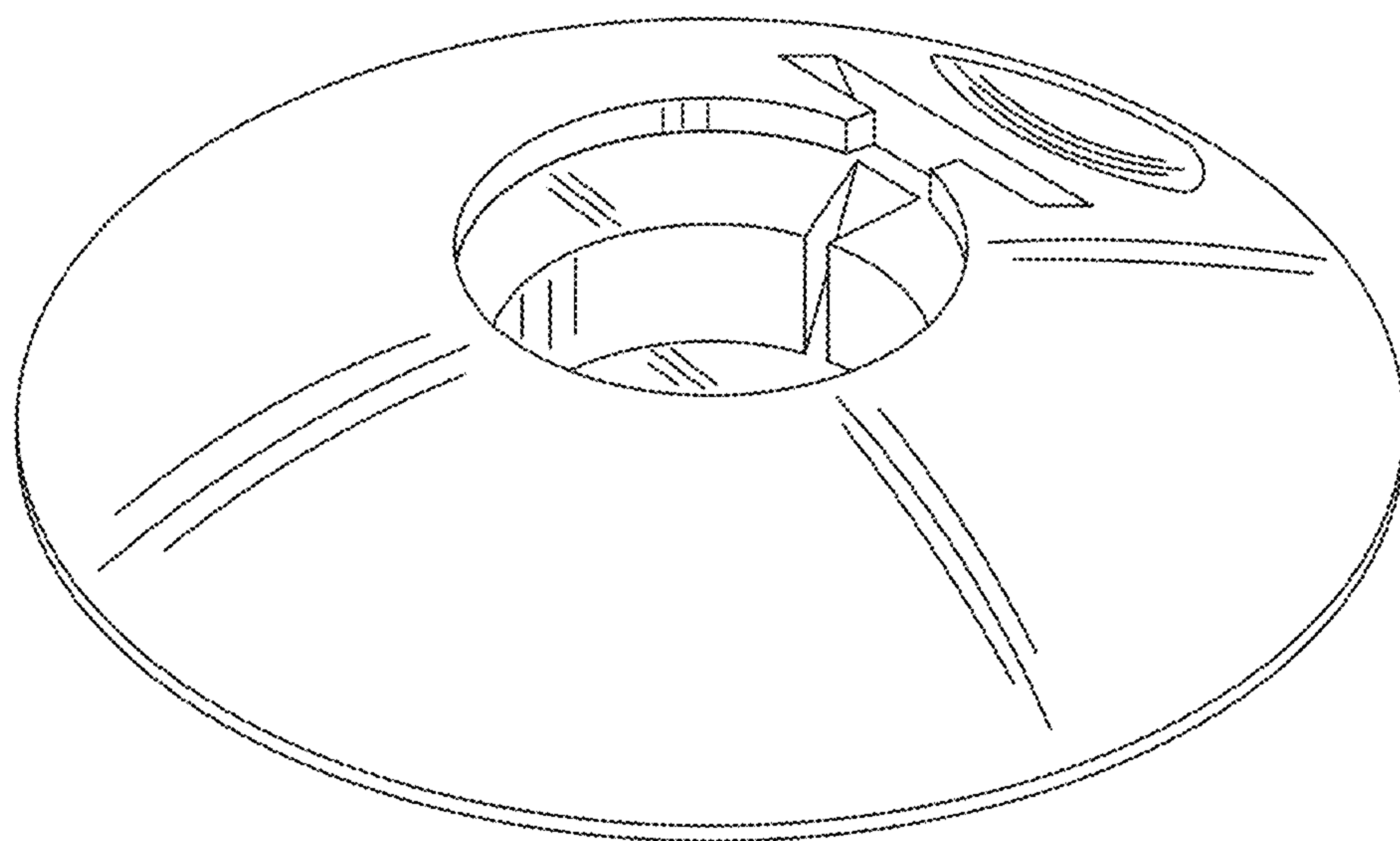
