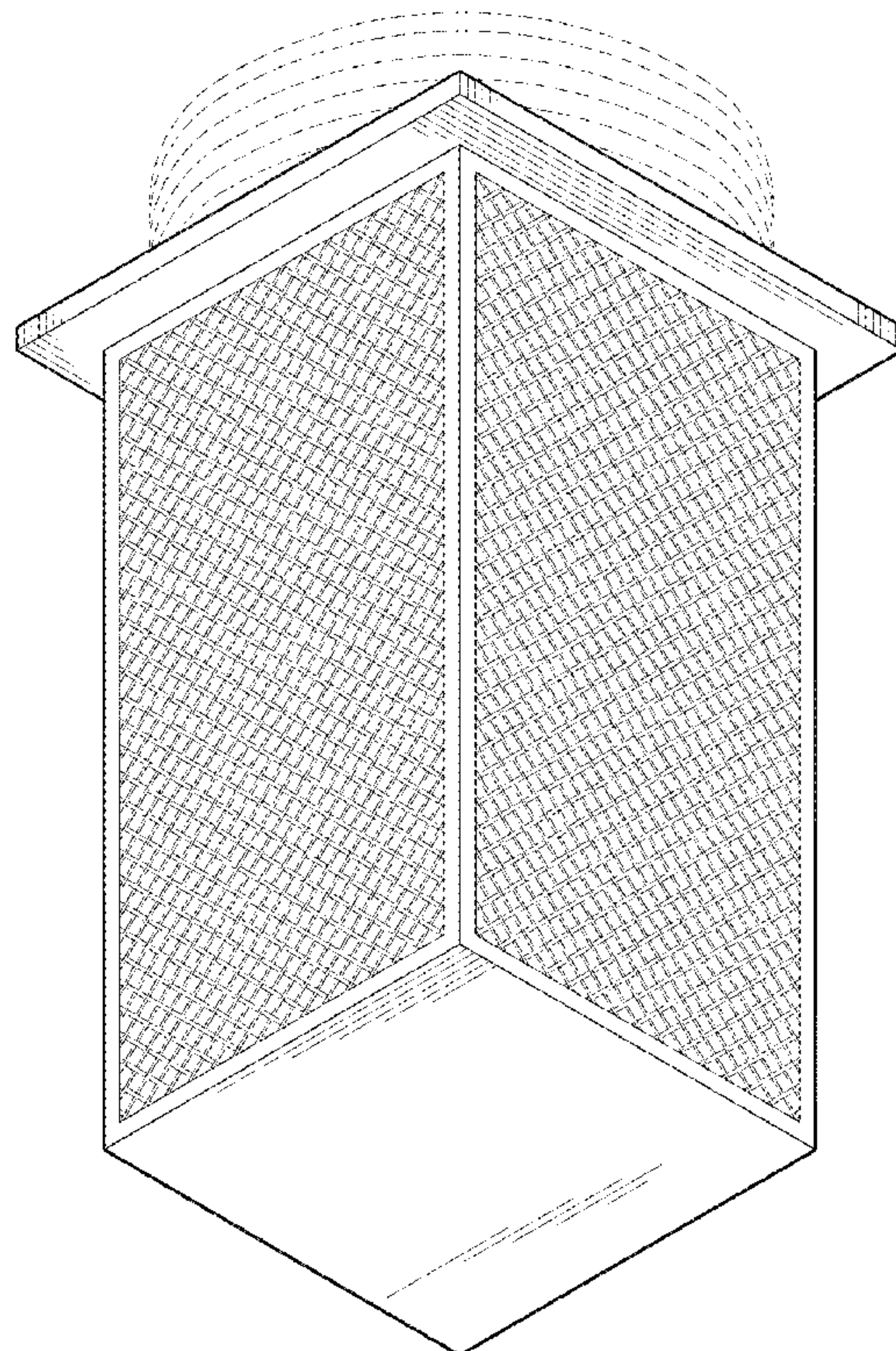
(57) **CLAIM**

We claim the ornamental design for a rectangular shaped flow through cap, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view showing the rectangular shaped flow through cap;
FIG. 2 is a side view thereof;
FIG. 3 is a top view thereof; and,
FIG. 4 is a bottom view thereof.

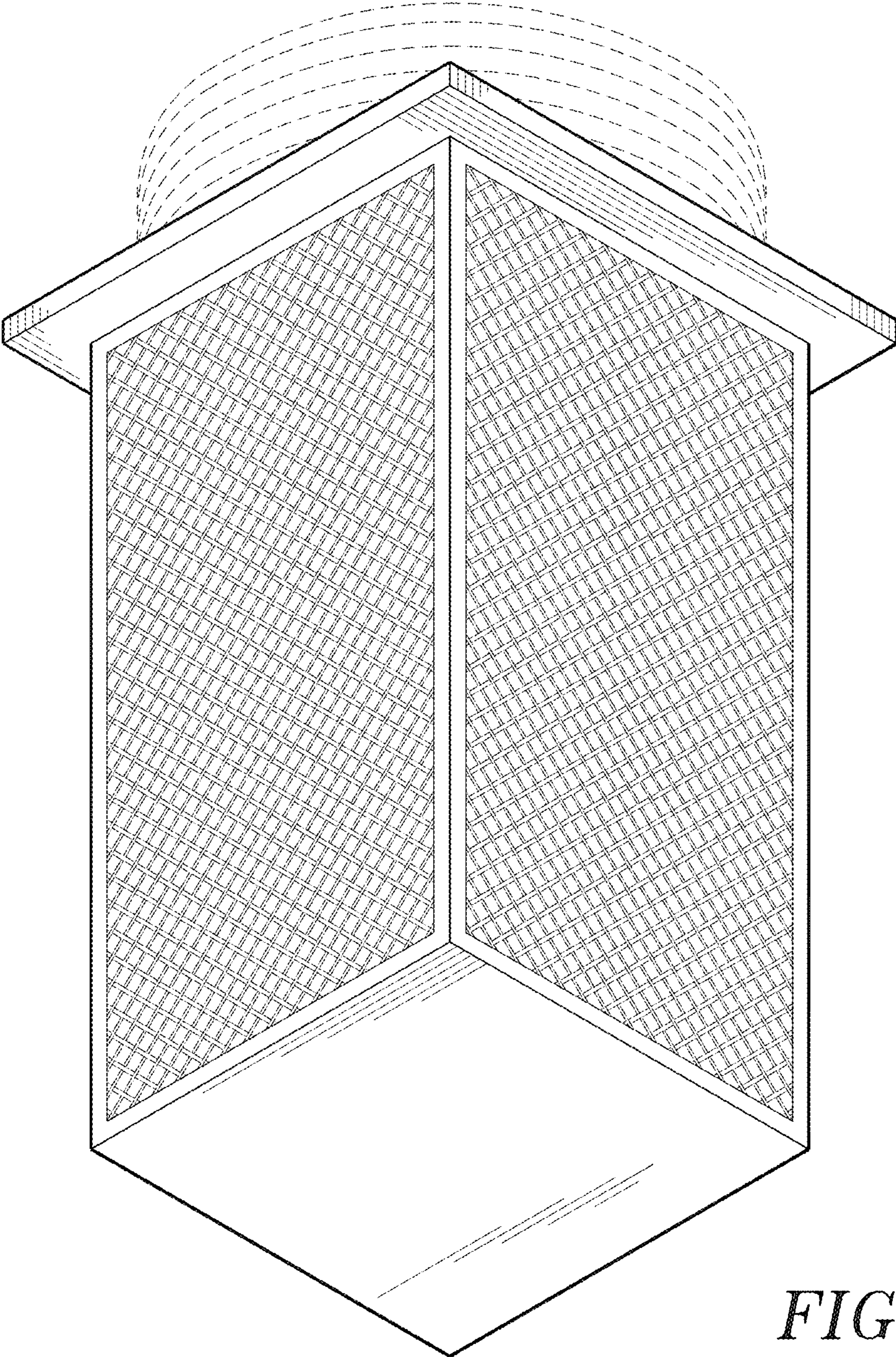

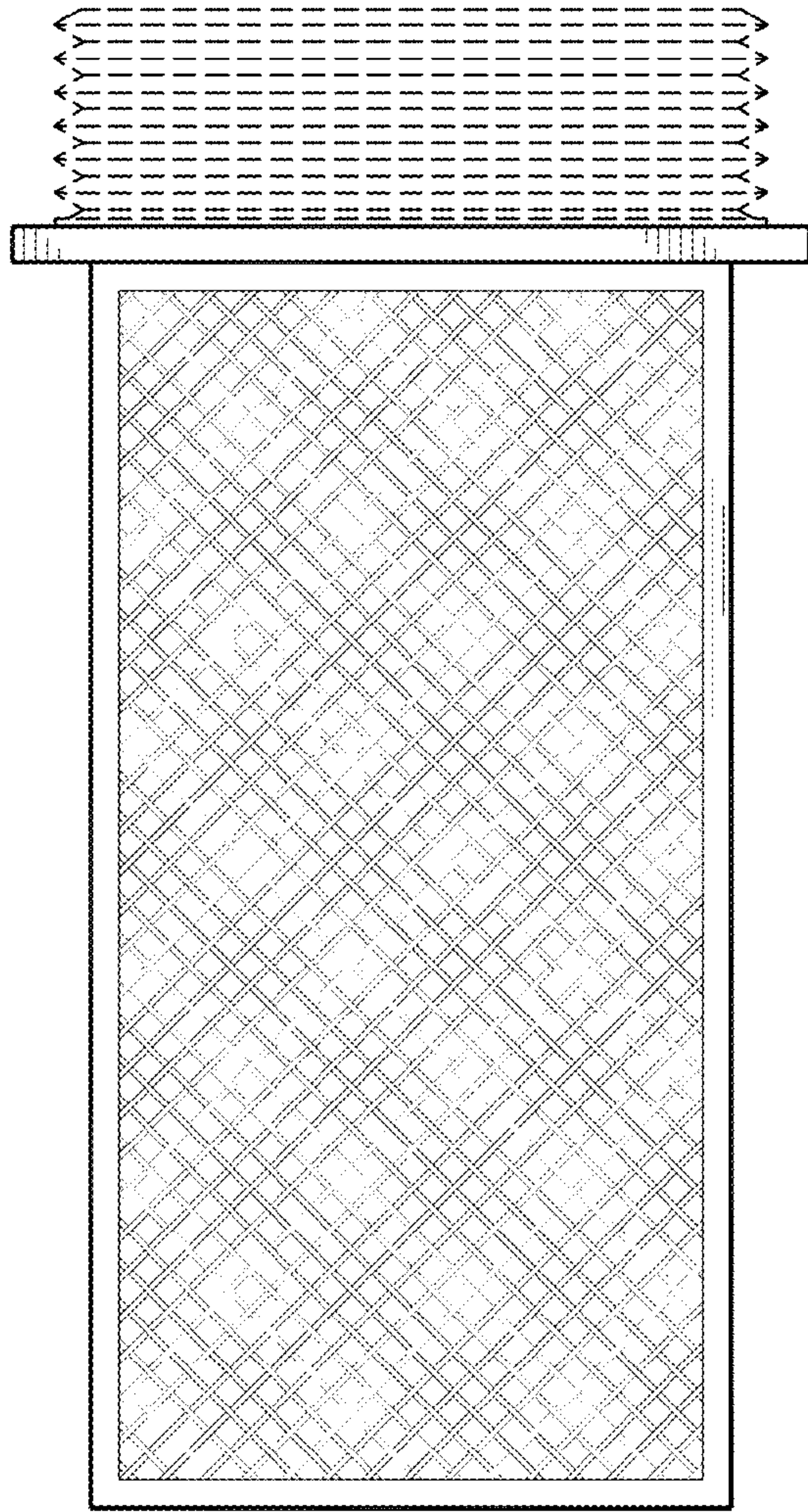

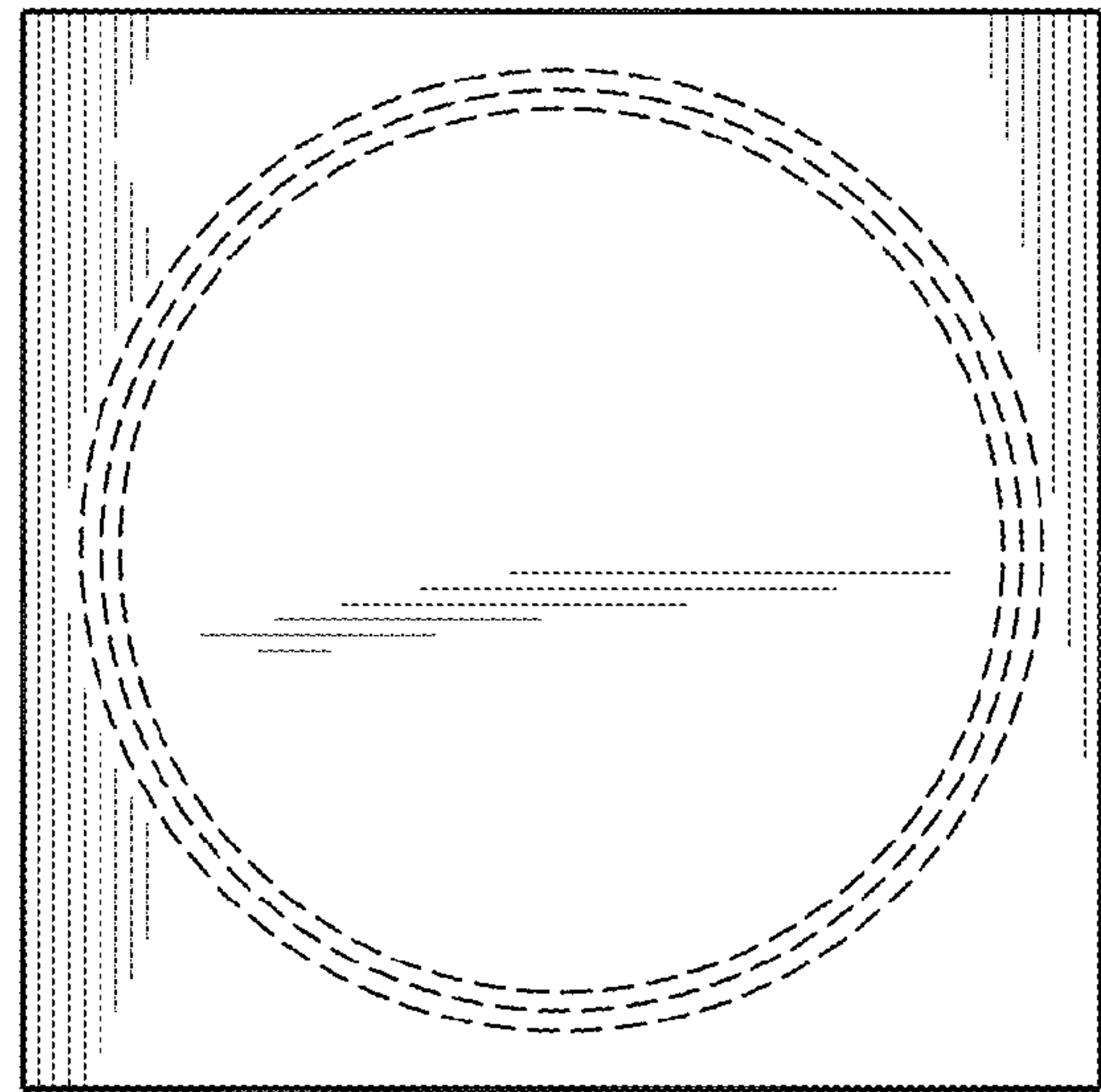

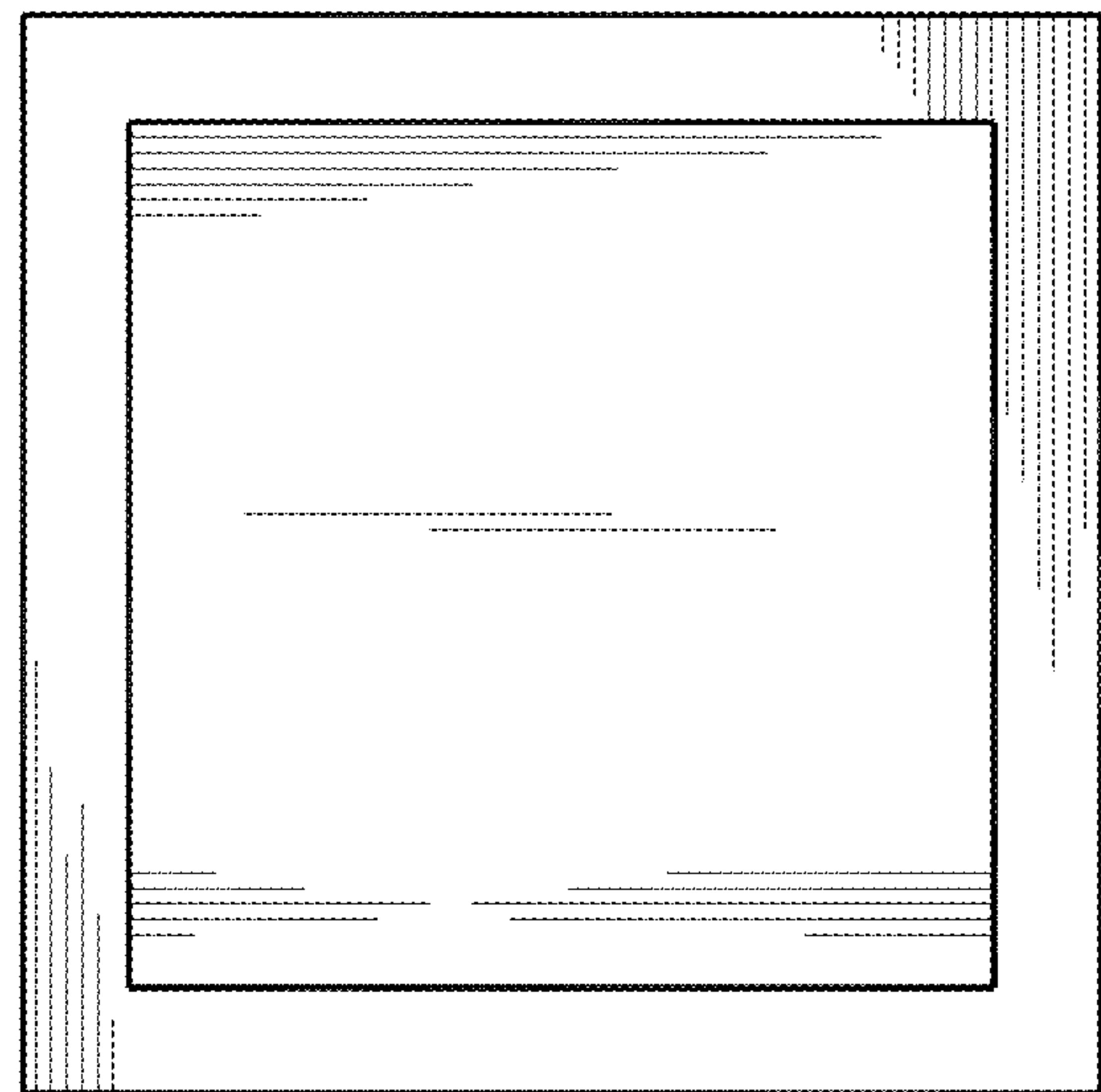
