DESCRIPTION

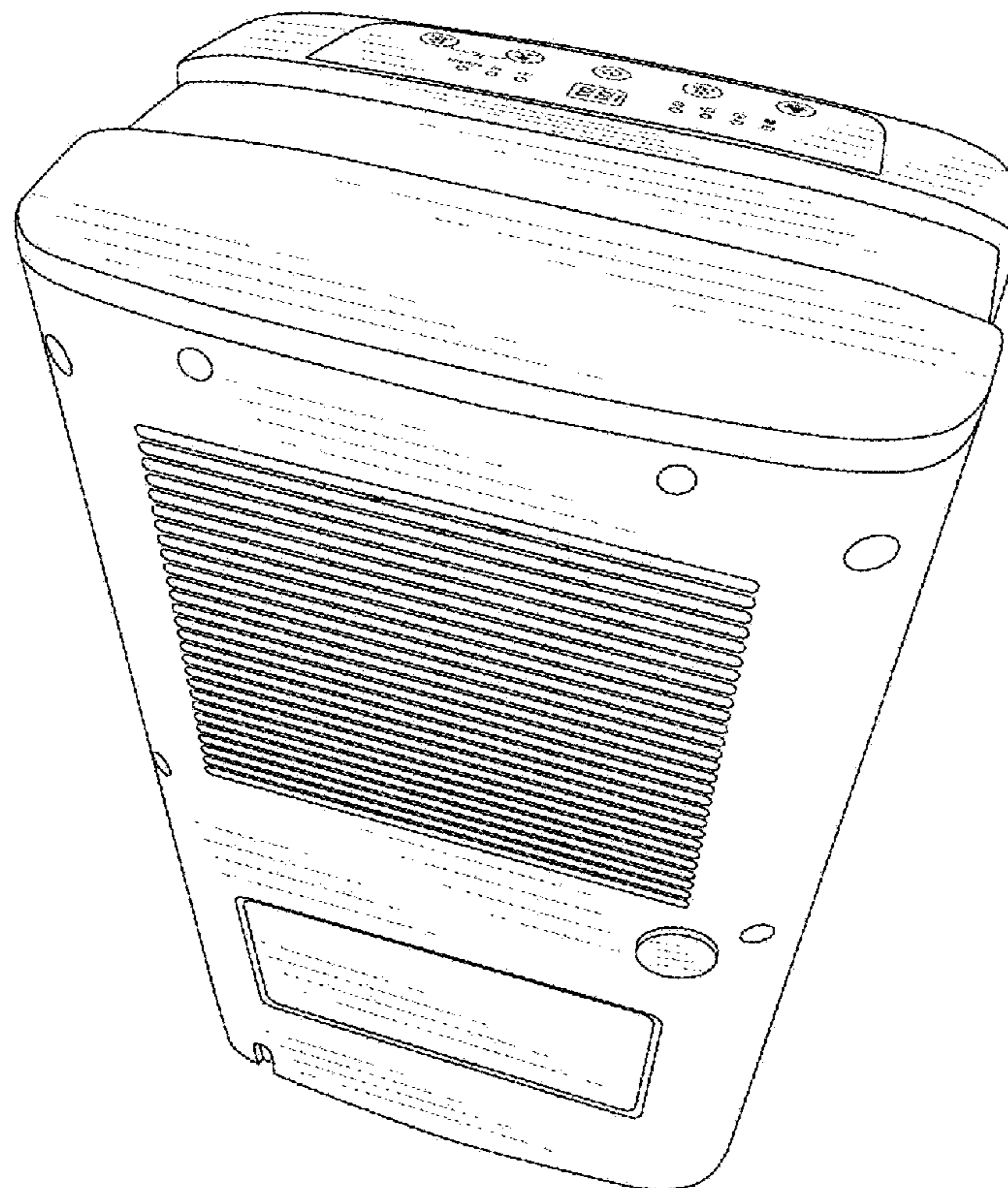
FIG. 1 is a rear and top perspective view of a dehumidifier showing my new design;

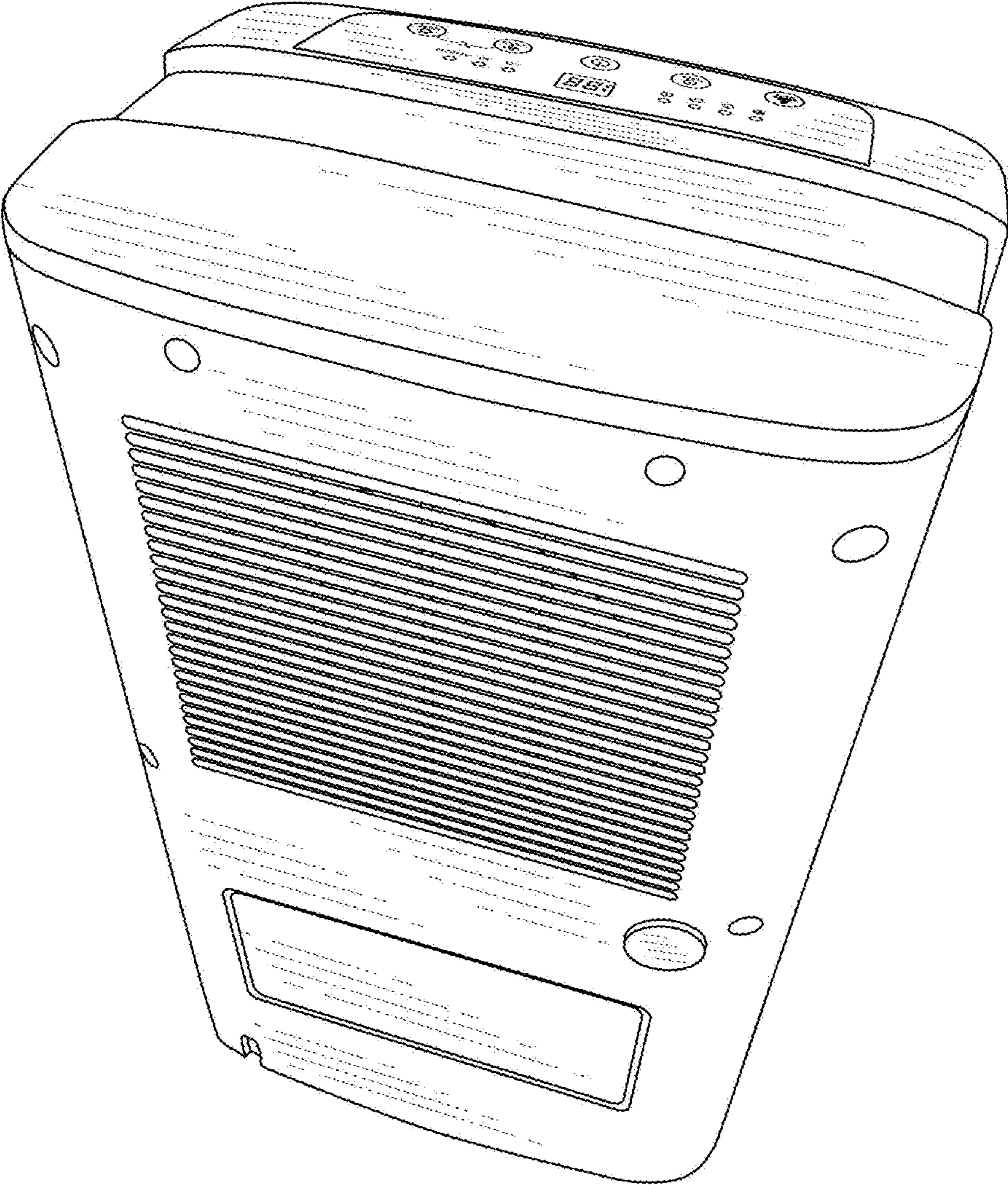

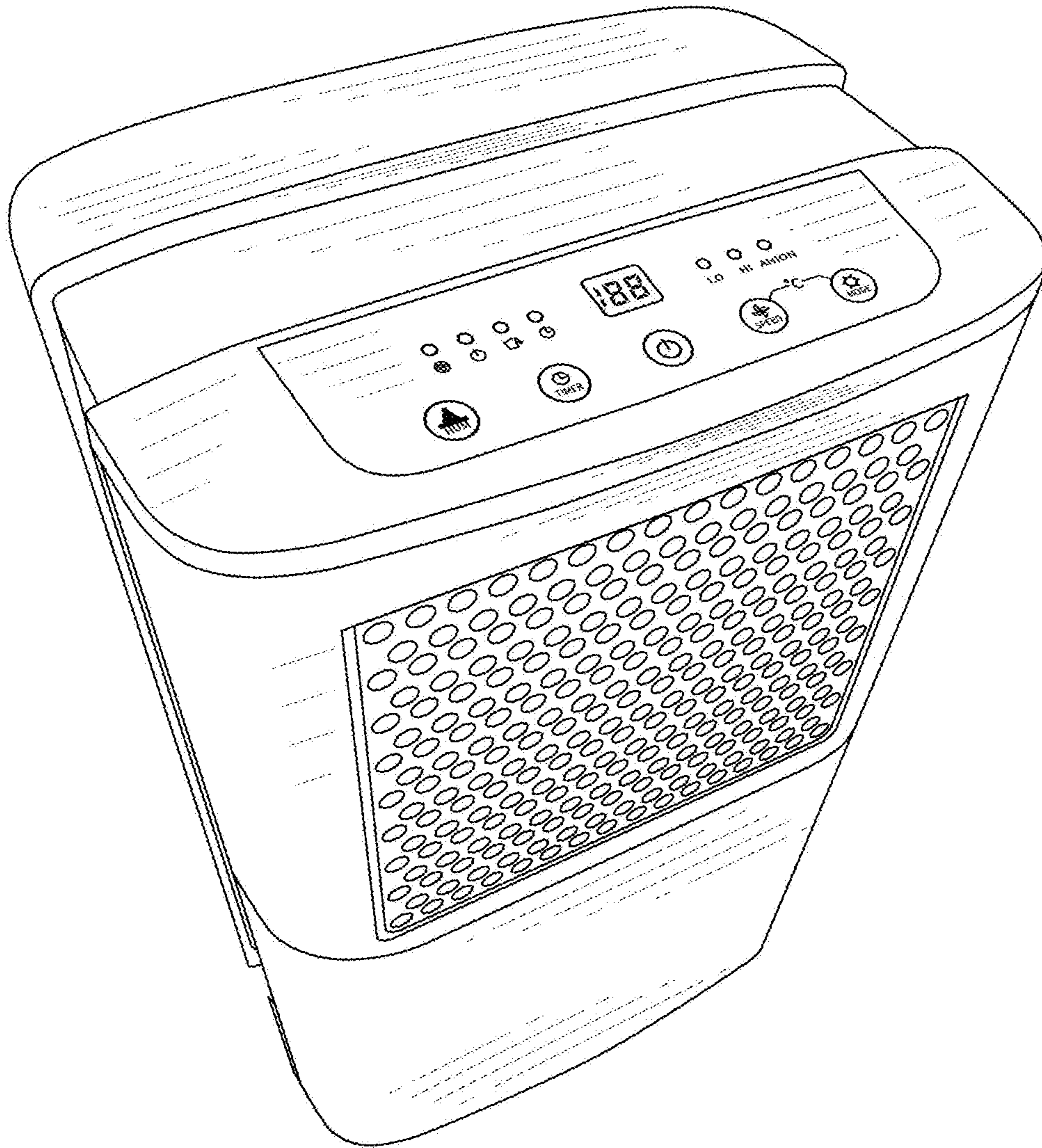

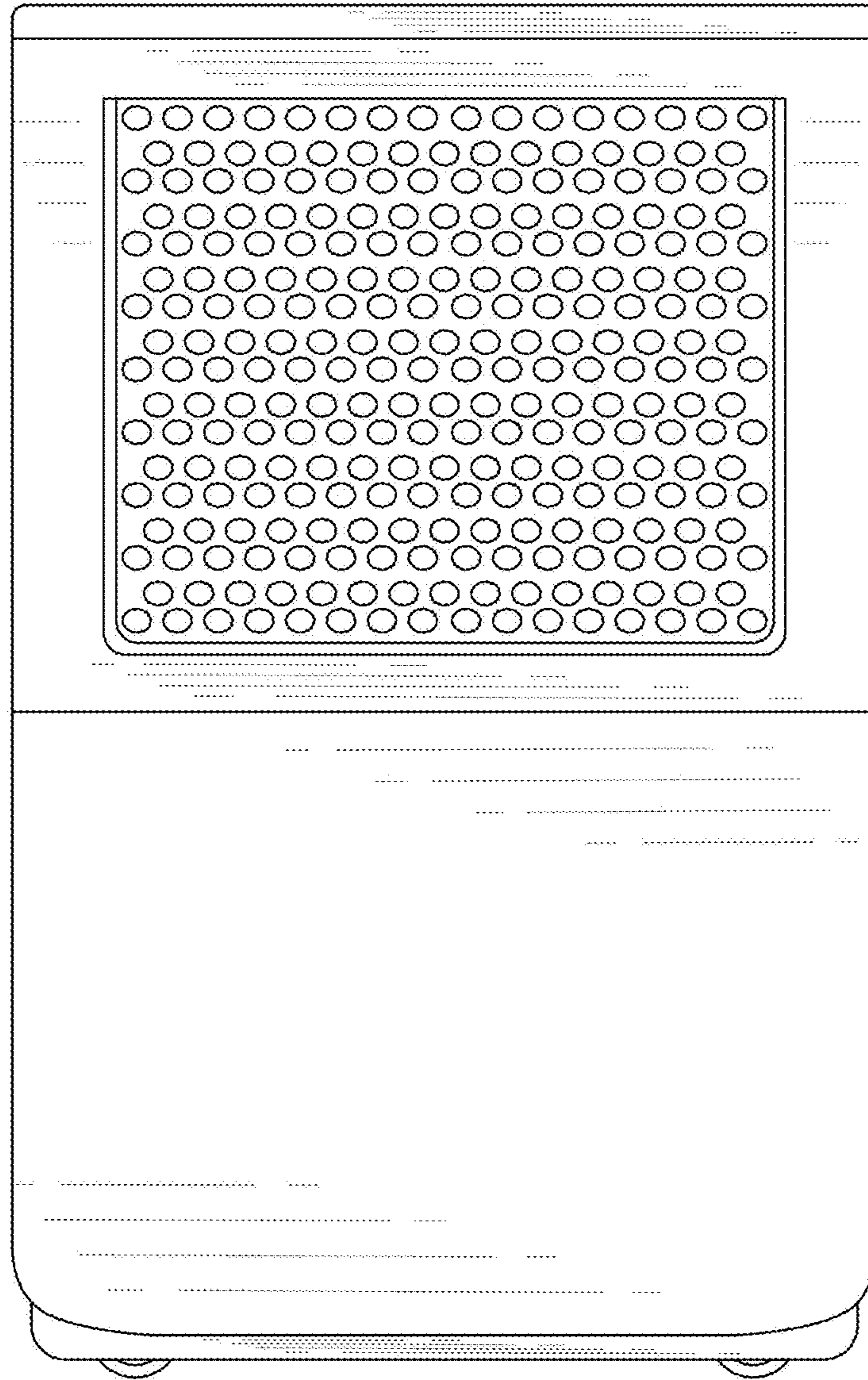

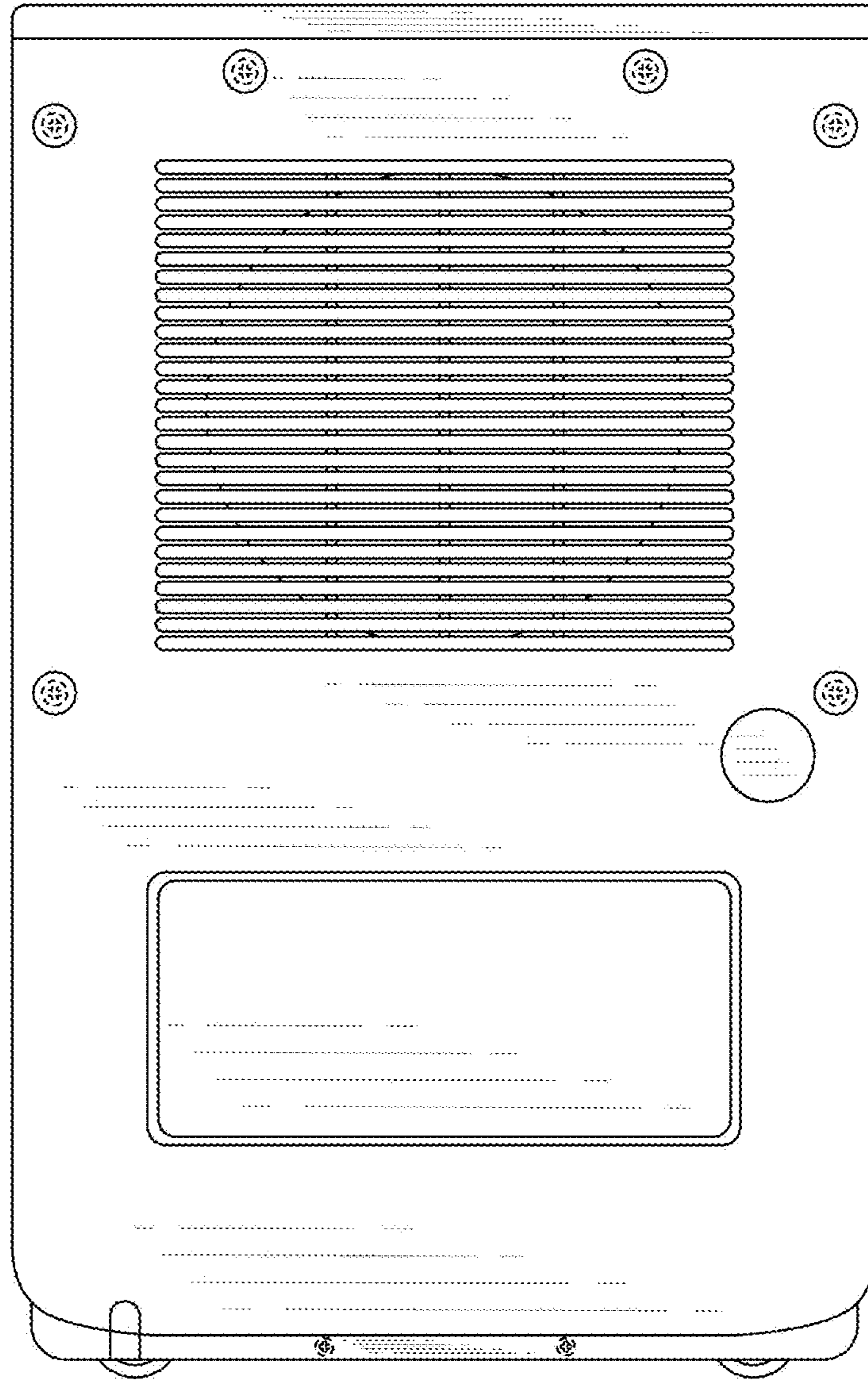

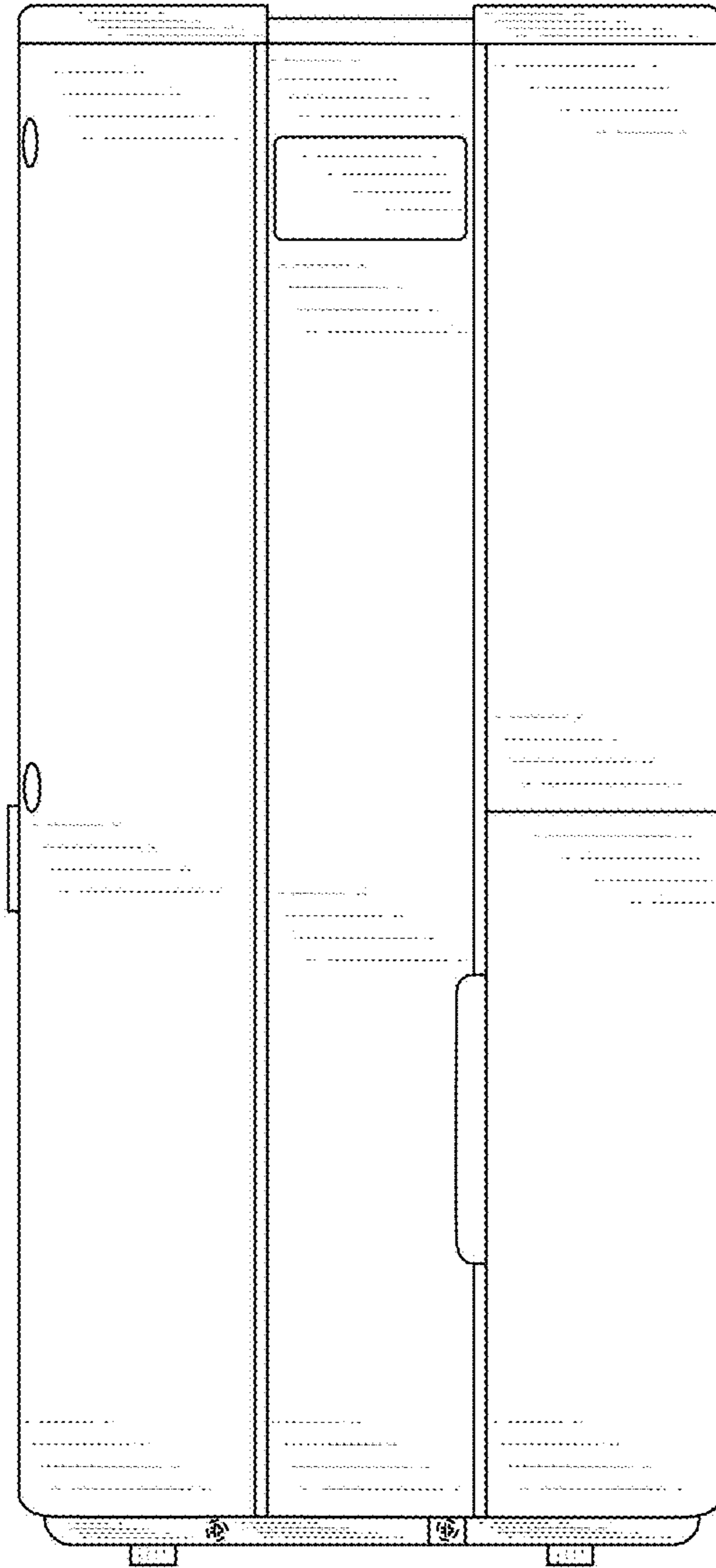

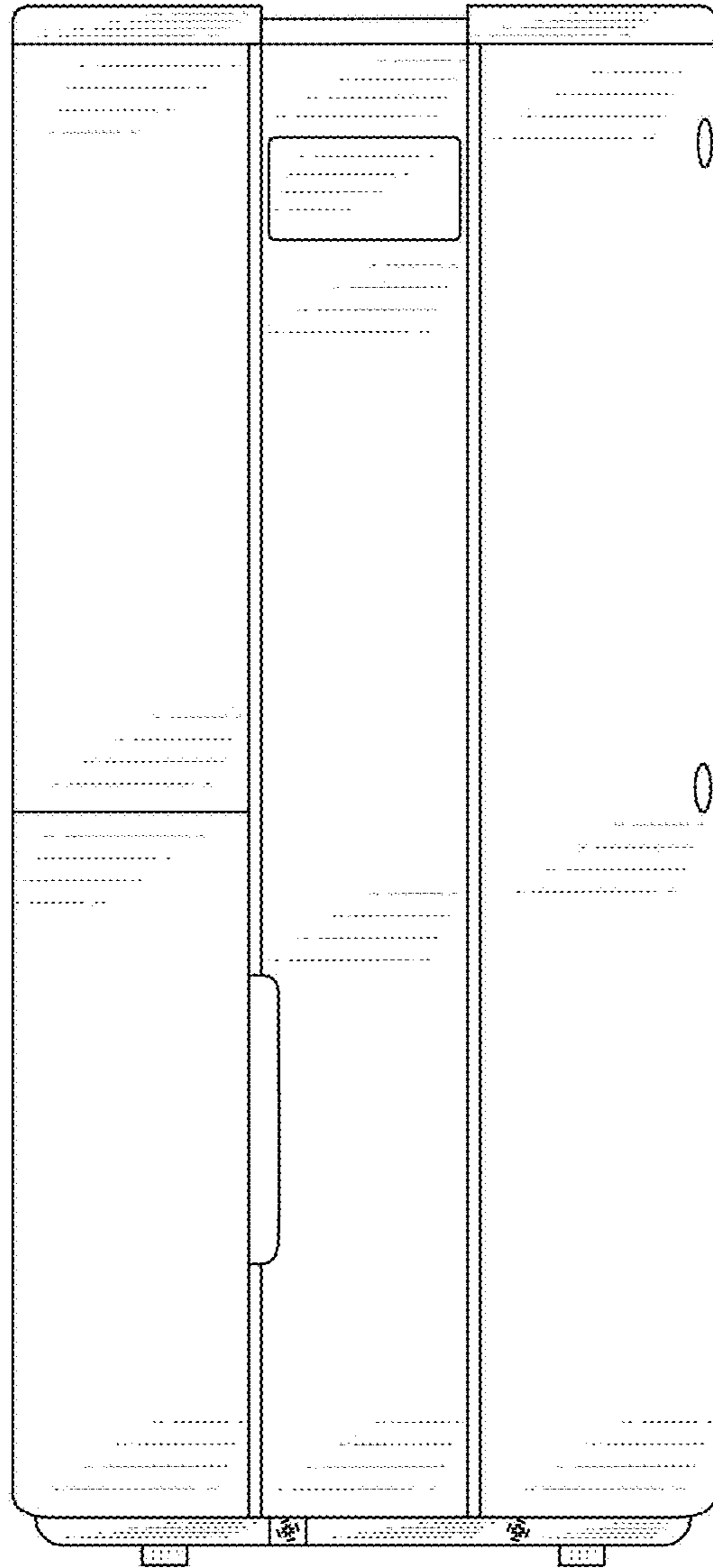

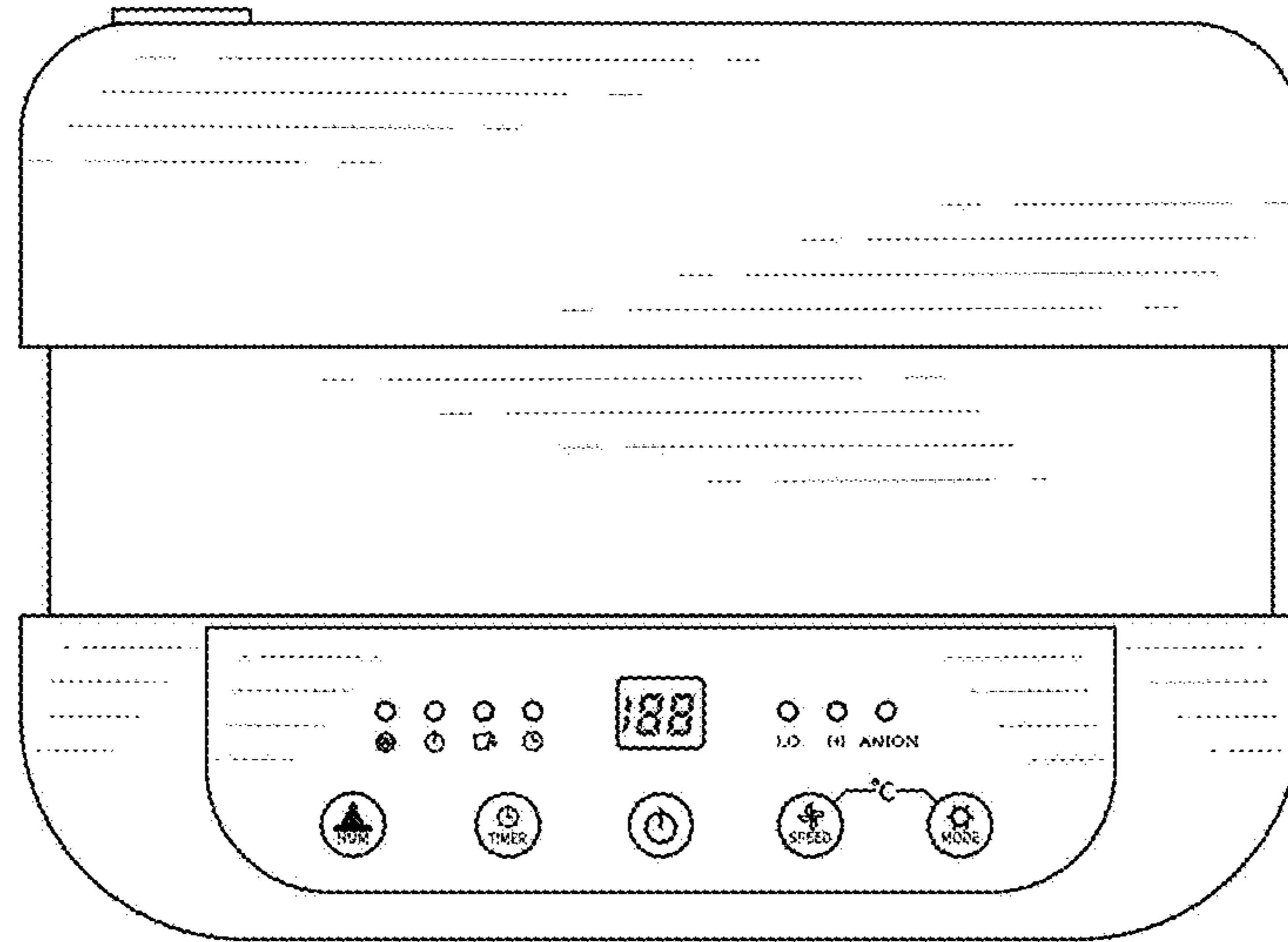

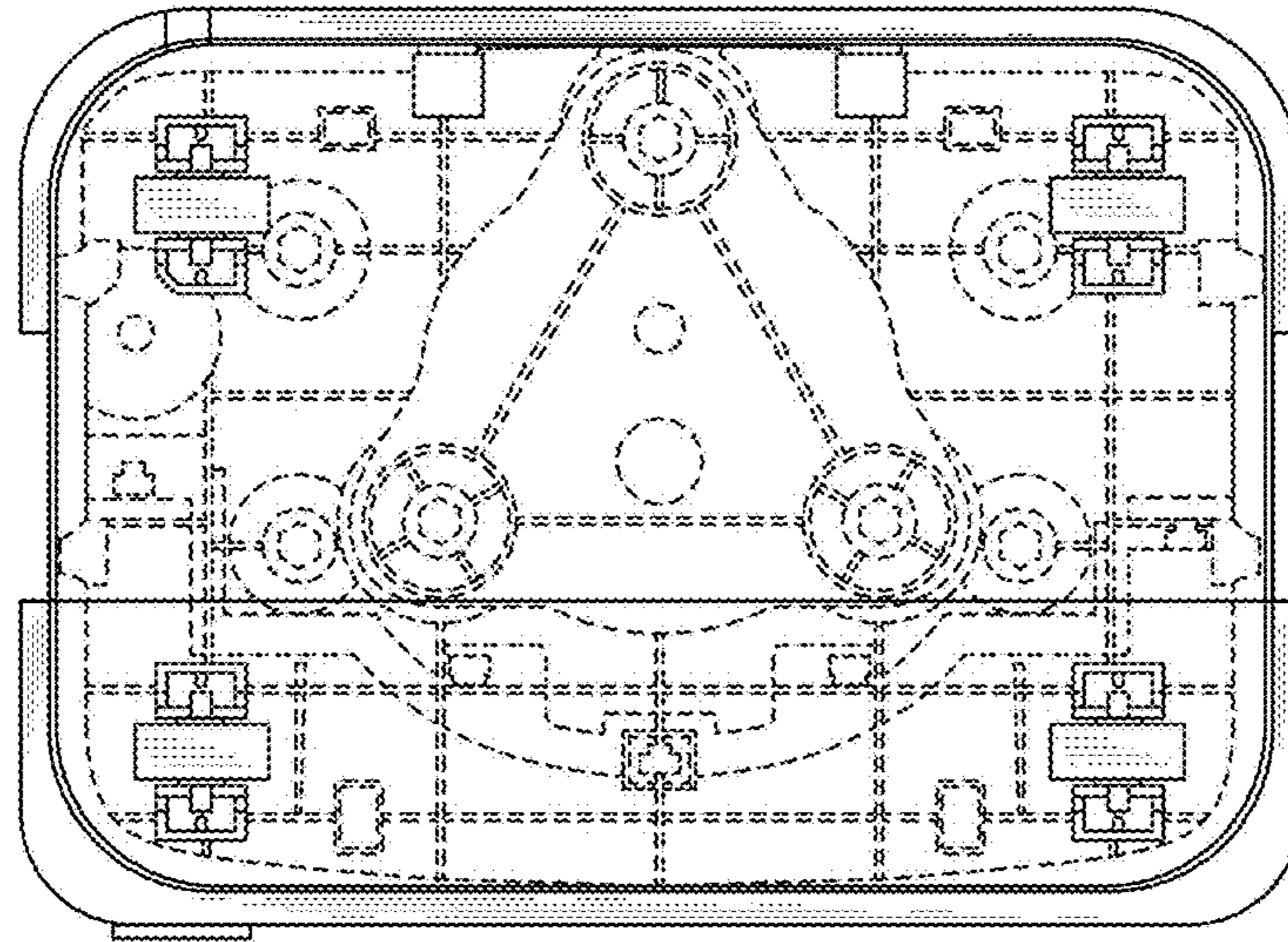
