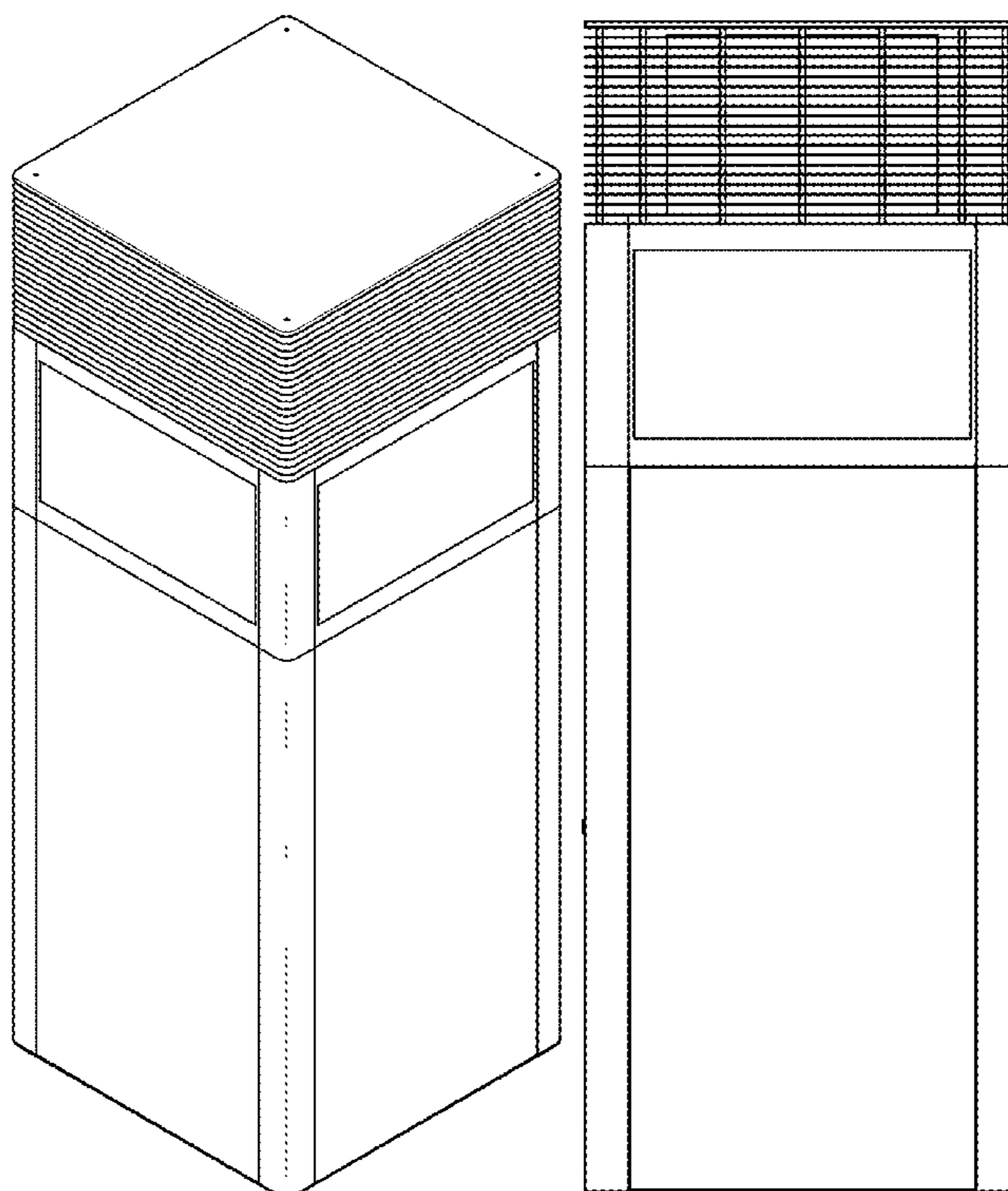

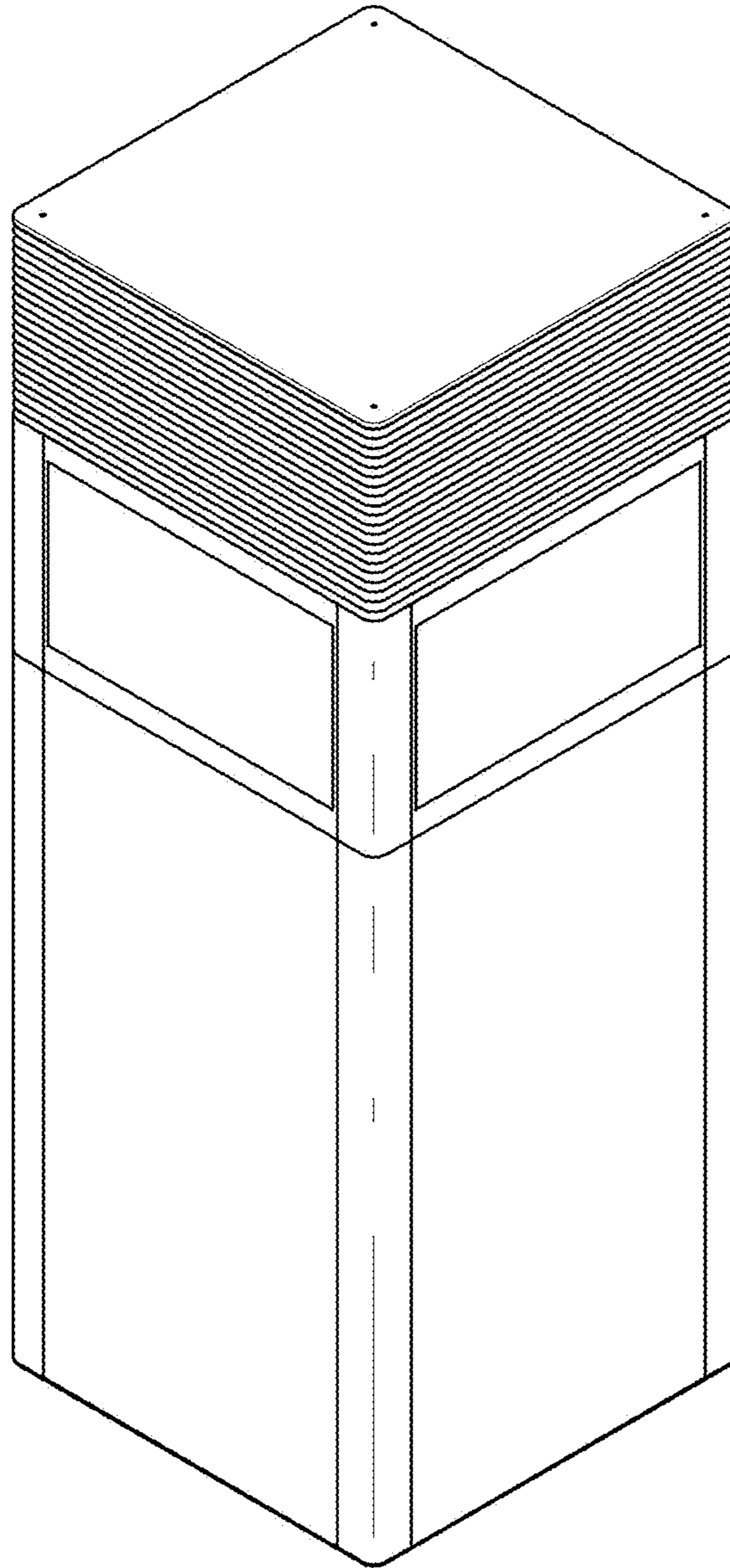

An air purifier with 4-way discharging ports in upper part of the body is shown in the reproductions.

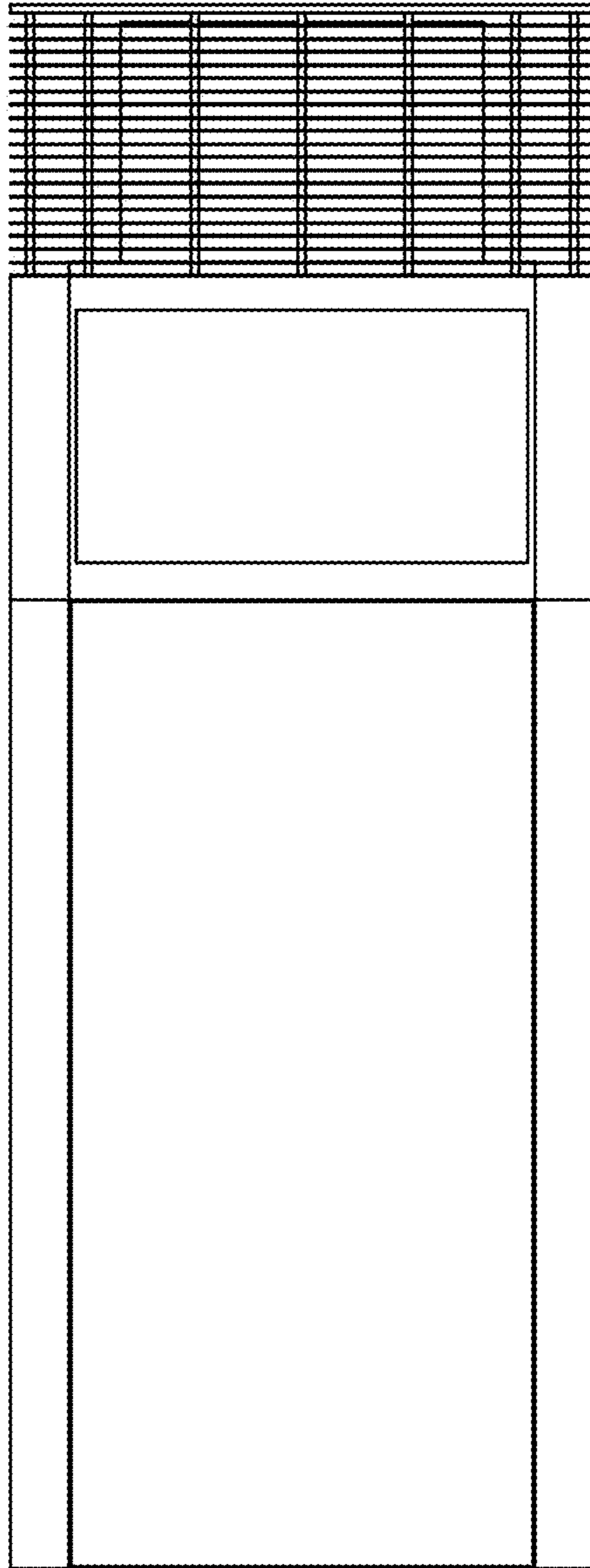

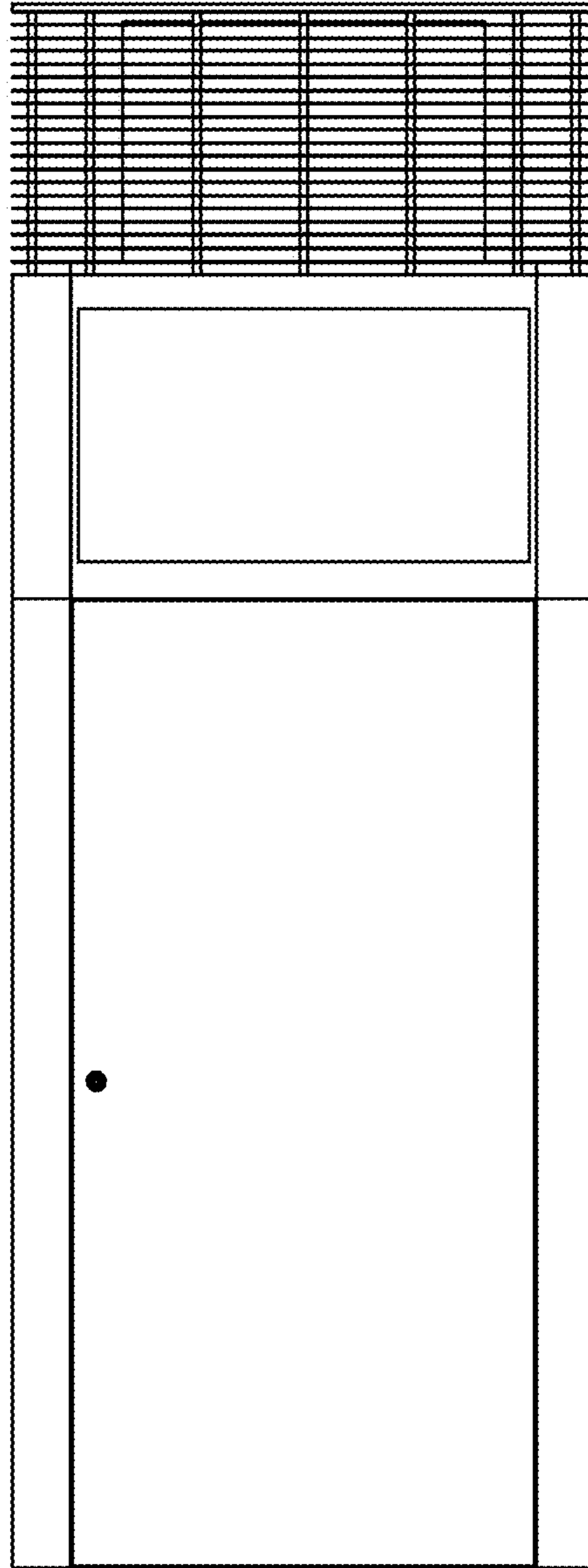

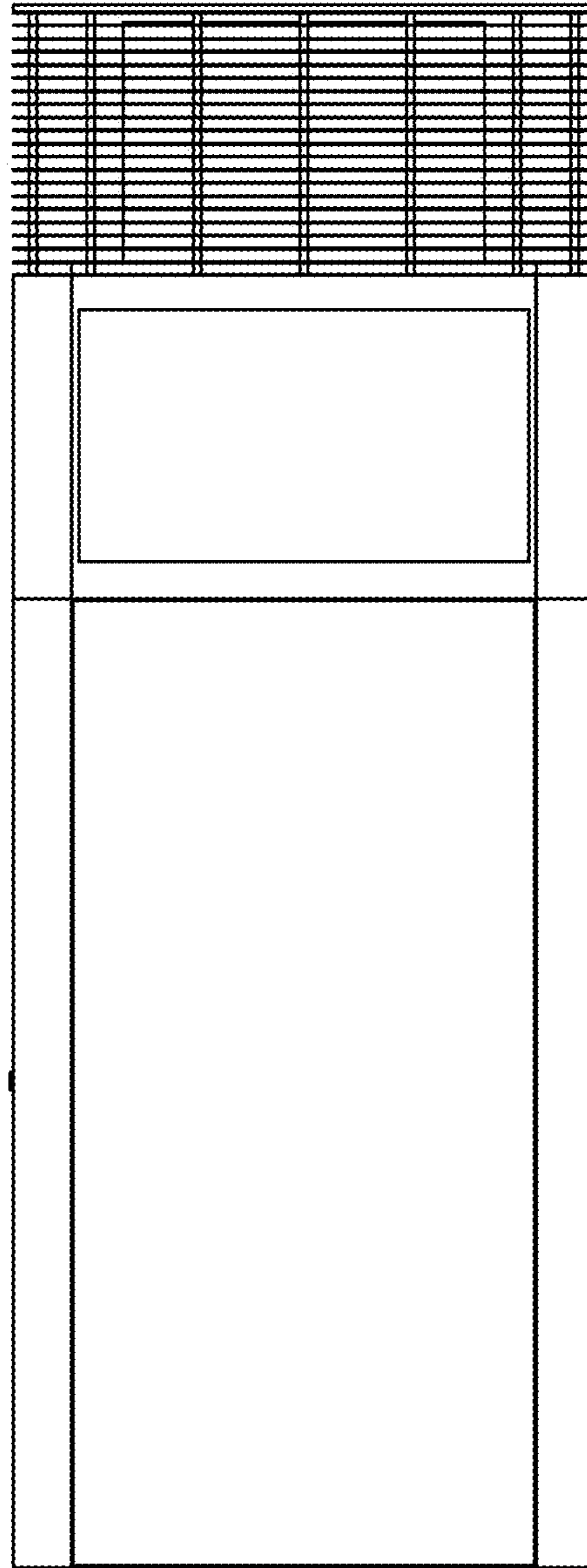

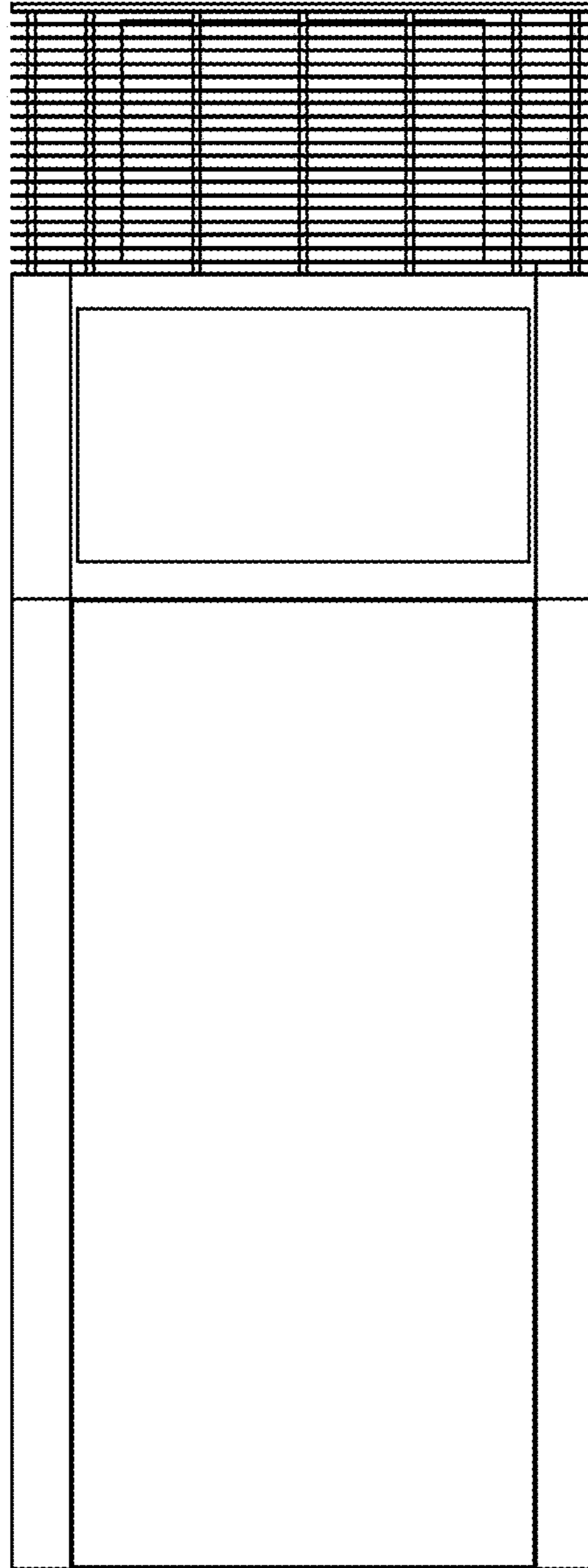

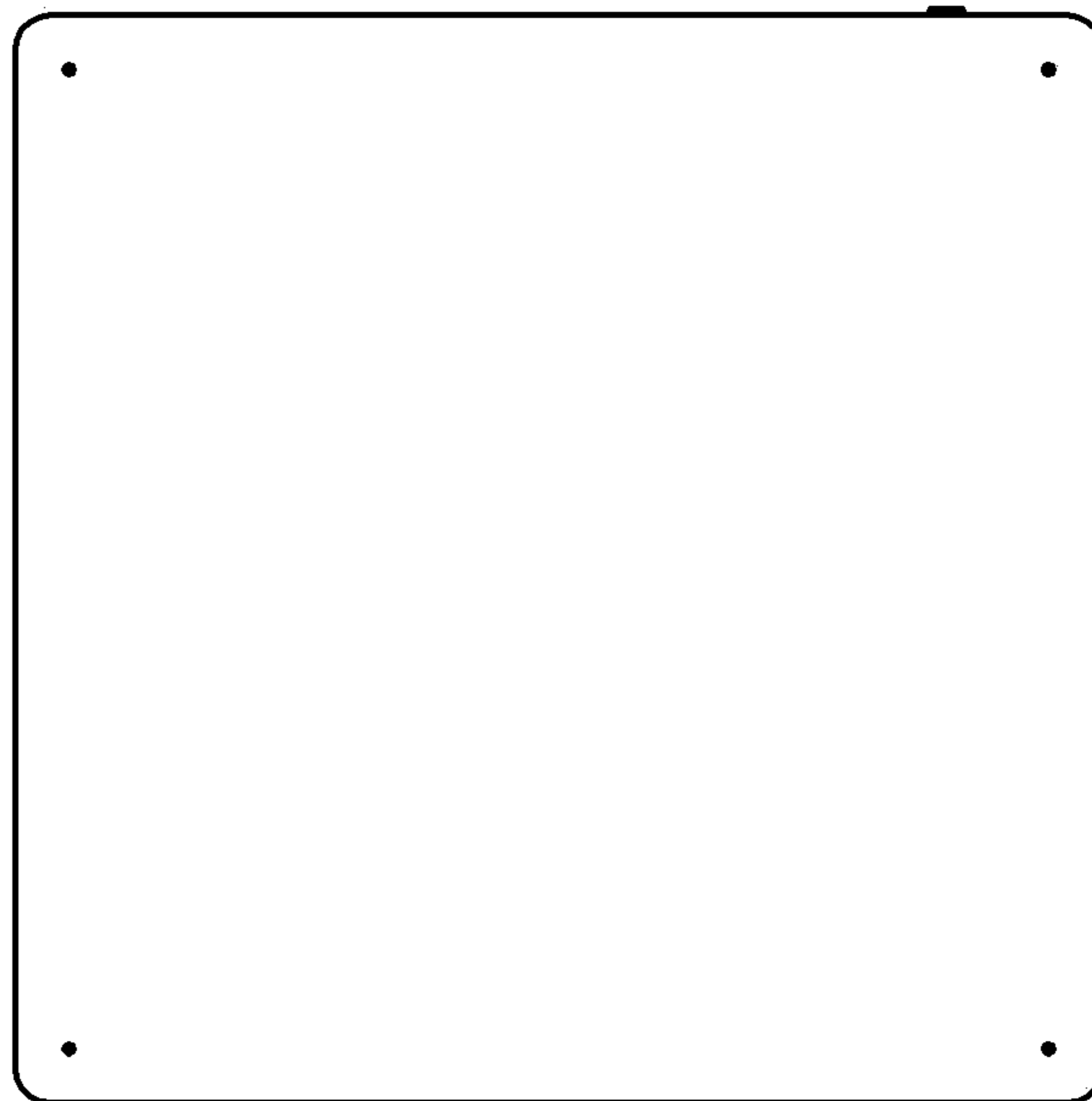
