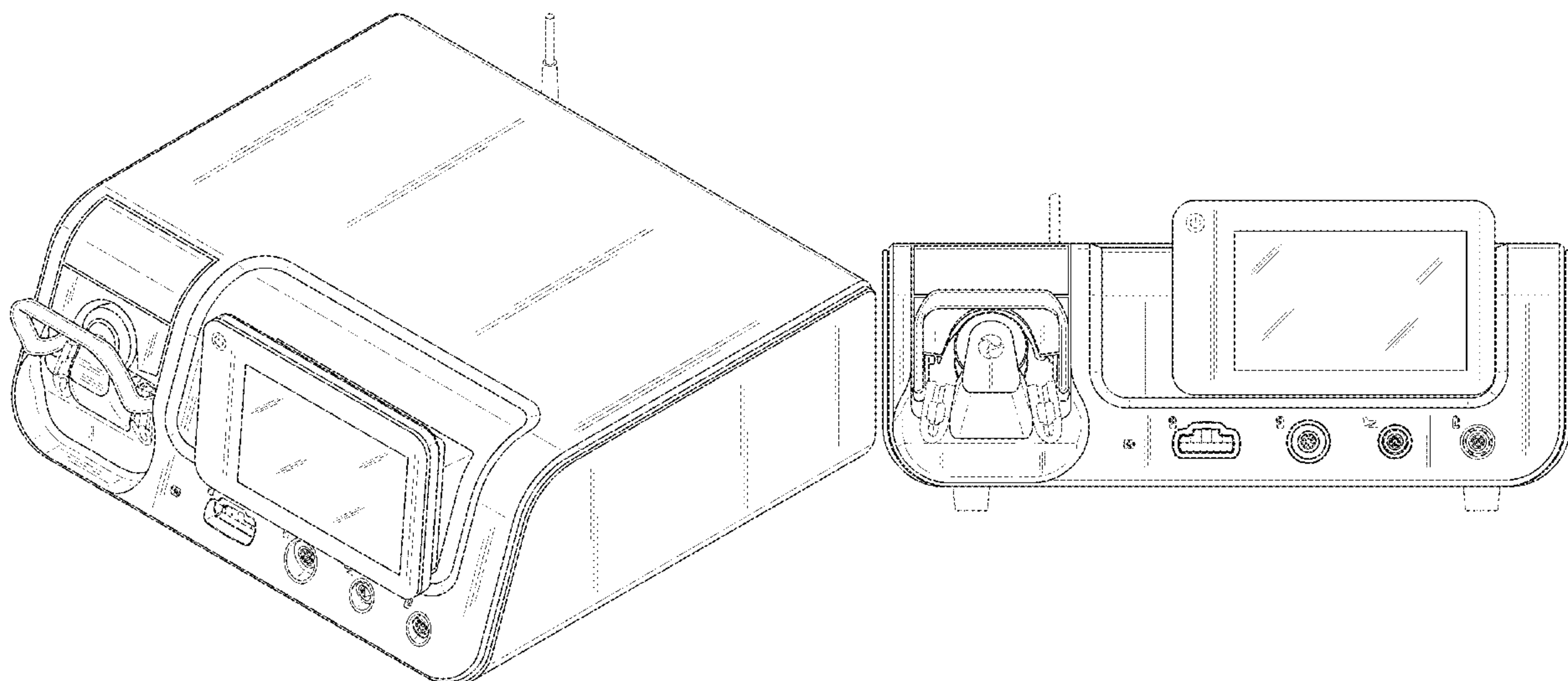
The ornamental design for a combined controller, as shown and described.

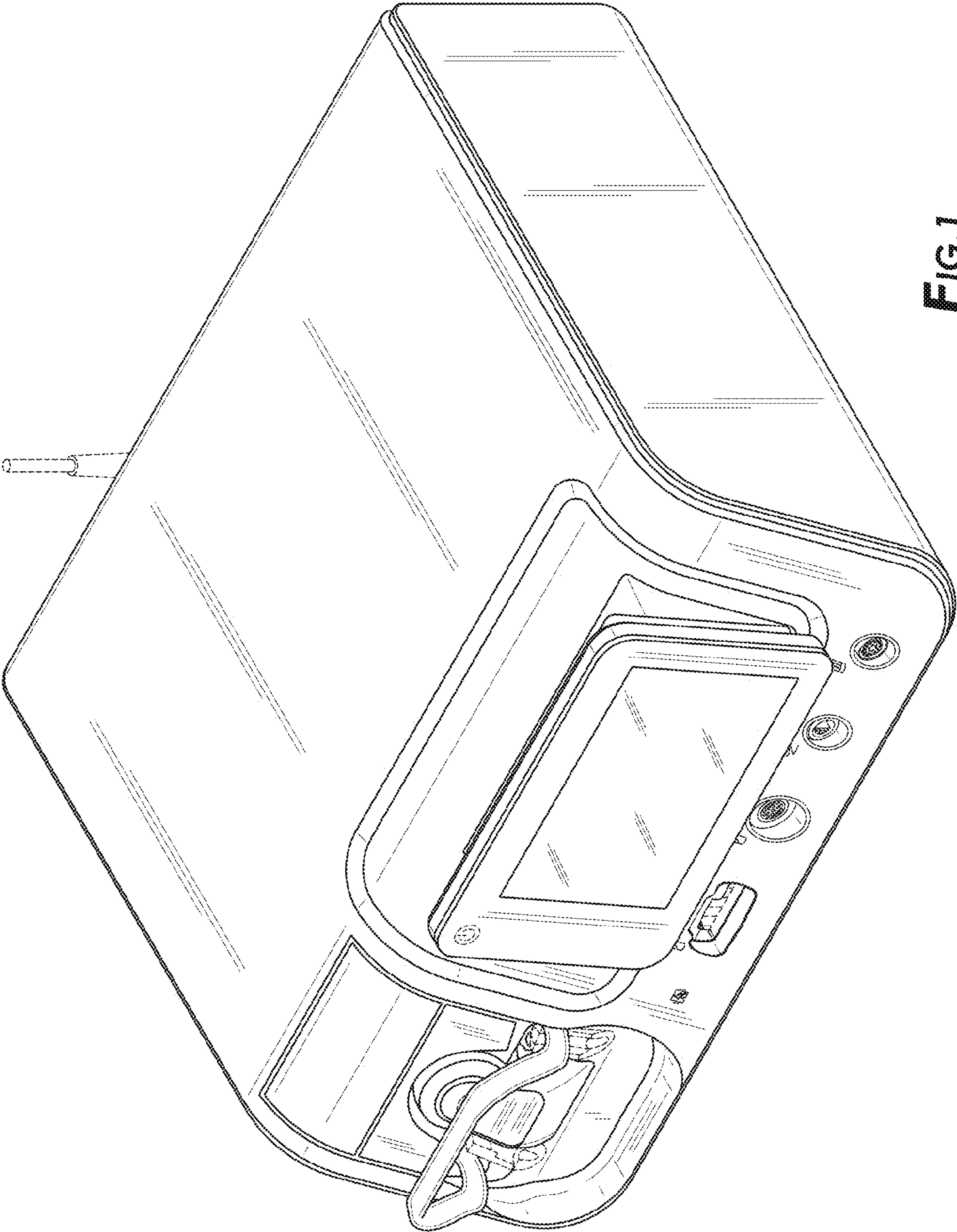

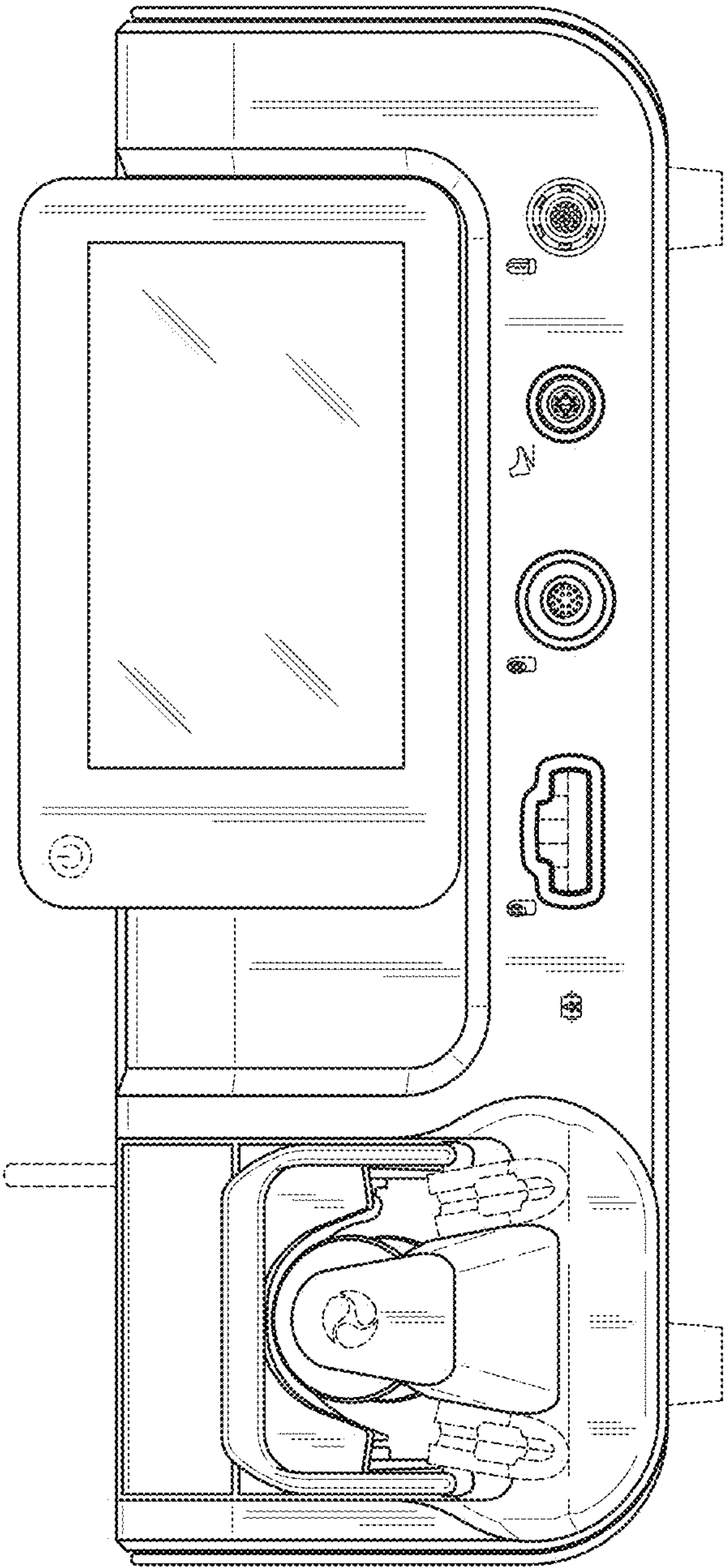

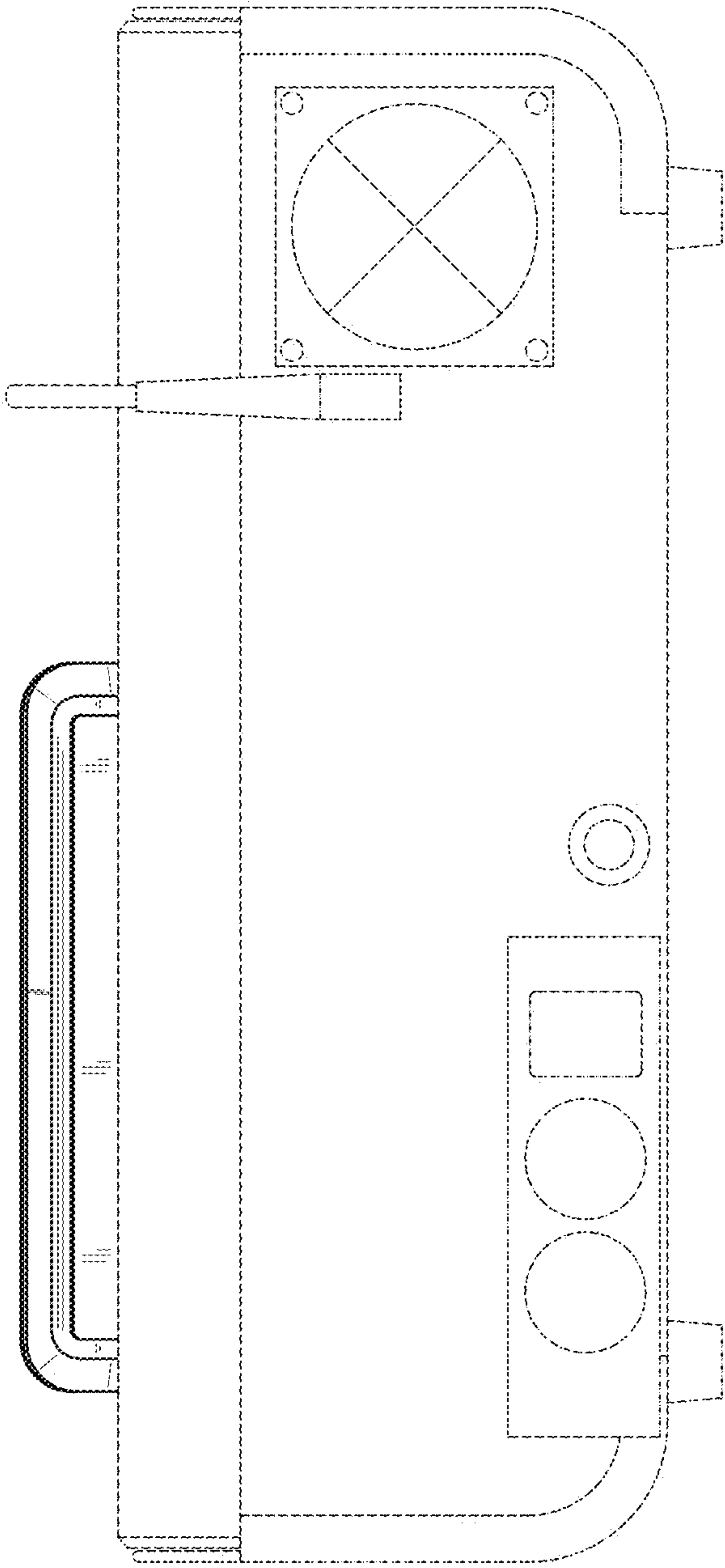

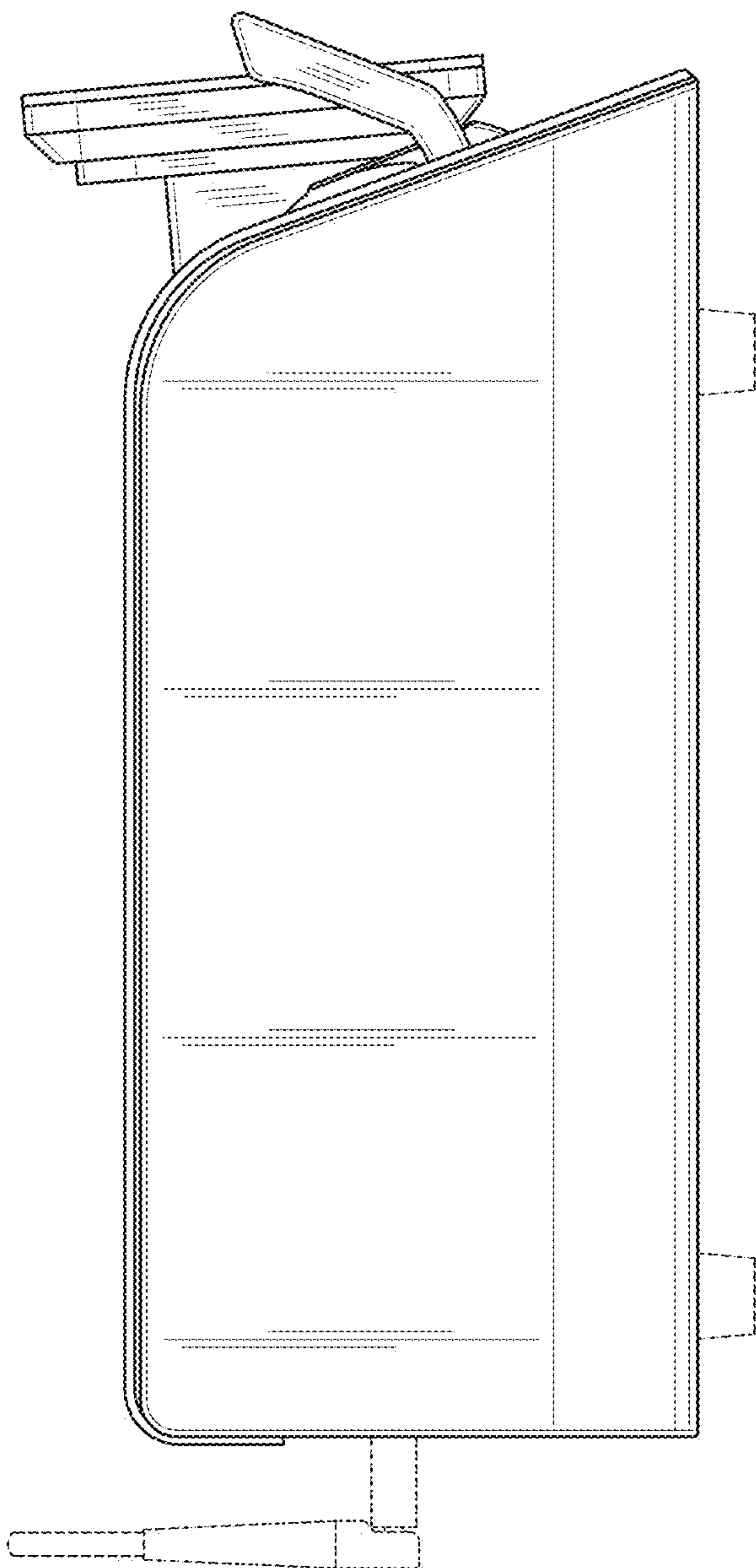

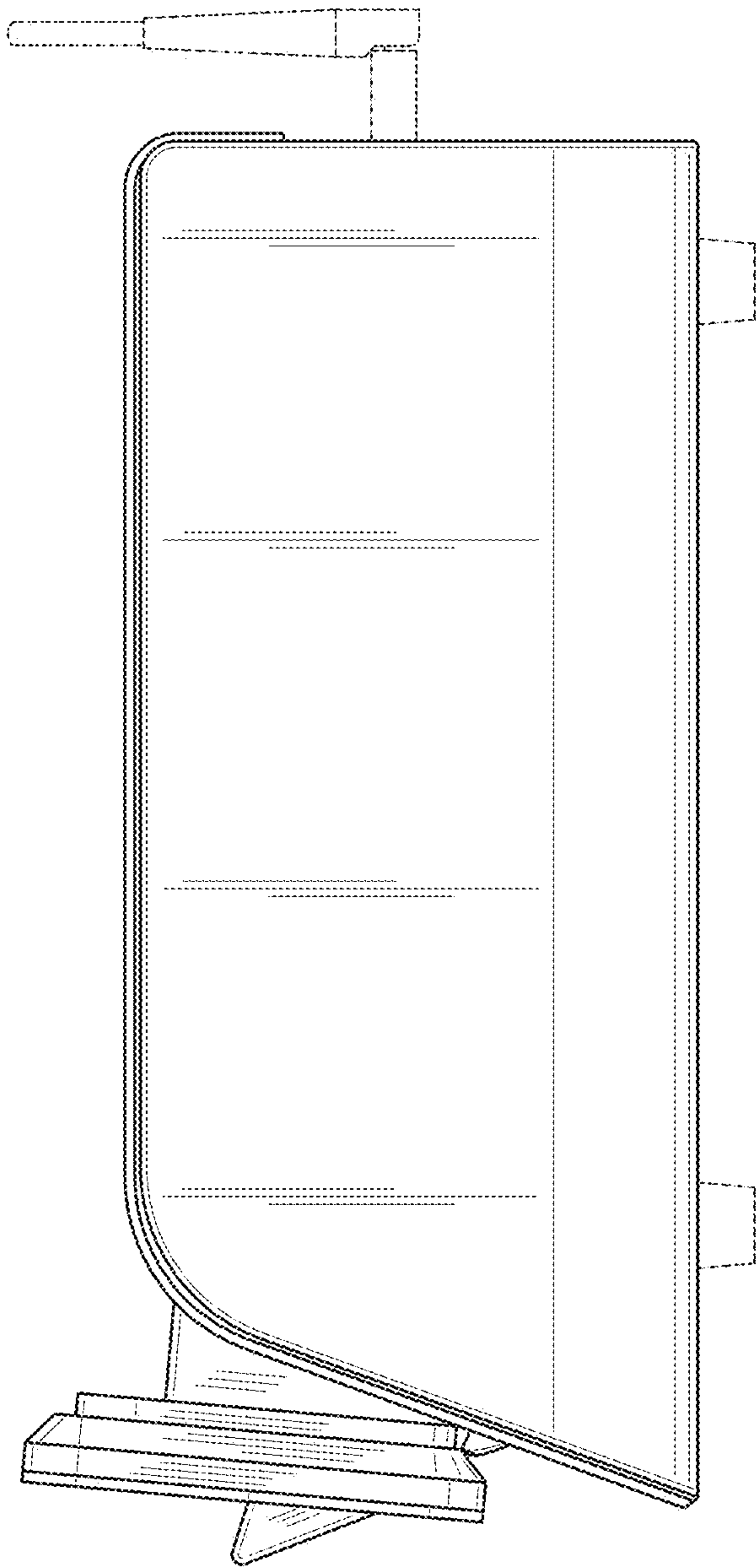

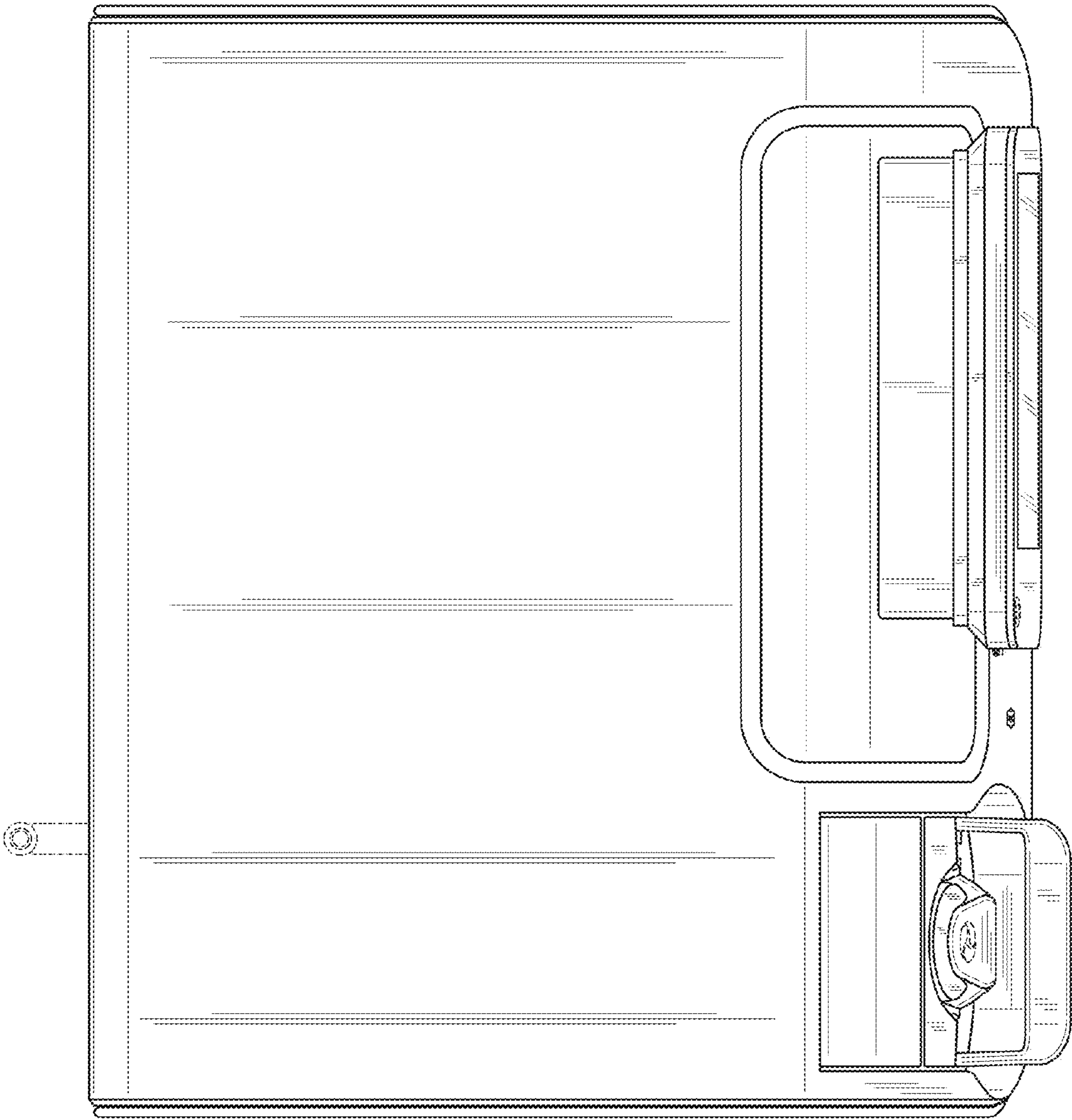

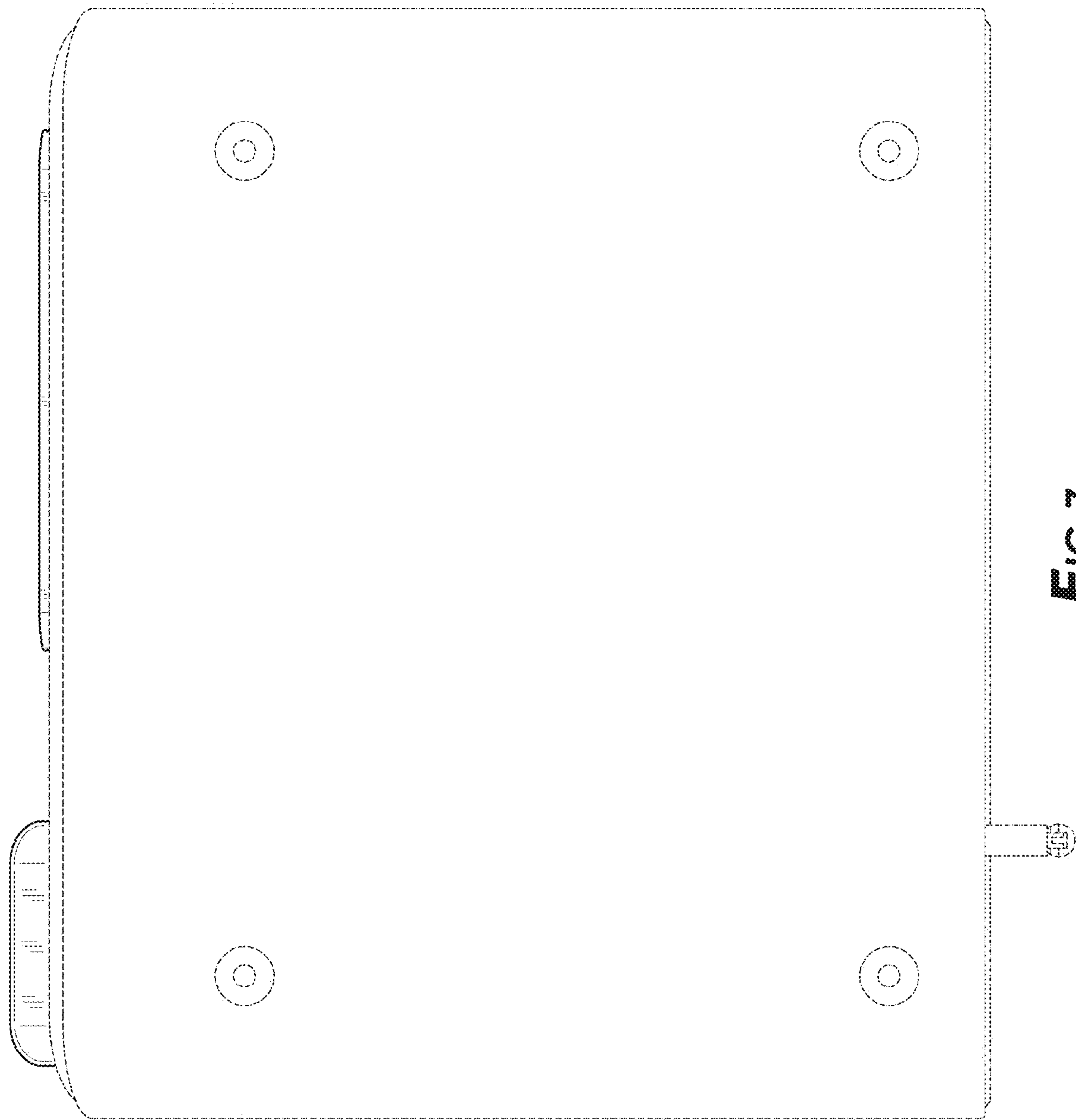
