FIG. 9 is a top, front and right side perspective view showing the paraffin wax warmer in a use state.

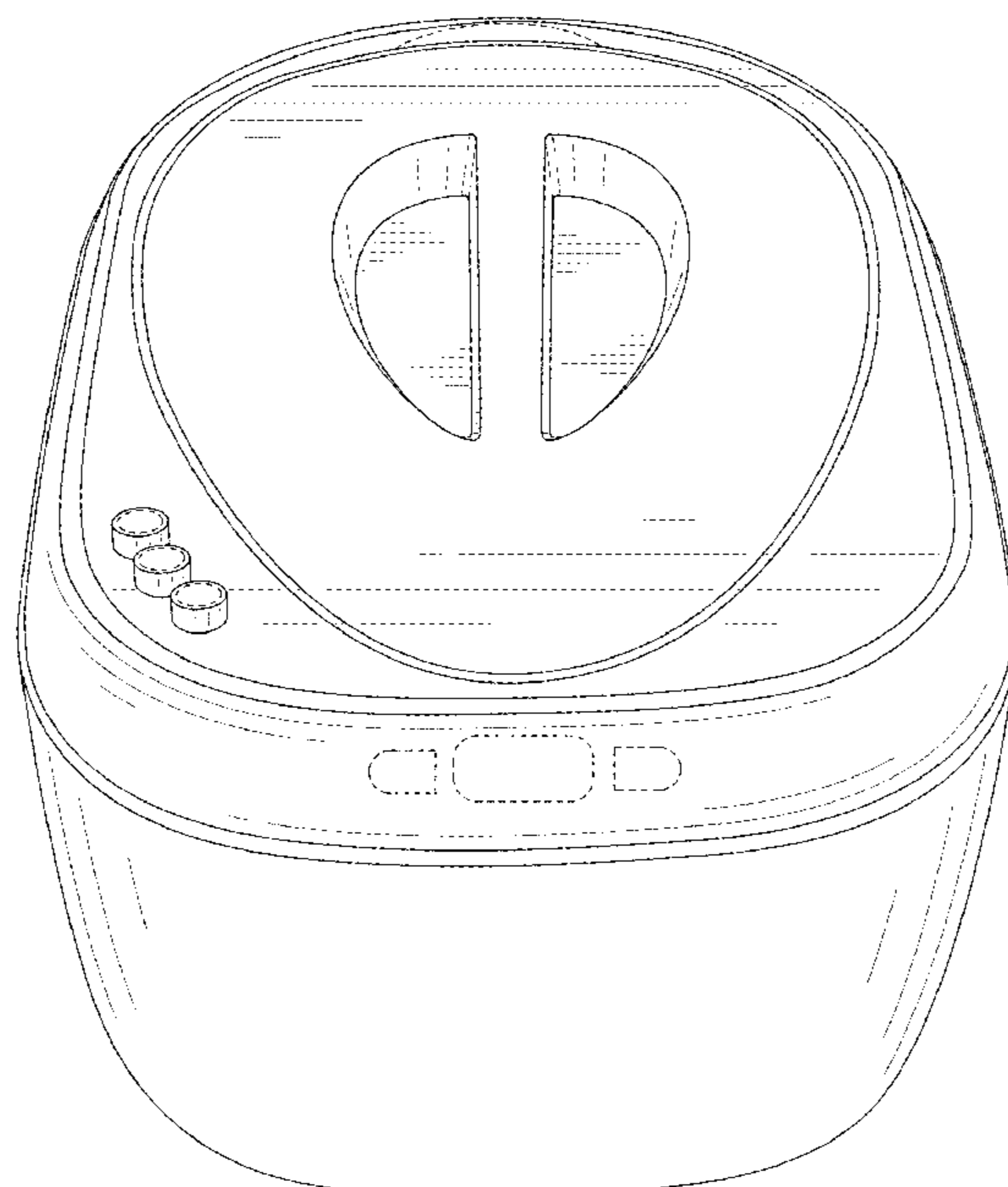

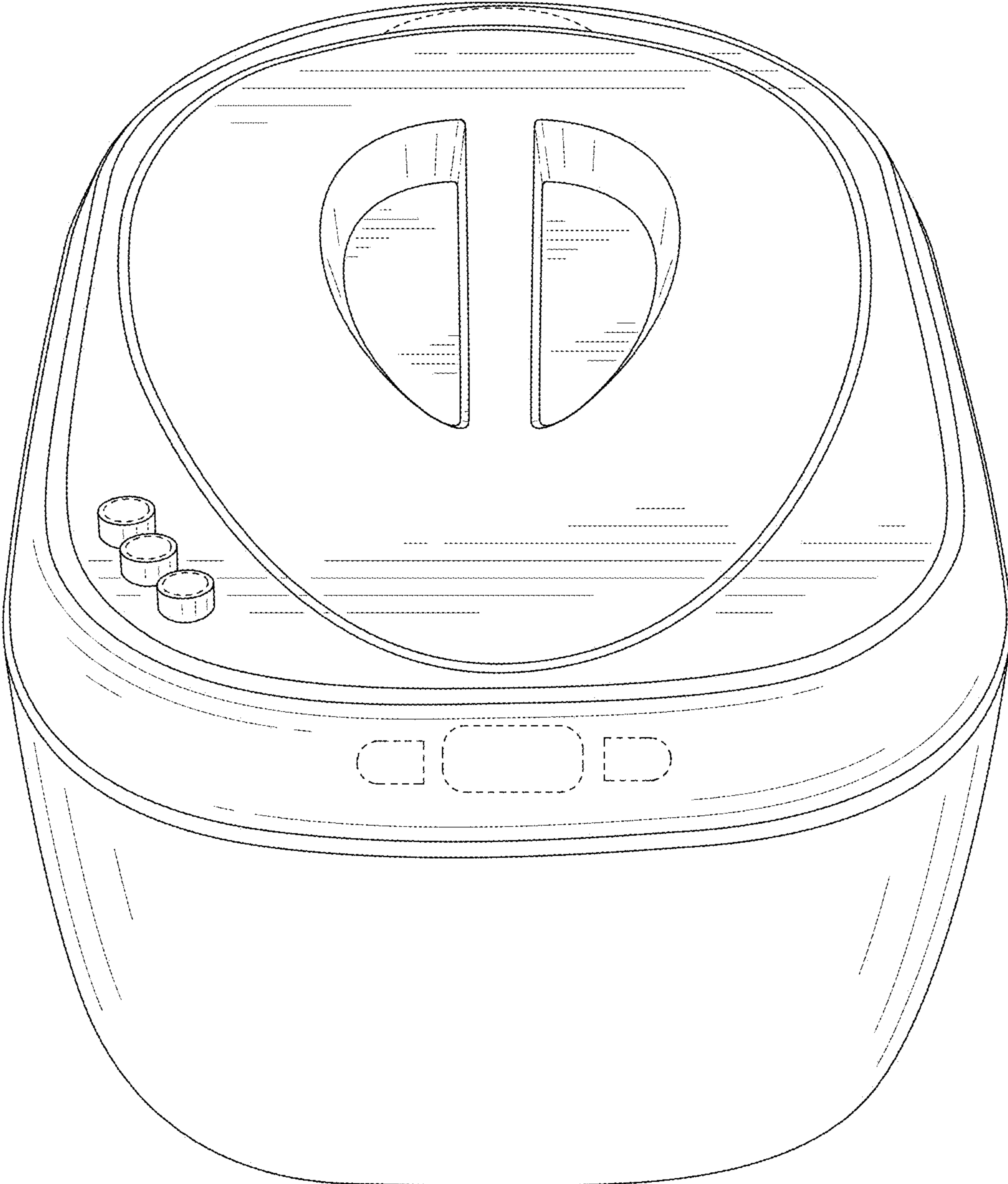

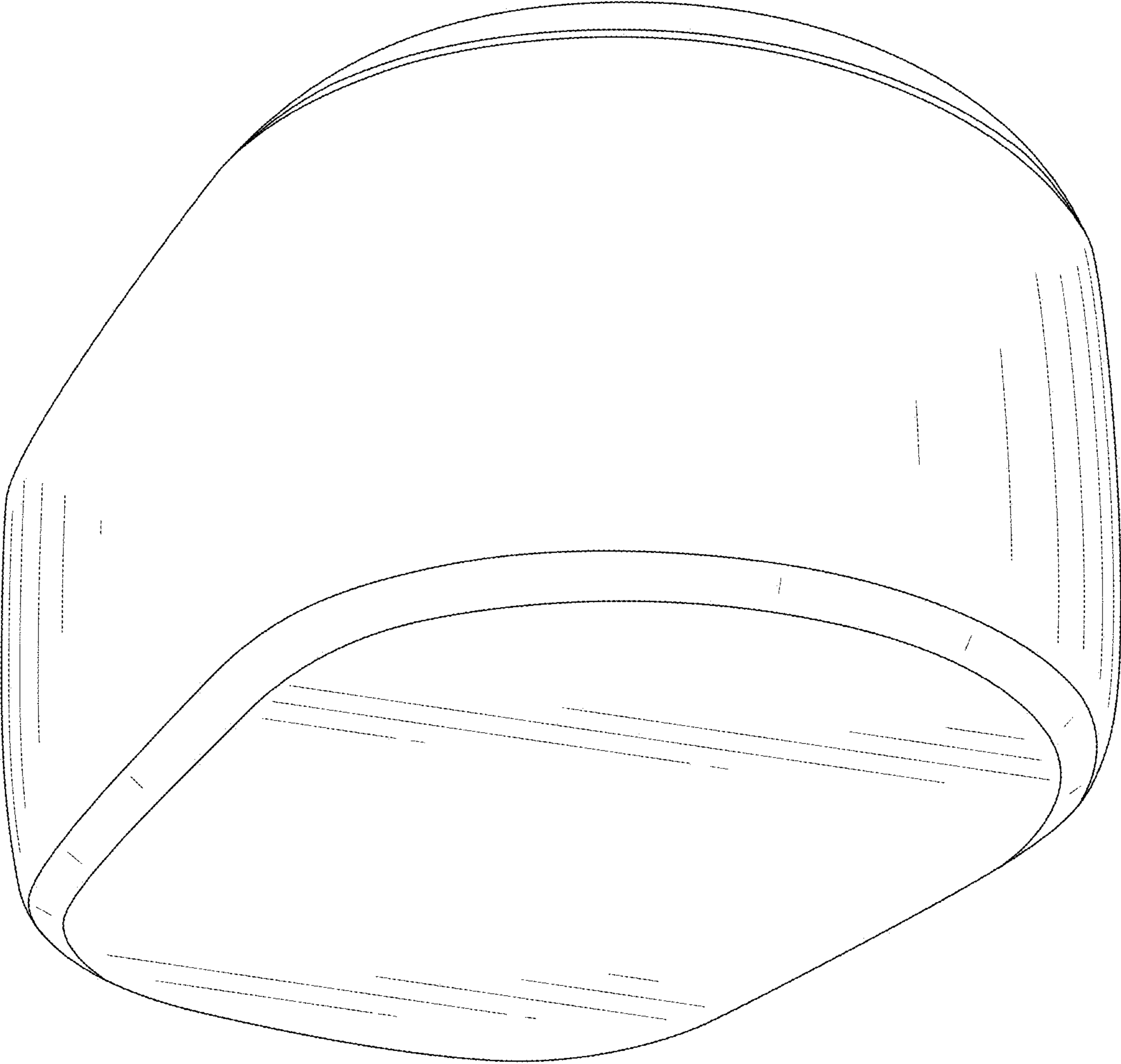

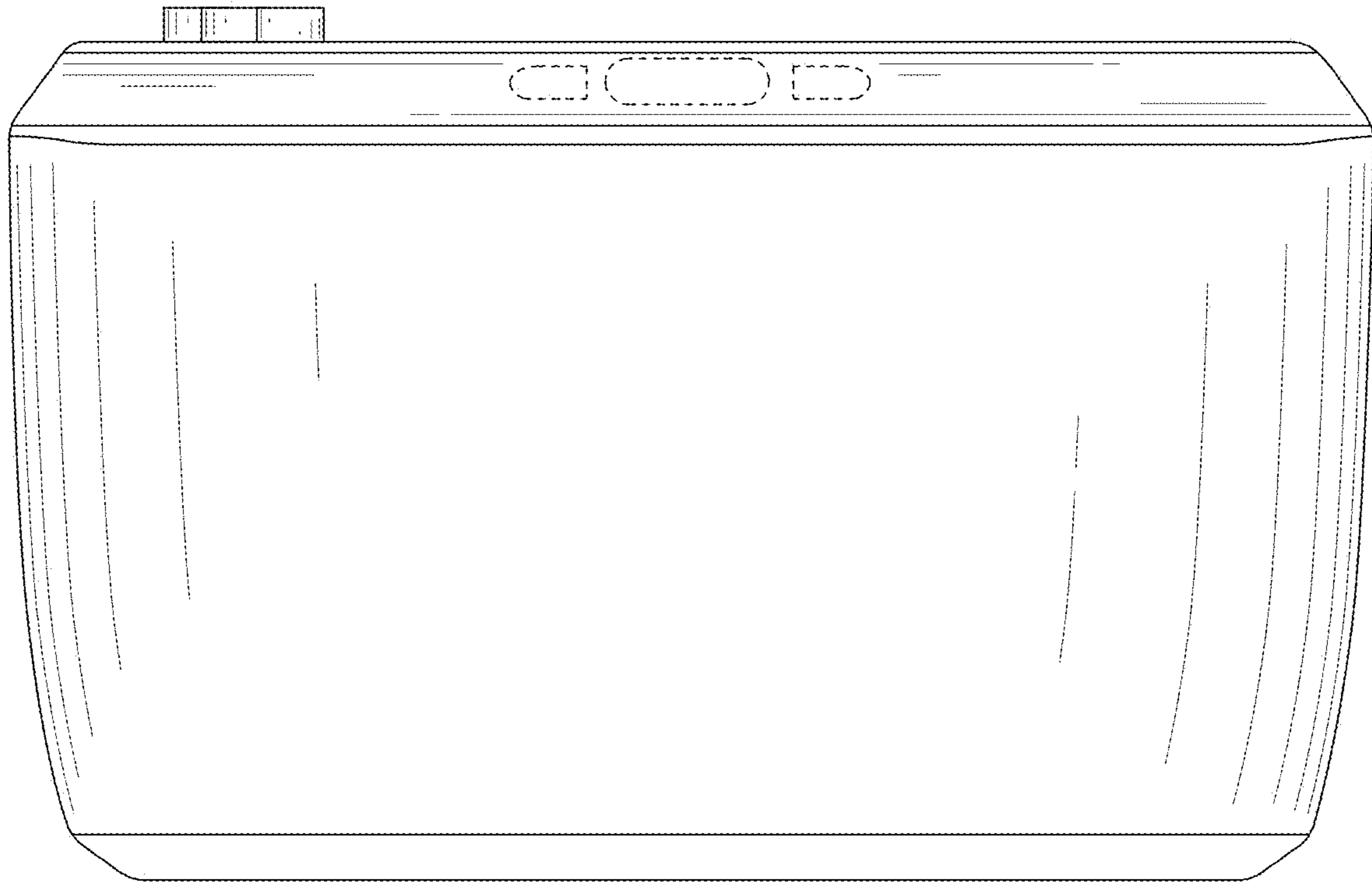

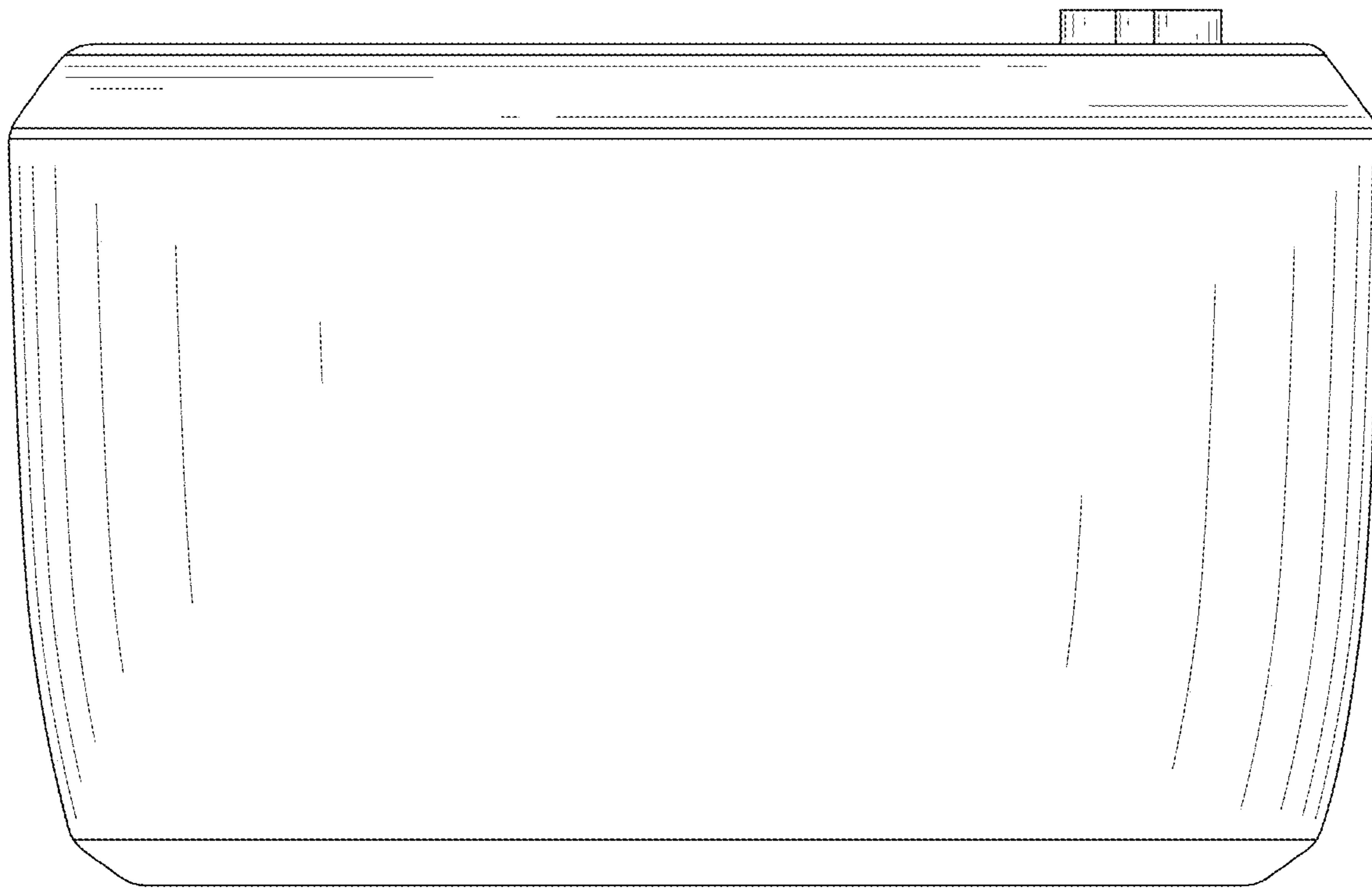

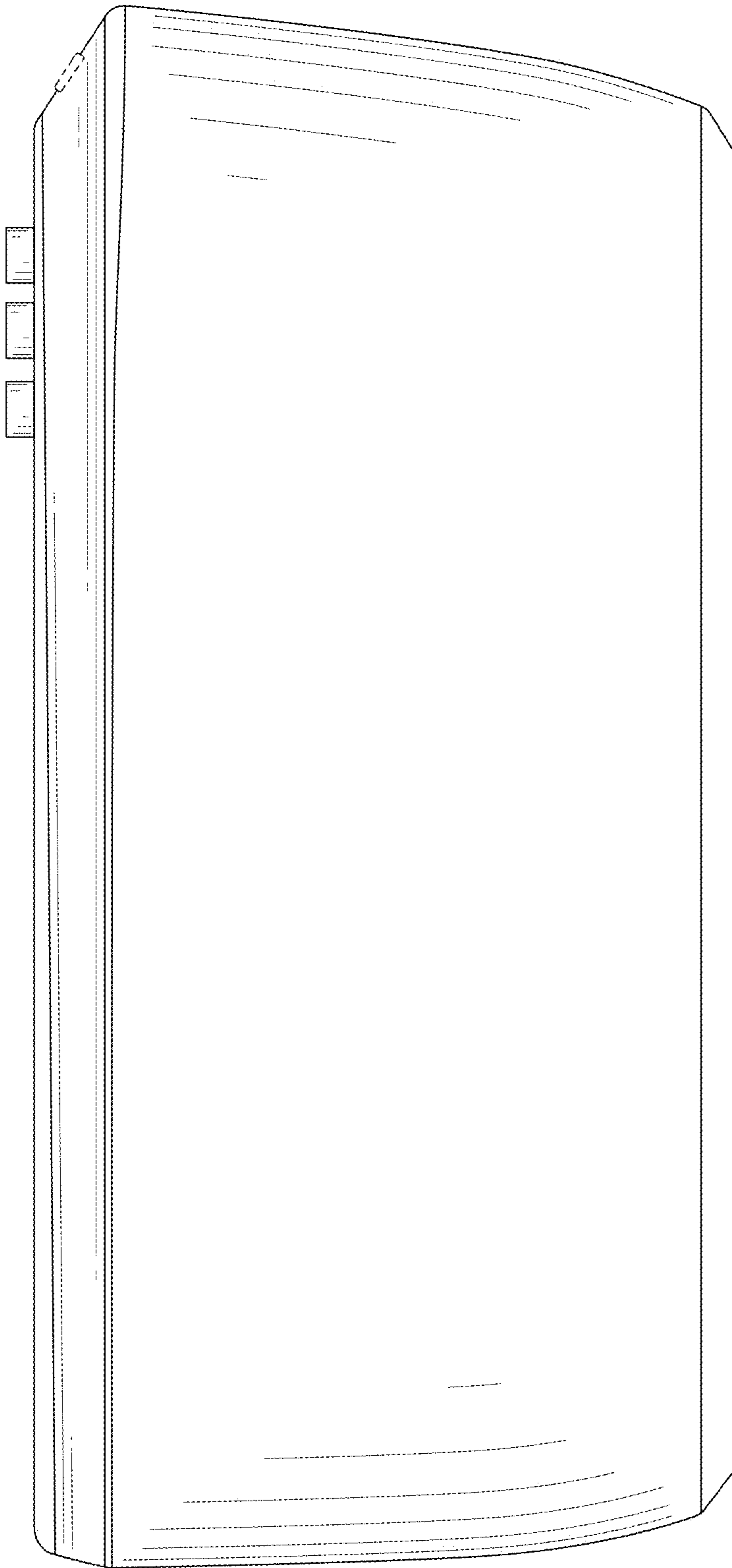

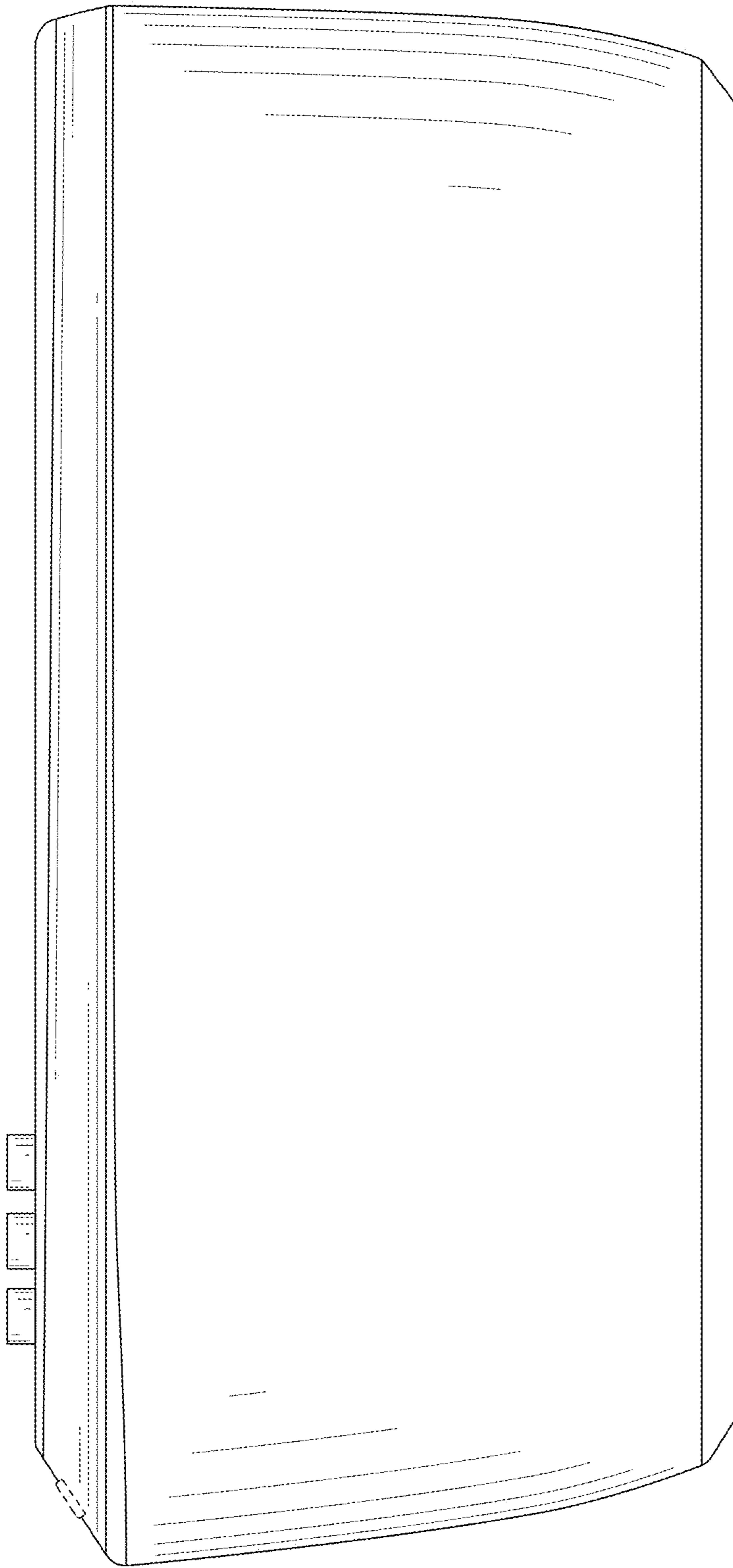

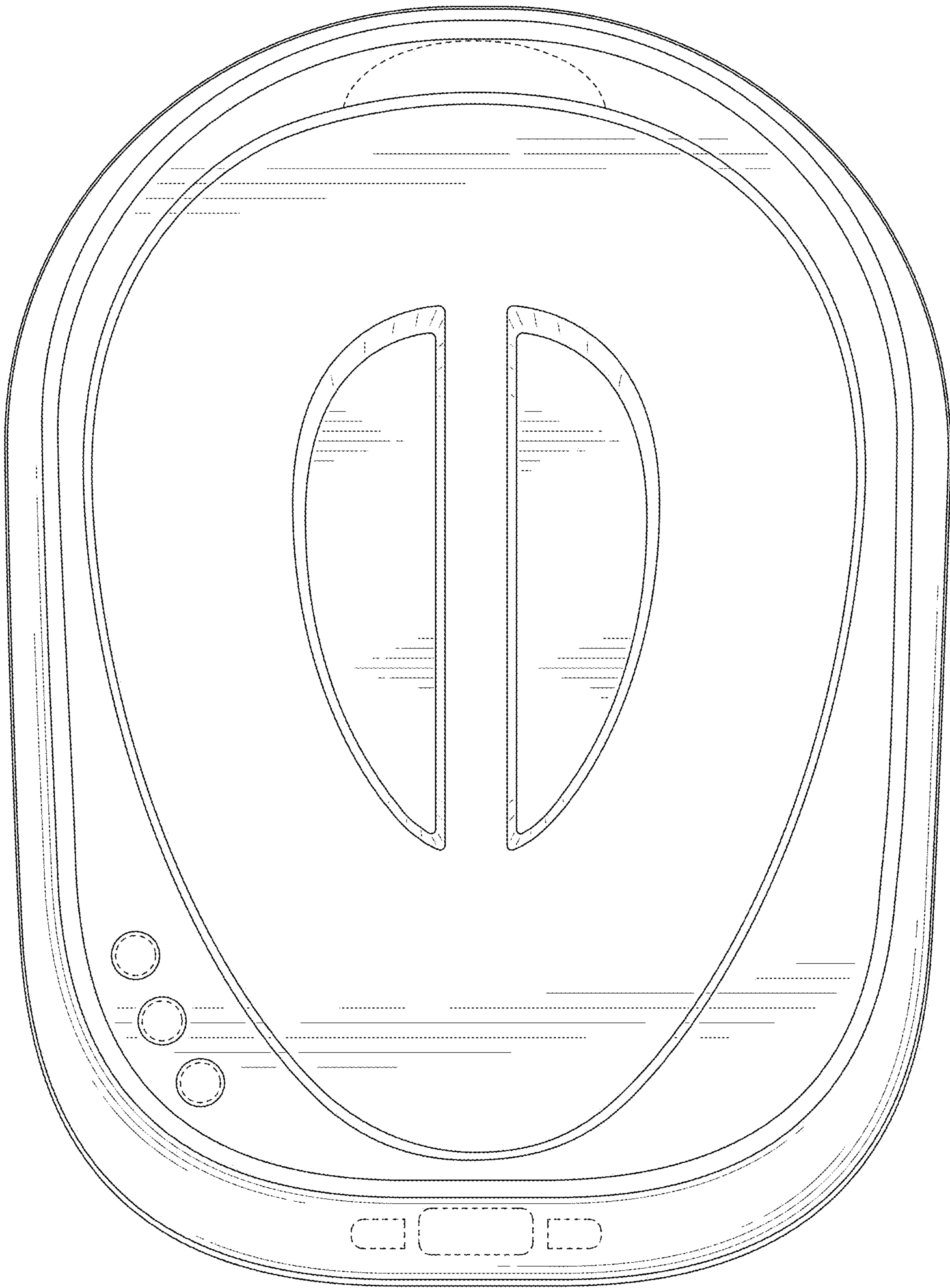

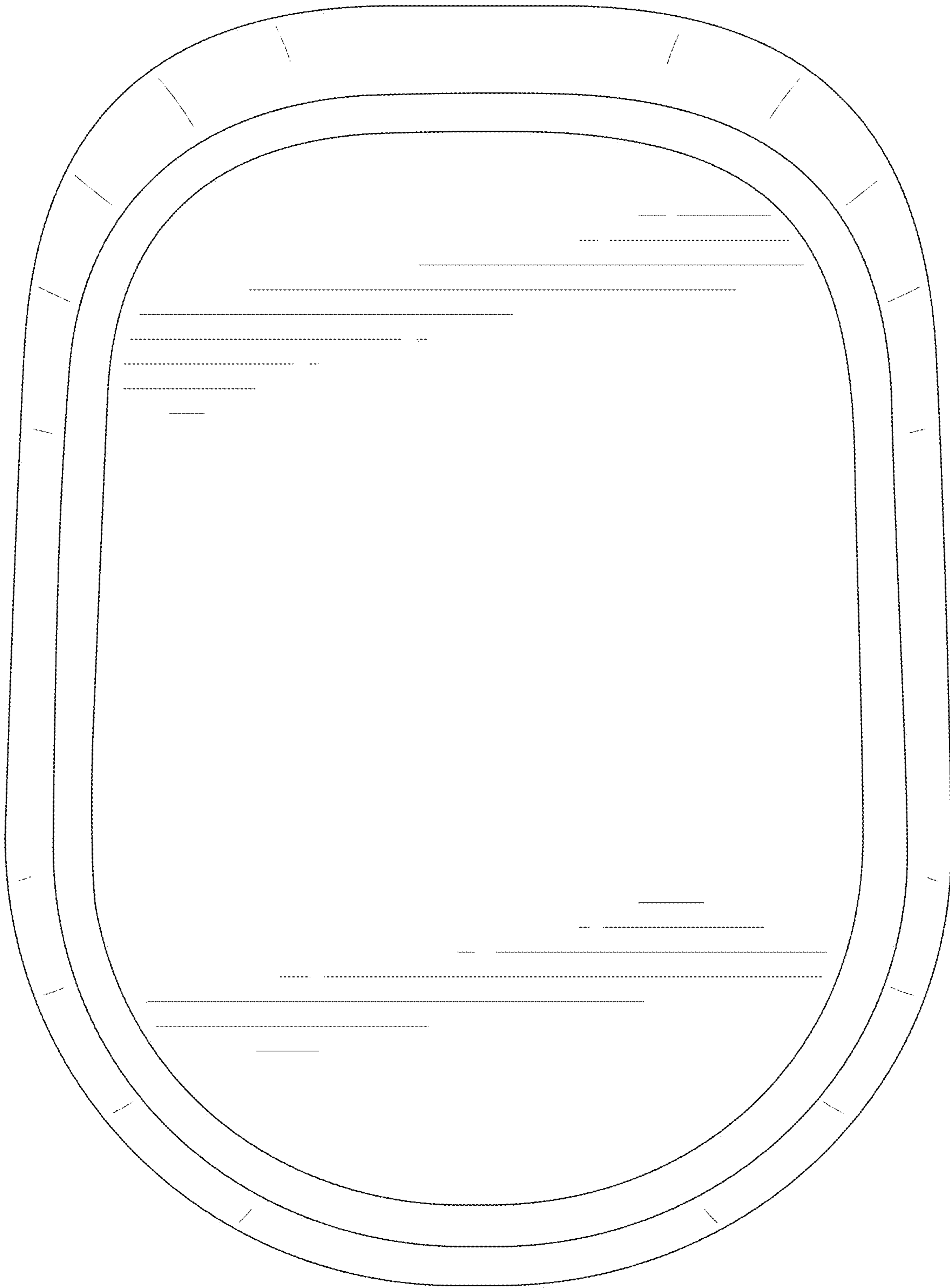

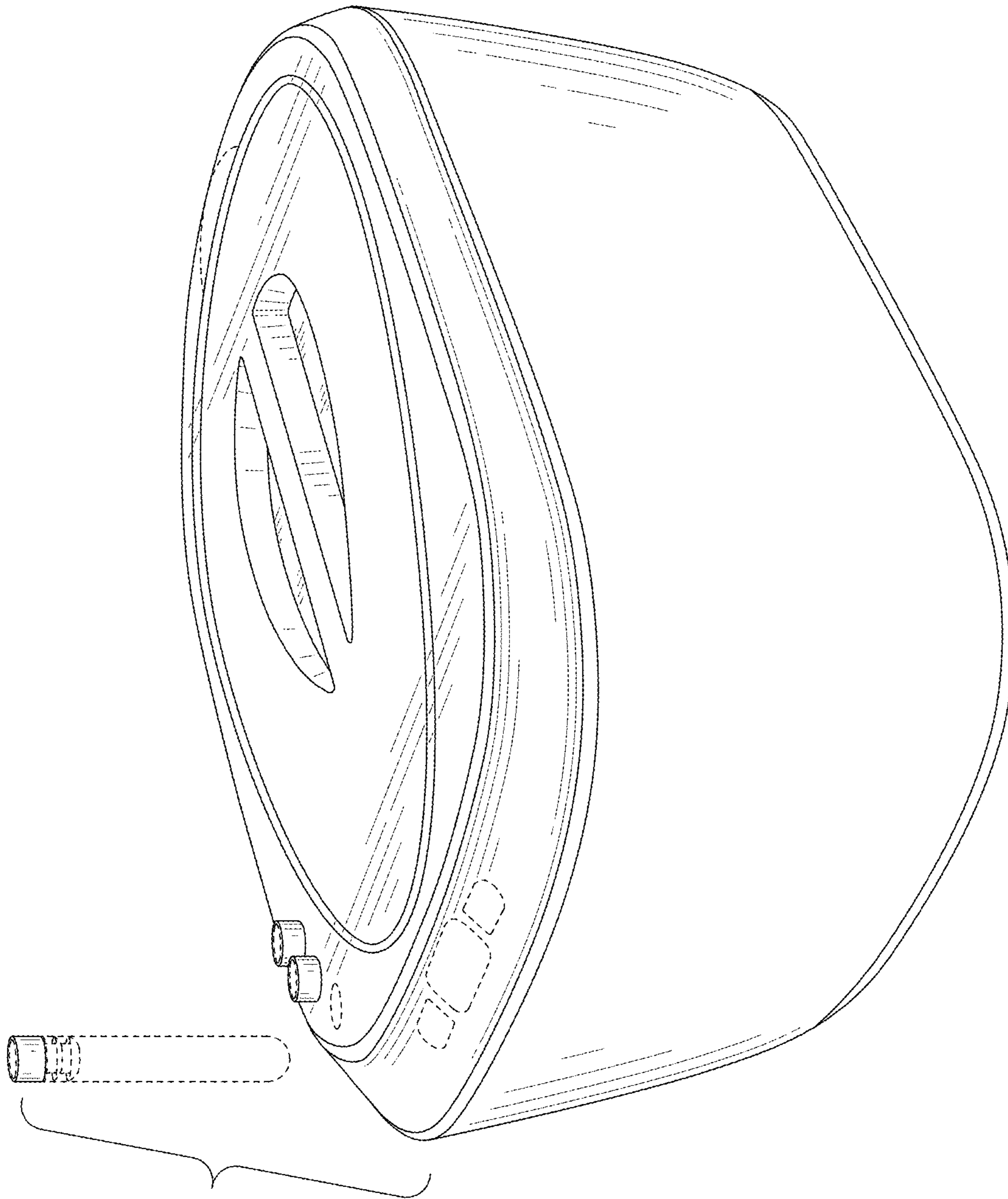
