DESCRIPTION

FIG. 6 is a closed back top plan view thereof;

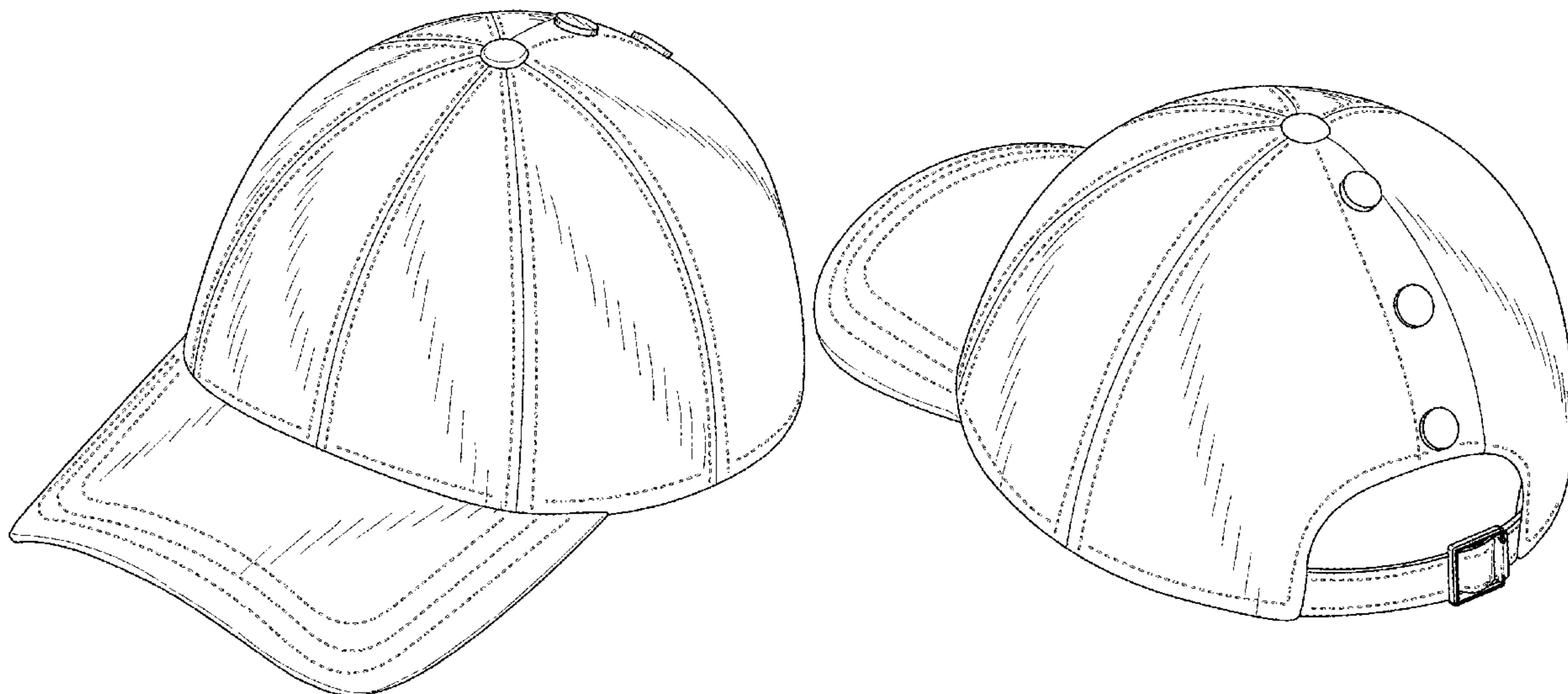
FIG. 7 is closed back bottom plan view thereof.

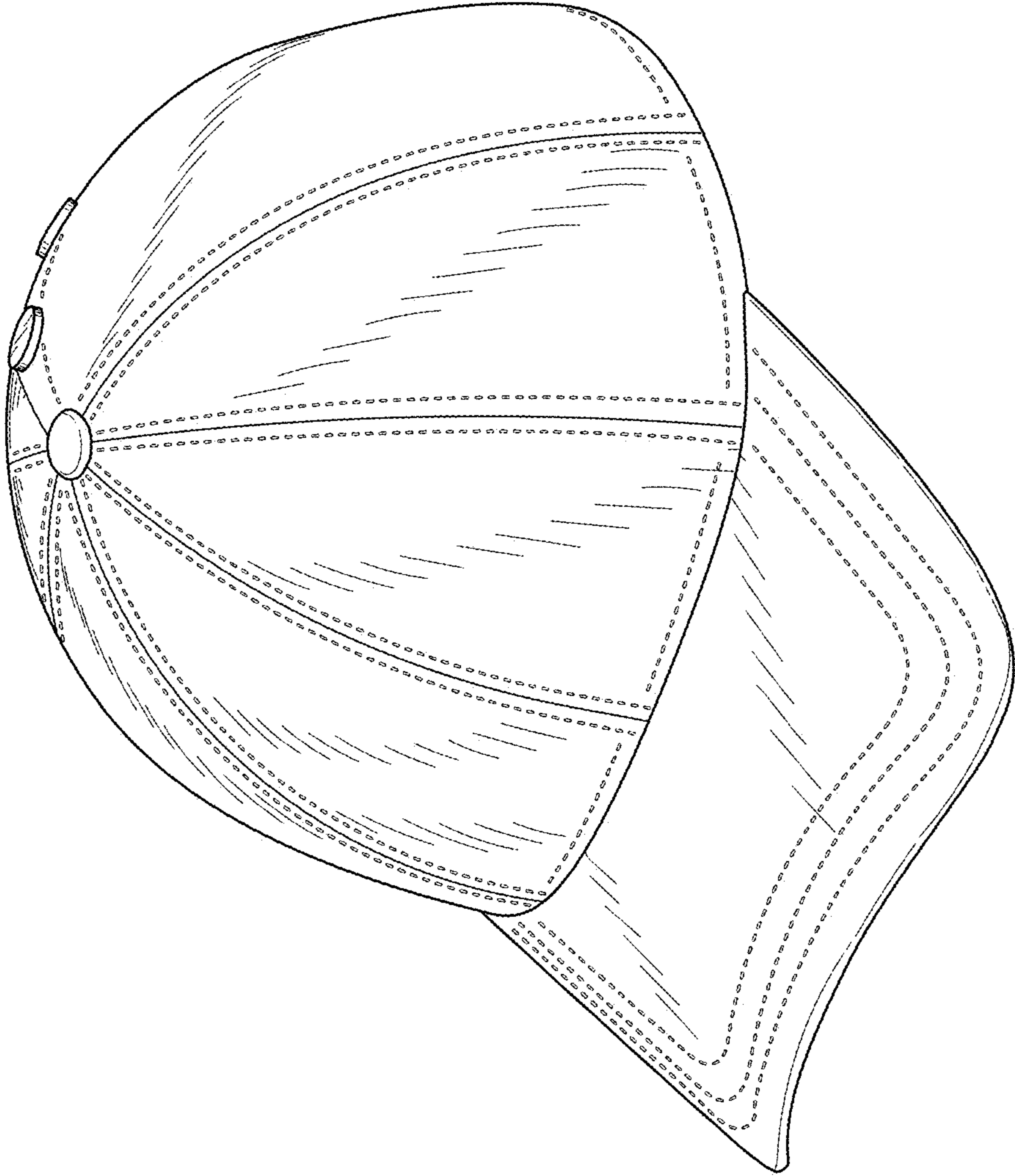

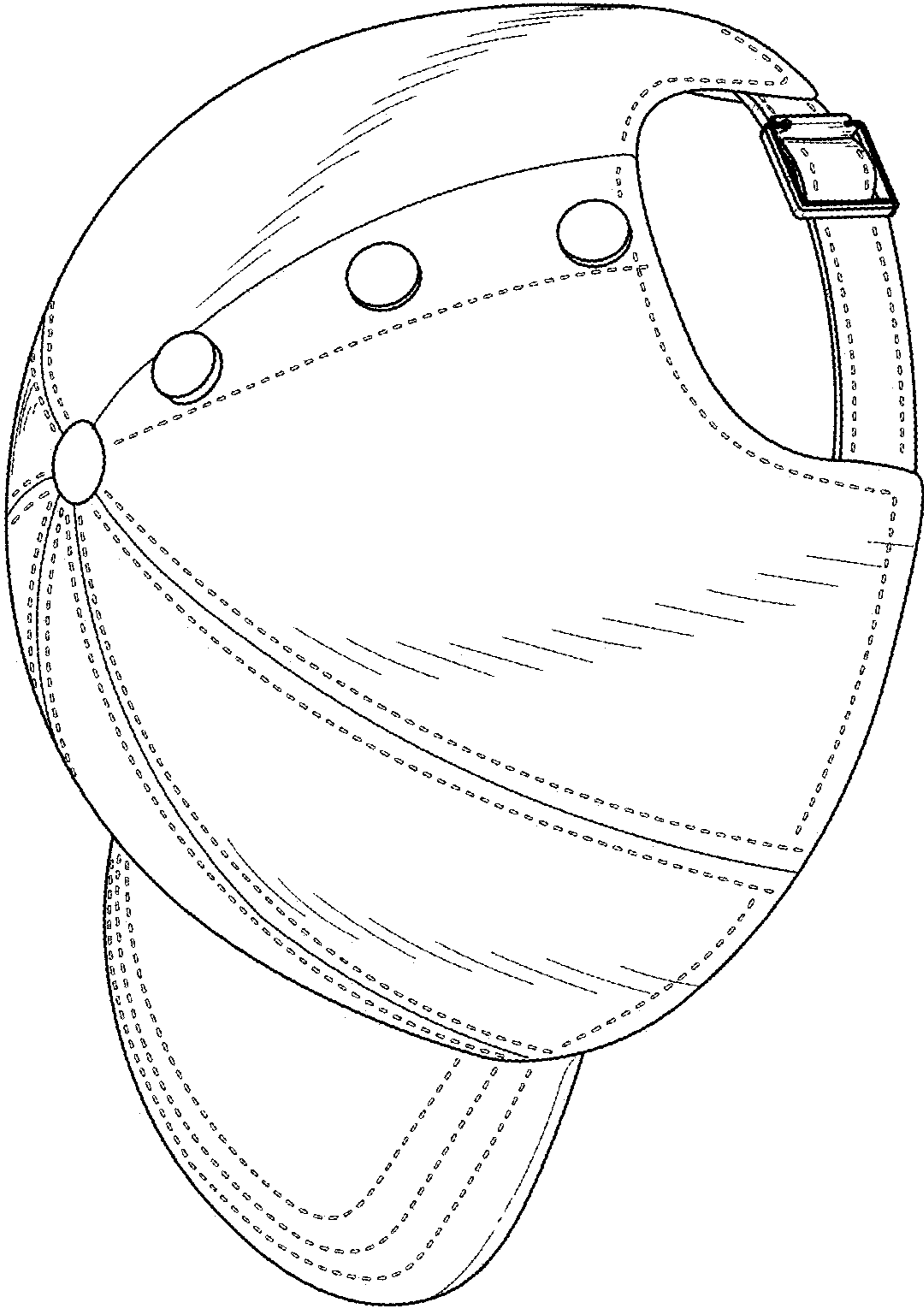

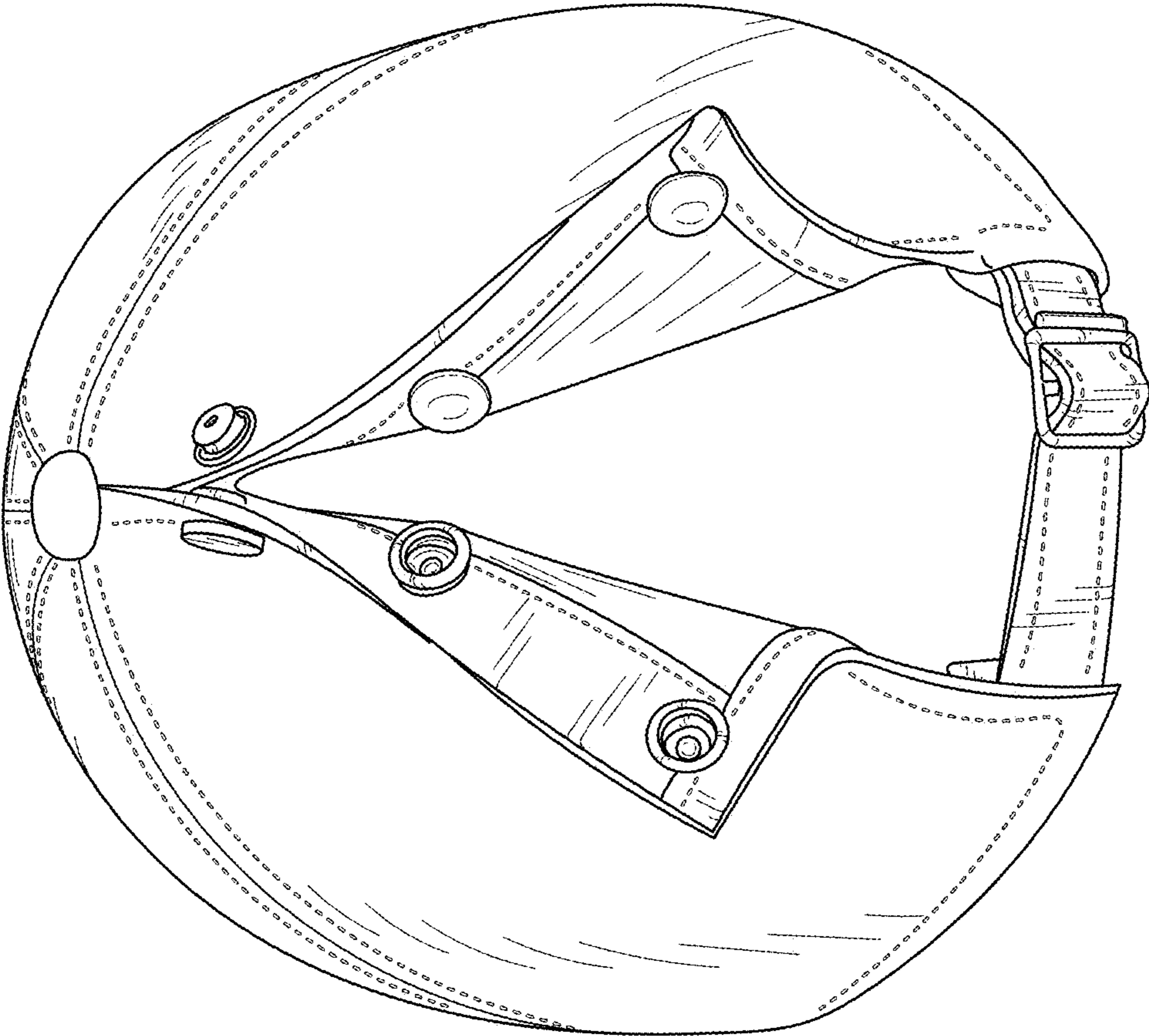

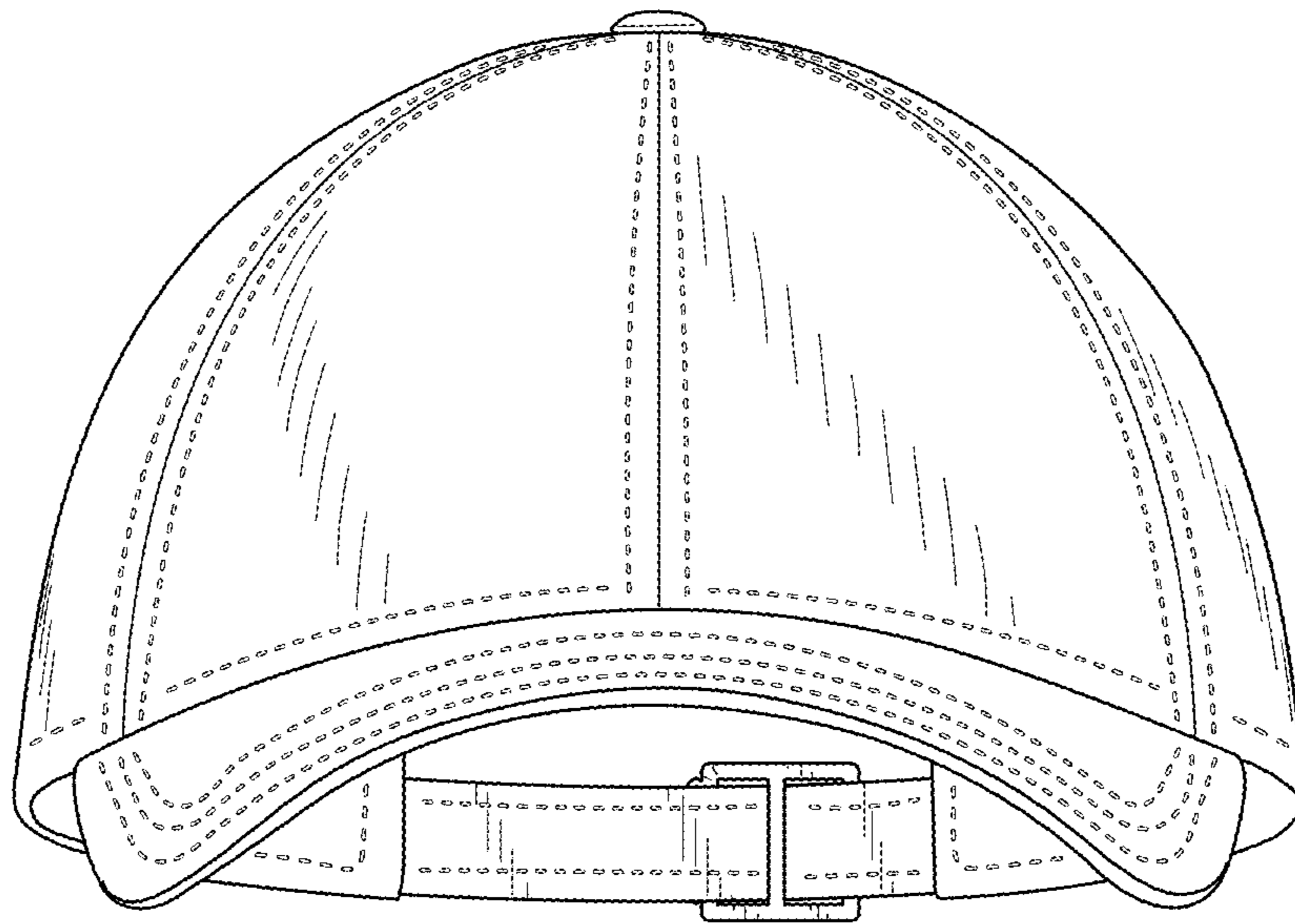

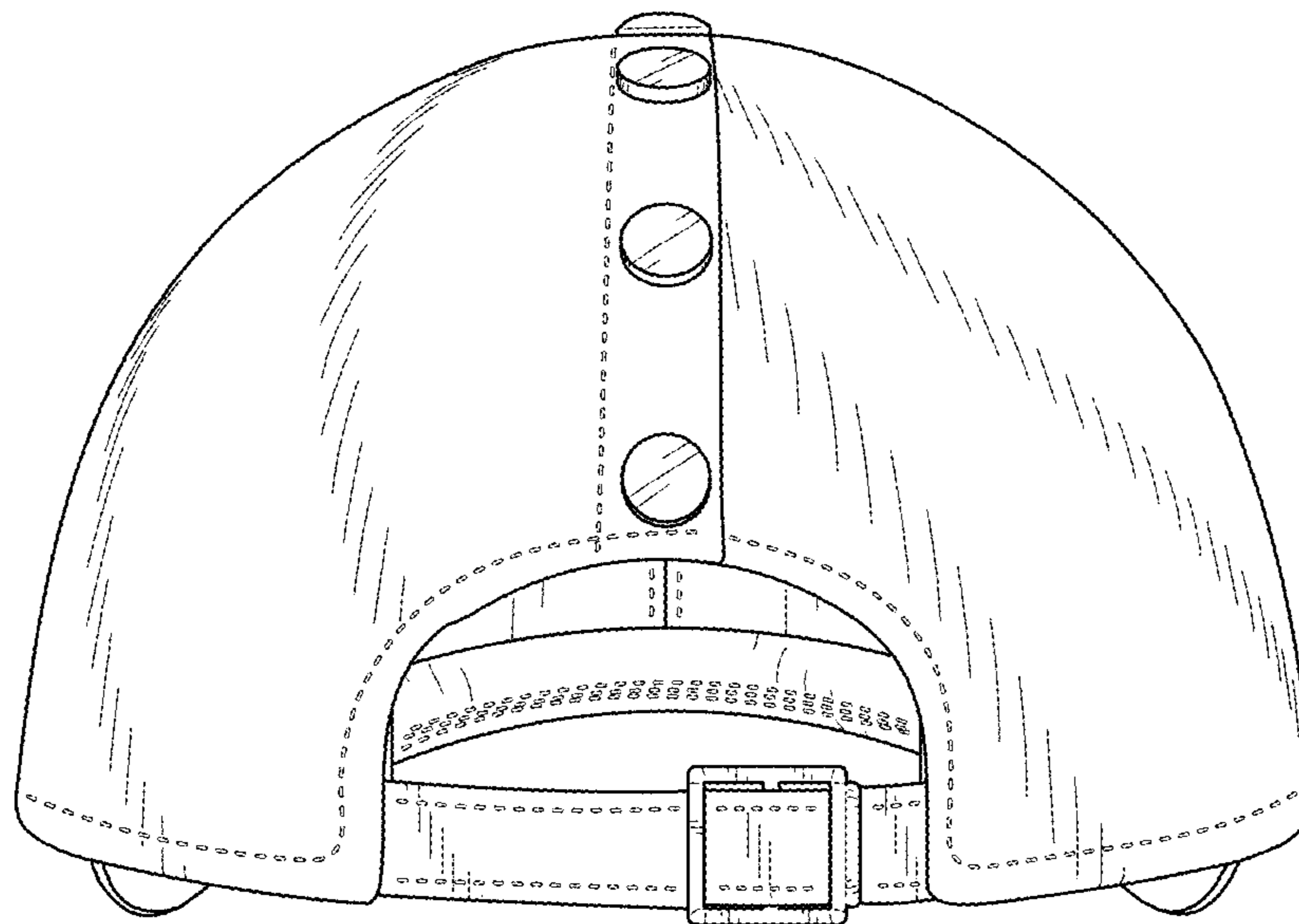

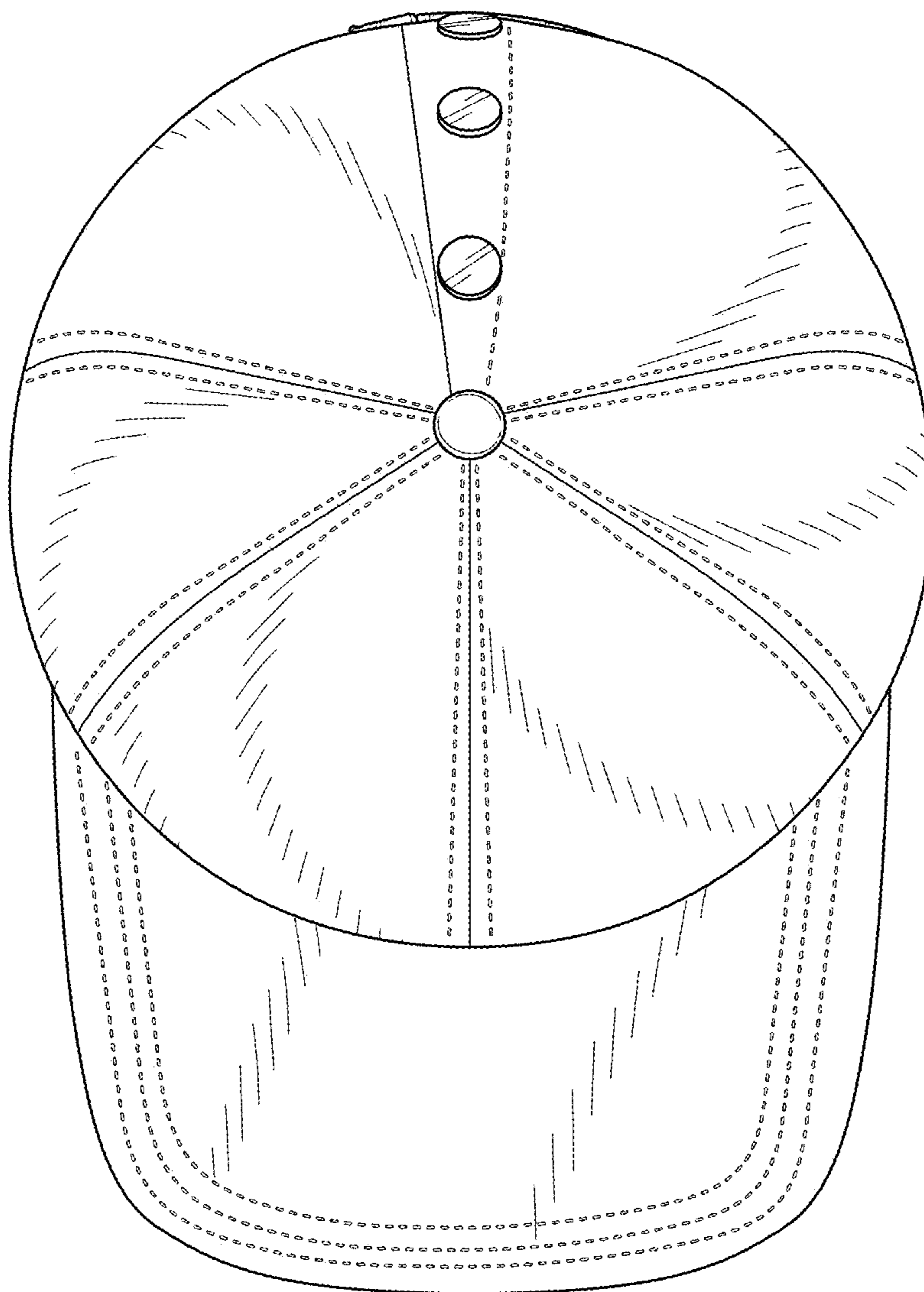

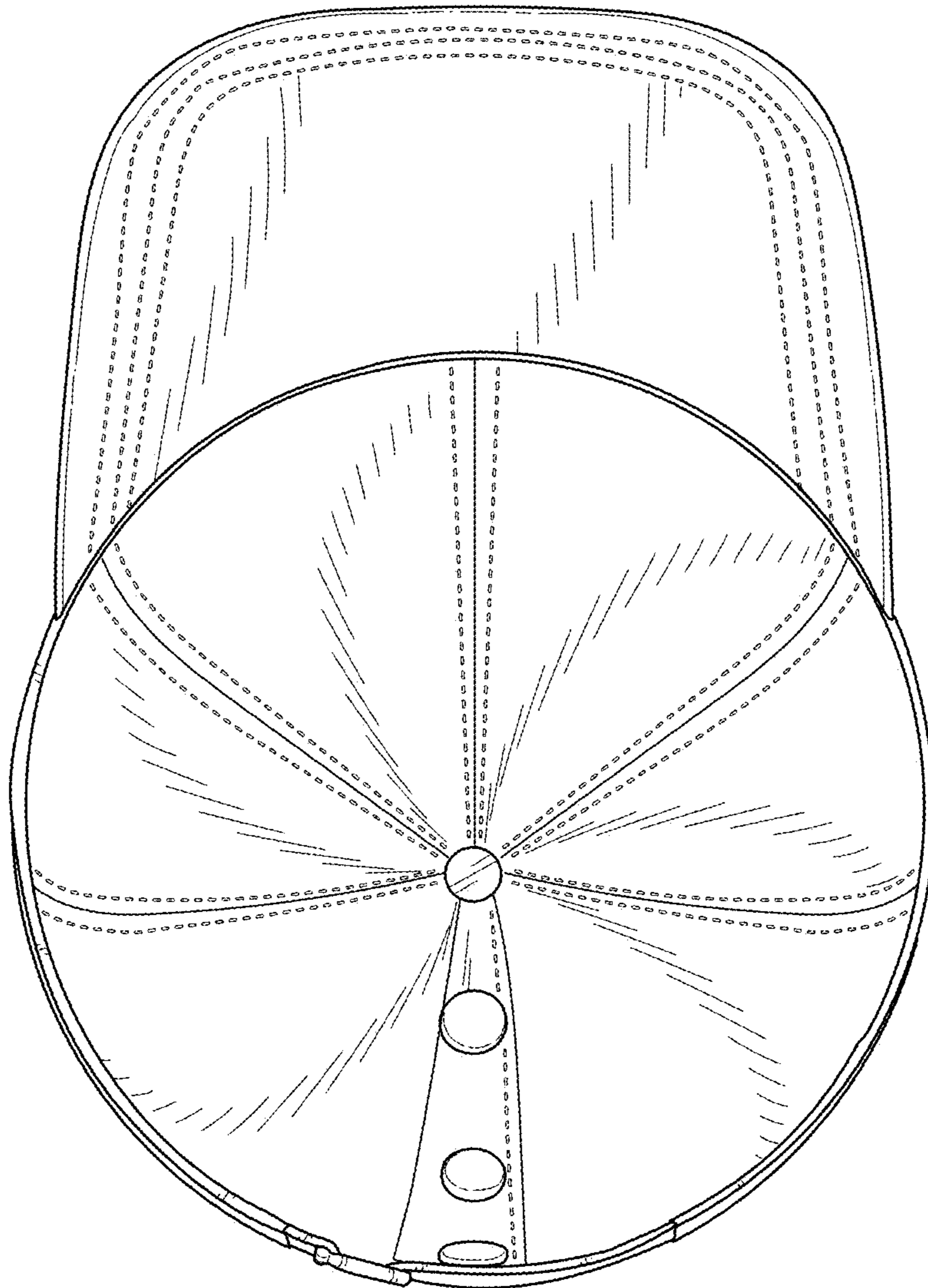

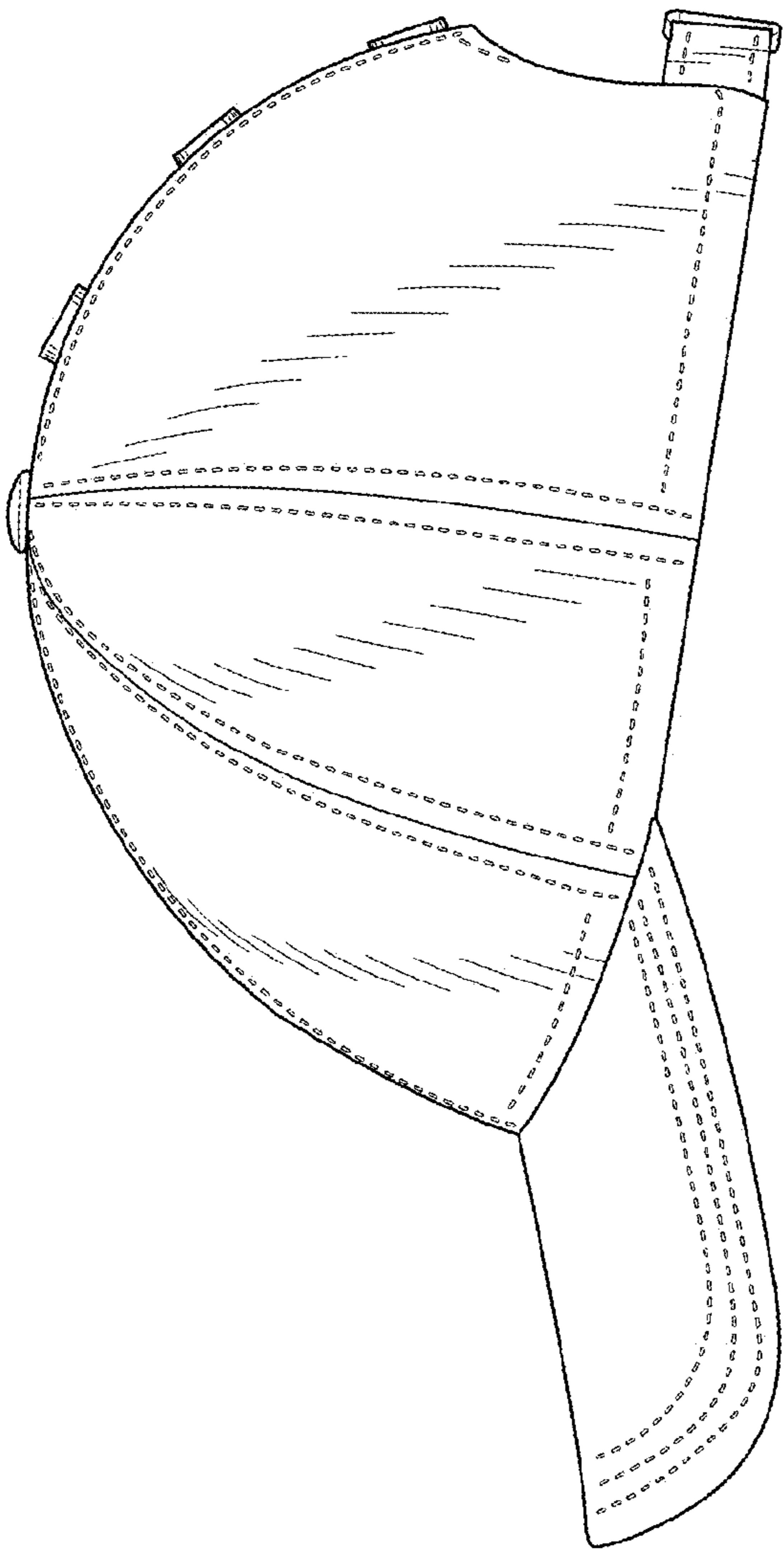
