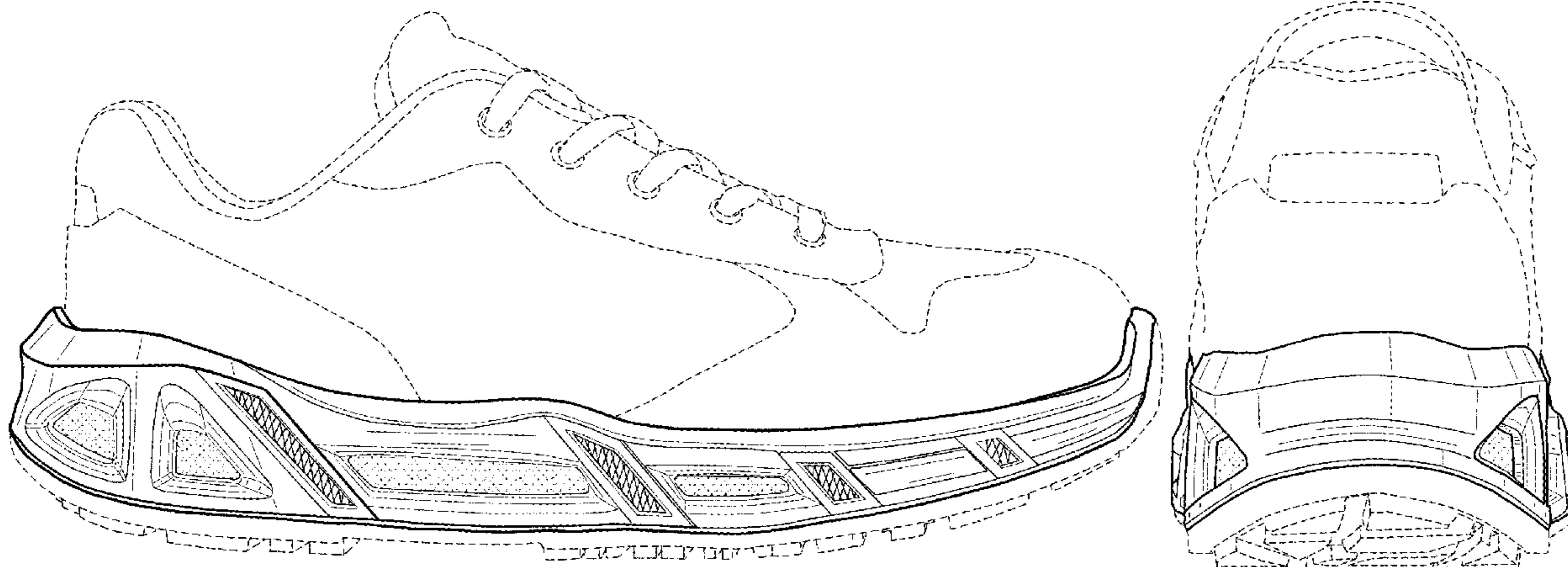
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side view of a safety shoe showing the new design;
FIG. 2 is a front view thereof;

FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

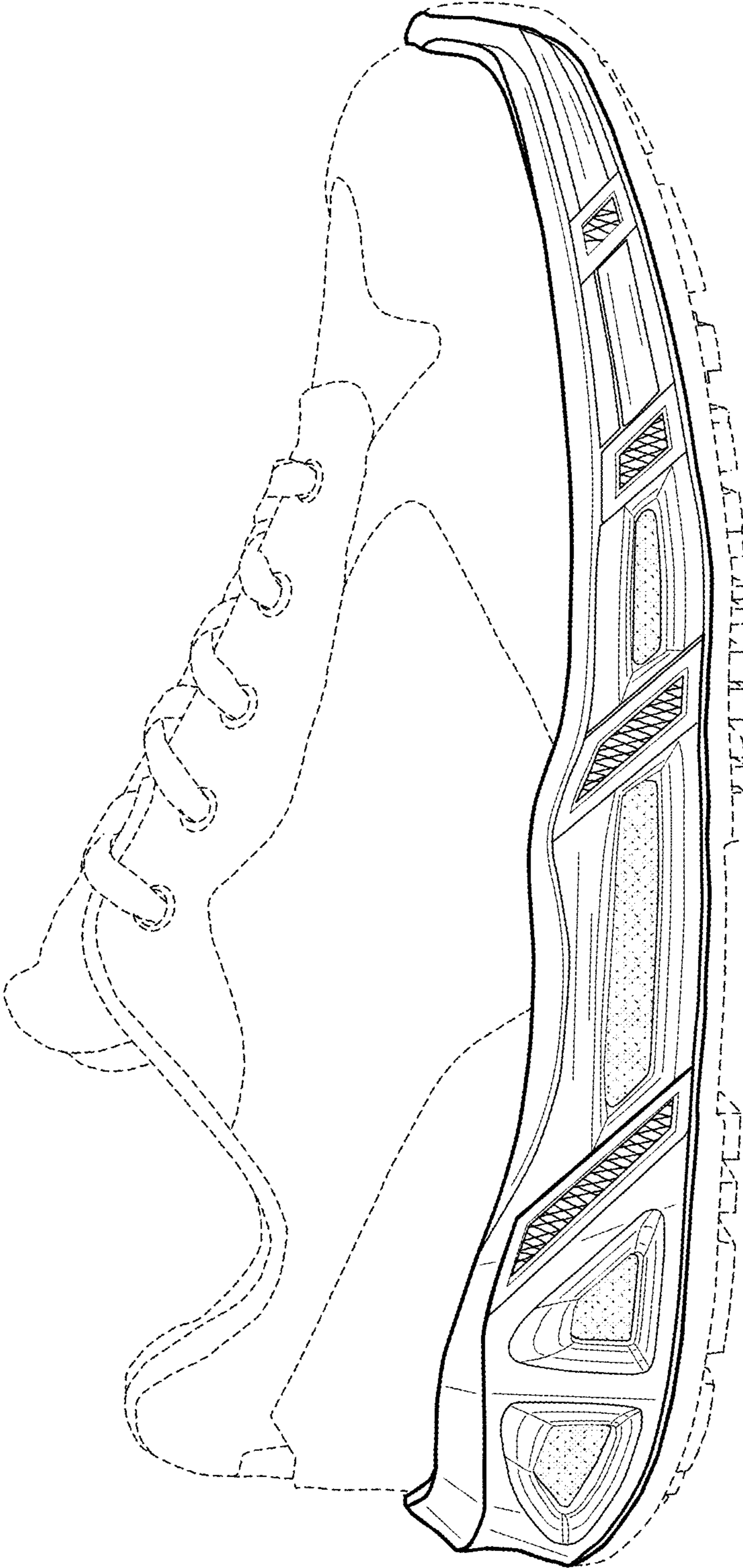

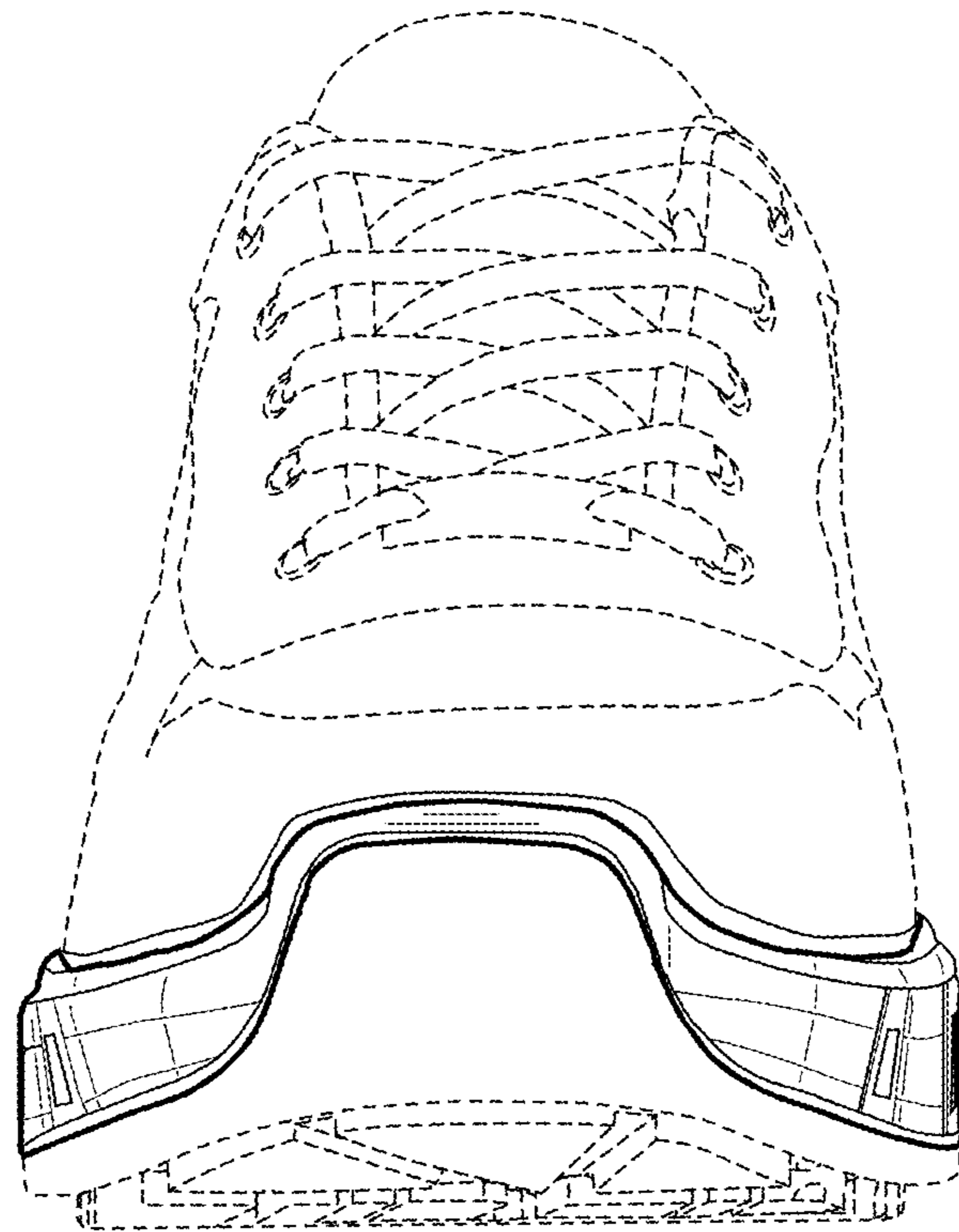

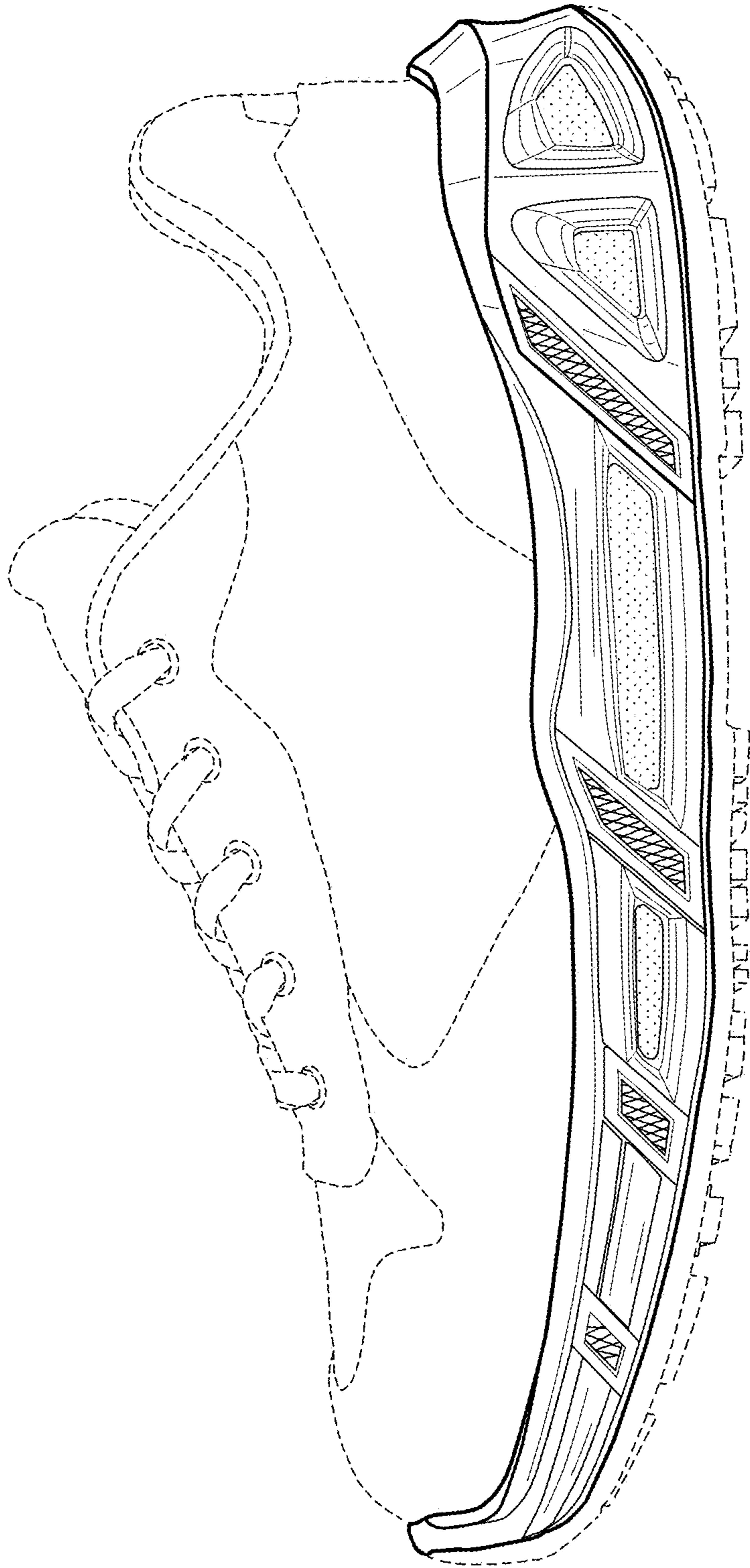

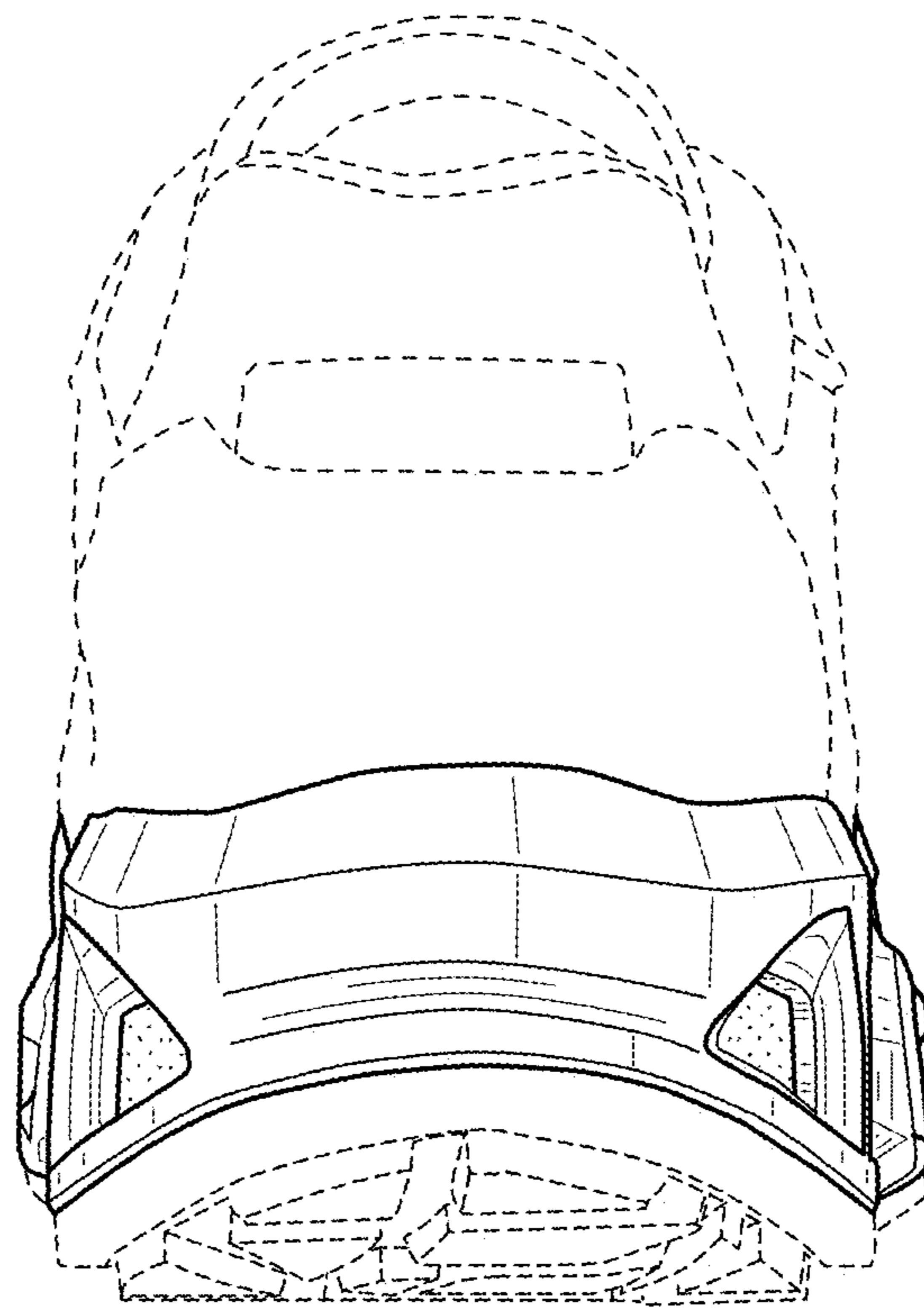

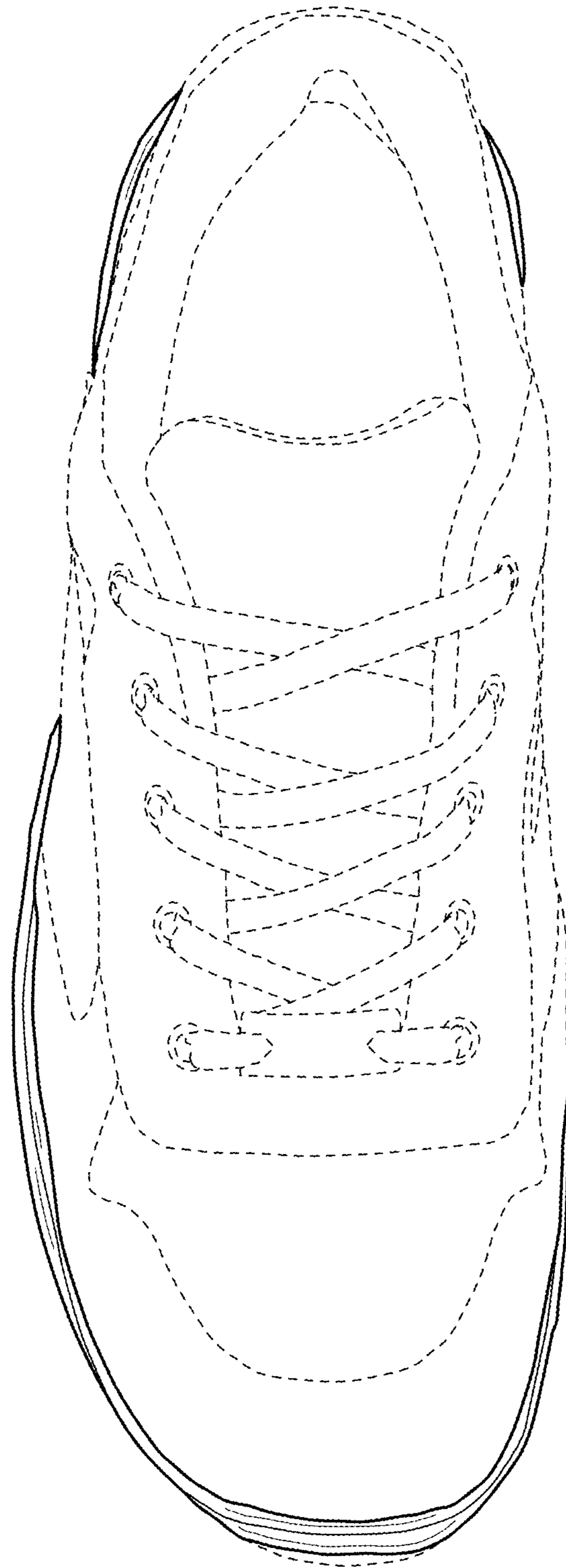

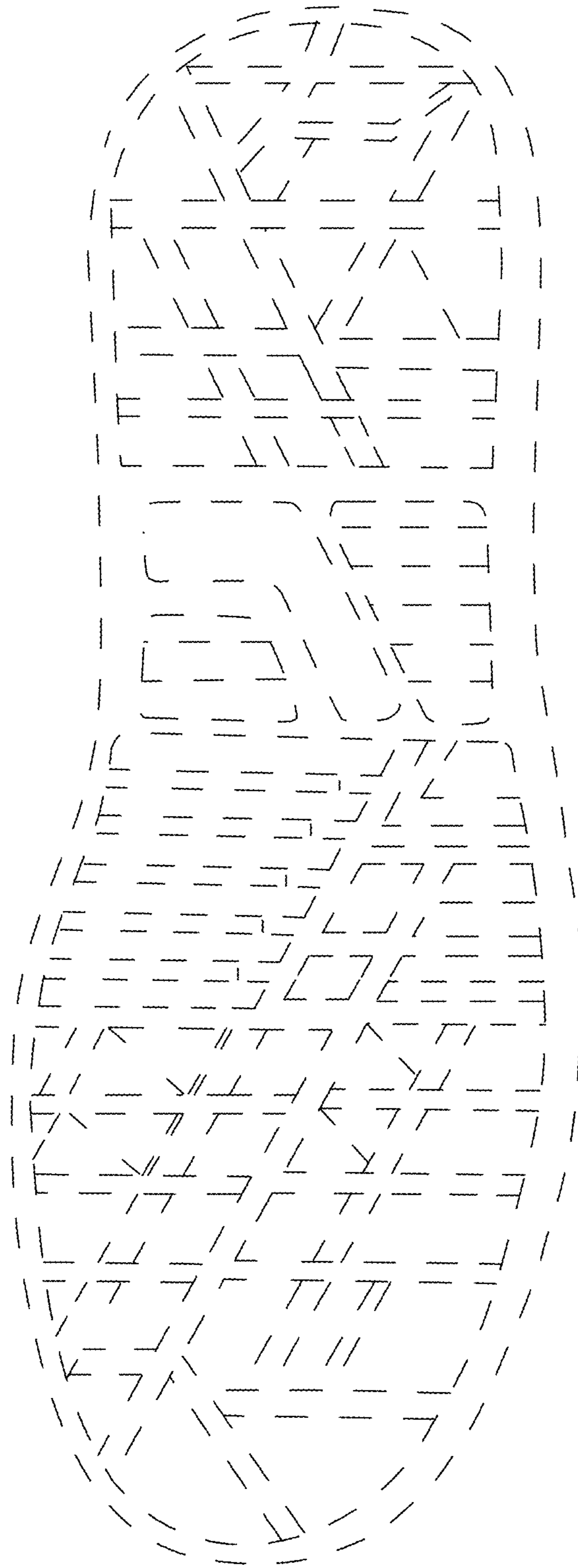
