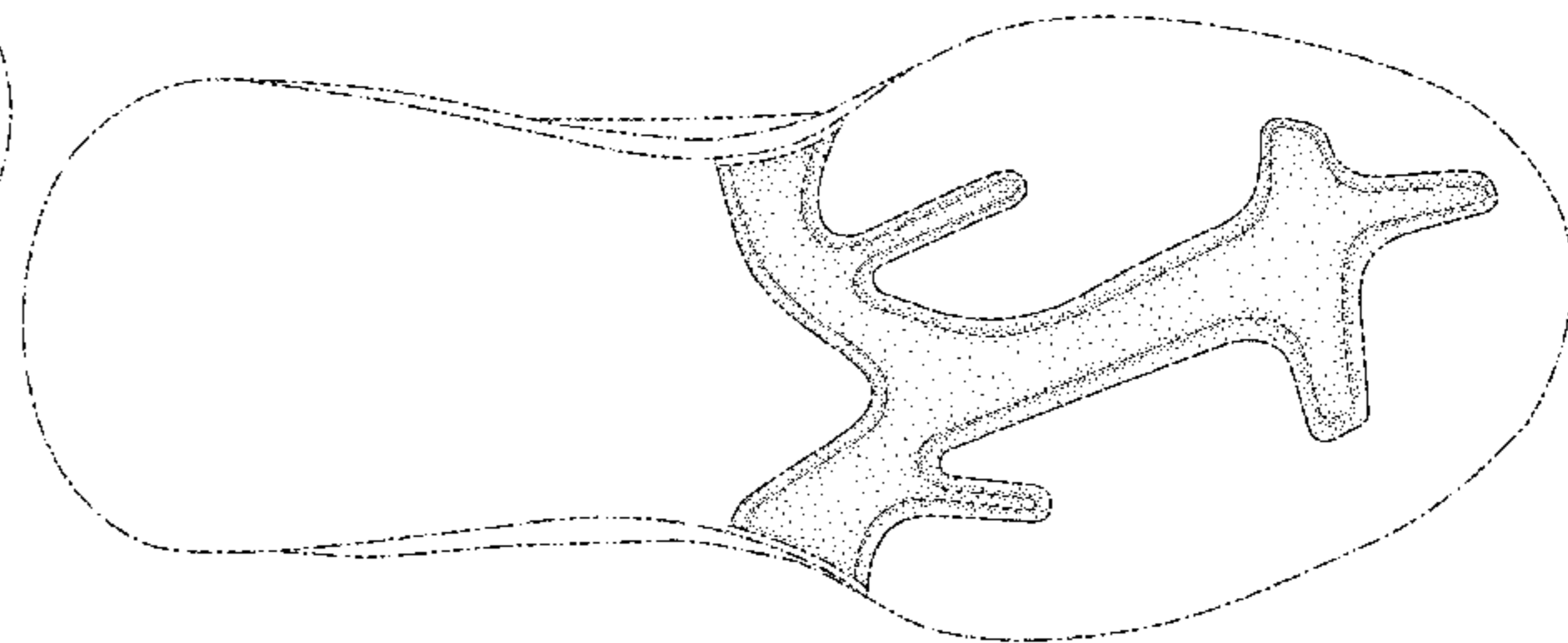
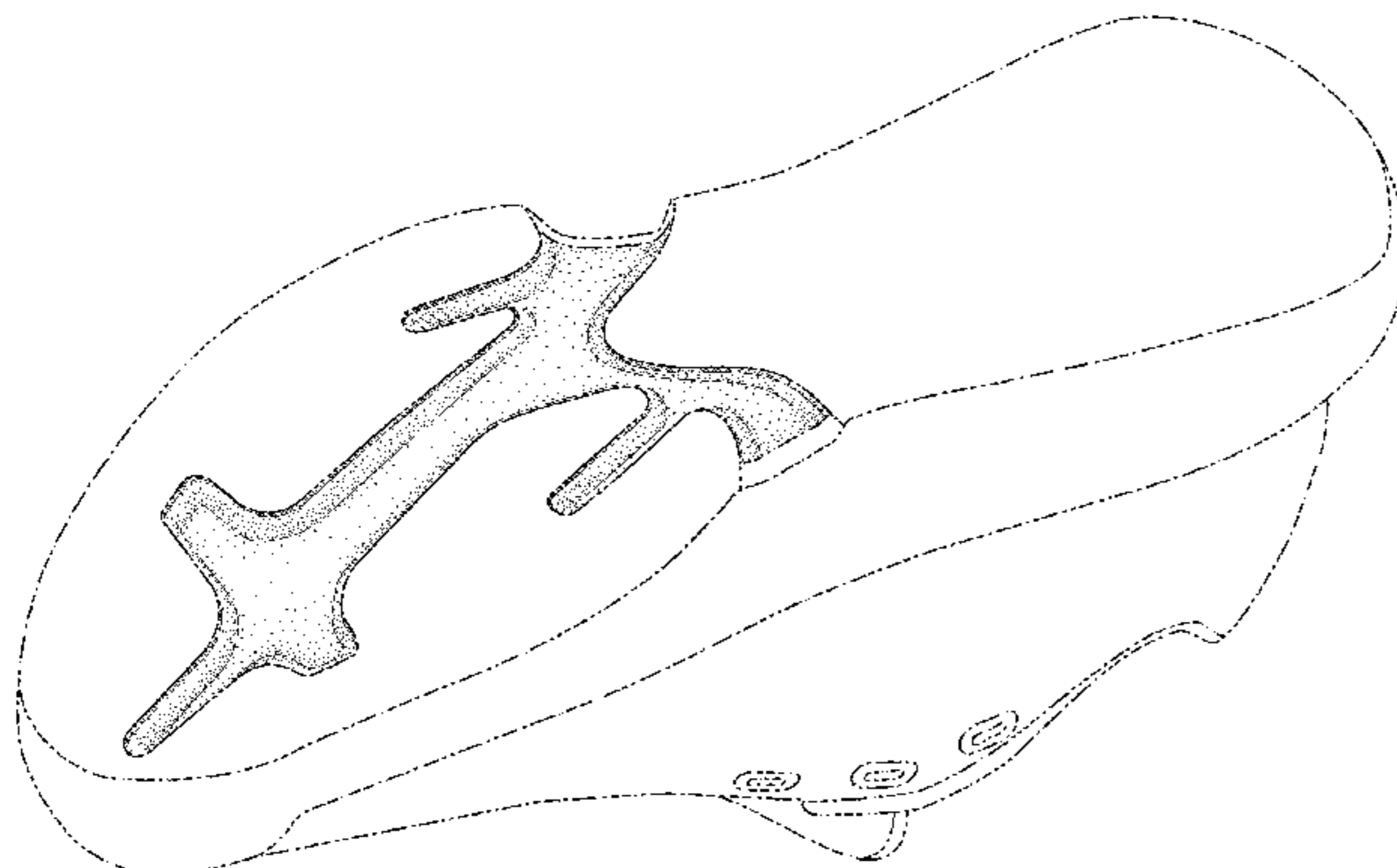
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design; FIG. 2 is a bottom view thereof; and, FIG. 3 is a bottom rear perspective view thereof. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. 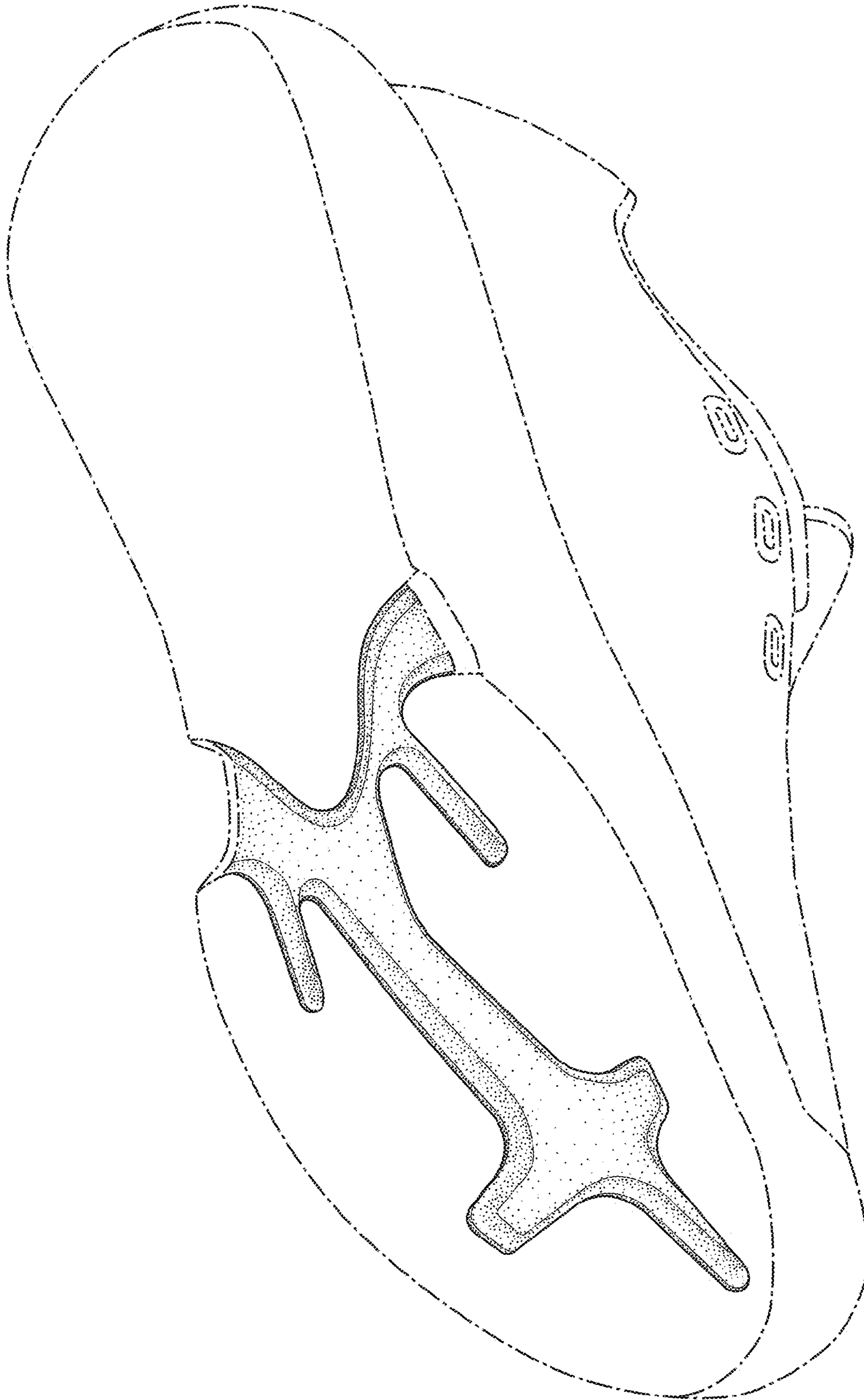

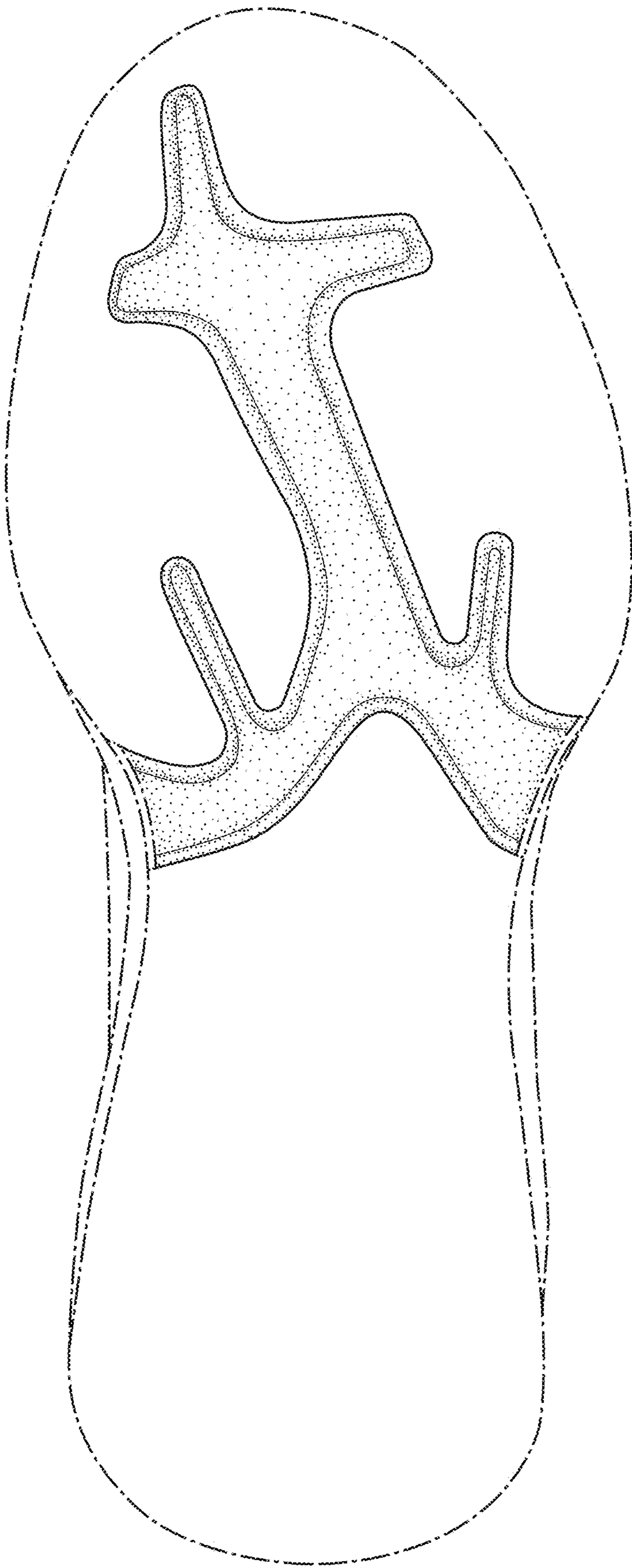

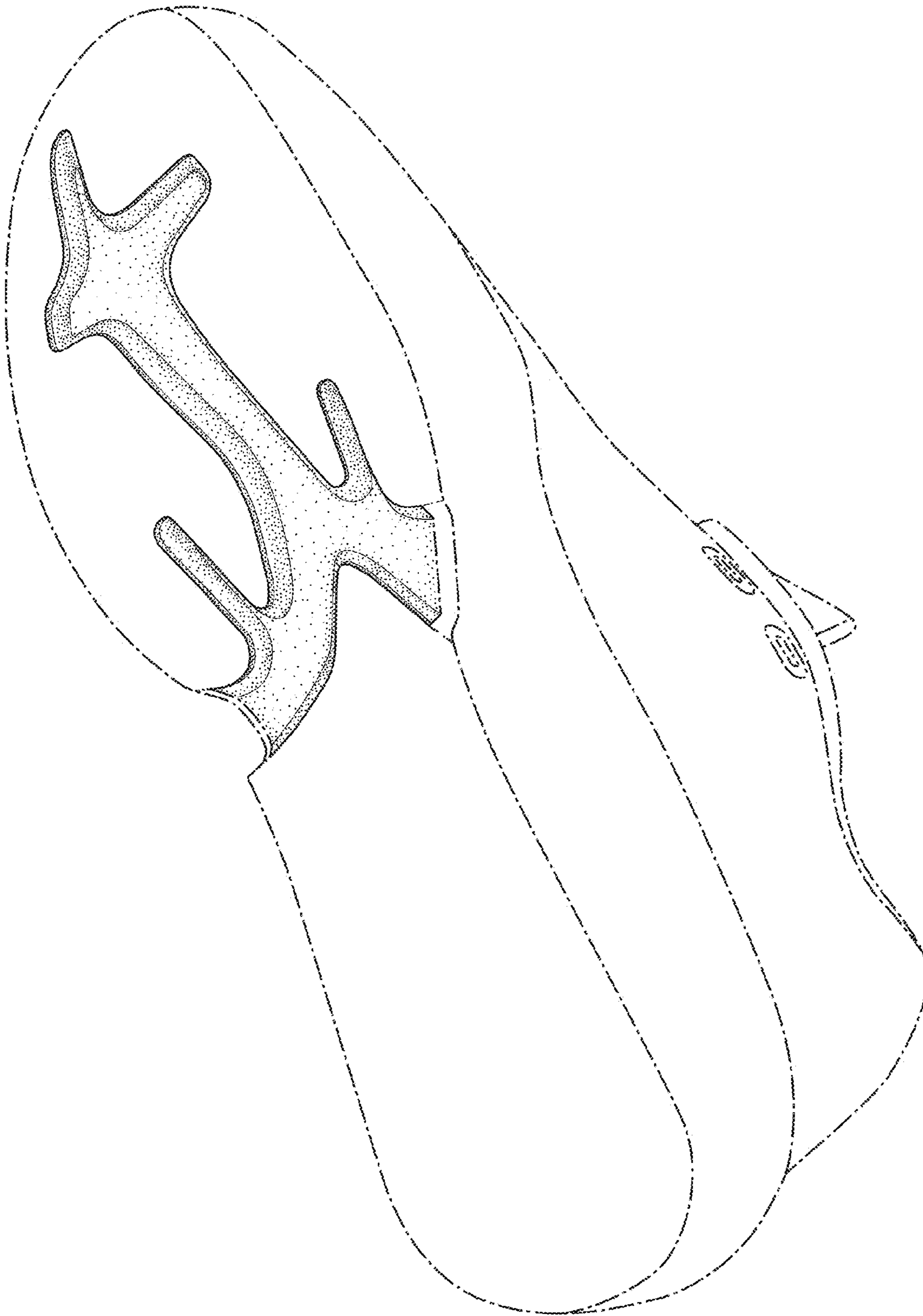
