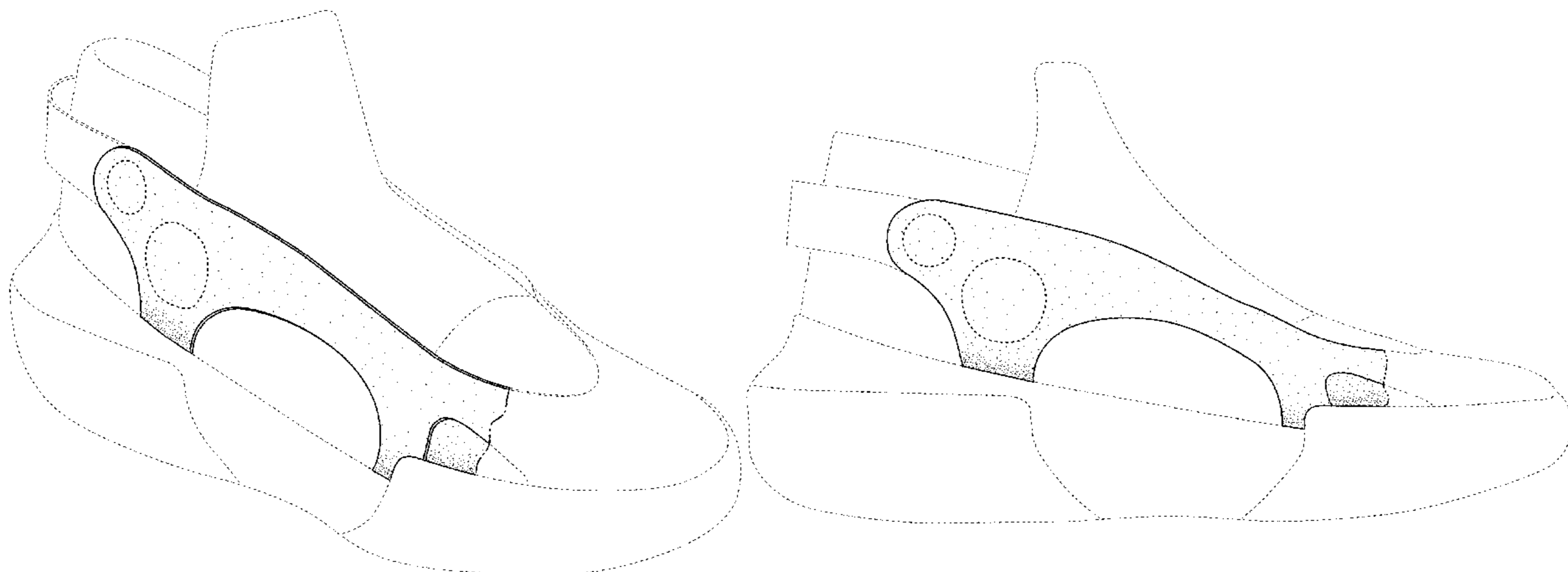

(57) **CLAIM**
I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe, showing my new design;
FIG. 2 is a right side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The dot-dot-dash broken lines adjacent to the shaded area represent boundaries of the claimed design and form no part thereof. The remainder of the broken lines show portions of the shoe that form no part of the claimed design.

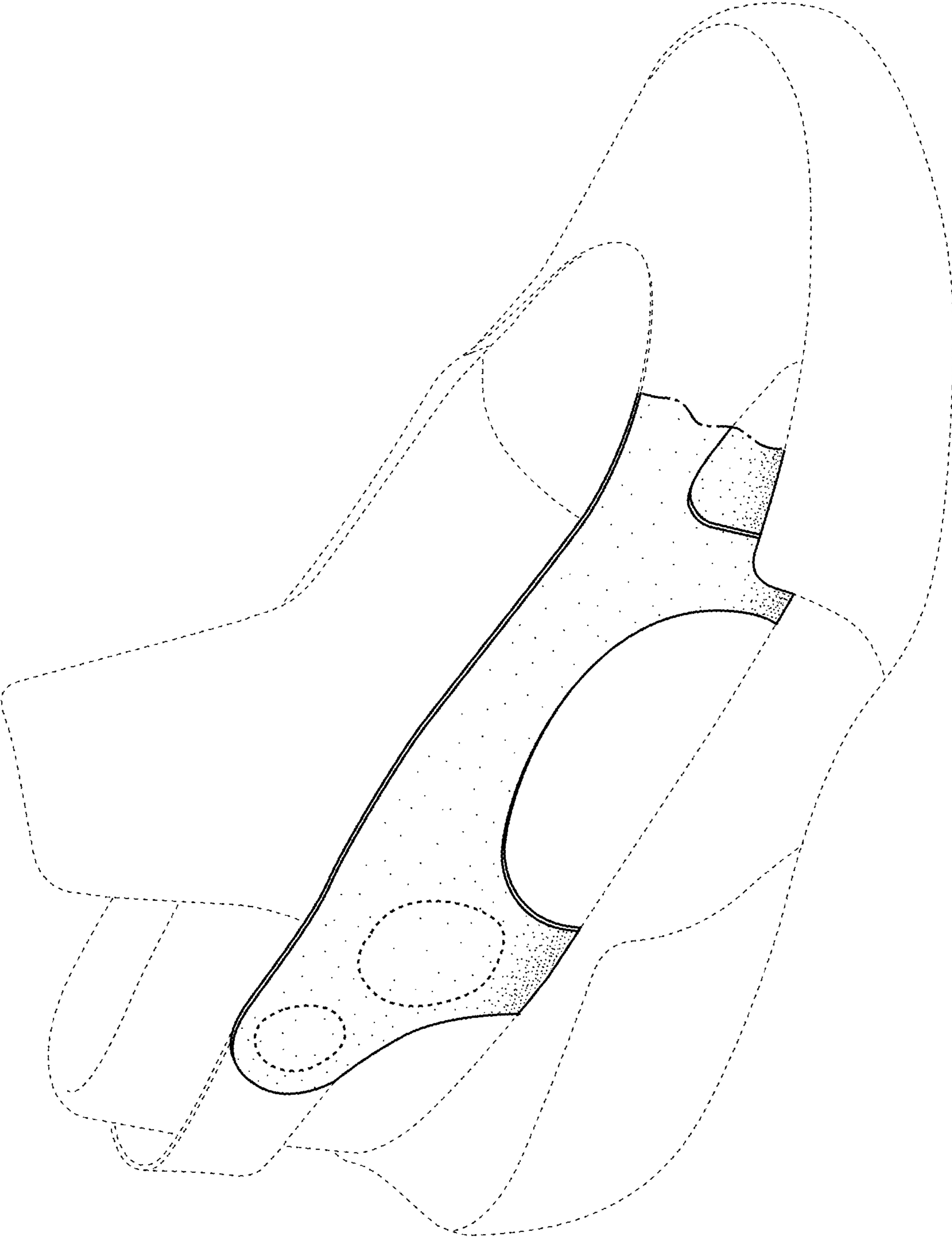

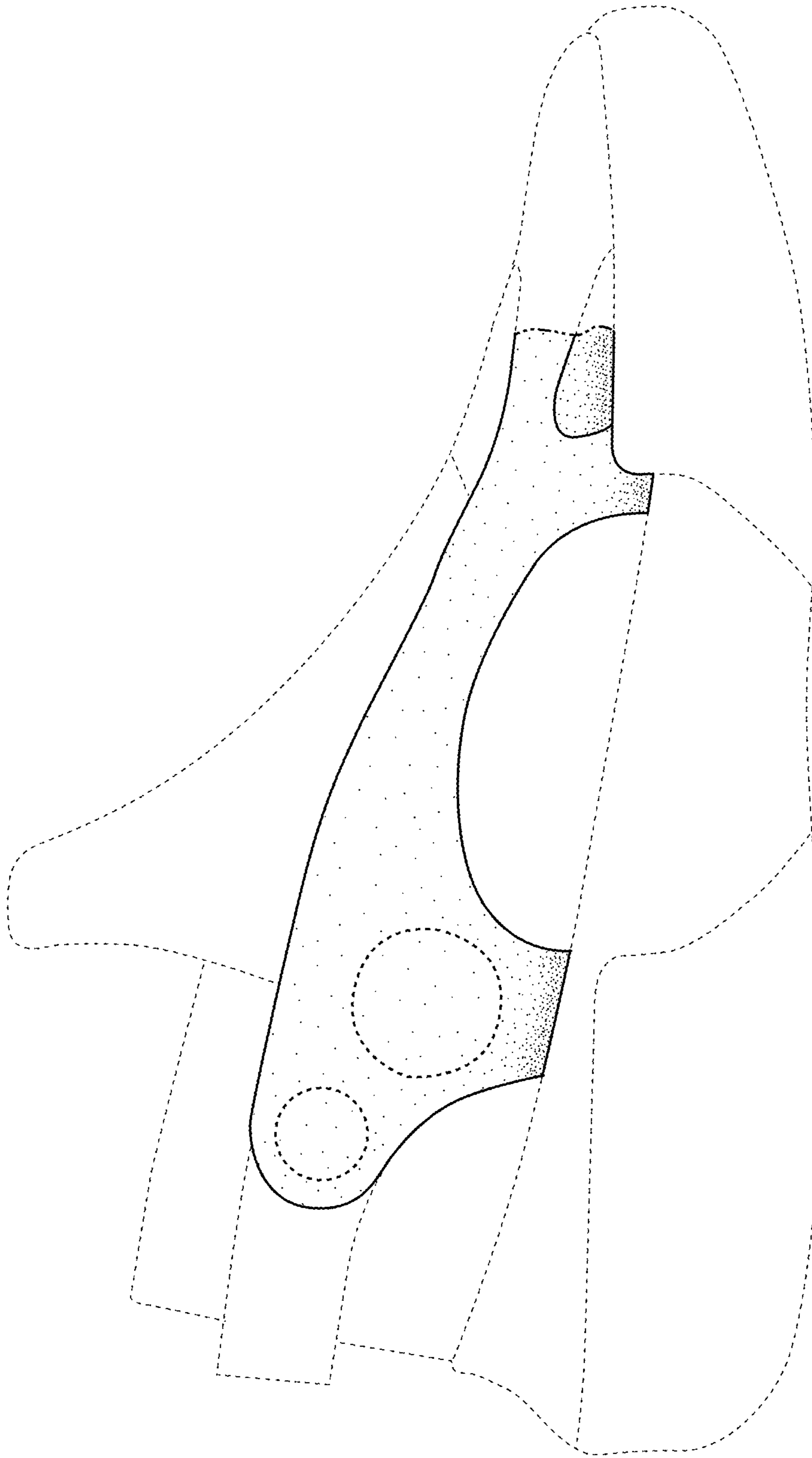

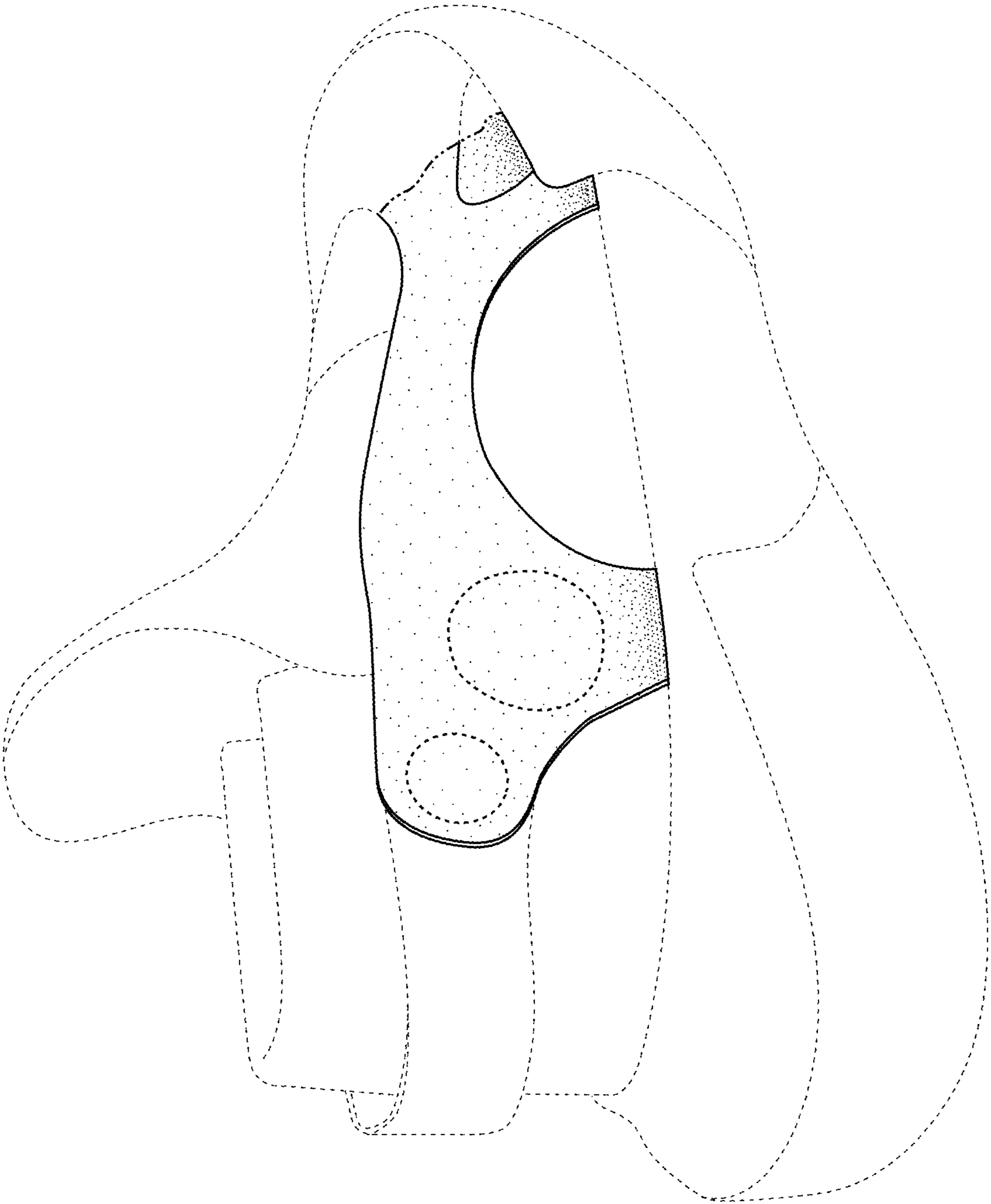
