DESCRIPTION

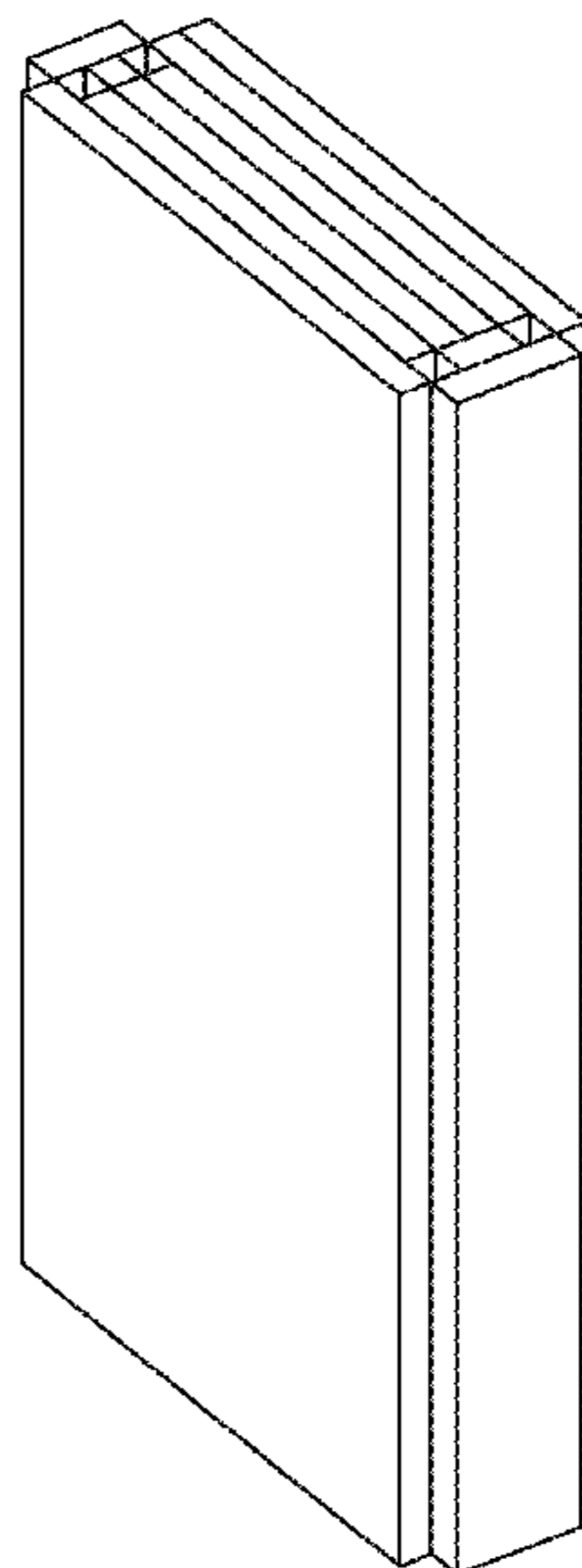
FIG. 1 is a perspective view of a playmat for a baby, showing my new design;

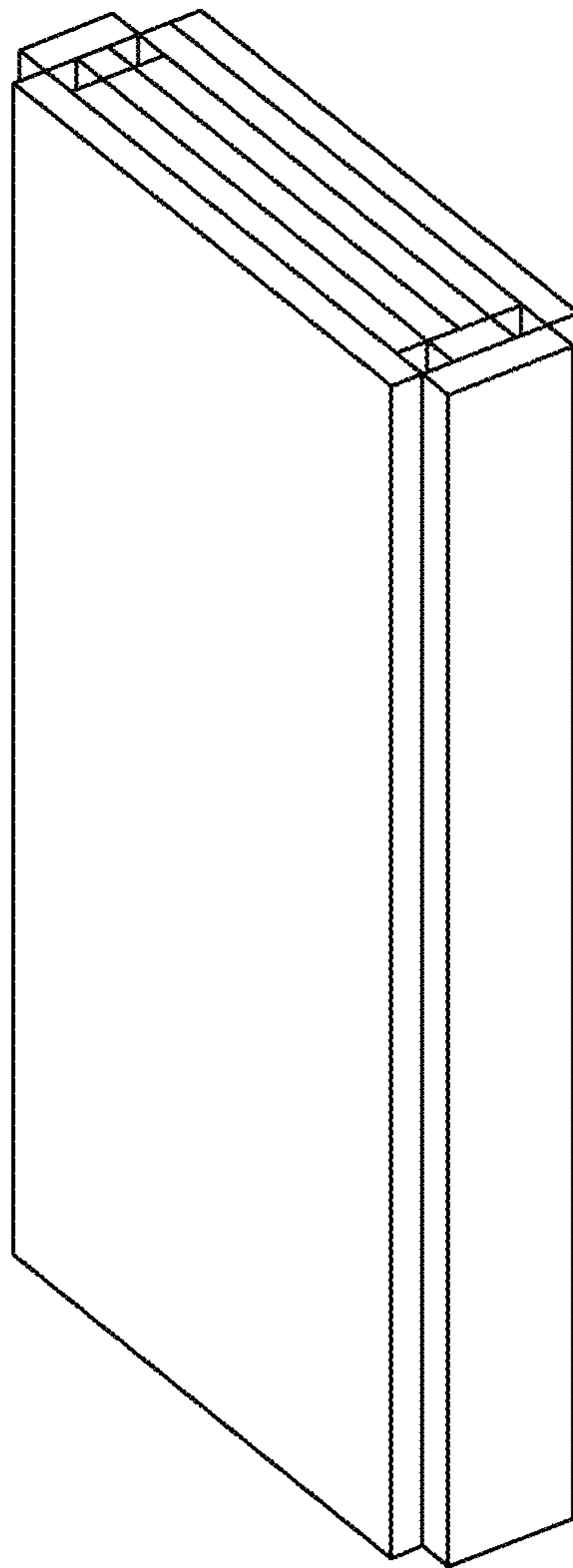

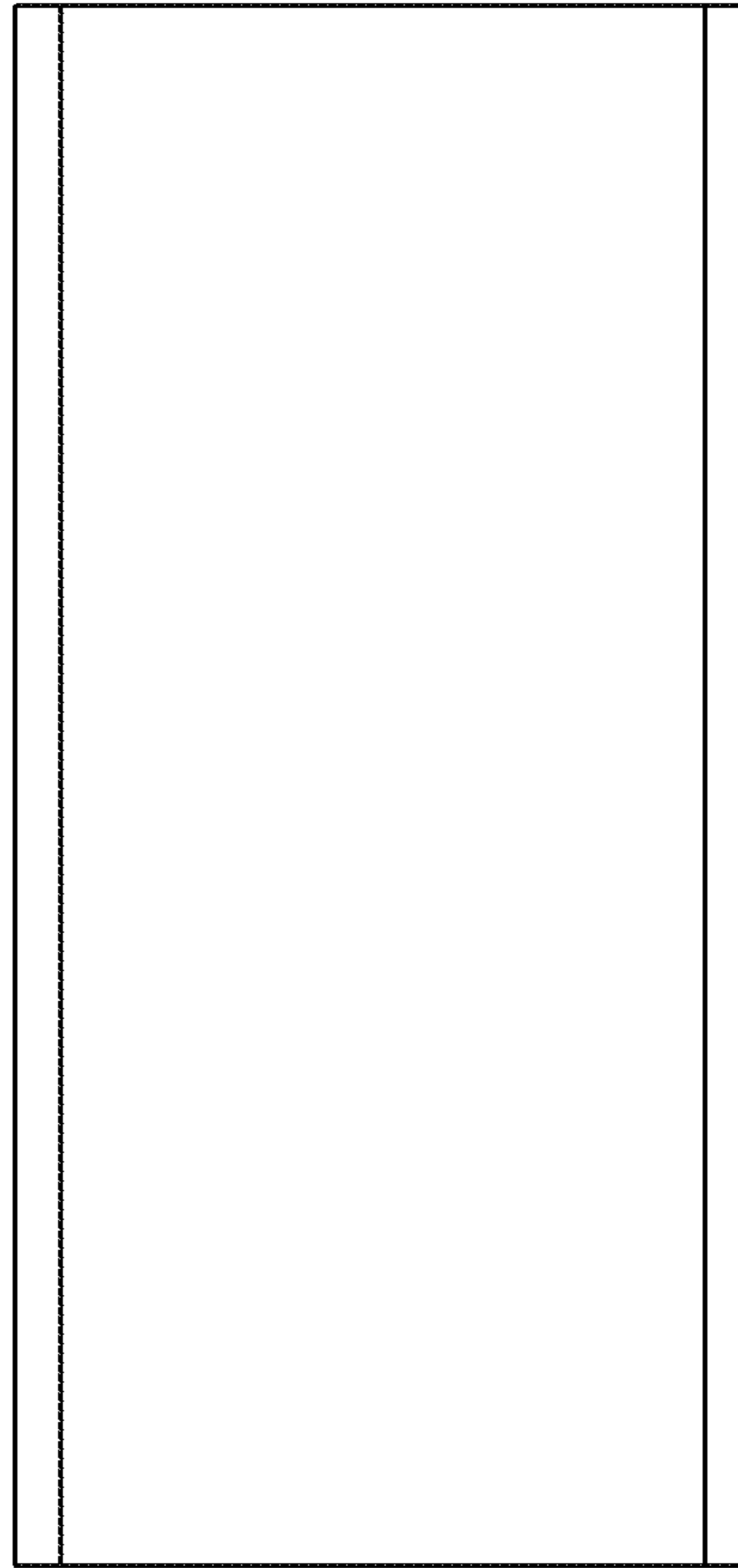

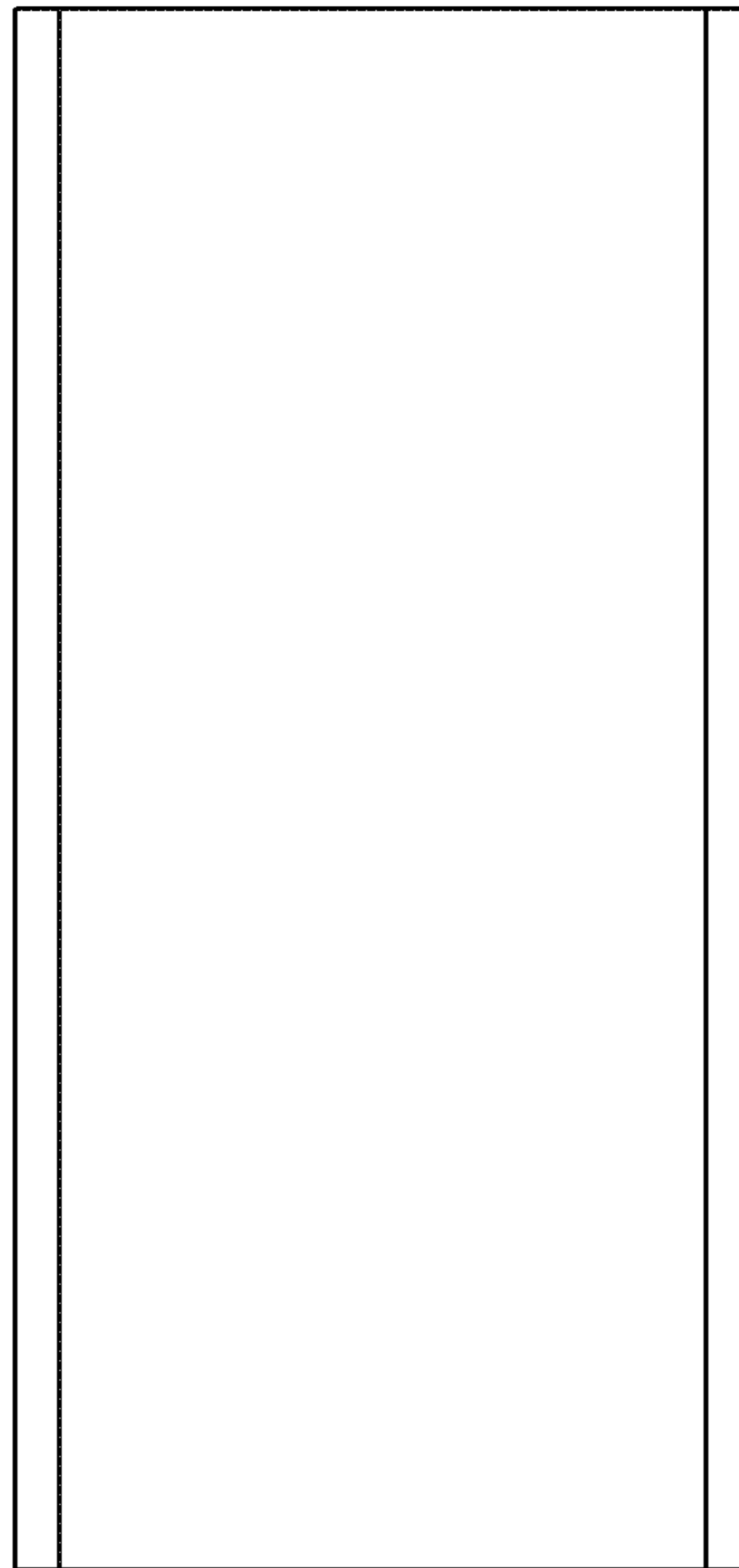

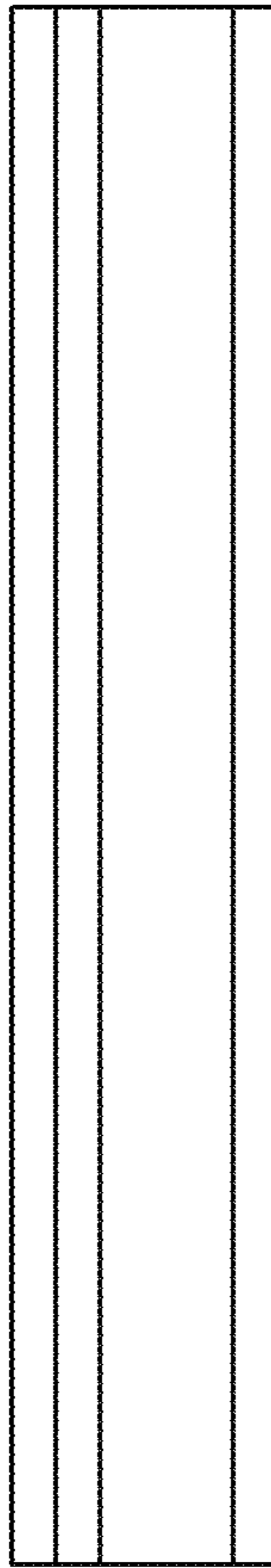

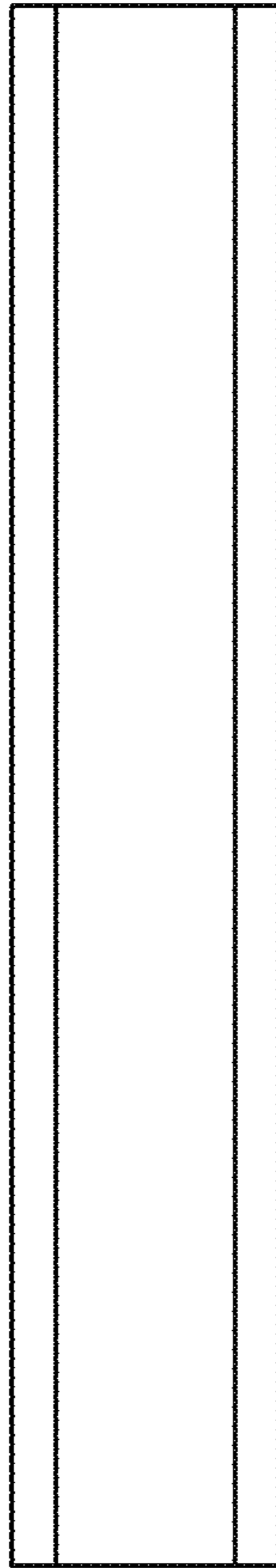

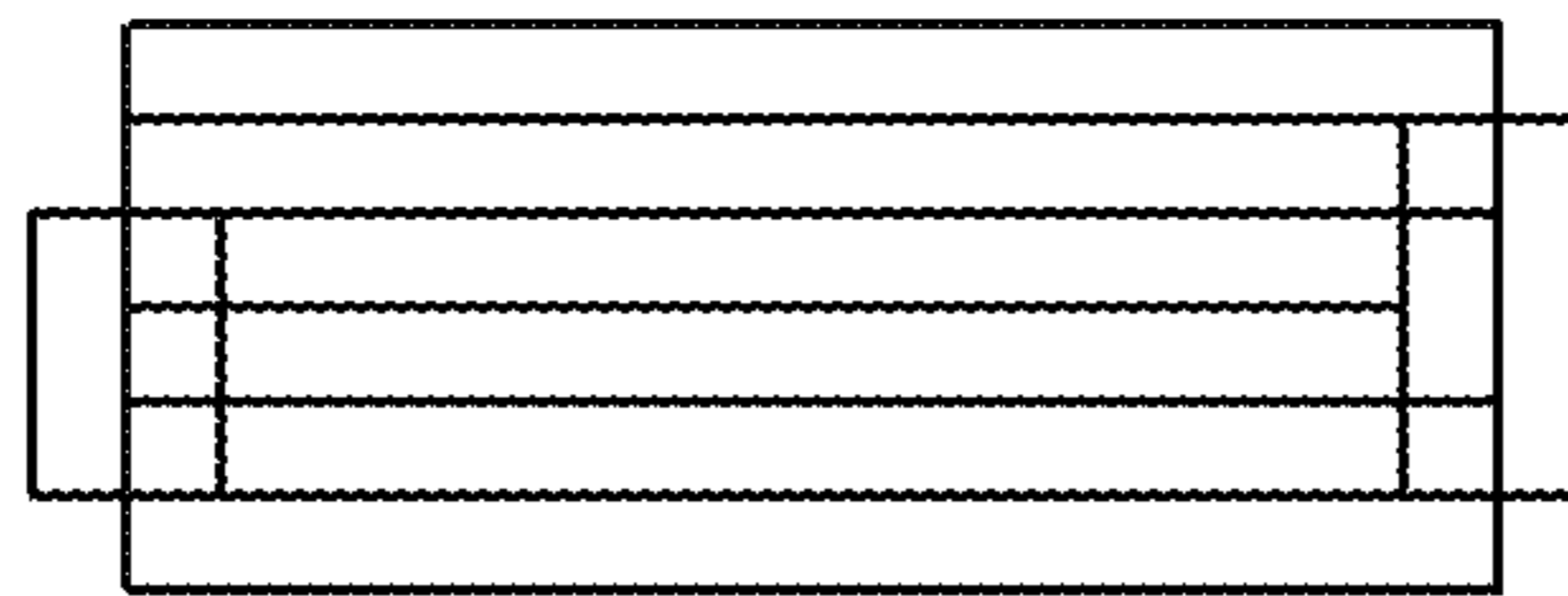

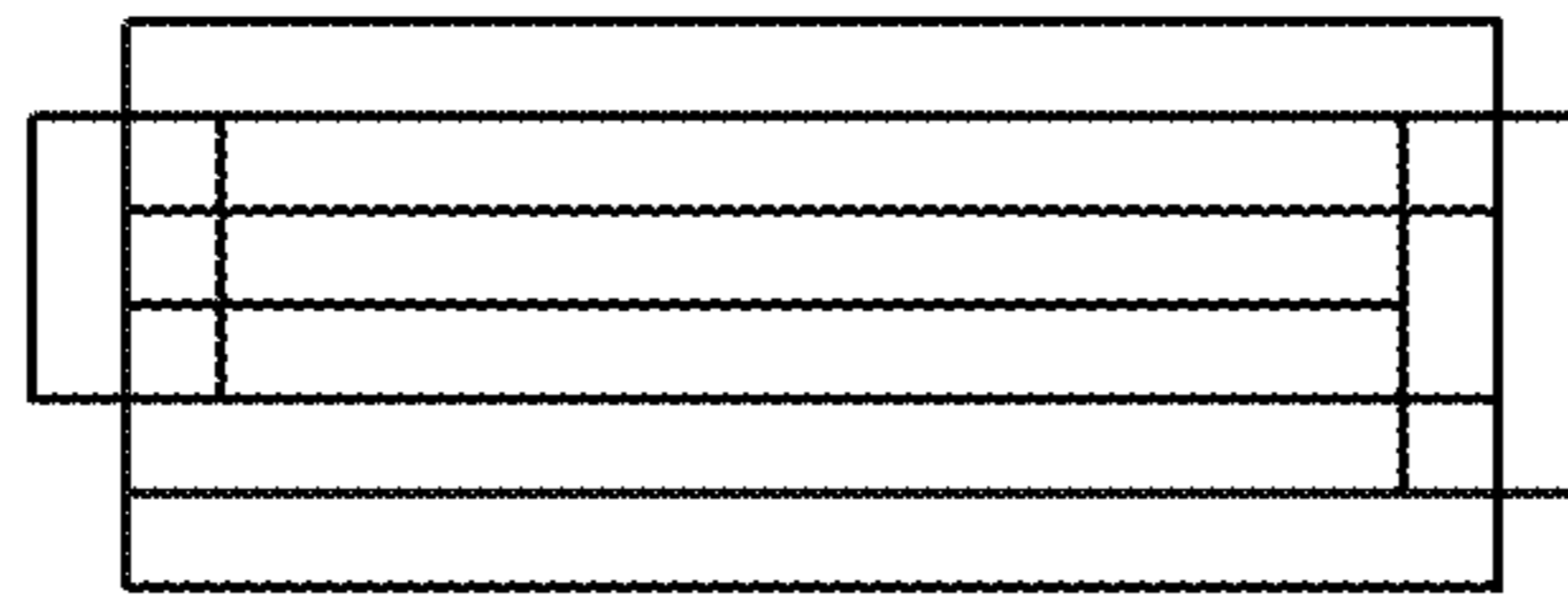

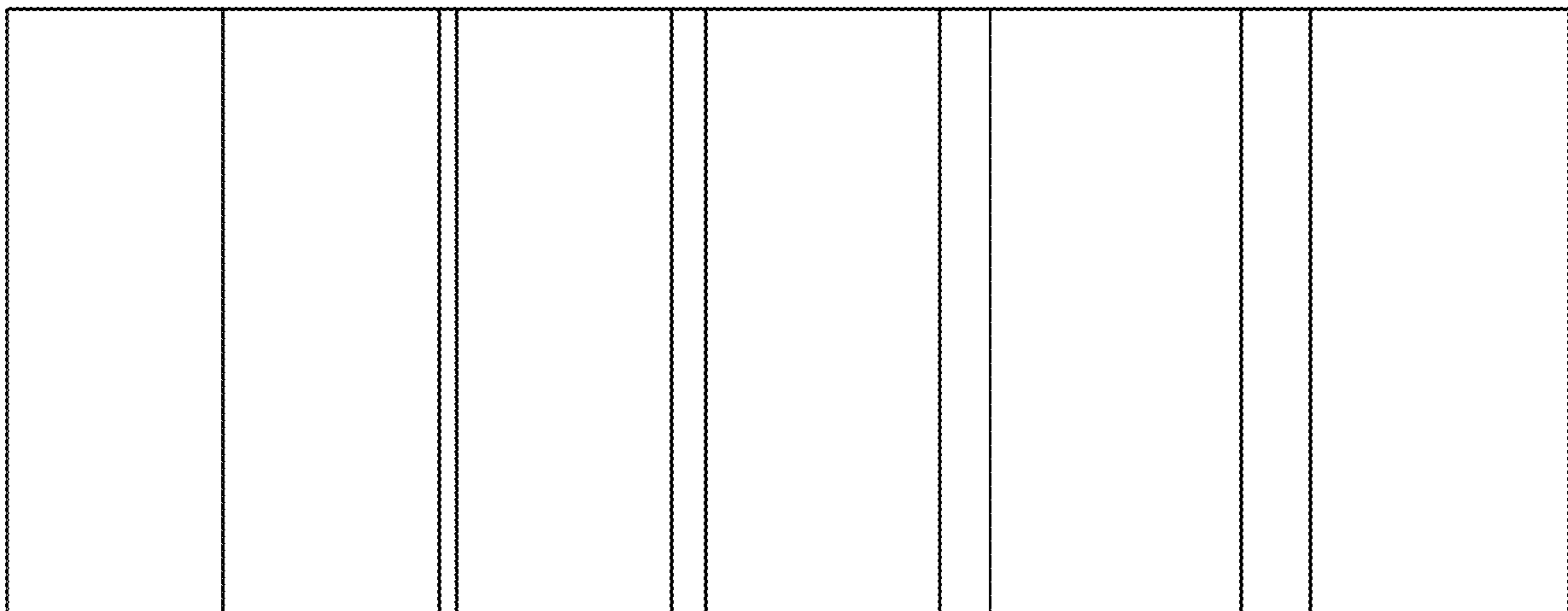
